



# Buhari's 'indifference' unsettles APC, others, as permutations favour VP, Amaechi, Tinubu

Tith the visit of the governor of Ekiti State, Dr. Kayode Fayemi, on Thursday to President Muhammadu Buhari to inform him of his intention to contest the presidential ticket of the ruling All Progressives Congress (APC), the race is gathering momentum.

Before Fayemi, Yemi Osinbajo, President Transport minister, Chibuike Amaechi; Imo State governor, Owelle Rochas Okorocha and Kogi helmsman Yahaya Bello had publicly declared their bids. The ambitions of Ebonyi State Governor Dave Umahi, Senate Chip Whip Orji Uzor Kalu and former Lagos State helmsman Bola Ahmed Tinubu, though mentioned, are yet to be formally declared.

Amid permutations favourable to the three major contenders, name dropping by people close to the aspirants indicating the purported closeness of their principals to the Presidency is rife. But the Presidency has remained silent since the body language of President Buhari does not portend his preference for anyone.

And although Buhari may not have given his blessings g to any of the aspirants, feelers from the grapevine say that power brokers within the Aso Rock Villa have preferences among the contenders.

Many political observers and policy makers are not comfortable with the lack of clarity on where the interest of the President is tilting among the aspirants, especially those regarded as the major ones

This has created room for speculations as to who is the anointed candidate whom Buhari wants to hand over the APC administration to in 2023.

A major factor that serves as a pointer to Buhari's interest is the power play within the Aso Rock Villa, otherwise known as 'The Cabal.'

But the Attorney General of the Federation and Justice Minister, Abubakar Malami to many people is the de facto leader of the cabal. He took charge after the demise of the former Chief of Staff to Buhari, the late Malam Abba Kyari, and he has been the pipeline through which most actions of the government are being dished out.

While it may be difficult to pinpoint on whose side Malami is, it is obvious that he will not only support Buhari's

choice but work it out

The National Chairman of the APC, Senator Abdullahi Adamu, is a close associate of Buhari and his emergence for the role has enlisted him into the cabal.

His emergence as Buhari's preferred candidate against all odds speaks volumes and his assigned mission in the party cannot be doubted.

As aforementioned, there are various permutations in favour of the three leading aspirants amid speculations that a dark horse might emerge owing to Buhari's alleged indifference.

Among those considered as influencers is the First Lady, Mrs Aishat Buhari, who was close to Yahaya Bello but now one of the major backers of Amaechi.

Alhough she is currently in Dubai, United Arab Emirates, sources said that her associates are already enlisted on the Amaechi-for-president project.

Her influence might look insignificant to some people who see Buhari as unperturbed by such lobby from a wife.

Amaechi has been a close ally of Buhari and his financial contributions to the president's emergence in the 2014 APC primary, subsequent campaign as well as in 2019 cannot be over-emphasised or underestimated.

The former governor of Rivers is a key minister involved in driving the policies and programmes of the Buhari government, particularly the rail networks, many of which are in the north. These make him a trusted one.

His conferment a few months ago with a traditional title in Buhari's hometown, Daura is significant and seen by many as an indication that the cabal preference scale is tilting towards him.

He is also seen as an ideal one to fulfil three roles: a southern Christian to run with a northern Muslim, an Igbo presidency and compensation for the South South not completing the unwritten eight-year tenure under Jonathan unlike Obasanjo and Buhari. Amaechi is also seen as capable of handling the Niger Delta and Biafran unrests as well as garnering South South and South East votes.

Bureaucrats within the Presidency are not left out in the power play as most of them are rooting for Osinbajo to emerge as APC candidate.

Political Adviser to the President, Babafemi Ojudu, is believed to be the arrowhead of the Osinbajo-for-President project.

He came to the Presidency as one of Tinubu's political benefactors but he fell out with

his former boss and openly profess that the Vice President is the best choice to succeed Buhari.

Permutations favouring Prof. Osinbajo include his academic qualifications (especially legal erudition), ability to garner South West as a Yoruba votes if he gets the APC ticket, a Christian to run with a northern Muslim for balance as well as his incumbency as the vice president which should ordinary give him the right of first refusal to succeed Buhari.

Tinubu equally has some permutations in his favour. As the party's 'National Leader,' he is regarded as the APC's most powerful politician after Buhari.

However, certain erstwhile powerful forces in Aso Rock backing some of the aspirants may have lost out in the powerplay within Buhari's kitchen cabinet.

Kaduna Governor Nasir El-Rufai who until lately lost favour with the Villa over APC national leadership tussle and outcome of its convention was a force to reckon with. He is now a staunch projector of Tinubu within the kitchen cabinet. With his influence waning, it is doubtful if he can successfully pull through the Tinubu presidency project.

However, Tinubu also has other strengths such as his political structure in the high population Lagos State, in fact, the Southwest as a Yoruba as well in the core north as a Muslim.

But the Islamic card is seen a double-edged sword for Tinubu if he does not play it well. There are strong speculations that he believes in a Muslim-Muslim ticket helmed by him winning the presidency as Yoruba Christians will vote for him due to ethnic solidarity. He is said to have in the past sought to run with Atiku and Buhari who are Muslims. He allegedly cited the victorious Abiola-Kingibe Muslim-Muslim ticket in the annulled 1993 elections and the Buhari-Idiagbon (Muslim-Muslim) regime that was welcomed by Nigerians after the coup that that brought it to power.

However, critics of the Muslim-Muslim ticket say that the times have changed and that the ethnoreligious fault lines have deepened since the voided 1993 elections. Some have also accused Tinubu of religious arrogance and insensitivity although his wife is a Christian.

But some pro-Tinubu people believe that they can clinch the presidency with Southwest and core Muslim North votes, arguing that South South, South East and Middle Belt/North Central ballots won't significantly affect his religious and Yoruba advantage.

Tinubu's age and health as well as the opposition of the umbrella Yoruba socio-cultural group Afeniifere to his bid are also counted against him.

The presidential ambition of Central Bank of Nigeria (CBN) Governor Godwin Emefiele, though still in the realm of speculation, is difficult to just dismiss with his position in the financial system.

Another name in the APC race to succeed Buhari is Science and Technology Minister Ogbonnaya. He was a stalwart of Buhari's defunct CPC as its national chairman.

However, persons close to and who understand Buhari said the President's disposition might not be towards any of the names or aspirants being touted and bandied about.

One said: "All those jostling may end up as huge jokes as President Buhari that we know might spring surprises. He may not have his preference among any of these ones as he may prop up a dark horse.

"You should be guided by what happened with the choice of the APC national chairman. Look at how the President's men just raised Senator Abdullahi Adamu and the leading contenders were compelled to step down from the race

"So, you should not overrule any possibility. The game is not over until it is over.

"While the game to outsmart one another continues among the power blocs within the Presidency, it is hoped that an acceptable candidate will emerge as APC presidential standard-bearer."

Peoples Redemption Party (PRP) to run for the presidency in 2023. He is the eldest son of the late Chief Moshood Kashimawo Olawale Abiola, who is presumed to have won the annuled June 12, 1993 presidential election.

Abiola was formally accepted into the party on Thursday at its national secretariat in Abuja by Falalu Bello, its National Chairman.

Receiving him, Bello said: "I formally welcome you into our fold. Your antecedents speak volumes."

Earlier, Abiola said: "Today makes my formal inroad after 27 years, back into politics. I particularly picked to come back into politics through the PRP for some good reasons.

"I have gone back to the history of Nigeria to look at the party that truly represents Nigeria. I have gone back and I have found out that the oldest living party is the PRP; it still holds those ideals of what Nigeria and democratic practice should be like.

"The PRP is a party that was started by the people and truly for the people. It is a party that has shown first, as its priority, internal democracy.

"I have come back to PRP

"I have come back to PRP to show Nigerians that not too long ago, we did things in the right way and the new entities that have come together nowadays forget that there was a Nigeria that did things right.

"I am one that believes in an equal opportunity be it employment, be it business, equally in politics and I believe this party represents all of these.

"Everybody should have equal opportunity, irrespective of age, religion and ethnicity and that is represented here."

Expressing concern over the low participation of youths in politics, he said: "We have a youth population that has been caught out of the system, the political process.

"The first thing I want to

"The first thing I want to do is to disrupt the political process, to disabuse the minds of the youth about godfatherism.

"The way to do this is to give the true owners of Nigeria, that is, the 18 to 36 years age group that makes up over 75 per cent of the population, an opportunity for their voices to be heard and their numbers to count "

He said PRP is the only party that could give youths such an opportunity to make their numbers count.

His father was an influential politician who took the political landscape by storm in 1993 when he ran for the presidency on the platform of the Social Democratic Party, SDP.

In what many thought was a political blitz, Alhaji Abiola won on the first ballot securing popular votes in the North and South of Nigeria after promising to banish poverty by driving down the cost of food, goods and services.

He was however arrested and imprisoned after the military junta at the time headed by General Ibrahim Babangida annulled the elections. Abiola later died while in custody in controversial circumstances.

The entrance of Kola into the presidential race could rekindle old memories among Nigerians who still believe the family was unjustly denied the opportunity to rule Africa's most populous country.

On its part, the Peoples Democratic Party (PDP) has earned N680 million from sale of Expression of Interest and Nomination Forms to 17 presidential aspirants.

Those who had previously collected forms included former Vice President Atiku Abubakar; erstwhile Senate President Bukola Saraki. and former Anambra State Governor Peter Obi. Another former Senate President and erstwhile Secretary to the Government of the Federation, Chief Anyim Pius Anyim; industrialist Mazi Ohuambuwa, medical doctor Nwachukwu Anankwenze, media icon Dele Momodu, Cosmos Chukwudi Ndukwe and the only woman in the race, Olivier Diana Tariela, have also done the needful.

Governors Aminu
Tambuwal (Sokoto State),
Bala Mohammed (Bauchi),
Nyesom Wike (Rivers), and
Udom Emmanuel (Akwa
Ibom) as well as a former Ekiti
helmsman Ayodele Fayose
and businessman HayatuDeen Mohammed are also in
the PDP presidential ticket
race.

Each of them paid the total sum of N40 million to obtain the forms which will enable them to participate in the PDP presidential primary election which holds between May 28 and 29.

Meanwhile, in the last 48 hours, some of the aspirants continue consultations with different organs and stakeholders within the party.

# Amid insecurity, 11,536 schools shut in Nigeria, says UNICEF

International Children's Education Fund (UNICEF) has stated that security challenges in Nigeria have affected 1.3 million children in the 2020/21 academic year.

According to UNICEF, since December 2020, a total of 11, 536 schools have been closed due to abductions and security issues.

This was disclosed by UNICEF in a statement issued on Thursday to mark the eighth anniversary of the abduction of 276 students at Government Secondary Chibok, Borno State.

UNICEF representative in Nigeria, Peter Hawkins, said attacks on schools have rendered the learning environment insecure and discouraged parents from sending their children to schools. The abductions and discouraged have children, especially girls, from learning.

According to UNICEF statement: "Today marks eight years since the first known to UNICEF attack on a learning institution in Nigeria on 14 April 2014, in which 276 students at the

School Chibok in North-East Nigeria were abducted by a Non-State Armed Group.

"Since then, a spate of attacks on schools and abductions of students - sometimes resulting in their deaths - has become recurrent in the last two years, especially in the North-West and North-Central regions of Nigeria. Since December 2020. 1,436 school children and 17 teachers have been abducted from schools, and 16 school children lost their lives.

"Unsafe schools, occasioned by attacks on schools and abduction of students, are reprehensible, a brutal violation of the rights of the victims to education, and totally unacceptable. Their occurrences cut short the futures and dreams of the affected students.

"Attacks on learning render the institutions learning environment insecure and discourage parents and caregivers from sending their wards to schools, while the learners themselves become fearful of the legitimate pursuit

of learning.
"The invisible harm school attacks inflict on the victims' mental health is incalculable and irredeemable.

been targeted, exacerbating the figures of out-of-school children in Nigeria, 60 percent of whom are girls. It is a trajectory which must be halted, and every hand in Nigeria must be on deck to ensure that learning in Nigeria is not a dangerous enterprise for any child, particularly for girls.

'In Nigeria, a total of 11, 536 schools were closed since December 2020 due to abductions and security issues.

"These school closures have impacted the education of approximately 1.3 million children in the 2020/21 academic year. This interruption of their learning contributes to gaps in children's knowledge and skills and may lead to the loss of approximately 3.4 billion USD in these children's lifetime earnings. This risks to further perpetuate cycles of poverty and inequality.

"To tackle the scourge in Katsina, 300 School Based Management Committees (SBMC) members have been trained, multi-sectoral task teams on school safety have also been established across all the 34 local government areas of

"In Katsina State, 300 SBMC members have been trained, and schools supported through the



Girls' Education Project funded by the Foreign, Commonwealth Development Office of the United Kingdom, have developed Emergency Preparedness and Response Plans to mitigate the impact of potential and actual threats.

"Multi-sectoral task teams on school safety have also been established across all the 34 LGAs of Katsina State to provide timely and efficient networking among actors on school security, with particular focus on the safety of girls. Additionally, 60 Junior Secondary Schools have developed emergency

plans and tested the plans in evacuation drills.

Katsina government and communities have fenced some schools, and this is encouraging girls to attend school, underscoring the reality that collaboration is required in addressing insecurity in schools and making schools safe, especially for girls."

Hawkins added collaboration is key to addressing insecurity and urged the government to increase their efforts encourage girls' education by keeping schools safe.

service procedures. He said, "The Board and Council are therefore responsible for setting out agencies economic, financial, operational, administrative policies, administrative policies, programs and targets, in line with the overall objectives as provided by the government.

They also have the responsibility for meeting targets, introducing broad policy measures for seamless operation and supervisory management to ensure that targets are achieved.

"The challenge before the Board and Council is one of reengineering and developing new strategies and suitable modalities for translating the broad objectives of governments to tangible goals in the lives of our citizens, especially the most vulnerable.

"The role of the Governing Boards is therefore to drive general policy formulation and implementation and not to be involved in the day to day running of the agencies.

"It is pertinent to remind you at this juncture that this administration has zero tolerance for corruption. It will therefore be irregular and indeed, unacceptable for you to ask your management to provide fringe benefits that you are not entitled to.

"Further to this, members who enjoy institutional representation, most as a matter of necessity inform the Board or Council of their retirement or redeployment, necessitating or replacement in the board or the council.

"This has become necessary following reports of retired or reassigned public officers, keeping quiet about their status to ensure they are still being in the Board or Council contrary to their terms of engagement.

"The conditions of service of Chairmen and members of the Board and Council, particularly on travels and tours shall be subject to extant public service circulars which are subject to review from time to time.

"For the purpose of oversea travels, members will be entitled to the approved estacode rates. Chairmen or members of Board and Council on all agencies must obtain prior approval through

the Supervising Minister from the President before undertaking official trips overseas. Such approvals shall be conveyed by the Office of the Secretary of the Federation or the Office of the Chief of Staff to the President.

'I want to enjoin you all to ensure that all public service rules as it relates to appointments promotions, and discipline are strictly adhered to by the management of your agencies. You are also to ensure that all outstanding allowances due to workers are cleared promptly.

"Furthermore, the operations of the various agencies must comply strictly with financial regulations and the provisions of the Procurement Act. The audited accounts of the agencies must always be prepared and submitted to the relevant authorities as at when due.'

Earlier while presenting his welcome address, the Director General of NDE, Mallam Abubakar Nuhu Fikpo said the reconstitution and inauguration of the Board and Council underscore the high premium that the government of President Buhari places on labour studies, employment, wealth creation and social inclusion matters, through the governing boards that will quickly fast track the agencies' policy directions.

'I'm sure that the Board will settle down to the rigorous tasks of policy formulation for the general good of the Nigerian citizenry," he

#### Lagos Customs impounds 206,000 pieces of machetes, other contraband

#### •Nets N135bn revenue in first quarter

The newly-appointed Controller in charge of the Tin Can Island Command of the Nigeria Customs Service, Comptroller Steven Oloyede, has up-scaled activities at the Command.

This has led to the seizure of 206, 000 pieces of machetes, suspected to be for violent and criminal purposes, loaded in eight containers and wrongly declared as vehicle spare parts.

The Command has also collected whopping N1354 billion revenues for the first quarter of 2022, which ended March 31,

as against the N112.7 billion collected in the comparative period of 2021, representing an increase of N22.7 billion or 20.18 percent growth rate.

Briefing newsmen for the first time, about six months after his appointment, the Comptroller disclosed that in addition to impounding the machetes, the Command, during the review period (January-March, 2022), also seized 145kg of Colorado, Indian Hemp concealed in two units of ridgeline trucks, two pieces of Toyota Corolla cars and 640 bales of used clothes.

Also seized were 236, 500 pieces of used shoes, 62, 500 pairs of brand new lady's shoes, 1, 814, 400 pieces of (500mg/5ml) Novalgen injec-

tion, 48, 850 rolls of cigarettes and 23, 800 tins of bromate and baking powder; all with a duty paid value of N1.04 billion.

The import of these products contravenes sections 46, 47 and 161 of the Customs and Excise Management Act CEMA 2004.

The Comptroller assured that the Command, under his watch, would continue to up-scale activities at the Command, using all the Information Communication Technology, ICT mechanisms at his disposal and a robust stakeholders' engagement.

"My arrival here signalled new dawn in the overall performance of the Command and this is simply in view of the fact that I was emphatic and categorical on my vision for a renewed enthusiasm in the areas of discipline, trade facilitation and revenue drive devoid of extortionist tendencies.

"Tin Can Port Command's operation for the first quarter was significantly aligned with the statutory responsibilities of the service in the area of revenue generation, trade facilitation and enforcement/ anti-smuggling activities. In addition to the above, my mandate also included putting modalities in place to boost export and increase revenue, through the use of risk management mechanisms in identifying areas of revenue leakage, with a view to blocking them.

"It is also instructive to

note that the Command's operations drew inspiration from the theme of the International World Customs Day: 'Scaling Up Customs Digital Transformation by Embracing a Data culture and Building a Data Ecosystem'.

"The Command continues to leverage on this theme, to harness such facilities that have been made available on the NICIS ii platforms, such as the Pre-Arrival Assessment Report (PAAR), Advance Manifest, Selectivity Engine and data analysis, which to a large extent enhanced our Risk Management Processes, culminating into trade facilitation, expedited Customs processes and ensuring collection of appropriate duty and taxes," Comptroller Oloyede said.

Adebote on Tuesday 12th April 2022, at the FRSC Mowe command."

According to Sonusi, "After the meeting, the team inspected the level of work at the construction site on Lagos-Ibadan Expressway and it was unanimously agreed that all diversions at the construction spots should be opened from Thursday, 14th April, till Tuesday 19th April 2022, for easy and seamless movement by motorist plying the road, since there will be high influx of vehicles travelling in and out of Lagos during the festive season."

Ogungbemide used the opportunity to inform the public that FRSC Lagos is ready to provide the necessary safety and traffic control needed by motorists during the Easter special patrol, as over 2,000 personnel (both Regular and Special Marshals), 57 patrol vehicles, eight bikes, three ambulances, two tow trucks, seven breathalyzers, will be deployed on major highways in Lagos State, to monitor, control traffic and clear obstructions along critical routes within the state during the Easter Special Patrol exercise."

The special patrol, involving regular and special marshals, which has kicked off already, will focus on overloading, speed limit violation, tyre violation, and light sign violation, among

#### Alleged serial rapist tells police how OOU Undergrad was raped, killed in her room

A serial rapist and murderer, Ikenna James Joshua, has opened up to the police on how he and his gang member, Rasheed, currently at large, conspired to rape his 29-yearold neighbour, Adefisayo Tosin, at Ogijo Town, in Ogun State, after breaking into her apartment at midnight, before she was killed for fear of being exposed.

Ikenna also revealed how, not minding killing their victim, they started ransacking her apartment to cart away belongings before he fell into the hands of local vigilante men while his accomplice escaped.

The Police Spokesperson, Abimbola Oyeyemi, a Deputy Superintendent of Police (DSP), who confirmed the arrest of the suspect, to The Trumpet, said that he was nabbed for raping and killing Tosin, a graduate of Obafemi Awolowo University, after invading her apartment to commit robbery.

The Police spokesperson said that the victim was fast asleep at midnight last Sunday, when Ikenna and his accomplice broke into her apartment through the ceiling, raped and then strangled her till she died.

He stated that other neighbours, including the mothers of the suspect and the deceased, discovered that Tosin's apartment had been broken into when knocks on her door by her mother got no reaction.

Unknown to them that the lady had been murdered, the

neighbours reportedly invited the local vigilante to the scene, and while trying to find out what had happened, Ikenna was seen coming down from the ceiling, where he had been hiding after committing the act.

He was quickly apprehended, while a distress call was made to the police at Ogijo Divisional Headquarters.

DSP Ovevemi said that on receiving the report, the Divisional Police Officer in charge of Ogijo Division, CSP Onatufeh Umoh, quickly led his men to the scene and got the suspect arrested.

On interrogation, Ikenna confessed that he and his partner-in-crime decided to kill the victim after raping her because they discovered that she recognised them.

Ikenna's mother, who was said to have described her son's arrest as good riddance, said that she had given up hope on him, as he had always been a bad son.

In an interview, Ikenna revealed his criminal escapade: "I'm from Imo State but living at Ogijo in Ogun State. I came to the town in 2017. My father is late and I live with my mother in Ogijo.

"On Sunday, April 3, I stole the sewing machine of my uncle's wife, which he kept with my mother. I immediately sold it as scrap at N4,000.

"When my mother came back from church, she went to the room where the sewing machine was kept and noticed that it was not there. She must have realised that I was involved in the disappearance

of the equipment so she started calling me. I ran from home immediately because I knew what she wanted to ask me. I went to my friend, Rasheed, to whom I sold the machine. He is also living at Ogijo and sells scraps. He had initially told me he would not buy things as he had been doing, telling me to look for ways to 'work' by robbing people of their belongings.


"That same night, he told me about how to get more sewing machines. I knew a lady called Tosin that was living in the same compound with me and my mother. Her apartment is next to ours. I told Rasheed that Tosin had two sewing machines and he said that we should break into her apartment at midnight, tie her down and take all her valuables.

"At about 1 am, we broke the ceiling of Tosin's apartment to gain entry. When we got in, we met her sleeping and I started romancing her as she had only her underpants on because of the hot weather.

"As I touched her, she woke up and was shocked at seeing us. That was when Rasheed told me to hold her hand and throat, while he started having sex with her.

"After he was done, I took my turn. She started screaming when she saw our faces, which made us hold her throat tightly and cover her face with a doth. She went limp as she could not breathe very well.

"Thereafter, we took one of her sewing machines, food items, such as rice, beans and spaghetti, copper wire



"We kept searching everywhere in the apartment to get more things, and by the time we wanted to leave at about 6 am, she had already died. As we were about going, her mother came and knocked at her door. When she didn't get any response, she went to my mother and asked her if she had seen Tosin that morning and my mother said she had

"My mother also came to Tosin's apartment to check on her. That was when she noticed the hole through which we broke into the apartment. Coincidentally, the vigilante group members were close by so they quickly informed them. At that time, we were still inside Tosin's room and we knew that we had been caught.

"We went into the ceiling to link my mother's apartment and as we were about coming out through the ceiling, with Rasheed coming out from the ceiling in my room and me using the sitting room, I just fell into the hands of the vigilante men who quickly grabbed me. However, Rasheed managed to escape.

"They had not known that Tosin was dead. When they started beating me, I opened up that her body was inside her room, as we had killed

Ikenna also spoke about his mode of living from a tender age. According to him, "my father died when I was about two years. My mother was not around then, and members of our extended family rejected and later pushed me and my elder sister out because they said that they could no longer cater for us and were after their own survival. My sister was taken to an unknown person in Abuja to live with.

"I was on the streets early and started smoking cannabis at the age of six. I learnt it where I grew up at Idi Oro in Mushin. I finished secondary school in 2016 without sitting for WASCE because of lack of money and no one to support me. I used to fight around.

"Apart from cannabis, I'm also involved in the use of other hard drugs such as cocaine, Colorado, amphetamine (popularly known as Ice), Loud and Skuchies (a mixture of cannabis, Tramadol, codeine, zobo drink and water)."

The state Commissioner of Police, Lanre Bankole, had directed the immediate transfer of the suspect to the Homicide Section of the State Criminal Investigation and Intelligence Department for further investigation.

He also ordered a manhunt for Rasheed, the accomplice, for him to be brought to answer for the crime he allegedly committed.

#### Man connives with others to kidnap girlfriend, collects N2m ransom

The police in Lagos are on the trail of one Ahmed for allegedly conniving with one Uchenna Daniels to kidnap his (Ahmed's) girlfriend, Hannatu

Daniels reportedly abducted Kabri in Abuja on March 31 and took her to Lagos.

It was learnt that the victim was released after her parents

paid N2 million ransom.

The case was reported to the police and a manhunt was launched for the suspects, leading to Daniels' arrest.

Addressing journalists on Thursday at the Lagos State Police Command Headquarters in Ikeja, Lagos, the Spokesperson for the Command, SP Benjamin Hundevin, said the police were making efforts to arrest Ahmed and one Biliya,

who allegedly participated in the crime.

He said, "On 31st of March, 2022, at about 1400hrs (2 pm), intelligence gathered revealed that one Uchenna Daniels, 30, kidnapped one Miss. Hannatu Kabri, 22, in Abuja and fled to Lagos.

"Operatives of the Command tracked and arrested the suspect, Uchenna Daniels, at Allen Avenue, Ikeja. The suspect revealed that the victim's boyfriends, one Ahmed and one Biliya, planned the kidnap with him and collected a ransom of N2 million in Kaduna, through a Bureau de Change from the parents of the victim before she was released.

"He added that they used a toy gun to commit the crime. Investigation is ongoing to

arrest other fleeing suspects." The PPRO said the arrest was one of the numerous breakthroughs recorded by the Command in the last one month in the fight against crime and criminality within Lagos.

He stated, "Before you today, we have a total of 32 suspects, who have engaged in various crimes including armed robbery, kidnapping, defilement, murder, cultism, etc.

"From all of these cases which we successfully cracked,

we recovered a total of 11 arms, 19 live ammunition, two cars, 16 inverter batteries, six modules, cables, three ATM cards, four SIM cards and four phones."

Hundevin said the State Commissioner of Police, CP Abiodun Alabi, has assured Lagosians that the security of life and property will continue to be prioritised by the Command.

## Yoruba groups to support pro-restructuring presidential candidate in 2023

Pan-Yoruba group known as the Alliance of Yoruba Democratic ▲ Movement (AYDM) made up of farmers, hunters, traders, market women, mechanics and civil society networks has vowed that they will ensure that the 2023 presidential election in Nigeria produces a candidate that will restructure the country

and resolve its lingering national question. The group said the 2023 elections must produce a Yoruba presidential candidate or risk a popular uprising. The groups stressed that political parties in Nigeria should know that the coming elections will be different, as it is not going to be about the All Progressives Congress (APC) or the Peoples Democratic Party (PDP) but the ordinary men on the streets.

AYDM Chairman Mr Adewale Adeoye, in a three page address entitled "2023 Democracy And The Future Of The South-West" which was issued on Wednesday, April 13 2022, in Lagos, in a two days conference, the group organized to mobilize and sensitized its members in all the old South-West region of the country, which included Edo and Delta states, He said his groups will take over the present political process and campaign to ensure the will of the people in the South West is accomplished in all Yoruba territories.

The AYDM Chairman warned, "Multiplicity of presidential candidates in Yoruba land will be counterproductive.'

Adeoye stressed, his coalition is aware of the presidential ambition of the likes of Dr Kayode Fayemi the present Governor of Ekiti state, the Vice-president of Nigeria Professor Yemi Osinbajo, SAN, GCON, and Asiwaju Bola Ahmed Tinubu the National Leader of the APC, adding that, the Yoruba people will now choose who would represent their interest as Yoruba people at the national level. Saying it is no longer for the candidates to impose themselves as representative of the Yoruba people. He added "We shall ensure this does not happen. The Yoruba people must decide their presidential candidate and work genuinely for him."

Adeoye said some of the reasons why these groups are pushed to take this position is because as of today, the people of the South-West are at a crossroads. As the people of the region are faced with one of the most difficult moments since 1960 when Nigeria became independent from Britain, some three years after the Western Region had regained her independence from Britain too.

AYDM Chairman explained further that the South-West region, as we speak, has various degrees of threats.

"We face internal, external and international threats to our livelihood. I summarise these concerns in a few words. Internally, we are afflicted by poverty, lack of jobs, deprivations, exclusion and worst still, degradation of our environment, our stream, our mountains, our valleys, our forests and our livelihood externally, we are at the mercy of marauders, terrorists, kidnappers, villainous spirits and gangsters that have surrounded some of our towns and villages, in the West, East, in the North, South of Yoruba land including our seashores.

"These forces are not only for domination but are bent on exterminating us and taking over our ancestral homes. The impacts of these threats on food security cannot be imagined not to talk of the impact on our forest resources that are

vanquished and destroyed with impunity. For the first time, murders, killings and assassination of our people is no longer a terror masterminded by the state, but by alien non-state actors, that are heavily armed and who kill without discrimination putting the whole Yoruba

territory in jeopardy.

He continued "The acts of terrorism on our highways, our street corners, our towns and villages have polluted our scared forest and groves, almost eliminated the nigh economy, restrict our freedom, deprive our farmers their trade, our fishermen their commerce and our communities their livelihood. The threat is no longer a shred of imagination. It is real. We live under fear, trembling and anxiety.

"The actors are not just people of Nigerian extraction; they are equally aliens, terrorists that have acquired deadly weapons and training in Algeria, Somalia and the Maghreb region. They have cells all over our indigenous territories from Lagos to Jebba, to Warri and Ondo State.

Our international threats came from the parochial instinct of many international institutions. While in Nigeria, hundreds of people are killed by terrorists and arms men, the world chooses to look the other way.

The number of Nigerians that have been killed in non-combat attacks by terrorists in the past six months is 10 times the number of people that have been killed in Ukraine since the beginning of the February 2022 War. While the European Union, (EU) are outraged by the killings in Ukraine, followed by imposition of sanctions, we have not seen the same concern demonstrated by the same EU on the situation in Nigeria which confirms that the future of the people of the South-West is in their own hands. The EU and those bodies may not be able to help us even as we are being strangulated by the conditions imposed on us"

Adeoye said the reason for the confer-

ence is due to the various solutions being offered by the situation that confronts the people of the South-West region of today. Some people are demanding regional autonomy, some others are asking for restructuring of the country, and some want a sovereign Yoruba nation.

Each logic has its merit. What is most important is a constructive engagement of the people. It is the masses, the pillars of democracy that matter. The future of the Yoruba people to a large extent depends solely on what the people want. It is their future. They must have a say. They must give direction. They must show us the way to follow. While in some communities, it is the leaders that dictate to the followers, in Yorubaland it is the people that dictate to their leaders who are expected to aggregate their collective feelings, aspirations, fears and provide

a melting pot for their collective spirit. The AYDM chairman said "We are aware that there is still a sizable number of our people who will participate in the coming 2022 and 2023 elections. We are aware some of them are registered and will go out to vote in the coming elections in line with democratic norms. The electoral process began this week.

"What then should be our attitude? Since 1999, the voting pattern and public enthusiasm towards elections in the Western Region have continued to wane. Many of our people appear to be losing interest in the democratic process. Many people think their votes do not count. Millions of our people think their votes have not been able to bring the good government they all desire.

"This has put our people at a disadvantage position. Increasingly, the people are marginalized based on their weak political strength expressed through their voting capacity. The votes coming out from the South West fail to reflect our population. This in future may affect our people in the context of local, regional, national and global politics where population is

"We want our people to show their determination to use their votes to determine their future. We want our people to use their votes to raise political consciousness. We want the Western Region to overwhelm the rest of the country through massive participation in any electoral process, so that we can assert ourselves as one indivisible people, bound together by common history, shared dreams common future for the prosperity of our people."

The Guest of Honour/Guest Speaker at the event Pa. Ayo Opadokun, in his presentation, first asked the delegates that gathered, "What is the relevance of any election at this time of our national life, without a resolution of the existential National Question?"

He asked again, "Can the current political operators, in good conscience, point to significant milestones they have accomplished meaningfully to improve the qualitative and quantitative standard of living of our people? I don't need to waste your time enumerating what has happened to the value of the naira; price of foodstuffs, provisions of social services like education, health, shelter, transportation (even if some efforts are being made through loans from China and Šukuk); not to talk about our infrastructure.

"Nigeria has admittedly spent over \$20 billion on power and yet electricity supply remains painfully unreliable despite our natural resources like water, sun, gas wind, etc. Lack of power continues to rob Nigeria of highly valued investments by blue-chip companies.

Opadokun, said for clearer understanding and critical appreciation of the parlous nature of the state of the nation, the following comparative global statistics on Human Development Index for Africa, and the state of corruption in Nigeria speak for themselves as to the country's

He continued, "The summary of the corruption perception index disclosed that Nigeria performed woefully and dropped down to become No. 154 of 180 countries where the survey was conducted. This is despite the much-taunted efforts of Nigeria's anti-corruption agencies.

Opadokun added, that, there is the need to remind Nigerians that in the last 35-40 years, Nigeria has been under-developing rather than developing. The latest statistics on African Development Index are avail-

able on the internet. It should worry Nigerians that despite the country's human and natural endowments, Nigeria is part of the low human development countries, comparable only to war-ravaged areas of the world like Sudan, Chad and Somalia. He said, making our situation of much more concern is the intolerable level of insecurity and its consequential effect on human lives that are degraded, the poor national economy and the deprivations that many Nigerians farmers are suffering as the fear of bandits, herders, terrorists have made many of them jobless. Saying that this is an unprecedented abnormality in domestic, municipal and international laws, and protocols.

Opadokun stressed that the second and perhaps a much more fundamental matter for the younger generation to consider, request and insist upon is that aspirants who will soon be coming to them for votes in the forthcoming elections, should be made to respond to where they stand on the Yoruba Agenda. Since 1994, the Yoruba Agenda has been harmonized under the Chairmanship of the late Professor Adebayo Adedeji. While the Political/Elite's position was harmonized with that of the Traditional Rulers at conveyed meetings at the Ogbagba Court of the Awujale of Ijebu land when the Yoruba people, thought that the late General Sani Abacha was going to organise a truly representative assembly of Nigerians to discuss and resolve the National Question.

He said "The most germane item in the Yoruba Nation's categorical demand for a return to Federal Constitutional Governance. As Yorubas have always stated with clarity that Nigeria secured its Independence on a Federal Constitution Governance that was negotiated by the different ethnic nationalities and their political leaders. He stressed that there was no time when Nigerians consented to, nor agreed with, the Unitary and Central Government that was imposed on Nigeria, by the military governments by decrees since January 15, 1966. Since this particular date, Nigeria has been governed unitarily and centrally till date, in spite of popular, credible and sustained categorical demands for a return to the negotiated Federal Constitution that recognizes the fact and reality that the geographic and political space created by imperialist Great Britain, composed of heterogeneous people with over 350 ethnic nationalities with their different languages, religions, cultures, customs, traditions, artefacts, folklore, mores and

Opadokun, told the Yoruba youths, that those who will come to see them for their votes in the coming elections, must be made to give them written and actionable guarantees of positive and categorical determinations on the 10 points AYDM agenda. And the Yoruba youths must make sure that those politicians did not again renege on their promises, as many recent past political operators

He concluded, by calling on the Nigerian Youths saying their jobs in the present political dispersion have been done for them. The most potent voting population today in Nigeria is the youth. The latest demographic population statistics indicate that ages below 19 years constitute over 40 percent of Nigeria's citizens. ## Stop castigating Buhari's government over insecurity, BMO cautions NEF

some is the claim that there has not been an appropriate response from the President Muhammadu Buhari administration to the problem.

"While we see it as a mischievous claim, we believe it would be good to hear the initiatives that NEF members had embarked on since 2009 to complement efforts of various governments to reduce insecurity in the part of the country.

"This is what is expected of elders and community leaders who are genuinely interested in ensuring peace in their domain.

"So, we believe that Nigerians would be curious to know what Hakeem Baba-Ahmed and his group have been doing across the 19 States of the North to ensure that the various peoples from as many as 200 ethnic groups live in peace", the statement

BMO also brushed aside suggestions by NEF that the Buhari administration had not been doing much to stem the tide of insecurity in the


"We make bold to say that the government is not unmindful of the security concerns in some parts of the country

"We have seen credible successes at the frontlines as well as massive arrests of the criminals, some of whom have been handed lengthy prison terms after a mass trial of terror suspects.

"Only recently, about 7,000 terrorists and members of their families surrendered to the military after another round of sustained air and land raids to bring the number of those who have surrendered since September 2021 to 47,975.

"Nigeria's military might on the watch of President Buhari is at an all-time high with a global ranking of 35th in the world, yet the government is also engaged in non-kinetic efforts to tackle the root causes

## Christ's resurrection and conspiracy theory of idle tale

Thile they were going, behold, some of the guards went into the city and told the chief priests all that had taken place. And when they had assembled with the elders and taken counsel, they gave a sum of money to the soldiers and said, "Tell people, 'His disciples came by night and stole Him away while we were asleep" (Matthew 28:11-13). Atthe heart of the Christian belief, doctrines and theology is the resurrection of Jesus Christ three days after He was crucified. Paul hit at the core of this statement when he wrote to the believers at Corinth that "If Christ is not risen, then our preaching is empty and your faith is also empty ... and if Christ is not risen, your faith is futile; you are still in your sin " (1 Corinthians 15:14).

In Luke 24, verse 5, the women came to beautify the body and grave of Jesus Christ with spice which they had prepared. They were asked by the angels, "why do you seek the living among the dead?" The three women and others who were asked this question included Mary Magdalene, Joana, and Mary the mother of James. Here the 'dead' are those in their tombs; the 'living' they have come to tend was Jesus Christ who unknown to them had been raised from death! Only the living preaches, speaks and witnesses. The stones used to cover graves and build sanctuaries do not. It is in this sense we are called the living stone.

The question the angels asked the women is still very relevant today. They were sceptical that Jesus Christ had risen. They had come to meet a corpse. But were taken aback and grieved that the corpse was 'missing.' But the angel told

them they were in the place of the dead. The one they sought was already among the living. They should go and seek Him there. The eleven grieving disciples also felt that Jesus' resurrection was nonsensical and an 'idle tale.' The angels said, "He is not here, but is RISEN!" the women were thus the first to preach the story of the risen Christ. And since this time, the Church has always proclaimed: He is Risen Indeed! Alleluia!! This manifests and signifies the one – Christ Jesus - on whom the Christian faith is anchored.

This incidence, Paul argued, is at the heart of Christianity (1 Corinthians 15:13-14). He goes on to explicate its necessity and importance in 1 Corinthians 15:45-50. The first Adam had a natural body that was corruptible. The second Adam, Christ Jesus, had a body that is incorruptible. Christ came to undo that which occurred at the fall of man. As a consequence of this, Peter writes, "Blessed be the God and Father of our Lord Jesus Christ, which according to His abundant mercy has begotten us again unto a lively hope by the resurrection of Jesus Christ from the dead (1 Peter 1:3).

So in the resurrection, God has offered us a 'lively hope and because of this lively hope, we are Christians with conviction. What is the Lord Jesus Christ to us? Who is Christ to us? Where should we seek Him? What meaning does His gospel give? A good number of us, by lifestyle and conviction, are still seeking Christ among the dead; but God forbid! We carry on as if Christ is neitheralivenor living with us. This attitude, and misplaced beliefin Christ's being make the difference in our Christian life."I am ready to preach the gospel to you ... for I not ashamed of the

gospel of Christ, for it is the power of God unto salvation to everyone that believes" (Romans 1:15-16). "For the preaching of the cross is to them that perish foolishness, but unto us which are saved, it is the power of God" (1 Corinthians 1:13).

Now, this is how Luke writes about the resurrection story in the face of those who were its early witnesses. "And the words seems to them as idle tale and they believe them not" (Luke 24:11). Christians are followers of Christ simply because they hold on to the actual existential reality of Christ as raised from the dead. But the challenge is one of obedience on the part of believers. "But we preach Christ crucified, a stumbling block to Jews and folly to Gentiles, but to those who are called, both Jews and Greeks, Christ the power of God and the wisdom of God" (1 Corinthians 1:23). Perhaps, the significance

of the resurrection will help us answer this question. Do we obey Him as one who is alive and living with us here and now? The women met a stone that was rolled off. But stones do not witness. It was the women and the disciples that witnessed. We are witnesses! How can we be Christ's witnesses in a world being torn apart by wars, poverty, deprivation and corruption, more so in communities that are Christian dominated?

Archbishop Justin Wilby, in his 2015 sermon explicated that: "Cathedrals and churches make great statements, but without words. Witnesses are those people who know Christ; lay or ordained, old or young, or whatever irrelevant - all are equally witnesses. The resurrection happened, and it changes our view of the universe. Once we have seen the reality of the risen Jesus nothing else should be seen in the same way as before." In his 2000 Easter sermon, Bishop Peter Adebiyistated that "this [Easter] is the time that Nigerians need our [Christian] love most, just as Jesus offered to us. A great number of people have no homes; a lot have been displaced due to religious wars, tribal and ethnic problems. As Christians, let us look beyond our own needs. Let us look at other Nigerians and offer them the hope of the gospel. Let us offer them the love of Christ, let us extend to them our knowledge of the power of the resurrection. Let us bring Christ to them in a practical way."

ligeria, being a secular state has never been in doubt. Some Nigerians are however fanatical about their faith, that they could be safely regarded as religious zealots.

According to Chief Solomon Asemota (SAN) "God has given Nigeria all it needs to grow, I am very hopeful, that this is the period for us to get out of the quagmire we have been for this long, if our religious extremists did not take undue advantage of our people's religious beliefs to perpetrate evil."

Nigeria has one of the largest populations of Christians in Africa and it is not surprising that there are many church denominations with thousands of congregations spread all over the country.

Nigeria also has a large number of Muslim faithful in Africa too.

According to a recent survey, the population of Christians in the country is slightly lesser than that of Muslims. In fact, Christianity which is one of the three major religions in Nigeria has about 48 per cent of the country's total population.

population.

While the argument as to which church in Nigeria has the highest population often goes unanswered, people tend to choose the church where they worship which of course makes their claim biased. Take, for example, Redeemed Christian Church of God, Living Faith Church Worldwide and Dunamis Gospel International, Abuja, these three Churches have one of the biggest church auditoriums in the country, this does not necessarily make them the biggest churches in Nigeria.

According to an estimate of the religious population in Nigeria in 2018, Nigeria's major religion is Islam with a total population of 53.5 percent. Over half of the country's population is estimated to be Muslims. Christian religion makes up around 45 percent of the total, with Roman Catholicism being the main branch with an estimated population of 10.6 percent. Other Christian bodies are estimated to be 35.3 percent. While other religious bodies, alongside traditional idol worshippers, are put at 0.6 percent.

idol worshippers, are put at 0.6 percent.

With the above statistics, it is obvious why Nigerians must embrace religious tolerance and peaceful co-existence for it to continue to survive as one indivisible united country.

In a recent remark in Lagos, Professor Wole Soyinka said, "With the way things are currently going in our country and around us, Nigeria is gradually seeding from humanity. As a humanist, I do not want to belong to a country that is seeding from humanity."

seceding from humanity."
On Thursday, April 7, 2022, Professor Wole Soyinka in a well-attended Media dialogue in Lagos, entitled "Forget The Past, Forget The Future; A Nation Seceding From Humanity." Cautioned Nigerians never to allow themselves again to be divided by religious extremists, who see religion as an easy weapon to put Nigeria asunder for them to achieve their aims. He said this appeal is necessary because we are once again approaching another election year.


He, therefore, appealed to all Nigerians, Muslims, Christians, Atheist and Babalawo - Native Doctors, Traditional idol worshipers, to endeavour for once in the general interest of our country, Nigeria, never again to be allowed to be divided by regions extremists, who usually see religion as an easy weapon to put Nigeria asunder during electioneering periods like the

one we are currently facing.

Professor Soyinka explained that the problem of Nigeria as we have all seen from the APC government, is not religion or ethnicity, but visionless leadership, who does not know what to do with the power they crave when they are eventually entrusted with power after several attempts.

Mr. Femi Falana (SAN) and Chief Solomon Asemota (SAN) were on hand that day, to join Professor Soyinka in the media chat.

Chief Asemota (SAN) in one of his interventions on that day, painted a graphic picture, as the Chief Prosecutor and Defendant for the Nigerian Government during the infamous religious riots led by one Muhammadu Marwa aka 'Maitatsine' in the 1980 religious civil disobedience in Kano, which he said could guide Nigerians never again to fall into such ugly pit-fall. He, therefore, appealed to all Nigerians never again should they allow religious extremists under any guise to use them

to set the country on fire.

Chief Asemota shared some of his experiences as follows, "I used to do battle with the late Chief GaniFawehimi and Falana. I was the Chief Prosecutor and Defendant of the Nigerian Government in the time past. Because of my experiences on the job at that time, I was able to see things differently from the likes of Falana. It was because of the theme of this dialogue "Forget The Past, Forget The Future, A Nation Seceding from Humanity, that "I pleaded that I should be allowed to make some comments here, I am happy that Prof Wole Soyinka granted me the permission.

"I will tell stories, but just briefly. In 1982, I was the leading Counsel in Justice Aniagolu's Inquiry in Kano. After the inquiry, the report was prepared, but before ex-President Shehu Shagari could implement the report, he was overthrown by the Military Junta led by then General Muhammadu Buhari. And what happened then, was that after assuming power as Nigerian Head of State, General Buhari succeeded in uniting all the Islamic groups that were fighting then, which resulted in the ugly Maitatsine religious unriging.

"It was after this particular incident, I believed, I may be wrong, that was when Buhari got his 15 million fanatical religious supporters across the Northern region, which he still has till this day.

But the question we ask is simple, who is going to succeed Buhari as Nigeria's President? Is the person going to be a Northerner? If he succeeds him, will the new President be able to change some of the things we have been complaining about him? Or if he is a Southerner, who is a Muslim, will he offend? The reason why all these things are important is that, when we were still with the Colonial Masters as subjects, we all knew, we only had one system, and the system was as provided by the Colonial Masters. There was a very interesting aspect when customary law was tested against equity and natural justice. In areas where the customary law was found not fit into equity and natural justice, the customary law is not accepted.

"The present popularity is such that, I do not think, and I want to be quoted, that if a Northemer succeeds President Buhari, he will be able to solve all the problems we are presently having. Also, if a Southern Muslim succeeds him, it will be very difficult because the dichotomy in the way Nigeria is being governed has been well established. So people presently saying, the North has so many years of this or the South has so many years of that, needs to think very carefully.

Well, I am a Benin man and I was born in Benin City. But my first language was Ibo. My mother took me and got married to an Okwale man. As they were speaking Kwale, I picked it up. This was in Jos, Plateau state, and I attended St Paul's school. I then went to St Luke's School, which was dominated by Yorubas or foreigners then in Jos. It was there, that I learnt my Yoruba

even in Jos, I also learnt how to speak the Hausa dialect fluently in Jos.

"I am completely against anybody who suggests that this country should be broken up. Please do not take it at face value when people begin to tell you, we have spent these numbers of years, they have spent these numbers of years in power. The question to be asked then, is how well did they spend it? Other questions that need answers as we approach another election year, is, must we now go and vote for someone, who killed so many of us Nigerians, when he was in power, or the one who made life very difficult for Nigerians while occupying the presidency. We should further encourage those people, by voting someone or people from their areas as our next president.

"The present situation Nigerians are facing is like the story of a Major in the Nigerian Army, who was alleged to have known, about a planned coup de'tat, as expected of an office of his rank, he quickly rushed to inform his superior officer, his Commandant about what was in the offing. Not knowing that the Commandant, he went to report the matter to was part of the coup planners. He was immediately arrested and put into detention until after the coup. He was later released to continue in the army. At another time, he again got to know about a coup to be staged, this time around, based on his past experience, he refused to make any report. He was again arrested, tried and executed, for having knowledge of the coup but refused to make a formal report. If one may ask, what type of justice is that?

"The above scenario reflects our country and it also reflects what is happening today in Nigeria. In the case of the late Sheikh Gumi, the father of the present Sheikh Gumi, I know him, because he was part of Justice Aniagolu's Panel of Inquiry. We all can see the type of preferential treatment he was being given, for virtually doing the same thing, as his late father did at that time in a different way.

"From all indications, the Nigerian government is presently running two systems, and any country with two systems, cannot succeed. The late Sardauna of Sokoto made sure he sent people round the world, and it took everything concerning Islam into consideration before the Penal Code of Northern Nigeria was passed into law. The Penal Code is identical and he considered everything about Islam because we were under the British Colonial Masters at that time, they ensured that we still had one Nigeria and one system of governance. But today, they have changed all this.

"The boundary between North and South for God's Sake, can any Nigerian physically show it to me where these boundaries are located? But sadly, it is so entrenched today, that even the boundary between Russia and Korea is not as firm as the one, we have, between the present North and South, even though we cannot see it. Why? Because people take advantage of bad situations and use them for their selfish gains.

Nigeria is not based on a tripod plus the Yorubas and Hausa-Fulanis. I will plead, that we minority tribes should be left out of these dangerous games they are presently playing! Leave us the minority tribes out of this dangerous scheming, which makes no sense!

For example, during the First Republic, the minority of Edo extraction also had Cocoa, Palm Oil, and Rubber plantations and made contributions to the South West. But we never had a fringe of what is today known as the Cocoa House in Western Nigeria, what did we do wrong then? Absolutely Nothing! The point is that these things all must be rectified. One, when I was a former student in those good old days, the Local Government Area Council in Benin used to grant scholarships. And I had so many of my friends, who got scholarships from the then Local Government Area Council. Today, Local Government Councils are no longer functioning. These have no doubt affected our morals and whatever we do.

"If the Local Government Area Councils were functional, at my age today, instead of looking forward to becoming a Nigerian President, or Governor in my state, I will rather prefer to go and be the Chairman of my Local Government Area Council, so that I can help my community grow, so that, they can help to bury me properly whenever the time comes."

In the Catholic church which has one of the largest Christian followers in Nigeria, two of its Cardinals, Francis Arinze and John Onaiyekan, have done a lot of work on religious tolerance, and peaceful co-existence between the Christians and Muslim communities in Nigeria.

Cardinal Arinze's literary works such as "Sacrifice in Ibo Religion, Ibadan University Press (Ibadan Nigeria) 1970. Christian and Politics, Tabansi (Onitsha), 1982. Answering God's Call, Chapman (London) 1983. Living Our Faith, Tabansi (Onitsha) 1983. Alone with God, Tabansi (Onitsha) 1986. Church in Dialogue Walking with Other Believers, Ignatius (San Francisco, CA), 1990 and Gospel to Society Optimal Computer Solutions (Nsukka Nigeria), 1990.

Most of these books by Cardinal Arinze are

Most of these books by Cardinal Arinze are centered on how to have harmonious, frictionless free relationships between Christians, Muslims and other religions in the same space as Nigeria.

Today, Cardinal Arinze is the oldest surviving Catholic Cardinal in Nigeria. Cardinal of the Holy Roman Church is a senior member of the clergy of the Catholic Church, they are immediately behind the Pope in the order of precedence. Collectively, they constitute the College of Cardinal and are appointed for life.

Their most solemn responsibility is to elect a new pope in a conclave, almost always from among themselves (with a few historical exceptions), when the Holy See is vacant. During the period between a pope's death or resignation and the election of his successor, the day-to-day governance of the Holy See is in the hands of the College of Cardinals. The right to participate in a conclave is limited to cardinals, who have not reached the age of 80 years by the day the vacancy occurs. In addition, cardinals collectively participate in papal consistories (which generally take place annually), in which matters of importance to the Church are considered and new Cardinals may be created. Cardinals of working age are also appointed to roles overseeing monasteries of the Roman Curia, the central administration of the Catholic Church.

Nigeria has since independence had four Cardinals in the Catholic Church. The first Catholic Cardinal from Nigeria, was Dominic Ignatius Ekandem, who died in 1995 at the age of 78 years. Followed by Francis Anizoba Arinze, who will be 90 years on November 1, 2022. He is an expert on Christian/Muslim dialogue. He spent most of his professional life in Rome, and is now retired.

Anthony OlubunmiOkogie, who will be 86 years on June 16, 2022, is also retired and was the Archbishop of Lagos Archdiocese for 39 years.

On October 24, 2012, Pope Benedict XVI appointed the then Archbishop of Abuja Archdiocese, John Onaiyekan, who is now 78 years old and five others as Cardinals.

Archbishop Onaiyekan is the youngest of the Nigerian Catholic Cardinals. He is known for his peace and reconciliation work across the bitter Christian/Muslim divide. These are men other religious leaders must emulate, for our country, Nigeria to survive, and prosper in peace and harmony.

## Nigeria overtakes Iraq on number of ISWAP attacks

slamic State – West Africa Province or ISWAP is a Salafist jihadist militant group, administrative division and affiliate of the Islamic State in Iraq and the Levant (ISIL). The objective of ISIL is to establish a caliphate control and govern the Caliphate, expand Islam and Sharia Law worldwide and recreate the power and glory of Islam. With the loss of ground in Iraq and Levant, ISIL cashed in on the pervading corruption, poor governance, poverty, local grievances, youth population bulge, resentment of heavy-handed and extrajudicial police and military actions against extremism that exists in many African countries to expand to the continent.

This expansion into Africa was done covertly. ISIL identifies a country with weakened national institutions, a fledgling insurgent group and a history of social injustice, then makes overtures to the militant groups in the target clime with the allure of financial and materiel support and a request for an oath of allegiance. The plan of action serves two purposes: to fast track insertion into the target jurisdiction without going through the hassles of local recruitment and to acquire its operating base. This was the case of ISIL intrusion into Nigeria, Mali, Somalia, Burkina Faso, etc.

ISIL was introduced into Nigeria in March 2015, when Abubakar Shekau's group, Jama'atu Ahlis Sunna Lidda'Awati Wal-Jihad (Boko Haram), pledged allegiance to ISIL and changed the group's name to Islamic State West Africa Province (ISWAP). ISIL accepted the pledge the same month. However, an internal dispute on account of differences in objectives and leadership style later fractured the group. ISIL recognized another leader in 2016, and Shekau's faction reassumed its original name, continuing to be commonly known as Boko Haram. ISWAP killed Shekau and almost wiped out or co-opted most of the Boko Haram adherents in Sambisa forest and took over the forest as its base.

This marked the coming of the ISWAP brand of terrorism in Nigeria. ISWAP distanced itself from the indiscriminate violence that came to characterize Boko Haram, renouncing the killing of Muslim civilians and vowing to focus attacks on Christians and state targets. It reportedly started providing some state-like services (e.g., basic law enforcement) in its areas of operation to win the hearts and minds of the local population. By 2020, it was assessed that ISWAP had outstripped Boko Haram in size and capacity and was operating with a degree of success including conducting raids on security forces, which have yielded significant war spoils in the form of materiel and other supplies. All these indicate, from the very beginning, that ISWAP may prove to be a more resilient threat than Boko Haram. ISWAP's efforts to build legitimacy in areas it governs and its reputedly strong resource base, which are in tandem with IS global objectives, were the initial pointers.

By January 2022, ISWAP Nigeria is estimated

to have 4,000-5,000 fighters and it tops the attack chart of all IS formations with 162 attacks. The group has attacked military facilities, killed soldiers, looted materiel and funds itself through raiding, kidnapping for ransom, and taxing local populations and commerce. Since 2020 more than 11,000 schools have been shut down in Northern Nigeria with over 2,968 persons killed and 1,484 abducted in the same period. Furthermore, amid rising insecurity in parts of northern Nigeria by the presence of bandits and pervading farmers/herdsmen acrimony there is a mounting concern of convergence of the ISWAP threat and the others. Additionally, United Nations (UN) investigators report that ISWAP Nigeria has links to another IS faction, known as IS-Greater Sahara, which is active in Burkina Faso, Mali, and Niger, although each group appears primarily focused on local aims, the platform can used for transfer of tactics

and knowledge.

The modus operandi of ISWAP Nigeria, just like the mother ship, ISIL, remains to take advantage of fragile states with the aim to supplant them. It brings to the fray resources, experience, knowledge from foreign terrorist fighters and the disposal of the organisation. In Nigeria, the writing is on the wall, ISWAP is now in the process of forging an alliance with the bandits in the north. This will lead, predictably, to increase in attacks, raids and kidnap for ransom in the first instance because financial strength is very important to ISWAP and quest for territorial control in the medium term and finally the destruction or co-option into ISWAP of the bandits in the long term for the organisation to carve a niche for itself in furtherance of ISIL objectives.

To avert this impending disaster, national institutions must be strengthened, morale in the security sector must be raised. Furthermore, social services and social justice must be entrenched. One of the favourite tactics of ISIL and by extension ISWAP Nigeria is to win the hearts and minds of the local population in areas they operate to ensure secrecy and loyalty. Therefore, it is imperative that the FGN engages in similar tactics for the same purposes urgently.







## Anxiety mounts in southeast as gunmen attack police station, registration center

- Police kills deadly gunman, recovers rifle, others in Anambra
- INEC suspends voters' registration as Gunmen kill official in Imo

There is tension and anxiety in the southeastern part of the country as gunmen suspected to be members of the proscribed Indigenous People of Biafra (IPOB) and the Eastern Security Network (ESN) are currently on rampage attacking public facilities and officials.

Operatives of the Anambra State Police Command in the wee hours of Thursday foiled an attack on the Nteje Divisional Headquarters, Oyi Local Government Area by hoodlums and killed one of the deadly gunmen as others fled the scene.

During the operation, one type 06 rifle, one magazine and fifty-three live ammunitions of 5.56mm as well as charms were recovered by

the operatives, The Trumpet gathered.

The State Police Public Relations Officer, DSP Ikenga Tochukwu, confirmed the attack on Thursday in a statement obtained by The Trumpet.

He said the state Commissioner of Police, CP Echeng Echeng, led the crack squad while responding to a distress call on the attack of

the station by the deadly gang.
He said, "Anambra Police Operatives led by CP Echeng Echeng on 14/4/2022 at about 3 am foiled an attack by gunmen at Nteje Divisional headquarters Oyi LGA. The Operatives recover one type O6 rifle, one magazine and fifty-three live ammunition of 5.56mm and

"The Commissioner of Police CP Echeng, led the crack squad when responding to the distress call as the station came under attack by the deadly gang. The Police Operatives decisively dealt with the assailants.
"During the gun duel, one of the gunmen

was neutralised and due to the superior fire of the Police Operatives made the assailants fled the scene. The station was secured and all police operatives and arms are intact.

"The CP while reiterating that the Command will not relent in delivering on its mandate on protection of life and properties, commended the Officers and Men of the Command for their perseverance and painstaking efforts to weed out all criminal elements in the State.'

Meanwhile, gunmen on Thursday attacked a voters registration center of the Independent National Electoral Commission (INEC) in Imo State and killed one of the officials.

Two other staff involved in the attack during the registration exercise at the polling unit are also said to be missing. INEC said it was making efforts to locate their whereabouts.

Following the attack, which lasted for several minutes, INEC suspended the Continuous Voter Registration (ĈVR) exercise in Isinweke, the headquarters of the Ihitte/ Uboma Local Government Area of the state, where the ugly incidence happened.
It was learnt that INEC Adhoc Staff were

registering members of the community for the 2023 general elections when the gunmen stormed the venue and launched the attack.

INEC National Commissioner, Festus Okoye, who announced the voter's registration suspension in the council, said the decision was taken following the attack on INEC and its officials, which left one dead.

According to Okoye, the staff, Mr Nwokorie Anthony, was shot dead at Nkwo Ihitte (PU 004) in Amakohia Ward (RA 02) of Ihitte Ubóma Local Government Àrea.

"Prior to this incident, the Commission had suspended the CVR in Orsu and Njaba Local Government areas of the State on account of insecurity while the exercise is taking place only at the INEC LGA office in Oru East, Oru West, Orlu and Ohaji – Egbema Local Government Areas of the State," Mr Okoye

He added that "The Commission extends its condolences to the family of Nwokorie Anthony and prays that God will grant them the fortitude to bear the loss. The incident has been reported to security agencies to unravel the circumstances that led to this unfortunate incident and bring the culprits to justice.

We enjoin the President General of the various Town Unions in Imo State as well as all the critical stakeholders to protect staff of the Commission engaged in national assignment. The safety and security of staff is of paramount importance to the Commission, particularly with the devolution of the voter registration exercise beyond our State and Local Government Area offices nation in our determination to serve Nigerians better.'

#### Army nabs 12 suspected impostors in Lagos, Ogun

Officers of the 81 Division Nigerian Army Military Police during 'Operation Checkmate' within Lagos and Ogun states, arrested about 12 suspected impostors fully kited in military camouflage uniforms

Acting Deputy Director of 81 Division Army Public Relations, Major Olaniyi Joseph Osoba, made the disclosure on Wednesday in a statement, adding that about 150 impostors have been arrested by the Army from January last year to date.

He further explained that preliminary investigation revealed that some of the suspects specialized in mounting roadblocks along Ajah Road to extort money from motorists as well as indulge in other illegal duties while dressed in Nigerian Army

Camouflage uniforms.

Major Osoba said, "The General Officer Commanding (GOC) 81 Division Nigerian Army (NA) Major General Umar Thama Musa in a press briefing dispelled the unfounded narrative that all illicit acts committed by persons dressed in military uniforms are always military personnel. He noted that persons displaying military banners and accoutrement such as belts and stickers on vehicles and driving commercial vehicles in military uniform as well as driving civil vehicles painted in Army colour are most often not personnel of the Nigerian Army.

'He said in an effort to curtail this ugly trend, the Division has heightened the activities of OPERATION CHECKMATE to ensure regular

#### Easter: **Security agencies** move to protect Christians, worship centers

As Christians across the federation begin the celebration of Easter, major security agencies in the country such as the Nigeria Police Force (NPF) and the Nigeria Security and Civil Defence Corps (NSCDC), have vowed to protect Christians, worship centers and other critical public facilities against attacks by terrorists and criminals.

The Inspector General of Police, IGP Usman Alkali Baba, on Thursday ordered intensive security patrols in all public places and critical national assets.

Acting Force Public Relations Officer, CSP Olumuyiwa Adejobi, in a statement forwarded to The Trumpet on Thursday night said the move is to ensure "crime-free Easter celebrations." Adding that the IGP specifically ordered all State Commissioners of Police (CPs) and their supervising Assistant Inspectors-General of Police (AIGs) to "ensure adequate deployment of police personnel, and operational assets to areas of security interest within their respective areas of responsibility (AoRs).

According to CSP Adejobi, "The IGP equally ordered that supervising officers should ensure confidence-boosting, proactive, and high visibility patrols are carried out along the highways, motor parks, train stations, airports, worship centres, recreation centres, banks, and other financial institutions while taking adequate measures to provide a peaceful, crime-free, and enabling environment for religious, cultural and other socio-economic activities to thrive.

"In addition, the Commissioners of Police and their supervising AIGs have been directed to ensure proper supervision of the men assigned for these assignments. They must be professional and courteous to law-abiding citizens but firm and ruthless to criminal elements who might want to take the advantage of the festive period to perpetrate their unholy acts.

"To this effect, the IGP Monitoring Unit

and X-Squad have been given marching orders to monitor and police activities of police officers policing the highways to ensure respect for the rights of citizens and operational conformity with the Standard Operating Procedures (SOP) and Rules of Engagement (RoE) of the Force; the Complaint Response Unit, vis-à-vis Public Complaint Bureau, have equally been charged to respond swiftly to complaints received from the general public."

#### NDLEA secures conviction of 677 drug traffickers in Q1

■ Rehabilitated 2,223 drug users across the country ■ Arrested 3,359 drug traffickers ■ Seized 65,915.891 kilograms of hard drugs

The National Drug Law Enforcement Agency (NDLEA) said it secured the conviction and sentence of 677 drug traffickers between January and March 2022.

The NDLEA Director of Media and Advocacy, Femi Babafemi, made this known while presenting the Commission's first quarter report on Wednesday. Adding that about 2,223 drug users were also counselled through brief interventions and were rehabilitated in NDLEA facilities across the country within the same period.

Babafemi also revealed that a total of 3,359 drug traffickers and dealers were also arrested in the first quarter while saying that 65,915.891 kilograms of assorted drugs were seized within the same period.

The report said Lagos has the highest number of drugs seized with 22,192.62 kilograms of drugs recovered within the state, followed by the Murtala Muhammed International Airport (MMIA) Command,

Ikeja, also in Lagos, with 8,979.869kg.

He said, "As the National Drug Law Enforcement Agency, NDLEA, intensifies the war against illicit drug trafficking and abuse across Nigeria, no less than Six Hundred and Seventy Seven (677) traffickers have been convicted and sentenced to various jail terms between January and March 2022, with a total of Three Thousand Three Hundred and Fifty Nine (3,359) arrests and 65,915.891 kilograms of assorted drugs seized within

the same period.

"No fewer than Two Thousand Two Hundred and Twenty Three (2,223) drug users were also counselled through brief interventions and rehabilitated in NDLEA facilities across the country in the first quarter of the year; figures that represent a fair balance between the Agency's drug supply reduction and drug demand reduction activities.

Affem, has upheld the appeal of the Economic and Financial Crimes Commission (EFCC) and dismissed the ruling of a Federal High Court in Lagos in the case involving a former Executive Director, Projects, Niger Delta Development Commission (NNDC) Tuovo Omatsuli, over an alleged case of money laundering to the tune N3,645,000,000.00

Justice Festus Obande Ogbuinya in his judgement held that the ruling of the lower court dated November 11, 2020, discharging the respondent, Omatsuli, of the money laundering charges "is hereby set aside and he shall enter into his defence accordingly on the same counts."

The Appellate Court, however, discharged Omatsuli on counts 27, 28 and 29 of the

Omatsuli is facing trial alongside Francis

Momoh, Don Parker Properties Limited and Building Associates Limited on an amended 45-count charge bordering on conspiracy and money laundering to the tune of N3,645,000,000.

One of the counts reads: "That you, Engr. Tuoyo Omatsuli, Don Parker Properties Limited, Francis Momoh and Building Associates Limited, between August 2014 and September 2015 at Lagos, within the jurisdiction of this Honourable Court, conspired to disguise the illegal origin of N3,645,000,000 (Three Billion Six-Hundred and Forty-Five Million Naira), being proceed of unlawful activity to wit: corruption and gratification; and thereby committed an offence contrary to Section 18 of the Money Laundering Act 2011 as amended by Act No 1 of 2012 and punishable under Section 15 (3) of the same Act."

Another count reads: "That you, Engr Tuoyo Omatsuli, between August 2014 and September 2015 at Lagos, within the jurisdiction of this Honourable Court, did procure Francis Momoh and Building Associates Limited to use the total sum of N3,645,000,000 (Three Billion

Six-Hundred and Forty-Five Million Naira) paid by Starline Consultancy Services into the Diamond Bank Plc Account No. 0023785116 operated by Building Associate Ltd when you reasonably ought to have known that the said sum formed part of the proceeds of your unlawful activity to wit: Corruption and Gratification; and you thereby committed an offence contrary to Section 18 of the Money Laundering Act 2011 as amended by Act No 1 of 2012 and punishable under Section 15 (3) of the same Act."

The defendants pleaded "not guilty" to the charges.

In the course of the trial, the prosecuting counsel, Ekene Iheanacho, had called 16 prosecution witnesses, the last being Segun Temitope, a staff of the Special Control Unit against Money Laundering (SCUML) who gave his testimony on July 7, 2020.

Rather than open their defence, however, the defendants filed a no-case submission, which was heard on October 12, 2020, while the ruling was reserved till November 11, 2020.

Justice Saliu Saidu in his ruling on November 11, 2020, discharged the first defendant, Omatsuli, saying, "I have gone through the charge preferred against the defendants as well as the evidence of all the 16 prosecution witnesses and I found no reason for the first defendant to enter the defence.

"Accordingly, the first defendant is hereby discharged.'

The Judge, however, held that the other defendants had cases to answer.

Dissatisfied by the judgement, the EFCC appealed the ruling of the lower court.

While dismissing the judgement, the Appellate court, also dismissed the applications of Momoh and Building Associates Limited seeking to set aside the ruling of the lower court on their no-case submission.

However, the appellate court, in its ruling affirmed the ruling of the lower court on the no-case submission filed by both Momoh and Building Associates on the grounds their appeal "is bereft of merit" and ordered them to enter their defence accordingly.

Five new Board members of the Independent Corrupt Practices and Other Related Offences Commission (ICPC)have resumed duties at the Commission after their swearing-in by President Muhammadu Buhari.

The new board members are Senator Anthony Agbo from Ebonyi State who is representing the South-East zone of the country, Anne Otelafu Odey, from Cross River State, (South-South) and Alhaji Goni Ali Gujba, from Yobe state, (North-East).

Others are Dr Louis Solomon Mandama, from Adamawa State, (North-East) and retired Assistant Inspector General of Police, Olugbenga Adeyanju, from Ekiti State, (South-West).

The Trumpet recalled that the appointment of the new Board members was confirmed by the Senate on Wednesday 9th March, 2022.

During a reception meeting at the Commission's headquarters in Abuja, the Chairman of ICPC, Professor Bolaji Ówasanoye SAN, commended President Buhari for identifying people with rich backgrounds in the public sector to be appointed into the Board.

While informing the new Board members that their appointments have changed their status, Owasanoye enjoined them to put forward their proven integrity and experience towards achieving the mandate of the

"ICPC is an integrity organization and the standard here is higher than the normal. What others do and get away with, if we do it, will be big news.

"Your status has changed with your appointment and I am happy that all of you have a rich stint in public service.

"We have a rich blend that will help us achieve the mandate of the Commission. We should not get administration wrong when we have a rich blend of professional administrators to guide our mandate," the ICPC boss said.

The new Board members who took turns to speak expressed their readiness to help combat corruption and project the good image of the Commission and the Country.

Hon. Odey, a retired Permanent Secretary in the Cross River State government, who

spoke first assured that she will work as a family with the Board, management and staff members of the Commission to project the aims of ICPC.

Also speaking, Dr Mandama, a retired Permanent Secretary and one time Head of Service in Adamawa State gave the assurance that he will bring his wealth of experience as an administrator to the Commission to aid the fight against corruption.

On his part, retired AIG Adeyanju, who left the police service in February 2021, noted that as a proven investigator and having headed the biggest investigation department in the Nigeria Police, he was ready to listen to people and project the good image of Nigeria through ICPC.

Another board member and former Permanent Secretary, Alh. Gujba said the new members will add more value to the Commission, coming from different parts of the country with diverse experiences. He pleaded for cooperation and patience from the chairman and the old board members to enable them to work as a family towards achieving the goals of the Commission.

Another count reads: "Kayode Odukoya, First Nation Airways Limited and Bellview Airlines Limited, on or about the 7th day of October, 2016 in Lagos within, the Lagos Judicial Division, dishonestly converted to your use the sum of N1, 742,994,962.04 (One Billion, Seven Hundred and Forty-one Million, Nine Hundred and Ninety-four Thousand, Nine Hundred and Sixty-two Naira, Four Kobo) property of Skye Bank Plc."

At the sitting which was held on April 13, the defence counsel, E.D. Onyeke, moved the application dated April 1, 2022, on behalf of his client, seeking an order of the Court for the release of his passport deposited with

"It is to enable him to renew same in order to travel to the United Kingdom for his son's graduation at the University of Kent on May 17," he said.

He further informed the Court that the said application had also been served on the prosecution.

Confirming the said position, the prosecuting counsel, Nnaemeka Omewa, raised no objections but left the decision to the discretion of the Court.

"Out of caution, the prosecution will want the defence counsel to take special undertaking that the defendant will be available at the next adjourned date," Omewa said.

Ruling on the application, Justice Dada, granted the prayers of the defence and ordered that his passport be released to him.

"The defendant must return the international passport to the Commission on or before the 23rd of May, 2022," the trial judge ruled.





#### Ogun first lady flays counterfeiters, commends Ecobank for promoting local products

**7**ife of Ogun State Governor, Bamidele Abiodun, has condemned the activities of the counterfeiters and their foreign collaborators in the country, saying they are sabotaging the nation's economy.

Abiodun said Adire fabric, which is produced mostly in Ogun State, was being massively counterfeited by some unpatriotic Nigerians with their foreign collaborators and that if not checked, it was capable of killing local producers and charged the Standards Organisation of Nigeria (SON) and other government agencies to tackle the menace.

Abiodun also pleaded with the agencies to address the issue of intellectual theft bedevilling the country, as she commended Ecobank Nigeria Limited for supporting the just concluded Adire market week, in Abeokuta, the state capital.

In her welcome address at the event, which was organised by her office in conjunction with the Ajose Foundation, noted that the unfair practice of counterfeiting was impacting negatively on the sector, adding that the situation had led to many people abandoning the trade.

"Foreign manufacturers, aided by Nigerian middlemen take away original, handmade Adire designed from Nigeria, mass produce them and sell them cheaply to Nigerian markets around the country. The effect of this is that makers of authentic Adire are unable to compete with the cheap print alternatives.

"An industry that employs thousands of Nigerians across the value chains is in dilemma, while many have cut back on production. Others have considered abandoning the trade altogether, even though it has been in their families for generations," she said.

Abiodun explained that the Adire Market week was meant to build on the gains of the successful launch of the adireogun.com to promote financial inclusion for women-owned businesses, enhance the tourism potential in the state and to further help Ogun State continue to set the pace as the Adire capital of the

Speaking on the initiative, Managing Director of Ecobank Nigeria, Bolaji Lawal, who was represented by Head of Agency Banking, Nike Kolawole, said the bank identifies Adire as a key driver of tourism, culture

#### AFAN to donate 500,000 tricycles for transportation of farm produce

President of the All Farmers Association of Nigeria (AFAN), Alhaji Sheu Mudi, has disclosed plans of the association and its partners to provide 500,000 units of tricycles for farmers to aid the transportation of farm produce in the country.

He made this known when some representatives of Nigerian companies and their South Korean counterparts visited the Minister of State for Agriculture and Rural Development, Mustapha Shehuri, in Abuja stressing that the development would create direct and indirect jobs for over two million members of the association.

"This will empower youths and farmers to reduce stress and cost of transportation of produce and in turn reduce the cost of food items," he said, adding that one of the association's partners would establish tricycle assembly plants in the six geopolitical zones of the country to create employment opportunities for the country's teeming youths.

Shehuri said the use of tricycles would ease the difficulties faced by smallholder farmers in the transportation of their produce, maintaining that the use of tricycles would ensure easy movement of food and agro-allied products and generate wealth for Nigerian farmers.

He said the Nigerian agricultural sector has huge potential to drive the country's economy, adding that the Nigerian market was massive across value chains and that the use of tricycles would help Nigeria in food distribution, food sufficiency

and export of agricultural produce. He appealed to the leadership of AFAN and other stakeholders in the agricultural sector to ensure that the tricycles on offer match the requirements of the small holder

There is no point bringing in tricycles without inputs by the end-users: please, the small holder farmers must have inputs for the initiative to achieve its objectives and goals," Shehuri stressed.

The minister urged the association to ensure that there is synergy between the federal, state and local governments in carrying out its programmes, adding: "There should be a robust collaboration between the three tiers of government and AFAN because all the relevant stakeholders must streamline policies and programmes to achieve food and nutrition security and boost the economy."

## High energy cost forces companies to run skeletal services

### As First Bank reduces operating hours

As the Russia and Ukraine war rages, Nigerian firms continue to take 'the bullets' as most local companies are gasping for survival. Findings during the week showed that nearly all firms from the Micro, Small and Medium Enterprises MSMEs) and bigger firms have reduced their operating hours from 24 hours to about eight or 12 hours.

While banks, insurance, agencies and other service support firms have cut their working hours from eight to about five hours daily, most MSMEs and manufacturing firms now run one shift of 12 hours instead of 24 hours and two shifts.

Some firms that use heavy diesel-powered generators have now bought smaller generators that use petrol.

Checks by The Trumpet showed that instead of some ganisations using one heavy duty generator that uses diesel now resulted in buying smaller generators that use petrol to cut

Findings by The Trumpet also showed that some of the smaller generators are unable to power most of the equipment and heavy air-conditioners, while some categories of employees have been asked to work from home as others have been asked to report for work for three days

Investigations also revealed that many workers were being asked to go home until the situation improves.

It would be recalled that crude oil that was sold for about \$70 in early February 2022 rose sharply to about \$140 per barrel at the commencement of the Russia and Ukraine war in late February and although a barrel of crude oil now sells for about \$120, diesel is currently sold for between N600 to N700 per litre.

The high cost of diesel also occurs during the period the country is experiencing constant collapse of the national grid, just as checks showed that the national grid collapsed four times between March and April this year, which threw the entire country into total darkness for several days.

While the high cost of diesel and epileptic power supply threaten businesses in the country, Director General of the Manufacturers Association of Nigeria (MAN), Olusegun Ajayi-Akadir, told The Trumpet in a telephone interview that the epileptic power supply and high cost of diesel have wiped away the little gain the manufacturing sector recorded last year after the COVID-19 pandemic.

He disclosed that many of his members were daily closing their shops due to the harsh operating

environment. He, therefore, appealed to the Federal Government to assist the manufacturing sector and businesses in the country by ensuring that the challenge of the national grid is settled once and for all.

Nigeria, Africa's highest producer of crude oil and one of the top 15 global major crude oil producers, has been unable to refine its abundant crude oil and provide stable public supply despite spending huge amounts of money on its energy sector over the years.

Meanwhile, First Bank Nigeria Limited has reduced the time of business transactions with its customers in most of its branches across the country to cut its energy costs.

A few days ago, the bank sent an SMS to some of its customers about its plans to review its business hours in most of its branches, with effect from Monday, April 11, 2022.

In a statement issued by the bank, it stated the time review was staggered and subjected to the volume of operations across different branches and outlets of the financial institution.

"We have revised our banking hours across all our locations. The revised opening and closing hours will be effective from Monday, April 11, 2022. Our alternative and digital channels are available and accessible 24 hours per seven days anywhere and anytime to meet your banking needs,"' the bank said in its communication. Findings showed that some branches were to open between 8:00a.m to 1:00 p.m daily, others

were to open between 8:00 a.m and 2:00 p.m.

Findings by The Trumpet during the week showed that,

in Ikeja and its environs closed Reports have it that some branches across the country were operating between 8:00a.m and 1:00 p.m.

while some banks in Ikorodu

and its environs opted to close

at 2:00 p.m, some of the branches

Some customers of the bank who did not receive the SMS on the bank's directive were livid when they visited their branches only to be told that the bank had closed for the day instead of the normal 4:00p.m closing hour.

A source in the bank, who spoke on the condition of anonymity, explained that the management of the bank decided to reduce the operating hours due to the high cost of diesel, which is the alternative source of power.

"With the current price of diesel, it only makes sense to review our operations and the number of hours we do business daily. As you know, most of our branches run on alternative power supply, otherwise, we will be failing in our services to our customers and the banking public, hence the decision.

## Access Bank acquires First Guarantee Pension Funds Administrator

One of the country's leading financial institutions, Access Bank Plc, has acquired 75 per cent stakes in First Guarantee Pension Funds Administrator (PFA) in a deal concluded last week in Abuja and subject to all regulatory approvals.

The Trumpet learnt that the Access Bank's acquisition of 75 per cent shares followed a rigorous process and discussions at the board of the two organizations, just as most shareholders of the First Guarantee PFA were warming up to go into politics as the 2023 elections draw nearer.

An insider to one of the parties to the acquisition revealed that the Access Bank acquired the PFA to boost its dominance in the country's financial sector, adding that the bank identified the PFA firm as a viable concern to enable it to dominate in the PFAs sector

Checks, however, showed that most employees of the First Guarantee PFA were apprehensive of what their fate would be when Access Bank fully takes over the running of the firm.

## SON laments restricted access to bonded terminals, markets, rising importation of arms

•As port users seek reversal decision on SON's exit from ports

Director General of the Standards Organisation of Nigeria (SON), Farouk Salim, has lamented the inability of agencies to track the importation of substandard goods into the country.

He stated this at a maritime stakeholders' sensitisation forum with the theme: Standards Save Lives, Grow Economy and attributed the escalating insecurity in the country to the importation of substandard goods through the nation's ports.

Salim lamented that restriction of access to the ports, bonded terminals and major markets was an avenue for importing arms and ammunition used in escalating insecurity in the country.

His words: "We don't have access to bonded terminals and people use bonded terminals to import arms and ammunition, which bandits and terrorists use to fuel insecurity in the country. We also don't have access to major markets. When our officials go to seek

information, they are attacked and injured in the process. This is limiting our ability to track illicit importations."

Salim noted that the essence of the sensitisation with stakeholders was to communicate and share views on how to make businesses more efficient.

Meanwhile, clearing agents operating at the Lagos ports have canvassed reversal of the executive decision banning SON from the ports to check the importation of substandard goods into the country.

Vice President of the Association of Nigeria Licensed Customs Agents (ANLCA), Dr Kayode Farinto, noted that if the country must win the war against importation of substandard goods in the country, there was a need to return SON to the seaports.

Farinto, who spoke on Juxtaposing Substandard Imports: SON's Absence At The Seaports, insisted that since the agency vacated the seaports with the Federal Government's intention to allow its regulation outside the ports, there has been increase in the importation

of substandard goods.

He said the effort of some nonconformists also showed that there was the need to reverse the executive decision, if Nigeria must win the war against the importation of substandard goods in the country, noting that if the trend was not checked urgently, it might affect the economy and the nation's revenue generation.

Farinto said if stakeholders must achieve ease of doing business, freight forwarders and customs brokers should do away with dishonest declarations, such as concealment, and inaccurate descriptions of imports and exports, to circumvent the procedures, which he described as an impediment to achieving ease of doing business.

On his part, the President of the National Association of Government Approved Freight Forwarders (NAGAFF), Tochukwu Ezisi, who was represented by his Chief of Staff Emma Agunbaze, urged SON to engage stakeholders more, which he said, was crucial to improving accountability in the organisation and its external audiences.

He said stakeholder engagement would further ensure proper consideration of interests and commended the SON for embracing the ease of doing business in the country.

### Largest vessel laden with agricultural commodities berths at Onne port

The Nigerian Ports Authority (NPA) has said the successful berthing of MV Lady Jane, the largest container vessel with 50 per cent agricultural commodities at the West Africa Container Terminal (WACT) in Onne Port, Rivers State, has proved its readiness to consolidate on the gains of container vessel traffic in the eastern ports.

MV Lady Jane, with overall

length of 295 metres and draft of 12 metres, berthed for the first time in Nigeria on Wednesday, April 13, 2022, at 3:00 p.m.

According to NPA, the historic landmark is that the vessel, which sailed from Majuro in the Marshall Islands, is discharging 840 TEUS and loading 1,060 TEUS, 50 per cent of which are agricultural commodities including cashew nuts, sesame seed and cassia

tora seeds, among others.

This is coming on the heels of the reception at Onne Port of the first ever export-laden barge containing 120 TEUs of Cocoa to Belgium via Cotonou earlier this year.

While the berthing of the MV Maersk Stadelhorn, a 300 metres LOA container vessel on August 15, 2020, tested the navigability of the channel, MV Lady Jane has proven

the capability of the channel for sustained container vessel traffic, NPA stated.

According to the authority, this is a testament to its unwavering resolve to promote exports and support the efforts of the Federal Government of Nigeria at positioning the non-oil sector as a revenue earner.

The authority said although the Onne Port Complex has traditionally been known as a logistics hub for oil and gas services, the implementation of fresh initiatives deployed by the Managing Director, Bello Koko's administration resulted in a 30 per cent increase in container traffic at the end 2021.

Speaking to stakeholders, who came to welcome the vessel, Koko, who was represented by the Port Manager, Stanley Yitnoe, said the milestone signposted the fact that NPA's initiatives geared towards repositioning the eastern ports for productivity were yielding positive results, adding that the Onne Port Complex was fast becoming an attraction for container vessels traffic.

"We cannot afford to rest on our oars, we must continually strive to surpass stakeholders' expectations," he said, and commended the pilots for the professionalism demonstrated through the effortless and safe berthing of the vessel.

He assured that in addition to the palliative works that have already begun on the arterial roads at the Onne Port, full-scale rehabilitation of infrastructure, improvement of port security through illumination and deployment of access control to check unauthorised entry, were top on management's priority.

## Nigeria's infrastructural development affected by relegation of surveying profession, says Kasim

Mr Olukolade Kasim, the 15thchairman of Lagos State Branch of Nigerian Institution of Surveyors (NIS), spoke in this interview with ONYEBUCHI SAMPSON, on the importance of drones in surveying, lack of patronage, building collapse, quackery and others issues.

Congratulations on your election as the 15th chairman of the Lagos branch of Nigerian Institution of Surveyors. What areas are going to focus?

Thanks for your compliments. One of the areas, I will like to focus on in my tenure is the area of unity of all surveyors in the state. We have surveyors in private practice, those working with the government and in the academia. We also have a few working in our regulatory bodies. So, I will try to ensure that all work under the umbrella of NIS. Currently, there are several groupings, but when we have a united house, we can achieve a bit more than through different divisions.

Before now, the surveying profession is said to be the root of any development in any country. Is it still the case now? Are surveyors doing enough to drive development in the country?

Yes, even if we should be able to do more. I will give surveyors a pass mark. Surveyors had been at the bedrock of infrastructure, which is the programme of this present administration. I know that surveyors have been involved in the railway projects right from their inception. Surveyors have made huge input in the area of road construction. So, I will give the Nigeria surveyors a pass mark, but I think with more engagement from the government, we can do more. We can stand shoulder tall with our colleagues all over the world. So, if the government gives us more opportunities, we can have a mutually

beneficial relationship.

Do you think that the absence of surveyors in politics is affecting the recognition of the profession in Nigeria?

On a lighter note, I don't want to agree completely with you, because we are claiming the governor of Lagos State, Babajide Sanwo-Olu as one of us. The Senate President is also a member of an allied profession. Over the years, we have had surveyors, who have played a big role in politics. Moreover, I agree with you, maybe we could do more. Most surveyors are now going into politics, I think we can bring professionalism into politics. As surveyors, we

are trained in precision and diligence, there is a lot we can bring into the political space, but we are also a bit conservative. I can tell you that in due course things will change and it is changing already.

What is your profession's relationship with Lagos State Government? Are there areas you want improvement?

As you are aware with the spate of recent happenings, particularly, with regards to incessant building collapse, we are trying to push for a bill to ensure that buildings over three floors are monitored. This will ensure that at least, we don't pray for such an unfortunate incident, but there will be some elements of check so to speak. We are also pushing for separate surveying inputs in infrastructural projects. So, instead of lumping them up as a turnkey project, we have surveying aspects, which should be strictly handled by surveyors. I am not saying that they are not being done by surveyors, but when surveyors come directly into the project, it is very reliable and they will be more careful than if it was just lumped under other professional bodies

in the built environment.

For any meaningful development, there is a need for us to consult surveyors. If you see any smart city in any developed country, it must have had the input of surveyors. So we are available and should be patronised. If we are patronised, you can be sure of quality jobs, So, for any development which you want to put your money into, you must ensure that you engage professionals, so that they can be held responsible for any issues

that may come up.

Professional fees were a major issue at a time in Lagos NIS. Are you planning for a review?

Between you and I, even now, a review is still necessary, but we all know the state of our economy now, so it will be a bit unfair if we are to review our

The honest truth is that the Exchange rate affects everything and I can tell you that it affects our instruments more than anything. We use position instruments and all of them are imported. So, Fired

affects our equipment. We cannot afford to manage our equipment, because they are very fragile and need servicing as well as replacements over years.

The surveying space is one, whereby the rate at which instrumentation changes is amazing. Nigeria surveyors do not want to be left behind. We want to be able to compete internationally. We don't want when jobs are coming in, and expatriates would say they want to bring their own colleagues from other countries. We want them to meet us here fully equipped as they will find in their own countries. So, all this affects how we charge, but I think to our credit, we have tried as much as possible to maintain the fees as they

What is your thought about government's investment in the surveying profession?

Over the years, surveyors used to have a place of pride in Nigeria In fact. during the colonial era, the surveyor-general used to be the number two man. When you look through history, we made claims of Herbert Macaulay being a surveyor. I know Oba Adeniji Adele II had a surveying background down to some of our past presidents, like Surveyor Adekunle Kukovi. So, surveyors used to have a place of pride, but over the years, it has been

dwindling. With the advent of modern technology, you can see what we've lost by relegating surveying. Back then, pictorial views of Lagos would show you green spaces and stuff like that, but now when you look at it. It's all buildings, now at it. it's all buildings, no more green area. These are the things that the latest technology in Geographic Information system (GIS), the technology will high-light these things. So I think, we've been neglected, but I think that

neglected, but I think that they are seeing what they have missed. There is nothing wrong when we realise our mistakes, the thing is how to retrace our steps as soon as possible. We will continue to engage governments until they retrace their steps and give us our rightful place in the scheme of things.

Do you think that adequate attention has

been given to surveying? What we ask for is Fed-

eral government patronage so they can improve our practices and build a very solid practice. We assured them that anything can be handled here. There is no need to bring someone from somewhere to handle our projects. I hope the government continues to patronise us which will enable practitioners to build solid practice. One of the problems that we have now, is the issue of bringing drones into the country. A few of our members have their drones seized because they need a permit right from the office of the National Security Adviser. This takes a very long time. So, we are appealing to

government to help us. I understand for security reasons they may limit the sizes of the drones because drones aid in our photogrammetric works. They can exclude drones, which carry heavier tonnage and may be subjected to these security checks. If government can help us in that regard, we will be grateful.

We also intend to sponsor a bill for monitoring high rise buildings. We will continue to push for that at the state level, but drones and stuff like that are what we will continue to push at the national level.

Do you think that government is doing enough to address building collapse in Lagos?

In recent times, I would say they are stepping up. The panel of inquiry set up to investigate the Ikoyi building collapse has just submitted its report. We heard that 26 out of 28 of their recommendations were approved in the white paper released afterwards. If these recommendations

are followed through and implemented, we would consider that they have done a very good job. If prosecutions also follow for all indicted persons then we can restore some confidence back into the real estate sector. The Government should also follow up with a lot of in-house deep reflection on the process of building plan approvals. That in essence means they are doing well but they can and must do more for us to get out of these unfortunate collapses.

How is your association handling the issue of quackery in the profession?

We are creating stronger and stricter monitoring units and we are revamping the ethics committee. We are also introducing what we called the monitoring committee Task Force. I don't want to let the cat out of the bag, but basically, we are going to empower the committee to actually look at that issue critically.

What do you think were the reasons for big cities like Lagos sliding into slums?

I have to sympathise with Lagos because of its population explosion and the latest development that caught everybody by surprise. I have to give Lagos State government credit because there is regeneration going on in parts of the Island. Even places like Lekki needs regeneration. As I said, the government needs to engage us more, because, for any development, surveying is the bedrock. The governor is a surveyor and he realises the importance of surveyors and I am sure

they will engage us.
Also, as surveyors, we don't give approvals, what we do is surveying, whether hydrographic or land. So, you can't blame us if you have issues with development and stuff like that, we will only do our

Many people are confused with surveying and mapping. How do they work together?

They are intertwined, mapping is an aspect of surveying. So, if you say you are mapping, you are carrying out a survey on another level. It is just large scale surveying so surveyors are mappers and geographers.

Government needs to accord surveying its rightful place because it is the bedrock of all development.

## **Expert laments incessant building collapse**

Managing Director, Jecmeralds Engineering Ltd, Engr. Chidiebele Uzoagba has urged the government, individuals, and Engineers to imbibe the culture of good maintenance, to curb the menace of building

He stated this while speaking on the topic: "Poor Maintenance Culture in Nigeria, Role of Facility Management" at a meeting of the Nigerian Society of Engineers (NSE), Victoria Island Branch, Lagos.

Uzoagba lamented that many infrastructural amenities in Nigeria, such as schools, hospitals, offices, and monuments, are in bad shape due to negligence.

He identified lack of funds, indiscipline and ignorance, bad economy, corruption, absence of the owner, and remoteness of the building as the reasons poor maintenance culture.

Uzoagba also highlighted causes of maintenance problems as faulty design and construction, bad workmanship, and use of sub-standard materials.

"It's inexplicably true that in Nigeria today, peoples' commitment to maintenance is poor," he said and emphasised the role of facility maintenance as a driver to encourage a good maintenance culture in the country.

We have seen this in the private sector, and even in private residences, where it's deployed, and how it has helped the life circle of those buildings.

"By the way, facility management is a multidisciplinary profession that involves every sector of engineering and integrating people's process and technology to deliver a good environment where we live and play," he said.

Across the country, according to him, there are building facilities that are poorly maintained due to poor culture, or bad attitudes.

"It would interest you to know that on February 19, 2019, the Federal Executive Council approved Building Maintenance Policy plan work, which has not been communicated to us till now.

'Not many Nigerians are aware of the policy and it is as if something has not been developed because if a policy is not communicated, or implemented of what use is that policy?

"So, if we have a policy, it must be communicated to the people. I believe this would transform the psyche of the people towards maintenance because policy should be able to transform, direct, or structure issues around that thing.

"Whether we are looking at maintenance culture on building, airway, road, oil & gas or in any sector of the economy, we must communicate it in a manner that helps to transform the psyche of the people and that could be through education, either formal or informal," he added.

He stressed that the formal education approach should be such that facility maintenance will be made part of the nation's curriculum in the universities. He noted that currently, no university in Nigeria offers facility management as a first degree except at the master's degree level.

### FG commences installation of solar power systems in Abia

The Federal Government has commenced the installation of solar systems in 5,000 households in Abia State. The project is being handled by the World Bank through the Niger Delta Power Holding Company (NDPHC) in collaboration with the Federal Government.

An NDPHC representative, Engineer Chinonso Ugwueke, who led the installation team to Abia, said the project targets five million households in the country. The households, he said, will benefit from 24-hour uninterrupted solar power outside the national grid.

He stressed that the lawmaker representing Aba South Constituency in the Abia State House of Assembly, Hon. Obinna Ichita paid for the 3,000 systems to be installed in his constituency as well as sponsored the installation team.

Speaking, Hon Ichita said that renewable energy had

the potential to meet the energy needs of rural communities, especially at a time when the national grid had almost collapsed. He stressed that the solar systems would provide opportunities for "unserved and underserved" communities in his constituency to overcome their power

challenges.

Ichita urged the state government to key into the project, saying renewable energy could provide constant power supply to households and businesses, which would, in turn, boost socio-economic development in rural areas.

"When I discovered this

opportunity, I decided to bring it down to my constituency, considering how important Aba is in our march to industrialisation.

"Besides constant power supply, 1000 youths will be taken off the street and get employed along the solar technology value chain," he added.

The Regional Manager of A-Solar Systems Company, the company that handled the installations, Mr Ibrahim Usman, told Aba South traditional rulers that the initiative (Project) was in furtherance of the Sustainable Development Goal seven (SDG 7), whose target was to provide affordable and accessible electricity off the national grid for rural and semi-urban communities.

Chairman of Aba South Council of Traditional Rulers, Eze Ibe Enyeazu, commended Hon Ichita for the gesture, saying it would end the power challenges in the rural areas.

### Delta approves 30 km of road projects

Delta State Government has in the state. approved the construction and rehabilitation of more than 30 kilometres of roads, across its three senatorial districts.

for Commissioner Information, Mr Charles Aniagwu, who addressed newsmen after the state's Executive Council, presided over by Governor Ifeanyi Okowa, said the approval was part of measures aimed at urbanising communities

He listed some of the projects to include 2.05km Kokodiagbene road in Warri South West Local Council; 10.85km Ute-Okpu/Ute-Enugu in Ika North East Local Council and 1.5km Ovie Palace road in Mosogar in Ethiope West Local Council.

Others include Etua -Oliogo and Etua Etiti roads in Ndokwa West Local Council: 4.9km Aviara - Bethel road in Isoko South Local Council; 1.2km Abi-Ezionum road and 12km internal roads in Uwheru, Ughelli North which, he said, cuts across eight agrarian communi-

He said: "We are still continuing with approval of projects, not just to enable us to finish strong, but also, to reach several rural communities and urbanise them.

## National Monument: Work begins at Ogaimen Ancient palace

he ancient Royal Palace of Ogiamen of Utantan, in Sakponba Road, Benin City, Edo State Nigeria, was built in 1160AD. It is one of the oldest palaces in West Africa still standing. After several visits to the palace

After several visits to the palace in Benin City by the then British Colonial Masters, the ancient palace was in May 29th 1959, declared one of the country's national monuments.

62 years after this declaration, members of the Ogiamen Royal Family, especially their elders, are still having problems clearing the surroundings of the palace of illegal structures and debris to pave way for the National Museum and Monuments.

The Ogiamen Royal Family's strenuous efforts to eject all the illegal occupants of the surroundings of the ancient palace in Benin City have yielded very little results. Unfortunately, the illegal occupants of the ancient palace neighbourhood have done all within their powers to frustrate this move, just because they want to continue to remain in the vicinity.

Plywood sellers in Benin City, who have made the palace surroundings their trading spot for years, constitute the majority of the occupants in the area. They are also accused of generating the huge dirt that litters everywhere around the palace ground, thus making it difficult to access the

palace and the entire area. The issue is further complicated by some relatives of the Ogiamen larger family who have also built their houses in the area in question without getting the approval of the elders of the Ogiamen Royal Family.

This has obviously resulted in a tug of war between the elders of the Ogiamen royal family and all the illegal occupants of the surroundings of the ancient palace for about 62 years.

The National Museum and Monuments management on its part, has continued to maintain, that it can only take over the ancient palace, only when all the surroundings are cleared of the filthy and illegal structures. They stressed that there must be, at least 50 meters radius between the ancient palace and all the structures in the vicinity.

In a deliberate effort to meet these conditions, the elders of the Ogiamen royal family of Utantan sometimes last year, met in Benin City and resolved to do all within their powers, to clear the palace surroundings of all illegal structures and debris so that the National Museum and Monuments can move into the place.

The head of the Ogiamen Royal Family, His Imperial Majesty, Rich Arisco Osemwengie, JP, the Ogiamen of Utantan Bini who spoke with Palace Watch, said, "We are surprised that this matter has continued to linger unnecessarily. Some persons, who bought the unauthorised

areas in conjunction with some of our relatives, who have built their personal these areas without seeking approval, are making things to be very difficult. At some point, they went to court, to restrain the Ogiamen Royal Family from ejecting them from the palace surroundings. But we on our part have now resolved to clear the place so that the National Museum and Monuments can take over the palace. It was in line with this resolve, that the larger Ogiamen family recently met again in Benin City, and decided to task itself and contribute money to rebuild part of the ancient palace that has fallen. From these contributions, the family has also embarked on the renovation of the inner chambers of the ancient

"As we speak, 15 deities inside the inner chambers of the ancient palace excluding Olokun and Orunmila, have all been appeased and revived. The Ogiamen Royal family, however, rejected the Olokun and Orunmila idols we located in the place because these idols are not aboriginal to the Bini people. As the name suggests, these idols are of Yoruba extraction. We are Bini people, not Yoruba

Osenwengie continued; "I was physically present in that palace on a one-day working visit, to supervise the work going on, in the inner chamber and surroundings of the ancient palace. The point that must interest you to note, is that among the deities just revived in the inner chambers of the palace, has one of the most potent deities in Bini land. It is known and called the fire eating and firespitting 'Osu Nazengban'. This deity immediately it was revived swung into action to exterminate all the people, who have been working over the years against the peace and progress of the Ogiamen Royal Family of Utantan

Another idol known as "Evan Nu Regbe" was also recently re-awoken, and is now set to strike, His Majesty stressed, "The time for the National Museum and Monuments to take over the ancient palace as a national monument is now because this project can no longer be delayed."

Your Majesty, what specific measures have you now put in place that will last and ensure that normalcy returns to the place and eventually results in the clearing of the palace surroundings of all the intruders?

Osenwengie: "As civilized people, our measures or more appropriately efforts, to clear all these surroundings of filthy and illegal structures, were initially that of stick and carrot. Then we were pleading and begging them to vacate the area peacefully. It was when these entreaties fell on deaf ears, we decided to adopt other measures to clear the place of all the mess.

Your Majesty after my tour of the ancient palace surroundings in Benin City, I discovered, there is still a lot of work to be done, to meet the requirements of the National Museum and Monuments:

First, at the front of the ancient palace at plot 97 Sakponba Road, only 20 meters as against the 50 meters of the National Museum policy, have been met. As areas cleared of structures from the major road to the palace, is just about 20 meters.

Second, the two sides of the palace have not been cleared of filth and illegal structures.

Third, the back of the palace has been cleared of dirt and structures up to about 50 meters or more. But there is still a lot of work to be done in the entire area, if the mess on both sides of the ancient palace must be removed?

The truth is that we are fighting very hard to remove this mess. No matter the present odds, we will succeed. My family will not relent in efforts to make the ancient palace ground a tourist attraction. For those illegal occupants and owners of those structures, who are recalcitrant and are still living within the palace grounds or areas, they either learn to leave the place voluntarily or would invariably be forced out of the place. It doesn't matter how long it will take us.

I must confess, presently, it has not been easy at all for us to clear some of the surroundings of the ancient palace, which we have so far succeeded in clearing. It is sad, that a place as important as these ancient palace surroundings has been for decades now the hub of plywood sellers and other illegal activities, which we strongly objected to as a family.

I must say, this illegality festered, just because we as a family were not too decisive in our initial actions then. So these people saw our passiveness as a sign of weakness, which is not. But now, this is no longer the case. In the process of being peaceful and civil in our approach, all manners of illegal structures continued to spring up around the palace. While the debris generated by plywood sellers daily and other activities in the areas continued to mount. Thus, making the whole area eyesore. This can no longer be tolerated or remained unchallenged.

I must at this point emphasize that no responsible member of the Ogiamen Royal Family sold any of these areas to anyone. As civilized members of the society, we initially tried to be civil in all our approaches. We appealed to the senses and conscience of all the people involved in these illegal activities, especially the plywood traders, alongside some of our relatives who decided to illegally build structures in the

palace surroundings to vacate the areas.

At some point, we have to issue them, with quiet notice since they refused to vacate the areas peacefully. At another point, we have to write to invite the Edo State Ministry of Environment to come and do their job and ensure that the whole area becomes habitable. At another point, the law enforcement agencies were invited to come and help in the clearing of the place of these people who have continued to constitute themselves as a nuisance in the entire area.

After all these efforts, the people who still have their buildings in the area, and who have refused to leave the place on their own volition, will have to be forced out of the place, when we finally appeal to the Federal Government to help us prevail on the Edo State Government, to do all within its powers to clear the areas of all illegal occupants and structures so that the national monument can now take off.

How will this National Monument benefit the Ogiamen Royal Family directly when it finally becomes functional?

Ogiamen Arisco: The preservation of the ancient palace and its relics is of great importance not only to the Ogiamen Royal Family of Utantan-Bini alone but to all the aborigine Bini people at home and abroad. Firstly, this particular palace was built before the palace now known as the Oba of Benin Palace. The present Oba of Benin palace was never inhabited by any of the Ogisos, who are the original owners of Benin City. The palace situated around the Ring Road area of Benin City, if the truth must be told, was once the burial ground of the people of Igodomigodo land.

Ogiso Evian and Ogiamien Erebo also lived in this particular ancient Bini palace before the invasion of Benin City by Oranmiyan and his forces. It was during the reign of Ogiamen Erebo that the sanctity of the ancient Igodomigodo now known as the Bini Kingdom was violated by the Yoruba invaders.

It was the crisis that arose, after several failed attempts to invade Igodomigodo land that was mostly responsible for the exit of our relatives, who later went on to establish other ethnic groups or kingdoms in other areas of Edo state of today. These kings and their people migrated from this place to where we now know as Edo North, Edo West and Edo South

In the case of the Niger Delta areas of today, the majority of our kingsmen formed the bulk of some of these areas in Delta, Bayelsa and Rivers States. People from these areas were our kit and

#### Stage performance is a discipline craft – Actress Kehinde Bankole

When it comes to bringing life to a character then talented actress, Kehinde Bankole best suit this accolades as her acting prowess stands her out. Having featured in countless movies and won some awards; Kenny as she is fondly called by her fans is not resting on her oars to get better. Kehinde who has tested both the craft of stage performance and film production in this chat with OMONIYI ALLI spoke about her acting prowess, the thin line between stagecraft and movies, keeping off scandal and what she considers good script amongst others.



You are a fantastic actress, what do you look out for in a script before you consider the script worthy?

The direction the story is going, there are some stories you will see and you will understand what they are saying but you don't understand the direction it's going, that is what I look out for, I want a good story, apart from

the story being good I should be able to understand the direction, there is a theme, a message the story is trying to pass, whatever happens to me the first time I open a script will be happening to the people watching at home, we serve as the bridge between the people at home watching the movie and the person writing the story.

You do a lot of stage performances; which will you consider more challenging, being a stage performer or an actress?

Both of them are challenging, stage is very disciplined, very challenging because you don't have a second take, there is no rewind and let me take it again and so, what you give at that time is what the people are going to get, it is important you make your decision for stage like in fraction of a second, you have to decide how you want to deliver that role within a fraction of a second, and once it's done you can't take it back, it helps you to focus, people think acting a movie is simple but it is not, it is also equally challenging, the opportunity you have to act a stage play once is not like that of a film, you might have to re-do like 30 times, think about rewinding a particular emotion, the stress of having to put yourself on the same level of that emotion for about 30 times, especially if there is a crowd in a scene and you have to re-do a scene plenty times and have to sustain the same level of energy, if you have to remember something bad that made you be in the mood, you have to remember that over and over if you are ask to act the scene over again, so it is equally challenging if not even more, it's a lot of hard work.

These days we see more female actresses delve into production and directing, are you also going into that direction anytime soon?

No, am an actor, well if I have the opportunity to produce something, it doesn't have to be a film, it could be telling a serious story through documentary, some people do this, somehow I could be involved in the process of the production, I don't have anything against it but I am an actor.

Some of your colleagues reject scripts based on who the other casts members are, do you also find yourself in such situations?

it is not a yes or a no if it is important to the life of that film, I have a team, we sit down and we make a decision, if we think the smallest person is not good for that film or the biggest person is not good, it is business decisions that people make will make them turn it down or accept it, I necessarily do not have to say because an actress is in it or not in it, I look at the story, sometimes if a story is very good and they cast you and you know within yourself that you don't find yourself in the story, you can't deliver it, that is one of the reasons why you turn it down, you don't think essentially because one actor is not there, it must be because of a business decision.

What is your take on the state of the

industry before the joined and now?

Yes there are a lot of changes, those who are ahead of us have done a lot of work, there are now so many opportunities, there are young producers, actors, it is spreading everywhere, the media is coming to us and we are also going to the media, it is not everybody in entertainment that are acting, everybody is doing serious work here, there are editors, cinematographers, it is way better than how it was before.

How have you been able to keep fit? Although the nature of my job is a bit stressful but more importantly; I watch what I eat, rest well, do exercise if need be and just put my mind at rest.

How have you been able to keep off scandals?

I keep things simple; simplicity is what makes you stay away from trouble, when you keep everything simple it makes whatever comes back at you simple

In the LMC response dated 12 April, 2022, the letter tagged: "RE: CERTIFICATION OF STADIA: STADIUM ABACHA SANI KANO" reads: "We acknowledge receipt of your letter dated 1 April 2022, informing us that the Kano State Govenment has made funds avalable for the urgent replacement of the playing turf, and also requesting for a provisional leave to return to the Sani Abacha Stadium, pending the mobilization and commencement of turf replacement

"Be informed that after due consideration of your request, the League Management Company is

granting Kano Pillars FC provisional clearance to temporarily return to the Sani Abacha Stadium for your home matches, pending the commencement of replacement works on the playing turf.

"You are however required to immediately propose an alternate ground where you ill revert your

remaining home matches when the turf replacement project commences at the Sani Abacha Stadium. Note further, that you are required to make instant improvements to the current condition to the playing turf, to make fit for purpose pending the commencement of the project.

"The above is for your information

and consequent action," the letter

Meanwhile, the club management had in the 2019/2020 season suspended all local matches from the stadium following the poor state of the stadium facilities.

According to the club in 2019, it appealed to the Kano state

government to renovate the stadium to meet the standard approved by the Confederation of African Football (CAF) for the 2019/2020 African Champions League.

The statement read in part: "The association, in this wise, wants to appeal to the Kano State Government to put more efforts into renovating the stadium to meet the CAF standard before the competition begins."

Following the appeal by the club, the Kano State House of Assembly in October 2021 adopted a motion moved by the House Committee Chairman on Sports, Nurudeen Alhassan, calling on the state government to put the stadium into shape.

Supporting the club's appeal in 2021, the honourable member representing Kiru state constituency, Alhaji Kabiru Dashi described the predicaments of Kano Pillars as pathetic noting the players have been subjected to play all their 2020/2021 games in Kaduna due to the coronavirus facilities Sani Abacha stadium has.

However, Kano Pillars' last game at the Sani Abacha Stadium was on March 15, 2020, which ended in a 2-0 win over Jigawa Golden Stars.

## NFF board composition, PFAN advocate for stakeholders' inclusiveness

The President of the Professional Footballers Association of Nigeria (PFAN), Tijani Babangida, said that the composition of the executive board of the Nigeria Football Federation (NFF) is 'deficient on all fronts'.

Babangida stated that the football governing board chose to favour chairmen of states' football governing bodies leaving out other key stakeholders which negate the democratic principles of the sport.

According to him, the faulty composition of the board has always hurt the distribution of votes.

Babangida on Tuesday in

Lagos opined that restructuring is the only avenue to make the membership of the NFF board more inclusive.

In a statement tagged, "NFF for Sustainable Growth and Development of Nigeria", and made available to newsmen, Babangida advised that if the body is to make progress, the provisions of article 10:1 of NFF Statutes must be reviewed.

He said, "The current structure of the NFF board is deficient on many fronts. The current structure dominated by the chairmen of the state football associations to the detriment of other important stakeholders does not portray the game of football as the most

democratic game in the world.

"The board dominated by the state football association chairmen has its roots in the faulty nature of the composition and distribution of votes.

"This votes amongst the five distinct members of the NFF, according to the provisions of article 10:1 of NFF Statutes must be addressed if we must move forward and make progress", Babangida added.

Furthermore, Babangida faulted the structure of the congress that ushers in new executives, adding that it is an avenue where electoral fraud and malpractices are promoted.

He continued, "There is no doubt that the current structure of the congress and the board has continuously promoted and encouraged election malpractices such as votes buying.

"This has negative effects on the quality of members of the board which robs on quality decisions making and good governance," he added.

Babangida proposed that the governing body should adopt a system that is devoid of the exclusion of key stakeholders across boards which will aid in curbing electoral malpractice and excesses of vote-buying.

He said, "What I mean is that we should adopt a system, and

structure where the board is composed of representatives of only duly, and democratically elected.

"They can be persons of the various stakeholders such as the football associations, the leagues, the player's union, coaches' association, Nigeria Referees Association, (NRA), Sports Writers Association, etcetera.

"They will now be responsible to elect the president of NFF and other key officials amongst themselves.

"By this, the election will be less expensive and devoid of manipulation and guarantee quality and professionalism," he added.
