Presidential aspirants intensify consultations as more enter race

onsultations by presidential aspirants of various parties are gathering momentum nationwide ahead of their primaries for the 2023 general elections.

They are meeting leaders and delegates of the parties in different states just as more aspirants join the race.

Transportation Minister, Rt Hon. Chibuike Rotimi Amaechi visited Cross River State where Governor Ben Ayade described him as a man with outstanding qualities fit to rule Nigeria.

Ayade spoke when Amaechi paid him a courtesy visit as part of his consultations with delegates of the All Progressives Congress (APC) in Cross River State.

According to him, "I agree with my brother Amaechi, totally. He comes with a lot of experience. He is one man who has shown commitment to Cross River State and Nigeria.

"We started trying to build a Deep Seaport, from the day I spoke to him about the Deep Seaport till today, he has given eight ministerial approvals. There was no day that our files stayed on his table for twentyfour hours. So, he has shown commitment to the State and to Nigeria, and I say this with all sincerity. He has also shown very outstanding sense of brotherhood. From the time I moved into APC, he said, "you are our leader, we will work with you and at any point in time we would always work together," Ayade explained.

Governor Ayade who also recently declared his intention to run for the Presidency on the platform of the ruling party, further revealed that between him and Amaechi, there is no competition.

"I have had extensive discussions with Amaechi, and I can tell you that we are not competitors, we are co-petitors. I am comfortable with him. He is somebody that speaks his mind, he is not somebody that you cannot understand, he is somebody that you can read, and such people are far more innocent, because if they are hurt, you know that they are hurt, and few minutes after, it's gone. He is not a trickish politician, and I think that's a good attribute of leadership. Let me mention clearly here, that for us as as State, outside of Ayade, we are very comfortable if you secure the ticket.

"And so, I wish you well, I commend you to go before the delegates of my State, and I ask you (delegates) to judge him based on balanced fairness, because what God has destined for him, I cannot take it," he said.

Addressing the Governor earlier, Amaechi said, "I will repeat what I tell people, I am 56 years old, so I am among the young candidates of the

party. I'm not the oldest, but am the most experienced. Of all the aspirants, both in APC and PDP, I am the most experienced. I have been Governor for eight Speaker for eight years, Minister for seven years now, I have not seen anybody that comes with that kind of experience for the office of the President that I come with. I was the Chairman of Governors' Forum and I was Chairman twice when it was very contentious to vote for the office of the Chairman of that forum. The reason why it was contentious was because we stood for the people, we spoke the minds of Nigerians at that contentious time. I come with performance in every office that I have held. I had a meeting with the President two days ago, in which we had very good conversation about the Lagos-Calabar rail, and we agreed that he would launch the Lagos-Calabar rail here in Calabar. The moment we are about to sign the loan, I will tell the President to come and launch the project and will commence from Calabar."

Amaechi, who earlier visited the Obong of Calabar, HRM Edidem Ekpo Otu V and his Council of Chiefs, assured of his commitment to provide good governance to the masses, pledging also, that he would run a transparent government if elected President.

The Presidential hopeful also met with party delegates in Calabar where he urged the people to vote for him based on his antecedents and track record and not just because he is from the South South, adding that he would deploy his wealth of experience to bear in his service to humanity.

According to him, "I am vour son, but let us not vote just because I am your son. Vote for me because I have the capacity to deliver. You have heard Northern candidate, Southern candidate, Western candidate, I am not a candidate of any tribe, I am a candidate for all Nigerians. Those who are Governors and running, let them tell us what they have done in their States. how many days do they sleep in their States, let them tell whether they are owing salaries or not. For me, judge me by my capacity. Go back to Rivers State and find out, when I was Governor, the primary schools, the secondary schools, power, water, new city, roads, and the fact that we provided security. I am the only aspirant that fought insecurity when I was Governor. So, vote for me because I have the capacity to turn the country around for

In his response, Chairman of the party, Alphonsus Eba said, "Your Excellency, there is nothing I will say about you today that will not be laced with praises, with encomiums and cornucopias. You have done so much for this party, to Cross Riverians, even during the era of

our former Governor, you were around, we saw the support you gave to Cross River State. When our Governor (Ayade) came on board, you have given every support. You granted eight ministerial approvals for the take-off of Bakassi Deep Seaport and a super-highway. The Governor spoke about that in the meeting we just attended.

"Today, I stand to say that in Cross River State, you are one man that we could boldly stand up and say, you are politically merchantable. You will not be a difficult product for us to sell. We have only one river to cross and that river is the fact that our leader is in this race, but he has just allayed my fears, when he said to you, that if it is not him, let it be you," Eba said.

PDP presidential aspirant and Bauchi State Governor Bala Mohammed has, on a visit to his Edo counterpart, Godwin Obaseki, said his wealth of experience and track record over the years will enable him to deliver good governance to Nigerians if elected president.

He said: "I have a track record of being a nationalist, a federalist, a civil servant, and a reporter like these young people. I know the country very well and the people of the country know me. I have been tested as a civil servant, a legislator in Abuja and in Bauchi, using small resources to do more as you are doing a similar thing here in Edo."

Bala Mohammed visited the governor to seek his support and that of the party delegates ahead of the party 's primary election at Government House, Benin City.

Mohammed promised that his reign as the president would foster oneness among Nigerians and further deepen leadership.

Responding, Obaseki said: "I believe that you know what the issues are in Nigeria today and have practically touched all of them. You are sensitive; you come with a lot of sensitivities and you have that displayed always, even when we go through contentious issues in our meetings.

"I can confirm that you are a patriot and as a democrat, I like your spirit which is why democracy is about contestation. There is nothing wrong when you throw your hat in the ring, and you've been quite clear and not ambiguous. There may be other aspirants who may possess such attributes.

"You feel that you have what it takes to run this country and deal with all the critical issues affecting us today. What I want to assure you is that for us in Edo, we're PDP and we want our party to produce the next president."

"Whatever that our party agrees to do, as long as it's fair and just, we, in Edo will support it. You've come to seek the support of our delegates. They also have the privilege to hear from you and know the decision to take when the time comes."

Meanwhile, Minister of Science, and Technology, Dr. Ogbonnaya Onu, has said that if he emerges as President of Nigeria in 2023, he will unlock the prosperity of the country leveraging on the power of science, technology and innovation.

He pledged his readiness to evolve a knowledge-driven economy at his official declaration to run in next year's presidential election on the platform of APC on Friday in Abuja.

The former governor of Abia State said no nation, whether in ancient or modern times, has ever become truly great without the efficient and effective deployment of science, technology and innovation to nation building.

"I am convinced that I have the knowledge, the experience, the credibility, the education having been trained in one of the best universities in the world, the vision, the integrity, maturity and a man who can be trusted, "he said.

Professing a greater future for the country, Onu stressed:"I have a dream that Nigeria will make one day lead the world. Let no one tell us that it cannot be done because if we cannot achieve it, our children can.

"The purpose is for Nigeria to do for the black people of the world, what Japan did for the yellow people," adding that "we must bring discipline into our nation, promote Justice, fairness and equity and allow creativity to flourish.

"This way, Nigeria will

become a nation that all Nigerians will be proud of and other nations will respect.

"Let there be nothing that can make any Nigerian lose hope about the future of Nigeria. Working together, we will make use of a knowledge economy driven by STI, to make Nigeria truly great."

The presidential aspirant called for local content by advocating self-reliance through the production of goods and services consumed in the country rather than an import-driven economy.

"Nigeria must be a producer nation, instead of remaining a consumer nation. We must produce many of the things that we need and use as a people. It is by doing this that we can create wealth and enough jobs for our people, fight poverty, create wealth and prosperity for our nation."

"Nigeria must be self-reliant," and can "no longer depend on other nations to solve our problems," he declared.

"We are better equipped to solve these problems ourselves. This is the road that we have to take; this is the road that we must take. I most respectfully ask my political party, the All Progressives Congress (APC), to elect me as the Presidential Candidate, and the people of Nigeria to elect me as the President of the Federal Republic of Nigeria, for me to be the Chief Servant of the nation"

A former Governor of Zamfara State, Alhaji Sani Yerima, has declared to run for the 2023 presidential election on the platform of APC.

The former senator who represented Zamfara West, at the National Assembly, was at the Presidential Villa Abuja on Friday, to inform President Muhammadu Buhari about his intentions.

He said when elected President, he 2would focus on fighting insecurity, poverty alleviation and ignorance of the mind which many Nigerians are living with unknowingly.

The former governor, who is famous for introducing the Sharia legal system in his state, debunked claims that he was a religious extremist.

According to him, that

perception people hold about him is one of the reasons he would work on the ignorance of Nigerians and give every citizen a sense of belonging.

While disclosing his plans to State House Correspondents, he noted that he had secured the consent of the President to run for the exalted office.

He is due to pick his expression of interest and nomination forms.

Presidential hopeful of the PDP, Alhaji Atiku Abubakar, was in Lagos on Friday to seek support of the party's delegates ahead of the May 28 and 29 presidential primary election.

At a meeting in the Ikoyi residence of a party chieftain, Chief Bide George, the former Vice President preached unity among PDP members. He stressed the importance of winning Lagos to the aspiration of the PDP to return to power in 2023.

According to Atiku, it is important for the PDP in Lagos State to come under one umbrella.

"As you all know, the major theme of my campaign is unity. But I think we should share the same gospel of unity with the PDP in Lagos State. This call will require shifting of position and common understanding. But this is the sacrifice that we all have to make to ensure that the PDP wins Lagos State.

"I have talked to leaders and elders of the party inside and I made a similar call on them. I am here with all of you too who are esteemed members of our party to please give the necessary support to our leaders and elders in making sure that the party is united," Atiku said.

George said that the message of Atiku about unity is well taken and it is an appeal that he is committed to.

According to Chief George, "it is not in doubt that Atiku knows Nigeria very well and Nigeria knows him too. The next election is the last battle of Berlin and it is necessary that we go into it with all the power and elements that we have.

"In Lagos PDP, we shall be united. It is what we must do to win the next election.

"In this upcoming election, Nigeria needs someone with the experience, capacity and deep knowledge of this country and you, Waziri (Atiku Abubakar), fits into that perfectly.

"We wish you well in your campaign. I like the way you ended your remark about winning Lagos for the people of Lagos. We must end the era of Lagos belonging to a stranger."

Minority Leader of the House of Representatives, Hon. Ndudi Elumelu, has urged presidential aspirants of the Peoples Democratic Party (PDP) not to abandon exploring the consensus option in finding a presentable candidate for the main opposition political grouping.

Akeredolu demands resignation of **Emefiele over alleged partisanship**

Governor Oluwarotimi Akeredolu has called for immediate resignation of Central Bank of Nigeria (CBN) Governor Godwin Emefiele for him to pursue his interest of being the next President of the Federal Republic of Nigeria.

Akeredolu said Emefiele could not combine partisan politics with the delicate assignment of his office, saying if he refuses guit, the incumbent President and Commanderin-Chief of the Armed Muhammadu Buhari should remove him with immediate effect.

Recall that the Governor of Central Bank of Nigeria (CBN), Godwin Emefiele, had on Friday picked the expression of interest and nomination forms to contest the presidential ticket on the platform of the All Progressives Congress (APC).

Emefiele's form obtained for him at the

office of party's organising secretary, at the International Conference Centre (ICC) in

Ákeredolu in a statement he personally signed in Akure, said the Governor Emefiele may be interested in immersing himself in the murky waters of politics like any other Nigerian partisan interests, adding that he enjoys a protected constitutionally right to belong to any group or association and participate fully, just as any



Nigerian.

He added that It was difficult for Emefiele who occupies the exalted and sensitive office Governor of the CBN to be brazen in actualizing his ambition.

His words: "The news of the purchase of Declaration of Intent and Nomination Forms to contest for the office of the President in forthcoming general elections, on the platform of the All Progressives Congress, purportedly by the

the Central Bank of Nigeria, Mr Godwin Emefiele, has been received with palpable disbelief and shock by many Nigerians. This act, unchecked, timeously, portends great danger to the fragile economy of the

"Rumours had been rife on the subterranean partisan activities linked to him through these shadowy characters in the recent weeks. Pictures of branded vehicles, ostensibly purchased for electioneering campaigns, were also posted on social media. The audacious moves by those who claimed to be supporting this interest have been unsettling.

"There is no gain asserting the obvious. The combined effect of the Public Service Rules, CBN Act and the 1999 Constitution, as amended, exposes not only the oddity inherent in this exercise of presumed right to associate. It also confirms the illegality of the act should he proceed to submit the forms while occupying the seat as Governor of the Central Bank of Nigeria."

arrangement, according to him, is a viable option which the PDP can explore because it will reduce contention and make the presidential primary election less acrimonious.

Elumelu gave this advice when one of the party's presidential aspirants, Hayatu-Deen, Mohammed met with the PDP House of Representatives caucus to seek their support for his ambition.

Recall that Hayatu-Deen and three others; Bukola Saraki, Bala Mohammed and Aminu Tambuwal went into a consensus arrangement which later broke down after the selection of Saraki and Bala by the Prof. Ango Abdullahi- led selection committee.

Hayatu-Deen and Tambuwal faulted the process which led to the selection of both Saraki and Bala as PDP northern consensus candidates.

However, Elumelu believed if carefully handled, the process of consensus can bring peaceful resolution of an acceptable recruitment process.

Elumelu said: "that brings me to the issue you were championing, which consensus. That brings me to the issue of the unity that all of you went around, crisscrossing this nation, seeking understanding amongst yourself, that are aspiring to lead this nation.

'I want to plead that you will continue in that strive. Nigerians are waiting for us; they're calling on us to rescue and rebuild Nigeria.

"Well, we can only do that If we also put ourselves in a position that Nigerians hope to see us, to rescue them and bring them back to where our founding fathers had wished that we should be."

The minority lamented the near total collapse of the socio-economic, political, security and infrastructural sectors of the country under government of the APC President Muhammadu Buhari.

He said: "when APC was coming, they promised Nigerians that we'll be able to sleep in our various homes, with our properties and lives secured but today it is a mirage. Our brothers and sisters that were kidnapped between Kaduna to Abuja bound train are yet to be rescued. One of our sisters had given birth where they are being held captive. That is the height of it.

'It is in this country only that a train will be leaving from Lagos to Ibadan and in the middle of the way, they will tell us the fuel has finished. It has never happened in other country or history of the world."

On behalf of the lawmakers he expressed confidence in the ability of Havatu-Deen to govern Nigeria and return the country to the path of

Earlier, Havatu-Deen said he is a detribalized Nigeria who will strive to unite the country.

He said: "even though I was born in Maiduguri, I'd hardly ever lived there for more than eight weeks at a time. So I've been in Nigeria where I went to school where I lived and commingled with Nigerians from all walks of life, regardless of background, regardless of geography, regardless of tribe or religion. So I have Nigerian blood flowing through my veins. It is too late at this time for me to be anything else, but a quintessential Nigeria."

He promised to fix the nation's economy because he is a shrewd economist that had served three Nigerian Presidents as Economic Adviser and a founding member of the Nigerian Economic Summit Group (NESG).

"I have been an adviser to three presidents on three presidential advisory councils. So don't blame me for the next thing that I'm going to say. I'm proud of what I did with every government. President-Elect Buhari had called me to join other Nigerians to put together a blueprint for his transition program. I was chairman of the committee on the economy and finance. I led the economic team. I want to let you know that we produced an outstanding document that can withstand the test of time, anytime, any day," he said.

As someone with a proven track record of transformation, he promised to unlock the potential and bring out the entrepreneurial energy that flows through the veins of Nigerians.

Presidential aspirant and Governor of Sokoto State, Aminu Tambuwal, has pledged not to abandon PDP if elected as President in 2023.

He said he has been a committed party man and will work closely with the party leadership as a sitting governor, not distancing himself from it.

He said: "when I get there, I will maintain interaction and consultation with the party and will respect the party's policy.

"I will be in constant touch with the NWC and the NEC, and will run my government with the party manifesto."

Tambuwaĺ gave assurance on Friday at an interactive meeting members of the PDP National Working Committee (NWC) at the party secretariat, Abuja.

Speaking about as the best uniqueness candidate that can win the 2023 election for the party, he said he has the right temperament for a leader and that he is a bridge across ethnic and age

He said he is one of the youngest presidential aspirants in the PDP while claiming that he is neither too young nor too old to be president.

Operators (AON) has Airline Nigeria announced a shutdown of operations, with effect from Monday, May 9, 2022 over the hike in cost of aviation fuel, which has reached an all-time high of N700 per

The operators sympathised with with passengers, saying current situation with Jet A1 has shot up the cost of operations to over 95 percent.

operators this in a letter its President, Alhaji Abdulmunaf Yunusa Sarina, sent to the Minister of Aviation, Senator Hadi Sirika, which was endorsed by the chief executives of all the domestic airlines.

letter is with a great sense of responsibility and patriotism that the Airline Operators of Nigeria (AON) have carried on deploying and subsidizing their services to our highly esteemed Nigerian flying public in the last four months despite the steady and astronomical hike in the price of JetA1 and other operating costs.

"Overtime, aviation fuel price (JetA1) has risen from N190 per litre to N700 currently. No airline in the world can absorb this kind of sudden shock from such an astronomical rise over a short period.

"In the face of this, airlines have engaged the Federal Government, the National Assembly, NNPC and Oil Marketers with the view to bringing the cost of JetA1 down which has currently made the unit cost per seat for a one hour flight in Nigeria today to an average of N120,000.

"The latter cannot be fully passed to passengers who are already experiencing a lot of difficulties.

"While AON appreciates the efforts of the current government under the leadership of President Muhammadu Buhari ensure air transport grows, in Nigeria grows, unfortunately, the cost of aviation fuel has continued

•Party's Lagos stakeholders endorse his re-election

Will Governor Babajide Sanwo-Olu be the standard bearer of All Progressives Congress (APC) in the 2023 gubernatorial election in Lagos State? This question has finally been answered by an open endorsement of the Governor and his Deputy, Dr. Obafemi Hamzat, for a second term in office by the APC National Leader, Asiwaju Bola Ahmed Tinubu and the entire members of the Lagos State chapter of the

Abuja Okada Menace: legislation our major challenge - DRTS Boss

The newly appointed Director of the Directorate of Road Traffic Services, Abdulateef Bello has said legislation is the major challenge toward the eradication of motorcycles popularly known as Okada in Abuja.

Speaking exclusively to The Trumpet over the week, the Public Relations Office Mr Kalu Emetu who spoke on behalf of the Director, noted that it will be difficult to eradicate okada without proper legislation. He, however, was optimistic that the directorate is doing its best to ensure that the Abuja transportation master plan is strictly adhered to.

Bello said, "Unlike other states where on the instance of the governor, the state House of Assembly will come up with a law that bans Okada, it is the National Assembly made up of eopie from different parts of the country that make laws for Federal Capital Territory (FCT). Most times they look at things in the way it affects their home state and try to bring the same here.

"We are struggling to make sure that the provisions of the Abuja transportation master plan is maintained. Though we are getting it right 100%, proper legislation has been a major challenge.

"You cannot just make a pronouncement that Okada has been banned. It has to be backed by law. And the administration is working hard to make sure that the law-making process is done in the way it's supposed to be done." Bello added.

He noted that the good synergy with other law enforcement agencies is yielding the much needed reward in curtailing traffic offences in the FCT.

"I'm glad that we have good synergy with other law enforcement agencies. We are making efforts to curtail the excesses on the airport road and other major roads in the FCT.

"The airport road is a presidential route and a gateway to the nation, that is where most visitors and investors to FCT pass through. It is an eyesore for Okada to be on Airport Road and other major Roads. Some may even be driving against traffic. What kind of impression are we giving to our visitors? That is why the new leadership of the Directorate is making the needed reforms and to enlighten the masses."

Bello reiterated that it is a huge security risk for Okada to be on a major road like the Airport road. He noted that the directorate will continue to educate

Okada riders on the risk involved.

He however disagrees that it is due to lack of enlightenment on the part of commuters that has led to the huge numbers of traffic offences and prosecution. He noted that though the directorate is working with a small budget which might not give the needed impact, he said that all forms of enlightenment have been deployed by the directorate to get the needed result.

While stressing that the huge number of prosecutions was part of the administration's effort in ensuring that the right things are done, the DRTS boss noted that in a recent meeting with the Okada union, which was an opportunity to enlighten Okada riders, the directorate gave the union the option of abiding with set rules and risk outright ban.

On the issue of trame gridlock in some major areas of FCT, Bello said it is due to the operation of illegal parks and the directorate has been working hard to ensure that the needed enlightenment is given to operators of the

"A few days ago we were at Area 1, Ărea 8 and Apo Bridge as part of our enlightenment and enforcement campaign. We

made them understand that if the park is filled up, they should move to another park. You don't have to drop or pick up people on the roads.

"From now on offenders are going to pay for training. We will take them to our training centers and educate them, the education is part of the enlightenment we are talking about. During that period their vehicle will be confiscated. All these are put together to serve as a deterrence to others.

DRTS boss sounds a word of warning that henceforth the directorate will no longer take lightly any attack on its personnel. He stressed that attackers will be prosecuted by the laws of the land.

Court slams Ekiti prince with death sentence for killing monarch, as judge throws out defence counsel's plea of insanity

An Ekiti State High Court, Ado Ekiti Division, has sentenced a 42 year-old prince, Ademola Ómoniyi, to death by hanging for killing the traditional ruler of his community.

Omoniyi was arraigned on one-count of murder contrary to Section 316 and punishable under Section 319 of the Criminal Code, Cap. C16, Laws of Ekiti State of Nigeria, 2012.

The charge read, "Ade-

mola Stephen Omoniyi on August 20, 2018, at Odo Oro Ekiti in the Ikole Ekiti Judicial Division, murdered His Royal Majesty, Oba Gbadebo Ibitoye Olowoselu ll, the Onise of Odo Oro Ekiti in the Ikole Local Government Area of Ekiti State."

A chief who testified before the court said, "We were at the palace on that day for the Onise-in-Council meeting around 7am. Before the commencement of the meeting, Ademola Omoniyi entered the palace and sat on kabiyesi's seat, but the chiefs frowned on his action and drove him away.

"After the meeting, the late Onise, in the company of his male clerk, was trekking back to the main palace when Ademola came out of his hiding and attacked kabiyesi with a knife on the road and stabbed him to death. Before that day, he had been parading himself as the king of the town."

To prove his case, the state counsel, Adegboyega Morakinyo, called five witnesses and tendered a medical report, statements of the convict, a knife and a rope, among others, as exhibits, while the convict spoke through his counsel, Tope Salami, and called no witness.

In his judgment, Justice Ogundana Olukayode dispelled the claim that the defendant was insane.

"Consequently, defendant, Omoniyi Ademola Stephen, is hereby sentenced to death and shall be hanged until he breathes his last," the judge added.

Police arrest alleged gang leader for homicide

Zamfara Police Command has arrested a notorious gang leader of an outlawed group, Yansakai for a case of culpable homicide and causing public panic in the name of celebrating Sallah.

A statement by the Police Public Relations Officer, SP Mohammed Shehu, on Friday, said the arrest of the gang leader followed a distress call from Tungar Dutsi community that members of the group invaded the village armed with guns and other deadly weapons.

It further stated that the display of weapons and sporadic shooting of guns led to the death of one Surajo Alhaji Ali, a 40 yrs old man.

On arriving at the scene, the leader of the gang, Bala Minister, was arrested while others fled.

The statement reads, "On 3rd May 2022, DPO Bukkuyum Division responded to a distress call from Tungar district of Bukkuyum LGA. accomplices and charge them

status with a tag, 'RIP'. The suspect, who is now in detention at the State Police Command Headquarters, Eleweran, Abeokuta, reportedly stabbed the victim to death around 11pm.

One of the deceased's friends, Onyemaechi Onwuzuribe, said Shogbola was given a hot chase as he attempted to board a motorcycle to flee the scene.

On seeing his bloodstained shirt, motorcyclists were said to have turned down his request for a ride.

The suspect reportedly raced to the Ilishan-Remo Police Station, where he handed himself over to the police.

Onwuzuribe said, "Federal was bloodied and I saw him running away though I did not know that he had stabbed Victor (Olabiyo). I knew that they fought earlier that morning over \$150 and as soon as I saw him running, I sensed that he must have done something.

"I grabbed him and just as I did, I saw people running after him and crying that he had stabbed Victor to death. That was when I and others tried to hold him, but he escaped and went to the police. If the boys had caught him, they would have lynched him."

The victim's brother, Adebowale Opasanya, told our correspondent that the deceased was a professional fashion designer.

He said the incident was shocking as the two friends were close and visited each other often.

"Victor's death was shocking to us. I am dazed that his friend, Federal, was the one who killed him just because of \$150. I had warned him about some of his friends, but I never thought Federal would do this.

Alleged thugs of Ojodu local gov chairman assault editor for challenging chairman driving on one way

Chairman of Ojodu Local Government area of Lagos State, Hon Odubakun, reportedly on Wednesday, May 4, 2022, assaulted editor of The SUPREME newspaper, Mr Aruga Joe Omokaro.

At about 11.35am, the editor was at Ogba bus stop, when the chairman in a black truck with tinted glasses and two other cars following, drove one way from Ogba bus stop entering Mokuolu Street.

Three traffic police officers in uniform (two are ASPs) from Area G Police Command, stopped the truck carrying the chairman and directed the driver to go back and take the proper turning, but the driver refused.

Apparently the chairman

would have ordered him not to mind the police. The police officers insisted not to allow the vehicle and the two others to take the one way route.

At that point, a scene was created and people gathered to know who was taking laws into his hands and would not obey the police

•Says S/West, S/ South presidential aspirants are not serious

Chief Edwin Clark, leader of the Pan Niger Delta Development Forum (PANDEF), has been at the forefront of agitation for a southern President in 2023. In this interview at his Abuja residence, he maintains the position that power must rotate to the south while urging southern aspirants not to accept Vice Presidential position from any northern aspirant. The elder statesman however declined comment on the rumoured interest of former President Goodluck Jonathan in the race among other sundry national issues. Politics Editor, TUNDE JOSHUA, brings excerpts.

What is going on within the political space, especially the South-West. to succeed President Muhammadu Buhari? As of now over 20 people have picked form from the South in the PDP and the APC. What is your take on this?

It is madness. If I'm to be realistic they are not serious; particularly the southerners from the South-West and the South-South. There are some people that have gone to be bottle bags to play double game. So when it comes to where we say no, some people would come out to say yes we are contesting. So they know why some of them are there. For instance, there are reasons to be told that my very good friend Adams Oshiomhole, the former national chairman of the APC was with Tinubu, I was surprised yesterday when I saw him entering the race. I'm also surprised that Amosun, after seeing the VP from his place in the race, also entered the race.


So you come back to the South-South, Jonathan was a Rivers State man before Bayelsa State was created in 1996. Today Nyesom Wike wants to be president of Nigeria, Rotimi Ameachi wants to be president of Nigeria both of them are in small Ikwere. You can imagine what is going on. I understand Timipre Sylva would soon declare. Meanwhile, people are asking me questions about Goodluck Jonathan and they are in the same senatorial zone in Bayelsa State. So they know what they are doing. And for the Igbo, some of them I encourage them to come out. If it is zone to the South-East the whole of Nigeria will vote for them.

I know that you belong to one particular platform, the eminent leaders of the Southern part of the country, what exactly are you going to say to these presidential aspirants in the Southern part of the country across the party divides?

A: I think the time will come, we must tackle them because of what is going on today. In the South-West from 1975 to 1979, a Yoruba man was the Head of State of this country after the death of Murtala Muhammad, Obasanjo was there for 3 years. when Abiola contested and won, they faulted him and then took over but they didn't last. But in 1999, Obasanjo came in with full force to rule Nigeria. At that time, Obasanjo had taken over the party; it was very easy for him to bring a northern candidate of his choice. So there was no contest of the primary major. But we don't have a doubt that Yar'Adua will win. So Jonathan became his running mate when Yar'Adua asked me to recommend the running mate to him.

Are you not surprised that both major parties PDP and APC were running away from being specific about zoning? Even when it was in the constitution of PDP but APC is also singing another tune about zoning. What is your position on this sir?

Thank you very much, that is a very good question. I used the word madness, now you have everybody in Nigeria where there is hunger, where there is lack of employment,

where there is kidnapping going on every day, where children cannot go to school, where the economy is going down, these people were able to mobilize N100 million to pick forms. So if these governors and ministers use their salaries, I don't think they have it because they must eat in their houses. But they then went back with pretence telling Nigerians we are fools; that their friends contributed money for them. El-Rufai sometime ago said that 19 governors met with Mr president, vice president and agreed that all the positions held by the northerners should be moved to the South and vice versa. So with that, the zoning has been done. So the South will produce the next president. Now that no southerner contested any position in the party which was zone in the north and because the chairmanship was zone to North Central, Abdullahi Adamu took over.

We strongly warn our politicians, former governors, ministers, senators and so forth not to accept running mate positions from any northern candidate because they cannot do without us and we cannot do without them. That will show how serious we are and anybody who offers himself as a running mate will be regarded as the most unpatriotic and a man who has sold his own side of the country and is not worthy of being respected and honoured.

What If the two dominant parties end up with northern presidential candidates te?

We are going nowhere. No southerner will like to see himself being treated as a slave or as a second class citizen. When he has the right of franchise than someone who believes in population alone. This matter was discussed at the national conference of 2014. Rotation is the only vehicle of unity in Nigeria and it was decided at that conference that there should be a power shift, there should be rotation

among the various ethnic groups or the various parts of this country if we are to have unity in this country. We were reaching there. And during the debate, I remember in particular I mentioned that in a situation whereby for instance in Kaduna State, southern Kaduna is bigger than the other part of Kaduna, the Zaria part yet they used religion and political authority from the center in suppression of southern Kaduna. So when, unfortunately, Architect Namadi Sambo was taken as vice president by Jonathan, the northerners instead of being happy, accused me in particular that we did it to make the deputy governor become governor of Kaduna State. Patrick Yakowa, mysteriously died in a plane crash and we were back to square one.

Go to Benue State, where the Tivs have been governing all the time at the expense of the Idomas. You go to Borno State the same thing. So, we took a decision, 18 more states should be created and they said the 36 states cannot maintain themselves because they are lazy. They have oil money and so nobody wants to work, their governors now stay in Abuja. So, created 18 states, four for the Igbos. It is on this matter those of us who were delegates again in 2005, Political Reforms Conference, set up by former president Olusegun Obasanio and the issues of the eastern region. The South East received five states instead of six. It was unacceptable. We recommended new states should be created immediately for the southeast zones. Then in 2014 National Conference, set up by former President Goodluck Jonathan, we recommended for the East to make it nine, northwest to make it nine, and three, each to the remaining four geopolitical zones to make them nine states each. That was our recommendation.

I would like to ask two questions about Jonathan. Do you think it is illegal for him

to contest as a president? And secondly, do you think he should run for president under the APC?

No comment from me I'm 95 years old.

Is it because former President Goodluck Jonathan is from Niger Delta? Your son? I don't want to respond

Did he discuss with you that he wants to join APC?
He has not.

So how will you advise President Muhammadu Buhari, INEC, and Nigerians about upcoming primaries and general elections, because there seems to be tension everywhere?

In the first place, I say categorically that we have no leader. Look at this country, do we have a president? For 34 days a train moving with unspecified number of passengers, luggages from Abuja to Kaduna, was bombed. A young lady a Doctor lost her life, about 30 people were admitted to the hospital, two of them died later in the hospital and about 70 of them were taken away. As El- rufai has always said, which forest in Nigeria is so difficult for the president to move into? And for 34 days the President of this country made no statement. We have people dying everywhere. About 70 people were killed in Benue, when the governor cried to Mr President, he said go and live with them. The question I am now asking is whether the president is aware of all the problems in this country? The number of killings every day, where a lady had to deliver a child in captivity.

We asked Mr. President the other day who is your candidate and his response was the man who won, but whether Nigerians are going to fight, whether things are going wrong he is not bothered. This is the man that said he will fight corruption yet presided over the levy of N100 million on forms for aspirants in the country that we say we are poor, where N30,000 minimum wage cannot be paid by some states, where pension cannot be paid, where some state can't pay gratuity. A professor receives 450,000 naira in a month and the vice-chancellor receives double. Then when the vice-chancellor goes back to the university as a professor, he will go back to earn a salary of N450,000. What ASUU is fighting for is not only for themselves alone. Develop our universities, provide facilities for universities, and modernize our universities.

I was Pro-Chancellor of University of Benin for 5 years. 3 years ago they named the Faculty of Management Sciences after me. Also a Pro-Chancellor, Federal University of Technology, Minna, they named the part of Engineering Faculty after me. Today the University of Benin is one of the largest. I have written a book on it. I have seen what the people are asking for. They are not asking for allowances for themselves alone, they are asking for things that will make learning better.

Nigeria's economy in comatose, says APC spokesman

Berates Osinbajo, says Tinubu has structure to win

The Presidency has reacted to the statement credited to the spokesperson of the Lagos APC, Seye Oladejo, over his claim that the nation's economy is in a bad state after about seven years of President Muhammadu Buhari in power.

Oladejo was obviously getting as the Vice President Prof. Yemi Osibanjo, following his declaration to contest for president in the 2023 general elections. He lashed at the presidency for failing to meet the expectations of Nigerians. He added that despite having a professor as the head of the economic team the economy of the nation is comatose.

But in a quick reaction, the Presidency took a swipe at Oladejo, stating that it was



a mistake for a party spokesman to abuse the legacies of the president because he wants to advance the aspiration of his preferred aspirant.

Senior Special Assistant on Public Affairs to President Muhammadu Buhari, Ajuri Ngelale in a statement made available to The Trumpet said that it is unwise for anyone under the guise of intra-party politics to criticize the achievements of Mr President.

He stressed that the act of condemning the legacy of this administration by the spokesperson of the Lagos APC due to his affiliation with one of the presidential aspirants was a misnomer.

Ngelale said, "I actively avoid politics, but it is necessary to state that as intra-party competition intensifies, the President's legacy should be protected at all times. For a party spokesman to abuse the legacy of the President to advance one aspirant is a mistake."

Oladejo lampooned the Osinbajo for daring to declare his interest to contest the seat of the president to truncate his godfather Asiwaju Bola Ahmed Tinubu's presidential ambition.

He described Osinbajo as a serial betrayal who failed to stabilize and grow the party using his office but prefers to empower his fellow pastors which is against the context and dictates of the constitution of the party and the 1999 constitution of Nigeria as amended.

"The news did not come to us as a surprise, except that it took forever for diverse reasons but he eventually summoned the courage to throw his hat into the ring and as he said, he was busy consulting and engaging in self-denial overtime about his interest to run for the office.

"It didn't catch us as a surprise and doesn't

change anything as regards who is calling the shots, as regards who is the leading aspirant, a presidential aspirant in our party APC.

There is no doubt that only one man has paid his dues in terms of fighting to enthrone democracy, in terms of making the reference point for good governance in Nigeria since the advent of democracy, in terms of being a fisher of men including the vice president himself. We believe that with the mammoth support he is enjoying in all the nooks and crannies of the country, Asiwaju Bola Ahmed Tinubu will definitely emerge victorious.

"I have read in so many media stocks about the issue of betrayal and all of that and people have really put this as they have started with Asiwaju but well it goes beyond that; betrayal should be put in perspectives. It should be put in context. It is multi-faceted; it is multi-dimensional. Betrayal of Mr President himself to the extent that the VP has not really been a stabilizing force as regards his activities very much in the media promoting his sector the Christian religion, the Pentecostal sect.

"The fact that all his appointees coincidentally have been pastors or members of the church. The fact that he has also betrayed the constitution of Nigeria, which in context and dictate promote secularity or the fact that he has not been able to contribute anything meaningful to the growth and development of APC as a party so the betraval is multi-faceted and I guess it is not really a big surprise that this coincided with the holy way, the windfall fashion where historically, the first betrayal took place," he added.

Following, the party spokesman in Lagos state said that the vice president cannot wrestle

the ticket with Tinubu in the southwest because, in the sojourn of his political career, the APC national leader was his pathfinder.

He said, "Actually put in succinctly, you don't challenge your father to a battle in the marketplace, politics or no politics I think there should be some sense of decorum, some morality, even in a political battle, by the way, Mr Vice President is definitely too old to be called Asiwaju's son.

"By trying to fight the battle, he has declared himself a minor to want to take on the might of the national leader of our party, who more than any other person contributed to bringing Mr vice president himself to limelight by appointing him as commissioner for justice and attorney general in Lagos and nominating him to be the vice president to President Muhammadu Buhari. The vice president has a whole lot of issues to clear. There is a big albatross on his neck so we'll see how it plays out," he added.

The Lagos APC spokesman in his outbursts noted that Osinbajo should be asked some salient questions about the economy of the nation because last he checked, it was within the vice president's purview to oversee the economic recovery plan of the nation.

Oladejo continued, "The last time I checked he has been in charge of the economy. The question Nigerians should ask is what is our net worth? Have our personal fortunes improved in the past seven years? And I dare say that this is a personal thing and is a personal failure of the man who holds the office and not necessarily the party.

"So these are fundamental questions that we're going to ask as party members and we also want to know politically what is he bringing to the table? Is he in a position to mobilize members of the party who have been likely deprived, who have been likely sacrificed as regards their interest and patronage of democracy for members of his church, which is clearly not in tandem with the spirit of the party constitution and constitution of the Federal Republic of Nigeria 1999 as amended? These are questions we are going to ask.

"There are issues bordering on the economy, unemployment, inflation, and a whole lot, so what is he going to give differently? All he said during his declaring speech was that he was going to continue what he has been doing before and I think Nigeria and Nigerians need someone with a clean slate in terms of personality and governance, not a reluctant president who can't take us to the Nigeria of our dreams," he added.

Nine PDP members in Kano Assembly defect to NNPP

Nine members of the Kano State House of Assembly elected on the platform of the Peoples Democratic Party (PDP) have defected to the New Nigeria People Party (NNPP).

The spokesperson of the Assembly, Uba Abdullahi, announced this in a statement he issued on Friday. He said the members have sent a letter to the Speaker of the House notifying the House of their defection.

He said some of the members cited a leadership tussle in the PDP at state and national levels for their action.

The affected members include Isvaku Ali Danja (Gezawa Constituency), Umar Musa

Gama (Nassarawa Constituency), Aminu Sa'adu Ungogo (Ungogo Constituency), Lawan Hussain Chediyar 'Yan Gurasa (Dala Constituency) and Tukur Muhammad (Fagge Constituency).

The others are Mu'azzam El-Yakub (Dawakin Kudu Constituency), Garba Shehu Fammar (Kibiya Constituency), Abubakar Uba Galadima (Bebeji Constituency) and Mudassir Ibrahim Zawaciki (Kumbotso Constituency).

Earlier on April 29, the House announced the defection of a member representing Kano Municipal, Salisu Gwangwazo, from the PDP to the ruling All Progressive Congress (APC), also citing an internal crisis in the main opposition party.

However, the latest defections are widely seen to be connected to the movement of a former governor of the state, Rabiu Kwankwaso, from the PDP to the NNPP.

Mr Kwankwaso moved to the NNPP earlier this year and is expected to run for president on the ticket of the party.

His defection has triggered the mass defection of his followers from the PDP to the NNPP where some of them have taken party positions ahead of the party's primaries.

30 Years on Throne: How Mai Gwari is viewed by his subjects

is Royal Highness Mallam Zubair Jibrilu Abubakar is the Mai-Gwari Traditional Ruler of Birnin-Gwari in Kaduna State, North-West Nigeria.

The 74 years old Mai-Gwari, who is very reserved, urban and highly educated, usually watches developments in his kingdom and the country with philosophical calmness.

On Saturday, 30th April 2022 the Mai-Gwari marked his 30 years on the throne. He was 44 years when he ascended the throne.

Although he holds very strong views on the socio-economic and political developments in the country, the Emir of Birnin-Gwari seldomly speaks on any issue because of his past ugly experiences, for speaking the truth to government. But whenever he chooses to speak about national issues, he is blunt and makes no pretence about it.

and makes no pretence about it. In April 2021 during the North-West Conference entitled "The State of the Nation and Contemporary Challenges in Nigeria," organized by the Arewa Research and Development Project, (ARDP) at Savanah Center in Kaduna, the Monarch lashed out at Nigerian politicians describing them as greedy and opportunist.

The Emir said, "Some politicians have capitalized on the high level of illiteracy and poverty among the people, to attain power."

He stated that "I have said this on so many occasions and so it's easy for me now to repeat what I have said in the past here. He then asked, "Why do we have failed politicians running local, state and federal governments? This problem could be traced to the people we consider to be politicians in our various

"In every area of the country, majority of the people, who pretend to be politicians, stakeholders, party chairmen and delegates in most elections, can't, in all honesty, be regarded as politicians in the true meaning of the word. As they are simply greedy and opportunistic in everything they do.

"This is part of the reasons, the country is not making any meaningful progress politically and economically as expected. Nigerian politicians do not care about the people in their immediate environment. All they want is to make money


no matter how distastefully and degrading the process could be. They do this because they want the generality of the people to continually troop to their homes for pittance and hand out. This is not supposed to be."

Mai-Gwari stressed that "Nigerian politicians use three things to subjugate the generality of the people in the country. They deliberately capitalized on the high level of illiteracy prevalent among the people. Knowing that it is very easy for the masses to be deceived and exploited once they are in that state in any society. Secondly, politicians again take undue advantage of the high level of poverty among the people and thirdly, very many of these politicians exhibit an unrestrained level of greed, which is shameful and un-Godly. These three qualities are so prevalent among our politics, thus making it very difficult for the country to have a workable political system that takes care of welfare and

well-being of the people."
An indigene of Birnin-Gwari, who simply wants to be identified as Al'Amin said, the Mai-Gwari forthrightness had made him an enemy to most people in the corridor of power. That is why the Emir of recent is maintaining a very low profile, so as not to continuously run into trouble with the power that be.

He continued, "Our Emir has a very rich background, he is one of the very few educated traditional leaders in modern day Northern Nigeria. If we had a good government in place, he needed to be consulted occasionally on several issues, before major decisions in our state, sadly this is never the case as we speak.

"His Royal Highness holds a first degree in English Language from Ahmadu Bello University, Zaria. He was among the first set of Nigerians that did the National Youth Service Corps (NYSC) in 1973. He served in the detunct Mid-Western Nigeria that is now Edo and Delta State. Thereafter he lectured at the College of Arts, Science and Technology, in Zaria. From there, he was transferred to Kufena College to teach English and Literature. He rose to become a Senior lecturer before going to Government Secondary School, Fadan Kaje, in Southern Kaduna. He was appointed the Vice Principal in 1975. In the year 1977, he was

posted to Rimi College in that same capacity as Vice-Principal. He was asked to open the first day secondary school in the North as its Principal. It was that same school that was later converted to be Tafawa Balewa way, Kaduna, which now metamorphosed into the Kaduna State University today.

"Our Emir as a young dashing teacher then was later transferred to the Kaduna State Scholarship Board as its Secretary in 1979. From there, he was again moved to the State Ministry of Education, while still in the State Ministry of Education, he was among the team that was mandated to establish Secondary Schools across the length and breadth of Kaduna state. An assignment he carried out with his team, with lots of diligence and efficiency."

Al'Amin added that "In 1981, the Emir whose name had become a household name in Kaduna state, was again pressurized to go into politics, unlike now, just because the people wanted a quality representation. It was then he became an active member of the People's Redemption Party (PRP) the then political party for the Talakawa, the downtrodden. After the un-ceremonial impeachment of

Balarabe Musa as the Governor of Kaduna State for not yielding to the underhand tactics of the majority members of the NPN led Kaduna House of Assembly, Abba Musa Rimi took over as the Governor of the State. It was then that Mai-Gwari was first appointed as the State Commissioner for Economic Planning. He was thereafter appointed again as the State Commissioner for Education. It was in that same year he contested for the Kaduna Central Senatorial seat, and he lost to the candidate of the National Party of Nigeria (NPN). Although there was obvious manipulation of that election, he did not contest the election in court, he went on to do other things. Just because he wanted to serve the people and not take undue advantage of them, as is the case today.

"The Mai-Gwari almost immediately got a job with the Peugeot Automobile Nigeria Limited (PAN) as Assistant General Manager (AGM) Commercial.

"When the Military Government led by General Muhammadu Buhari struck, Mai-Gwari was among the persons arrested in 1984 and thrown into Kaduna prison, just because he served

in the civilian government overthrown by the Military Government then. Mai-Gwari spent a year in Kaduna prison and was released in 1985. Some years after his release from the Kaduna prison, that was when he ascended the throne of his ancestors and became the Mai-Gwari of Birnin-Gwari. Since his ascension to the throne, Mai-Gwari had provided leadership in all ramifications of life. This we are most grateful about." He concluded.

Speaking in the same vein, Mallam Zubair Abdura'uf Idris, who is the Danmasani of Birnin-Gwari, says "the Emir's thirty years on the throne, had shown beyond any reasonable doubts, that he is a true leader not just a ruler of his people."

He stated, "Twice, the Mai-Gwari was queried for saying the truth and reflecting the feelings of the people in his Emirates over the insecurity situation in Kaduna. The insecurity the Mai-Gwari complained about then, had eventually grown today to become a national embarrassment. The Danmasani Birnin-Gwari said, it is gratifying to note, that after so many years, the powers that be kept on denying the exact security situation in Kaduna State, the Emir" has been vindicated.

Zubair regretted that "After fifteen years of the persistent assaults on our people and economy, resurfacing of criminality in the Birnin-Gwari axis of Kaduna State, which went on, for a very long time unchallenged, the entire state, has now become the epic-centre of kidnapping, armed banditry and all manners of crimes, which are now threatening the peace of the country."

The Danmasani Birnin-Gwari said the Emir is highly regarded by his brother Emirs across Northern Nigeria, because of his forthrightness. Saying the Mai-Gwari has consistently followed the virtues of the revered Sheikh Usman Danfodio. The Emirs in question admire the Mai-Gwari's deep knowledge of Islamic tenets, as he adjudicated on matters among his subjects which he regularly leads in congregational prayers.

He concluded, that the Mai-Gwari's humility, and consistency in whatever he does, stand him out among his peers wherever he goes. Thus bringing honour and glory to the entire Birnin-Gwari people and Emirates

Police arrest Lebanese for crushing lady in Lagos

Lagos State Command has arrested a Lebanese for hitting a lady, Omotomi Akinsanya, as a result of driving recklessly against traffic along Sanusi Fafunwa road, Victoria Island in Lagos.

According to the account of an eyewitness, Gbadamosi Damilola, the Lebanese, John Greg was on high speed and driving against traffic, thereby forcing pedestrians to take to their heels. Damilola said it was at the process that the suspect ran into Akinsanya.

"The man was driving on a one-way, against traffic and on was on high speed around Sanusi Fafunwa Victoria Island. People had to run helter-skelter for their lives. The driver then drove into Omotola and pushed her against the wall.

'The impact was so much that the plate number fell off. The driver did a hit and run, he absconded instead of waiting to care for the victim. A passer bye took a bike and chased after him. He was caught, brought back and handed over to the police," Damilola stated.

The victim was said to be severely injured and in critical condition. She is currently taking treatment at the Lagos University Teaching Hospital.

Confirming the incident, Police Public Lagos Officer, Benjamin Hundeyin, said suspect is currently in custody and further

in Tsafe LGA of the State, were said to have stolen large quantity of Aluminum conductor wire worth N800,000.00.

Their arrest according to a statement by the state Public Relations Officer, SP Mohammed Shehu, followed a distress call by the Area Manager of PHCN.

statement further stated that the suspects have confessed to the have committed the crime. Noting, however, that other fleeing suspects would be arrested by the Command as discreet investigation has commenced.

statement "The Zamfara State Police Command has arrested two (2) Suspects, Namely: Mubarak Aliyu and Sani Ahmed both 'M', 25YRS of age from Wanzamai Village in Tsafe LGA.

"The arrest followed a distress call received from the Area Manager, Power Holding Company of Nigeria, popularly known as NEPA, Tsafe branch, regarding the

vandalisation of Transformer other electrical installations in Wanzamai Village, where large quantity of Aluminium conductor wire valued at about Eight Hundred Thousand Naira (N800, 000) were removed.

Governor Okowa and he will not allow us to die in crisis.We need peace in Oleh as people cannot go to their farm because of fear," Alakri said.

Oleh women leader, Mrs. Itewor Juliana, commended Okowa for setting up the panel of inquiry and appealed to him to release the white paper for peace and justice. She added that Oleh is tired of war and wants to bury the 12 indigenes of the community whose bodies are in the motuary.

That viral video on bestiality

ast week, social media was set aflame by a video of a young Nigerian lady boasting that she had sex with a dog for a fee of one million five hundred naira only. The furore which it generated must have alarmed the lady. A few days later, she claimed in a remorseful manner that the dog-sex claim was a stunt to gain followers. The debate which followed suggests that bestiality is a widespread practice these days. The viral video therefore is a slice of our now degenerated lives that is mirrored by the social media. It is a comment on the degeneration on our core values. It reflects failed socializations at family, school, and religious levels.

The question is what triggers bestiality? The answer could be found in mankind's penchant for the abnormal, especially by a small minority. It also happens when humans refuse to give their souls to the Great Spiritual force of the Universe – God Almighty. They sell their souls to dark forces and sink into moral depravity. The result is all forms of bestialities like that viral video of a lady having sex with a dog!

Bestiality is as old as mankind. For this reason, the two major religions – Christianity and Islam - and our traditional society made laws to taboo the practice. Those core-values are what make man different from animals. Porn sites which are easily available with the advent of social media promote depraved behaviour. But bestiality exists in different forms in our world.

Ritual murder and pounding a day-old baby to be eaten for political power is a form of bestial behaviour. We also have terrorists, kidnappers, herders' killings, stealing and destructions in a bestial way. The level of man's inhumanity to man in our country is bestial in a sense. Bestiality does not start in a day. It has its origin in many factors. When Government removed religion and prayer from our schools, distorted curricular of Christian and Muslim Religious Studies, removed Civic Education, introduced new normal Human Rights Philosophy, strange political correctness, they were sowing the seeds of bestialities in our societies!

When parents do not train their children the way they should go, so that when they are old, they will not depart from such ways, as well as nurturing happy homes, they end up laying the basis for bestial behaviours in their children. Christ Jesus' Being is Life Eternal and not Death

't is quite weighty to brothers and sisters of other faiths to assert that Jesus Christ has power over life and death. The Incarnated Lord Jesus described Himself in various ways. This was to make His followers to truly know Him fully. In the Gospel according to St John, there are seven of such. (1). Bread of Life (John 6:35-51); (2) Light of the world (John 8:12; 9:5); (3) Door of the Sheep (John 10:7-9); (4) the Good Shepherd (John 10:7-9); (5) Resurrection and Life (11:25); (6) Way, Truth and Life (John 14:S6); and (7) True Vine (John 15:1-6). Today's meditation shall be mainly on the subject of life, as emphasised in John 11:25-26.

Jesus said to Martha, "I am the Resurrection and the Life. He who believes in Me will live, even though he dies; and whosoever lives and believes in Me will never die. Do you believe this?" The believer's answer to Jesus' question is a key to their faith and salvation. It is our prayer that we believe this! And that many who do not believe shall be brought to this faith in Christ's mercy.

Death is one of the most dreaded human phenomenon. It is a major theme in existential theology and philosophy. The meaningfulness or meaninglessness of life is paradoxically tied to how we conceive death. The reality and certitude of death have never been an issue of doubt, though the use and significance of death remain a mystery to us mortals. Jean Paul-Sartre thinks death signifies the meaninglessness of human life and existence; it tells of the nothingness of life. "What must be noted first is the absurd character of death," Sartre asserts.

But another philosopher, Martin Heidegger, position on death, as a human

reality, is totally antithetical to Sartre's pessimistic view about it. As a Christian philosopher, Heidegger viewed death positively. He felt that "the moment a man is born, he lives towards death, and each person has their death to die alone. Nobody can die your death for you. Human life is 'deathwards.' Heidegger pointed out that death makes man aware of his singularity, his individuality and his uniqueness. Death, in Heideggerian existentialism, imposes upon us our finitude and possibilities. Death tells us that life is brief. Consequently, we should put haste into our human calls and challenges. Heidegger puts his view powerfully by saying, "death becomes the meaning of life as the resolved chord is the meaning of the melody.'

The message Christ is passing to believers, in John 11:25-26 as in elsewhere, is that it is in His Being that human life can ultimately have meaning. Outside the Being of Christ Jesus human life is meaningless. Believers are therefore called to live in, through and for Him. To die in Christ is to live. In order to achieve this, believers are called to fulfil Christian conditions that are necessary for the attainment of eternal life such as to: follow Christ (John 6:37, 44, 45, 65); eat Christ's flesh and drink his blood (John 6:50-51, 53, 58); have knowledge and fear of God (John 17:2-3); forsake the world (Matthew 19:27-29); live right with God by forsaking sin (Romans 5:21; Revelation 2:7); believe and obey the gospel (John 3:15-19); obey God's commandments (Matthew 19:17) and

"And this is the testimony, that God gave us eternal life, and this life is in His Son. He who has the Son has life; and he who has not the Son of God has not life" (1 John 5:11-12). And this is how St John puts it in the Gospel he wrote, "he who believes in the Son has eternal life; he who does not obey the Son shall not see life, but the wrath of God rest upon him" (John 3:36). And to believe in Jesus is simply to have faith in Him and obey Him. A life of faith and obedience secure life eternal for believers.

Thus far, our exposition shows that Jesus Christ did not come, or rightly, Jesus was not given to the world by God (John 3:16) in order to bring death. He rather brought life. Death is an option the unbeliever has chosen. It is a consequence of the 'wrath of God.' Perhaps a better way of putting this is to say that ultimately, in Christian eschatology, there shall be those who will live for ever and those who will be put into a permanent

'second death.' Without going into the contentious hermeneutics of the millennial – premillennialism, postmillennialism and amillennialism - we read how the Bible records the question of choosing between Life (Jesus Christ) and death, "Then I saw thrones, and seated on them were those to whom judgment was committed. And also I saw souls of those who had been beheaded for their testimony to Jesus and for the word of God, and who had not worshipped the beast or its image and had not received its mark on their foreheads or their hands. They came to life, and reigned with Christ for a thousand years. The rest of the dead did not come to life until the thousand years were ended. This is the first resurrection. Blessed and holy is he who shares in the first resurrection! Over such the second death has no power, but they shall be priest of God and of Christ, and they shall reign with him a thousand years."

In Christ Jesus, believers are called and elevated unto a higher platform. "But you are a chosen race, a royal priesthood, a holy nation, God's own people, that you may declare the wonderful deeds of Him who called you out of darkness into His marvellous light. Once you were no people but now you are God's people; once you had not received mercy but now you have received mercy" (1 Peter 2:9-10).

Dr Prince Obed Ezeonye, Senior Pastor, Excellent Glory Christian Centre, Lagos, whether so many Pastors, who are today shepherding churches still hear from God?

Rev. Obed: Yes! Some Pastors, not all the people who claimed to be Pastors today hear from God. We must not deny the fact that some people are into the Ministry, just to make quick money. Despite this deplorable situation, Pastors sent by God are still able to do exploits.

It is therefore easy to differentiate these Pastors from the other characters. For example, when the voice of God led to the presence of Christ, John collapsed in the presence of the Lord. A deluge flooded the cave as Christ opened His mouth; His voice sounded like the noise of many waters. John said that many waters were in His voice, but the fire was on His feet, Effective communication is always transmitted from the base of burnt feet. John said Jesus' feet looked as if they had been in the fire. What a comfort to the indicted character of this Pentecost preacher to find that the feet of his Consoler had been through the fire. Dearly beloved, hear me today: Your Deliverer has feet that have been burnt. He knows what it feels like to be in the fire.

Trumpet: What will you say is the reason, why people are becoming very sceptical about Christianity and Islam?

Rev. Obed: Well, let me remain in my lane, I can only speak about the possible reasons why people are becoming sceptical of Christianity, not Islam. The truth is that, when we talk about religion, we should understand that religion is spiritual. We should also not fail to understand that there is an enemy called Satan, who is coming from different angles to fight the church. It is this Satan that is out to fight religion to give different colourations to what religion is supposed to be. This is where the problem lies. Many people who do not understand this spiritual aspect of religion, easily get misunderstood and carried away.

It is just like you have an enemy, and this enemy is after you, all you need to do is guide yourself against the attack of the enemy in question. You, therefore, need to fortify your stronghold. Because any little advantage the enemy will penetrate and use against you, this is exactly the problem the churches are facing today.

The point we should therefore not ignore is that, for every counterfeit, there must be an original elsewhere. So no matter the kind of misconception about the Christian religion, and the misunderstanding the enemy is bringing about religion that does not mean that religion is not there. Now, coming to the people, who are trying to merchandise the people already in the faith, these same people who are trying to merchandise religion for personal gain, this is a reality we must not rule out or discountenance because it is here with us in reality.

A deeper look inwards has shown that the popularity of modern-day Christianity is what is responsible for its being counterfeited. Yes!

There are people doing all within their powers to adulterate the Christian religion and faith. I must say that this doesn't preclude the fact that there are still lots of good Christian leaders, who are genuinely called by God. These men of God are there for the real reasons of their callings. It is therefore wrong for us to assume or generalize that true Christian religion or practice is no longer there.

Trumpet: What did religion really stand for, from your point of view?

Rev. Obed: Let me attempt to draw a thin line between religion and what Christianity is all about, from a general point of view. Religion is an act of man desperately trying to know God. It is an act of one seeking God. The thin line between what we call religion and Christianity is therefore as follows. While religion is the act of man seeking God, Christianity is the act of God seeking man. The bible says, "For God so loved the world that he gave his only begotten son, that whosoever believes in him, shall not perish. But have everlasting life." From the foregoing, you can see clearly that it is God that is seeking man at this particular point. That is Christianity for you.

But the general idea about religious practices is an act of man seeking God, in the process, mankind degenerated into several acts of worship, both the good acts and the bad ones.

Trumpet: What would you say is responsible for the present-day commercialization of Churches and Christian religious practices by some Pastors?

Rev. Obed: The scepticism about Christianity and its faith, is borne out of what I earlier said, the reason why we have counterfeit in anything we do, is because we do have an original elsewhere. It is not everybody that has commercialized the act of faith or religion. It is not everyone that has gone into Christian religious practice to enrich himself. No! Be far from this belief. Let me tell you, when one is honestly serving God in spirit and truth, God will bless the person. Those who are trying to go the extra mile to do it on their own, are bound to incur the wrath of God in the process. But when we

go the way of God, follow God's principles just like what I am presently trying to do in 'Double Diamond' trying to change the mindset of people for good, change their thinking, and let them know that it is still possible to become prosperous without corruption. Make believers know that it is possible to make money, without crime or killing anyone.

It is a known fact today, that many people to get rich, have gone into all manner of rituals, and some others have gone into drugs, especially some of them who are putting on cassocks. Some of these people claimed to be in the faith. These types of people are also found in other religions. They use their faith as a cover to commit all manners of crimes. These acts are against God's will.

As you must know, most of these people are already reaping what they sow aside from all this nonsense, some people are genuinely serving God. They are daily preaching faith, and in the process of doing the things that please God, and you see God blessing them.

For example, there are frontline churches around the world and in Nigeria, that are preaching holiness without even concentrating on preaching prosperity and money and what have you, some of these churches are still being blessed. The fact that must not be lost is that when God calls a man, he gives such a man messages because for every messenger, there is a message.

Now if God has called me to the area of healing, and asked me to preach healing, I have to stay in that stream, to make progress. I have to remain in that stream and continue to do what God has asked me to do, so long as I am doing what God has directed me to do, the same God will bless me. And if God has called his messenger and asked him to preach prosperity, if such a person is doing what he or she is asked to do genuinely there is no way he or she will not be blessed.

Now, what happened with this prosperity thing, which most people are fraudulently abusing today in the name of Christianity, when you look at the history of Christianity some years ago, you will discover that there is this phrase that was used then, 'as poor as the Church rat.' In other words, in those days, it was difficult to see somebody rich in the church. It was difficult to see someone riding a good car in the church. Even Pastors in those days, go about their duties with bicycles. At that time, Satan was very happy. It was about the 19th century, just before we stepped into the 20th century, that God began to give a balanced message, that people can be serving God and become rich. In the churches of old, people were running away from serving God, because they did not want to wear the toga of poverty. But today, glory to God, that is no longer the case, hence, the proliferation of churches. Despite what people have to say, we still need a lot of churches, because it takes different types of churches to reach different types of people.

Haven't said all these, it doesn't mean that one should take the opportunity God has given him or her to exploit other people and enrich themselves. As a person, I am of the strong belief that if I am doing the will of God, God will one day bless me. God will enrich me. Because taking from the covenant fathers, none of them was poor. Abraham was not poor. Isaac was rich and successful. Isaac was a farmer, in Genesis 26:11, he said, Isaac sowed and reap in the same year, a hundredfold. Jacob was an institution himself. When we, therefore, follow the antecedent and understanding, and historical parts of where we are coming from, we will see that when we are serving God in truth and spirit, God will bless us. And when we talk about prosperity, it encompasses peace, wealth and what happens to you as a person.

Trumpet: Now that most Pastors are getting off the way of preaching the biblical doctrines, the way it is, what should be done to correct them?

Re. Obed: In the Christian faith, there are already established bodies like the Christian Association of Nigeria (CAN). We also have a body like the PFM, these bodies should serve as strong regulatory bodies. Once a Pastor or group of Pastors and the church members are going out of the established tenets, or the doctrines of the church, they can quickly correct these people and bring them to order. I am of the strong belief that these bodies are already doing this.

Apart from this, I will also want to say that all these types of religions, if you like to call it ministerial rascality, if you look at the people involved in these acts, they have no people they are submitting their ministries or themselves to. I am talking about mentoring. They have no mentor. If you have a mentor, to whom you submit yourself, you'll be careful, because whatever you do, you know, someone, somewhere, is watching over whatever you do or say. And if you are getting out of line, and your mentor calls you to order, and you refuse to listen to him, you will be disowned or excommunicated in the process. The truth is that most of the pastors causing all these problems, do not have people they submit to. They do not have mentors. They do not have Ministries they are looking up to. It is advisable that anyone that is called into the Christian Ministry should look for a mentor that has the same pattern of Ministry, to submit. Once this is done, it will help the Pastor, and his ministry to mentor the person, in the way and manner he does his things.

As a Pastor, I am very careful about whatever I do, because whatever I do, negative or positive, will be regarded as the practice of where I am coming from.

From the above, I might be regarded as not representing my roots very well. Even without me saying who is my mentor, once I am preaching, people with discerning minds will immediately know where I am coming from. If I try to go contrary to the doctrines known with where I am coming from as a Pastor, the leadership of my root will pick on me, and say, you are not representing us well.



May Day Celebration: Dilemma of Nigerian workers

On May 1, 2022, Nigerian workers joined their counterparts all over the world to celebrate the International Workers Day as it is called in some climes. While workers in most climes look forward to expectations of the good plans the government has for them, that is hardly the case with Nigerian workers. May 1 every year has become a day for Nigerian labour leaders to celebrate their pains, sufferings and deprivations of the government, **JOHNMARK UKOKO** writes.

International Workers Day came into effect in 1889 to celebrate workers' struggle, following the fallout of Hey Markers Affairs in Chicago, United States of America, where workers led a protest to insist on working for eight hours instead of 12 hours daily, besides other welfare issues.

From the days of pioneer labour leaders in Nigeria like the late Michael Imoudu, who fought the colonial masters to a standstill with the strike he organised in the 1950s to late Pa Sumonu and Adams Oshiomhole the country's labour movement has consistently engaged and fought successive military regimes on several issues, such as fuel scarcity, minimum wage, increases in fuel prices and other socio-economic issues.

Labour leaders like former Secretary-General of National Union of Petroleum and Natural Gas (NUPENG), Chief Frank Kokori, held the General Ibrahim Badamasi Babangida regime in the jugular, as the strike led by Kokori totally paralysed the country in a bid to force the IBB regime to reverse the annulled June 12, 1993, presidential election, believed to have been won by the late Moshood Kashimawo

The NUPENG strike was the mother of all strikes the country's labour union ever organised as the entire country was paralysed for over three months. Kokori who was later arrested and detained for years with several other labour and their civil society activists showed that organised labour could be truly powerful and should not be ignored by any reasonable government.

In the heydays of the current democratic dispensation, Oshiomhole also gave former presidents Olusegun Obasanjo and Goodluck Jonathan a lot of headaches, as he consistently organised strikes and protests by calling out Nigerian workers to protest against the constant increases in the prices of petroleum products and induced scarcity.

On several occasions, Oshiomhole was arrested and brutalized in the course of leading workers to protest one government policy or another to the extent that it took the efforts and interventions of the late Gani Fawehinmi to deliver the labour leaders from the country's security forces and the law courts.

However, in the last decade, it appeared that the Nigerian workers have lost their voice and have been unable to champion the cause of the workers, especially as the President Muhammadu Buhari has increased the prices of petroleum products by about 300 per cent without any protest or action from the Nigerian Labour Congress (NLC) and the Trade Union Congress (TUC).

The famous NUPENG strike led by Frank Kokori in the 1990s had been seemingly forgotten despite the challenges and hardship Nigerian workers and citizens have had to grapple with. The same is true of the Petroleum and Gas Senior Staff Association of Nigeria (PENGAS-SAN), which was also considered very resilient, but seemed to have lost its teeth.

Also, the once-powerful Academic Staff Union of Universities (ASUU) that was dreaded by the government during the days of the late Prof. Festus Iyayi, Prof. Itsye Sagay, and Prof. Atahiru Jega and several other brilliant academicians appear to have lost their verve.

On May 1, Nigerian workers joined their counterparts in the world to celebrate International Workers Day, a day set aside every year to advocate for better working conditions and environment.

Speaking at the occasion on the backdrop of hardship foisted on them by the current administration, President of NLC, Comrade Ayuba Wabba, urged the workers to register for their Permanent Voters Card (PVC) and ensure that they vote for credible politicians, who will improve their lot in 2023 and

He charged them to make their voices and votes count ahead of the 2023 general elections, insisting that the country's workers were grappling with shortage of foodstuff, and hyper-inflation, while most youths of the country remain

He pointed out that the workers were celebrating the international worker's day at a period their morale was down and pleaded with the Federal Government and other tiers of government to heed the worker's cry. As expected, because the country was heading towards the general elections, the Vice President, Prof. Yemi Osinbajo, who represented President Buhari during the worker's parade at the Eagle Square, Abuja, commended the workers for their resilience, steadfastness and dedication to

Buhari, who said his administration was doing everything within its powers to address the myriad of challenges Nigerians were contending with, pledged that the presidency was addressing the insecurity and economic challenges frontally, adding that the government appreciate the sacrifices workers and Nigerians were making to ensure that the country overcame its many challenges.

Also speaking at the event, President of the Senate, Ahmed Lawan, assured workers that the National Assembly will continue to partner with organised labour to address issues relating to them.

Lawan charged ASUU to ensure a

speedy and amicable resolution of its three months old strike, saying: "Nigerian workers deserve our appreciation and respect for their contributions to the development of our country. I also salute them for their cooperation with the government and other institutions in our collective efforts to address societal challenges."

On his part, National Leader of the All Progressives Congress (APC), Bola Ahmed Tinubu, said workers remain the unsung heroes of society, adding: "Labour's work helps to define our nation and the goods and the services its members provide are the basis of our collective wellbeing. Today is worker's day. It is a day for us to fully celebrate the Nigerian workers.'

Governors were not left out in the praise of organized labour, as they also trooped to their various state capitals, where workers were observing the yearly rituals to celebrate with them.

In Edo State, Governor Godwin Obaseki, who assured workers that his administration would continue to prioritise their welfare, announced a N40, 000 new minimum wage for civil servants of the state.

Lagos State Governor, Babajide Sanwo-Olu, urged the workers in the state to remain productive and committed to their duties and assured them that his administration would continue to accord them all their entitlements at all times.

Governor Dapo Abiodun of Ogun State, who joined workers to celebrate the day at the Moshood Abiola Stadium in Abeokuta, commended the workers for their loyalty, professionalism and perseverance in the face of the global economic challenges.

He assured the workers of better years ahead as he pledged to settle all outstanding gratuities, deductions and other welfare packages.

But in Kaduna State, NLC Chairman, Comrade Ayuba Suleiman, lamented that the state workers' productivity and their safety have been largely affected by banditry, terrorism, killings and kidnappings generally ravaging the state and other parts of the country.

He, therefore, urged the Federal Government to rise to its responsibility of protecting the life and property of the country's citizens.

Even as several speeches were rendered and goodwill messages sent across the country by politicians, respondents expressed reservations that talk will always remain cheap, but it is left to be seen how the various promises by the political leaders are implemented.

They maintained that this had been the worst time in the country's history with kidnappers, terrorists and bandits freely roaming the streets and cities and unleashing mayhem on citizens of the country.

Bandits and unknown gunmen have sent many Nigerian workers to their early graves, while many have been forced to pay huge amounts of money to regain their freedom.

The ongoing Russia -Ukraine war has further compounded the worker's plight, as they now grapple with high inflation, which has soared to over 17 per cent at a time most Nigerians were losing their jobs.

The celebration of this year's International Workers Day has come and gone, but beyond the parades and celebration, what is the hope that the Nigerian worker will experience a better tomorrow?

Beyond the long speeches by labour and political leaders, what benefits will now accrue to workers from the yearly rituals? With the dehumanising conditions Nigerian workers are being subjected to daily by private and public employers, does the celebration of the worker's day still have any benefits for the workforce?

By the time Nigerians celebrate the next Workers Day on May 1, 2023, will workers look back and say they have achieved the various promises the government made to them on May 1, 2022?

These questions and more become pertinent in the light of the workers' dilemma and government's insensitivity to their plight under the current reality

The years ahead will determine if the celebration of May 1 every year still has any meaningful impact on the Nigerian workers.

ONICCIMA seeks govt partnership in Anambra market reforms

Expert attributes NGX rally to uncertainties in fixed income market

An expert in the fixed income market and Managing Director of ARM Securities Limited, Rotimi Olubi, has attributed the sustained rally in the Nigerian economy in recent times to uncertainties expected to persist until the third quarter (Q3) when fixed-income yield will peak.

He explained that the development would encourage more inflow of funds into the stock market, stressing that the rally would persist and that the stock market was currently thriving due to liquidity flows from the fixed income space.

Olubi, who revealed that the NGX All-Share Index (ASI) recorded a growth of 5.6 per cent in April 2022, noted that the ASI, which opened for trading during the period at 46,965.48 rose by 2,673.46 points to close trading in April at 49.638.94.

On the sectors that would drive the stock market in the coming months, Olubi said consumer goods, agriculture and oil and gas sectors were likely to be the major drivers.

Speaking on the foreign exchange drivers, he said that multi-listed companies such as Airtel Africa, Seplat Energy and Exchange Traded Funds would drive the stock market rally.

"The recent uptrend in performance in the Nigerian Stock market is expected to roll into May, June and July 2022. We expect this to thrive on several factors, among which we have an uptrend in yields, encouraging earnings performance setting the tone for a nice full year for tickets in June," he stated.

He added that the uncertainties

He added that the uncertainties might persist till early Q3 when fixed-income yield should peak.

BENCCIMMA doubts Edo MSMEs' ability to pay N40,000 minimum wage

The Benin Chamber of Commerce, Industry, Mines and Agriculture (BENCCIMA) has expressed concern and doubt over the ability of Micro, Small and Medium Enterprises (MSMEs) firms in Edo State to pay the N40,000 new minimum wage announced by Governor Godwin Obaseki.

The Trumpet recalled that Obaseki announced a N40,000 new minimum wage, against the Federal Government's approved N30,000 on May 1, 2022.

However, the President of BENCCIMA, Mrs Aina Omo-Ajeonu, who spoke in Benin City, said it would be a huge burden and difficult for the private sector to pay the new minimum wage as announced by the governor.

She said that based on the current situation in the country, most members of the chamber were not in a position to pay the new wage.

We can't afford it because

the business environment is not conducive for us. We are still grappling with poor power supply, poor infrastructure and high cost of doing business. But it is good for the state government workers, as it will help increase their purchasing power," she said.

Omo-Ojeonu, however, said Obaseki's announcement would cause further inflation in the state, adding that prices of goods and services would further increase, as sellers of goods will believe that the people's purchasing power has increased.

She disclosed that the state government did not consult the chamber before the announcement was made.

It would be recalled that with Obaseki's announcement, Edo State public service workers are now the highest paid in the country, as most other states are still paying the N30,000 minimum wage President Muhammadu Buhari announced about three years ago, even as some are still struggling to pay.

It will also be noted that some

states are still paying N18,000 old minimum wage that was approved about twenty ago by former President Olusegun Obasanjo.

Businessman laments Nigeria's harsh operating environment

Managing Director of Liberty Industries Limited, Jamal Abuh, has lamented that local manufacturers in the country have been going through harrowing experiences in the past few months.

Abuh stated this in an interview with The Trumpet, saying that the little growth the manufacturing firms were recording after the COVID-19 pandemic had been subdued and eroded by the impact of the Russia-Ukraine war.

He revealed that Liberty Industries which is into packaging, plastics, PVC, nylon bags and assorted items was experiencing the impact of the war, which he said was impacting negatively on the local manufacturing firms.

He also pointed out that the recent plunge in public power supply further compounded the challenges of local businesses, adding that diesel now sells beyond the reach of the country's small businesses.

"The war in Ukraine has almost crippled our businesses. We are unable to afford the diesel which is now sold for between N700 and N900 per liter. As if that is not bad enough, the public power supply since the beginning of the year has nosedived. We used to enjoy between 12 and 16 hours of public power supply daily.

"But since February this year, we are told that the national grid has collapsed on four different occasions, which has made power supply very epileptic and unreliable. Yet, electricity bills continue to rise every month." he lamented.

He disclosed that due to the constant increase in bills, his firms have had to make do to break even, adding that the demand for his products had drastically reduced.

Abuh further lamented that most

of his colleagues have been forced to close shops due to the harsh operating environment, maintaining that he had to reduce the number of his workforce to less than 40 percent, as his firm was unable to pay for diesel to power his plant for several hours.

"I now operate my factory for between six and eight hours daily. As such, I have to ask half of my workers to proceed on compulsory leave without pay. I have to ask about 20 percent of my employees to be coming to work three days per week, while the remaining will work as long as there is public power supply. Factories are not run that way," he stressed.

He, therefore, appealed to the Ikeja Electricity Distribution Company (IEDC) to increase the number of hours it supplies electricity to the industrial areas in Lagos State.

Telecoms firms seek 40% tariff hike over high cost of business, inflation

Telephone users in the country may have to pay more for making calls, as telecommunication operators have submitted a proposal to the Nigerian Communications Commission (NCC) to increase their tariffs by as much as 40 percent as the country's inflation rate surges higher.

The plan is to raise the cost of making calls by subscribers to N8.95 from N6.4, while the price cap of SMS will increase to N5.61 from N4.

In a letter to the NCC titled: Impact of The Economic and Security Issues On the Telecommunications Sector, the telecom firms said there has been a 40 per cent increase in the cost of doing business in the country.

In the letter written under the aegis of the Association of Licensed Telecommunication Operators of Nigeria (ALTON), they noted that the telecommunication sector has been financially impacted following the nation's economic recession in 2020 and the impact of the Russia-Ukraine crisis.

The body also cited the recent introduction of excise duty of five percent on telecommunication services had further increased the burden of multiple taxes and levies on the industry.

"In view of the foregoing, ALTON considers it expedient for the telecommunications sector to undergo periodic cost adjustment through the commission's intervention to minimise the impact of the challenging economic issues faced by our members.

"We seek an upward review of the price determination for voice, data and SMS. Given the state of the economy and the 40 per cent increase in the cost of doing business, we wish to request for interim administrative review of the mobile (voice) termination rate for voice administrative data floor price and cost of SMS as reflected in extant instruments.

"With respect to voice SMS cost, ALTON respectfully requests the commission to consider a mark-up approach to address the upward price adjustment desirable for the industry," the

Custom seizes over 12 trucks with imported toxic rice from India By ADAKU WALTER rice into the country, some of the

The Federal Operations Unit (FOU), Zone A of the Nigeria Customs Service (NCS) has said over 1, 000 bags of foreign parboiled rice in the seized 12 trucks imported from India contain toxic malleable metallic element, otherwise known as lead.

The Acting Comptroller, Hussein Ejibunu, who disclosed this to journalists in Ikeja, said the truckload of rice totalling about 7, 259 bags were smuggled into the country through the country's western neighbour- Republic of Benin.

According to him, after the seizure, a laboratory test was conducted by the National Agency for Food, Drug Administration and Control (NAFDAC), which revealed that over 1,000 bags of rice branded 'SIMBA' contained lead, thereby making them poisonous to human consumption.

He said part of the negative economic impact of importing foreign

rice into the country, some of the imported rice were unhealthy for human consumption, and therefore, advised consumers to desist from patronising prohibited foreign parboiled rice.

He said other impounded items include, 55,800 litres of Premium Motor Spirit (PMS) or petrol, 73 bales of used clothes, 82 units of used fridges, 104 pieces of compressors, 143 bales of textile, 1,264 pieces of used tyres, 156 cartons of frozen poultry, 7,960 pairs of shoes, 240 pieces of ladies purses, 93 cartons of tin tomato, 11 pieces of used rugs and two units of foreign used vehicles with a duty paid value of N533 million.

Apart from Federal Government's policies geared towards the protection of the local economy against foreign competitors, the government prohibited used clothes, fridges, compressors and used tyres, among others; because of their effects on the security, health and the economy.

'Federal, state governments to generate \$201b from taxes, duties in Lekki Port'

•Nigeria to regain lost maritime businesses from Togo, Ghana, others

Minister of Information and Culture, Lai Mohammed, has said the Federal and state governments will generate about \$201 billion through taxes, royalties and duties from the Lekki Deep Seaport.

He said the port would have a great impact on the economy by creating about 169,972 jobs and enable Nigeria to regain the maritime business earlier lost to ports in Togo, Cote d'Ivoire and Ghana.

Mohammed stated this during inspection of the port with the team from the Ministry of Transportation, said with the port will become a trans-shipment hub, noting that the revenue the country had been losing to neighbouring countries would be regained

would be regained.

He said the commencement of the port operation in the last quarter of this year, will also boost

Nigeria's economy in its quest to take advantage of the implementation of the African Continental Free Trade Agreement (AfCFTA).

"The investment is huge for \$1.53 billion on fixed assets and \$800 million on construction, but the aggregate impact has been projected at \$361 billion in 45 years, which will be over 200 times the cost of building it. The direct and induced business revenue impact is estimated at \$158 billion in addition to the impact on manufacturing, trade and the commercial services sector," he said.

Managing Director of the Lekki Deep Seaport, Du Ruogang, said the port would change the economic landscape of Nigeria and become a central hub in the West and Central African regions.

African regions.

He said the second phase of the port will commence between six and seven years, adding that in the long-term, the third phase of

the port would be developed and appealed to the Federal Government government for support in the trans-shipment policy, which he said, remains an important target for the port.

He also sought government's support in the cargo evacuation system, noting that the roads connecting the port were not satisfactory to the demands of the evacuation requirements of the port.

General Manager and Head of

Government Relations and Security, Lekki Freeport Terminal, Fubara Awanta, said with the port's draft, which is the deepest in West Africa, Nigeria should not lose the huge revenue that it would generate to several bottlenecks.

He appealed to the government to ensure that the major roads connecting the port should be completed to boost cargo evacuation as short-term support, while in the medium-term, government should assist in ensuring movement of consignment through barging.

peration Plan Edo,' an exercise aimed at recertifying building plans and collecting data on socio-economic needs of communities in Benin City, the capital will be kicked off by the state government.

Commissioner for Physical Planning, Urban and Regional Development, Isoken Omo, during a press briefing, said the exercise, which will commence in the Ugbor area of Benin City, is an expansion of the 'Operation Show Your Building Plan.'

She thanked those who have complied with 'Operation Show Your Building Plan' exercise, assuring that all applications have been fast-tracked and that over 400 approvals will be granted to those who have already gone through the process.

She noted that the state government through the programme will be able to collate needs of communities which in turn will enable it to provide relevant services to Edo people.

According to her, "The programme enables the government to know what services and infrastructure the people need. The 'Operation Plan Edo' will involve various ministries, such as Education, Roads and Bridges, Health, Power, among others".

She called on citizens to cooperate with officials of the ministries and provide necessary information to help plan the city and State in line with the 30-year master plan.

Condemning attacks on its staff by residents, she warned: "Edo State Government frowns at the attack on Staff of Ministry of Planning, Urban and Regional Planning on duty. Government is concerned about the ugly incident and has vowed to bring the perpetrators to book to serve as deterrent to others."

Meanwhile, Edo State Coordinator of Nigeria Erosion and Watershed Management Project (NEWMAP), Dr. Tom Obaseki, has canvassed media collaboration in driving the conversation on flood control as the rains intensify.

Obaseki made the submission at a flood engagement workshop organised by the agency in Benin City, the Edo State capital.

He stressed that beyond government action and infrastructural intervention, there was need for all stakeholders, particularly the media to con-

tinue to sensitize the people so they can take ownership of flood control efforts and change their attitude towards environmental protection.

According to him, "The media has a crucial role in spreading information in bridging the knowledge gap and enhancing public awareness. The media chooses which issues to highlight to its viewers and how to frame them, influencing what people perceive to be a priority.

"When the public discussion about a particular topic is structured in such a way that it creates a sense of outrage and menace, people will put pressure on their leaders to put that issue at the top of the political agenda.

"The manner in which the media presents information shapes audience perceptions. When communicating a message, the media transmits not just the content of the message, but also their interpretation of

Highlighting the state government's intervention in tackling erosion in the state, Obaseki said that the state government has built a total length of over 40 kilometers of secondary drains.

"We have built a total length of over 40kms of secondary drains. This excludes over 400km constructed by other ministries and agencies; over 14kms of primary stormwater culverts, drains and over 4km of earth storm water channels. This is more than what has been done by any other government in the history of the state.

On his part, the Resident Engineer and ZUTARI Consultant, Mr Almeroux Loubser, said global warming has contributed to the excessive rains while advocating for use of green energy solutions to reduce burning of fossils.

Also, Edo State Primary Health Care Development Agency (ESPHCDA) has urged stakeholders to collaborate with the government across all levels to sustain awareness campaigns on regular hand washing to prevent diseases.

The Executive Secretary, ESPHCDA, Dr. (Mrs.) Otaniyenuwa Obarisiagbon, made the submission in commemoration of the 2022 World Hand Hygiene Day in Benin City.

She urged healthcare workers, parents and other stakeholders to adopt the culture of washing hands frequently in order to prevent diseases.

She said, "Healthcare workers are to ensure proper handwashing with soap and water before contact with patients, before a sceptic procedure, after contact with patients' body fluids, and after leaving the patients surrounding in line with the World Health Organisation's 5 moments of hand hygiene.

"This will help protect the health worker as well as others from diarrheal diseases, Covid-19 and others. The use of liquid soap for hand washing is better than bar soap, especially in our health facilities.

Obarisiagbon noted, "When the hands are visibly dirty, washing hands with soap should be done rather than using alcohol-based hand sanitisers."

She added, "Special attention should be paid to the fingertips, the thumbs, the inter digital spaces between our fingers, the back of our hands, and our wrists when washing our hands. After hand washing, hands can be air dried or single use hand towels should be used to dry our hands. The hand towels should be washed after use and not shared with others."

"We must avoid touching the eyes, nose, and mouth

with unwashed hands to avoid infecting ourselves."

She urged, "Mothers of children less than 5 years old must remember to wash their hands after changing their diaper and before preparing food for their children.

"Let's remember to wash our hands before we eat, after using the convenience (rest room), and before and after contact with a sick person," the Executive Secretary added.

According to her, "the celebration helps to increase awareness on the importance of washing our hands regularly and ensure people of all levels work together to influence the culture of washing hands always. Washing of hands regularly is a simple and effective way to remove germs, avoid getting sick, and prevent the spread of germs to others."

AMCON property confiscation: Folawiyo seeks injunction, dissociates self from defaulting firm

Billionaire businessman, Mr Tunde Folawiyo, has filed an exparte motion before a Federal High Court in Lagos seeking a stay of execution after a judge ordered the Nigerian Asset Management Company to seize property that belongs to him.

Mr Folawiyo, in a suit no: FHC/L/CS/799/2020, is seeking an order of stay of execution of the ex-parte orders made against him on March 24, 2022, pending the hearing and determination of his Motion on Notice seeking to set aside the ex parte orders.

Lewis Allagoa, a judge in the federal high court in Lagos, ordered on March 24 that AMCON take over some of Mr Folawiyo's assets for an alleged debt of N727.9 million

AMCON had sought an injunction to freeze Mr Folawiyo's accounts in 18 banks and provisional confiscation of his property in Lekki Phase 1, Lagos.

Folawiyo was allegedly instrumental in a N522.4 million loan from Spring Bank by Compagnie Generale de Logistique, where he is reportedly a director.

A 2017 lawsuit between AM-CON and Compagnie Generale De Logistique & Others led the judge to grant an ex parte order in favour of the former.

The interest payable on the N522.4 million amounts to the loan at N727.9 million.

Folawiyo argued that he was not a party to the 2017 lawsuit and was not served with the judgment.

He argued that he was not a director of Compagnie Generale de logistique at the time of the lawsuit and was not involved in the loan transaction with spring

Folawiyo said that, as a result, he is not a "debtor" within the meaning of section 61 of the AMCON act in terms of ensuring the provisional confiscation of his assets and the freezing of his bank accounts because of the

ruling of 2017.

He argued that a combined reading of sections 49(2), 50(2) and 61 of the Amcon act would show that only current directors of a company fall within the definition of "debtor" as to justify the freezing of their assets and

The businessman accused AMCON of not disclosing his status in Compagnie Generale De Logistique, the main debtor of the judgment in the lawsuit.

He also said that the ex parte order obtained by AMCON is an abuse of the judicial process, adding that the origin summons he filed is incompetent as it had expired at the time the order was

He complained about the impact the order would have on his employees and the reputation of the three-generation family business that he has worked hard to maintain and grow over the

Lagos residents write Sanwu-Olu, over proposed demolition of houses

Residents and landlords of houses situated along some parts of Isheriosun/Bucknor/Jakande Oke-Afa extension areas in Ejigbo Local Council Development Area have appealed to the Lagos State Government to intervene in the proposed demolition of houses in the area.

The concerned property owners, in a joint statement, accused some officials of the Lagos State Ministry of the Environment and Water Resources of inconsistently marking their buildings in a bid to create a drainage route.

The statement read partly, "The area in question (Isheri, Jakande and Bucknor) is a valley plain which was clearly laid out in plots by the owners. We never experienced flooding until some individuals colluded with some members of the family to buy portions of it, thereby infringing on its right of way. Due to the blockade, flash flooding became the new order from 2012. This led to a diversion of the stream upwards. As work on the drain progressed, we suddenly noticed a second marking of the buildings on January 19 and as if that was not enough, a third marking was made on February 22, all pointing upwards on the plane.

"The questions now are: does water flow upwards if not powered by a force? Would it not end up as a wastage that failed to achieve its purpose? We call on Governor Babajide Sanwo-Olu and goodspirited members of the public to come to our aid in whatever capacity and put a stop to the impending and unjustified calamity that is progressively reeling its ugly head."

Some of the residents were quoted as; "The officials have not been fair in the marking of houses for demolition; they marked 40 houses including mine which was not sited close to the natural way whereas only seven houses should have been affected. They refused to mark a particular house blocking the way but marked ours. Why? They served us notice on April 1 and the date on it indicates March 28. This is unfair. We are appealing to the government to please intervene."

In his response, The Director of Drainage Enforcement and Compliance, Ministry of the Environment and Water Resources, Mr Mahmood Adegbite, explained to our correspondent that the demolitions were inevitable because the houses were built along a water course.

built along a water course.

Adegbite said, "The ministry got to know about this in 2014 and there was a consensus that a particular route should be formed to curb flooding. From the map, it is clear that houses have been built over the natural stream and we have started constructing ridges of 30 metres but we had to reduce the required setback to give them some leeway.

"Our aim is not just to go there and destroy anything but to make sure that we have a water course and this demolition will give them a respite, so it needs to be done for a greater good. We will try to reduce the number of houses that will be affected, but the demolition is inevitable.

"We have given them notice late last year and early this year; they have six months' notice. So we request that if they have any form of approval to submit, because the government will only deal with those with approval, but none of them have come up with any approval" Mr Adegbite noted.

Why cement prices are higher in Lagos, Kano

Recently, the price of Cement in two of Nigeria's biggest industrial and real estate hubs has been on the rise occasioned by price hikes by manufacturers despite the closeness of these cities to manufacturing plants.

While the consumers, builders and prospective homeowners berate the manufacturers for the hike in price and complain bitterly of not enjoying the benefit of being close to the manufacturing hub, the latter blames the increase on the cost of spare parts and logistics, dollar to naira exchange rate etc.

The biggest cement manufacturing plants are owned by Dangote, BUA and Lafarge. While Dongote's factory is located at Ibeshe, the Lafarge factory is located in Sagamu

In Lagos, a 50-kilogramme (kg) bag of Dangote Cement, BUA and Lafarge is sold between N4, 300 and N4, 600 in Lekki and other areas where property development is high. In Kano, Dangote cement is about N4, 500, while BUA N4, 700 and Lafarge cost N4, 450 for a 50kg bag.

The Trumpet gathered that other areas of the country are experiencing growth in the real estate sector apart from Kano and Lagos. This has increased the demand for cement and raised the cost of building materials, coupled with unfavourable government policies and debt burdens

Speaking on the development, Group Executive Director, Strategy, Portfolio Development and Capital Projects, Dangote Industries Limited, Edwin Devakumar, said, "We are expanding capacity from about 50,000 tons a day at the beginning of the year to 70,000 tons a day at the end of the year. All other producers in the market can sell at their own price," He however added that price-fixing does not exist in the present Nigerian market noting further that prices have scaled up as a result of higher demand, increased cost of diesel and unstable supply of gas required for powering manufacturing plants across the country.

Speaking further he said: "Transport fares for moving cement have jumped up, due to congestion at the ports that have resulted in longer turnaround time for trucks."

According to some experts, Lagos is the fastest growing city in Sub-Saharan Africa, and this puts pressure on building materials. The development of Lagos is unprecedented and cement is in very high demand because of an increase in construction activities

One expert said: "In a situation where demand overshoots supply, you are bound to have such a price surge,'.

He blamed the increase on middle players that want to earn higher profits.

Mr. Debo Adejana, Vice President, Real Estate Developers Association of Nigeria (REDAN), Southwest zone when asked said that transportation should not be a factor when it concerns bringing cement to Lagos noting that the price should not be so high, as their returns are being reflected already on the profit declared by the manufacturers. Speaking further he said, "except big developers that could buy in bulk, small private developers, who contribute largely to the increase in the housing stock, find it difficult to do as it reflects on the home prices. Private developers are desirous of engaging manufacturers on how to make cement affordable to their members, adding that they will not relent until it is done"

Mr Kunle Awobodu the immediate past president of the Nigerian Institute of Building, corroborated the fact that Lagos and Kano have higher demand than in any other city in Nigeria, anticipating cheaper cement prices stating however that the expectations that Lagos should benefit from the closeness of cement factories in Ibeshe, Ewekoro and Sagamu are being affected by the state of roads in some of the locations noting that most of the roads are in a very bad state.

It is expected that before the end of 2022 the cement production capacity of Nigeria should be around 60 million tonnes per annum (mtpa) with Dangote cement controlling about 60.6 percent of the market share,

Lafarge Africa Plc 21.8 per cent and BUA Group 17.6 per cent share.

Specifically, Dangote Cement is Africa's leading cement producer with operations in 10 African countries, revenues over \$2.5 billion as well as a production capacity of up to 48.6 million tonnes per annum (Mta) across Africa as of 2020.

Dangote Cement plant in Obajana, Kogi, is the largest in sub-Saharan Africa with 10.25 million tonnes per year capacity across three lines and a further three million tonnes per year capacity currently being built.

In 2012, the firm opened a \$1 billion cement plant in Ibese, Ogun. The facility is capable of producing six million metric tonnes of cement per year, raising the company's total production by 40 per cent at the time.

The company's plant in Gboko, Benue has three million tonnes per year capacity with an upgrade to four million tonnes per year.

Dangote Cement controls 61 per cent of the market share, Lafarge Africa 22 per cent and BUA Cement the rest.

With BUA Cement planning three new cement plants each having a capacity of 3 million tonnes yearly in Edo, Sokoto and Adamawa states, with the expected completion date put at the end of 2022, It is expected that the total output capacity of 20million metric tonnes will help in reducing the price of Cement in the local market.

ICPC chair says corruption a huge obstacle to development, ethical values

hairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC), Prof Bolaji Owasanoye, SAN, has said that corruption remains a huge obstacle to the development and ethical values in Nigeria.

Prof Owasanoye disclosed this while speaking during the Annual Making a Difference Leadership Seminar of the Harvest Fields International held

at the Events Centre, Agidingbi Road, Lagos.

In his presentation titled "Corruption and Integrity: Making the Difference Leadership Series", the ICPC Chairman, who was the guest speaker, stated that corruption undermines infrastructure development due to skewed procurement processes.

"Corruption is the greatest obstacle to development and an existential threat to unity. It affects everyone and everything negatively and gravely.

"In the minimum, corruption destroys ethical and moral values; compromises security, justice and rule of law; deprives citizens of economic, social and constitutional rights; breeds distrust, mistrust, unemployment, violence; breeds poverty as it diverts resources from poverty reduction projects; hinders effective resource allocation and deployment, and fuels ethnic distrust and conflicts due to unjust resource allocation," he said.

The ICPC boss, however, listed some corruption and integrity red flags for leaders in the public service to be wary of or to avoid slipping into them.

According to him, the red flag includes public procurement, contract splitting, fiscal management skill, abuse of office or power, and disconnect from reality.

He identified the recovery of assets from corrupt persons as a key measure in the fight against corruption.

"Asset recovery from corrupt persons has become necessary to deny them the use of whatever they had stolen from the public coffers. Our efforts are geared towards recovery of identified stolen assets and resources that will be used for the development of the country.

"Millions of Nigerians suffering denial of basic social services and lack of infrastructures such as hospitals, schools, water and employment will receive succour when stolen assets are recovered from looters," he added.

The ICPC Chairman cited some scriptural passages in his recommendations to the seminar participants on how to make a difference in leadership while avoiding corrupt tendencies.

The recommendations include: reducing expectations of reward or gratitude (Luke 17:10); having options and reminding oneself that he or she is not the only person who can do it (1 Kings 19:10); focusing on basic needs not the vanities of life (1 Tim 6:8) and ignoring praise singers who exaggerate someone's importance to the system (John 6: 25-26).

Others are forgoing a privilege or entitlement

when in doubt about it (1 Cor. 6:12), conceding benefits to others and focusing on the welfare concerns of subordinates (Matt. 5:40), shouldn't be ambiguous about integrity issues (Proverbs 11:3), and be ready to speak truth to power and to walk the talk.

Earlier in his welcome remarks, the host and Senior Pastor of City Harvest Church, Rev Abraham Akinola, said the 2022 Leadership Seminar is aimed at creating a better society and providing redemption for the country.

He said, "It has been a long journey. This is the 16th Edition and is creating a better society. We shouldn't be overwhelmed by our numerous challenges; we have Nigerians who have faced the challenges of our society and our guest speaker is one of them.

"We need to exert the influence of Christ more in our life and attitude to enable us to preserve our nation. We, particularly, need the character of Christ in our life, choice of words, dress code and attitude in order to influence a change in our society."

Ex-Perm Sec bags 12 years' jail term for non-declaration of assets

• Forfeits N97.3m, \$139,575.50, £10,121.52 to FG

A former Permanent Secretary in the Ministry of Labour and Productivity, Clement Illoh, has been convicted to 12 years imprisonment by Justice Babs Kuewumi of the Federal High Court sitting in Ikoyi, Lagos.

The Trumpet gathered that the Economic and Financial Crimes Commission (EFCC) secured the conviction on Thursday, May

Illoh was prosecuted by the EFCC on a three-count charge bordering on nondeclaration of assets to the tune of N97.3m.

One of the counts reads: "That you, Dr Illoh Onubuogo Clement, on the 19th day of April 2016 in Lagos, within the jurisdiction of this Honourable Court, failed to make full disclosure of your assets to wit: the sum

of N97, 300, 613. 44 (Ninety-Seven Million, Three Hundred Thousand, Six Hundred and Thirteen Naira, Forty Four Kobo), which sum you warehoused in Account No 3033750243 domiciled with First Bank of Nigeria Ltd in your name and you, therefore, committed an offence contrary to and punishable under section 27(3) (C) of the Economic and Financial Crimes Commission (Establishment) Act 2004."

At the proceedings, the prosecution counsel, during cross-examination of the defendant, revealed that Illoh received funds to the tune of N65million from SURE-P project contractors, which was domiciled in his personal First Bank account with no:3033750243.

In the course of proceedings, the defence counsel, T.S. Awana, sought the court's permission to confer with his client.

Thereafter, the defendant, through his counsel, applied to change his "not guilty"

Justice Kuewunmi granted the application and Illoh "pleaded guilty".


While delivering his judgment, Justice Kuewumi held that "I have given due attention to the allocates of the defendant.

"However, the court will not fail to perform its duty in accordance with the provisions of the law.

"Consequently, the defendant is hereby sentenced to four years in each of the counts and the same shall run concurrently from the 10th of October 2019."

The Judge also ordered the forfeiture of the sum of N97, 300,613.44, \$139,575.50 and £10,121.52 respectively to the Federal Government of Nigeria, being proceeds of unlawful activities.

According to a statement by its spokesperson, Wilson Uwujaren, "The EFCC had, on October 3, 2019, secured the conviction and sentencing of Illoh to five years imprisonment over a N14.1m fraud before Justice Oluwatoyin Taiwo of the Ikeja Special Offences Court sitting in Ikeja, Lagos.'

Company's employee arraigned for fraud

Court closes serving senator's defence on alleged N204m fraud

Justice Agatha Okeke of the Federal High Court sitting in Uyo, Akwa Ibom State has ordered the defence team of Senator Albert Bassey, standing trial on a six-count charge bordering on money laundering, to close its defence and prepare its final address.

The judge gave the order on Thursday,

May 5, 2022, following the failure of the lead defence counsel, Kanu Agabi, SAN, to continue the trial of the serving Senator representing Akwa Ibom North-East district, in alleged N204million fraud.

When the matter came up for continuation of trial on Thursday, a member of the defence team, Mike Ozekhome, SAN, prayed the court for an adjournment on the ground that the lead counsel, Agabi who is in possession of the case file, is currently receiving medical treatment abroad.

He said, "With due respect my Lord, we shall be asking for an adjournment. We have filed a letter to that effect before this Honourable Court. The lead counsel, Chief Kanu Agabi, SAN is abroad for medical treatment and he has the file of this case.

"He called me to passionately plead for just one more adjournment. If I had the case file, I would have proceeded with this case."

Responding to the application, the counsel of the Economic and Financial Crime Commission (EFCC), Ekele Iheanacho, expressed displeasure with the numerous pleas from the defence and the several adjournments granted in the course of the trial at the instance

He said, "My Lord, we just got the letter of adjournment from the Chambers of the learned silk, Kanu Agabi. On our part, we will say that this is very worrisome and we urge the court to refuse the application."

Ruling on the defence's prayers, Justice Okeke upheld the argument of the prosecution and turned down Ozekhome's request for an adjournment. The court consequently ordered him to continue his defence.

However, Ozekhome, while addressing the court after the ruling, insisted that the defence could not continue as the case file was with the lead defence counsel.

"My lord, we don't have the case file,"

The prosecution thereafter applied that the case of the defence be close. The application was granted and the court-ordered parties to file their final addresses.

Justice Okeke adjourned the matter till June 22, 2022, for adoption of final addresses.

Bassey is being prosecuted by the EFCC for alleged money laundering and being in possession of six vehicles worth N204 million, at the instance of one Olajide Omokore, whose companies allegedly executed contracts for the Akwa Ibom State government.

It is normal, some men will tell you that I am a married man as well so what is the big deal, you know what you want for yourself and you go for what you want.


Now that you are a versatile actress, how many languages can you speak?

Emotionally drained Bassey, in his tweet, said, "For Jimmy, we love you, Jimmy," touching the black armband to his chest.

'Italian teams must learn from Madrid's Champions League victory if...'

Ex-Italy and Milan coach Arrigo Sacchi said there are a lot Italian football teams need to learn from the 3-1 victory of Real Madrid over Manchester Wednesday's Champions League match at the Santiago Bernebeu.

Sacchi, who spoke to La Gazzetta dello Sport in an exclusive interview, praised the relentless spirit of Madrid players who never gave up but continued to fight for a win and eventually got it.

He acknowledged Carlos Ancelotti for being a genius by taking out experienced Casimero, Luka Modric, and Toni Kross for the young, promising players who have the zeal to excel.

Thanks to Ancelotti's changes that paid off with Ancelotti's inspirational Rodrygo lighting up the atmosphere at the

Sacchi said, "Ancelotti won against City as he had done against PSG and Chelsea, with a comeback inspired by substitutions.

"He replaced some champions with youths that

make enthusiasm their most important quality. He subbed off all the midfielders in the second half: Casemiro, Luka Modric, and Toni Kroos. Even Karim Benzema in extra time.

"He gambled on the freshness of Rodrygo, Marco Asensio, and Eduardo Camavinga. He turned the game around thanks to Rodrygo, who scored a decisive brace when Manchester City seemed to have secured a place

"Every goal came from pressing, possible thanks to the energy of young players and quick counter-attacks.

Sacchi opined that Italian teams must change their defensive mentality for an attacking type as Real Madrid did over Manchester City if they are to succeed in Europe.
"That's what our teams must

do to pursue success in Europe. Pressing gives courage and scares the opponents, forcing them to do something they can't do well: defend.

'Foreign clubs are much better attacking rather than defending. Manchester City proved it over the two legs. Therefore, we must press them to win. Unfortunately, every Italian club uses one or even two extra men at the back, often to man-mark just one opposing striker. Like this, they lose a man in midfield and miss the chance to dominate games," the ex-Italian boss added.

The win against Manchester City makes it the fifth final Carlo Ancelotti has reached and could become the manager with the greatest number of Champions League titles if he triumphs over Liverpool to lift his fourth.

Mike Arteta extends Arsenal's contract until 2025

Arsenal head coach, Mikel Arteta has extended his contract with the Gunners until 2025 saying he is happy his ideology fits into what the Arsenal board wants for the club.

The 40 years old manager who has taken Arsenal to fourth on the Premier League table, a position which had been out of sight since 2017, hopes to build the North London club to compete fiercely with European greats.

The Spaniard signed for Arsenal in 2019 and won his first silverware in 2020 when Arsenal defeated Chelsea in the FA Cup final to lift the

Following the success over

the Blues at Wembley, Arsenal sustained the winning relics over Jurgen Klopp as they dismantled Liverpool in the Community Shield clash to lift the trophy.

Though Arsenal had a poor run of form midway in the 2021/2022 season, Arteta has been able to find the best rhythm to stabilize the team which has propelled them to leapfrog teams along the line to occupy the Champions League spot.

"I'm excited, grateful and happy today. When I spoke to Josh [Kroenke] he could see the club at the same point and he wanted to take the club the way I wanted to do it. So everything that he's said, and that Stan has said when I've been together with both of them, they've always delivered," Arteta said after signing a new deal with

"We want to take the club to the next level and to compete really with the top teams. To do that, we have to be playing in the Champions League. "We have to be able to evolve

the team, improveoururr players, improve all departments, generate even more connections with our fans, improve the atmosphere at the Emirates, be able to recruit top, top talent and the best people for this club to drive this project to that level,"

LMC sanctions MFM, Kwara United for misconduct

The League Management Company, (LMC) have sanctioned the MFM football club over several unprofessional conducts and breach of game rules in their matchday 26 fixture against Rangers of Enugu.

MFM supporters had during the match, encroached into the field of play to attack the center

Allegedly, that not being enough, the MFM team manager, Geoffrey Aghogi, visited the match officials in the hotel where they lodged to constitute a nuisance,

According to LMC, MFM failed to provide and ensure effective security during the game which resulted in the breakdown of law

and order at the match venue.

LMC stressed that MFM conduct contravenes the rules as their supporters, players and officials behaved in a way capable of bringing the league to disrepute.

The administrators of NPFL added that MFM failed to control their players and officials in ensuring they displayed proper conduct in the course of their

match against Rangers.
Furthermore, LMC said that
MFM team manager Geoffrey
Aghogi breached the Fair Play
rules by going to the hotel of the
match officials to harass, threaten

and intimidate them.
Following the series of infringements, MFM has been fined N1 million for failure to provide general security and also fined another N1 million for

encroaching into the field of play. A fine of N1 million has also been imposed on MFM for the unsporting behaviour of their players, officials, and fans.

Accordingly, MFM players, Jerry Isaac and Christian Molokwu have been handed a 12-match suspension for their involvement in the infraction in the first instance.

MFM team manager Geoffrey Aghogi was banned indefinitely

from all NPFL-organised activities including matches.

The NPFL administrators ordered MFM to identify the persons involved in the assault of match officials and further show evidence of an arrest by the police and prosecution/arraignment in

a competent court of jurisdiction.

LMC revealed that the assaulted center referee will get a compensation of N250,000 and any other additional verifiable medical costs.
Sequel to the above, the LMC

stated that MFM will play their next three home matches at the Dina Dipo Stadium in Ijebu-Ode and will only return to their home ground after LMC must have received a satisfactory police report on the prosecution of the persons involved in the alleged assault.

A suspended two-point deduction has been imposed on MFM which will be for a probationary period for the remainder of the season.

LMC reiterated that MFM has 7 working days to pay all fines and also has 48 hours from the date of the notice to appeal the sanctions.

Nigeria to play France, Canada and Korea Republic in U20 W'Cup

ollowing the U20 World Cup draw that was held at Teatro National in San José, the capital of Central American nation, Nigeria, France, Canada, and Korea have fallen into Group C.

Defending champions Spain will slug it out in Group A with host nation Costa Rica, Australia, and Samba girls Brazil, while fellow African compatriot Ghana battle with the Netherlands, Japan, and three times champion United States in Group D.

More so, the German machines who have an equal record with the United States of winning the diadem three times, two of which were against Nigeria in the finals, 2010 & 2014, fall into Group B with Columbia, New Zealand, and Mexico.

According to FIFA, all group phases and quartermatches will be played at the Alejandro Morera Soto, comprising a hybrid of natural and

The draw ceremony at the Teatro Nacional in San José was witnessed by the Head Coach of Nigeria's U20 girls, Christopher Danjuma, and the Team Secretary, Patricia Osuji, the NFF media report.

Nigeria's opening group match will be against the 2018 host nation France. A francophone colonist that finished third place in 2014 where Nigeria emerged as runners-up.

'AFCON 2023: Delay in Equavoen's successor not good for Super Eagles'

Following the constraint on time to get the Super Eagles prepared for the 2023 Africa Cup Nations (AFCON) qualifiers, Nigerians have grimaced at the delay by the Nation's football governing body (NFF) in announcing Augustine Eguavoen's successor.

Nigeria have been scheduled to play Sierra Leone at the MKO Abiola national stadium after approval to that effect was granted by the continental football governing body (CAF) in a letter conveyed to the NFF on Sunday, May 1, 2022.

But like a sheep without a Shepard, the Super Eagles are yet to know who steps in the stead o steer the team to success which is a question every concerned sports lover is get answers begging to from the NFF

One could recall that the NFF after its technical development and committee submitted its report, swung into action to name new technical crews, which were all indigenous coaches, for the nation's football teams.

On the aspect of the Super Eagles, the NFF opted to secure the services of a foreign coach, an option which did not augur well with the Ministry of Youth and Sports Development which preferred indigenous gaffer with the 1994 nation cup winner, Sunday Olise, in its scope.

Adamantly, NFF made a list of foreign coaches vying for the Super Eagles' job with Portuguese Jose Poseiro, former PSG manager, Laurent Blanc, Ernesto Valverde, and Phillip Cocu all in the frame.

However, from a source, NFF forwarded Jose Poseiro as the successful candidate to succeed Eguavoen, choice opposed by the sports ministry who faulted the NFF's selections over improperly conducted screening.

The sports ministry reminded the NFF that they are much concerned about who takes charge of the Nigeria senior men's team because they will be responsible to foot the bills of the head

With this internal imbroglio, Nigerians have lamented that the Nigerians impasse is harming the Super Eagles' preparation for the 2023 AFCON qualifiers.

A former Nigeria goalkeeper, Äikhoumogbe, bemoaned that Nigeria was supposed to have announced Augustine Eguavoen's successor by

He warned a further delay announcing the foreign coach would not tell well of a nation preparing for an imminent 2023 AFCON qualifiers.

"I expected that by now the Nigeria Football Federation would have named a substantive coach for the Super Eagles so that the new coach can quickly get used to the system in Nigeria," Aikhuomogbe told Complete Sports from Cairo, Egypt.

"Delaying announcement of a new foreign coach may not be too good for Nigeria, because the 2023 Africa Cup of Nations qualifiers will commence soon.

"NFF must get this right before it is too late,"

Former Lobi Stars coach petitions club to FIFA

Lobi Stars football club have been dragged before the International Federation Association Football (FIFA) over a breach of contract involving ex-Nigeria international and professional football manager, Eddy Dombraye.

Dombraye through his agent, Alicia Nikolis, forwarded petition before the highest football governing organ over the inability of the Makurdibased club to compensate him after being relieved of

The football gaffer's two years contract signed in September 2021, was terminated by Lobi Stars in March 2022 after a poor run of results that saw the Ortom Boys struggling to beat the drop zone of the Nigeria Professionals Football League (NPFL) table to evade relegation.

FIFA, which oversees and upholds the dignity of football globally while disciplines anybody/ institution whose actions and inactions are meant to bring the game to disrepute, presently reviewing petition brought before it by Dombraye's agent, according to Mmenyeneabasi Akpan's



However, this is not the first petition that has been lodged before the FIFA Disciplinary and Ethics

Committee NPFL club as Heartland of Owerri have tasted from the vine of FIFA's unbiased sanctions as well. Heartland of Owerri were

petitioned to FIFA in May 2020 after they unlawfully terminated the contract of Brazilian Santos Da Costa Ivo Jorge.

Though the Samba boy was not the only player to have been dropped by the Owerri-based club, he sought to exploit the option of letting the world football governing body decide his fate despite having a year left to run in his 2 years

FIFA sanction former Gabonese U17 coach, others over sexual abuse of minors

he independent Ethics Committee of the International Federation of Association Football (FIFA) has sanctioned former Gabonese U17 coach Patrick Assoumou Eyi, President of La Ligue de Football de l'Estuair, Serge Ahmed Mombo, and two Gabonese coaches Triphel Mabicka and Orphée Mickala over sexual assault on minors.

The incident happened in December last year when local media alleged that U17 Gabonese coach was sexually assaulting minors and young footballers which spurred the Ethics Committee to swing into action by launching a preliminary investigation.

According to The Guardian, several of Eyi's victims reported being abused by the former Gabonese U17 coach who later became the technical director for La Ligue de l'Estuaire, the country's highest league, necessitated the International players union

(Fifpro) to register a complaint to FIFA.

"Our preliminary inquiries yielded consistent evidence from credible witnesses who all tell of an ongoing and long-embedded practice of forcing young players into sexual relationships as a pre-condition for footballing opportunities," Fifpro said.

"If these allegations are indeed true, it is yet further evidence that football is being consistently exploited, across leagues and continents, as a forum for abusers to access, groom, extort and assault players. More must be done to prevent this horrific abuse and we call on football's governing bodies to act as a matter of urgency," the players union added.

After a review of the degree of allegations, the chairman of the Disciplinary and Ethics Committee directed that the scope of the investigation be broadened which saw Serge Ahmed Mombo, Triphel Mabicka and Orphée Mickala indicted

Following the investigation by the disciplinary organ of the world football governing body, Mambo, Mabicka, and Mickala have been suspended from partaking in all football-related activities for 90 days while Eyi who was suspended on December 17, 2022, by the Gabonese FA has his sanction exacerbated to have a global effect.

Former Chelsea midfielder Michael Ballack has ridiculed Liverpool's defender and captain, Virgil Van Dijk, for feeling too confident as a defensive block-wall.

Ballack, according to Football Tweet, opines that the Liverpool man got the opportunity because the league does not parade strikers in the same clime as former Premier League greats.

The German, who thinks the Dutch Defender is overrated, mentioned a class of Premier League strikers that would make a mess of the latter.

Virgil van Dijk has been inspirational to Liverpool's success and quadruple campaign this season.

The 30 years old, who joined Liverpool through 2018's winter transfer window at a record fee of £75m, hopes to lift the second Champions League trophy of his career in Paris after he captained his team to a legendary win against Villarreal.

Dijk, this season, has featured 47 times for Liverpool in all competitions, scoring three Premier League goals and providing an assist in the process.

2023 AFCON: Nigeria host Sierra Leone in MKO National stadium

Confederation of African Football (CAF) has approved the Moshood Abiola National Stadium, Abuja as the venue for Nigeria's 2023 Africa Cup of Nations (AFCON) qualifying matches.

CAF in a letter to Nigeria's football governing body (NFF) on Sunday, May 1, 2022, approved the nation to use the aforementioned venue

for the qualifier between the Super Eagles of Nigeria and Leone Stars of Sierra Leone.

Going by this development, all suppositions that the stadium would be banned from hosting competitive tournaments due to the incident that happened when Nigeria failed to qualify for the Qatar 2022 FIFA World Cup, have

been thwarted.

Meanwhile, the International Federation of Association Football (FIFA) recently, sanctioned Nigeria and other countries after it concluded preliminary investigations on varying degrees of incidents that happened during the FIFA World Cup qualifiers around the globe.

Nigeria, after the investigation,

was fined CHF150,000 which is equivalent to N63,685,371.31, and was subjected to play one match in closed doors without spectators to cheer them up to victory.

Consequent to the second resolve by FIFA, the Super Eagles will have to play the Leone Stars in the MKO Abiola national stadium without the support of Nigeria fans.

'We were close to Champions League final



Manchester City head coach Pep Guardiola has lamented the devastating outcome of the Wednesday Champions League semi-final clash against Real Madrid at the Santiago Bernebeu.

The City gaffer, whose team at 89minutes still had a 2 goals lead over Madrid, having secured a 3-2 win at the Etihad in the first leg, never thought the home team could put up a shocking fightback.

Guardiola, signed by Khaldoon Al Mubarak in 2016 from Bayern Munich to help the Blues of Manchester secure their first-ever Champions League trophy, fell to his sixth elimination in the semi-finals like Jose Mourinho, the most for any manager in history.

The City boss in a post-match

interview undeniably agreed that the game was tough despite getting close to the finals.

He, however, accepted that the defeat resulted from the inability of the Sky Blues to perform in top form.

More so, Guardiola conceded that Madrid exploited the option of packing the 18 yard-box with attacking-minded players while crossing the ball simultaneously to pressurize the Manchester City defence.

"It is tough for us, I cannot deny," Guardiola to BT Sport after the loss on Wednesday.

"We were so close to the Champions League final.

"Now we need to process that and come back, with our people at home and in the last four games we have." "They put a lot of players in the box, with Eder Militao, Rodrygo, Vinicius Junior, Karim Benzema and they put in crosses and scored two goals.

"We didn't play our best, but it is normal, a semi-final, the players feel the pressure and want to do it. Football is unpredictable, it is a game like this. We have to accept it," he added

Manchester City return to England to concentrate on the Premier League title hunt with four games remaining to end the season.

Meanwhile, Jurgen Klopp is on the trail to leapfrog Pep Guardiola on the top spot before the season's end, which depicts Liverpool's focus on finishing the season with a quadruple.
