

# Security strengthened for Eid-el-Kabir

nspector-General Police. IGP Usman Alkali Baba, has charged the leadership of all commands to beef up security and prevent any breach in their Areas of Responsibility (AoR) throughout the Eid-el-Kabir season and beyond.

Nigerian Muslims are joining others worldwide to mark Sallah.

Baba, in a statement signed by the Force Public Relations Officer, CSP Olumuyiwa Adejobi, also assured the general public of the efforts of the police to improve safety and security across the country.

Insecurity has worsened across the country in the last few months with critical infrastructures and other major facilities such as worship centres, airports, security bases, schools and marketplaces among others, being targeted.

According to Adejobi, "The IGP equally charged charged Commissioners of Police (CPs) and Tactical Commanders in all the States of the Federation and the Federal Capital Territory (FCT), and their supervisory Assistant Inspectors General of Police (AIGs), to beef-up security ahead of the Eid-el-Kabir celebration, to prevent any untoward situation in their Areas of Responsibility (AoR) throughout the Eid-el-Kabir season and beyond."

He further stated that the IGP directed the supervisory AIGs and their respective CPs to ensure adequate deployment of officers and assets to prevent the occurrence of crimes and criminality, as well as build confidence amongst citizens.

"The police boss charged officers and men of the Police to engage in critical assessment of threat prone areas, thorough stop and search, raids on black spots and other anti-crime strategies capable of sustaining peace and public safety in Nigeria.

The IGP equally warned that personnel deployed must be professional and mindful of the fundamental rights of the citizens, and discharge their responsibilities with all sense of decorum and alertness," he stressed.

Congratulating the Muslim faithful on the occasion of Eidel-Kabir celebration, the IGP enjoined them to celebrate and enjoy the beauty of the religious festivities while remaining security-conscious.

He equally urged them to reportall suspicious individuals, movements, or activities to the police for prompt intervention. He admonished them to cooperate with operatives of security agencies deployed on

duty at strategic places for the Eid-el-Kabir celebrations.

Sokoto State Command assured residents of adequate security in worship centres. Major highways and recreational centres during the Sallah celebrations.

Commissioner State Police, CP Muhammed Usaini Gumel, gave the assurance in a press statement signed by the spokesperson of the Command. DSP Sanusi Abubakar, on Friday. He disclosed that security strategies in synergy with other security agencies have been revised.

"CP Muhammed Usaini Gumel FIPMA, psc wishes to assure members of the public that adequate provisions are being put in place to provide elaborate security to locations that include: worship centres, major highways, recreational centres, entry and exit routes and other strategic locations before, during and after the celebration to the people across the state.

"The police command is also mindful of the volume of human and vehicular traffic occasioned by the Sallah festival and advised members of the public to cooperate with policemen deployed for traffic control by police and the relevant security agencies deployed on duty to ease such traffic congestion in the city and other locations across the state. Abubakar said.

The command implored members of the public to be vigilant, watchful of their wards, and children and to suspicious activities to 07068848035 for a prompt response.

În the same vein, CP Ari Muhammed Ali of the Delta State Command has assured all Muslim faithful in the State of a hitch-free Sallah celebration.

According to the Public Officers of the Relations Command, DSP Bright Edafe, in a statement, Ali has ordered a massive deployment of officers to ensure adequate security across the State.

"The CP warns cultists and mischief makers to steer clear as the Command will deal decisively with anybody who is found wanting. To this end, the CP has ordered a massive deployment of personnel which includes special constabularies across the State for the purpose of providing adequate security in all Muslim prayer grounds and strategic locations in the State.

"The CP also directed all DPOS to intensify raids of criminal hideouts and black spots within their areas of responsibility. The CP adjured the Deputy Commissioner of Police in charge of operations, Area Commanders, Divisional Police Officers, and Tactical Operations Officers to employ means of ensuring thorough supervision of personnel

On a philosophical note, President Muhammadu Buhari on Friday, urged Nigerians to end the orgy of evil in the land. saying no amount of religious pretence could win the love of God, without genuinely practising the injunction of true love for humanity, which all faiths preach.

The President in his Eid-el Kabir message to Nigerian Muslims and other citizens, while admonishing the people to put the interest of the country above selfish ones, said they must use religion as a motivation for the love of our common humanity.

His words: "If we are putting the teachings of our religions into practice, most of the evils afflicting our society would have been solved. Religion shouldn't just be used as a mere badge of identity, but as a motivator for doing good for our country and humanity.

"The exploitation of the people by traders and the stealing of public funds by civil servants and other holders of public trust is a reflection of the abandonment of the teachings of our religions.

"Our society is a bundle of contradictions. People display external religiosity without fear of God; they make life difficult for others; money becomes their god; leaders abandon their oaths of office by taking money meant for the welfare of the people and divert it to their private pockets," he said.

Buhari congratulated the Muslim Ummah in Nigeria and the world and particularly saluted "the brave men and women in uniform fighting terror on many fronts and their families, as well as others held hostage and kept away from their families by wicked and heartless terrorists.

He urged Muslims to reflect on the significance of the sacrifice epitomised by Eid.

The President, who flew to Dakar, Senegal shortly after two significant security scares in the country, first, with the attack on his convoy and invasion of the Kuje Prison in Abuja, were some 64 dangerous terrorists were freed by their members, said the incidents were against the Islamic faith.

He said: "We should show love and care to our neighbours and others while celebrating this spiritually important event in our lives. Muslims must promote the good virtues of Islam through personal examples and practice. Muslims should avoid association with violent extremist ideas that have wrongly given Islam a negative image or poor perception.

On the current security challenges and costs of living in the country, President Buhari assured Nigerians: "I won't rest until I bring relief to Nigerians. I am quite aware of the difficulties people are facing and working to resolve them."

The President hopes that this Eid will be a source of blessing, peace, prosperity and safety for all Nigerians, stressing that coexistence and stability will prevail in the

Buhari arrived in his country home, Daura, in Katsina State, for the Eid-el- Kabir, on Friday evening.

The President had earlier arrived at the Umaru Musa Yar'Adua International Airport, Katsina, from where he was flown to the ancient town in a helicopter.

He arrived Daura few minutes to six in the evening to the warm embrace of the Emir, Alhaji Faruq Umar, and other dignataries in the town.

According to reports, the President would be in Daura throughout the Sallah period where he is expected to join his kinsmen in celebrating the Sallah.

He is also expected to use the Sallah vacation to attend to

On his part, former Vice resident, Atiku Abubakar, President, has again bewailed the present grinding poverty and pervasive insecurity in the land, saying this is the period Nigerians must look out, comfort and help one another in order to survive the ugly situation.

The Waziri Adamawa, who is the presidential candidate of the Peoples Democratic Party (PDP), in his Eid-el-Kabir message, acknowledged the harrowing experience Nigerians, are facing.

### Reactions trail emergence of Obi's running mate

Presidential candidate of Labour Party (LP), Mr. Peter Obi on Friday officially announced the choice of a businessman and politician, Dr. Yusuf Datti Baba-Ahmed, as his running mate for the 2023 presidential election.

This announcement confirmed The Trumpet report of Baba-Ahmed's choice during the week.

Obi had initially forwarded the name of former presidential the name of former presidential spokesperson, Dr. Doyin Okupe, to the Independent National Electoral Commission (INEC) as a 'place holder' pending the choice of a substantive running mate.

Okupe on Thursday wrote to INEC to withdraw his candidature as the party's vice-presidential candidate.

Yusuf Datti Baba-Ahmed is reportedly the son inlaw of General Aliyu Gasau, one of the kingmakers in the country. He is also the younger brother of Dr. Hakeem Baba-Ahmed, who tweeted about Peter Obi on June

Hakeem Baba-Ahmed is the Spokesman of the Northern Elders Forum while Prof. Ango Abdullahi who last month said Atiku and Tinubu can't fix Nigeria is the Chairman.

Senator Yusuf Datti Baba-Ahmed said the only reason for accepting to be the LP's vice presidential candidate is to

rescue Nigeria with Obi. Baba-Ahmed, a 46-year-old academic, businessman and politician stated this in his acceptance speech, shortly after he was unveiled in Abuja.

He said he believes in the

genuineness, integrity and capacity of Obi to rescue Nigeria and he had no choice but to be part of the movement.

Baba-Ahmed, who praised the Almighty Allah for making it possible, thanked Obi and his team for finding him worthy to be his running mate in their journey to rescue Nigeria.

"I wish to begin by uploading my endless praises to Almighty Allah who gives power to whom he wills, when he wills and how he wills.

"Also, I will remain ever submissive and indebted to my leader and my principal, the President (Peter Obi) and his team who worked diligently, researched and found worthy. I will remain forever humble and appreciate him for this honour. My task is simple to accept this nomination at

this time, but in doing so, I will normally give justification as

undeniable. 'The unchallengeable fundamental reason for being on this ticket is to rescue Nigeria. And the whole logically and without saying it that you can only rescue that which you are involved in for Nigeria to be able to transform. I cannot afford not to be part of this movement to rescue Nigeria.

The second reason is that I believe in the greatness of Nigeria, I believe there will be peace and prosperity, I believe that Nigerian people will unite; in fact, let me say that having come from educational background; I belong to the system where you walk into the classroom, after one hour you come out a changed person.

"Ever since I met his Excellency Peter Obi, I have been changing every day," he

He said Obi told him that the land mass in the North is the "crude oil of Nigeria."

"How much more nationalist can you be? How much more detribalised can you be? I see a brighter future for Nigeria from such comments," he said.

"Then I want to justify it, who was motivated by success in the private sector and fought and after those eight years, has. maintained his integrity and honour till this day, is the one that will not fail in his campaign promises, Mr Peter Obi.

'Someone who believed in financial propriety will not engage in financial rascality. who believes in credibility and integrity no matter who he associates with will not mismanage personal, human and public resources and he is

"This is the high point in my life, in my career and I think this is pure. Having said this with all trust to Almighty Allah; with my belief that I am doing this for the sake of Nigeria, with all humility, I accept your generous invitation to be your

running mate."

Reactions have followed
Baba-Ahmed's emergence.

All Progressives Congress
(APC) chieftain Joe Igbokwe Adeyanju and activist Deji Adeyanju dismissed Baba-Ahmed a political paperweight. However, Adeyanju said the LP presidential ticket is truly

progressive.

But Igbokwe said: "It is political suicide to pick a VP candidate who cannot deliver something as ordinary as his LGA for you in a presidential election. Anyways, everyone will wake up from the social media delusion soon. Kwankwaso can deliver his state and many former Govs will also do well. When we criticize, we are doing so with deep understanding of Nigeria. One thing is clear now, this is nothing serious but just a social media good feeling presidency dream."

Reacting, Obi's media adviser, Val Obienyem, remarked: "Oh, Uncle Joe Igbokwe is thinking about the success of Mr. Peter Obi otherwise how else do we explain this his post? From his post, it appears he actually prayed that Obi should choose person that would deliver for him so that he wins the election Does he not appear dejected that Obi made the wrong choice?

"If you are close to Uncle Joe, tell him that "Obidients' are not looking for a person that will deliver his ward, a local champion, but a person that will deliver the totality of Nigeria.

"Should he be patriotically concerned with the man's ward or his pedigree and competence? Has it not bothered Joe that Nigerians are now looking for those that are healthy and competent to withstand the rigours of governance, while he is still stocked at the elite descriptive quip: "He cannot deliver his ward", a veiled imprimatur for old, corrupt, turn by turn politicians turn-by-turn politicians.

"Look at the the VP's age, what else shall the youth demand from such a choice? This is a clear sign of the desire to break away from the past and allow the youth take over their

shoulder a lot of responsibilities. When we got you a location, we had to renovate it.

'We do not run away from the fact that the Police is overstretched. In the same way, we do not run away from the fact that a single police command in Abuja will not be adequate to police the large populace of the country. This has led to our demand for State

"We can complement each other. I have had Senior Police Officers who agreed on State Police. Maybe they can't say it in public. Go to Ekiti and even here in Ondo State, most of the Police Stations have no vehicle. Look at the unfortunate incident that happened in Owo, Police said they had no vehicle

to pursue the perpetrators.
"Let us all sit down and agree that we should have a system that will create division of labour. We can have the Federal Police and then, the State Police.

You can face up to a major task like intelligence gathering and pass it to the State Police to work on. What is happening, if not for lack of intelligence people will not go to Kuje and attack the place in Abuja. We need your cooperation too in this our cry for a dual Police System that can work together.

"People are moving down south to take refuge in our forest. You don't have the men and officers to secure the country. The Police Force is understaffed. We appreciate your limitations in terms of men, ammunition and so on.

Meanwhile, the presidential Progressives Congress (APC), Bola Tinubu, has condemned Tuesday's attack on the Kuje Medium Security Custodial Centre in Abuja by terrorists.

Tinubu stated that the attacks incessant terror plaguing the country were worrisome just as he called on Nigerians to remain vigilant

and united behind constituted authorities.

The former governor of Lagos State said this via a statement issued on Friday by his media aide, Tunde Rahman.

The Nigerian Correctional Service (NCoS) confirmed that four inmates of the correctional centre in Tuesday's attack, while hundreds of prisoners escaped.

NCoS said The assailants broke into the correctional centre using explosive devices through the main entrance and the fence of the facility respectively.

The Islamic State of West Africa Province (ISWAP) terrorist group had claimed responsibility for the attack.

Reacting to the attack, Tinubu said: "Tuesday's terror attack on Kuje Medium Security Custodial Centre is worrisome. These incessant attacks on government's institutions and innocent citizens is a sad reminder that we still have

a lot to do to put these evil forces in check.

totally condemn dastardly this attack. The government must immediately go after the attackers and fleeing inmates of this facility.

"While also calling for full investigation of the incident and the possible failure to act on intelligence, we must all remain vigilant and united.

"This moment calls for national unity and deep introspection.

"Wemust continue to support the President Muhammadu Buhari administration in its battle against insurgents and determination to confront these agents of darkness.

"I commiserate with the families and relations of those who lost their lives in the attack. I also call on the government to continue to provide succour and medical attention to those injured," the APC presidential standard-bearer stated.

### 120 inmates gain admission into National Open University in Enugu

o fewer than 120 inmates of Enugu Correctional Centre have gained admission to study at the National Open University of Nigeria (NOUN) special study centre at Enugu Custodial Centre.

The Controller General of the Nigeria Correctional Service, Mr Haliru Nababa, said that a total of 11 inmates were performing their convocation.

Nababa, who was ably represented by the Controller of Corrections in Enugu State, Mr Nicholas Obiako, said that the inmates were graduating with flying colours from various courses at the university.

"My administration is focused on using education as a viable tool for reformation and re-orientation of the inmates.

"The Nigeria Correctional Service (NCoS) under my

watch has committed available resources to ensure that inmates develop themselves while in custody to ensure public protection.

"I will want to use this occasion to thank non-governmental organizations, faith-based organisations and NOUN for their partnership over these years," he said. Speaking, the Vice Chancellor of NOUN, Prof. Olu-

Speaking, the Vice Chancellor of NOUN, Prof. Olufemi Peters, represented by the Director Enugu special study centre, Prof. Alexander Onyia, administered the oath of allegiance to the newly admitted inmates.

Peters cautioned the matriculating inmates to be of good behaviour and shun acts capable of truncating their educational pursuits. The Vice-Chancellor also presented first degree certificates to 11 graduating inmates of the centre.

Officer in charge of Enugu Custodial Centre, Mr Joseph Usifo, commended the inmates for the educational feat they have attained.

Usifo, who is a Deputy Controller of Corrections, urged other inmates to take advantage of the opportunity provided by the Controller General of Corrections to better their lots educationally.

The Assistant Controller of Corrections, Mr Kevin Iloafonsi, who is the desk officer of the study centre, said that the study centre started with 11 inmates but now has over 500 students.

Iloafonsi said the study centre had created a platform where inmates can realise their educational dreams,

adding that no inmate who passed through the programme comes back to jail.

Represented by his Chief of Staff, Dr Otive Igbuzor, the Delta Central lawmaker advised that the advocacy be extended to the Executive arm of government since it is the final authority in implementing the Act.

"I am gender sensitive. I support the inclusion of women in the development process. So you can be assured of our support in terms of your demand for women inclusion in the relevant structures of the Petroleum Industry Act.

"But you also need to continue the advocacy, especially to the Executive arm of government because they are the ones that will make the final appointment. And they are also responsible for the implementation of those areas. But you can rest assured of our commitment to continue to push for women inclusion in development and justice for women", he said.

Earlier, the leader of the delegation, Mrs Glory Bassey called for the inclusion of women in the application of the three percent Host Communities Fund of the Petroleum Industry Act.

She said the group was founded in 2005 with a mission to promote

transparency and accountability for consolidation of Nigeria's democracy.

She asked the federal lawmaker to lend his voice for the inclusion of women in the application of the Petroleum Industry Act 3 percent Host Communities Fund.

She lamented that gender inequality is one of the

oldest and most pervasive forms of inequality, adding that about 153 countries have laws that promote gender discrimination.

She said: "In tackling the problem and advocating for women's economic inclusion in the Niger Delta with the Petroleum Industry Act as an enabler, our organisation is embarking on a 30% campaign that focuses on ensuring female participation in extractive - resource - governance, making sure women participate strategically in local governing structures and extractive industry boards, community development committees, governing organs of petroleum companies, governmental entities, and communities trust funds, where decisions on resource allocations and management are to be made in consultations with other gatekeepers in the oil and gas host communities in line with the Petroleum Industry Act".

# 9 absconded NYSC corps members to repeat service in A'lbom

Nine corps members out of 1,522 posted to Akwa Ibom in 2021 will repeat their service for absconding after their orientation exercise in the state last year.

Speaking during the passing-out ceremony of batch 'B' stream 1 corps members in Uyo on Friday, the State Coordinator, Mrs Chinyere Ekwe said that eight other corps members who indulged in several forms of misconduct will also undergo various forms of extension between two weeks and four months respectively.

"I am proud to report that during the last year, this set of corps members under my watch, was not only committed to their assigned daily duties, but they were active in both group and individual Community Development Service activities.

She said that Corps members are leaving their various host Communities better than they met them and have lived harmoniously in these locations without conflicts

She disclosed that a total number of 1,522 corps members were qualified to exit service this year.

Ekwe explained that out of 1,522 corps members posted to the state, nine absconders were recorded and have been booked to repeat the service year.

She said eight others who indulged in acts of misconduct, ranging from absenteeism, unauthorized journeys, and other misconducts shall serve various degrees of extension ranging from two weeks to four months.

She commended the state government for their support and the National Governing Board of NYSC for visiting the camp to ensure that all the basic needs of corp members were put in place.

Akwa Ibom State Governor Udom Emmanuel urged the corps members to leverage the Skill Acquisition and Entrepreneurship Development to develop themselves and become self-reliant with capacity to employ others.

Emmanuel, who was represented by Mr Emmanuel Akpabio, Director of Youth Development, Ministry of Youths and Sports, said that the state would continue to be committed to the scheme.

"Our resolve to sustain our welfare package to corps members has remained sacrosanct. Apart from ensuring regular and timely payment of monthly stipends, the culture of ensuring the provision of transport fare to corps members at every orientation exercise has been maintained." Emmanuel said.

In a related development, Governor Udom Emmanuel has provided relief materials to Youth corps members who were attacked by armed robbery in Uyo recently.

Udom, who was represented by Commissioner for Youths and Sport, Sir Monday Ebong Uko said it was necessary to provide succour and all necessary assistance to the Corpers adding that the robbery incident was unfortunate and unacceptable.

## Robbers invade NYSC lodge, female victim alleges rape in A'Ibom

### •As coordinator refutes rape rumour of corps members

rmed robbers have attacked the residence Lof Corps members along Udo Ekong Ekwere Street, off Information Drive and dispossessed them of their valuables, The Trumpet gathered.

The incident occurred on Wednesday night as the robbers stormed the area by 1 am in a tricycle ransacking all the rooms where 21 youth corps members lodged in Uyo.

An eyewitness in the neighbourhood who pleaded anonymity said items carted away include laptops, cell phones, and an undisclosed amount of money.

Some of the corps members who spoke with The Trumpet on Thursday morning lamented that there was no help in sight during the attack despite their cry

One of the Corps members who identified himself as Emeka Emmanuel said, "They arrived on a tricycle, popularly called Keke and immediately started operation. They beamed high-intensity torchlight

everywhere and pounced on every door with heavy iron and threatened to shoot us if we failed to cooperate."

A female Corps member, who also spoke on condition of anonymity, while fighting back tears, said her phones, laptop, and cash were forcefully taken away from her after the hoodlums gained entrance into her room from the back door.

You know at that time of the night, most of us females, we used to sleep naked and the suddenness of the attack caught us unprepared. They beamed the torch through the window and threatened to shoot if the door was not quickly opened," she explained.

Another female Corps member alleged rape while saying targeting serving Corpers was totally out of place and unheard.
"I have never heard of

this anywhere in Nigeria, even in the North, where insecurity is at the highest peak, that Corpers could be deliberately targeted, raped, and robbed by criminals at gunpoint. Is it because we are not from Akwa Ibom that no one could hear our



shouts and come to save us?", she lamented. Mr Nsikak Ibanga, a

night guard at the State Secretariat of the Nigeria Union of Journalists which is located opposite the Corpers lodge said, "I raised alarm by hitting the supporting pillars holding the reconstructed NUJ auditorium," but "the sound reverberated across the whole area but no response."

Änother neighbour, Bassey Offiong, said "when I heard the attack and the outcry of the Corpers, I quickly

reached out to the Police at Ikot Akpanabia Command, which is very close here, but they arrived a little late after the criminals had finished and left with their tricycle."

Also, the Youth Leader of the area, Comrade Godwin Okpo, blamed incessant criminal activities around communities on the collapse of internal security organized by the local residents.
"I used to go round from

house to house to collect monetary contributions for the night vigilante group to secure the area at night, but suddenly they started accusing me of embezzling their money. So there was nothing I could do again," he said.

Meanwhile, the State's Coordinator of the National Youth Service Scheme in Akwa Ibom, Mrs Ekwe Chinyere has debunked rumours making the rounds across the country that female Corps members were raped during the operations.

According to a statement issued and make available to newsmen in Uyo on Thursday, Mrs Ekwe in the company of the Commissioner of Police, Olatoye Durosinmi visited the Corps members' lodge for an onthe-spot assessment, adding that no Corps member was raped.

"While there, it was confirmed that 21 Corps members occupy the said property. The interaction with the Corps members further revealed that an

attack on them was actually carried out by thieves at about 1 am this morning, the statement said.

The statement, however, confirmed that the invaders took valuables including phones, laptops, and some cash during the operations adding that no bodily harm was meted on the victims.

#### Bayelsa, Cuba Consortium sign MoU on vaccines, pharmaceuticals factory

Bayelsa State Government has signed a Memorandum of Understanding (MoU) with BioCubaFarma Consortium of the Republic of Cuba for the establishment of a vaccines and pharmaceuticals production plant in the state.

This was the fallout of a three-day investment visit to Cuba led by Governor Douve Diri.

At the ceremony in Havana, the Cuban capital, which was witnessed by Governor Diri, the Bayelsa Commissioner for Health, Dr Pabara Igwele and the Secretary, Permanent Ministry of Trade, Industry and Investments, Barrister Patience Abah, signed for the government while the First Vice President of BioCubaFarma, Dr Mayda Mauri Pérez, signed for the consortium.

A statement by the Director, New Media to the Bayelsa State Governor, Dr Kola Oredipe, noted that the partnership is in furtherance to an earlier bilateral agreement between the Nigerian government and that of Cuba on scientific cooperation, technology transfer, academic collaboration and the co-production of vaccines and other pharmacological products in the country.

Igwele said the partnership deal marked a milestone in the quest of the government to attract investments into the state.

"This is a good development for us in Bayelsa State. The vaccines and other pharmaceutical products are in high demand in Nigeria and beyond. With the centre, Bayelsa can serve other states and nations in the West Africa sub-region. In the next few months, the technical teams from both sides will work out further details of the agreement with the technical teams from both ends," he stated.

The Commissioner for Health said the vaccines pharmaceuticals production factory would provide job opportunities, build expertise of Bayelsa people and also ensure technology transfer for sustainability of the plant.

Also, as part of the visit, the Bayelsa delegation met with Deputy Governor of Havana Province, Mrs Yanet Hernandez Parez, and the Vice Minister for Trade, Matanzas Province, Ms Deborah Rivas Saavedra to explore other business opportunities, including discussions on sugar production, renewable energy, ICT and exchange programmes for students in Science, Technology, Engineering and Mathematics.

Others who joined the governor at the various meetings and witnessed the signing ceremony include the Nigerian Ambassador to Cuba, Benaoyagha Okoyen, Dr Fred Agbedi, representing member Sagbama/Ekeremor Federal Constituency in the House of Representatives, Prof. Ebitimitula Etebu, Vice Chancellor, Bayelsa Medical University, Yenagoa and Major Lancelot Anyanya



"We are just remembering our ancestors and giving them the honour that they deserve. I, therefore, urge the Oodua race worldwide, especially the Yorubas in particular, to jointly continue to celebrate the Ayangalu festival to let the whole world know that the drum originated from us here in Africa".

He emphasized the roles played by Orunmila in the drumming communication being the deity that first decoded the meaning of the drum and things that had to do with it.

"Our ancestors used drum majorly for communication, for it goes beyond entertainment and till date, Yoruba people use the drum for communication and as a vital tool for preaching peace and harmony.

"By the spirit of Ayangalu festival, we use the rhythm and tone to communicate peace and peaceful coexistence to our people.

"We are like the barometer in



the next electioneering campaign in Nigeria, Osun gubernatorial election is coming up in the next two to three weeks and that will lead to a major election in Nigeria by next year, January." Ooni Ogunwusi stated.

Ms Bisola is the Ogbomosho born Award-winning Nigeria's first female "Bata" drummer. # Osun 2022: Ooni assures INEC of neutrality, support

#### World Igbo leaders task South-East Governors on Nnamdi Kanu's release

# Prison, security officers are accomplices in Kuje's attack — Senate President

Senate President, Ahmad Lawan, has alleged that terrorists of the Islamic State West Africa Province (ISWAP), who attacked Kuje Medium Maximum prison on Tuesday night have collaborators within the Nigerian Correctional Service (NCoS).

Lawan made the assertion after an assessment visit to the damaged custodial centre on Thursday, adding that security agencies in the Federal Capital Territory (FCT) must have gotten wind of the operation during the planning stage or when the terrorists were on their way to invade the facility on foot.

According to him, the attack on the facility could only be possible with the help of insiders.

"An attack Medium Kuje Security Custodial Centre have been possible with the collaboration of insiders within the nation's correctional system.

"The attack on facility correctional

symptomatic of the failure of security architecture. The attack is only a culmination of the failure," the Senate President said.

Over 300 Islamic fighters stormed Kuje late Tuesday, shelling the facility relentless rockets propelled with grenades and improvised explosive devices, operation that led to the escape of over a thousand inmates, including many top commanders of terrorists who had been held captive in the facility for years.

Speaking further, Lawan said "We were told that an estimated 300 suspected this terrorists attacked facility. They came on foot and I believe they should have been detected.

"In the first place, 300 people will not come for an operation like this without planning. Planning must have taken a week, a month or a bit more.

"I believe that our security agencies should have picked this from their tracking systems in the FCT," he

Lawan also disappointment the lack of Close Circuit Television (CCTV) cameras in the facility. He, therefore, directed the NCoS to make provision for CCTV cameras in all Correctional Centres in its 2023 budget to tackle reoccurring attacks in the country.

"Having gone round the facility itself, we are disappointed that this facility does not have CCTV cameras, something that would record and give you details of what is happening and sometimes record the events.

"This is a medium-security custodial centre, how on earth in the FCT facility of this magnitude we don't have CCTV? It means we can say that all other medium security centres across the country do not have CCTV.

have asked Comptroller General Correctional ensure that the request for CCTV at the maximum medium custodial centres of the country are included in their 2023 budget



because this is essential and indispensable.

"Now, as this facility lacks a functional CCTV, there's no record of what happened, except narration. But if we had CCTV, at least the records would have been there and analysis made, and arrest will be based on the information from the CCTV," the Senate President stated.

Lawan tasked the security agencies to ensure that the inmates who escaped from

the centre were brought back. Earlier, the Commanding

Officer of the Nigerian Army Battalion in Gwagwalada, Lt Col Adisa, told the Senate leadership that over 300 suspected insurgents attacked the facility on Tuesday.

"Only a total of 50 security were on the ground when they came armed with Improvised Explosive Device (IED) and other weapons," Adisa

#### Troops kill 5 terrorists, rescue boat that lost propelling ability for 32 hours

Troops of the Nigerian Army have killed five Boko Haram terrorists in Gamage village of Borno State, recovering assorted weapons like AK47 rifles among others.

Director of Defence Media Operations, Major General Benard Onyeuko, in a statement optioned by The Trumpet on Thursday, confirmed the killing while adding that troops also rescued a 16 meters surfer passenger boat, MV NUE SWIFT, which lost its ability to propel for about 32 hours.

According to Onyeuko, the crew and boat which drifted at Agbara platform while transiting from Forcados to Bonny Mooring on July 5, 2022, were handed over to Forward Base Operation Bonny the following day.

He said, "On 3 July 2022 troops of 24 TF Brigade Operation HADIN KAI made contact Boko Haram terrorists at Gamage Village in Borno State, after the encounter 5 terrorists were neutralized.

"Items recovered include 2 x AK47 rifles, 3 x dane guns, 2 x AK47 magazines, 70 x rounds of 7.62mm ammunition, 7 locally fabricated rounds of 7.62mm ammunition, 4 x cell phones, 3 x ATM cards and several bags of assorted foodstuff.

"In compliance with its role of search and rescue as well as responsibility towards the safety of lives and property in the Nigerian Maritime environment. The Nigerian Navy Ship OKPABANA of Operation Delta Safe on 5 July 2022 responded to a distress message about the propulsion of a boat on transit in a swift reaction to the message located and rescued the 16 meters surfer passenger boat MV NUE SWIFT belonging to Lagosbased oil service company.

"The boat lost its propelling ability at Agbara Platform while transiting from Forcados to Bonny Mooring and drifted for 32 hours before being rescued by its own troops. Accordingly, the crew and boat were handed over to Forward Base Operation Bonny on 6 July 2022."

The Army General further stated that the military high command while commending troops on the frontlines for their timely interventions, also encouraged the members of the public to avail troops of credible and timely information on criminal activities.

### Taraba security worsens, soldiers, police now bandits' targets Government abandons citizens for 2023 elections

The security in Taraba State is growing worse on a daily basis with becoming uniform men bandits' prime targets, The Trumpet reports.

lucidly This was demonstrated last week when no fewer than seven soldiers were killed in an ambushed by bandits Karim-Lamido Government Council.

The killing of the seven soldiers came barely two months after six soldiers and a mobile policeman were murdered in gruesomelv Tati village of Takum Local Government.

Apart from the security personnel whose lives are being wasted by bandits, who have taken over the entire forests surrounding the State, our correspondent learned that the lives of innocent citizens are as well going down the drain daily in Taraba with no help in sight.

Recall that over of the Reform members Church of Christ for Nations (RCCN) slaughtered in night attacks by militias at Kwenten and other communities in Ussa Local Government Council of the State.

The same goes with the Muslim worshippers, as several numbers of them were noticed to have been abducted from different Mosques during the justconcluded Ramadan.

The bandits who have been having a field day in the state know no religion or tribe as members of both religions have continued to fall prey to their attacks.

Leaders assigned with the responsibility of building walls of protection around their subjects seem to have failed in their responsibilities, as the people have begun to seek alternative areas of domicile and protection.

While the bandits have continued to make life more cumbersome and burdensome for the people, the leadership of the State that ought to show concern for the lives being wasted daily were noticed to have been busy plotting how to achieve their political ambitions in 2023.

the security personnel, especially the police and soldiers, are putting in their best, however, their best seems not to be good enough, as the muchdesired support, especially in the area of logistics, has not been forthcoming from both the state and the federal

Piqued by what is happening in the State, a third Republic senator, Ibrahim Goje, who was not comfortable with the way and manner Governor of the State, Darius Dickson Ishaku is handling governance by dabbling into the traditional institution affairs of Gassol council, beckoned at the governor to concentrate in addressing the security challenges bedevilling the state.

Some of the Council Chairmen who also admitted their councils are that gradually being overtaken bandits are caps in hands seeking help from governments at the state and federal levels.

The Trumpet gathered that the help, which is not forthcoming has compelled some of them to relocate to Jalingo, the State capital.

One of the Council Chairmen who spoke with our correspondent on the condition anonymity of admitted that he now oversees the affairs of his council from Jalingo, the State capital.

"Though I am aware that even Jalingo is not safe, I still prefer here to my Local Government Council because of the numbers of security operatives we have here," he said.

The council boss who also agreed that the state government is not doing arrest situation, also felt sad that the government at the centre has on its part "neglected Taraba because it is not an APC state."

While those who have the well wither, have begun to relocate from their areas of domicile to Jalingo metropolis, the Have-Not, whom the government of the day seems not to be bothered about, have on their parts resolved to seek help from the local Vigilantes who are as well doing their best.

Reeling out the numerous efforts so far put in place to checkmate the activities the State bandits. Commissioner of Police, CP Abimbola Shokova, said their efforts have begun to yield results, as some suspects that are allegedly connected to the various bomb explosion in the state have been arrested.

According to him, 37-year-old man, who specialized in making bombs has been nabbed by the men of the command.

Shokoya, who also spoke on the mapped-out strategies to frustrate bandits from resurrecting their ugly heads during and after the Sallah celebration, said over 3,500 officers and men of the Command have been deployed to ensure a hitch-free celebration.

Reiterating determination that the Sallah celebration will "be peaceful in Taraba", he beckoned at the people not to hesitate to reach out to the security operatives with genuine information that would assist the security agencies to track down the bandits.

# As Muslims mark Eid El Kabir

igeria, like many countries around the globe will on Saturday 9th July celebrate Eid-El-Kabir, also called the "Sacrifice Feast", which is the second of two Muslim festivals. It is considered the holier of the two and honours Prophet Ibrahim's willingness to sacrifice his son Ishmael - an act of obedience to God's command. On Eid El Kabir, Muslims demonstrate their obedience to Allah by sacrificing an animal.

The holiday is inspired by a story from the Quran that is also known to Christian and Jewish faithful. Although Eid - El - Kabir traditions vary from country to country, there are some common elements. The day usually starts with a communal prayer (Eid Salaah). Muslims congregate at the local mosque after sunrise to say special Eid prayers and hear a sermon. Following the prayer, people wish one other Eid Mubarak, meaning Happy Eid or Blessed Eid. They may embrace each other and exchange small gifts.

In commemoration of the event, many millions of animals are slaughtered on this day. By some estimates, over 10 million animals are sacrificed each year in Nigeria alone. Sharing and charity play a large part on Eid, and many people give money to charitable causes on this day, in addition to sharing the meat of the slaughtered animal with people in need.

Though Eid El Kabir involves actual animal sacrifice, its underlying meaning is based on a more symbolic and selfless interpretation of the concept. Muslims are encouraged to sacrifice personal desires and share their wealth with those that are less fortunate. Simply expressed, Muslims are enjoined to give up something they hold dear, just as Prophet Ibrahim did when he showed willingness to sacrifice his own beloved son. The fundamentals of the celebration approximate love, togetherness, and harmony.

It is against this background that 2022 Eid

El Kabir remains relevant to all Nigerians now more than ever. Owing to the hyper - inflation that is afflicting the country, the poor state of the national economy, ASUU unending strike, banditry and general state of insecurity, the celebration will be low-key this year. The occasion should be used to send special messages to the leaders and the led in the society.

For the leaders, we are using the occasion to remind them that obedience, as manifested by all Nigerians in these trying times, deserves to be compensated with good governance. Government should be mindful of its contract with Nigerians as enshrined in the Constitution. Leaders must eschew the temptation to dip their hands into public treasury for self – serv-



# Settling in locations outside God's will

Then the Lord appeared to him needed to look up to God. and said, "Do not go down to Egypt; live in the land which I shall tell you" (Genesis 26:2). In many ways, the writings and words of the Holy Bible are cast in poetic language. The instruction of the Lord to Isaac is one of such. Isaac was commanded not to go down but to live in the land where God will show him. We go down if we do things out of the purview of God. We live if we put ourselves in the sight range of God.

Our prayer is that we shall be where God has marked for us as our location Between Isaac and his father Abraham, there were two famines. Consequently, there is nothing we are undergoing today in terms of hardship and lack or scarcity that the people of God did not undergo in the Bible. However, in all this, our relationship with God matters a lot.

The experiences of human lack and deprivation may lead to desperation. The account of Esau (Genesis 25:29-34) is instructive. Hunger made Esau so weary that his reply to his brother, Jacob's request was "Look I am about to die; so what is this birth right to

Hunger can be 'weaponized.' Why do you think unscrupulous politicians keep their people poor in a state of destitution? In the face of death, shame, failure, and poverty, we naturally become eager and desperate. This state makes us devise human ways that we may figure as the way out. There is nothing wrong with using human reason to solve daily problems that we face. But we must seek the divine face in every situation. Isaac

Our human ways should not be outside the divine will of God. Our today's experience can be

likened to the famine faced by Isaac. In spite of the resources and structures we see everywhere, both human and non-human, we are enmeshed in poverty, unemployment,

dying industries and firms, decaying health and education systems, and even in areas with huge budgetary votes, we are still shamefully in dire need of help. Look at our oil sector, look at our security, etc. People manning these areas cannot complain about the lack of resources and finance. "Unless the Lord builds the house, they labour in vain who builds it; unless the Lord guards the city, the watchman stays awake in vain" (Psalm 127:1). It is not late in the day for us to seek the face of the divine Builder and Watchman in our human affairs.

There are many impediments we encounter in our life's journey. They come in our workplace, family, spouses, children, and businesses. We should strive to be victorious over these challenges and obstacles. Only those who stand up to confront and put these obstacles down are called overcomers and conquerors (Romans 8:37). In our text today and based on the experience of Isaac (Genesis 26:1-33), as a victim of a natural evil – famine - Isaac needed to look up to God. His situation can only be turned around when he could find water. But not water in just any location! The natural place to seek water was Egypt. The Nile was there. But God told him otherwise. In the Bible, Egypt is a metaphor for bondage, slavery,

and punishment. Are you living in plenty but in punishment, bondage, and slavery?

Many are in such situations here and outside Nigeria.

God has since delivered His people from Egypt and would not want them to return to this experience again. Isaac became his own barrier. He failed or chose not to follow God's leading. He did not go down to Egypt, but he did not go the way of God either. Isaac went to the land of Gerar. He met Abimelech, the King of the Philistines. But the men of the place 'asked' about his wife (Genesis 26:6). Isaac had to resort to falsehood for the fear of death.

He ran away from one death to another death. The king rescued Isaac from this first disaster.

The story says further that Isaac sowed in this land and reaped in the same year a hundredfold "and the Lord blessed him. The man began to prosper, and continued prospering until he became very prosperous" (Ğenesis 26:12-13).

Nevertheless, Isaac became an object of envy due to this prosperity and wealth. The same King Abimelech issued Isaac a quit notice. "So the Philistines envied him" (verse 14) "and Abimelech said to Isaac, "Go away from us, for you are much mightier than we" (verse 16).

Isaac only got material blessings in a location that was outside the will of God. He had no rest! He opened blocked wells. He had good harvests. His flocks increased. But so were the quantum of envy, hatred, and enemies that surrounded him. At the Valley of Gerer, Isaac opened all the closed wells of Abraham, giving them the same names his father gave them thus: Esek (contention, v. 20); Sitnah (hatred, v. 21), and Rehoboth (there is room, v. 22).

God did not appear to Isaac in any of these places.

We must go to locations where God would appear to us. This will be a place of worship, prayer, and where God gives his people rest. It is in such a place we can chant, "O come, let us worship the Lord! Let us shout joyfully to the Rock of our salvation. Let us come before His presence with thanksgiving; let us shout joyfully to Him with psalms" (Psalm 95:1-2). God

desires our worship. We cannot be truly blessed where we cannot worship God truly.

"We pray that he may become more like our High Priest and Good Shepherd, the Teacher and Servant of all and so be a genuine sign of Christ's loving presence among us.

"We pray for the Bishops, Priests, religious men and women, lay faithful and eminent personalities that will be honouring the event from far and near, that God will grant them safe journey.

### Bullion Go Neat Global urges FG to fix challenges of manufacturing sector

President of Bullion Go-Neat Global Limited, Olufemi Ajadi Oguntoyibo, has challenged the Federal Government to assist Micro, Small and Medium Enterprises (MSMEs) and the manufacturing sector to remain sustainable to enable them create more jobs in the country.

Oguntoyibo, who spoke at a forum organised by the Commerce and Industry Correspondents Association of Nigeria (CICAN) in Lagos, listed lack of long-term, accessible credit facilities for local manufacturers in particular and other businesses in the country.

As a politician, philanthropist and promoter of talents, he also disclosed that lack of stable power supply has dwarfed the country's business sector for years, adding: "The Federal Government's failure to guarantee stable power supply has killed and continued to kill MSMEs, Small and Mediums Enterprises (SMEs), as well as medium and large-scale firms.

"In my company located at Mowe area of the Obafemi Owode Council of Ogun State, the Ibadan Electricity Distribution Company (IEDC) that provides electricity to the area told us that we will be given electricity at some time of the day. We now programme our operations to it, but unfortunately, they don't keep their promises. Once they restore power and we begin operations, they will switch off power.

"When we put off our generators to continue with production as soon as public electricity is restored, they again plunge us into darkness almost immediately and that happens all the time, which leads to damaging our generators, raw materials and other equipment. That led me to call the IEDC to remove my company and home from their power network. And since then, I run my factory and home with my generators.

"There is also the problem of scarcity of high cost of petroleum products. When you even go to the filling stations to buy diesel and petrol, they ask you to go and bring your generator set or ask for gratification or they will not sell the products to you, even though you express readiness to pay any amount they chose to sell the products," he lamented.

He said government had failed woefully in its responsibility to guarantee public power supply to the business firms and homes in the country, despite the huge amounts being budgeted on a yearly basis to service the power

The Bullion Go-Neat Global boss also lamented the deplorable state of roads in the country, stressing that the company spends huge amounts monthly to fix the damage bad road network causes his company's vehicles.

Oguntoyibo, who disclosed that he has 80 direct workers on his company's payroll and over 500 indirect workers, blamed the high rate of crime in the country on unemployment and appealed to the government to tackle the issue.

He also lamented multiple taxations, adding that the businesses were being over-taxed in the country.

The company, however, appreciated its customers for

their patronage and pledged more incentives adding that customers of the company, which manufactures alcoholic and non-alcoholic beverages stand the chance of getting mouth-watering incentives if they continue to patronise its products.

According to him, the incentives include cash rebates, discounts on orders and brand ambassadorship, stressing that the pack of incentives was a way of appreciating loyal customers and also encouraging new distributors who had desired a franchise arrangement with his company.

He attributed the rising profile of the company to the uniqueness of its brands, especially Coco Samba, which demand, he said, had soared in recent times, adding: "As a company, we have been particularly thrilled by the wide acceptability of Coco Samba.

"That wide acceptance is the assurance we have that the effort, in terms of research and blend of raw materials we put in Coco Samba, as well as production cost, was not a waste. Coco Samba meets customer's need and we are working to make it even more available to more clients and more consumers."

Oguntoyibo appealed to the Federal Government and its agencies to work towards removing the bottlenecks militating against the manufacturing sector, saying this would not only help in creating additional jobs in the country but also enable the real sector to fulfil its role of job creation, value addition and triggering technological development.

#### LCCI seeks removal of fuel subsidy over lingering scarcity, queues

The Lagos Chamber of Commerce and Industry (LCCI) has charged the Federal Government to be courageous by removing the controversial fuel subsidy once and for all if the country's economy hopes to grow.

President of LCCI, Dr Michael Olawale-Cole, who made the call at the chamber's second quarter economic review in Lagos, also asked the government to curtail if not totally eliminate crude oil theft to enable the government to generate enough funds to provide infrastructure, health, education and other social amenities in the country.

He called for agricultural sector to be supported to boost food production rather than depend on food imports, saying: "There is the need to address structural bottlenecks and regulatory constraints that have contributed to the high cost of doing business in the country.

"A supportive and conducive investment environment is crucial to boosting private sector involvement in the economic recovery and growth process. Government should initiate moves towards having cost-reflective tariffs in the power sector. As this will attract the needed investment to boost power supply and halt the frequent national grid crashes. We should also begin to initiate special purpose interventions in boosting deployment of renewable energy."

He also canvassed more investments in export infrastructure, enhanced and automated port operations, policy to tackle high production costs and boosting foreign exchange supply to sustain the country's trade with other countries of the world.

Olawale-Cole also urged the government to ensure diversification of its exports by boosting local refining capacity, production of petrochemical products and accelerating reforms in the oil and gas sector to attract more foreign investments in the future.

He said the Russia and Ukraine war had lingered contrary to expectations, adding that the crisis was engendering deeper fear about worsening food scarcity and that more Nigerians were falling into poverty.

Noting that the food supply chains were been attacked, thereby making it difficult for the food supply to get to their intended destination, adding that has made foodstuffs become very expensive, he said the most sustainable solution to the high cost of foodstuff is for government to encourage local food production to attain food sustenance in the country.

It would be recalled that the LCCI on a quarterly basis reviews the country's economy to draw the government's attention to the challenges the business community were contending with.

#### Bread bakers threaten nationwide withdrawal of services

Edo State chapter of the Association of Master Bakers and Caterers in Nigeria (AMBCN), has declared that its members will participate in the proposed nationwide withdrawal of services as directed by its national body.

Chairman of the Edo State chapter of the association, Benjamin Agbonze, who disclosed this during a media chat with journalists in Benin City shortly after the association's monthly meeting, said the withdrawal of services was necessitated by the incessant increases in the prices of baking materials in the county.

His words: "Our national body has directed that on July 13 to 27, we should withdraw our services in order to rearrange our services to meet up with the current economic realities. A bag of flour that was sold for about N21,000 in January this year has risen to about N30,000. We are not making profit with the continued increments in the cost of materials used in the baking business.

"The national body has resolved that we cannot continue to increase the price of bread, so we are calling on the Federal Government across board to

His words: "Our national dy has directed that on y 13 to 27, we should thdraw our services in order rearrange our services to intervene. We want the government to help reduce the tariff on baking materials and also give flour millers' easy access to foreign exchange.

"People are already looking for an alternative to bread and if we continue to hike prices of bread continuously, it will not augur well for the people and bread value chain business.

"If we continue the way things are, very soon we will go out of business. The national executive council of our association during our June meeting directed its units across the country to embark on two weeks' withdrawal of our services."



### Fidelity Bank takes over Benin, Kano, Kaduna DisCos over multi-billion debts

Fidelity Bank Plc has taken over the Benin, Kano and Kaduna electricity distribution companies (DisCos) over their inability to repay multi-billion naira loans they obtained to pay for assets acquired in the 2013 privatisation exercise.

This followed Federal Government announcement of the restructuring of the Ibadan Electricity Distribution Company (IBEDC) and Port Harcourt Electricity Distribution Company (PHEDC).

The actions underline a wave of distress sweeping through electricity distribution companies due to operational losses amid issues about service delivery, bill collections and debts owed gas suppliers.

While the Benin DisCo is owned by Victor Osibodu and his wife, Funke, a former managing director of Ecobank and Union Bank, the Kano DisCo-Alhaji Tajudeen Aminu Dantata, Kaduna DisCo is owned by former Nigerian Communications Commission (NCC) commissioner, Alhaji Yusuf Hamisu Abubakar.

The bank has written to the Bureau of Public Enterprise (BPE), which oversees the government's 40 per cent stake in the DisCos that it had replaced the board members of the affected DISCos.

The new board members for the Kano DisCo are, Hasan Tukur as Chairman and Nelson Ahaneku and Rabiu Suleiman as members, while the Benin DisCo has K. C. Akuma as Chairman with Adeola Ijose and Charles Onwera as members.

For the Kaduna DisCo, the new appointments are, Abbas Jega (Chairman), while Ameenu Abubakar and Marlene Ngoyi are members, just as the BPE has also nominated Bashir Gwandu (Kano), Yomi Adeyemi (Benin) and Umar Abdullahi (Kaduna) as independent directors to represent government's 40 per cent interest in the three DisCos during the transition period.

On the Ibadan and Port Harcourt DisCos, a statement jointly signed by the Executive Chairman of the Nigerian Electricity Regulatory Commission (NERC), Sanusi Garba and Director-General of BPE, Alex Okoh, explained that the announcement followed Fidelity Bank's activation of the call collateralized shares of KEDCO, BEDC and Kaduna Electric over their inability to repay loans obtained to pay for assets acquired in the 2013 privatisation exercise.

They added that the Assets Management Corporation of Nigeria (AMCON) would be a placeholder board for IBEDC in temporary capacity, while the PHEDC undergoes restructuring to prevent its imminent insolvency.

The NERC and BPE chiefs said the new boards of the affected DisCos have been approved and the bureau was collaborating with the Central Bank of Nigeria (CBN) and the Ministry of Power to ensure no service disruptions during the transition.

"Today we were informed by Fidelity Bank that they have activated the call on the collateralised shares of Kano, Benin, and Kaduna (Fidelity and AFREXIM) DisCos and that they have initiated action to take over the boards of the DisCos and exercise the rights over the shares.

"Fidelity Bank's action is a contractual and commercial intervention and is between the Core Investors in the DISCOs and the lender. BPE is involved because of the 40 per cent shareholding of the Government in the DisCos. Fidelity Bank has informed us of the new board members of the affected companies," the statement added.

We have also received assurances that Fidelity Bank will participate fully in all the ongoing market initiatives aimed at improving the sector, especially the National Mass Metering Programme. In the interim, NERC and BPE met on an Emergency Basis and activated the Business Continuity Process and have appointed interim Managing Directors in the affected DisCos.

They explained that the Kano DisCo has Ahmad Dangana as Managing Director, Benin DisCo has Henry Ajagbawa and the Kaduna DisCo has Yusuf Usman Yahaya as managing directors, just as the BPE has obtained approval from NERC to appoint Kingsley Achife as the interim Managing Director with the takeover of the Ibadan DisCo by AMCON.

In a temporary capacity, AMCON will be a placeholder for the Ibadan franchise and will have Ahmed Kuru as Chairman, while Eberechukwu Uneze and Aminu Ismail are members, just as Oluwaseyi Akinwale will represent government interest on the board alongside the Director-General of BPE.

"Lastly, we are re-structuring the management and board of the PHEDC to forestall its imminent insolvency of the entity and as a condition to meet its market obligations, Iboroma Akpana will take over as Chairman of the board, while Emmanuel Okotete, Eyo Ekpo, Ismaila Shuaibu and Director-General of BPE will form the interim Board and Benson Uwheru will take over as Managing Director as part of the changes.

The Government will support the activation of emergency funds through the Nigerian Electricity Market Stabilisation Facility to support the entity while it goes through restructuring and repositioning to serve the citizens of the franchise area better. We are working with the Minister of Power to ensure no service disruptions during these transitions. We remain committed to supporting the Nigerian Electricity Supply Industry to serve Nigerians better," the statement added.

### Ogun, LCCI to partner on establishment of paper mill

The Printing and Publishing Group of the Lagos Chapter of Commerce and Industry (LCCI) has sought partnership with the Ogun State government in establishing a paper mill in the state.

Chairperson of the group Mrs Layo Okeowo disclosed this in Abeokuta, the Ogun State capital during the group's visit to the state Ministry of Industry, Trade and Investments.

Okeowo, who said the LCCI had indicated interest to invest in the paper mill value chain, sought allocation of 20 hectares of land from the government as its equity contribution towards the establishment of a modern and functional paper mill in the state.

She revealed that the demand for paper mills and related products in Nigeria has grown to over three million metric tons yearly, adding that the installed capacity had stagnated at 200,000 metric tons, making importation of raw materials and finished products inevitable.

According to investment analysts, about 4.3 million worth of investment machinery could produce 100 metric tons of paper per day, adding that paper products were being imported with the scarce foreign exchange to meet the country's current demand due to inadequate capacity, weak production and lack of enough investments in the sector.

"LCCI plans to establish a modern and functional paper mill in Ogun State in line with the actualisation agenda and the state government's public, private partnership (PPP) framework. The establishment of the paper mill will create opportunities for inclusive economic participation, as well as

engender direct and indirect jobs.

"It will also support the state government's revenue drive by facilitating income and wealth creation which will sustain the economic development. It will also bolster the industrial profile of the state as the industrial hub of Nigeria," she stressed.

Responding, Commissioner for Industry, Trade and Investment, Mrs Kikelomo Longe, expressed appreciation to the group for its resolve to partner with the government by establishing the firm in the state.

Longe assured the group of government's assistance in ensuring that the business thrived in the state.

According to her, the setting up of a paper mill firm in the state will further strengthen the relationship between Lagos and Ogun and create job opportunities in both states.

### Nigeria loses \$10 million daily to oil theft

Managing Director of TotalEnergies EP Nigeria Limited, Mike Sangster, has said that crude oil theft in the country has assumed the dimension of an organised crime for which Nigeria loses about \$10 million daily in revenue.

Sangster spoke at the Nigerian Oil and Gas (NOG) conference and exhibition in Abuja during industrial leaders' panel session on the future of Nigeria's energy sector in the era of the Petroleum Industry Act (PIA).

Sangster noted that the PIA had made provisions for a Host Community Trust Fund, which was a step in the right direction to empower the local communities and ensure a clear and consistent framework in the industry.

He, however, said this would not immediately end the activities of crude oil thieves and pipeline vandals, which had transcended into organised crime and disrupting the operations of oil and gas companies.

The TotalEnergies EP boss said the company had declared a force majeure on its Operational Mining Licence (OML) 58 and had stopped production since February 24 due to the vandalism of its oil and gas infrastructure.

"You can see some of the figures in the press. I mean maybe it is up to 100,000 barrels per day being stolen. With crude oil selling even at \$100 per barrel, that means \$10 million per day is stolen, which has been lost and mainly to the country because you know the Nigerian National Petroleum Corporation (NNPC) has 60 per cent of most of the Joint Ventures (JVs) while the International Oil Companies (IOCs) pay tax at 85 per cent.

"That is a huge loss for the country and so, I think it really needs to be a priority to look

beyond the host communities and how we can address the safety of crude oil and eradicate the theft once for all," he stated.

Sangster, therefore, urged the Federal Government and industry stakeholders to find a lasting solution to the issue of vandalism in order to make Nigeria an investment destination.

Also speaking, Managing Director of Chevron Nigeria's Mid-Africa Business Unit, Rick Kennedy, advocated institutionalisation of the PIA, which would define clear role for industry stakeholders going forward.

Kennedy, who is also Chairman, Oil Producers Trade Section (OPTS), said traditional oil and gas businesses had a key role to play in Nigeria's energy transition journey.

"We're going to transition to more and gas. I think that we all agree that we agree with that. That's our transition on fuel and with time other sources of energy. They will become economically viable and readily available," he said.

Kennedy said the transaction would happen at a different pace for different countries, adding that Chevron remains committed at present to its traditional oil and gas business.

### Senate seeks more support for AMCON's debt recovery drive

Chairman, Senate Committee on Banking, Insurance and other Financial Institutions, Uba Sani, has restated the willingness of the National Assembly to continually support the debt recovery efforts of the Assets Management Corporation of Nigeria (AMCON).

He said the support had become critical because AMCON remained a strategic national institution that plays an important and pivotal role in helping to stabilise the nation's economy.

Sani, who was represented by Senator Olubunmi Adetumbi, however, commended the management of AMCON for remaining resolute in spite of being saddled with the tough assignment of recovering nearly N5 trillion owed the country by debtors, who have been hiding under all manner of technicalities to approach the courts in their bids to stall repayment.

Sani spoke at a one-day retreat recently in Niger State with the theme: Asset Recovery As A Tool For Enhanced Growth And Stability Of The Banking Sector Sustaining The Impact And Bridging The Challenges Of AMCON.

While appealing to other Federal Government agencies to support AMCON's recovery drive, Sani also appreciated the contribution of the inter-agency committee set up in 2019 to ensure that debtors are held accountable.

The committee's work had brought many obligors to the negotiation table through the efforts of the Inter-agency Committee chaired by Prof. Bolaji Owasanoye, who is also Chairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC).

The committee comprises heads and representatives of agencies including the ICPC, the Economic and Financial Crimes Commission (EFCC) and the Nigerian Financial Intelligence Unit (NFIU), Central Bank of Nigeria (CBN), Nigeria Deposit Insurance Corporation (NDIC), Ministry of Justice and AMCON. They were expected to review the status of all debts owed AMCON, as well as deliberate on practical, legal and other strategies for the recovery of the outstanding debts.

### Ezuzu bags 3 years jail, loses properties over N5bn investment scam

The Benin Zonal Command of the Economic and Financial Crimes Commission (EFCC) has secured the conviction of David Wealth Ezuzu, an investment fraudster, before Justice Efe Ikponmwonba of the Edo State High Court, Benin City.

Ezuzu, who is the Chief Executive Officer of Arerben Ventures, an investment company, was arraigned on one count charge of obtaining by false pretence. He was said to have fraudulently obtained over N5 billion from unsuspecting members of the public on the pretext of investment in forex trading.

The charge reads, "That you, David Wealth Ezuzu (trading under the name and style of Arerben ventures) sometimes between 11th January, 2020 and 1st day of March, 2021 in Edo State within the jurisdiction of this Honourable Court did transfer the aggregate sum of N15,2000,000 (Fifteen Million, Two Hundred Thousand Naira) out of the total sum of N5,458,171,996.95 (Five Billion, Four Hundred and Fiftyeight Million, One Hundred and Seventy One Thousand, Nine Hundred and Ninety-six Naira, Ninety-five Kobo) you received in your Access Bank account number: 0795689642 from unsuspecting members of the public as investment into Forex trading to your Guarantee Trust Bank 0114467985 in the name of Ezuzu David knowing that same represent proceeds of Ezuzu David's criminal conduct, to wit: obtaining money by false pretense and thereby committed an offence contrary to Section 17 (a) of the Economic and Financial Crimes Commission (Establishment) Act, 2004 and punishable under section 17 (b) of the same Act."

The defendant pleaded guilty to the charge. Following his plea, the prosecution counsel, Francis A. Jirbo, prayed the court to convict and sentence him accordingly.

However, the defence counsel, A. Afamefena, pleaded with the court to temper justice with mercy as restitution shall be made to the victims of the crime.

In his ruling, Justice Ikponmwonba convicted and sentenced Ezuzu to three (3) years imprisonment with an option of N 2 million fine, while his company, D.W. Arerben Global Investment, was convicted and sentenced to a fine of N2 million. The company is to be wound up and the balance of N1,099,503.08 in its account forfeited to the Federal Government through

the EFCC for the purpose of restitution of the victims of the crime.

The judge also ordered the forfeiture of N102,131.45 in the defendant's business account and five other bank accounts (David Wealth Ezuzu Zenith bank account no: 2179944006, David Ezuzu Guarantee Trust Bank account no: 0046882751, David Ezuzu Standard chartered bank account no:5005093998, David Ezuzu Wema Bank account no: 025183759; 0620469522; 0620485793; 0620485786; 2009369467 and Prestana Enterprise Sterling Bank account no: 0081931988) to the Federal Government through the EFCC for the purpose of restituting victims of the crime.

The court further ordered that the defendant forfeits to the Federal Government through the EFCC for the benefit of the victims of the crime the following properties:

## FG to establish wood technology park, mass plantation

The Federal Government has proposed to establish a wood technology park where wood technicians can be trained. This is part of government's youth empowerment initiative and to aid the revitalization of the wood value chain industry.

Concluded plans have been made to embark on the mass plantation of timber across the country.

It is to establish this through its Raw Materials Research and Development Council, as the move will help in the provision of raw materials for the wood and wood products.

Organisers of the Wood Expo Nigeria disclosed this in a communique put together from the WEN 2.0 event in Abuja and made available to journalists at a press conference to announce 2022 edition of the expo coming up in Lagos in November.

The communique read in part, "The Expo noted and commended the Raw Materials Research and Development Council's initiatives of proposing to jointly establish a wood technology park for training of wood technicians.

"It also noted the proposed mass plantation establishment

(by the RMRDC) across the country for sustainable provision of raw materials for the wood and wood products, pulp and paper industries, as well as for environmental protection."

The communique pointed out that the objective of the expo was to promote sustainable use of forest resources as well as wood and wood products through the entire value chain in the sector while working out economic strategies for effective competition in the global market.

The forum noted the increasing environmental threats the country was facing as a result of forest depletion and the need to map out effective strategies to mitigate climate change effects.

The expo organisers noted and lamented that there was currently no certified forest in Nigeria, which queried the legality of forest resources in the international market.

Speaking to reporters at the press briefing in Abuja, the Chairman, Wood Expo Nigeria, Danny Sokari-George, said there was a need to have certified forests to meet the Federal Government's 25 million tree planting policy, which he said was achievable.

He stated that to plant the 25 million trees across the country, WEN would partner with state governments and engage youths to create jobs from the value chain. He said, "WEN has a vision of partnering state governors to help the Federal Government realise its plan of planting 25 million trees.

"It is not a waste of time to secure land and plant trees because when you plant trees today, there are ready buyers to buy it off here in Nigeria and abroad. And biologically, it is beneficial to the environment.

"We will engage the youth in planting trees because it will be beneficial to both parties. The youths will benefit economically and it will also help us solve forest depletion in Nigeria."

### Developers, others abandon construction sites over rising cost of materials

buildings and construction sites abandoned by developers because of the high cost of building materials, while many buildings collapse every day because of the use of substandard building materials.

The rise in prices of building materials has posed a major threat to the construction sector, housing development by private developers and independent builders who desire to have a roof over their head.

Building materials, which play a critical role in the construction industry have reacted to the nation's inflationary trend in the last two years. Adding to the woes of the sector are exchange rate, port charges, haulage and diesel cost.

Developers and investors have witnessed materials costs shoot up by over 50 per cent in the last one year with inflation rising to about 17.7 per cent as of May 2022. The most affected material components include cement, reinforcement bar, tiles, doors, gravel, sand, paints, roofing sheets and others.

The 50kg bag of cement that was sold for N2, 600 in 2019 rose to N4, 500; Iron rod increased from N300, 000 per tonne to N415, 000 in the building materials market.

Consequently, most developers had to increase their rent and price by 40 to 50 per cent across major cities, while the abandonment of projects has become a social menace in the country. Many contractors started projects, which have become untenable due to cost variations.

Experts say the preponderance of uncompleted and substandard buildings was not unconnected to the inflation and high cost of building materials, which fuelled fluctuation in the construction cost.

Confirming the trend, the South West Chairman, Real Estate Developers Association (REDAN), Mr Debo Adejana, told newsmen that developers are adopting a wait-see approach to the staggering prices of building materials in the market.

He said: "It is very real but what is happening mostly is that developers are watching the prices, especially for off-plan projects so that cost variation will not totally stall projects.

Adejana said both developers and independent builders are pulling out of site, adding that the way out for most people has been to ask and settle for negotiated reviewed prices.

According to him, in the South West states, Lagos, which is the commercial nerve centre of Nigeria, is the most prominent in terms of abandoned projects due to high cost of materials.

He attributed the development to the fact that Lagos commands the highest number of projects ongoing.

In terms of cost variations between last year and now, he argued that depending on the point in time, the average

There are thousands of buildings and construction sites abandoned developers because of the variation between last year and now has been between 70 per cent to 100 percent on most materials.

An independent builder located in Okota area, Mr Godwin Eze told newsmen that the increase in prices of materials has become too alarming as he had to abandon construction work of his three units of two-bedroom flats because of a hike in the price of roofing sheets, which almost doubled in recent times.

"You can imagine buying a bundle of roofing for over 17, 000 naira and 1 will require more than six bundles. I have to concentrate on more pressing needs first like payment of my children's tuition in school. Let me survive first by eating well with my family. I hope the price will come down soonest, then I may consider resumption of work on the project," he said.

The Managing Partner, Refin Homes Limited, Kazeem Owolabi, also said it is unfortunate that abandonment of projects has become the reality of today's market. He said: "Lots of projects are left either uncompleted or uninhabitable due to high cost of building materials and this usually leads to project overrun. Projects are uninhabitable in the sense that most developers are drastically reducing the quality of materials and project specifications just to break even. You then see that the market isn't responding to such developments and this has now further compounded the housing shortage."

"Most independent builders

"Most independent builders are now developers. The only difference is in the structure. Rise in the cost of building materials affects all, however, the direction being taken now is to increase the property price rather than totally abandon the site. Invariably what this means is that we now have fewer people with the capacity to purchase properties."

He added: "I'd say all Southwest states are victims

of these. However, the rate at which it affects each state differs. Unlike other states that have unregulated physical planning and urban development policies, these states are expected to have lots of abandoned sites with no consequences attached. However, due to strong regulatory policies in Lagos, site abandonment is an offence and can lead to the confiscation or a 'seal-off' of the site by the government. So, rather than face such heavy sanctions, developers will ensure that they complete construction regardless of the cost of construction materials."

Owolabi said in terms of percentage variations between last year and today, it has been a bitter pill to swallow daily but only a few developers found a sound strategy around this.

a sound strategy around this. He said: "Back then, it was far easier to plan according to construction prices in the market as they were stable.

Unfortunately, the volatility in the market has made it quite

tough for most developers to plan ahead. When project analyses are done with certain market prices on Monday, you'd be amazed that the prices have fluctuated by Thursday. An average of 30 to 50 per cent unprecedented hike in prices of construction materials from last year up till now has sent many developers packing."

Speaking on the issue, the President, Nigerian Institute of Building, Prof. Yoahanna Izam called for improved production of local building materials with some of them significantly insulated from inflation that is related to importation.

He argued that the government must lead by example in using local materials for housing for instance, while others like the private sector should copy such moves.

Izam said: "This will serve as a better shock absolver to some of the expenditures. But we will need a long time to research such local products."

### Building code: Lagos govt holds sensitisation workshop

The Lagos State Ministry of Physical Planning & Urban Development, with support from the European Union and the German Federal Ministry for Economic Cooperation and Development within the framework of the Nigerian Energy Support Programme, on Wednesday, held a one-day sensitisation workshop for stakeholders in the state's built environment.

The sensitisation exercise, which focused on modalities of domesticating the National Building Code for Lagos State, had participants cutting across building professionals' bodies, academia and building regulators.

The awareness workshop served as a forum for stakeholders to deliberate on a methodological approach toward the domestication of the National Building Code and the integration of the Building Energy Efficiency Code and green building principles to the code.

building principles to the code.

Delivering the address of welcome to participants, the Commissioner, Lagos State Ministry of Physical Planning & Urban Development, Dr Idris Salako, said the domestication of the National Building Code and its eventual launch as 'Lagos State Building Code' would deliver another national milestone from Lagos State.

"The Code will ensure that buildings are more resilient to disasters such as floods, fire outbreaks and collapse, by specifying requirements for structural stability, durability and energy efficiency," he said.

The Special Advisor to the Governor on e-GIS, Dr Olajide Babatunde, stated in his speech that, "Lagos as a front runner in the country is taking the bold step to regularise its building standards which, in addition to protecting its people and property, would lower construction costs and drive economic development"

economic development."

The Permanent Secretary, Lagos State Ministry of Physical Planning & Urban Development, Eng Abiola Kosegbe, in her remarks, urged the participants to leverage the expertise gained from previous training, to incorporate energy efficiency and green building principles in the design and construction of buildings in

order to achieve energy savings.

If implemented, Lagos State would become the first state to domesticate the National Building Code while also adopting the BEEC and other sustainable building measures to support the goal of transforming the state into a sustainable, smart city.

The NESP also provides technical advisory and capacity development to private developers and building professionals on improved energy-efficient building design and construction.

The Head of Programme, NESP, Mr Duke Benjamin said, "NESP is committed to supporting Lagos State to implement its Code domestication plan and would provide technical assistance throughout the process."

## Fake Army General bags 7 years jail term for N266.5m fraud

Tustice Oluwatoyin Taiwo of the Special Offences Court sitting in Ikeja, Lagos, has convicted and sentenced one Bolarinwa Abiodun, a fake Army General to seven years in prison on a 13-count charge bordering on obtaining money by false pretence, forgery of documents and possession of documents containing false pretence to the tune of N266,500,000.

The offences are said to be contrary to Section 1 (3) of the Advance Fee Fraud and other Fraud Related Offences Act 2006, Section 363 of the Criminal Law of Lagos State 2015 and Section 6 of the Advance Fee Fraud and other Related Offences Act No 14 of 2006, respectively.

The defendant, who was prosecuted by the Lagos Zonal Command of the Economic and Financial Crimes Commission (EFCC), posed as a General in the Nigerian Army and made false representations to the complainant, Kodef Clearing Resources, that the President, Muhammadu Buhari, had short-listed him and one other to be appointed as the Chief of Army Staff (COAS) and that he needed a short grant to "press and process the appointment."

Abiodun, who was arrested at his house in the Alagbado area of Lagos State on Wednesday, January 12, 2022, was also accused of forging a letter of appointment as COAS purportedly signed by the President and showing the same to the victim to further prove his claim.

In the said letter, he claimed that he needed to pay a certain amount of money into the coffers of the Federal Government of Nigeria, as part of the requirements for the appointment

Abiodun was also accused of forging a

Nigeria Army Identity Card with serial number 387140, claiming the same to have been issued to him from the Nigerian Army, and another forged Letter of Recommendation purportedly signed by Chief Olusegun Obasanjo recommending one Adebayo Rasaq Adebola, with recruitment No 77RRI/OG/556/0032555 and Adeogun Emmanuel Adesola with recruitment No 77RRI/OG/352/0123751 for employment into the Nigeria Army.

He was also accused of being in possession of a forged Certificate of Confirmation dated November 7, 2018, purporting the same to have emanated from the Nigerian Army

He was also accused of being in possession of a forged document titled 'Letter of Authorization", purportedly signed by Chief Olusegun Obasanjo permitting one Bamidele Olusegun Safiriyu of De-Rock Maritime Resource Ltd to enter Apapa Port freely and load their truck.

One of the counts reads: "Bolarinwa Oluwasegun Abiodun, between 15th June 2020 and 31st December 2020 in Lagos, within the jurisdiction of this Honourable Court, with intent to defraud and whilst holding yourself out as a General in the Nigerian Army, obtained the sum of N111,400,000 from Kodef Clearing Resources Limited, under the pretence that the sum represented part of the amount expended to "press and process" your incoming appointment by the President and Commander-in-Chief of the Armed Forces, as the CHIEF OF ARMY STAFF of the Nigerian Army, which pretence you knew to be false." Another count reads: "Bolarinwa Oluwasegun Abiodun, sometime in May 2020 in Lagos within the jurisdiction of this Honourable Court, knowingly forged LETTER OF AP-POINTMENT AS CHIEF OF ARMY STAFF dated 20th May 2020 and purported the said document to have emanated from the President of the Federal Republic of Nigeria, which document you know to be false."

When initially read before him at his arraignment on April 11, 2022, Abiodun pleaded "not guilty" to the charges.

Justice Taiwo had also on April 25, 2022, denied him bail, holding that the facts presented by the prosecution showed that he was a flight risk, and ordered an accelerated hearing instead.

In the course of the trial, the prosecuting team, Rotimi Oyedepo, A.O. Muhammed, S.I. Suleiman and E.K. Uduak presented six witnesses and tendered documentary evidence to prove the case against him.

The prosecution opened its case on April 25, 2022, and closed its case on June 20, 2022. Thereafter, the defendant was ordered to open his defence.

However, at the resumed sitting on Thursday, July 7, 2022, the defence counsel, Otunba Ogunleye, informed the court that his client had decided to change his plea, "rather than going through the rigours of defence".

### EFCC rescues alleged kidnapped yahoo apprentice in Abuja

Operatives of the Economic and Financial Crimes Commission (EFCC) have rescued an alleged kidnapped yahoo-yahoo apprentice in Abuja.

A statement by the EFCC spokesperson, Wilson Uwajaren, on Thursday said the 17-year-old Destiny Peter was rescued on Friday, 1st July 2022, from an apartment in Mpape, a suburb of the Federal Capital Territory (FCT), Abuja.

It was gathered that Peter had on July 1, 2022, contacted the EFCC on its official Twitter handle, @officialEFCC, narrating how some yahoo-yahoo boys kidnapped him and intended to use him for money rituals.

He was therefore guided to send a screenshot of his location to the Commission, using the Google Location App on his Android phone.

In a series of tweets, Peter wrote: "Good afternoon sir, I called the EFCC number and lay some complaints about some yahoo boys intending to use me for ritual and he said I should send a screenshot of the

"The house is in Mpape, but don't know the exact place so check google Maps and save the screenshot.

"I'm in the bathroom because I don't want his boys to know what I'm doing.

"My name is Destiny Peter and the place is Mpape. I don't know the actual place but I used google maps and the people in the house now are his boys. Hold on let me try and do a video, sir"

Following his tweets alert, the EFCC quickly mobilized a team of detectives to the area for his rescue, and they found him locked up in a room. They rescued him and arrested 16-year-old Aboaba David, 18-year-old Isaac Johnson, 20-year-old cook, Miracle Moses, a hair stylist, and the leader of the syndicate, a 20-year-old Jamilu Aliyu, popularly known as Jamilu

During interrogation, Peter said he was threatened by Jamilu Smith, leader of the gang that if he was not able to cash out (defraud) people within two weeks, he would be sacrificed for rituals.

Under interrogation, David said Smith was their leader and recruited them to join him in scouting for potential online dating victims for fraud. All other suspects also pointed at Smith as their leader.

On his part, Smith debunked Peter's claim that he was kidnapped. He rather said Peter's brother brought him to him willingly to teach him bitcoin and gift card trading.

According to the spokesperson, all the suspects are in EFCC's custody and would be charged to court as soon as the investigation is concluded.

### Soludo denies padding budget in Anambra

Governor of Anambra State, Prof Charles Soludo has denied the reports alleging 'budget-padding' in the State.

Soludo, on Thursday in a press statement by his Press Secretary, Christian Aburime, described the reports as false while adding that the peddlers of the rumour were doing so because they have lost out on milking the treasury of the State.

According to him, "These are the handwork of losers and detractors. The misinformation should evoke pity for the purveyors in the light of the manifest ignorance boldly couriered in every paragraph of the hasty piece of distraction.

'Bad as it is, no credible reporter has signed this off, establishing it for what it is; lazy propaganda."

He said for clarity the government is not oblivious of the diversionary antics of those whose lucrative criminal enterprise is being smoked out by the government's renewed fight against all forms of criminality in the state.

"We want to make the state a liveable and prosperous smart mega city by confronting head-on the infrastructural decay, such as in the area of roads that is clearly in a deplorable situation," he said.

According to him, the government has declared a state of emergency on Anambra

The governor said that giving priority to infrastructure development, the government has allocated about 64 per cent of the capital budget and an ambitious target of flagging off at least 220km of roads as soon as rain

"With this ambitious program and knowing fully, that failure does not exist in our determined minds, the detractors are at loss and are raising the battle cry with the sole aim of trying to scuttle our determination with all manners of blackmail.

"They claimed that the commissioner for works refused to appear before the state Assembly to defend the budget. This again is the figment of the imagination of the unknown writers with the intent of creating rancour between the executive and the members of the House of Assembly.

'The Commissioner for Works and infrastructure was, indeed, the first commissioner to appear before the House Committee on the first day of the budget defence exercise being 29th of June, 2022 at about 10.00 AM. This is on record and was captured by the Press," he added.

Meanwhile, the Anambra State House of Assembly has expressed displeasure over a 70 per cent budget slash in Education from N3.23 billion to N1.1 billion in the 2022 revised budget presented by Soludo.

Hon Ejike Okechukwu, member representing Anaocha Constituency ll made the assertion during the ongoing 2022 Revised Budget defence of the Ministry of Education on Thursday at Awka.

According to Okechukwu, the budgetary

allocation to the Education Sector is unrealistic and the slash would lower the standard of teaching and learning, as well as the development of students.

Okechukwu, who is also Chairman of the House Committee on Education, said that education was the bedrock of any society and that the legislature had a duty to check the actions of the executive.

The education ministry is self-sustaining because it generates revenue annually from students' tuition, sports levy and exam fees. These money are paid directly into the government's account.

"It is sad that these funds are not released to the ministry to operate which is why our students are being exploited, they pay these levies twice or three times a year.

"The slash in the budget is unacceptable. We are supposed to be working towards having 10 percent of our budget allocated to education as recommended by the United Nations Children's Fund," he said.



# Blatter, Platini, cleared of corruption charges

o r m e r President of the International Federation Association Sepp Football (FIFA), Blatter and former President of Union of European Football Association (UEFA). Michel Platini have been cleared of all corruption charges by the Federal Criminal Court in Bellinzona, Switzerland.

Blatter held topmost position in the world football governing body for 17 years while Platini held the helms of the European football governing body for 8 years but one thing is common between both, they were kicked out of office in 2015.

The prosecutors said that the duo who ruled football in the continental and world stages, were charged with a deep conspiracy to swindle FIFA of a huge amount of money.

According prosecutors, in 2011, Sepp Blatter in connivance with Michel Platini tried to unlawfully through FIFA, pay the latter the sum of

Reportedly, Blatter had said that the payment followed a 'gentleman agreement' between both of them when in 1998, he asked Platini to be his Technical Advisor.

Following the approval of the stimulated sum to Platini by Blatter, who then was campaigning for his reelection to become FIFA President, Platini was having a feed day to influence Blatter's votes from the UEFA bloc.

The whole scenario was finally unearthed through an investigation carried out by the United States Department of Justice into bribery, fraud and money-

laundering at FIFA in 2015, which culminated into Blatter's resignation.

However, after victory in court, Platini expressed his happiness over the judgement adding that the it was a battle against lies, deceit and conspiracy for seven years.

"I want to express my happiness for all my loved ones that justice has finally been done after seven years of lies and manipulation," the former UEFA boss said.

"My fight is a fight against injustice. I won a first game.

"In this case, there are culprits who did not appear during this trial. Let them count on me, we will meet again. Because I will not give up and I will go all the way in my quest for truth.

"Believe me, going from being a legend of world soccer to a devil is very difficult, especially when it comes to you in a totally unfair way," Platini lamented.

Affirmatively, Swiss Attorney General's Office said that it has noted the decision of the Federal Criminal Court and would decide further on the proceedings after it receives the written reasoning of the court

arcelona President Juan Laporta has said Manchester United's prime target, Frenkie de Jong, will only leave Camp Nou if the Catalans have no

Laporta, who recently said Dutch midfielder was not for sale and would do everything within his powers to see the player determined to continue with the Blaugrana, is made to stay.

According to the President, De Jong is one of the best midfielders in the world and the club do not want to lose him for any price.

Manchester United need the player to reunite with Erik ten Hag, who once coached him in Ajax and with Tyrell Malacia switching to Old Trafford from Feyenoord, and Christian Eriksson and Ajax defender Lisandro Martinez in the loop, the Red Devils are set to accelerate their business in the transfer market.

However, United are not finding the negotiations to snap their prime target to Old Trafford easy as Laporta has continued to insist the player is not for sale.

Saturday, during a tribute to Johan Cruyff stressed that "There are clubs that want him, not just United. We have no intention of selling him, he wants to stay.

"Frenkie is considered as one of the best midfielders in the world by all the experts. We are happy to have him.

"I'm going to do everything I can in my power so that Frenkie stays here, but there's also a salary issue and that would have to be adjusted," he stated.

To further affirm his position regarding De Jong's presumed move to the English Premier League, Laporta on Wednesday said Barcelona



will only allow the player to leave if they are faced with no choice.

"Frenkie de Jong is a Barcelona player, we don't want to sell him unless we have no other choice. Of course, we know there are offers for de Jong but we don't want to sell him," Laporta declared.

According to a Spanish

journalist, Gerard Moreno, yesterday, Barcelona needs about £64m for the midfielder upfront with an additional £ $\bar{1}$ 0m as add-ons.

Barca had previously pegged their price for De Jong at £56m plus add-ons but the recent development will have Manchester United go back to the drawing board to bring forward a better offer.

#### **Jack Wilshere leaves** Danish Superliga club

Former Arsenal and West Ham midfielder Jack Wilshere has left Danish Superliga club, Aarhus GF, on mutual consent after five months in Ceres Park

The former England international joined the club in February and played 14 games for the club last season after being out of the club since he was released by Bournemouth last summer.

To keep fit, the 30-year-old trained with Arsenal and Italian club Como before he was offered a contract with the Danish Superliga side five months

However, the player and the club have parted ways in what is understood to be the best interest of both parties.

Wilshere's footballing career has been threatened with injuries intermittently, with the midfielder making 302 club appearances, prodding in 20 goals coupled with 43 assists in his career.

In a statement to call it off with Aarhus GF, Wilshere appreciated the fans for their support and love despite the results they needed were not forthcoming.

He said, "My time at [Aarhus GF]

has come to an end. Myself and the club have mutually agreed it's best for me to move on.

"I would like to thank everybody at AGF for the support and confidence they gave me from day 1.

"The club showed trust in me that not many others were willing to give. Although results were hard to come by the fans' support of me and the team was unbelievable.

"Thank you guys for welcoming me into your club and city. I wish you all the best in the future. Personally, I am considering all of my options, Wilshere added.

The club, however, has released a statement to that effect commending the former England international whose contract with the Danish Superliga club ended in June.

The club further added that it was in the best interest of both parties to discontinue the talks over a possible contract renewal of Wilshere.

"AGF and Jack Wilshere have agreed not to extend the partnership," the club said.

"In the spring, AGF benefited from Jack Wilshere's great footballing and human qualities on a deal that expired at the end of June.

"There has subsequently been dialogue on continuing the poperation, but after careful cooperation, consideration, the parties have jointly come to the conclusion that the agreement will not be extended," the dub added.
