Edo's anti-grazing law'll resolve farmer/herders' conflict, enhance security says Obaseki

he Edo State G o v e r n o r , Mr Godwin Obaseki, has said his government has signed the anti-grazing

law to tackle farmer/ herders' clashes and ensure peace and security across Edo communities.

Obaseki disclosed this at the Edo Central Security Council Meeting, held in Irrua, the Administrative Headquarters of Esan Central Local Government Area, Edo State.

The governor said, "I am pleased to inform you that the Edo State Government now has a law which prohibits open grazing in Edo State. The bill has been signed into

law by me. It was signed on the 27th of May and the objectives of the law are as follows:

"The law prohibits open grazing of cattle and other livestock in the state and creates

peratives of the National Enforcement Agency (NDLEA) have arrested 51 suspects for drug-related offences in Kano State.

Director of Media and Advocacy, Femi Babafemi, disclosed this one Sunday in a statement made available to The Trumpet, saying the suspects were arrested in a raid at a restaurant.

"In Kano, 51 suspects were arrested in a raid at Sky restaurant in Nasarawa area of the state on Friday 29th July. The suspects were caught with various quantities of cannabis and codeinebased cough Babafemi stated.

He further disclosed that no fewer than four notorious trans-border drug dealers were arrested Adamawa by Agency.
"In Adamawa state, four

notorious drug dealers

in Konkol and two villages at Nigeria -Cameroon border have been arrested for exporting and retailing Tramadol and importing Diazepam into the country," he said.

He gave the names of the suspects as Kabiru Ahmadu, Eric Abdulmumini Bapetel and Alphonsus Yusuf while stating that a total of 59.018kg of Tramadol, Diazepam, Exol-5, Cannabis Sativa and two jerry cans of formalin substance (Suck & Die) were recovered from them.

Meanwhile, no fewer than 2,750,000 tablets of Tramadol 225mg weighing 1,650 kilograms worth about N1.375 billion were intercepted at the Apapa port in Lagos by NDLEA's operatives.

According to Babafemi, "The consignment packed in 55 cartons of Tapentadol and Carisoprodol types of Tramadol was seized during the examination of a container number SUDU 7538656 on Saturday 30th following credible intelligence."

"At least, five suspects have so far been arrested in connection to the Babafemi attempts,"

He further said, "On Monday 25th July, a HAE Dubai, bound passenger Ms Ebhodaghei Gloria Osenemeshen was intercepted during the outward clearance of travellers on Rwanda Air via Kigali to Dubai. Discovered in her luggage were sachets of Tramadol 225mg concealed inside garri, a cassava product packed among

"She, however, claimed that the bag was given to her by someone who she passed the night in his house before coming to the airport to help deliver to another person in Dubai.

"The following day, Tuesday 26th July, a total of 50 blocks of cannabis Sativa with a total weight of 27.1kg concealed inside large quantity of crayfish going to London, UK as part of a consolidated cargo were seized at the SAHCO export shed.

"Same day, a Dubaibound female passenger, Emebradu Precious Rachael, was arrested with 1.8kg cannabis packed inside bitter leaf in her luggage while attempting to board Rwanda Air flight to UAE via Kigali.

"The mother of one who hails from Oghara in Ethiope West Local Government Area of Delta State said she was into selling of men's wears she decided to travel to Dubai to expand her clothing business. She claimed her ex-boyfriend that lives in Dubai, requested her to bring the bag, which contains the illicit substance along with foodstuff.

"In the same vein, operatives at the NAHCO import shed of the airport on Saturday 30th July evacuated cartons of khat leaf with a total weight of 51.50kg. The consignment had earlier come in from Sierra Leone on Royal Air Moroc flight."

The spokesperson also disclosed that no fewer than 90 blocks of cannabis (48.2kg) and 700grams of methamphetamine were intercepted at Jabi motor park in Abuja. "A suspect has been arrested in connection with the drug exhibits," he added.

Also, no less than 4,010 ampoules of pentazocine injection were seized on Friday 29th July when a commercial vehicle with registration number Sokoto RBA 220 XA was intercepted along Yawuri -Kebbi road in Kebbi State. Two suspects, Muktar Yunusa, 26 and Lukman Aliyu, 30, arrested.

While earlier in a raid operation in Oko-Olowo area of Ilorin on Tuesday 26th July led to the arrest of Onaolapo Zakariyau, 50, with 79kg cannabis

Recall that The Trumpet had earlier reported that Destiny was arrested with one AK-47, one pump action, 91 bullets of 5.56 mm, 16 cartridges and cash of N347,000.

Destiny, who said he was a timber trader, stated this after he was paraded in Akure, the state capital. He said he did not take the bag which contained an AK-47, one pump action, 91 bullets of 5.56 mm, 16 cartridges and cash of N347,000 to the Police station because he never knew it would bring problems for him.

"I saw it in a bush in the place where I am working. I saw it in a nylon bag they used to wrap it and I carried it to my village. I didn't know it would cause me problems. I was coming from Bayelsa State and was going to my home town after Agadagba, in Ese-Odo Council area of Ondo State. The money is my own and it was from my timber business?

The State Commandant of the NDLEA, Mr Kayode Raji, while parading the suspect, said the suspect was arrested during a stop and search operation along Ore-Okitipupa Road. Raji added that the suspect tried to bribe his men on duty with the cash found on him, which his men rejected and took him into custody.

According to him, "the suspect was arrested on 20th of July, along Ore-Okitipupa Road by our men on stop and search operation. Upon search, he was found with various arms and ammunition of various kinds.

'He was also arrested with strap bags and we asked him what it was used for, he said he would die if he confessed it. It looks like bags where they keep dead bodies or mangled bodies of human beings. We have done our preliminary investigation and we are going to hand him over to the Nigerian Police."

promote will high enhance and healthier breed of livestock and ensure security in ranching areas and ensure good relationships between herders of cattle and local communities and individuals, and address the security challenges associated with open grazing in Edo State."

Disclosing plans to set up a cattle and livestock committee to facilitate implementation of the law. Obaseki said. "There would be a cattle and livestock committee which will be chaired by a retired senior security officer, not below the rank of a major or its equivalent in any of the forces. It will have a representative of the governor on security matters. The committee will also have the state

Chairman of the vigilante groups and representatives of the vigilante group, one from each senatorial district.

"It will have a representative of Commissioner of Police, Department of State Services, civil defence, Nigeria Legion, and the secretary will be in a rank of a chief state council.

"The Managing Director of EdoGIS will be on the committee; one representative of each of the traditional rulers from three senatorial districts will be on the committee: representatives two of registered cattle or other livestock farmer's associations will be on committee, while three community youths selected from the three senatorial areas of the state will be on the committee.

"This committee will have a lot of powers to set the rules for anybody who wants to be involved in livestock business in the state and also impose required fines. So, it is now a crime for anybody to just allow their cattle or animals to roam without control. And before the end

of August, the committee will be constituted and inaugurated," he added.

The governor at the meeting urged traditional rulers Esanland to identify all the black spots and report the same to the appropriate authorities for follow-up, adding, "Nobody can come to your house and stay without your permission and knowledge. Is it possible? If you find a person you didn't permit to stay there and you want to remove the person and you can't, that's when you need support from outside to help you do it. "However, we want

to know who they are. Are they people of good character? Do you know them? if they do anything outside, are you going to be responsible for their actions?" he queried.

The governor further pledged to sustain support to the local vigilante to facilitate the fight against crime and criminality, urging local government councils to ensure they register only persons of good character as vigilantes.

A' Ibom records one case of monkey pox — Health Commissioner

kwa Ibom State Ministry of Health has .confirmed one case of monkey pox diagnosed in the state and asked residents not

Speaking to newsmen Uyo on Sunday, the Commissioner for Health Prof Augustine Umoh said the only case discovered in the state recently was external as the patient was brought into the state from outside.

He recalled that monkey pox was first discovered in 1958 and had since spread to

other countries in the world including Europe and America adding that people are worried about it.

The Commissioner disclosed that the spread of the disease is not as fast as covid 19 which has devas-tated the entire world within a short time.

Umoh said that World Health Organisation (WHO) has declared monkey pox a public health emer-gency international concern.

" In Akwa Ibom state, we had someone who came in from outside the state and his test revealed that he was infected with monkey pox. So that one case was external to us but was diagnosed Akwa in Akwa Ibom."

directed He residents to report incidents of monkey pox to the nearest health facilities in the state for urgent medical attention.

Monkey pox does not spread fast like covid 19 but it is necessary to report such incidents for quick intervention by health workers.

" Although we have not noticed any internal incident of monkey pox except the one we diagnosed from a visitor who came into the state, we must be watchful.



N2.5b Debt: Imo govt replies Innoson motors

■Say firms claim is mischievous

Government has reacted to the allegation by Innoson Vehicles Manufacturing IVM, Compa-ny, claiming that the government state under Governor Hope Uzodinma is owing over N2.5billion mischievous, distasteful and cheap blackmail against the current administration.

Reacting to a threat by the company that it is filing a lawsuit recover 'over N2.5billion debt owed' being the cost of vehicles supplied to the state, Commissioner for Information and Strate-gy, Hon. Declan Mbadiwe Emelumba deplored the manner the company is going about the re-covery of the so-called debt.

Emelumba insisted that the company's claims are half-truths intended to impugn the integrity of the state government for ulterior motives.

According to him,

the truth is that the government bought vehicles worth over N5 billion from Innoson motors and has so far paid them N3.5billion.

Contrary to the claim of Innoson Motors, commissioner disclosed that the N2.5billion is actually the balance due from the original value of the purchase and expressed regret that the firm for reasons best known to them, decided to hide this fact from the public.

Emelumba insisted that the total value of the vehicles supplied was in excess of N5 billion and that the government has been servicing the debt since



He noted that in spite of the fact that the company breached this agreement, the state govern-ment has been servicing the debt and still maintaining the vehicles, disclosing that more than 70% of the vehicles have already broken down.

His words, appears the company is out to rubbish the integrity of the government, otherwise it would not have twisted the facts of the case and published the same concerning this honest busi-ness transaction, even when it failed to show the public the terms of the contract and the clauses the government breached therein. "It is regrettable that

Innoson Motors had not actually exhausted all means of negotiation before threatening the government with a lawsuit.

"The mischievous resort to media trial has confirmed that the company is more interested in compromising the integrity of the government rather than being paid its outstanding balance from the contract sum."

Disclosing that no court process has been served, the government will meet the company in court as soon as a process is served.

4 feared dead in renewed transport union clash in Lagos

No fewer than four persons have been killed in a clash between rival groups over the right for the sale of tickets and collection of tolls from truck drivers along the port

Our sources claimed that the clash was between members of the Lagos State Park and Garage Management and other unions that are vet to be identified.

The names of the victims could not be ascertained at the press time, but an official of the Maritime Workers Union of Nigeria, who said he does not have the authority to speak on the matter, confirmed the death of four of its members, adding that the leadership of the union will issue an official statement on the matter tomorrow.

It would be recalled that members of the Lagos State Parks and Garage Committee, last week, invaded the port's access roads, dislodging members of truckers' unions and selling tickets to truck drivers at the second gate of the Tin-Can Island Port in Apapa.

A visit to the port by our showed correspondent members of the com-mittee came into the port as early as 9 am with about 200 members, alongside policemen from the Rapid Response Squad, RRS.

As the crisis brewed, it was gathered that the Port Police Commissioner, Mr Adeleke, who was alerted of the situation, made a distress call to the Commissioner of Police, Mr Abiodun Alabi, and the Head of RRS to ascer-tain if they were aware of the presence of the Parks and Garage Committee in the port.

It further gathered that both Adeleke and Alabi said they were oblivious of the visit, a development that made Adeleke visit the scene.

Immediately members of the Parks Committee with their Police escort sighted CP Adeleke, they took to their heels.

Information at our disposal revealed that members of the committee had collected tolls for about two hours before the arrival

Reacting to the development, Chairman of the Lagos State Park and Garage Management, Mr Musiliu Akinsanya, said he does not think that his boys were behind the attack because their operation has nothing to do with the port environment.

He said: "Maybe some people went there to cause trouble under the name of Lagos State Park and Garage Management but I am very sure our members did not attack because our operations are not within the port environment."

Also speaking on development, an official of MOB Resources Limited, operators of MOB Truck Park, said: "MOB Tin-Can is currently closing its gate as there is a serious brawl between rival gangs. Once things normalise, we can open our gate. This is to secure lives and property within our prem-ises."

A truck owner, who simply identified himself as Michael, said: "It is unfor-tunate that a city, which prides itself as a mega city, would allow such non-sense to happen."

NSCDC, Navy pledge synergy in fight against economic saboteurs

The Nigeria Security and Civil Defence Corps, (NSCDC) and Nigerian Navy have pledged collaboration in the fight against crime and illegal oil dealings in

The two security agencies came up with this at a strategic meeting between the State Commandant of NSCDC, Michael Besong Ogar and Commander, Nigerian Navy Ship Pathfinder Port Harcourt; Commodore SD Ibrahim at the naval command headquarters in Port Harcourt at the weekend.

According to Ogar, the meeting was premised on the need to cement the long-term existing relationship with the Nigerian Navy which he said remains a critical partner in the fight against illegal dealings in petroleum products across the coastal region.

Commandant Ogar noted that from the series of arrests made by the Command and cases handed over for prosecution by the NNS Pathfinder, the NSCDC Rivers State Command through her Legal Department has gotten forfeitures

of 39 boats and proceeds remitted to the Federal Government coffers. He further noted that11 suspects had been convicted for illegal oil bunkering activities, vandalism of oil pipelines, conspiracy and economic sabotage while 30 suspects are currently being arraigned in court.

While extolling the outstanding role of the Nigerian Navy and the level of relationship with the

NSCDC; Commandant Michael Ogar solicited for a more robust synergy especially in the areas of training and retraining of personnel, sharing of intelligence before, during and after tactical operations to enhance the war against criminally minded persons sabotaging the nation's economy through illegal oil bunkering activities in Rivers State.

On his part, the Commander

Nigerian Navy Ship Pathfinder Port Harcourt; Commodore SD Ibrahim called for a concerted effort by the security agencies and all critical stakeholders in the fight against illegal oil bunkering in Rivers State which he said had overtime erupted into environmental degradation, health hazards and pollution of the Marine life.

He maintained that the war against vandals would not be limited to arrests of suspects on the waterways alone but also extended to their sponsors and potential buyers of the products noting that with thorough investigation the prosecuting agencies must dig deep into such cases to unravel the numerous actors behind the crime.

Commodore Ibrahim assured that his command would give maximum support to the NSCDC Rivers State Command in capacity building for effective service delivery, intelligence gathering, joint operations and unrelenting war against pipeline vandalism in order to rid the nation's economy of saboteurs.

Siemens mega transformers to arrive Nigeria in September

f feelers from the presidency are anything to go by, the first batch of mega transformers ordered by the Federal Government under President Muhammadu Buhari's Presidential Power Initiative (PPI) are expected to start arriving Nigeria in September

This followed as indications emerged at the weekend that the transformers have successfully undergone a factory acceptance test at Siemens' transformers factory in Trento, Italy.

Managing Director of the Federal Government of Nigeria's Power Company (FGN-Power), Kenny Anuwe, who led a delega-tion that included engineers from the Transmission Company of Nigeria (TCN), witnessed the factory acceptance test conducted on Thursday, July 28, 2022, in Trento Italy.

The Trumpet learnt that the factory acceptance test had paved the way for Siemens Energy to commence the delivery of the transformers to the country, a move aimed at resuscitating Nigeria's energy crisis and abysmal of the power sector

performance over the years.

This was revealed by the Minister of Power Engr. Abubakar D. Aliyu, who led a delegation on visits to Siemens Energy factories in Berlin and Frankfurt in Germany in April of this year and held meetings with the senior leadership of Siemens Energy on the need to fast-track the delivery of the early orders that would kick start

the transformation of Nigeria's electricity.

'The successful factory acceptance test shows that Nigeria's engagement with Siemens Energy is on track. It also shows the Federal Government's commit-

ment to addressing Nigeria's electricity challenges," he said.
Also in December 2021, the Minister of Finance Zainab Ahmed and Aliyu secured the approval of the Federal Executive Council (FEC) for a €63 million (Euro) to procure equipment to boost power supply under the Presidential Power Initiative (PPI), which first phase is expected to provide 10 mobile power sub-stations and 10 mega transformers that would be deployed across the country to boost and stabilise electricity

supply.

Earlier in 2018, President
Buhari initiated the PPI to enable Siemens Energy to upgrade Nigeria's electricity systems, the first phase of which seeks to modernise, rehabilitate and expand the national grid by investing in the electricity value chain, including generation, transmission and distribution systems across the country.

IGP decries unauthorised sales, use of police uniforms, orders prosecution of offenders

The Inspector-General of Police, IGP Usman Alkali Baba has raised concern over the unauthorised possession and use of Police uniforms and accoutrements by some individuals, movies and skit makers.

In a statement issued by the Force Public Relations Officer, CSP Olumuyiwa Adejobi, on Sunday, the IGP also expressed worry over the illegal sale of Police materials and accoutrements by traders in shops, open stores not approved

nor recognized by Police authority. Adejobi said the IGP has ordered the immediate arrest and prosecution of all offenders who henceforth abuse the police uniform without applying for, and being duly issued a permit

The statement reads, "The Nigeria Police Force has expressed concern over the incessant and authorised possession and use of Police uniforms and accoutrements by some individuals, movies and skit makers, as well as the illegal coutrements by traders in shops, open stores not approved nor recognized by Police authority.

"The IGP has equally frowned at the demeaning manner in which movie makers and skit makers portray the Police institution in their movies and skits, using the police uniform without recourse to the provision of Section 251 of the Criminal Code law, and Section 133 of the Penal Code Law which criminalise such unauthorised use with accompanying necessary sanctions.

"The IGP, therefore, charged all commands and formations, the IGP Monitoring Unit, Provost marshals and X-Squad, to arrest and immediately prosecute, in accordance with the law, all persons or groups of persons engaging in the illegal sales of police uniforms and accoutrements within their jurisdictions, while film or skit makers who portray the Nigeria Police Force officers in bad light, without applying for, and being duly issued a permit letter for such portrayals, to desist with immediate effect or face the full wrath of the law.
"The IGP further reiterates

the commitment of the Force to guaranteeing compliance with law, as the Force Public Relations Officer has been charged with the task of ensuring prompt authorisation for all applications for approvals of usage of police items in movies, in tandem with the extant laws and which will portray good values, impress positively on the Nigerian public, add value to our system, provide police officers with modern innovations to actively carry out policing duties and on-screen role models who would influence their lives and career; and consequently improve security mechanisms in

Nigeria.
"The Inspector-General of Police strongly believes that such sanity in movies production, regulation of sales, possession and usage of police uniforms and accoutrements will definitely impact positively on resuscitating moral values, and correcting wrong perceptions and ideologies towards commissioning of crimes in our society. It is obvious that this step will surely curb proliferation of Police kits, uniforms and accoutrements and eventually reduce police impostorsinduced crimes in our society."

It was a very sad spectacle.

A cocktail of other negative stories cascaded out. Police station attacked in Ondo, cop killed. Bandits kill many in Kaduna, Taraba, Plateau. Later in the day, we heard of bandits attacking troops of the Guards Brigade, with three soldiers dead. And the Nigerian Labour Congress, in the midst of it all, was threatening to shut down the country in sympathy protests with the striking academic staff of universities. It never rains, it pours.

But however overcast the sky may be, the ravening clouds are not always completely victorious. They don't possess the entire sky. You always see streaks of light. That blistering light came from Eugene, Oregon, United States of America, where the World Athletics Championship, was taking place.

Nigeria's Tobi Amusan, 25, had won Gold in 100 meters hurdles, setting a world record in the process. In fact, she had set two records within 90 minutes, first in the semi-final race, and then in the final. But the second was deemed wind-assisted, as the speed of the wind was above the legal limit.

Oluwatobiloba Ayomide Amusan had done what Napoleon couldn't do. She had won the first ever Gold medal for Nigeria in a World Athletics Championship. The flag of Nigeria was fluttering proudly in the global skyline, and our National Anthem was resonating melodiously. What a great time to be Nigerian, a breath of fresh air in a country being asphyxiated by bad news from every corner.

Tobi Amusan had burst into the limelight in 2013, when she won Gold at the African Youth Championships in Warri, Delta State. She performed the same

He got us to repeat it so many times, till it became ingrained in our psyche.

Tobi fell just short of the mark in some global competitions over the past couple of years. She would end in fourth position, till

she described herself as the "almost girl." She finished 4th at the Championships in Doha, and at the Tokyo Olympics. Her words: "I was the 'almost girl.' I got fourth, fourth, fourth. Now I finally

Yes, she did it along with long jumper, Ese Brume, who also won Silver medal at the Championships. An elated President Muhammadu Buhari described them in superlatives, extolling them for bringing honor to motherland.

I watched Tobi Amusan as she climbed the dais to be invested with her medal. Besides herself with joy after crossing the finishing line ahead of others (who wouldn't?), she was a perfect picture of calmness. The Gold medal was emblazoned round her neck, followed by the National Anthem.

The song wafted forth, with that look of wonderment on the face of the new champion. When it got to; "the labour of our heroes past, shall never be in vain, to serve with heart and might..." lo and behold, Tobi began to cry. As the tears streamed down her face, I was surprised to see myself crying with her. And unabashedly too.

This was our country standing tall in the comity of nations. Our country, not a zoo. Our country, not a failed state. Our country, beleaguered, besieged, but not broken, indeed, unbreakable, and being celebrated. Nigeria we hail thee. Our own dear native land. Tobi cried, and I cried along.

The English writer, William Cowper (1731-1800), was the one who looked at his country, and exclaimed:"

England, with all thy faults, I love thee still-My country."

Nigeria, with all thy many faults, I love thee still-My country.

Was I ashamed of my secret tears? No. As Charles Dickens wrote in Great Expectations, "Heaven knows we need never be ashamed of our tears, for they are rain upon the blinding dust of the earth, overlying our hard hearts. I was better after I had cried, than before-more sorry, more aware of my own ingratitude, more gentle."

May we always be aware of our ingratitude to this blessed but blighted country. And may we be more sorry, more gentle. Nigeria shall win over all her adversaries. Las las. Amen.

Anxiety as INEC suspends voters' revalidation and card transfer in Delta

There is growing anxiety amongst the eligible voters that are yet to complete their registration for Permanent Voters Cards(PVCs) that empowers one to perform their civic responsibility during elections as the Independent National Electoral Commission (INEC) has said it is not going back on the July 31st, 2022, deadline for the termination of the ongoing Continuous Voters Registration

Prior to the expiration of the deadline for the exercise, there has been last minute rush by eligible voters to INEC's main and franchise offices to get themselves registered. When The Trumpet visited some of the INEC offices in Delta State, long queues were still observed despite the creation of franchise offices and engagement of Adhoc staff across the state to address the large turnout that were overwhelming the workforce of the electoral umpire.

Currently, staffers of the electoral body are returning all those who have visited their offices for revalidation of voters cards and transfer of voting points, to give full attention to those for fresh registration. One of the affected voters, Ojo Butunde, who spoke to The Trumpet, said he was returned back, that

there was no problem with his registration despite explaining to the attending officer that he wanted to transfer his voting point from his home state, Adamawa to Ughelli where he now resides to enable him to exercise his franchise.

According to data released by INEC on Monday, 25th July 2022, Delta State stands at number three in the whole federation in terms of completed new registrations with a total of 481,929 registrants. However, despite this position, there seem to be hundreds of thousands that might just end up being disenfranchised in the state unless something urgent is done by both the government and the electoral umpire.

Reacting to the development, the Delta State Coordinator, Transition Monitoring Group, TMG, Pastor Edewor Ogedegbe, absolved INEC of any blame for failing to capture aspiring voters. He argued that a whole year, with an additional one-month extension was more than enough time for any serious individual to get him or herself registered.

He said, "For me, INEC has done their best so far. This programme started in June last year, it is only recently people became more interested and you also discovered that there was an extension in the quest to get more people registered.

The court also has empowered INEC to determine when they can stop their process. So they have given a window of 31 days, which will end tomorrow and the chairman has said they are no longer going to extend it. So for me, INEC is within the law, it is within the act that established it to determine when to end it.

"I think people should be more serious when civic responsibility props up at any time. I was at the INEC office yesterday; the crowd was huge but they are trying as much as they can. So tomorrow, next tomorrow, those

that are not able to get captured when the next dispensation comes they should try.

"The lesson to learn is that next time when any process begins, people should take advantage and not wait till the dying minute. It is not totally true that people came out and were not captured, the system is now electronic and no longer manual when you can register anybody. The process needs to run through, and that is not the problem of INEC. I don't want people to put a negative narrative there, for us as Transition Monitoring Group, we have been following up for upward of like four months now and INEC have been doing their best, I must say that.

"Citizens most times are very impatient with the system because they always want it to be done their way and once it is your way, it may be going contrary to the laid down rules. And that is the problem we have in the society. We are saying, allow the process to evolve, the electoral act has clearly backed up, that, we are going electronic and not manual. There will be network for the process to run through so people have to be patient. That is part of patriotism, if you can't do it today, go back tomorrow, Nigerians are not ready to give back to the country, they are only interested in what the country wants to give to them."

Edo attracts ROK **Studios to Victor Uwaifo Creative** Hub, churns out 18 movies in 6 months

SERAP asks Buhari to withdraw BBC, Trust TV sanction threat in 48 hours

ocio-Economic Rights and Accountability Project (SERAP) has urged President Muhammadu Buhari to "urgently instruct Mr Lai Mohammed, Minister of Information and Culture to withdraw the threat to sanction the BBC and Daily Trust over their documentaries on terrorism in the country, whether through the Nigeria Broadcasting Commission (NBC) or any other agency of government."

Mohammed had last Thursday stated that the Federal Government would sanction the BBC and Trust Tv for airing documentaries that allegedly "glorify", "promote", and "fuel" terrorism and banditry in Nigeria.

In a letter dated 30 July, 2022 and signed by SERAP deputy director Kolawole Oluwadare, the organization said the media has the duty to impart information and ideas on issues of public importance, saying that if carried out, the threat to sanction the BBC and Daily Trust would inhibit the media from reporting on issues of public interest and lessen the flow of diverse viewpoints and information to the public.

According to SERAP, Media houses and journalists ought to be given the room to determine how best to present information of public interest, especially information about the growing violence and killings across the

The organization further said that rather than punishing the media for promoting access to diverse opinions and information

on issues of public importance, the Buhari government should focus on delivering her promises to ensure the security of Nigerians.

The letter read, "We would be grateful if the requested action is taken within 48 hours of the receipt and/or publication of this letter. If we have not heard from you by then, SERAP shall take all appropriate legal actions in the public interest.

"A free, uncensored, and unhindered press or other media is essential in any society to ensure freedom of opinion and expression and the enjoyment of other rights. It constitutes one of the cornerstones of a democratic society.

"Sanctioning the BBC and Daily Trust would be entirely inconsistent and incompatible with Nigeria's obligations under article 9 of the African Charter on Human and Peoples' Rights and article 19 of the International Covenant on Civil and Political Rights.

"The threat if carried out would impermissibly restrict the constitutional and international rights to freedom of expression, access to information, and victims' right to justice and effective remedies that are central to public debate and accountability in a democratic

"Access to information is essential for the enjoyment of other human rights and freedoms and constitutes a fundamental pillar for building a democratic society and strengthening democracy.

"Allowing the media to freely carry out their duties is essential to building secure society and leaving no one behind. Conversely, imposing impermissible restrictions on media houses, journalists and other Nigerians undermines the security that builds a healthy and vibrant

The grounds for sanctioning the BBC and Daily Trust as stated by Mr Mohammed fail to meet the requirements of legality, necessity, and proportionality.

"The requirement of necessity also implies an assessment of the proportionality of the grounds, with the aim of ensuring that the excuse of 'glorifying, promoting, and fuelling terrorism and banditry' are not used as a pretext to unduly intrude upon the rights to freedom of expression and access to

"Any interference with the constitutional and legal duties of the BBC and Daily Trust would not be justified in the context of the right to information.

"The Federal Government has not shown that the documentaries by the media houses would impose a specific risk of harm to a legitimate State interest that outweighs the public's interest in the information provided by the documentaries.

"The documentaries by the BBC and Daily pose no risk to any definite interest in national security or public order.

"It is inconsistent and compatible with the Nigerian Constitution 1999 [as amended] to invoke the grounds of 'glorifying, promoting, and fuelling terrorism and banditry' as justifications for suppressing freedom of expression or withholding from the public information of legitimate public interest that does not harm national security.

"It is contrary to both the Nigerian Constitution and international standards to threaten or punish journalists and media houses such as the BBC and Daily Trust for disseminating such information.

"The vague and overbroad definitions of 'glorifying', 'promoting', and 'fuelling' raise concerns that the threat by the Federal Government if carried out would unduly interfere with the rights to access to information, and disproportionate to any purported legitimate governmental aim. Ill-defined and/or overly broad grounds are open to arbitrary application and abuse.

"The broad definitions of what may constitute 'glorifying', 'promoting', and 'fuelling' also heighten concerns of overreach, confer far-reaching discretion on the government, and suggest that the grounds cited by the Federal Government are more intrusive than

"These words do not indicate precisely what kind of individual conduct would fall within their ambit.

"The use of these words by the Federal Government, given their opaque and ambiguous meaning, leaves open the possibility for application beyond unequivocal incitement to hatred, hostility, or violence. Such words may function to interpret legitimate reporting by media houses, journalists, and other Nigerians as unlawful.

"The grounds cited by the Federal Government for sanctioning the BBC and Daily Trust also fail to establish a direct and immediate connection between the reporting by the media houses and any risks to national security and peace.

"The threat if carried out would also create an environment that unduly deters and penalizes media houses and journalists, and the reporting of government wrongdoing more generally.

"The cumulative effect of any attempt to sanction the BBC and Daily Trust would be the gagging of the media from reporting on cases of violence and killings by terrorists and kidnappers, the reporting and information that is clearly in the public interest.

Bawa seeks attitudinal change, collective actions against corruption

The Executive Chairman of the Economic and Financial Crimes Commission (EFCC), Abdulrasheed Bawa has called for practical attitudinal change and collective actions as preventive tools in the fight against economic and financial crimes.

Bawa made the call in Abuja while delivering a Keynote Address at the Chatham House African Programme Conference with the theme, "Towards Collective Action On Corruption In Nigeria: Linking Evidence and Practice in Support of Attitudinal Change".

The EFCC boss admitted that issues of economic and financial crimes have caused reputational damage to Nigeria and Nigerians across the world but acknowledged the bold, decisive and far-reaching efforts of the government in breaking the strongholds of the crimes in the land

According to him, "behavioural and social norms are the drivers to our daily response to issues, which collectively impacts society, either positively or otherwise.

"This audacious task of government is exhibited in the clear political will to

deal with the issues frontally. To show its understanding of the problem, the government came up with the mantra; if we don't kill corruption, corruption will kill us."

Bawa, who advocated a multiple-pronged approach to solving the corruption problem, pointed out that the EFCC has always employed such a mechanism in addressing the menace of economic and financial crimes.

"The Economic and Financial Crimes Commission, EFCC, is conscious of its mandate and the need to adopt multiple approaches in its fight against corruption, money laundering, economic and financial crimes. These approaches revolve around the brick - and - mortal surveillance, investigation and prosecution processes and mechanisms that centre on attitudinal and behavioural changes that can serve as preventive tools in the fight against this malaise," he said.

The EFCC boss also advocated the use of social media to push for more vigorous citizen engagement in the fight against corruption.

He said, "We must look beyond the traditional approaches to citizens' engagement and extend to new frontiers, such as the digital space. Social media offers a delicate but helpful outlier for participation by citizens in the fight against corruption."

While highlighting the success of the EFCC in previous years, Bawa said, "The Commission set yet another record of convictions in 2021, where it recorded Two Thousand Two Hundred and Twenty-Two (2220) convictions, representing a 127.5 percent improvement over the 2019 record. The 2021 conviction record represents a 98.49 percent success rate in prosecution, as the Commission lost only 34 cases during this period."

He urged Nigerians to take active interest in the affairs of the agency through the whistle blowing policy of the government while pushing for accountability of the anti-corruption agencies by demanding for more appropriate counter measures against graft.

The Conference paraded a cream of accomplished professionals, including Dr Alex Vines OBE, Managing Director, Ethics, Risk and Resilience and Director, African Programme, Chatham House; Professor Olatunde Babawale, Provost, Anti-Corruption Academy of Nigeria (ACAN), and Bishop Matthew Hassan Kukah, among others.

GF Malami asks U.S to extradite jounalist over alleged defamation

The Attorney-General of the Federation and Minister of Justice, Abubakar Malami, has requested the extradition of journalist, Azuka Jebose from the United States embassy over alleged defamation and cyberstalking of billionaire, Ned Nwoko.

This was contained in an extradition request dated June 27, 2022, with reference CÂU/EXT/175/21, signed by Akutah Pius Ukeyima, Head, Central Authority Unit, and

titled "Request for the Extradition of Azuka Jebose in a Case of Cyberstalking from the United States of America to Nigeria."

"I am directed by the Honourable Attorney-General of the Federation and Minister of Justice of the Federation of the Federal Republic of Nigeria to present his compliments and forward the attached request for Extradition to Your Excellency for onward transmission to the United States of America Department of Justice," the request read.

Nwoko in July 2020 sued the U.S.-based journalist who accused him of complicity in

the murder of one Ogogo Blessing.

In a Facebook post, the journalist claimed that Mr Ogogo's corpse "was found floating inside the pool" of a building that belonged to the former lawmaker.

He further accused the sacked lawmaker of using his wealth and influence to stall the investigation of the matter.

In reaction, Nwoko filed a lawsuit alleging defamation of character and demanded N2 billion damages including a "public apology to be published by the defendants in at least two national daily newspapers circulating in

Nigeria and social media platforms."

Nwoko claimed that the defamatory publications in several online blogs and other social media platforms were aimed at denigrating his reputation.

Meanwhile, in a similar extradition matter, the Nigerian government had yet to accede to the request of the U.S. government to hand over embattled and disgraced Deputy Commissioner of Police, Abba Kyari, who allegedly connived with international fraudster, Ramon Abbas, aka Hushpuppi to defraud a Qatari businessman of millions of dollars.

EDITORIAL

Confronting inflation in Nigeria: what options?

ccording to the National Bureau of Statistics (NBS) Consumer Price Index (CPI) and Inflation Report of May 2022 released in Abuja recently, Nigeria's inflation rate increased to 17.71 percent on a year-on-year basis in May. This is worrisome. This is not an abstraction. Buyers and sellers are groaning because of the biting inflation. Salary earners are hard pressed into making difficult choices. The purchasing power of the naira is woeful. The naira has depreciated over 100% in the last five months. What are the options for the Nigerian government?

The implication of a high inflation rate in any society is far-reaching and damaging. It impacts negatively on wage earners whose emoluments are usually systematically eroded and devalued by the high cost of goods and services. This may snowball into labour crisis in a country. Inflation means more money chasing fewer goods and services. It follows that a society experiencing inflation is operating as a consumer rather than a producing economy. Such a society is import-dependent.

By the time President Muhammadu Buhari ends his tenure in 2023, Nigeria will have enjoyed twenty-four unbroken years of democratic governance. The current government gave hope of "change" during the campaigns that successfully brought her to power. But the question is: have things changed for the better? The inflation index is usually used by economists to appraise the government's economic performance. If we go by the current index, the obvious conclusion is that the government of Nigeria has failed woefully.

Our country is gradually slipping into what is called run-away inflation. That a high Court of competent jurisdiction could fix the salary of the Chief Justice of Nigeria at N10 million, is an indication of how worthless the Naira may be. This is not the time for blame trading but to call on all relevant bodies as well as

the Nigerian Economic Society to find a way out of this economic quagmire. This should be urgently done!

Two major sectors that must be immediately addressed are the power and energy sectors. It is shameful that no government under the People's Democratic Party that ruled Nigeria, and produced three presidents – Olusegun Obasanjo (1999-2007); late Umaru Yar'Adua (2007-2010); and Goodluck Jonathan (2010-2015) – in 16 years was able to build a new refinery in a country that ranks number five in the crude oil production in the world. The electricity sector is not different. It is a sector used to "cash out funds" by corrupt politicians and public servants. Goods produced in Nigeria are uncompetitive due to the high

cost of production. High cost of power and energy negatively impact the cost goods in Nigeria.

It is also a thing of shame that a country with a population of over 200 million people would depend on food importation. Government must come up with an agricultural Marshall Plan, even if it means engaging the NYSC as an agricultural intervention corps until the country becomes self-reliant in food production. The food crisis has been further exacerbated by attacks from bandits and terrorists as well as outright dislocation of farming communities.

Be that as it may, the inflationary trend in the country is the source of stress, depression, and mental health problems for many citizens. Ghana is witnessing protests from its citizens due to the high cost of goods and services. The government of Ghana recently went into an agreement with organised labour unions in the country and increased the wages of workers; agreeing that the "Cost of Living Allowance (COLA)" will be paid at a rate of 15% of base pay from July 01, 2022. The Nigerian government should be proactive by taking concrete measures to arrest the ever-increasing inflation.

There are many other measures government must take in order to assuage the pains inflation has brought on the average income earner. Government should provide more houses for low-income earners. There should be constant expansion and improvement of mass transit for the public. The burden of the unemployed on family members and other relatives who are working should also be reduced since high "unemployment" means many people are idle and not productive. Government must protect local industries, encourage the establishment of new productive firms and promote a "buy Nigeria" culture. Capital flight in the form of health and education tourism must be checked. The time is nigh for this government to put some forms of austerity measures in place. A stitch in time saves nine.





The policy, organization and administration of the Nigeria Police Force and all other matters relating thereto (not being matters relating to the use and operational control of the force of the appointment, disciplinary control and dismissal of members of the force) shall be under the general supervision of the Nigeria Police Council. 13. The President shall cause the Nigeria Police Council to be kept fully informed concerning the matters under its supervision and shall cause the Council to be furnished with such information as the Council may require with respect to any particular matter under its supervision. 14. The Nigeria Police Council may take recommendations to the Government of the Federation with respect to any matter under its supervision, and if in any case the Government acts otherwise than in accordance with any such recommendations it shall cause a statement containing that recommendation and its reasons for acting otherwise than in accordance with that recommendation to be laid before the National Assembly"

And that is why Chief Rotimi Williams in his speech on November 1, 1977, did not include State Police creation when he presented his bill to the Constituent Assembly presided over by Justice Egbert Udo Udoma((21 June 1917 – 2 February 1998), who was the Chief Justice of Uganda from 1963-1969 . The regimes of President Shehu Usman Aliyu Shagari GCFR (25 February 1925 – 28 December 2018), Turakin Sokoto, Major General

Muhammadu Buhari GCFR (79), General Ibrahim Babangida(80) GCFR, Chief Chief Ernest Adegunle Oladeinde Shonekan GCFR (9 May 1936 – 11 January 2022, General Sani Abacha GCFR (20 September 1943- 8 June 1993) and General Abdusalam Abubakar GCFR (80) did not create state Police.

After his inauguration as President on May 29,199, President Olusegun Obasanjo GCFR then set up a Presidential Committee on the Review of the 1999 Constitution. The Committee was inaugurated on behalf of President Obasanjo by his then Attorney General and Minister of Justice, Chief Kanu Agabi (76). The Committee which was later headed by Chief Clement David Ebri(69) former Governor Cross River State, submitted its reports to President Olusegun Obasanjo GCFR on February 28, 2001, unfortunately the committee did not recommend the creation of State Police.

Prominent members of the Committee were Chief Avo Adebanjo, Chief Avo Opadokun, Chief Barnabas Gemade, Chief A.K. Horsfall, Alhaji Iro Abubakar Dan Musa, Chief Arthur Nwankwo, Barrister Adeniyi Akintola, Chief Solomon Asemota (SAN), Mrs. Ayoka Lawani and others.

What the committee recommend was this "Two positions were canvassed by Nigerians on the desirability or otherwise of allowing States to establish and maintain their Police. Proponents of separate Police for the States rested their demand on the strong ground that it was consistent with federal practice. The arrangement, they argued, enabled the Federating States to effectively

riots and ethnic militancy without the often costly delays in obtaining Federal approval by the Commissioner of Police e ewe a State Governor has so directed/requested. The handling of the various inter communal upheavals in the various states of the federation since the beginning of the current democratic governance left much to be desired. This, many people believe was due to the provision of Section 215 (4) of the Constitution which hinders a Governor from exercising his power as Chief Security Officer of the State.

Another example mentioned for the failure or weaknesses in the present centralized Police structure was the inability of the Nigeria Police to contend with the high rate of violent crimes which ravaged major towns all over the country. In response to the hostage-like situation in which the States were held by hoodlums, some State Governments have resorted to establishing Vigilante Groups which they claim have successfully dealt with the crime situation in those States. In some instances however, people often accuse these groups as some kind of local "militia" who would not hesitate to take the laws into their hands at will and molest people. The recent experiences in some parts of this country constitute sufficient lessons not to allow local "militia" to be formed. The Nigeria Police is however so badly equipped and unmotivated and so could not effectively deal with the crime and security situation in the country

Representations against State Police bordered on the fear of abuses to which State Governors may subject their Police. These fears included those of intimidation and harassment of political opponents and perpetuation of electoral frauds. References were made to the experiences in the Country during the former Regional Governments when the authorities put the Regional and Local Authority Police to abuse - a development which led to occasional breakdown of law and order. The fall of the first Republic was partly blamed on the ignoble use of the Regional and local Police. It was, therefore, feared

that it 'Was too soon in the life of Nigeria's nascent democracy for the idea of State Police to be entertained. For this school of thought, it was argued that the need for State Commissioners of Police to occasionally clear operational instructions with the Inspector-General was intended to check abuses and ensure that the orders by Governors were actually lawful What the Nigeria Police needed in order to function properly and serve Nigerians more effectively, was a retraining programme, proper funding and adequate and up-to-date equipment while steps should be taken to sanitise the institution and rid it of corruption and other vices. The Committee weighed the agitations for and against allowing States to establish their Police Force. Both sides of the argument have their merits and demerits. However, the

Committee notes that while the idea of State Police at some future date could not be wished away as Nigeria gradually matures in democratic governance, the prevailing situation today does not warrant the establishment of a parallel Police Force at the state level let alone at Local Government level. By so doing, there is the inherent danger of threatening the corporate existence of the nation. The Committee maintains that national stability and unity at all times should be the overriding concern of all Nigerians.

In view of the possible destabilising effect of having parallel Police at the State and Federal levels, the Committee recommends that the existing constitutional provisions as provided in Sections 214, 215 and 216 be retained. It however agrees that there is need for reorientation, reorganization and repositioning of the Nigeria Police to enable it meet the requirements of public order, public safety and democratic governance at all levels".

I could not believe what I read in Clement Ebri's committee's report.

Even in the United States, the state police is a police body unique to each U.S. state, having statewide authority to conduct law enforcement activities and criminal investigations. In general, state police officers, known as state troopers, perform functions that do not fall within the jurisdiction of the county sheriff (Vermont being a notable exception), such as enforcing traffic laws on state highways and interstate expressways, overseeing the security of the state capitol complex, protecting the governor, training new officers for local police forces too small to operate an academy and providing technological and scientific services. They support local police and help to coordinate multi-jurisdictional task force activity in serious or complicated cases in those states that grant full police powers statewide.

In many states, the state police are known by different names: the various terms used are "State Police", "Highway Patrol", "State Highway Patrol", "State Patrol", and "State Troopers". However, the jurisdictions and functions of these agencies are usually the same, regardless of title. Some agencies' names are actually misnomers with respect to the work regularly done by their members. All but two state police entities use the term "trooper" to refer to their commissioned members.

I am aware that Spain, Mexico, Indonesia, India, Germany, Canada, Brazil, Australia, Argentina and many countries have state police. And this has helped the security outfit of those

Since 1999, we have been attempting to amend the Constitution but till today, we have not created state police. Since 1999, every deputy Senate President to date, Alhaji Ibrahim Mantu(2003-2007), Ike Ekweremadu(June 6 2007-June 11. 2019), Obansi Ovie Omo Agege(11 June 2019 to date) and deputy speakers of the House of Representatives from 1999 to date, Chibubom Nwuche (61), Austin Adiele Opara(58), Emeka Ihedioha(57), Yusuf Sulaiman Lasun(61), Ahmed Idris Wuse(58) have all been charged as Chairmen of various committees to amend the Constitution. Huge amount of money have been allocated for these exercise, we are yet to have state police included in the constitution.

The question now is, do we need State Police and is it desirable. Of course we do and it is urgently desirable. It is hereby advocated.

Insecurity: Tinubu mulls decentralization of Police, jobs creation

residential candidate of the All Progressives Congress (APC), Asiwaju Bola Tinubu, has declared that he will tinker with the security architecture of the nation by decentralizing the police as a way to fight the nagging insecurity challenges that threatens the unity of Nigeria.

As part of agenda for Nigeria's greatness, the APC candidate is set to reduce inducement to criminal activities by creating jobs and employment opportunities which will in turn boost economic activities and place the nation on the track of prosperity.

According to a press statement signed by Bayo Onanuga, Director of Media and Communication of the Tinubu Campaign Organisation (TCO), if elected president come 2023, his administration will lead Nigeria to a new era of economic prosperity, peace, security and political stability.

Tinubu's his vision for Nigeria is based on five thematic areas of improving security by decentralising the policing of the country and creating hundreds of thousands of new jobs simultaneously and transforming Nigeria into an enviable country where there will be justice, peace and prosperity for all, with a "robust economy".

Titled 'My Vision for Nigeria', Tinubu promised in the document, "a nation transformed into greatness, the pride of Africa, a role model for all black people worldwide, and respected among all other countries.

"A vibrant and thriving democracy and a prosperous nation with a fast-growing industrial base, capable of producing the most basic needs of the people and exporting to other countries of the world.

"A country with a robust economy, where prosperity is broadly shared by all irrespective of class, region, and religion.

"A nation where its people enjoy all the basic needs, including a safe and secure environment, abundant food, affordable shelter, health care,

and quality primary education for all.

"A nation founded on justice, peace, and prosperity for all."

On economy, Tinubu promised to build an economy that will make the nation's Gross Development Product grow quicker annually for the next four years while also providing jobs for millions of youths in the country.

He also promised to launch a new National Industrial Policy focused on special intervention to reinvigorate specific strategic industries.

"I will focus on stimulating jobs, which will be my top priority as President. I will get Nigeria to work by launching a major public works program, a significant and heavy investment in infrastructure, and value-adding manufacturing and agriculture.

"My administration will build an efficient, fast-growing, and well-diversified emerging economy with a real GDP growth averaging 12% annually for the next four years, translating into millions of new jobs during this period," he said.

Tinubu also promised to create six new Regional Economic Development Agencies which will establish sub-regional industrial hubs to exploit each zone's competitive advantage and optimise their potential for industrial growth.

The presidential aspirant also promised to formulate a new National Policy on Agriculture to boost food production.

He promised to promote the establishment of new commodity exchange boards, while also strengthening the one in Lagos in order to guarantee minimum pricing for agricultural products such as cotton, cocoa, rice, soya beans, corn, palm kernel, and groundnuts.

On infrastructure, Tinubu promised to "Build A New Nigeria (BANN)" by developing a National Infrastructure plan, which will cover strategic roads, bridges, rail, water, power, seaports, and airports spanning the length and breadth of the country.

He said his administration will combine government funding, borrowing, public private partnership, private sector financing and concession to initiate a medium and longterm financial model for the BANN initiative.

Tinubu further stated that his administration will target an electricity distribution goal of 15,000 megawatts across the country and ensure a sustainable 24/7 supply.

"On Electricity, I will embark on a renewed action-oriented focus and take immediate and urgent action on resolving existing challenges of power generation plants, gas purchasing, pricing, transmission, and distribution. My administration's critical goal is to have 15,000 megawatts distributable to all categories of consumers nationwide to ensure 24/7 sustainable supply within the next four years," he added.

On the oil and gas sector, Tinubu said there will be no need for a subsidy because the market will be open and transparent.

"Supply will come from local refineries, and the forces of demand and supply will determine the price of petroleum products.

"My administration will establish a National Strategic Reserve for Petroleum Products to stabilize supply during unexpected shortages or surplus periods. This will eliminate any form of product shortages and prevent wild swings in prices.

He promised to strengthens the education sector by increasing the spending on education to 25 per cent of the nation's budget, continue the free school feeding programme of the APC, feeding "millions of primary school children across the country" and eradicate strikes by tertiary institution workers.

He said the former vice president is more sane, physically and mentally fit and politically experienced than others having occupied the office of vice president of Nigeria in the past.



According to him, he was neither consulted or coopted into such plan by the eleven other senators alleged to masterminding the plot.


He said " at no time was I consulted or coopted into such plan. It is just the figment of imagination of the online publications and the others who are linking me to such a move.

Purported defection plans: Lawan not sitting on defection letters of APC senators

Halliru Dauda Jika (Bauchi Central) and Lawal Yahaya Gumau (Bauchi South)

The Senate President, it was learnt after frantically talking to the APC lawmakers who are hell bent on jumping ship, deliberately held on to their defection letters till the Senate adjourned last week for a long vacation

But, apparently referring to a publication

alluding to the fact that Lawan was sitting on such letters, a statement from his media office categorically stated that the story is utter falsehood as there was no such letter before the Senate President.

Ola Awoniyi, Special Adviser(Media) to President of the Senate on Saturday said "obviously, the purveyors of the syndicated lies had not even bothered to confirm from the Distinguished Senator if and when he submitted any such letter to the Senate President.

2023: Labour Party, PDP charge INEC not to compromise credible conduct of election

Both the Labour Party (LP) and People's Democratic Party (PDP) have charged the Independent National Electoral Commission (INEC) to know that it's credibility is at stake in conducting acceptable elections in 2023.

The charge is on the heel of insinuations of alleged plans by actors in the political class to compromise the Commission ahead of the general election.

One of the national officers of the Labour Party and coordinator of a support group campaigning for Peter Obi presidency alleged of plans to rig out Obi even before the election by politicians who are terrified by the soaring popularity of the LP presidential candidate.

Speaking anonymously, he said that the Labour Party has latched on a thick plot to involve INEC staff and workers of communication network service providers to disenfranchise voters in catchment areas of the LP candidate, particularly in the South East and South South regions of the country.

Specifically, he said the Bimodal Voters Accreditation System (BVAS) machines are going to be tampered with and sent to strongholds of Obi in both S/ East and S/ South.

"The aim is that the BVAS machines will malfunction or work slower and drastic reduce the number of willing voters that will be accredited before voting proper commences. Thereby hundreds of thousands of Obi's supporters will be disenfranchised and his

prospect of gaining huge number of voters in those areas truncated.

"This can only be achieved in collusion with INEC and that is why we are warning the Commission not to fall prey to such plot to manipulate the system".

Part of the plots to deny Obi of acruable votes at the he poll, according to the Labour Party, include a deliberate plan to ensure that election materials arrive late in these areas

He said "the idea is to frustrate voters and ensure they get tired and retire. And at the end of the day a minimal percentage of registered voters will be accredited and allowed to vote, thereby disenfranchising a larger number of voters.

"We are going to plan ahead of such plot as we will educate voters, particularly our members to be on the alert and insist that all registered voters must be allowed to carry out their civic responsibility.

"We will ask then to go out with their foods and drinks and share with others. They should wait there even if it is midnight to vote and their votes must count. They should stay until the end of the whole exercise and ensure they have results sent immediately."

Finally, the LP chieftain send warning signals to operators and technicians in network service providing companies not to compromise their operations.

He alluded to a plan to lobby operators to deliberately tamper with network to ensure that frequencies are not strong enough in areas of strength for Peter Obi.

This, he said, "is to slow down network

to affect the functionality of BVAS and uploading of results immediately on INEC portal. This, he added "is to create room for manual recording of result which can be falsified or hijacked by hoodlums.

"We are also privy to information of plans to create violence in polling units with the end aim that INEC will cancel results of voting in such area in line with extant electoral laws."

Upon all the alleged plots, he said leadership of the Labour Party will address a press conference in which it will raise these issue and seriously warn INEC and network service providers not to yield to compromise.

On its own part, the Peoples Democratic Party (PDP) warned that INEC should be aware of it's responsibility to Nigerians to conduct acceptable elections in 2023.

The party admonished the Commission to replicate the INEC Candidates Nomination Portal (ICNP) which was successfully deployed at the recently conducted Osun State governorship election during the coming general election.

The PDP insisted that the deployment of the (ICNP) technology will ensure transparent, fast, credible polling and transmission of results in the 2023 general elections.

According to the party, the ICNP technology allows political parties to use specified and dedicated Access Codes issued by the Commission to log in and electronically upload the names and particulars of their candidates onto the INEC Web Portal in a manner that guarantees promptness, safety of materials as well as the integrity and transparency of

the submission process.

The PDP noted the effort by INEC to train Mobilization staffs of political parties for seven days; an initiative that played key role in the success of the ICNP process while urging INEC to organize more capacity building trainings for its officials ahead of the 2023 general election.

National Publicity Secretary, Debo Ologunagba said "our party believes that the success of the ICNP is a further pointer that technology can be effectively deployed to enhance the credibility of sensitive electoral processes such as rapid uploading, transmission, collation and final declaration of election results at all levels.

"The PDP, a critical stakeholder in the Nigerian Democratic System, applauds the deployment of technology in the electronic transmission of results in the Osun State Governorship election but urges the Commission to expand its capacity so as withstand the expected pressure in the large-scale transmission of results from across the country in the 2023 general elections."

The PDP therefore, charged INEC to ensure the security of its electronic system to prevent infiltrations and manipulations especially in the 2023 general elections.

"INEC must know that the process of the 2023 general elections is crucial to the people and Nigerians expect nothing short of free, fair, transparent and credible elections that will reflect only their expressed Will and aspiration to rescue our nation from the current misrule," the party cautioned.

Aftermath of PDP Presidential primaries: Wike opens up on crisis in party, says truth will prevail

Rivers State Governor, Nyesom Ezenwo Wike on Friday said he would address Nigerians on the impasse in the opposition Peoples Democratic Party, (PDP) occasioned by the outcome of the presidential primaries and consequent choice of the presidential running mate of the party.

The governor who stated this on arrival to the state from Spain described as unfortunate the unguarded public comments credited to respectable party members against him after the conduct of the Peoples Democratic Party (PDP) presidential primaries.

"But there comes a time that people will understand and know the true facts. So, obviously, whether I will speak is not in doubt, to let Nigerians know the actual truth. Having known the truth, whatever they decide to do with it is left for Nigerians.

"Because, you can imagine, the presidential candidate of the PDP Alhaji Atiku Abubakar, when he unveiled the vice presidential candidate, no right thinking lover of this party would say that the speech he made on that day was fair. Forget about the favour seekers. Forget about the scavengers. But I never reacted to it. That is because this party belongs to all of us.

"Thereafter, he appeared on Arise Television, see the statement he made. So many lies were told and you said

I should not react to some of those issues. That would not be fair."

Governor Wike explained that after the PDP primaries he returned to Rivers State to focus on fulfilling the remaining promises that he made to Rivers people.

He said, already a number of completed projects have already been outlined for inauguration and when that was done, he would respond to all the lies peddled against him.

all the lies peddled against him. He said, "Assuming today, I'm not alive, obviously what they have said would be accepted as the truth. Look at his (Atiku) attack dogs, Sule Lamido, Babaginda Aliyu, Maina Waziri. Look at the statements they issued. Look at the abuses they rained on me, but I never reacted.

"And Nigerians will ask, you mean these things happened? So, it is important that as a person and for my own future, and for those who rally around me to say, look, this is not fair. So, I will

He emphasised on speaking to lovers of the party by putting the record straight so that they will know who is being truthful.

"Look at it, a presidential candidate who believes that he wants to win election, and somebody who contested fiercely with him that has never raised any issue. I just kept quiet, just minded my business, to see how my state can move forward.

"We will say look this is not correct, so that posterity, history will be on our side so that we have been able to keep the record straight. So, nobody should be in doubt whether I am going to speak on the issue of PDP, issues of the primaries and other related matters.

"Nigerians will know what happened, Nigerians will know those who love this country, Nigerians will know what went behind. And that is to assure you are going to speak on that."

Governor Wike clarified that Senator Bukola Saraki met with him in Spain, but said he was not sent by Alhaji Atiku, so nobody should think in such a direction.

The Rivers State Chief Executive wondered why Alhaji Atiku Abubakar who visited him at his place to solicit his support does not know the way to the house he once visited.

The Governor also said that he is not aware of any committee that has been set up by PDP or the party's presidential candidate to reach out to him.

"I want to tell members of the public, as far as I am concerned, I love this party, I have remained committed and I have been able to play my part. I'm not talking about leaving this party.

"I am not one of those who are running around the presidential candidate to say I want to be this. I am not one of those favour seekers, scavengers looking for how they will survive.

"After the commissioning of projects that we have lined up, we will be able to speak to Nigerians and tell them what happened. It doesn't matter who is involved.

"I am not a slave, and I will not be a slave, am a free-born of this country. I must be able to say how things are, whether it suits you, or it does not suit you, is immaterial.

"So, members of the public should please bear with us that we must put the records straight. If we don't put the records straight, history will not be happy with us", Gov Wike insisted.

I need donation to buy N15m Labour Party governorship form, aspirant appeals to Lagosians

Lagos gubernatorial hopeful, Babatunde Gbadamosi has decided to raise fund to pay the N15 million fee for governorship nomination form of the Labour Party (LP).

Gbadamosi who contended for the governorship ticket of the Peoples Democratic Party (PDP) but lost out has dumped the PDP for the Labour Party.

He said the feasibility to contest the 2023 governorship election in Lagos State depends on ability to raise the fee for nomination through donation from people that wish he could be the next governor of the state.

He added that his hope of contesting was revived by demand by his numerous supporters to latch unto the opportunity provided by the Labour Party.

The politician took to his tweeter handle to appeal to his supporters to donate money to a dedicated bank account for the purpose of obtaining the LP form before the August 12th, 2022 deadline for final substitution of Gubernatorial candidates by parties.

He had earlier contested in the governorship race in 2011 and 2015 under the PDP platform. In both years, he failed to secure the party's ticket and lost to Ade Dosunmu in 2011 and Jimi Agbaje in 2015.

And in 2019, he contested the governorship election on the platform of the African Democratic Party (ADP) but lost to the incumbent governor, Babajide Sanwo-Olu of the APC, after which he rejoined the PDP in 2020.

Gbadamosi in his tweet said "while it is true that Lagos needs rescuing from the clutches of those who have turned it into their ATM, it is true too that because of their looting of that ATM, the effort will be an uphill task that will require immense resources, from my personal experience," he wrote.

"My political experience has taught me that you cannot rescue people who are not interested in being rescued. The only way I can believe Lagosians are ready for true freedom from the Jagajagabandits is when I see true commitment."

"I am told the Labour Party Expression of Interest and Nomination Forms cost ©15m, and there is a fee for waiver, that could bring the total to up to N20m. INEC deadline for final substitution of Gubernatorial candidates is August 12th, 2022.

"If truly, you're interested in getting me to run, it is time to put your money where your mouth is, and go get me the Labour party form, because honestly, I really no get shishi to give."



OPEC posts 2.84mbd lesser oil production output in June

xpectations that the Organisa-**J**Countries (OPEC) and its coalition members can rapidly rise to the challenge of supply disruptions in the international oil market is beginning to fade as gaps between the groups output protections and actual barrel deliveries continue to deepen.

Output deficits relative to production target, become more worrisome even after Saudi Arabia boosted output amid struggles to repair its shaky relationship with the United States of America

Russia pumped more output as it seems to make up for steep price discounts, and Libya doubled its output to over a million barrels per day.

Despite significant production rise the 24 nations group started output recovery in late 2021, returning to Pre-Pandemic Production level has been difficult for the group, whose members have suffered gross exploration under investment and production

Nigeria, a prominent member of OPEC, for instance, was unable to rise to its assigned output quota as the group's compliance rate drops to lowest oil production, just as the oil group's underproduction rose to whopping 2.84 million barrels per day in June 2022 according to data corroborated by international

market and shipping players. Some of the OPEC group's delegates told news agency sources, the alliance suffered massive shortfall of 2.84 million barrels per day (bpd) in June between Actual Production and the target oil output level.

As OPEC releases its oil output, more members have been falling further behind their quotas due to a lack of capacity or investment in supply, consequently, the gap between nameplate-production per the agreement and actual production continues to widen.

According to the report of a survey conducted by Argus Media in the month of June, OPEC pumped over 2.5 million bpd more than 2.5 million bpd below its target in June, in spite of a rebound in Russia's oil production that helped the group's output rise by 730,000 bpd from May.

Russia's oil production Rose in June and was approaching the levels last seen in February, just before the Russian invasion

of Ukraine, while most of the rebound was due to higher intake from domestic refiners

The Trumpet reports that 10 OPEC producers pumped 24.8 million bpd of crude oil in June according to the organisation's data showed that in the monthly oil market report (MOMR) with production falling one million bpd short of the target levels.

Top OPEC producer, Saudi Arabia, naturally raised its crude oil production by the most in June compared to May.

OPEC's secondary sources stated that even the Saudi Arabia was even lagging behind their quota for June, adding that its oil production rose by 159,000 bpd to 10.585 million bpd and that to compare the figures, Saudi Arabia's target was 10.663 million bpd, so the kingdom was 75,000 bpd below its quota last month according to figures from secondary sources.

OPEC is expected to continue to under-performed compared to its production target for July and August after the group decided to accelerate the rollback of the cuts and have those completely unwound by the end of August.

Already, Libyan Production is back on track and production rates in country have surged above one million bpd, almost doubling month-on-month less than one week after the Tripoli government lifted the blockade of oil ports and infrastructure.

Oil output had more than halved since the middle of April, as the increase followed an agreement with protesters and tribal heads on the need to reopen fields and export terminals that had been largely shut since mid-April, but before the resumption, production was down to 560,000 barrels per

Chartered Insurance Institute of Nigeria (CIIN), noting that the new phase of regulation was already being implemented and there are policies in the works to reinforce the commission's new direction.

While establishing the commission's distinct Lever Push in the regulators perspectives, Abubakar, who represented the Commissioner for Insurance, Sunday Thomas, said NAICOM has almost finished work on guidelines for cover of assets of MDAs with collaboration of Federal Ministry of Finance, Secretary to the Government of the Federation (SGF) and Head of Service (HoS) of the Federation.

The coming guidelines, he stated, would require MDAs to insure

known recently at a forum of the all assets and non-compliance would be sanctioned, adding: "It is worrisome to the commission that most assets and liabilities of government are never adequately and appropriately insured, which further accentuated the need for urgent measures to be put in place by the commission to ensure that government gets value for money in the purchase of insurance by MDAs.

"Recently two insurance companies' licences have been withdrawn and these are Niger Insurance and Standard Alliance Insurance. Though managing the death and failure of financial institutions is very demanding, nevertheless more may still be liquidated in order to sanitise the industry," he added.

Abuja Terror Attack: How terrorists dislodged army, killed captain, four others - Insider's Account

Facts on how terrorists attacked military officers of the 7 Guards Brigade and soldiers of other Battalions last Sunday in Bwari Council Area of the Federal Capital Territory (FCT), Abuja have emerged.

In a leaked audio clip, a soldier of the 7 Guards Brigade, who was part of the operation, gave the detailed account of how the terrorists dislodged the soldiers, who included those from 177 and 102 Battalion in Keffi, killing no fewer than five. However, he said the soldiers killed about 12 terrorists and chased them from the entire area.

According to him, the terrorists, who were armed with Improvised Explosive Devices (IEDs) and other assaulted weapons, ambushed and engaged the soldiers from all sides after they (soldiers) advanced into the bush without their RPGs, Gun Trucks, AA and GPMG due to obstruction caused by water and rocks.

The soldier, who said he was injured and receiving treatment at the National Hospital, stated that the terrorists had written the School of Law at Bwari Road that they would be attacking the school.

He said the school on receiving the letter immediately informed the 7 Guards Battalion.

He noted that the Brigade instantly mobilised to the school and started all round defence deployment. He further stated that there was contemplation that the terrorists may have plan B to attack another place, so they looked for the nearest prominent target that they may attack, which happened to be a University very close to the Law School, about 3.2 kilometre away.

"So, we also went there to create all round defence as well. We were there for over two weeks before the attack last Sunday," he said.

According to him, the terrorists, who were already in the bushes, knew the soldiers were already on ground but did not have the plan of engage them until they (soldiers) advanced into the bush to clear their (terrorists) doubt after observing torch lights in the bush.

"At night we were always observing torch lights in the bush, so we were wondering who could be there at that time of the night. Therefore, we asked the security men at the University if they usually see the torch lights at night, but they said no. When it was morning, which was on Sunday, we have to advance into the bush. I was there in person.

"When we arrived there, we saw where they were smoking, where they cooked goat for food and also their tramol, so we confirmed that they were in the bush. Then we called for reinforcement and backup. They brought APC, gun truck, and Artillery team for us. So, we advanced into the bush, searching for them. This was on Sunday.

"Then we got to a place and there is water and some rock there, the gun truck could not channel through that particular road, so we parked them and that was why we had casualties to be sincere; we parked the AA, GPMG, the gun trucks because they cannot proceed through that route. We were with only our riffles and AK 47. We did not even carry RPG because we were thinking they will be only a pocket of enemy, like 20, 30 or thereabout.

"So, while we were inside the bush, we didn't know that they have seen us from a very far distance. So, they laid ambush waiting for us to penetrate, flagging us from left and right. The moment we got to their AOR, they engaged us and really engaged us. We lost four soldiers in my Unit and it was three Units that

went there – 177 and 102 from Keffi including my own Unit, 7 Guards Battalion.

"They dislodged us because they were fully prepared. They shell mortar and Improvised Explosive Devices (IEDs) but we still managed to kill about 12 of them. On our

side, they killed one Captain, one Lieutenant and two soldiers in my Unit while 177 battalion lost one soldier and 102 battalion also lost one soldier," he stated.

He, however, said the soldiers got reinforcement and have completely dislodged the terrorists in the eras after engaging them fearlessly.

"But since that day, we have been dislodging them. We have had reinforcement and I don't think any of them is still in that bush again. They went through Kaduna route and we followed them. We later carry the Gun Truck through another route to block and engage them.

"They didn't have the mind to face soldiers. They knew we were outside for that two weeks that was why they didn't attack. If we were not there, they would have destroyed that school of law long time ago but they have to wait because they knew soldiers were outside and we mounted the place like it was our barrack since they wrote the school.

"We turned it to duty with 10 soldiers in each duty armed with rifles, AK 47 and gun trucks. It was because we went to the bush to clear their doubt that brought about the attack on us but they suffered it too," he added.

Kidnappers of Nollywood actors demand \$100,000 ransom

Idnappers of prominent Nollywood actors and members of the Actors Guild of Nigeria (AGN), Cynthia Okereke and Clemson Cornel aka Agbogidi, who were kidnapped in an Enugu suburb days ago, have contacted their families, demanding for a \$100,000 ransom.

The actors, who are renowned for starring in movies shot in Enugu and Delta states, were reported missing after their family members confirmed that they didn't return home from a film location at Ozalla Town, Enugu State, on Thursday.

The AGN National President, Emeka Rollas, told journalists on Saturday that the kidnappers are requesting a lump sum in dollars as ransom.

Rollas said that the AGN is working closely with the families of the victims and the security forces to ensure their safe release.

"The kidnappers have made

contact with the families and are demanding the sum of \$100,000. We pray to God for his intervention and for Him to put confusion in their midst.

"We are also working closely with the different security operatives, but we are not sure what to expect from them because the same thing is happening everywhere in the country," he said.

AGN's Director of Communications, Monalisa Chinda, broke the news of the kidnap of the actors in a statement made available to newsmen on Friday.

Ms Chinda said their kidnap had increased fear amongst members about the safety of actors filming in the country.

Meanwhile, the Enugu State Police Command has said it has launched investigation to unravel and locate the missing Nollywood actress, Cynthia Okereke.

Police Public Relations Officer of the state, DSP Daniel Ndukwe, made this known on Saturday in Enugu.

Ndukwe said the current report at the disposal of the Police dwells on a case of an abandoned and recovered vehicle, as well as one missing person.

He said the vehicle was abandoned and recovered at Four-Corners on Enugu-Port-Harcourt Expressway, precisely within Ozalla community in Nkanu West Local Government Area of Enugu State axis of the road.

"On July 29, at about 7:30am, we received information that a red-coloured Toyota RAV4 Jeep with registration number AGL 199 CY was noticed to have been parked in an abandoned way at Four-Corners on Enugu-Port-Harcourt Expressway.

"Hence, the location was visited and the vehicle recovered.

"Coincidentally, at about 11:30am, on the same date, a report was further received stating that the vehicle belongs to one Cynthia Okereke (f), a Nollywood Actress, who was last seen on July 26," he said.

Gunmen kill 3 policemen, 5 vigilante members in Kogi

Gunmen have reportedly killed three police officers and five vigilante operatives in Ajaokuta Local Government Area of the Kogi State.

It was gathered that the security operatives were killed while on the trail of some suspects, following a report at the Divisional Police headquarters by villagers that some people were using their farms for criminal activities.

Confirming the killings, the Security Adviser to Kogi Governor, Commander Jerry Omadara (rtd) said that the three police officers and five members of local vigilantes were killed in an ambush on Saturday.

Omadara said that a Divisional Police Officer (DPO), acting on intelligence report that hoodlums had invaded some farms and engaging in illegal activities, mobilised officers in collaboration with local vigilantes and headed for the area.

"They were, however, ambushed and in the process eight of them were killed – three Police Officers and five members of the local vigilantes," he said.

Omadara, however, said that the state government will not rest until the culprits are brought to book

He said that the state government under Alhaji Yahaya Bello has assured the people of the state of adequate government protection and Saturday's incident would not be allowed to repeat itself.

In recent times, attacks by gunmen have become rampant in Kogi state. On Tuesday men of the Nigeria Police Bomb Squad were hurriedly drafted to detonate an object suspected to be an explosive device found in premises of the office of the Secretary to the State Government (SSG) on Lugard road. The explosion created by the detonation of the object created panic in the area.

Also a leaked security memo by the Nigeria Security and Civil Defence Corps (NSCDC) on Monday listed Kogi State among six other States including the FCT that terrorists and bandits have earmarked for attacks in the country

Kwara police dismisses report, warns bandits, criminals to keep off state

Police in Kwara State has warned bandits and other criminals to keep off from the state, saying Kwara should not be seen as one of their bases.

Spokesperson of the Kwara State Command, Okasanmi Ajayi, served the warning in a statement made available to journalists on Sunday in Ilorin.

Ajayi in the said statement

dismissed as fake an intelligence report that some forest reserves in parts of Kwara have been taken over by bandits.

A reports had earlier claimed that bandits were ready to use the forests to launch attacks on Kwara and neighbouring states.

Responding, the spokesperson said, "The command wishes to state categorically that Kwara is safe and secured and no part of Kwara is

occupied by bandits or terrorists.

"The writers and sharers of that fake intelligence report are mischievous, desirous of sowing a seed of distrust and fear in the minds of the good people of Kwara in particular and Nigeria in general.

"This is an attempt to create panic in the minds of peace loving Kwarans, but they have failed."

According to Ajayi, the State Commissioner of Police, CP Tuesday Assayomo, had renewed police and other security agencies' commitment to the protection and the defence of lives and properties of residents.

"Aggressive and extensive patrols have been emplaced in the state, while vigilante groups and hunters have been co-opted in patrolling the forests and bushes.

"Consequently, the good people of the state are advised to give information to the police whenever anything negative or sinister developments is being suspected around their vicinity," he added.

Meanwhile, residents of the state have been enjoined to go about their lawful businesses without fear of attack or intimidation.

Ajayi said that the command would not relent in regular patrols, intelligence gathering and raiding of black spots in conjunction with sister security agencies in the state.

The fight scheduled for August 20 at Jeddah Super Dome in Saudi Arabia already has its undercard fixed. This has further raised the level of expectancy about the hypothetically most debated bout in recent times in boxing history.

According to the fixtures



of the undercard, the undefeated Croatian Filip Hrgovic, with fourteen wins and 12 knockouts, fights China's undefeated Zhilei Zhang, who has a record of 19 knockouts from 24 wins, in a Final Eliminator for the IBF Heavyweight World Title.

While for the Final Eliminator for the World Title with its current champion being Russian Artur Beterbiev, English Callum Smith, with 20 knockouts from 28 wins, tangles with French Mathieu Bauderlique, who has recorded 20 knockouts from 28 wins

Joshua is eager to reclaim his heavyweight championship belts, WBA (Super), IBF, WBO, and IBO heavyweight titles from the Usyk who left Ukraine, presently being ravaged by the Russian army, to honour the challenge activated In principle last year.

"The rematch was specified in the contract," Alexander Krassyuk, Usyk boxing promoter said last year in a press conference.

"It has already been activated in principle, from the side of Joshua."

"So I remember when we discussed with Oleksandr the issue of a rematch, he was delighted and said 'Wow, cool, I will beat Antokha [Anthony] twice," he added.

Both greats will look to share at least £100m in the cracking rematch but what is more pressing is to even or extend their head-to-head record.

Other fixtures for the undercard include Tyron Spong against Andrew Tabiti, Daniel Lapin against Jozef Jurko, Ramla Ali tangles Crystal Garcia Nova, Ziyad Almaayouf battles Hector Alatorre and Badou Jack pitched against Richard Rivera.

Kounde, a defence fixer - Xavi

Barcelona boss Xavi Hernandez has praised Jules Kounde as a good signing who has the needed leadership acumen to lead the defensive line of the Catalans.

Xavi said the defender brings in a competitive challenge in the defensive lineup which is good for the club's target to win titles.

The Spanish manager described the former Sevilla's player as being versatile and can play as a winger as does Ronald Araujo, which is a vital factor in the club's yearnings for success.

According to him, every player will have to fight for a spot in the starting lineup by giving their best performances.

"He is a very good signing, he will help us a lot. When the ball is out, he knows how to fix the central defenders, he has leadership capacity," Xavi said in the preview of the match against the New York Red Bulls.

"With the rest of the defensive line, to compete and try to win titles, which is the main objective.

"He can play as a winger, like Ronald and for him, it means competition, it means a lot to us, the one who performs best will play.

"Like everyone [Pique], everyone is going to compete for a position, the one who gives the most performance will play. And the more options he [Xavi] has, the better," the Barcelona boss reiterated.

Kounde has been on the radar of several European clubs with Chelsea at the forefront of the pursuit of the defender.

West London having lost to a free transfer Andreas Christensen and Antonio Rudiger to Barcelona and Real Madrid respectively swooped into the summer transfer window to beef up its backline They resorted to different alternatives in Italy with Inter Milan defender Milan Skriniar and Juventus Matthijs de Ligt spotted for an imminent move.

Unpleasant to the Blues, the asking price for Skriniar was above the Blues valuation for the player which saw Paris Saint-Germain beat them at the forefront while Dutch De Ligt was snapped to Allianz Arena away from their grips.

Barcelona have been very active in the transfer market swooping on top targets ahead of the start of the new campaign.

The Cataluyan-based club have been able to bolster its attack with the signing of Robert Lewandowski from Bayern Munich and Brazilian Raphinha from Leeds United.

Also advantageous are the signing of Andreas Christensen from Chelsea and Franck Kessie from AC Milan on a free transfers with Jules Kounde the recent addition to a club that have not ruled out further deals.

Xavi said, "Everything that is reinforced is good. I already said that there should be two players per position, more this year with the World Cup.

"We need footballers to compete and to be better. Yes, we want to reinforce ourselves more, the more the better," he added.

Barcelona open the 2022-23 season with a La Liga fixture against Rayo Vallecano in Camp Nou. Last season, the Vallecans defeated Catalans 1-0 on their home ground through a sublime finish by Alvaro Garcia.



Milenkovic's decision over future alerts clubs

Serbian defender, Nikola Milenkovic, has been told by Fiorentina to give his decision about his future.

This resolve by Fiorentina, to the centreback who has a contract until 2023 at Stadio Artemio Franchi, became imperative not to lose him on a free transfer.

Getting wind of the latest resolve by the Purples, European clubs are red on alert to swing in on the 24-year-old versatile defender that also plays in the right-wing-back position.

Atletico, a long-time admirer of the Serbian, would open the option to

secure the signature of the player despite ruling out further transfer deals this summer.

Accuses Bayern of complicity "I feel like I'm in the right position, in the right

Barcelona forward Robert Lewandowski said his move to the Spanish club was the right time to accept a new challenge in his career.

The Pole, who is with the club on their preseason tour, accused Bayern Munich of complicity which was a ploy to thwart the deal from scaling through.

According to the 34-year-old striker on Friday during an interview with ESPN, Bayern Munich exploited all political machinations to hamper negotiation in a bid to justify their position.

"The club tried to find a fight to justify my sale because maybe it was difficult to explain to them.

"And I have to accept this even if there were a lot of lies, a lot of lies about me. They were false things, but in the end, I know that the fans, even in this period, are still very supportive of me," he added.

The Pole joined Bayern Munich eight seasons ago from Borussia Dortmund and netted 344 times in 375 appearances to win many Bundesliga titles and the UEFA Champions League alongside domestic accolades.

He continued: "Some people don't tell the truth, they say something different. For me, it was always important to be clear, and honest, and perhaps for some, this was a problem.

"In the end, I know that I realized that if something wasn't right with myself either, then maybe It was a good time to leave Bayern and sign for Barcelona," Lewandowski added.

He admitted that he is excited to seal the deal that has presented a new challenge where he hopes to score more goals and do what he knows how to do best.

Mathys Tel joins Bayern on five-year deal

German champions Bayern Munich have secured the services of Stade Rennes' striker, Mathys Tel on a fiveyear deal to keep him at Allianz Arena until 2027.

Having lost star striker Robert Lewandowski to Barcelona this summer immediately after signing CAF player of the year Sadio Mane from Liverpool, Bavarians are on a campaign to bring in fresh additions to the club.

According to the report on Tuesday, the 17-year-old who captained France U17 national team in February 2022 in his debut, was signed circa 30 million euro to become the fifth signing this summer for Bayern Munich

In a statement by Hasan Salihamidzic, the club's board member on sport, he described Tel as a talented player and divulged that the Frenchman has been under the club's watchlist.

Salihamidzic stated that several clubs were in a race to sign Tel but Bayern Munich were able to convince the striker who grew through the youth ranks of Stade Rennes to feature 7 times last season in Ligue 1.

"Mathys Tel is one of the biggest talents in Europe, a very quick, technically strong and versatile striker," Hasan Salihamidzic, said.

"We've been watching him for a long time, and we were able to convince him to take his next important steps in Munich with us now," he added.

He continued: "The development of such an exceptional young player is an exciting project for us all. Of course, Mathys needs time, he needs minutes on the pitch and rhythm





Emirates reduces flights to Nigeria over trapped \$85m revenue

mirates Airlines has plans to its reduce to Nigeria flights from August 15, 2022, due to its inability to repatriate trapped amounting revenue to \$85 million in the country.

The airline said it has no choice, but to reduce the flights from Dubai to Lagos from 11 to seven per week to mitigate the con-tinued losses it is experiencing as a result of the situation.

Emirates made this known in a letter dated July 22, 2022, signed by the Divisional Senior Vice President (DSVP), International Affairs, Sheikh Majid Mualla and addressed to the Minister of Aviation, Hadi Sirika.

"Emirates will be forced to reduce flights from Dubai to Lagos from 11 per week to seven per week. We have had no choice, but to take this action to

mitigate the continued losses Emirates is experiencing as a result of funds being blocked in Nigeria.

"As of July 2022, Emirates had \$85 million funds awaiting repatriation from Nigeria. This figure has been rising by over \$10 million monthly, as the ongoing operational costs of our 11 weekly flights to Lagos and five to Abuja continue to accumulate," the letter reads.

It said the funds were urgently needed to meet its operational costs and maintain the commercial viability of its services to Nigeria, adding that it could not continue to operate at the current level with mounting losses, especially in the challenging post-COVID-19 pandemic climate.

Emirates further explained that it tried to stem the losses by proposing to pay for fuel in Nigeria in naira, which would have at least reduced the costs, but the suppliers denied

the reques

"This means that not only are Emirates' revenues accumulating, but we also have to send dollars to Nigeria to sustain our operations, while our revenues are out of reach and not earning any credit interest.

"This decision was not taken lightly. Indeed, we have reached out to the Central Bank of Nigeria (CBN) to find a solution to the issue. Our Senior Vice-President met the Deputy Governor of the CBN in May and followed up on the meeting through a letter in June.

"However, no positive response was received. Meetings were also held with Emirates' own bank in Nigeria and in collaboration with the IATA to discuss improving FX allocation, but with limited success," it stated.

Emirates disclosed that despite several efforts, the situation continued to deteriorate, and is now in the unfortunate



position of having to cut flights, to mitigate further losses going forward.

"While we appreciate that this issue is primarily a financial one, any support you could

kindly provide would be warmly welcomed by Emirates. We are confident that your valuable involvement will make a real difference in improving this very difficult situation," the letter added.

The airlines further noted that if there is any positive development where it can have access to funds soon, it will re-evaluate the decision and revert to normal operations.

Intelligence operatives arrest 4 informants behind Kuje prison attack

Four informants suspected to be leaking information to terrorists about troops' locations and movements around the outskirts of Abuja have been arrested.

The criminals are already in the custody of a security agency.

But an intelligence operative told PRNigeria that the suspects were arrested with sophisticated equipment including Walkie-Talkies, revolvers, knives, amulets, and old Chinese made phones, that do not use data.

The source, who was part of the raid

that led to the arrest of the informants, said discreet investiga-tions are ongoing to confirm their leaders and financiers.

The source claimed that activities of the terrorist collaborators were responsible for the recent attacks around the vicinity of the Federal Capital

Territory (FCT).

"The suspects are currently being interrogated to determine if they are working for terrorist groups or armed bandits or other elements with ulterior motives.

"I can authoritatively inform you that, while the military has deliberately refused to provide updates since the attack on Kuje Prison, to last attacks on troops at the Bwari and Zuma Rock axis, the joint se-curity task force has so far killed more than 70 armed criminals, including dangerous Kuje prison escap-ees and terrorists," the source

added

Meanwhile, that gathered Intelligence Defence Agency (DIA) coordinating a discreet intelli-gence operation that is providing new clues and traces of groups behind attacks security personnel and
