

# Govt declares emergency over oil theft

inister of State for Petroleum Resources, Chief Timipre Sylva, has disclosed that the country loses 400,000 barrels of crude daily to oil theft, describing the development as a 'national

emergency.' Sylva, who stated this when he visited the State Governor, Imo Hope Uzodimma at the Government House, Owerri, lamented that the country had fallen short of the Organsaition of Petroleum Exporting Countries (OPEC) daily quota, from 1.8 million barrels to 1.4 million barrels due to crude theft.

He warned that such huge economic loss was capable of crippling the nation's economy, if not given proper attention and expressed concern that the menace had persisted in spite of efforts by the Federal and state governments to end it.

Sylva said the challenge of crude theft could not be handled in Abuja alone, adding: "It is a national

the theft has worsened because most of theft takes place in the host communities of oil pipelines. As a result, it has become necessary to involve the stakeholders, especially the communities.

"Due to the seriousness and orchestrated nature of the menace, Nigeria could not take advantage of the opportunities in gas production, because no investor would want invest where there incessant insecurity vandalism infrastructure."

Sylva, who appealed the stakeholders to collaborate in tackling the menace, commended Uzodimma for his efforts in ensuring that Imo remained safe, while safeguarding the state's

economy.

Also speaking, Chief of Defence Staff (CDS), Lucky Irabor, thanked Uzodimma for supporting the Armed Forces in the fight against rising criminality in the oil-producing areas of the South East region.

Irabor urged the state government, stakeholders and communities to be actively involved in the fight against oil theft and leave the rest for the army and assured the governor that the army was ready for more assistance in the



fight against banditry and other criminality in the state and entire country.

Responding, Uzodimma, who assured that his administration would sustain checking efforts economic sabotage being perpetrated by pipeline vandals, described the consequences of crude theft as very alarming and too much to be tolerated.

He added that the problem did not only result in the reduction of oil revenue for the Federal Government, but also created environmental pollution and other health hazards for the host communities.

He, therefore, called for cooperation among federal and state governments, NNPC and host communities to effectively fight the scourge, adding that the meeting was part of the nationwide intervention efforts to curb crude oil theft.

Uzodimma commended the NNPC for the 200bed capacity hospital the company was building at the Imo State University Teaching Hospital, Orlu and appealed to the company to facilitate the project and ensure its timely completion.

Others on the entourage were the Minister of State for Education, Gooduck Opiah, Group Managing Director of NNPC Mele Kvari. Limited. traditional rulers

and representatives of oil producing communities in the state.

On his part, Governor Douye Diri has assured Bayelsa State's collaboration with other stakeholders to tackle oil theft, saying it poses serious threat to the to the Niger Delta and the entire country.

He stated this at House, Government Yenagoa when the Federal Government delegation led by Sylva visited the state on Monday.

Diri, who noted that oil theft had affected the environment and image of the region negatively, canvassed urgent actions to end the ugly trend in the interest of the region and entire country.

In a statement issued by his Chief Press Secretary (CPS), Daniel Alabrah, the governor lamented that oil theft, which also affects government at all levels, has denied the local communities their means of livelihood, stressing that if not stopped or reduced drastically, the implications would be grave.

Recalling how the Chief of Defence Staff (CDS) discussed governors on the issue, Diri stressed the need for collaboration between the states and the Federal Government to tackle the menace and assured that

his administration would play its role to ensure that the menace is tackled effectively.

His words: "The federal and state governments largely depend on oil. So, oil theft does not affect only the federal government. It affects us as a state government and the local governments. We have spoken about this over and over and we will continue to say it.

'We are talking about our environment that has been brazenly polluted through oil bunkering activities. If you go to our communities, you will see oil floating on our rivers, and that has led to the locals not having a means of livelihood. It has led to unknown diseases and sicknesses.

"There is a spiral effect of oil theft that is going on in the Niger Delta and it affects the communities and the people. So, I assure you that we will collaborate to ensure an end to oil theft.

Speaking, Sylva said the team visited the state to seek collaboration with a view to ending oil theft in the Niger Delta, adding that stealing of oil was going on at an alarming rate and should no longer be tolerated given its negative effects on the country's economy.

Sylva, a former governor of the state, who lamented that production has been badly affected, which is also having negative to

## Delta community protests over abandoned road project

Residents of Onicha village in Ubulu-Uku town, Aniocha South Local Council of Delta State, have embarked on a peaceful protest over the deplorable state of Onicha-Uku/ Onicha-Ugbo Road. They urged the Economic and Financial Crimes Commission (EFCC) to re-open investigation on the alleged misappropriation of N245 million, released for the rehabilitation of the road.

The road, which links them to Abuja, Lagos and Asaba was awarded in 2015. The community also called on the State Governor, Senator Ifeanyi Okowa, the Niger Delta Development Commission (NDDC) and the World Bank to come to their rescue before erosion sweeps the entire community away. The present state of the road, according to

the placard-bearing protesters, has brought untold hardship, after the state and federal governments have abandoned them to their fate. They had to resort to unsustainable self help efforts.

Secretary of the community, Osaji Ephraim Iwebunor, who read the content of a save- oursoul letter, alleged deceit on the part of officials of the NDDC, who he said pretended to be working on the road only to disappear sooner or later.

He said: "In 2019, some persons came to parade themselves as workers who came on instructions of the Senator representing Delta North, Peter Nwaoboshi, who incidentally was representing us in the NDDC Senate Committee at the time. The workers came with their tools, including bulldozers and other equipment. Few days after loitering around,

the workers disappeared with their tools.

"We later found out that the so-called workers appeared in our community to give impression to the EFCC team visiting Delta State at the time to investigate some NDDC abandoned projects, that work was in progress.

"Regrettably as you can see, the only access road to our community, which is like express road to other communities, especially Onicha-Ugbo, in Aniocha North, Edo State, even Delta State capital, Asaba, is in a very deplorable condition. We have been totally cut off from other communities, even in the same town, Ubulu-Uku.

"It is no longer news that our elderly, the sick, non courageous, weaklings and our children can not attempt to access the road, as passing through is like walking through the valley of death."

### Why Edo raised minimum wage, by Obaseki

Edo State Governor Godwin Obaseki has said the increment of the state's minimum wage from N30,000 to N40,000 as well as payment of the harmonized pension to retirees was to provide succour to workers and pensioners who are overburdened with the weight of the harsh economic realities in the country.

Obaseki, who stated this while addressing journalists in Benin City, said the state government remains committed to the welfare of workers and will sustain policies and programmes to ensure that the workers are adequately empowered to deliver quality service to Edo people.

Governor Obaseki had on 2022 Workers Day announced the payment of harmonized

pension to retirees in the state after 21 years, as well as the increment of the minimum wage in the state from N30,000 to N40,000.

The governor said, "I want to assure workers in the state that, as a government, we feel their pains. We know that things are tough and wish we had more resources as a state government for our people.

"The N40, 000 minimum wage we introduced was because of the pain our people are facing."

He added, "This was not when dollar was N700; it was when the dollar was still N400. So, you can imagine how the hardship of workers has progressed or is progressing.

"As a government, we will join you to do everything possible to make sure that we get those who are in charge and those who are responsible for managing this country at the national level to stop this

Hailing workers in the state for their continuous support to the government, Obaseki said, "We have enjoyed tremendous goodwill from Edo workers. It is on record that no strike or protest has been embarked by any of the unions against our administration, except it is politically motivated. I am not sure that there is any government outside this state that boasts of such records."

"This has been made possible by all Edo workers because of the trust they built with us and by the grace of God, we will not betray that trust," the governor reassured.

# New twist on East-West Road repair

ven as the 10 kilometer **⊢** Eleme junction to **⊿**Trailer Park stretch of the East-West road has badly deteriorated following return of the rains, the repair program enunciated by the federal government remains hazy.

Following agitation by stakeholders within the Eleme-Ogoni axis who are regular users of the road which culminated in the blockage of the road in protest for about one week in 2021, the federal government through the Ministry of Niger Delta Affairs had moved to repair the road and commissioned Reynolds Construction Company, (RCC) as contractors to take up the project.

But after a while that the RCC mobilized to site, the company pulled

out unceremoniously.

However, the then
Minister of Niger Delta Ministry, Senator Godswill Akpabio later said that the magnitude of the project which cost he put at about N85 billion was too heavy for the ministry to carry, explaining that the Federal Ministry of Works had taken over the project and listed it to be funded from the Federal Infrastructure Development Fund Program.

But last Friday, the Managing Director of Nigeria Ports Authority, (NPA), Mohammed Bello Koko said that NPA was interfacing with the new minister of Niger Delta ministry, Umanah Okon Umanah with a view to exploring ways to fix the road from Oil Mill to Trailer

Bello Koko who disclosed this in an interactive forum with stakeholders of Onne Port at the port complex conference hall assured that government would do everything possible to ensure that the Ease of Doing Business policy of the federal government impact positively on the operations at the port.

The MD's attention had been drawn to the deplorable state of the road by one of the stakeholders at the meeting who urged the NPA authority to drive the repair of the road since it is the main gateway to the port and impacting very negatively on the business of stakeholders at the port.

If the revelation by the MD that he was interfacing with the new minister of Niger Delta ministry for the repair of the road is to be taken seriously as it should, then what becomes of the take- over of the road by the Federal ministry of Works which

Is it the case of inter agency rivalry or duplication of functions to get some private pockets well padded? Some analysts have been alleging that the same portion of the East-West Road has become a piece of cake for some unscrupulous government

Almost every year, one form of patchwork or the other takes place on the road, sometimes by companies that can hardly boast of modern tools for a road of such importance to the socio-economic well being of the nation.

Now the question begging for answers is at what point was the take- over by the ministry of works reversed, and has the Niger Delta ministry suddenly become so buoyant that it can now afford a whopping N85 billion needed to put the road into shape which it had earlier said it could not afford? Or was Akpabio being economical with the truth about the ministry not having the financial muscle to do the road?

Analysts are also wondering whether this is another befuddling rigmarole by the Buhari administration to keep passing the buck until it exits power next year.

The stories surrounding the road repair are strange as they are heart breaking. One of the stories making the rounds currently is that the arrow heads of the agitation last year who caused the road to be blocked for one week have been 'settled' to abandon the struggle.

This may not be far from the truth if the body language and reaction of some of the dramatis personae now are anything to go by. When the action (road block) was on, one would say from the seeming uncompromising stance of the people that nothing could make them yield to any lure of the lucre, more so given the hardship people go though daily on

What is baffling also is that the Executive Chairman of Eleme Local Government Council, Chief Obarilormate Ollor who championed the struggle by providing logistics for the protesters throughout the duration of the protest has suddenly gone dumb and dodging interviews. He would not respond to calls nor react to whatsapp messages where the reasons for the calls were explicitly stated for him to even say something without any physical contact.

With the passion the

chairman spoke last year about the hardship people, particularly his subjects in the local government area go through on the road, one would think and believe that he would not hesitate to remobilize the protesters to occupy the road once again as he had hinted then.

Hear the chairman, "Immediately I was sworn in as chairman, I made a press conference where I complained bitterly of what has been happening, even before I was sworn in as chairman where there have been series of protests against the Federal Government by our people, youth groups, different political groups, women organizations so many times for the past 10 years concerning this road and its deplorable state.

"All of you know that what we have on this road is completely reprehensible. So what happened was that I had to give a 14 day

ultimatum to the Federal Government. The 14 days expired on the 2nd of July, 2021. After that, we gave another 2 weeks of grace and the youths kept prevailing on me to shut down the entire stretch of this road.
"I had no option than

to allow that action take place last Monday, 25th of July, 2021. A lot of persons have died, business owners have lost their businesses, containers and trucks have collapsed, investment is threatened in our LGA which is supposed to be an investment destination. So the action pleased all those who are investors. We have been here for 7 days." That was excerpts from the chairman's speech while announcing the suspension of the road blockade last year following assurances by federal government through then minister of Niger Delta, Senator Godswill Akpabio that the

Apparently enraged by the failure of government to fulfill the pledge to commence work on the road, the chairman at a meeting with critical stakeholders in the transportation sector early this year informed them that another action on the road was imminent and gave till end of February for FG to commence construction work on the road or face the wrath of the people.

"We cannot watch our people suffer continuously as a result of the insincerity and irresponsibility of the Federal Government and its agencies. It is very clear that as we get closer to the electioneering period, the Federal Government would shift attention from infrastructural development and focus on campaigns. Therefore they have to fix the road as they promised before election or nobody will have access to that road", the council chairman threatened.

This is August and in September campaigns would commence to confirm the fears of the chairman that the campaign and election-eering would overshadow every other program of government. Yet not even a whimper can be heard from him again.

On the aspect of the youths, hear Legborsi Yamaabana, President Ogoni Youths Federation, (OYF) who was one of the arrow head of the protest. 'The Ogoni axis of the East West road is the only link to the Port Harcourt Refining Company, Indorama Petrochemicals, Nigerian Ports Authority Onne, Oil and Gas Free Zone Onne and about 300 multinational companies.

"Despite the aforesaid, and the huge economic value of the road, the Federal Government has refused to fix it, thereby inflicting hardship on our people and commuters. We have suffered for too long. Enough is enough! History is on our side; God is on our side," he bellowed while justifying the protest and why the youths blocked the road.

Amidst all the red eved threats, one year after, the condition of the road has degenerated with most commuters abandoning the road and seeking recourse through community roads adjacent to the dilapidated road. All the people and groups who threatened fire and brimstone if the road was not done have strangely kept mute, suggesting that there might have been some 'oiling' of palm to take the pressure off the government.

But the reality is that the anguish on the road has gone out of hand as commuters are now forced to abandon the vehicles they boarded and trek long distances to escape the frustrating, long labyrinthine traffic jams that have become a daily feature on the road particularly near the Indorama junction and going beyond the archaic bridge linking Eleme-Ogoni axis to the port Harcourt

city.
"You can imagine what would be the fate of anyone being rushed to the hospital on medical emergency with this kind of situation on this road. Wouldn't the person die here?, one the persons trapped on the road was heard asking a colleague seated with him in a car.

As it appears, everyone seems to have resigned to fate, wishing and hoping that government will graciously turn its eyes to the all important road and do the needful. Will they?

## Akeredolu confirms arrest of Owo church attackers

He noted that the Ebiras have lived together with the people of the state peacefully for several decades, adding that they have always been supportive and hardworking. He said:

"Now that the military has announced it, I can tell you that five of them have been arrested now. They are still on the trail of the rest. The home where they lodged in Owo and the person that accommodated them before the attack, has also been arrested.

"We did not spare a moment. I am happy that the Chief of Defence Staff has announced it. We have known for a while but we needed not to come out with it because more works are still ongoing. I can confirm that this arrest has been made. And they are still on the trail of some of them. I want to use this medium to urge our brothers to concentrate on their farming trade. It will be unfortunate to know that the Ebiras in our midst are now involved in the kidnapping. We are appealing to them not to copy bad things. The traders selling by the roadside should not become informants. We are not fighting them.

"We have seen their numbers, they supported and voted for us during elections. I will call their leaders and talk to them. Our brothers who were kidnapped on their way to Ikare, talk to them. They were taken to Ebira farmsteads. For me, we have lived together for too long for this to happen. I am ready to make any effort to ensure that the conviviality that we have enjoyed continues. But we are begging their leaders to urge them not to copy bad things. They are in our midst , we are surrounded by them. The issue of security is key and it's dynamic," Governor Akeredolu noted.

# Bad policies kill 50 manufacturing firms in seven years

Investments in the manufacturing sector has reduced by 56 per cent in seven years, while 50 firms have shut down since 2017 due bad government policies and economic headwinds.

Data compiled and released by the Manufacturers Association of Nigeria (MAN) showed that Surest Foam Limited, Mufex, Framan Industries, MZM Continental, Nipol Industries, Moak Industries and Stone Industries and others are among manufacturing firms that have closed operations in the last five years.

Investments by those still surviving have decreased from N489.44 billion in 2016 to N217.22 billion in 2021, the data further revealed.

Chairman Qualitek Industries, a major player in the aluminum and steel sector, Oluyinka Kufile, said:

"How many companies in our sector are still in operation? Wempco has shut down, WAHUM is struggling and the rest are just there bidding time. When we come for meetings, we will not be more than 11

companies."

Kufile blamed the development on a combination of bad government policies, arguing that Nigeria was yet to understand 54 per cent from N197 its true direction towards to the dollar to N425 in economic diversification.

The economy witnessed two recessions between 2016 and 2021, one caused by foreign exchange (forex) problems and the other by the COVID-19 pandemic.

Economic and financial analysts say federal and state governments have responded poorly to the economic challenges in the country.

Insecurity has worsened in the five years, while forex crisis have increased, with the naira depreciating as much as the official market and over N700 at the parallel market over the period.

The situation has been further exacerbated by Ministries, Departments and Agencies (MDAs) of government focus on revenue collection and do not bother to ease business for 41.5 million micro, small, medium businesses and other larger enterprises.


# University Education: The chickens have come home to roost

resident Muhammadu Buhari recently gave a 2-weeks ultimatum, which has since expired, for the negotiating parties to resolve the Federal Government-ASUU imbroglio. Some of us who had been in the educational sector long enough and had witnessed the aberrations knew it was a tall order and more fittingly, an impossible condition. This is not because the matter cannot be resolved in less than two weeks but because it was clearly discernible that the parties involved and other stakeholders in university education have not been telling ourselves the bitter truth. The closest to uprightness was the statement by the Honourable Minister of Labour that the Federal Government does not have the funds to meet its obligations in the agreement signed with the Unions, and that the country is broke. How else can one explain a 2009 agreement that is still begging for implementation in 2022? What is the assurance that a follow-up agreement in 2022 will be implemented before another 13 years (2035), if the prevailing conditions remain unaltered?

I struggled within me in deciding whether to send my modest suggestions covertly to the major parties involved or put it in the public domain. I have however come to the conclusion that it will serve greater public good with the latter approach since virtually all Nigerians are stakeholders. The unwary public has the right to know what is responsible for this seemingly intractable challenge, the ultimate solution and what should be their role in resolving the issues. It is embarrassing that the current ASUU strike which began on 14th February, 2022 has again been "rolled over" for another 4 weeks. Other staff Unions on our campuses (SSANU, NASU and NAAT) have not fared better. The last ASUU strike in 2020 lasted for nine months and from all indications, the current strike may last longer. Must we continue this way? Is incessant strike the solution to the decadence in the educational system? Have the strikes been effective or of any overall benefit to the stakeholders? The answer to all these questions is ambiguous and clearly dependent on the side to which the individual belongs.

ASUU embarked on the current strike to press home its demands for; the renegotiation of the ASUU/FGN 2009 agreement, deployment of UTAS to replace IPPIS, release of the reports of Visitation panels to federal universities, funding for revitalization of public universities, earned academic allowances, poor funding of State Universities and promotion arrears. I have not been privileged to read the Nimi Briggs Report but snippets in the newspapers and other information outlets indicate that a major part of the report is increment in salary. Nigerian lecturers are now the poorest paid in Africa and it is obvious that such a system can never retain the best. We know from the Minister of Labour, Employment and Productivity, Dr. Chris Ngige, that the Nimi Briggs Committee proposed "109 to 185 per cent increase in the University wage structure", and that "the Federal Government will incur an additional N560 billion as salaries alone". The Minister has opined that negotiating with ASUU without simultaneously doing so with other university-based unions only delays the strike as it would not achieve a quick resolution of the issues. The Minister at several for has also declared that Nigeria is broke (saying the obvious!) and that the Federal Government does not have the funds to meet its obligations in the agreement signed

with the Unions. He has therefore called for renegotiation of the terms of the Agreement with ASUU, in the effort to end the ongoing strike by University staff.

If we continue this way, the negotiations are unlikely to record any significant achievement.

Emeritus Professor Nimi Briggs (Pro-Chancellor, Alex Ekwueme Federal University, Ndufu-Alike Ikwo), chairing the current negotiating Panel and other members of the panel are reputable and highly revered individuals with very deep insight of university education. They have over the years proven their devotion and total commitment to the growth and development of higher education in the country. However, the fact remains that they have to work within the ambit of their terms of reference. The Committee inaugurated on March 7, 2022 had three months to conclude the renegotiation of the 2009 FGN/ASUU agreement and, as expected, it submitted its report on schedule. However, the efforts of the 7-member renegotiating team now appear to be inadequate in resolving the present impasse, reopening our universities and keeping our campuses functional. It will be necessary to know the suggestions proffered by the Renegotiating Committee on how the Federal Government would source the funds to meet the proposed salary increase.

Another major grouse of ASUU and the other staff Unions with the Federal Government is the introduction of the Integrated Payroll and Personnel Information System (IPPIS). The IPPIS is domiciled in the Office of the Accountant General of the Federation (OAGF). The IPPIS project, which commenced in 2007, centralises the payment of salaries and wages directly to the bank accounts of all federal government employees in Nigeria. It is one of the major issues that led to the 9-month strike by the ASUU in 2020, and the follow-up industrial actions by SSANU and NASU early in 2021. The challenges of IPPIS are enormous for all stakeholders and especially for the Universities. Due to the peculiarities of the Universities, there are major challenges with the use of IPPIS. Most of these are, to all extent and purposes, human problems. The scheme has become an albatross bedeviling the tertiary education system in the country, and further undermining the autonomy earlier enjoyed by the Universities. Interestingly,

while the Unions are agitating, University administrators are lukewarm about the use of IPPIS because it has shifted the heat and agitations on salaries and wages from the campuses to Abuja. Instead of ASUU insisting on the use of University Transparency and Accountability Solution (UTAS), and the Joint Action Committee of the Non-Academic Staff Union of Educational and Associated Institutions (NASU) and the Senior Staff Association of Nigerian Universities (SSANU) marketing the University Peculiar Payroll Payment System (U3PS), relocating and shedding the control of IPPIS for Federal Universities to the National Universities Commission (NUC) will be a fair compromise. My opinion!

The peculiarities of the University system (such as sabbatical leave, appointment of expatriate staff and other practices necessary to internationalize and make a university world-class can then be continuously built into the IPPIS software domiciled in NUC. It could ideally be referred to as IPPIS-U. I do not expect ASUU to agree with this suggestion just as I also would not expect the Federal Government to concur. This is because ASUU is known to fight "until the last man" for a just cause and on the part of the Federal Government, egos of those who have maintained the "IPPIS or nothing" stance may be bruised. However, for the sake of the system and to bring some stability to our universities it appears to me to be the best solution and gladiators must at this point sheath their swords. The unending expectation of a positive outcome from the integrity test by the National Information Technology and Development Agency (NITDA) for both UTAS and U3PS should be a source of worry to all Nigerians. We have had enough of IPPIS politics! No software, no matter how robust, would eliminate the negative factors identified with IPPIS, particularly if some of the operators are attuned to selfish and dishonest pursuits, and offenders are not severely and promptly punished. The very best financial accountability software in the world can always be compromised but such occurrences are minimized where and when there are active deterrents. It is time for the stakeholders in the education sector to now come to "reason together" and stop acting in silos and fiefdoms. Government must declare an emergency in the

education sector and all critical stakeholders must now dialogue, and come to amicable and reasonable solution. Truth be told, this is not the time for negotiations spanning months, it smirks of insincerity or failure to grasp the enormity of the problem. While not ignoring the letter and spirit of the Trade Dispute Act on resolution of industrial actions, I will propose that the Government conveys an expanded assembly of critical stakeholders, and not just the Ministries and the Unions, to deliberate and take critical decisions that will move the education sector forward, and ensure that our students, who have been at home for five months, resume immediately. The meeting should have representatives of; the core Ministries (Education, Labour, Finance, and Science and Technology), the staff Unions (ASUU, SSANU, NASU and NAAT), the students, National Salaries and Wages Commission, Head of Service of the Federation, Accountant-General of the Federation, and the Tertiary Education Committees of the Senate and House of Representatives. The Federal Ministry of Education/National Universities Commission should coordinate the meetings which ideally should be chaired by the Minister of Education. If discussions at such a forum is open and sincere, it will be possible to chart a new course for University education in the country and forestall any future strikes and closure of our higher institutions. We all know the truth but, we must now allow the truth to set us free.

A quick background information on the current financial contribution of students in our Federal Universities will shed some light on the insincerity pervading the system. Allow me to use Obafemi Awolowo University as an example. The students still pay N90, with N2,500 maintenance fees, per session for accommodation even in situations where the session extends beyond 12 months. The N90 is the same amount I paid as a student in the same University in the 1970s. The cost of the receipt issued for the payment is probably more than the amount paid and it would have been more "economical" for the university if offered free! The charging of "fees" is not supported by the Federal Government but in OAU, undergraduate student pay "Departmental charges" of N5,000 per session for Arts, N10,000 for Sciences, Social Sciences, Technology and Law, and N15,000 for Medicine and other courses in the Health Sciences. These charges were fixed over 20 years ago and the uproar that followed has ensured that it remained the same.

OAU with a student population of about 25,000 runs an annual Personnel budget of approximately N10 billion. This in essence means N400,000 per student per session will double the personnel budget. Of course, it will be ridiculous to expect that all students must pay the same amount of fees. It may mean payments of between N200,000 and N600,000 per student per session depending on the course. This is nowhere near the N900,000 to N3,000,000 per session that students pay in most private universities today. Students would be charged based on the standard staff-student ratio and the number of lectures per course, with a standard fee fixed for each lecture. A personal experience would suffice. I was in a . University in South Africa, as Visiting Professor, in 2002 and the Department could not deliver a lecture because it fell on a Public holiday that was never envisaged. It was the last week of formal lectures, just before the examinations, and the department had to negotiate with the students to find a suitable time.



### Senator Adeola dabbles into Ogun APC crisis, says Amosun can't play God

- Wants former governor sanctioned for anti- party activities
- APC on the verge of losing Ogun if crisis not resolve Hon. Azeez

chieftain of the All Progressives Congress (APC), Hon. Niyi Azeez has tasked stakeholders in the Ogun State chapter of the party not to fold their arms and watch the party goes into flames.

His plea was predicated on the dangerous dimension the crisis in Ogun APC is taking.

## EFCC arraigns three over alleged N44.5m fraud in Sokoto

The Economic and Financial Crimes Commission (EFCC) on Tuesday said its Sokoto Zonal Command has arraigned the duo of Yahaya Abdulrahman and Mohammad Iliyasu alongside their company, Azzumee Multipurpose Cooperative Society, before Justice Mohammed Mohammed of the Sokoto State High Court on a three count charge bordering on criminal conspiracy, issuance of a dud cheque in the sum of N4,859,000.00 and obtaining by false pretence.

EFCC spokesperson, Wilson Uwujaren, who disclosed this in a statement said suspects are alleged to have fraudulently induced the petitioner to supply 1,651 bags of rice to their company at the cost of N27,000.00 per bag, totaling N44,577,000.00 and jointly issued cheques of N14,359,000.00 in the name of the petitioner, which was returned unpaid due to insufficient funds standing to the credit of the drawer.

According to Uwujaren, count one reads, "That you, Yahaya Abdulrahman while being the Chairman of Azzumee Multipurpose Cooperative Society, Mohammad Iliyasu while being a Director and Vice Chairman of Azzumee Multipurpose Cooperative Society and Azzumee Multipurpose Cooperative Society sometime in November 2020 at Sokoto within the Judicial Division of the High Court of Justice, Sokoto State did conspire among yourselves to commit an illegal act to wit: Criminal Breach of Trust and thereby committed an offence contrary to Section 59(a) of the Sokoto State Penal Code Law, 2019 and punishable under Section 60(2) of the same Law."

He further disclosed that count two reads, "That you, Yahaya Abdulrahman while being the Chairman of Azzumee Multipurpose Cooperative Society, Mohammad Iliyasu while being a Director and Vice Chairman of Azzumee Multipurpose Cooperative Society and Azzumee Multipurpose Cooperative Society sometime in March 2021 at Sokoto within the Judicial Division of the High Court of Justice, Sokoto State with the knowledge that you have insufficient funds in your account issued to one IMUDAN Ventures a Stanbic IBTC Bank cheque number 00000061 dated 5th March 2021 for the sum of N4,859,000.00 (Four Million Eight Hundred and Fifty-nine Thousand Naira) which said cheque when presented was dishonored due to insufficient funds in your account and thereby committed an offence contrary to Section 1(1) (a) of the Dishonored Cheques (Offences) Act, CAP

D11, Laws of the Federation of Nigeria, 2004 and punishable under Section 1(1) (b) of the same Act."

All the defendants pleaded not guilty to the three-count charge. Consequently, the prosecution counsel, S.H Sa'ad prayed the Court to allow the hearing to commence as two witnesses were in Court, ready to testify. However, the defence counsel, Y.Y Bazawa urged the court to grant his clients bail.

Justice Mohammed granted the defendants bail in the sum of N5,000,000, 00 and one surety each in like sum.

According to the Judge, the sureties must be residents of the Sokoto metropolis and own landed property in the city. Also, the sureties are to deposit a passport photograph each with the registrar of the Court.

The Judge adjourned the matter till 26th September 2022 for trial

# EFCC arrests 29 alleged internet fraudsters, secures conviction of 11 in Ibadan

The Economic and Financial Crimes Commission (EFCC) has said its operatives in the Ibadan Zonal Command have arrested no fewer than 29 suspected internet fraudsters in a sting operation at Omi-Adio area of Ibadan, Oyo State.

Wilson Uwujaren, the spokesperson for the Commission, said in a statement on Tuesday that the suspects were arrested on Wednesday, August 3, 2022, noting that items such as mobile phones, laptops, two motorbikes, one i-watch, video games, and jewelry were recovered from them.

He said, "Operatives of the Ibadan Zonal Command of the Economic and Financial Crimes Commission, EFCC, on Wednesday, August 3, 2022, arrested twenty-nine (29) internet fraud suspects in a sting operation at Omi-Adio area of Ibadan, Oyo State.

"The suspects are Abdullahi Kehinde Tawab, Ayomide Alase Abiodun, Hassan Larla Olamilekan, Makinde Adebowale Saheed, Tofunmi Oyebade Segun, Rotimi Gbadamosi Ayomide, Igbamidun Joshua Olamiposi, Gbadamosi Samson Tobiloba, Qodir Ayoola Babalola, Frank Obi Ogechukwu, Olawale Abowaba Joshua, Dauda Kareem Oladayo, Hammed Dauda Akanji, Yusuf Akorede Abiodun and Haruna Adedoyin Kayode.

"Others include Yusuf Lawale Raji, Adejare Ayuba Olamide, Owolabi Gbadamosi Moses, Victor Salami Gbenga, Abdullahi Teslim Taiwo, Oluwaseun Abowaba Samuel, Alase Ayodele Philip, Oduola Kunmi Ireola, Ajayi Olumide Olamilekan, Opeyemi Samuel Enitan, Yusuf Ayobami Qudus, Atanda Jamiu Olamide, Ibrahim Bashit Alade, and Ilori Peter Oladapo.

"Items recovered from them include mobile phones, laptops, two motor-bikes, one i-watch, video games, and jewelry."

Uwujaren added that the suspects would be arraigned in court as soon as the investigations are concluded.

Meanwhile, the Ibadan Zonal Command of the EFCC, on August 3 and 4, 2022 secured the conviction of eleven (11) cyber criminals on separate charges of fraudulent impersonation before Justices Olusola Adetujoye and Bayo Taiwo of the Oyo State High Court sitting in Ibadan.

The offences are contrary to Section 419 and 484 of the Criminal Code Law Cap 38, Law of Oyo State, 2000.

According to Uwujaren, Justice Adetujoye convicted and sentenced the fraudsters, Fatai Musbau Opeyemi, Ayodele Olumide Sunday, Oribolawa Idris Abiodun, Abdulahi Malek Olaniyi, Onigbinde Rasaq Oyindamola and Emmanuel Victor Mayowa to various jail terms; while Justice Taiwo convicted Moses Oyowevotu Oghenaire, Awwal Babatunde Arekemase, Adewale Ayomipo Owolabi, Yusuf David Olamide and Atitade Hassan Ajao.

The defendant pleaded "guilty" to the charges filed against them by the EFCC, leading to their conviction and sentencing.

"Justice Adetujoye sentenced Oyindamola and Abiodun to six months community service each; Mayowa who was convicted on a two-count charge bagged three months jail term while Opeyemi, Sunday, and Olaniyi were sentenced to three months community service each.

"Furthermore, Justice Taiwo sentenced Oghenaire, Arekemase, Owolabi, Olamide, and Ajao to six months of community service each," Uwujaren said.

According to him, the court also ordered that the convicts restitute their victims and forfeit all items recovered from them to the Federal Government of Nigeria.

### **Court convicts internet fraudster in Lagos**

Justice Oluwatoyin Taiwo of the Special Offences Court sitting in Ikeja, Lagos has convicted and sentenced an internet fraudster, Yusuf Adetokunbo, for offence bordering on possession of documents containing false pretence.

The Lagos Zonal Command of the Economic and Financial Crimes Commission (EFCC) secured the conviction on August 8, 2022.

Adetokunbo was arraigned by the antigraft agency on a one-count charge on July 22, 2022. The charge was on possession of documents containing false pretenses contrary to Section 320 of the Criminal Law of Lagos State, 2015.

According to a statement by the EFCC

spokesperson, Wilson Uwujaren, on Tuesday, the convict was accused of involvement in fraudulent chats with the intention to defraud unsuspecting members of the public.

"That you, Yusuf Olawale Adetokunbo on or about the 29th April, 2022 at Lagos, within the Ikeja jurisdiction of this Honourable Court with the intent to defraud had in your possession a bundle of fraudulent chats containing false pretence in your Google voice app and email with the name phamhoangcungnai30@gmail. com which pretence you knew or ought to know to be false," the count read.

Adetokunbo pleaded "guilty" to the charge when it was read to him.

Consequently, the EFCC prosecuting counsel, Nnaemeka Omewa, thereafter gave a review of the facts.

Omewa further tendered in evidence the fraudulent documents printed from his iPhone X and iPhone 6+, as well as a draft of N200,000 issued as restitution by the defendant.

There was no objection by the defence counsel, Kayode Oyedele, and they were admitted as Exhibit A and B.

"We urge the court to convict the defendant as charged and to forfeit to the Federal Government the items recovered from him," Omewa told the court.

In his ruling, Justice Taiwo convicted Adetokunbo as charged and sentenced him to six months at a Custodial Centre, with an option of N150,000 fine. Items recovered from him were also ordered forfeited to the Federal Government.

### EFCC busts suspected fraudsters hideout in Lokoja, nabs 18

The operatives of the Ilorin Zonal Command of the Economic and Financial Crimes Commission (EFCC) have busted a hideout of suspected internet fraudsters popularly known as 'Yahoo-Yahoo' in Lokoja, the capital city of Kogi State, arresting 18 suspects.

The spokesperson for the Commission, Wilson Uwujaren made the disclosure in a press statement on Tuesday, saying the move is part of the efforts of EFCC to curb the rising tide of internet-related fraud.

According to Uwujaren, the operatives of the Ilorin Zonal Command of the Commission had in June 2022 arrested 19 suspected fraudsters at different raids in Lokoja.

He said, "As part of efforts by the Economic and Financial Crimes Commission, EFCC, to

curb the rising wave of internet-related fraud otherwise known as 'Yahoo-Yahoo', the Ilorin Zonal Command of the Commission has again extended its dragnet to Kogi State leading to the arrest of 18 suspected 'Yahoo-Yahoo Boys' in Lokoja, the state capital.

"This is the second such operation in the State within the last two months. Operatives of the Ilorin Zonal Command of the EFCC, had in June 2022 arrested 19 suspected fraudsters at different locations in Lokoja.

"The latest arrest, which was made on Wednesday, August 3, 2022 followed actionable intelligence received by the Commission.

"Among the suspects are two siblings - Bala Caleb Abdulkarim and Ayuba Bala. Others are Adebayo Olubunmi, Yusuf Salawu, Victor Yakubu, Victor Udeh, Abutu Francis, Moses Akeji, Aiyegbe ThankGod, Eniola Adeniji, Abraham Ayodele, Julius Omowale, Samuel Onojah, Saka Usman Ojo, Isaac Emmanuel, Yusuf Mohammed, Ibrahim Musa and Omaonu Ojochenemi Victor.

"Preliminary investigations have shown that the suspects operate as a syndicate to scam unsuspecting victims."

Uwujaren further disclosed that incriminating items like exotic cars, phones, and laptops were found in the possession of the suspects.

"The suspected 'Yahoo-Yahoo Boys', had incriminating items in their possession including five different brands of exotic cars, phones, and laptops. They have volunteered statements to the Commission and will be charged to court upon the conclusion of the ongoing investigations," he added.

# Tobi Amusan at World Athletics Championships: good news for Nigeria

he spirit of bleakness which had enveloped our dear country in recent times was lifted somewhat two weeks ago when Tobi Amusan set not one but TWO new world records in the women's 100metres hurdles at the 2022 World Athletics Championship held in Oregon, USA . She set the first record in the semi-finals, finishing the race in 12.12 seconds; only to break that record and set a new one in the finals when she finished in an incredible 12.06 seconds, bringing home the gold. But for Amusan, Nigeria would have returned home from the competitions with nothing to show. Amusan won us the gold and allowed us to return home in glory, our heads high that our own had won.

These are not the only achievements attributed to our prodigy. She is the first Nigerian athlete to win a Diamond League Trophy; this was in 2021. She was a Silver Medalist at the 2013 African Youth Championship in Warri. In 2014, she won silver at the African Youth Games in Botswana and gold a year later in Ethiopia at the Under-20 Championships. She had a breakthrough victory at the All-Africa Games in Brazzaville, Congo and in 2016 was awarded a scholarship to the University of Texas at El-Paso.

Tobi Amusan's feat is a refreshing piece of good news for Nigerians in these bleak times. It is heartwarming, in a country bedeviled by insecurity, poverty and every bad thing in between, to have something to celebrate. And not only is her achievement worth celebrating but her life as well, which is a story of grit, hard work and determination – a true inspiration.

Tobi, a remarkable young woman from Ijebu Ode was not born with a silver spoon in her mouth. Her parents were both teachers who took education seriously. Her father, in particular, was skeptical of her involvement in sports, fearing that it may lead her nowhere. But Tobi's heart was in sports and was not to be deterred. With her mother's encouragement, Tobi fought her way to where she is today.

Her journey to success was not without its disappointments. She consistently came fourth in her races, the winners' podium eluding her grasp; but she never lost faith in herself. Indeed, in 2016 she wrote in a post: "Unknown now, but soon I will be UNFORGETTABLE ... I will persist until I SUCCEED ..." and, just the night before her record shattering performances, she wrote "Incoming record holder". Tobi's attitude is

an example of what a strong belief in oneself and one's abilities can do in a person's life. Despite her failure to win in previous races, she never accepted defeat. She continued to believe in herself and she continued to push hard. Her tenacity is remarkable. The result is her smashing success at the Championship. This is indeed the spirit of true champions!

In an interview, Amusan disclosed that her career really took off after she got the scholarship in Texas. This is the story of many a Nigerian athlete, getting better opportunities and training abroad. This is unfortunate. The Nigerian Sports Ministry needs to step up to its responsibilities. Nigerian youths have proved time and again that they have everything it takes to succeed if only their country was willing to give them a chance and the necessary support. It is disheartening that a beacon like Amusan will be allowed to feel that another country gave her a better chance than her own. This is a big shame on the Sports Ministry and on the Nigerian government. So many promising young sportsmen and women are out there fighting hard on our dilapidated sports fields and stadia, needing only the smallest push to emerge as stars on the world stage but we keep allowing this promise to slide between our fingers. Brazil made its name in football, why can't we in other sports and athletics?

But we must not give up. We at The Trumpet call on Nigerian youths to take Amusan's story as an inspiration, not only in sports but in everything they do. She is an example of how hard work, determination and a strong sense of self-worth can take one anywhere in the world and help to achieve one's dreams. We congratulate Tobi Amusan. Nigeria is proud of this daughter who has lifted our heads and lightened our hearts with a spark of good, uplifting news in these troubling and troubled times.

# Exposed: The real Peter Obi

in the era of his lame duck Presidency. In the third Schedule of the Constitution, Section B states that The Council of State shall comprise the following persons- the President, who shall be the Chairman; the Vice-President, who shall be the Deputy Chairman; all former Presidents of the Federation and all former Heads of the Government of the Federation; all former Chief Justices of Nigeria; the President of the Senate; the Speaker of the House of Representatives; all the Governors of the States of the Federation; and the Attorney-General of the Federation.

The Council shall have power to-advise the President in the exercise of his powers with respect to the-national population census and compilation, publication and keeping of records and other information concerning the same, prerogative of mercy, award of national honours, the Independent National Electoral Commission (including the appointment of members of that Commission), the National Judicial Council (including the appointment of the members, other than ex officio members of that Council), and the National Population Commission (including the appointment of members of that Commission); and advise the President whenever requested to do so on the maintenance of public order within the Federation or any part thereof and on such other matters as the President may direct.

Between January 20, 2019 and April 21 this year, the National Council of State did not hold any meeting. When the Council met on April 21, the Council pardoned 159 persons. Till date, the gazette on the pardon of the affected persons had not been released. Since President Buhari got to power on May 29, 2015, no Nigerian has been given National Honours.

The last time such honours were bestowed on distinguished Nigerians was on September 10, 2012 by the then President Goodluck Jonathan, GCFR. Does that mean no Nigerian deserved to be honoured President Buhari? If we are to go by the provisions of the Constitution, giving out National Honours and the prerogative of pardon, is obligatory.

For a start President Buhari has no

The Federal Government's borrowing from the Central Bank of Nigeria has jumped to N23trillion.

The amount as it currently stands is a 2,701 per cent increase under the administration of President Muhammadu Buhari when compared to N648.26 billion it stood as of June 2015 a month after coming to power.

The Federal Government takes loans from CBN through the Ways and Means Advances facility used to finance the government in periods of

temporary budget shortfalls subject to limits imposed by section 38 of the CBN Act, 2007.

Breakdown of CBN data published on its website shows in 2021 alone the government turned to the apex bank for a loan of N4.34 trillion to push its total debt to N17.45 trillion. Another N704 billion was borrowed in January 2022. A breakdown from CBN data shows that as at the end of 2015, CBN loan to the government stood at N856.33 billion before increasing to N2.23 trillion in December 2016.

The amount grew by N1.08 trillion in 2017 to N3.31 trillion. It rose further by N2.1 trillion in 2018 to N5.41 trillion. Government borrowing from the CBN surged by 61.18 per cent (N3.31tn) to N8.72 trillion at the end of 2019. Borrowings hit N13.11 trillion in 2020 after FG collected another N4.9 trillion to plug its fiscal financing gap.

As of now, the economy is getting

As of now, the economy is getting worse and worse daily. It is clear that the economic strategy of President Buhari is not working. The issue of the failed Economy is affecting all Nigerians as of today. Every home in this country is feeling the pinch.

Terrorists attack Niger community, ki By PAUL MICHAEL, Defence Editor, Abuja

Terrorists popularly known bandits have attacked Saminaka community, along Lapai-Lambata Road in Lapai-Lambata Niger State, killing Alhaji Muhammad Kudu Adamu, Coordinator, Federal Inland Revenue Service (FIRS) in charge of Zamfara, Sokoto and Kebbi states and abducting three others.

Dr Zubairu Ibrahim, who is a friend of the deceased, disclosed this to newsmen while saying Adamu was killed when he was returning from Lafiagi, his hometown in Kwara State, where he had gone to greet his relations who just returned from the pilgrimage to Mecca, Saudi Arabia.

According to him, Adamu and the three other occupants in the vehicle ran into the bandits who shot indiscriminately in their direction on Sunday evening.

It was gathered that two tankers loaded with Premium Motor Spirit and parked by the roadside were also hit by bullets and engulfed in fire.

Saminaka is a busy community along Lambata-Bida Road where dozens of tankers and heavy articulated drivers and other travellers

The Niger State Police Public Relations Officer (PPRO), DSP Wasiu Abiodun, confirmed the attack and said three persons were kidnapped while two tankers caught fire.

He said the attack occurred around 10:30 pm on Sunday. Abiodun said the bandits invaded a restaurant in Saminaka and abducted its owner, Zainab Usman, and two others.

Also, the Chief Imam of Saminaka, Alhaji Umaru Mohammed, told newsmen on the telephone that the bandits chased a woman into the Mosque during Quranic teaching and abducted her alongside the deputy chief

"When they wanted to shoot her in the Mosque, the deputy chief imam started deputy chief imam started pleading with them and one of them said he should also be taken along. Luckily, they (bandits) entered a shop opposité the Mosque where they sell mobile phones and started packing phones. It was in that process that the deputy chief imam escaped but they went away with the restaurant owner and two of her workers," he said.

Mohammed said restaurant had been attacked twice in two years, adding that boy named Mohammad,

was also hit by a bullet in his shoulder and was taken to a hospital.

According to him, the vehicle in which the FIRS official was travelling was also hit by a stray bullet but the driver of the vehicle was able

to escape.
A community leader, who pleaded anonymity, lamented that the area which extends from Old Gawu to Yaba in Abaji Area Council had been very dangerous due to mountains and a thick forest that served as shelters for criminals.

He said, "Sometimes, they do send their informants to communities to work as labourers who study the environment and get back to them before they attack. The Abaji Area Council has posed a serious threat to our communities.

"They have kidnapped many people in our area. A few weeks ago, they invaded Rafin-Daji village and kidnapped 15 farmers including four women on their farms. One of the tractor drivers was killed and one of the two tractors with which they were working was set ablaze. They were released after collecting N3 million for

each person as ransom.

"We also spent N400, 000 in buying bags of rice, wraps of Indian hemp, cartons of noodles, packs of cigarettes and other hard drugs that they noodles, demanded. The victims spent about two months before they were released.

"Also recently, six people were kidnapped in a village very close to us. They were released after the payment of ransom. The village head that was among the victims had his legs and hands broken before they released them.

Meanwhile, residents in the area decried the absence of security operatives despite the incessant attacks and

kidnapping. "There are no armed security personnel in our area. There are policemen but you won't see them with guns. The attacks were beyond the strength of our vigilantes," a resident said.

### Former governors Dariye, Nyame freed from prison

Federal Capital (FCT) Command Territory of the Nigerian Correctional Service (NCoS) has released two former governors, Joshua Dariye and Jolly Nyame, as well as three others from custodial centres.

Public Relations Officer of the Command, Chukwuedo Humphrey, Monday, disclosed this to Journalists in Abuia.

According to Humphrey, the letter of their release was sent to the command by the Presidential Prerogative of Mercy Committee on Monday.

He said that the two former overnors were pardoned on ill health and age grounds and were released immediately, but did not disclose the names of the three others

"We have no right to hold them further as soon as we have the letter of clemency from the presidency

"If we do, it will be against fundamental human rights.

"They have left the facility today. We got the warrant of release today and have done the needful.

"Dariye and Nyame were in Kuje custodial centre while the three others were in Suleja custodial centre," he said.

Recall that the ex-governors were among the 159 prisoners pardoned by the Council of State during a meeting presided over by President Muhammadu Buhari in Abuja on April 14.

Jolly Nyame, 66, governor of Taraba from 1999 to 2007, was serving a 12-year jail term at the Kuje prison over misappropriation of funds while he was in office.

In a similar manner, Joshua Dariye, 64, who governed Plateau between 1999 and 2007, was also jailed for corruption during his time as governor.

### Police warn cultists against unlawful gathering in Osun

properties.
"Therefore, the Commissioner of Police has given a marching order to the Area Commanders, Divisional Police Officers (DPOs), and Tactical units to be at alert and nip in the bud any act capable of

truncating the peace of the state.

"Also, hoteliers, recreation/ event centers, and landlords/ event cerucis, and landladies are, by this mannement, warned not he to allow their facilities to be

used for any cult-related activities/meetings, of such facilities are liable for prosecution.'

The CP advised parents and guardians to caution their wards to be law-abiding and desist from any act or unlawful gathering and assembly before, during, and beyond the said date while warning that any individual found in contravention of the warning would be arrested and prosecuted.

"Finally, the citizens are urged to be security conscious, vigilant, co-operate and collaborate with the security agents by giving useful, credible, and timely information and report any suspicious movement or activities of cultists and other criminals through these numbers: 08039537995, 08123823981 and 08075872433," the statement

# Situating bakers' alert to another hike in bread price

Last week, Premium Bread Makers Association of Nigeria (PBAN, once again addressed the media to alert members of the public about planned increase in the price of bread due to the several challenges facing the sector daily. It said the move was aimed at intimating bread consumers ahead of the increase, prompting JOHNMARK UKOKO to ask whether another hike in the price of bread is necessary, as the economy takes a toll on ordinary Nigerians.

Bread remains one of the oldest and commonest food items all over the world, as the product predates the birth of Jesus Christ over two thousand years ago. It is a staple food item taken by majority of people, but especially by the masses, as it should be available and accessible to all and sundry in all climes and countries.

To stress the importance of bread and fish, the scriptures told a story of how Jesus Christ and his 12 disciples fed and a multitude that followed Jesus while on earth with five loaves and some fish.

In most Arab countries and some Latin America countries, the citizens of those countries have sent their government packing because bread price was increased by few Shillings or little amounts.

In the time past labourers in Nigeria live on bread and beans alone daily to carried out their daily shores.

In times past in Nigeria, pupils and students from poor homes practically, live on bread to survive.

In times past, when Nigerians travel back to their country's side, one item they must buy home in large quantities to share for their kit and kin or simply put, their kinsmen and other relatives is bread.

The product was so cheap and sold everywhere that it was taken for granted until the Russia-Ukraine conflict started.

Since the beginning of the conflict in late February 2022, the price of the product that was usually taken for granted, as the food of the poor has increased by over 300 per cent.

Last week, precisely on August 5, 2021, the umbrella body of the bread bakers had during a media briefing where the news was once again broken in quick succession, lamented that the commonest food for ordinary citizens has suddenly become like a precious gold.

Chairman of the Premium Bread Makers Association of Nigeria (PBAN), Emmanuel Onuorah, broke the news that the association was proposing to increase the price of bread for the umpteenth time this year due to rising cost of baking materials

He noted that the recent development in the global market place had not translated to a better operating environment for local bakers.

The planned hike followed a recent strike by members of PBAN and the Association of Master Bakers and Caterers of Nigeria, which culminated in a 15 per cent hike in the price of bread about three weeks ago.

Onuorah said most members of the association had been forced to close down their business operations this year due to increasing cost of doing business, maintaining the price of bread had to increase just as millers and sugar refiners have increased their prices by over N2,000.

"We had an increase of over N10,000 between three weeks ago and last week. We have no other option, but to increase our prices again within a few days. The price of preservatives has also increased by N2,000, while the price of butter has risen by over N2,000. So, we have to respond accordingly to remain in business.

"For us as an industry, our own is garbage in, garbage out. If the price of wheat reduces, certainly we will look at the price of our products and also act accordingly," Onuorah said.

He also appealed to the Federal Government to open up foreign exchange (forex) window for the sector and industry players, particularly the flour millers, saying this would significantly address the indiscriminate increase in the prices of flour in the market.

"When we withdrew our services, flour was sold for N28,500 per bag, but as of Friday, August 5, 2022, the price had increased to N30,500," he further lamented.

Although the PBAN leadership has good grounds to contemplate another increase in the price of bread less than two months after the last hike, most Nigerians are asking whether only Russia and Ukraine are producing wheat and flour in the whole world.

"What happened to the

cassava bread experiment that was promoted by former President Olusegun Obasanjo's administration through the Federal Industrial Institute Research Organisation (FIIRO) about a decade and half ago? Does it mean that despite the huge amount of money the Obasanjo administration gave FIIRO to ensure that the country depended less on wheat importation simply ended in private pockets?

On many occasions, Obasanjo and FIIRO assured Nigerians then that the country would no longer be at the mercy of the foreign wheat producers, the Russia and Ukraine conflict has shown that Obasanjo and FIIRO did not tell Nigerians the entire truth.

While the impact of the Russia-Ukraine war is being felt in Nigeria and other African countries, the warring countries signed an agreement to ship over 20 million tons of grain stuck in Black Seaport, through an agreement brokered with support of the United Nations (UN) and Turkey, which Secretary General of the UN, Antonio Guterres, described

as an unprecedented accord between both countries.

Does it also mean that the Minister of Agriculture and Rural Development did not render any account in the ministry's avowed assistance for local wheat farmers?

It is also curious to observe that all intervention grants the Central Bank of Nigeria (CBN) claimed to have given local farmers through its Anchor Borrowers Programme (ABP), which gulped trillions of naira did not include local wheat farmers.

The CBN forex crisis has dealt a big blow to all sectors of the country's economy, especially the importation of machineries, raw materials and other production inputs, but exactly the country reached the current situation beat everyone's imagination, as some politicians and their family members continue to easily access dollars, which they spray in parties.

The PBAN also cited the current price of diesel, which now sells for between N800 and N1,000 per litre depending on the location, as one of the main

reasons why the association is contemplating price hike. But in all, the Buhari government and the successive administrations are to be blamed for the country's present situation.

No doubt, diesel is the main energy source in Nigeria as the successive administrations have been unable to repair, or even built and turn around the country's comatose refineries.

When the likes of Chad, Republic of Niger are building and refining enough diesel for their local consumption and export, Nigeria, which prides itself as the giant of Africa and with all the abundant natural gas and crude oil reserves, has failed to do so.

While some Nigerians have urged the Federal Government to support and hasten completion of the Dangote Refinery, it remains a sad reality that Aliko Dangote is about to achieve what the government and over 200 million Nigerians could not do

The other issue, is while Nigerians await the Dangote Refinery to come on stream to refine petroleum products for the country, what happens to the modular refineries, which Vice President Yemi Osinbajo encouraged during his visit to the Niger Delta some time ago?

Does it mean that after six years of the Vice President's pledge, the modular refineries were still in the drawing board as none of them have commenced refining crude oil? If Nigerians are unable to buy rice, beans, garri, semovita and now bread, what do the authorities expect the people to eat?

Onuorah and members of PBAN may increase the price of bread in response to skyrocketing prices of flour, sugar, butter, diesel and worsening forex exchange crisis, but Nigerians are asking whether if and when the Russia and Ukraine war ends, the prices will ever revert to the pre Russia-Ukraine war rates?

They also wonder whether Nigerians will be able to afford bread again with the way the PBAN has been increasing the prices of bread every month. Only time will tell!

### FG's indebtedness to CBN hits \$47 billion

Indications have emerged that Nigeria's indebtedness to the Central Bank of Nigeria has reached \$47 billion or an equivalent of N20 trillion even as the obligation has not been added to the country's outstanding public debts.

This was revealed by a recent report on the official website of the Budget Office, which provided details of the country's expenditure plans for 2023-2025.

It hinted that the country's outstanding public debt is now in excess of N41.6 trillion and that even with the additional obligations, the country remains within its self-imposed limit of 40 per cent dept to Gross Domestic Product (GDP).

It also revealed that the Federal Government plans to securitise its ways and means advances from the CBN and upgrade it into a longer-tenor amortised facility at a lower interest rate.

According to the Budget Office, the Federal Government earlier declined that it barely earned enough revenue to cover payments for debt servicing in 2021, adding that government income amounted to only N1.63 trillion in the first four months

Minister of Finance, Budget and National Planning, Zainab Ahmed, said expenditure was less than N1.94 trillion needed to cover debt servicing, adding that while the debt portfolio remains vulnerable to revenue and exports shock and that the government was trying to address the issue through strategic revenue growth initiatives.

# Why Buhari approved Seplat's acquisition of \$1.283 billion Mobil share capital

•Nominates Executive Commissioner for Upstream Regulatory Commission

President Muhammadu Buhari has endorsed the granting of ministerial consent to Seplat Energy Offshore Limited, a subsidiary of Seplat Energy cash acquisition of Mobil Producing Nigeria Unlimited's (MPNU) share capital of its shareholders, Mobil Development Nigeria Incorporated (MDNI) and Mobil Exploration Nigeria Incorporated (MENI), being entities of Exxon Mobil Corporation (ExxonMobil) registered in Delaware, United States of America (USA).

As announced on February 25, 2022, Seplat Energy agreed to acquire the share capital of MPNÛ for \$1,283 billion and \$300 million contingent consideration.

The transformational transaction would create one of the largest independent energy companies on the Nigerian and London Stock Exchanges and boost Seplat Energy's ability to drive growth, profitability and stakeholder prosperity.

The approval was given by President Buhari in his capacity as substantive Minister of Petroleum Resources, with the granting of ministerial consent pursuant to the powers of the minister under paragraphs 14, 15 and 16 of the first schedule of the Petroleum

A separate announcement from the State House, Abuja was released earlier on the development in a letter through which the President directed the Minister of State for Petroleum Resources to convey ministerial consent to all relevant parties.

The stakeholders are the Nigerian Upstream Petroleum Regulatory Commission (NUPRC), Nigerian National Petroleum Company Limited (NNPC), ExxonMobil companies, the Federal Competition and Consumer Protection Commission (FCCPC), Seplat Energy and Seplat Energy Offshore Limited, among others.

The President further directed that the Minister of Petroleum Resources shall ensure that the ExxonMobil and Seplat Energy operating entity, being the MPNU, carries out operatorship of all the Oil Mining Leases (OMLs) in the related shallow water assets to optimise production in support of Nigeria's quota of the Organisation of Oil Producing Countries (OPEC) in the short-term, as well as ensure accelerated development and monetisation of the gas resources in the assets for the Nigerian economy.

Responding, the board and management of Seplat Energy thanked President Buhari for

the ministerial consent on the landmark acquisition of the share capital of MPNU.

Meanwhile, the News Agency of Nigeria (NAN) reports that President Buhari has forwarded the name of Muhammad Sabo Lamido to the Senate, as Executive Commissioner, Finance and Accounts, for the Nigerian Upstream Petroleum Regulatory Commission.

Senior Special Assistant to the

President on Media and Publicity, Femi Adesina, confirmed this in a statement in Abuja on Monday.

Buhari, in a letter addressed to President of the Senate, Ahmed Lawan, said Lamido was nominated due to the death of Hassan Gambo, who occupied the position until his demise and therefore, urged the Senate to confirm the nominee "in the usual expeditious manner."

# Again, bakers threaten to hike prices of bread

Premium Bread Makers Association of Nigeria (PBAN), the umbrella body of bakers in the country has concluded plans to increase the prices of bread for the umpteenth time this year due to the skyrocketing cost of baking materials.

President of the association, Emmanuel Onuorah, said the recent developments in the global market place had not translated into a better operating environment for local bakers.

The planned price hike follows a recent industrial action by the PBAN as well as the Association of Master Bakers and Caterers of Nigeria, which culminated in a 15 per cent hike in the price of bread barely two weeks ago.

Onuorah said many of his members had been forced to shut down business operations this year due to the skyrocket-

ing cost of doing business.

The price of bread is going up again. The Millers just increased prices by N2,000.

Sugar refiners increased by N2,000, we had an N10,000 increase in the last two to three weeks.

We are set to increase the prices of our bread again. Preservatives has increased by N2,000 and butter has increased by N2,000, so we have to respond. For us as an industry, our own is garbage in, garbage out. If the price of wheat comes down, certainly we will look at the price of our products and act accordingly," he assured.

Onuorah appealed to the federal government to open up a forex window for industry players, particularly the flour

This, he said would significantly address the indiscriminate increase in the prices of flour in the market, adding: "When we went on withdrawal of services, flour was N28,500 as of Tuesday, August 9, 2022, it is N30,500," Onuorah.

It would be recalled that

on July 22, 2022, Russia and Ukraine signed an agreement to free more than 20 million

tons of grain stuck in Ukraine's Black Seaports, the agreement brokered with support from the United Nations and Turkey, was projected to have major implications on global good security and food prices.

The inability of Ukraine to export grain from its Black Seaports had severally reduced the supply of food to import dependent African and Middle Eastern countries.

Before the war in Ukraine, Ukraine had a breadbasket, providing wheat, maize and barley to countries, throughout Asia, Africa and the Middle East.

A baker, Sunday Ighotemu, who spoke to The Trumpet, also lamented the rapid increase in the price of flour.

According to him, bakers now had to review prices on a weekly basis in order to recoup costs and maintain profit margins, adding: "A bag of flour now sells for N30,000. That was on Friday, August 5, 2022. Who knows if it has increased again by now?

We have to review prices

regularly. People don't want to understand, but we are all in this country and we know what is going on in the economy.

Ighotemu said the bakers were not happy over the regular increase in the price of bread, adding that they also feel the pains of Nigerians and that the constant increase in the price of bread had reduced the demand and sale of the product, as most Nigerians could no longer afford bread.

"PBAN as an association is not happy with the situation in our industry. At the beginning of the year, we didn't imagine that by early August, the price of bread would have increased for four times, but that is the situation we find ourselves.

"The Russia-Ukraine war and scarcity of foreign exchange (forex) in the last three months have impacted negatively, not only in the bakery sector, but also the entire economy of Nigeria," Ighotemu said.

Monarchs, others back Umana, urge FG, IOCs to release \$5.6 billion owed NDDC

Traditional rulers and youth groups from the nine states of the Niger Delta region have urged the Federal Government and international oil companies (IOCs) operating in the region to release the \$5.6 billion being owed the Niger Delta Development Commission (NDDC).

They said paying the money would allow the Minister of the Niger Delta Affairs, Umana Okon Umana, to reposition and implement the commission's newly developed roadmap, adding that at the last count under the tenure of the former Minister, Godswill Obot Akpabio, the NDDC was owed about \$5.6 billion and another N649 billion by the multinational oil companies.

"Umana's newly developed roadmap to achieve the commission's core mandate may not work if the NDDC is not removed from its life support approach, because what the commission receives every month is only enough to pay employees' salaries and office maintenance," they stated.

The stakeholders, comprising traditional rulers, chiefs, women and youth leaders, in a statement issued by its Secretary-General, Chief Anthony Loveday, noted that the call on the Federal Government and the IOCs was necessitated by the short time left for the President Muhammadu Buhari administration and the reality that the roadmap developed by Umana could not be implemented without proper funding

They also restated their support for the rebranding of the commission to enable it to serve as a vehicle for driving the socio-economic development of the region.

"The leadership must understand that time is of the essence, as millions of people in the region are languishing in abject poverty. Therefore, the Federal Government should match its words with action and release the funds owed the NDDC, as well as direct the multinational oil and gas companies to release the money owed the commission.

"We support the new policy directions and the expected rebranding of the commission under Umana's leadership. We await the Federal Government to release the funds for the expected reforms to commence. We expect the reforms to lead to sound decisions on various issues affecting the Niger Delta region, including the completion of the East-West road and review of various infrastructure development projects across the region.

"The Presidency should as a matter of urgency, grant the NDDC powers to award new contracts to enable the it to provide communities in the nine states of the region empowerment and entrepreneurship training programmes to alleviate the sufferings of the people and ensure payments of verified and completed contracts before the expiration of President Buhari's tenure," the statement reads.

The stakeholders also commended Umana and management team at the NDDC for prioritising projects execution and payments that deliver most impact for the region and their new focus on execution of security, health, education, water and road infrastructure projects

infrastructure projects.

The equally backed the minister's directive that further award of contracts on water hyacinths in the Niger Delta region should be suspended, while all such ongoing projects should be reviewed.

# Stakeholders kick as FG plans to raise tax on telecoms services, others

There are indications that the Federal Government has concluded plans to begin the implementation of its proposed excise duties on telecommunications services and beverages from the 2023 fiscal year.

The Budget Office under the supervision of the Minister of Finance, Budget and National Planning, Zainab Ahmed has assured that the plan will start in 2023 and last till 2025, adding that it was in the Medium Term Expenditure Fiscal Strategy Paper, which was released recently in Abuja.

She explained that this was in a bid to boost the country's non-oil revenue streams, adding that it was expected that excise duty revenue would grow exponentially due to the introduction of charges on telecommunication services.

Discussing the tax under the purview of the Nigeria Custom Service (NCS), she said the NCS would introduce a framework for recovering duties, taxes, as well as appropriate fees and transactions conducted through electronic platforms.

Explaining the strategies that would be implemented to improve customs revenue collections between 2023 and 2025, the minister said full implementation of the excise duty would apply to telecoms services, alcoholic drinks, sugar, sweetened beverages, cigarettes and other tobacco products.

It would be recalled that the introduction of the excise duty on telecoms services was against the backdrop of opposition to the move by the Minister of Communication and Digital Economy, Prof. Isa Pantami and the Manufacturers Association of Nigeria (MAN).

Pantami, who stated this during the maiden edition of the Nigerian Telecommunications Indigenous Content Exposition organised for developing the indigenous telecoms sector, said the ministry slammed e five per cent tax on telecoms services.

He said: "The ministry of communications and Digital Economy is not satisfied with any effort to introduce excise duty on telecommunication services. Beyond making our position known, we will go behind the scenes against any policy that will destroy

the digital economy sector. We will go to any extent to legally defend its interests."

However, the Ministry of Finance, Budget and National Planning had attributed the main reason behind the introduction of the excise tax on telecommunications services to the dwindling revenue against increasing government expenditure, which had resulted in huge deficits pending finance through huge borrowings.

"Revenue generation remains the major fiscal challenge of the Federal Government. The systemic resources mobilisation problem has been compounded by recent economic challenges and for sustainable development, the Federal Government has instituted the strategic revenue growth initiative to improve revenues and entrench fiscal prudence with emphasis on achieving value for more.

"The measures include improving the tax administration framework, including tax filing and payment as well as the introduction of new and or further increase in existing pro- health taxes like excise on sugar, sweetened beverages and tobacco products," he added.

However, mixed reactions have trailed the Federal Government's plans with many respondents rejecting the move saying it is one tax too many, maintaining that when implemented, the tax would further increase the operations for telecoms companies, worsen the local manufacturing challenges and increase the prices Nigerians will have to pay for the services.

## Customs, brokers allege extortion, delays by NPA, NCS at Onne Port

Clearing agents under the aegis of the Association of Nigeria Licensed Customs Agents (ANLCA) have decried delays and extortions by officers of the Nigeria Customs Service (NCS) and the Nigerian Ports Authority (NPA) at the gate of Onne Port in Rivers State.

The clearing agents, who operate at the eastern ports, accused officers of both agencies of serious infractions through their nefarious activities during

the three-day working visit of ANLCA officials led by the Acting National President, Dr. Kayode Farinto, to the eastern port last week.

They maintained that the most frustrating experience for freight forwarders was the delay of consignments duly cleared from the oil and gas customs command, but which were delayed alongside conventional cargoes from the Onne Port at the gate by customs officers.

They also lamented that the delays and illegal packing fees attracted N25,000 daily from the NPA

Speaking at the meeting, Chairman, Calabar Chapter of ANLCA, Dr. Ohabuchi Uchecukwu Magnus, who stated that containers duly cleared at the Onne Oil and Gas Free Zone were usually delayed for several days by customs officers, lamented that the situation has created serious challenge for the clearing agents at the port.

Also, Chairman, Oil and Gas Zone of ANLCA, Okere Chinyere, said it took a minimum of 30 days to move bulk containers from the port due to lack of customs personnel to escort the consignments, explaining that as a result of the delays, freight forwarders

were running at a loss due to huge demurrage charges being incurred.

Her words: "It will take an agent who has bulk containers to clear, who loaded 100 containers going to Kano a minimum of 30 days to clear all the containers because Customs rations consignments in five.

"So before the 100 containers will leave the port you have incurred demurrage because NPA charges N25,000 each day they stay in the port after the first two days free grace period. As such, most times we finish the without even making money for ourselves and customs officers are living large."

She also lamented that the oil and gas customs command still extort cargoes at the Onne Port gate as such oil and gas consignments, which are urgently needed by operators are often delayed alongside conventional cargoes.

She pleaded with the leadership of ANLCA take up the issue with management of the NCS for the customs officers not to kill their business.

On the issue of multiple alerts, she accused the customs, especially at the Port of generating multiple alerts to extort them and called on the ANLCA leadership to also

intervene on the matter.

Also speaking, Chairman of Onne port Chapter of the association, said a member loaded truck and for good five months, customs officers did not allow the truck to go out.

Speaking on the other challenges affecting the eastern zone, Chairman of Airport Chapter Area I, Charles Onyeama, who lamented the issue of the low volume of cargoes at the eastern port, particularly at the Airport chapter, added that there were no more jobs and that the MSC Shipping Company has practically relocated from the area.

He said this was due to the fact that the Port Harcourt Airport was not a certified airport, as such international airlines do not patronise, a situation which is making the agents to lose cargoes that would have been coming to the port.

Responding, Farinto promised to engage the various government agencies to tackle some of the challenges members of ANLCA were facing.

He also asked them to be compliance and law-abiding in their activities, so as to be able to challenge any government agency that might trample on their rights, while carrying out their daily business operations.


#### Q: How did you become an actor? Was it by coincidence or by choice?

A: Initially the plan was not to become an actor, although I've always wanted to perform on a stage or in front of a camera from when I was pretty young. I mean as young as age seven, I was already mimicking the characters I saw on TV. But I really decided to be an actor after secondary school. I left secondary school as a science student but realised a few years after that I wasn't cut out to be a scientist. I wanted to be a doctor or a pilot in the army. In fact at some point, I wanted to be too many things. So I thought to myself, how can I be all these things? I decided to become an actor. I went to the university to learn performance.

### Q: Who or what were your early influences?

A: My earliest influence was Patrick Cargill who played Patrick Woodford in the British comedy many 'Wives of





### Q: Would you regard Patrick Diabuah as a lover boy?

A: Lover boy, well, I know I like women and I respect them and will never treat them as "a play thing". I can be smooth if I decide to be, but I think I'll reserve that side for stage and screen.

### Q: How do handle romantic roles?

A: Romantic roles have always been the most difficult for me to play. I believe it's because of its subtlety, but then it has to be big enough for the viewers to feel it and yet authentic enough for them to believe it. So what I do most times is build trust with my scene partners. So I start off by knowing who my partner is, what they like. Basically we just become friends. It's easier for me, to play romantic roles with a friend, than a complete stranger

#### Q: So how easy was it for you blending knowing that you are coming from stage?

A: It wasn't easy at first but you know having that stage partner that we were trained on the stage to be large, to be very big. It wasn't easy but I got over it after first two days of shoot.

#### Q: Is there any other dream role that you would love to play?

A: I have always wanted to join the army but my mother prayed it out of my brain, I will like to do more of action, do more of stunts like I said it has always been my dream as a child and these things are driven just by the desire to just change the world

#### Q: What do you look out for the most before accepting a script?

A: I know it would be cliché to say I look out for a good story, but yes I do look out for a good story. One that I too can learn something from. I also look out for a story that can take me to a world outside of my existing reality, that's another reason we are actors, the fun of escaping to a different world. The privilege of leaving behind every day, that we have so much come to take for granted. Another thing I look out for is the character I will be playing, the more complex the better

#### Q: You are a sculptor, voiceover artist, actor, singer and acting coach. How do you cope with Imposter Syndrome?

A: I think it is only natural sometimes to feel like you're not as good at what you do. I've learned to see that feeling as natural and somewhat true. But instead of letting it drive me to the ground, I use it as a springboard to push my skill to the next level. In the words of Marcus Aurelius "throw me to the wolves, and I shall return, leading the pack". It is a bad feeling -"impostorism" but then what are you going to do about it? I choose to let it move me to the next ring of the ladder.

# Injury rules Thiago Alcantara out of Liverpool's August actions

hiago Alcantara has been ruled out of action for Liverpool after the midfielder limped out of the field in a 2-2 draw against Fulham, on Saturday, after he was affected by a hamstring injury.

The player will undergo a scan within the week to ascertain the level of injury.

With this report, the 31-year-old will be ruled out of action in August and may likely return in September.

In August, the Reds' will play Crystal Palace, Manchester United, Bournemouth and Newcastle which the Spanish player regrettably will not be part of.

Despite the sad incident and the effect, Reds boss Jurgen Klopp has shrugged off the absence of Thiago from the squad.

Klopp claimed that the absence of the player will not have any effect as the club have the depth to cover for



the slack but laments that some other midfielders were also injured.

"We said we don't need a midfielder because we have enough - and we actually have enough, but the problem now is we get punished for something that is not our responsibility really because things like this can happen," the Reds' boss said.

"Nobody could imagine that Curtis gets the thing he gets; it is nothing serious but he is a young boy and it is a kind of stress reaction. Bodies are like this. Naby is only ill and he will now be back definitely next week again. Oxlade happened

early and now with Thiago that is, of course, not good and we will see" Klopp added.

The Liverpool boss urged the club to do something quickly because some of their midfielders, Naby Keita, Curtis Jones and Alex Oxlade-Chamberlain, who could have covered up for Thiago's absence were down with injuries or ailments.

He continued: "Look, a transfer must make sense now and in the long term; we have midfielders, we still have enough midfielders. It is not that we lack midfielders, but it's just that some of them are injured.

"This is not a good situation, I don't like it at all, but we have to see how we react to that - but for sure not panicking," Klopp added.

# Chelsea to make clubrecord bid for Fofana

Chelsea owner Todd Boehly has not ended his business in the transfer market for a defender despite signing Kalidou Koulibaly from Napoli and has turned his attention to Leicester City centre-back Wesley Fofana.

Reportedly, Boehly wishes to snap Fofana to Chelsea at a club-record fee that will make him the most expensive defender in the world but Leicester insist he is not for sale.

Chelsea are eager to build back a formidable defence after losing Antonio Rudiger and Andreas Christensen to Real Madrid and Barcelona respectively on free transfers.

Boehly is prepared to give Thomas Tuchel what he wants for the season and another highly rated Fofana could be just that player the club needs.

According to reports from England, Chelsea are prepared to tender a bid for the 21-year-old France international who made his debut for the France U21 national team in October 2020.

However, from the Blues' proposition, Fofana could

cost them up to £85m should they decide to formalise their words into actions.

Recall that in 2019, Leicester sold one of their priced assets, Harry Maguire, to Manchester United for €87m.

Meanwhile, French media L'Equipe reports that Chelsea's initial bid of €75m was rejected by Leicester who need a minimum of £80m that will see the defender become the most expensive sale of the club, surpassing Maguire's record in the process.

Fofana joined Leicester last two years from French Ligue 1 side Saint-Etienne and has featured in 51 matches while scoring 1 goal in the process.



# Your remarks on Africans, AFCON, irresponsible, unacceptable, CAF tell Napoli President

The Confederation of African Football (CAF) have taken a swipe at the President of Napoli, Aurelio de Laurentiis, over his recent comments against African players and the Africa Cup of Nations (AFCON).

CAF said the remarks by De Laurentiis were unacceptable and irresponsible after the latter stressed that African players coming to Napoli must sign a waiver to withdraw from the AFCON competition.

According to the continental football governing body, in a statement released on Sunday, the decision by the Napoli President likely falls under Article 14 of the UEFA Disciplinary Regulations.

Going by the above Disciplinary Regulation, CAF have charged the Union of European Football Associations to commence a disciplinary investigation against De Laurentiis.

"By publicly declaring that players who sign for Napoli must sign a waiver denouncing participation in the Africa Cup of Nations as a condition of employment, De Laurentiis' comments are likely to fall under Article 14 of the UEFA Disciplinary Regulations. CAF, therefore, urges UEFA to initiate disciplinary investigation against him," CAF said.

The continental football governing body stressed that they are committed to the role that unites diverse people of different cultural and language backgrounds.

"CAF is committed to

"CAF is committed to the role that football plays in Africa, Europe, North and South America, Asia and globally of bringing together and uniting people of different cultures, language groups, races, ethnic groups and religious backgrounds," the football continental body said.

Furthermore, CAF noted that they believe that Napoli and UEFA are committed to the same humanitarian role as it does.

"We have no doubt that Napoli and UEFA are as committed as CAF is to these global humanitarian objectives,"



However, the continental football governing body asked De Laurentiis if he was going to extend such actions against players from other continents from taking part in their continental competition.

CÂF asked, "Are we to assume that the Chairman of Napoli is going to include similar restrictive conditions to players from South America, Asia and other Confederations prohibiting them from playing in their Continental competitions which are important for the development and growth of football globally?

Recall that Napoli President recently made a comment where he said the club will never sign African players unless they are ready to sign a waiver, prohibiting them from taking part in AFCON.

CAF, to exemplify the importance of AFCON to the African people, explained that the "African Cup of Nations is the flagship competition of the African continent and one of the leading global football competitions. Its last edition in Cameroon was shown in more than 160 countries and attracted more than 600 million viewers".

### 'Joe Aribo £6m fee to Southampton shocking'

Scottish pundit Si Ferry said he is shocked a good player like Joe Aribo would be offered to Southampton for £6m despite his contribution and importance in the field of play.

Ferry adjudged the Super Eagles midfielder as strong, does the box-to-box runs, create opportunities and score goals.

According to the soccer pundit, who praised the £20m move of Calvin Bassey to Ajax, a deal that will potentially rise to £22.5m, Aribo's national teammate only performed for six months to become Rangers' record sale.

"£20m is the most that clubs in Scotland will get for a player now. If you look at Kieran Tierney, who was exceptional in the league over the course of a couple of years, he left for £25m and so you look at Calvin Bassey who's only really performed consistently for six months for me £20m is a no brainer," Ferry told Grosvenor Sport.

"Joe Aribo's £6m fee was more of a shock for me. He can run box-to-box, he's strong, can tackle and also score and create goals," the soccer pundit added.

The 26-year-old joined the Gers for a nominal fee of £300,000 from Charlton while other sources reveal it was on a free transfer. Either way, Rangers made huge profit in a deal that will potentially rise to £10m on add-ons.

However, Ferry rethought that Aribo's drop in form in

the peak of the last season's campaign for the Gers would have culminated into the £6m offer from the Saints.

Furthermore, the Super Eagles midfielder had a year left in his contract at Ibrox which Rangers had to capitalise on than to lose him on a free transfer.

"But maybe, because he wasn't as effective in the last three months of his Rangers career as he was in the first six months of the season, the price tag came down a little bit," he said.

"Based on his quality alone I'd have been wanting a bit more than £6m but what Scottish clubs don't want is players running down their contracts and going for free so if there is a hint that Aribo is looking for a move away, it's so important that clubs do get a bit of money for them," Ferry added.

Aribo made his debut for the Saints against Tottenham on Saturday under Ralph Hasenhüttl where they fell 4-1 at the Tottenham Stadium.



### Fred, McTominay, won't get United on top, says Keane

"I was happy he didn't get sent off [for a high challenge] but I think he was slightly lucky. Again, he's running the ball, absolutely ridiculous.

"It could easily have been red card. The quality in the middle of the pitch was nowhere near good enough but we've seen that for the last few years with these two players," he added.

He advised the manager Erik ten Hag to drop one of them, stressing that even this proposition is

surplus to requirement. Scholes continued: "With Fred and McTominay, he [Ten Hag] is going to have to go with just one of them but even one of them is probably too many.

'Fred gives the ball away all the time and McTominay tries to run with the ball constantly and then gives it away. Pass it to your best players! It's not that difficult. Ît's criminal on a day like today," he lamented.

### Barcelona to void Frenkie de Jong contract for irregularities

midfielder Frenkie de Jong has been told by the club management that his contract will be voided for failure to meet the required guideline.

The club said that the contract

offered by the previous board under the leadership of president Josep Maria Bartomeu, was illegal.

De Jong has been on the radar of Manchester United who have offered €85m to Barcelona to snap the midfielder to Old Trafford but reports reveal that the player refused to honour the move following the failure by the Red Devils to qualify for Champions

League.

In a new development, The Athletic reveals that the player is seeking that Blaugrana pays him €20m in deferred wages after he agreed to alter his contract during Barcelona's financial struggles in

the last couple of years.

The Athletic said the Dutchman was contacted by the club management on July 15 to inform him of the irregularities found in the contract extension he signed in October 2020 with the knowledge of former President Bartomeu.

According to the contract signed

by the 25-year-old which will see him remain in Camp Nou until 2026, there was a reduction in wages for the 2020/21 and 2021/22 seasons, with the difference being made up in the following four years

The present Barcelona board headed by Joan Laporta 'have since told De Jong they believe certain laws were broken in signing such a deal and they are considering legal action with a view to the contract being annulled. They then proposed the midfielder returns to the terms of his first contract with the club signed in 2019'.

According to the present board, the previous board who concluded the deals that also included Gerard Pique, Marc-Andre ter Stegen and Clement Lenglet agreeing to the terms, everything regarding these contracts was above board because La Liga and other legal parties greenlit them.

Brain health can be defined as the state of brain functioning across cognitive, sensory, socialemotional, behavioural and motor domains, allowing a person to realize their full potential over their life course, irrespective of the presence or absence of disorders. Many determinants are known to impact brain health and continuous interactions between these determinants plus individual's context lead to lifelong adaptation of brain structure and functioning. The position paper provides insight into the following clusters of determinants:

• physical health,

healthy environments,

safety and security,learning and social

connection and

• access to quality services.

Optimizing brain addressing health bv these determinants leads multiple benefits including lower rates of many chronic health conditions - neurological, mental, substance and physical - as well as improved quality of life and multiple social and economic benefits, all of which contribute to greater well-being and help advance society. The paper demonstrates the relevance of optimizing brain health within the broader context of public health and society and policy future offers practical solutions and directions for the field including specific actions for addressing brain hearm ongoing principle health tions health determinants. priorities in research, and operationalizing and measuring brain health.

# Again, INEC denies Lawan's, Akpabio's names on candidates lists By TUNDE JOSHUA, (Abuja) attention has been drawn to a two personalities in question to a two personalities in question were not published by the

Independent National Electoral Commission (INEC) has again denied allegations of listing names of the Senate President, Ahmad Lawan and that of former minister for Niger Delta Affairs, Senator Godswill Akpabio as candidates of the All Progressives Congress (APC) for Yobe North and Akwa Ibom North West senatorial districts.

This is coming on the heels of an online publication purporting that INEC has doctored, backdated and certified documents to accommodate the nominations of the duo.

According to the National Commissioner and Chairman, Information and Voter Education Committee, Barrister Festus Okoye, the allegations is spurious and total falsehood as the Commission has not recognized either Lawan or Akpabio as APC candidates.

He described such publication as unwarranted attack in the Commission.

Reacting to the allegation in a statement on Tuesday, Okoye said "not for the first time, our attention has been drawn to a story published by an online medium that the Commission has doctored, backdated and certified documents to accommodate the nominations emanating from Yobe North and Akwa Ibom North West Senatorial Districts in respect of Senators Ahmed Lawan and Godswill Akpabio. Nothing can be further from the truth.

"As evidence of the alleged role played by the Commission, a certified true copy of Form 9C uploaded by their political party and received by the Commission on 17th June 2022 when the nomination portal closed was presented.

"For clarity, the Form EC9 (submission of names of candidates by political parties) is the Form uploaded by parties on the INEC nomination portal. This is clearly indicated on the title of the Form which was received on 17th June 2022 when the portal closed.

"What follows is the publication of the personal particulars of nominated candidates which was done a week later. The Forms of the

two personalities in question were not published by the Commission. The decision of the Commission triggered legal action which are still ongoing. It therefore defies logic and common sense to go around and submit doctored documents purportedly recognising the duo as candidates when the matter is clearly sub-judice.

"As part of the ongoing case in Court, a law firm requested the Commission for a Certified True Copy (CTC) of the Form EC9 submitted by the All Progressives Congress (APC) as its candidate for Akwa Ibom North West Senatorial District which we are duty bound to oblige them under the law. The Form was certified on 15th July 2022. If minimum care has been exercised by the promoters of the story, they would have seen the two stamps of the Commission bearing different dates on the Form. It is this Form that is now misconstrued as INEC's endorsement.

"For the record, the Commission has not recognised any of the two personalities as a Senatorial candidate."
