

INEC faces court cases over voter registration

uits are being filed by concerned individuals and groups against the country's electoral umpire over the recently concluded voter registration.

Socio-Economic Rights and Accountability Project (SERAP) has urged Mahmood Professor Yakubu, the Chairman Independent of the National Electoral Commission (INEC) to "immediately give seven million Nigerians who have carried out their voter registration online the time and opportunity to complete the process, so that they can obtain their permanent voter cards (PVCs), and exercise their right to vote."

INEC recently disclosed that out of 10,487,972 Nigerians carried who pre-registration online, only 3,444,378 completed the process at a physical centre. This represents just 32.8 percent of completed online registration.

In a letter dated

13 August 2022 and signed SERAP director Kolawole Oluwadare, the organisation said: "The right to vote is not merely the right to cast a ballot but also the right to be given the time and opportunity to complete the registration process, so that the right can be meaningfully and effectively exercised.

"Closing the gates on eligible Nigerians and denying them the time and opportunity complete their registration cannot preserve trust in the electoral process.

"Denying a significant number of eligible voters the time and opportunity to complete the registration for their PVCs would impair the right to vote of those affected, deny them a voice in the 2023 elections, and lead to disparate and unfair treatment of these voters."

The letter read in part, "The failure of the

applicants to complete their registration may be due to factors entirely outside of their control, especially given well-documented challenges faced by many Nigerians registration centres across the country.

We would be grateful if the recommended measures are taken within 7 days of days receipt and/or publication of letter. If we have not heard from you by then, SERAP and the affected Nigerians shall appropriate legal actions to compel INEC to comply with our request in the public interest.

"Unless they are given a reasonable time and opportunity to complete the registration process, and to obtain their voter cards, these eligible Nigerians will not be able to vote in the 2023 general elections.

"If citizens' chance vote is denied, that would amount to violation of their fundamental right to vote, just as it would be if they were prevented from casting any vote at all.

"The alleged failure the applicants complete registration at INEC designated centres are not sufficiently weighty to justify their exclusion from the 2023 general elections.

proffered "Anv justifications saving time therefore are wholly insufficient. Administrative convenience is simply a compelling justification in light of the fundamental nature of the right to vote.

"This severe vote deprivation justified cannot be any perceived considerations saving time, especially because Section 9(6) of the Electoral Act 2022 provides that 'the registration of voters, updating and revision of the Register of Voters shall not stop not later than 90 days before any election covered by this

opportunity for the seven million Nigerians to complete their registration would promote and preserve the right to vote, and ensure that legal and eligible voters are not inadvertently unjustifiably turned away from exercising their fundamental right

"By refusing the over seven million Nigerians opportunity complete the registration for their **INEC** PVCs, have unfairly, unreasonably, and unjustifiably denied them the opportunity to be heard at a meaningful time and in a meaningful manner as to the reasons for not completing their registration.

"Voter distrust is apparent in virtually empty polling places on election days. Nigeria historically has had low levels of voter turnout.

"Allowing eligible Nigerians to complete their registration would improve citizens' participation in the electoral process, and public confidence in the electoral system, as well as the ability of INEC to discharge its constitutional and statutory responsibility fairly, justly, reasonably.

"The Nigerian Constitution 1999 (as amended) provides in Section 14(1)(c) that,

N'Delta groups disagree over NDDC board

Liberation Group, Itsekiri Coalition for Good Governance, Freedom Itsekiri Congress, National Association of Itsekiri Students, Sisan Ebiren Iwere and Iwere Women Consultative Forum.

The coalition handed down the condition peaceful during a protest in Warri, Delta State. They vowed that the protest would continue until FG appoints an Itsekiri as Chairman and/or MD of NDDC. Members of the groups later presented their demands to representative the Igba of Warri Kingdom, Chief Rita-Lori Ogbebor.

protesters carried placards with inscriptions such as: 'We just quiet since, if FG nor appoint Itsekiri as Chairman or MD of NDDC, Peace no go reign 0000', 'Na we dey produce the highest crude oil in Delta State, but have the least developed communities', 'No Itsekiri, No NDDC' and '8 years of marginalization, enough is enough."

They said: "Since the year 2000 when NDDC Board was created, no Itsekiri has been considered to serve in the capacity of Chairman or MD of the Board, despite being

the highest oil and gas producing ethnic group in Delta State. This is not acceptable to us anymore.'

President of Itsekiri Interest Group, Gbubemi Awala, while addressing newsmen at the Merrick Lori Cultural Centre, Warri, urged President Muhammadu Buhari to "face fact and leave the politics surrounding the NDDC inauguration."

He implored Ogbebor and the father Itsekiri Nation, the Olu of Warri, His Majesty, Ogiame Atuwatse III, to present their demand to Buhari.

Chairman of Itsekiri Liberation Group, ILG, Comrade Oris Mone, in his address, said: "It is not a crime to be minority in Nigeria, Itsekiri has the highest quantum of crude oil and gas production in Delta State, that makes it a must for an Itsekiri to be considered as Chairman and MD of NDDC."

President of Itsekiri Freedom Congress, Comrade Igiogio Matthew, expressed the sadness over perceived long marginalization of the ethnic group in the Board of NDDC by the Federal Government, "NDDC saying: rotational for oil and gas producing ethnic groups, which Itsekiri

happens to be the highest oil producing ethnic nationality in Delta State and second highest in Nigeria.'

Gbubemi Awala, on behalf of the coalition, presented the letter to Ogbebor, represented by the Director of Merrick Lori Cultural Centre, Warri, Frank Uromieyaghan, who assured them that he would present their demands to her, commending them for the peaceful protest.

However, two other groups disagreed with the Itsekiri, describing the continued delay in inaugurating the board as becoming repulsive to the people of the area and endangering peace.

They are Community Development Committee of Oil and Gas Producing Communities of Niger Delta (CDCOGPCND) and Mothers of Oil and Gas Producing Communities of Niger Delta (MOGPCND).

In a joint statement signed by Joseph Ambakederimo, Board Chairman Trustees, CDCOGPCND Нарру and Lady Convener of MOGPCND, the groups stated that the process of appointing a substantive board has been completed a long time ago," and that "what is going on in and all people of good conscience must condemn and oppose

The groups held that the Federal Government deliberately taking the people of the region for granted over time again and again, adding that, it was ready to disappoint the government on its plan to instigate fresh hostilities in the region.

It said, "It seems the government and its agents only understand the language of violence and destruction, but we will not give in to such provocation. Whatever they think they are doing, the import of it is that they have completely destroyed the integrity and high esteem of President Muhammadu Buhari in the region. The President's hands have been misdirected too many times by his appointees. There should be consequences on the part of those who have entrenched this kind of behaviour with Certainly this attitude of 1 don't care is a recipe and a call to violence.

"The patience of the people of the region is running thin, any moment from now the government should accept whatever comes out of the frustrations



"According to a report released by INEC, out of 10,487,972 Nigerians carried out pre-registration their online, only 3,444,378 Nigerians representing 32.8 percent, completed the process at a physical 7,043,594 centre. Nigerians carried out their pre-registration but are yet to complete the process at a physical centre.

"This represents over 67 percent of those who began their registration process online.

"According to INEC, total of 12,298,944 Nigerians completed their voter registration; 8,854,566 of which were persons who did their registration entirely at a

physical centre. "The over million Nigerians have already completed their registration online. that is, via INEC online portal by providing biodata required documents.

"According INEC process, that is outstanding for the applicants to complete the registration for their PVCs is to visit INEC designated centres for their biometric to be captured."

SAN, has dragged the Independent National Electoral Commission (INEC) to court over the stoppage of the Voters' registration exercise.

The Plaintiffs, in the suit marked FHC/ABJ/ CS/1335/22, are praying mandatory a injunction compelling INEC to forthwith, extend the continuous voters' registration till November 27, 2022, which is 90 days to the 2023 general election as provided by sections 9 (6), 10 (1), and 12 (1) of the Electoral Act 2022.

Mike Ozekhome SAN and Abubakar Sani are identified as the Plaintiffs in the suit dated August 3, and filed at the Federal High Court, Abuja.

The Plaintiffs are asking the court to declarethatINECcannot purport to terminate the continuous voters' exercise registration on July 31, 2022, more than 6 months before the general election scheduled to hold on February 25, 2023, as doing so would disenfranchise millions of eligible potential voters (including the 2nd Plaintiff).

They want declaration that the stoppage of the continuous voters' registration by INEC on July 31, 2022, which is six months to the 2023 general elections, contrary to provisions of section 77 (2) of the Constitution of the Federal Republic Nigeria 1999 (as altered), sections 9 (6), 10 (1), and 12 (1) of the Electoral Act, 2022, and Article 13 (1) of the African Charter on Human and Peoples (Ratification & Enforcement) Act, Cap. A9 LEN, 2004, is, therefore, ultra vires, invalid, null and void.

More so, Ozekhome and his co-plaintiff are seeking a declaration that having regard to the provisions of section 77 (2) of the Constitution of the Federal Republic of Nigeria 1999 (as altered), section 12 (1) of the Electoral Act, 2022 and Article 13 (1) of the African Charter on Human and Peoples

Enforcement) Act, Cap. A9 LEN, 2004, the Defendant (INEC) cannot refuse or decline to register any eligible citizen of Nigeria that has attained the age of 18 years, who presents and or intends to present himself to Defendant for registration before 90 days to the general elections.

"A declaration that Defendant can only stop the continuous registration of voters 90 days before the next general elections scheduled to hold on 25th February 2023, (ie, on or before the 27th day of November 2022).

Newspaper distributor arrested over alleged offensive publication

newspaper distributor identified as Chidi Mr. Ngadiubia has been arrested by operatives of the Nigeria Police Force, Akwa Ibom Command and detained at its Ikot-AkpanAbia, headquarters, allegedly on the order of the state government. It is allegedly over an offensive publication against the interest of the state government.

The Trumpet has gathered that Ngadiubia was picked up at his distribution point, No 15. Asutan Street, which also houses the Punch newspaper office, by the operatives who were on

a mission to arrest the publisher of a local tabloid - The Mail, Mr. Ifreke Nseowo, over alleged offensive publications.

An eyewitness, Mr Chris Etim, who was with the distributor before he was arrested told said that a female caller had tricked the publisher, now at large, by telling him she had an advert for him for publication in his paper.

Apparently sensing problems, he said the publisher directed the caller to drop the advertisement materials with the newspaper distributor to be picked up at a later date.

But on arrival at Ngaduibia's distribution point, they arrested and took him to the police headquarters at Ikot Akpanabia, in Uyo, the state capital, and asked him to produce the publisher or face the wrath of the law for alleged connivance.

The plot to arrest the publisher had been widely reported by other local tabloids in the state which had alleged that the state government is not happy with certain publications of the newspaper as it relates to the PDP candidate, Umo Uno's alleged certificate forgery scandal.

Meanwhile, Federated Chapel of Nigeria Union of Journalists (NUJ) of which the hunted publisher is a member has condemned the manner in which journalists are being hounded in the state.

Chairman of the chapel, Mr. Nsibiet John, in a statement, described the development as "wicked, callous, ungodly, satanic and a fresh attempt to violently violate all known rules of democracy and free press."

He said the arrest of the distributor in place of The Mail Publisher has also raised fresh concerns as the NUJ in Akwa Ibom State had reiterated its stance of not allowing any of its members to be victimised and hounded by any individual, group or institution.

However, the Police Public Relations Officer, Akwa Ibom Command,

SP Odiko Macdon. while responding to the development said that the State NUJ chairman, Mr Amos Etuk, had already drawn his attention to the matter.

Pledging that the command would invite the parties involved for an amicable resolution, he added: "I have been called by the NUJ Chairman on this not long ago. We need more details on this. We

will stand for the truth as an institution. We are committed to serving the good people of this state.

"We wish to call on our amiable members of the Fourth Estate of the Realm to practise their profession within the ambit of the law and respect other people's views and rights. Let those concerned reach me for us to find the truth and create a level playing ground for all, please."

10,000 displaced as France battles month-long wildfire

France is battling a wide-fire incident which has ravaged over 7000 hectares of pine forest in Gironde near Bordeaux.

The blaze, an outcome of the record-breaking drought that has enveloped the European continent, resulted in the melting of over 2000 years old glaciers in Switzerland which led to the discovery of a plane wreck and body parts from a Piper Cherokee

crash that happened in 1968.

According to reports by Daily Mail, the fire outbreak that started in July overwhelmed the firefighters of France who decided to call for assistance from other European countries like Greece, Italy, Romania, Poland and Sweden to extinguish the blaze.

The drought over Europe is one of a kind as it has dried up lakes, turned evergreen forests into tinder-dry, melted glaciers and resulted in a fire outbreak that has chased out over 10,000 persons from their homes.

Surprisingly, on one of the occasions when the firefighters were tackling the outbreak, they were chased fiercely by a fire tornado that erupted when a wind tornado blew through the fireplace.

However, the multitude of firefighters numbering over 1100, are yet to allay the blaze despite deploying different firefighting

strategies including using extinguishing powder from helicopters and water-bombing planes.

Unfortunately, Europe is sweltering during this period caused by the drought that has brought undue heat to the region. Luckily, it has also unravelled the 54-year-old crash of Piper Cherokee of registration HB-OYL in the Aletsch Glacier in Wallis canton, near the Jungfrau and Monch mountain peaks in Switzerland.

Flush out criminals among you, Akeredolu charges Ebira leaders

Governor Oluwarotimi Akeredolu has warned Ebiras living in Ondo to flush out criminals among them and join hands with the government in ridding the state of crime.

This is coming after Ebiras were named among the attackers of worshippers at St. Francis Catholic Church, Owaluwa in Owo, Local Government by the Chief of Defence Staff (CDS), General Lucky Irabor, in Abuja, last week.

Governor Akeredolu stressed that the Ebira people have lived together with the indigenes of the State for too long, charging them not to deviate from the farming trade. Akeredolu stated this on Saturday at a meeting with the leaders of the Ebira

Community in the State at the Cocoa Conference Hall of the Governor's Office, Alagbaka, Akure. He said the meeting was summoned in the light of the recent development of the June 5 attack in Owo and other kidnapping cases in the State urging the leaders of the Ebira Community to deal with the situation in the best way, to protect their name and integrity in the State.

"We summoned this meeting with our brothers. They are not new here but because of the recent developments that have to do with the Owo massacre and kidnappings, we have to call ourselves. I can assure you all we have had a very frank discussion with ourselves and the leader of the Ebiras in Ondo State spoke on behalf of Ebiras and a few other persons.

"It is clear that the message from us to them is well understood and we have assurance from the Ebiras who are living in Ondo State that they would cooperate with the security agencies and that the incident in Owo was something that they felt very bad about."

Akeredolu, who is the Chairman of the Southern Governors' Forum, disclosed that he received a letter of commiseration and expression of embarrassment from Ohinoyi of Ebiraland—leader of Ebira in the World— on what happened.

"Ŝo, we leave here today with the belief that our brothers, Ebiras, that are here, would at the least work to ensure that there is security in Ondo

State and in doing that, we have charged them to discuss with all their people."

He urged the state citizens to continue with their brotherliness and maintain the good relationship built with Ebiras in the past, adding that they have assured them of good conduct.

"We believe that it

is not those who are residing here that came to perpetrate this crime. That is what they have said and we should give them another chance. Let us live together in peace and I hope and pray that the Ebiras who are here in Ondo State will work with the government and security agencies to make sure that criminals are flushed out within our midst and they have our cooperation in whatever way they wish."

Bandits kill, kidnap many in Taraba

The weekend was black and bloody for the people of Gassol local government council of Taraba State following bandits activities which led to the killing of over sixteen persons.

The incident which occurred at the weekend in Gidado and Garinkuka, as well as in Jauro Manu villages in Gunduma district of Mutum-Biyu, led to the abduction of scores of the villagers.

Apart from the recent attacks in the council which led to the abduction of travellers, it would be recalled that the first bomb attack was also recorded in the council.

The explosion which occurred early this year in the council, led to scores of deaths with several other persons left with various forms of injuries.

Aside from the deaths and abductions recorded in the weekend incident, several other persons were also confirmed to have been left with various degrees of gun injuries.

The attackers, according to The Trumpet source, invaded the communities in large numbers on motorbikes and began to shoot sporadically, killing sixteen persons on the spot in the different areas.

Wondering why the bandits have continued to have a field day in the area, some of the villagers who spoke with The Trumpet, were sad that the government at the center and in the state have not been able to put in place mechanisms to checkmate the bandits.

The villagers who said the bandits always attacked in broad daylight said the weekend episode occurred at about 5.00 p.m.

Abdullahi Chul, a staff member of the council, said the communities tried to repel the bandits to no avail.

Confirming that two of the bandits were killed by the villagers, he said their efforts to repel the terrorists would have yielded positive results but for the sophisticated weapons being brandished by the bandits.

State Command Police Public Relations Officer (PPRO), Abdullahi Usman, agreed that there was an attacked in the aforementioned council.

The PPRO who could not state the casualties figures, said the command is working round the clock to track down at the bandits.

He also urged persons with useful information about the bandits to make it available to the command.

Prostitute killed allegedly by client

A sex worker has by killed by a suspected client in a popular brothel (name withheld) in Ughelli, Delta State.

The lifeless body of the victim was discovered in her room, suspected to have been stabbed and strangled to death by a yet-to-be-identified assailant.

According to sources at the hotel, the victim simply identified as Miss Confidence, failed to show up to join her colleagues to scout for customers on that faithful day, prompting the suspicion that something might have happened to her.

"Her colleagues were waiting for her outside as they were looking for customers but they didn't see her. They now went to knock at her door and it was when they opened the the door that they found her dead in her room," the source anonymously said.

The development caused pandemonium in the area as panic-striken colleagues of the deceased are said to have fled.

Contacted, the Police Public Relations Officer of the State Command, Mr. Bright Edafe, confirmed the incident saying, "She was stabbed on the stomach and strangled.

He said the police had commenced investigation into the matter, adding that no arrest has so far been made.

Monarch to die by hanging for killing subject over allegations of witchcraft

n Akwa Ibom State High Court sitting in **▲**Uyo has sentenced the Village Head of Efen Ibom, Chief Essien Matthew Odiong, in Ika local government area to death by hanging.

Delivering judgement, the presiding judge, Justice Edem Akpan, found the monarch guilty of a four-count charge of conspiracy, presiding over unlawful trial by ordeal, stealing of motorcycle belonging to the victim and murder of Udoma Akpan Udo Ubom - owner of the stolen motorbike.

The late Ubom was accused by

his brothers of being a wizard and reported to the Village Head, who brought him before the Efen Clan Council, where the deceased was given an oath to swear and clear himself.

It was gathered that the village Head, 82 years old, married to 12 wives and with 60 children, presided over the trial by ordeal where the deceased was forced to swear and substances injected in him using syringe.

Justice Akpan, found the accused guilty of murder of Ubom by injecting him with some chemical substance, leading to his death on 26th April, 2017.

The Court held that "having

sensed the consequences of his criminal activity, the monarch escaped from the village since 2017 and returned in 2019, when he was arrested by the Police."

Justice Akpan also held that since "the accused had voluntarily admitted that he sat at Efen Clan Council with five other village heads and members of the Clan Council to try the deceased on the allegation of witchcraft, the law has relieved the prosecution of the burden to prove the offence of conspiracy."

According to the Court, "the admission of the process of trial and the decision of Efen Clan Council to administer oath on the deceased, has logically brought to the conclusion that a plastic bath on the head of the late Udoma Akpan Udo Ubom and injecting some chemical susbtance through a syringe into his buttocks by the village head, caused the death of the deceased."

Justice Akpan sentenced the Village Head to death by hanging for murder, seven years imprisonment with hard labour for directing unlawful trial by ordeal and three years imprisonment for conspiracy with others now at large.

Before the death sentence, the convicted Village Head, popularly known as "Kill and Bury" pleaded for leniency, asking the court to temper justice with mercy.

Teachers, mgt settle quarrel at school in A' Ibom

Teachers and management of Federal Science and Technical College, Uyo, AKwa Ibom State have resolved to settle differences bothering on minor misunderstanding that almost resulted in breakdown of law and order in the school.

Investigation revealed that the teachers accused the management of refusal to pay Duty Tour Allowance (DTA), approved by federal government to staffers in Unity Schools across the country.

It was gathered that the teachers also accused the management of admission racketeering, illegal levies and misappropriation of funds from IDEAS World Bank project for the school.

It was gathered that the School Based Management Committee (SBMC) waded into the matter to avoid disruption of academic

Speaking to newsmen in Uyo, the chairman of SBMC in the college, Elder Simeon Umoette, said the committee decided to wade into all the allegations and

address them properly to restore peace needed for learning.

Umoette said the committee comprises representatives of the State Ministry of Education, Divisional Police OFFICER (DPO)" C" Division Uyo, Chairman, Parents /Teachers' Association (PTA), Association of Old Girls Association of the college and leaders of the host community

He said all the allegations were out of misunderstanding and lack of communication between teachers and the school management, stressing that the matter has been resolved.

Umoette claimed that all the allegations were false and misleading as the Federal Government has established standard procedures guiding administration and operations of all Unity Colleges nationwide.

' Admission into Federal Government Colleges are done with strict adherence to the criteria and guidelines as directed by the Federal Ministry of Education and not the Principal as alleged by the Teachers.

'Fees are paid through re-



mittal system and nobody can defraud such a system which is strictly monitored. There are no illegal levies charged in the college besides the ones recommended by the Federal Ministry

He further disclosed that teachers did not know that the IDEAS project for the college was awaiting execution as the World Bank has a standard in the implementation of their projects which cannot allow any form of fraud all over the world.

He said the main cause of friction between teachers and them was payment of DTA which has been paid to about

90 per cent of staff members.
"The union insisted that the DTA must be paid at the new rate approved by Federal Government. They didn't know that even though the approval had been made, funds were not yet available. Management was waiting for funds to implement

it .
" Meanwhile , the DTA has been paid at the old rate. Subsequent payments of the difference between the old and the new rate is subject to availability of

He therefore urged the general public to disregard reports from

alleging frauds and other unfounded misdemeanors against the school management as peace

has returned to the college.

Umoette said during the meeting of the SBMC, members passed a vote of confidence in the Director/Principal, Ms Dinah I. Gogo for all her efforts in attracting federal government presence to the school through a series of infrastructural development and staff capacity building.

He listed achievements of the principal to include academic excellence through the performance of pupils in WAEC, NECO and NĀBĪEB examinations, upgrading of hostel facilities, World Bank project for the school and winning of prizes and laurels.

Umoette observed that the principal's intolerance to indiscipline from both staffers and students such as lateness, truancy, irregular attendance in classes and other vices brought squabbles.

He appealed to parents and

Parents finger friends, peers as barber dies after Abuja trip

The family of Mr. and Mrs. Anietie Okókon Obot is in dilema over the mysterious death of their son, Ofonime, who was the breadwinner but suddenly died on Friday June 8, 2022 without

any serious sickness.

The Trumpet gathered that on the fateful day, Ofonime, a promising young barber aged 25, had returned from work late in the evening complaining of in the evening complaining of chest pains and vomited blood the previous day.

It gathered that before the deceased finally gave up the ghost at around 12:15pm the following day, he follow the

following day, he fell on the laps of his elder sister while his tongue and mouth turned black. Efforts to revive him by his parents failed.

Although no doctor was able to ascertain the actual cause of his death before he was buried on Saturday, July 16,2022, family sources said he died allegedly from food poisoning right inside his father's rented house located at Atai- Idung street, Urua Ikpa, in Itu local government of Akwa Ibom State.

However, another family version of the story claimed that his death came after he visited one of his friends in Abuja. They claimed that he was no longer his usual self after his return from the journey ,as his mood and behaviour completely changed.

According to the deceased's father: "July 8 was a sad day for the entire family . I was in the palace of a chief in another village over a land dispute case when I received a call from the house that my late son, Ofonime Okokon was vomiting blood

"I rushed back home and met my wife at the entrance to my

compound and she told me that she had the same call and both of us went into the house together. We met my late son lying in arms of his elder sister still vomiting blood. I saw the remaining meal he ate mainly two eggs and cooked indomie noodles, they prepared for him to eat before his health became worst, I even ate the remaining egg while the sister ate one full egg from the prepared meal.

"By this time he was lying

on the arms of the sister, they have already sent for drugs from a nearby pharmacy store . But when she forced the mouth of the deceased to administer the drugs , we discovered that the tongue, teeth, gum and entire mouth had turned black indicating that he was poisoned.

"I called on his pet name I used to call him "Ikpa" and he turned his face, put his two hands into my my palm and breath hislast that was around 12:15 pm on

"But that morning when he wake up we greeted and food was prepared as he requested to eat egg and indomie noodules which he ate very little before we went out .He was not sick up to the point of death.

Then I asked the chief that followed me what could be the cause of the the black mouth and he said if someone hates you, he can poisoned you and before you die, your mouth can turn bĺack.

"I think this boy, in one way or the other went into a wrong way to help the family from poverty. That is my personal thinking. Friends must have told him this is the way you can enter and get fast luck. He travelled to Abuja to meet his friend and returned on 11th May to Uyo."

Meanwhile, the deceased's younger sister, Ruth Okokon, aged 22, told The Trumpet in Uyo that the death of her brother is not unconnected with the recent journey he made to Abuja, to see his friend.

Ruth who was constantly trying to hold back tears while narrating her story said before his late brother travelled to Abuja, he promised that he was coming back with money and that the family fortunes will change automatically for better.

She observed that the way and manner her late brother came from Abuja, was suspicious as he became a changed person from his usual self.

She played a video from her phone showing a scene of his deceased brother and his supposed friend and remarked: " The way my brother came from from Abuja, was not nice. He came back without some of his things. He looked worried and emaciated and was lost in thought; he changed completely.

"He stopped talking to everybody. He will just stay on his own all alone without talking to anyone and when we try to ask him what was wrong, he will not say anything and when we asked him he will get angry and leave the place."

Asked how she got the video, she replied that it was copied from the deceased's phone.

The deceased mother, Mrs. Comfort Obot, who was psychologically broken when The Trumpet visited the family said the death of her son had shattered peace in the family.

"He was everything to me. The most painful thing is that there was no premonition of his death. There was a revelation from the church, that we should

pray for the family which we have been doing but like a thief in the night death came. My son never said any last word before he died," she said sobbing. One of the deceased's appren-

tices identified as Elijah said all the workers were surprised by the unsual behaviours of their master after his return from Abuja, adding everything about him changed.

"Before he travelled to Abuja, he was talking to us and we used to crack jokes together, we sometimes eat together in the shop. But since he came from Abuja he became a different

person entirely.

"One thing we noticed again with him was that he was always on long phone calls during work hours and whenever he started receiving such calls he would not want anybody around him again," Elijah disclosed.

However, a community source who pleaded anonymity said that his death may not be unconnected with the 'unholy association ' the boy must have allegedly entered.

According to the source there was a " candlelight procession of young guys numbering about 200 who stormed the venue of his wake ostensibly to pay their last respects to their friend.

But the deceased's father had vowed that anyone directly or indirectly responsible will not go unpunished.

Cursing the perceived killers of his son, Mr. Obot said that they have only succeeded in shattering the peace of the almost 40-years old union. He affirmed that the God of Justice shall certainly avenge his death.

"I used to call him Mbakara(meaning a white man) and I called him that name that morning before i went out and he assured me that nothing was wrong with him. The God that we served will certainly punished any one who has done this to mé," he sobbed.

The challenge before the family now is how to bear the irreparable loss of their breadwinner, whose death they said will continue to impact negatively on their fortunes.

According to the deceased's father, Ofonime was God-sent to the family. He emphasized that his son's death will remain a blow to the family for a long

He said: "Whenever he comes back from the barbing shop, he always buy some foods for the family. Even, if we are asleep, he will wake us up and we will rush the food. A night before he died, he bought food for us in the house and all of us ate together. His death is a big blow to the entire family."

Elijah added: "He was a father to me and indeed to all of us under him because he sometimes buy food for us in the shop.'

On how far the police had gone in investigation of the matter, Mr. Obot said: "I have not reported the incident to the police because we don't have money for the case, I trust you (journalists) more than the police.Police see white and call it black" he said adding that the family he was was born into

don't go to police for anything.
Obot added: "I was working with the AKwa Ibom State Secondary School Board but my salary was stopped in 2009 for offence I didn't commit and since then I don't have confidence in the police. After that incident, i have been at home, growing water leave farm."

A' Ibom PDP in search of peace over 2023 guber ticket

Kwa Ibom State chapter of the Peoples Democratic Party(PDP) is embroiled in various intricacies arising from the gubernatorial ticket given to Governor Udom Emmanuel's preferred candidate, Pastor Umo Bassey Eno, for 2023 general election.

Consequently, peace needed to drive the to victory in the state is an illusion as stakeholders, aggrieved aspirants and party faithfuls have decided means to stay afloat in the political system against the party interest

In the past weeks, chieftains of the party have defected in droves to protest the choice of pastor Umo Eno as governor Emmanuel's preferred successor. The wind of defection is very unprecedented in the history of the state since 1999. The roll call include ward chairman at the grassroot, chapter officers in local government areas and some governoship aspirants who are lukewarm in party affairs.

Last week , the Peace and Reconciliation Committe headed by senator Effiong Bob invited some aggrieved party chieftains especially aspirants who were angry with the manner the party gubernatorial primary which brought pastor Umo Eno was conducted.

Though details of the parley was not made public, but sources disclosed that the meeting ended in fiasco as those who attended returned home with straight faces.

The party ticket given to pastor Umo Eno has generated dust in the state resulting in court action over credentials particularly the West African School Certificate of pastor Umo Eno now pending before the federal High Court in Uyo as well as Permanent Voters Card and Age declaration which his accusers believed were forged.

Our Correspondent gathered that trouble in AKwa Ibom PDP started when the leader of the party and state governor Udom Emmanuel began the search for his successor. First, Umo Eno was appointed Board Chairman of the state investment company and later became Commissioner for Lands before the lot fell on him to be the party candidate for next year's election.

This never augur well with party chieftains who had stake their necks against all odds to sustain PDP in the state.

Our investigation reveal that one of the party bigwigs who had vowed never to see Umo Eno become the governor of the state is senator Bassey Albert Akpan representing AKwa Ibom North East senatorial district. When the chips were down and it was dawn on him that governor Udom Emmanuel was determined to make Umo Eno his successor against the ambition of the Senator Albert, he dumped the party and settled for Young Progressive Party (YPP) where he had picked ticket to contest for governoship in 2023.

Addressing supporters during the reception ceremony organized by YPP party to receive senator Albert, he described himself as loyal and faithful party man whom colleagues nicknamed him as the last man standing for AKwa Ibom in the senate . Of course , they were right as it was only Senator Bassey Albert alone for PDP in the red Chambers after Senator Nelson Effiong and Senator Godswill Akpabio have defected to the APC on the floor of the National Assembly.

Albert said such steadfastness was supposed to be compensated and accused PDP of lacking reward system and back stabbing her supporters promising to throw out the party in the state through the ballot box come 2023.

However, the last straw that breaks the camel's back for the PDP is the party gubernatorial primary that almost throw it off balance . The primary conducted at Godswill Akpabio International Stadium turn out to be another albatross for the party .

Notable aspirants with the goodwill of the people who were in the race include Senator Bassey Albert , Hon Onofiok Luke and Mr James Iniama

Others were pastor Umo Eno, Mr Akan Okon, Akanimo Udofia, Ide Owodiong Idemeko, Idorenyin Umoh and Ini Okpon .

In the present circumstance, what has the Reconciliation Committe done to bring lasting peace in the party ahead of 2023 general election? How the candidate conducted themselves during and after the party primary will help to facilitate in the peace process.

Be that as it may, it is pertinent to examine actions and inactions of the aspirants to guide the peace committee in bringing them back.

Beginning with the winner of the governoship ticket in the state - Umo Bassey Eno now enmeshed in a very embarrassing certificate forgery that drags integrity and status of PDP into the mud . Observers are saying that considering the avalanche of evidence now before the court , what happened to PDP governoship candidate in Delta state

ment of campaign nationwide. His words" We don't know how the case of forgery involving our governoship candidate will end in court. The best thing to do now is to plan for his replacement. Our party can not be shut out from the ballot because of interest of one man " he said

Meanwhile, if the idea of substitution of candidate to the Electoral Umpire scales through, who among the aspirants would be favoured to fly the party's flag in 2023.? Some residents in the state have said that the candidate should be selected from Umo Eno's local government area or the PDP should use the opportunity to address agitation from Itu/Ibiono Ibom Federal Constituency who were clamouring for governoship slot within Uyo senatorial district.

Again, the only aspirant from Umo Eno local government area who was supposed to be considered is the former speaker of the State House of Assembly and now member representing Etinan, Nsit Ubium and Nsit Ibom in the federal House of Representatives Hon Onofiok Luke

Unfortunately, few days to 25th May, 2023 when the PDP governoship primary was conducted, Luke sent a letter of withdrawal from the race to the state Chairman of the Peoples Democratic Party (PDP) announcing his withdrawal from the gubernatorial race. The announcement was made at the venue of the primary before the media and party supporters.

But despite the withdrawal, Luke got two votes from a die hard delegates and was

No wonder, he is still supporting Umo Eno inspite of the bad forgery case before the court.

Recently, Luke claimed he stepped down for pastor Umo Eno in attempt to collapse support base the party candidate during peace meeting in the palace of Oku Ibom Ibibio and Paramount Ruler of Nsit Ibom local government Ntennyin Solomon Etuk where both Umo Eno and Luke hail from .

Speaking at the Palace of the Oku Ibom Ibibio and President General of the Akwa Ibom State Traditional Rulers Council, shortly after Barr Luke collapsed his campaign structure and support base to him, Pastor Eno promised to integrate all his supporters and work together with him in the overall interest of the state

He said the reconciliation meeting was symbolic because it was instituted by his fathers and as a child from a humble home, he (Luke) couldn't disobey the monarchs.

"It would have been very difficult for me to be convinced if this meeting had been at the instance of any other set of people.

of people.

"I never haboured any intention to betray my party PDP because everything I have achieved, has been made possible by the PDP," Barr Luke stated.

The Monarch, who presided over the reconciliation parley in the presence of other paramount rulers said as a father he could not stay alive to watch his children stay at opposite directions.

He advised the winner of the PDP primaries, Pastor Umo Eno to carry his brother and others along, as more hands make the job a lot easier.

A legal luminary and Executive Director of Compart Foundation For Justice and Peace Building Saviour Akpan Esq confirmed the position of law on PDP guberbatorial debacle in the state.

His words: "Onofiok Akpan Luke, Aniekan Akan Etim, Sen. Bassey Albert Akpan [assuming he did not leave PDP] cannot benefit from any action/decision of PDP to substitute Umoh Eno.

"They had written to withdraw from the Gubernatorial primaries. They did not participate. They termed the primaries as illegal. Only Aspirants/persons who bought the nomination/expression of interest forms are qualified. No stranger- Udom Inoyo, Dr. Essien, etc can come close to the substitution option. That is the position of the law "he stated"

Many have suggested that the only aspirant that PDP can substitute is Mr James Iniama who had maintained a peaceful disposition and conducted himself well as a genuine party man throughout the primaries.

What is left for the PDP reconciliation Committe to do in the prevailing circumstance is to ask pastor Umo Eno to officially withdraw his ambition as he has found himself in a tight corner.

This action will be supported by the new Electoral Act which had stated the obvious in such situation

By this provision of the new Electoral Act, the PDP in AKwa Ibom can arrange a fresh primary within the time frame stipulated by law to produce another flagbearer for 2023 governorship election.

The reconciliation Committe must ensure that only those who bought the form and are still members of the party participate in the fresh primary election.

Tackle graft, delay in litigation, Okutepa urges NBA President-elect

resident-elect of the Nigeria Bar Association (NBA), Yakubu Chonoko Maikyau, SAN, has been urged to tackle issues of corruption, bribery, and delay that usually bedevil the litigation aspect of the Nigerian law practice, especially at various Court registry.

A Senior Advocate of Nigeria, J.S. Okutepa, who gave the charge in a statement at the weekend noted with dismay the endemic corruption that bedeviled the court registry, the first collapse of Justice in the country.

He expressed dissatisfaction with the unprofessional of most Court bailiff-official process servers, as well as the difficulty and frustration at most registries in serving court documents from companies, working in connivance with some legal practitioners, using untraceable addresses and directors as hurdles in serving court

He said, "Whether you are young, or old, SAN or not, we all face these militating and excruciating experiences in practice. When you file processes, you go through hell to have them served. The process servers in most court registries, otherwise called bailiffs, are in most cases something else.

"Justice starts getting murdered from this stage. The frustrations you face when they act in collaboration with some lawyers on the other side are in most cases nightmares. Yet, without service, no proceedings can take off.

"It is worse when you are to serve companies that have no traceable addresses but have registered addresses on record; no traceable directors but have directors' names in CAC record."

The learned silk further decried the frustrating antics of trials in the hands of lawyers whose only brief may just be to frustrate the hearing of matter

while accusing some legal practitioners of deliberately employing these tactics when expedient.

"If and when you manage to get judgments, you may discover that there is no justice in the judgments. You then want to go on appeal. Here you are face to face with another hurdle.

"Certified true copies of some judgments are not ready to be collected for months after delivery. Some judges in Nigeria now have the habit of claiming

to be correcting judgments after they have been delivered.

"Whether these practices that have acquired notorious status across Nigeria are constitutional and legal are yet to be tested.

"The Nigerian Constitution says we are entitled to a copy of a judgment within 7 days of its delivery. In some cases, you don't get copies of these judgments/rulings for months.

Yet, inability to obtain or get copies

of judgments on time has been held not to be a good ground for extension of time," he added.

Okutepa urged the incoming NBA under the watch of Yakubu Chonoko Maikyau SAN to come to the aid of core litigation lawyers.

He stressed that lawyers must be seen as doing right, as well as "clearly defined boundaries for the judex, the registries and legal practitioners" in other to bypass the collective difficulty experienced by all.

Minister of Communications and Digital Economy, Isa Pantami, at the weekend inaugurated a Presidential Steering Committee for the technical review of the Integrated Payroll and Personal Information System (IPPIS), the Treasury Single Account (TSA) and Government Integrated Financial Management System (GIFMIS) over irregularities.

He is the chairman of the committee which also comprises the Minister of Finance, Budget and National Planning; Managing Director, Galaxy Backbone; and Chairman, Economic and Financial Crimes Commission (EFCC).

Others are Office of the Head of Civil Service of the Federation; Office of the Auditor-General of the Federation as well as National Salaries, Wages and Income

The rest are the Director General, Bureau of Public Service and Reforms (BPSR) and Director General, National Information Technology Development Agency (NITDA), who serves as the Secretary of

The committee is expected to 'cleanse' the systems from the manipulation of some corrupt officials.

Pantami during the inauguration said that the committee would be supervised by the ministry and the relevant government

The minister disclosed that the systems have technical challenges which needed

According to him, the committee has mandated to proffer solutions to the possible leakages inherent in the systems that were exploited by people to divert public funds.

"The committee is to advise the president on how to improve the systems particularly, if there are leakages that are being exploited by evil people," Pantami stated.

The efficacy of some of the government's payment systems, especially the IPPIS, has een put under spotlight following the uncovering of over N100 billion fraud by ousted Accountant General of the Federation, Ahmed Idris and the refusal of public lecturers to be enrolled on the salary payment platform.

As part of its argument in favour of the over five months of strike, ASUU has maintained that IPPIS was defective, prone to fraud and unworkable for a peculiar remuneration regime for university lecturers.

Pantami explained that at the time IPPIS (2006), GIFMIS (2012), and TSA (2015) were deployed, the provision of NITDA Act 2006 under section A of setting the standardisation of ICT deployment in federal public institutions was not followed.

He said as a result of this, "these three systems were not subjected to government certification and IT project clearance as encouraged by law and many other government policies.

"However, in spite of that, many achievements had been recorded by their deployment.

'For example, based on the report from the relevant institutions of government, the IPPIS saved the government over N120 billion, while TSA saved over N10 trillion for government."

According to the Minister, these records showed that government had recorded some gains, particularly in the recent allegations on the system by people who siphoned money.

"It is because of this that we must identify where the challenges are, if any and see how these systems can be enhanced technically.

'So that we will be able to consolidate the gains achieved so far and also improve on them to achieve many more successes,"

The minister warned that any institution that fails to give access would be reported to President Muhammadu Buhari.

"A punishment is going to be recommended to the President for implementation," he said.



Long before he was elected governor of Nasarawa state in 1999, long before he became National Chairman of APC, Alhaji Adamu Abdullahi, the Sarkin Yakin Keffi, represented Keffi, when it was part of Nasarawa at the Constituent Assembly in 1977. He was thirty years old (30) then.

On November 1, 1977, he addressed the Constituent Assembly. He declared on that day "Before I make my observation on the principles of the Draft Constitution, I would like to crave the me on the issue of ratification. I want to get the position clear in relation to the Head of States' pronouncements during the opening ceremony. I want to know at what stage we would decide or get to know exactly where the final authority for ratification of the Constitution lies.

Still before I make my observations on the Draft, I would like to know also whether the Head of State's speech during the inauguration ceremony would be

debated or not. I have some more observa-

tions to make. I would like to comment on the observations made by the Chairman of the Constitution Drafting Committee (Chief Rotimi Williams) when he was introducing the Bill. I want to emphasise the need to follow members to inculcate the spirit of oneness bearing in mind the diversities of our societies. I would like to mention here that it would appear that as a result of the military intervention in the political life of this country over a decade now, a lot of our citizens concept of federalism. We have to find avenues as much as we can, and we must try by all means to accommodate the diversities that are obvious in the plurality of our nation.

I would like also to comment on the Presidency as presently provided. I would like to observe that the Presidency as being advocated, new as it is, should not provide avenues for fear simply because it is a new venture in our political process. I do believe that in view of the diversities that have been inherent in our system, and

experiences before the advent of the military in our politics, we need some unifying grounds, or some unifying authority and I see this type of unifying factor in the office of the Presidency as is presently advocated in the Draft. We all know that our experiences over the Parliamentary system which we have experi-

mented upon in the past, a lot of energy had been dissipated in unnecessary rancor as a result of which certain fundamental issues had been deliberately ignored for selfish reasons and because of the destructive nature in accommodating one another's feelings with regard to national

When we get to the Committee Stage, I would want fellow Members to make a critical analysis of the electoral requirements for the Presidency as at present provided for in the Draft, that is, the area that stipulates what percentage of votes a prospective presidential candidate has to obtain from a given percentage again of the State that make up the Federation. I hope we will give some thinking to the provisions as is contained in the Draft of the moment.

I would like to make a comment or two on the Sharia even though previous speakers have made comments on it. I want the idea to be enshrined in the Assembly that the question of Sharia is fundamental to the existence of a citizen of this country who opts to have faith in Islam, and if we want to provide for the right of individual to pursue a faith

of his choice, we have to create avenues for the atmosphere under which he would observe the basic injunctions of his religion. Here, I would like to observe that the debate or the observation which people have made or have been making in the papers and some of the utterances one has heard this morning with regard to Sharia are, to my mind, not only emotional but very unrealistic. We are living in a country where it is a reality that in Nigeria today we have at least bearest minimum of forty percent of the entire population in the teachings of Islam. This being the case and these people having accepted the principles enshrined in the Islamic faith are binded by certain very strict requirements that would have to regulate their day to day lives. If this be the case, there should not be the question of your giving somebody a right to choose a religion and on the other side of the scale only to go back and remove his right to exercise that fundamental provision that you have in the Constitution.

I would like also sound a note of warning here on the comments in the papers and some of the views from one or two colleagues in the Assembly this morning. These comments seem to border on threat. If you do this, it would be this or that. The thing is, short of saying do not follow a particular faith in terms of religious obligation, you cannot stand between anybody and what he believes in.

Also, I would like to touch on the question of the creation of more states. The Draft at the moment touches on the fact that Nigeria is

Abdullahi Adamu on issues forty-five years ago composed of so many states, and in some other sections there seems to be a tautology on the procedure for creating new States where there is need for such creation. In as much as I cannot oppose the opinion of anybody, having realized the fundamental rights of any section in this country to determine its own political association, I would like to sound a note of caution that we should not be led by some super logics into being sentimental again on the question of States. We have to face it very realistically. We have to face it, bearing in mind the interest and aspirations of the particular group who want a State to be created for them. Their case should be taken into consideration.

I would also want to touch on the question of traditional institutions in this country. I do believe and very honestly, too, that for some time now we have been deceiving ourselves in this country. We, as a people, have certain norms of life that we cherish. This being the case it is absolutely unbecoming, Mr Chairman, for us to do away with them completely and neglect our traditional institutions which are the basis of our plurality as a people--- the institutions on which this country has relied over the past centuries, institutions that have stood the test of time, institutions that we can go to at critical moments of need. Maybe we tend now to relegate these institutions to a position of neglect. I feel we should distinguish between failures of institutions and the failures of functionaries of institutions.

Ebonyi founding fathers split over Umahi's successor

Barely six months to another governorship election in Ebonyi State, the political turf is being heated as intrigues over who succeeds the incumbent governor, Engr. David Nweze Umahi, heightened.

There is a cold war among the founding fathers of the state as Governor Umahi is allegedly 'foisting' the governorship candidate of the ruling All Progressives Congress (APC) Rt. Hon. Francis Ogbonnaya Nwifuru on the elder statesmen.

The attempt, The Trumpet learnt is allegedly being perfected by the governor, under zoning arrangement or charter of equity, which some of the elders had reportedly said does not exist in Ebonyi State.

A credible source further told The Trumpet that the governor's plan was to use the founding fathers to resurrect and proclaim that there's written charter of equity that had long existed in the state since creation, and therefore, it is the turn of the Northern Senatorial zone of the state to produce a governor in 2023.

Recall that Governor Umahi had during a recent courtesy call on him by the founding fathers at the new Government House, Abakaliki urged them to preach and insist that equity prevails in Ebonyi State governorship election in 2023.

He had consequently asked them to set up a committee to see to its actualization, as according to him, it will bring peace and unity.

The source further hinted that the fears of Governor Umahi that the APC gubernatorial candidate, Nwifuru, may not get the nod of the elders ahead the 2023 elections heightened after Nwifuru met with the founding fathers last week during which they remained adamant to his obvious overtures to be endorsed by them.

One of the founding fathers who did not want his name mentioned told The Trumpet that during the meeting, Nwifuru went into a lengthy narrative on zoning and why his

Izzi people had been accommodative of the rest of the other parts of the State and visitors being where the State capital is located.

According to the source, the APC guber candidate extensively argued and pleaded for the support of the founding fathers but apart from countering some of his narratives on historical grounds, they refused to succumb to his plea for them to endorse him.

"At this stage of our lives, ours remain to maintain peace, unity and ensure the progress of the State among everyone and not to take sides, because they are all our children. We are like the Referees and therefore shouldn't take side with anybody", the source told our reporter.

Unsatisfied with the feedback he got from the founding fathers after the Speaker's visit, another source within them authoritatively disclosed that recently, they received another invitation via text messages from their Secretary that a meeting had been summoned yesterday, Thursday August 11, 2022.

The agenda for the proposed meeting, according to the source, simply read; "Communique".

"When I got across to the Secretary to enquire more, I realized he was actually instructed by the Chairman to send out the invitation. But the natural concern for many of us was the agenda which caused some of us to enquire deeper.

"We were told it was about our last discussion with the Governor on the need for us to ensure that equity prevails. But because some of us share a different opinion that as elders, we cannot begin to take certain actions that is tainted with divisiveness at this stage of our lives, the Chairman saw the need to postpone the meeting indefinitely so we can meet and take a stand that will be in the best interest of all of us and the group", the source further hinted The Trumpet.

The elder statesman, however, expressed surprise that while they had thought that another date would be collectively agreed upon by the elders, they were shocked to receive another text message re-summoning another meeting by 11:00 a.m today being Friday, August 12.

"Again, I picked up my phone as usual and phoned the Chairman if the invitation was his directive and he said he's not aware of it. Well, my findings proved that it was His Excellency (the Governor) who asked the Secretary to summon the meeting and get us to concur with a communique that has already been prepared.

"For some of us, we have decided to stay away from that meeting because that's not the mode and pattern of convening our meetings. Those planning to meet tomorrow (today) has a hidden motive and agenda and we can never be a part of such", the founding father reiterated

The said Communique from the 'faction' now

loyal to the governor and his choice candidate, Nwifuru, led by a former Governor of the State which was sighted by our Reporter after listing the historical pasts of how Governorship had rotated peacefully among the three Senatorial zones of the State; from North to Central and then to the South, stated clearly that as elders they were deeply interested in the Governorship position returning back to the north under the principle of "Charter of Equity".

"Anything or anyone seeking to govern the State from any other zone can lead to crises and disunity which the State can ill-afford at this time in it's history", the communique which was yet to be officially endorsed by the Chairman and Secretary as the group's tradition demands reads in part.

However, The Trumpet also sighted another Communique prepared by the other 'faction' where the Chairman of the group and some others particularly from Ebonyi South Senatorial zone which countered the claims contained in the document prepared by the 'faction' loyal to the Governor.

Though, it is also yet to be officially endorsed, paraphrased, it reads in part, "... The Governorship position has always been contested among candidates from the three Senatorial zones... It was Dr. Ogbonnaya Onu from the South who contested against Dr. Sam Egwu from the north in 1999 and the founding fathers had no role to play in it. In 2007, Dr. Onu contested again against Chief Martin Elechi from the Central. In 2015 when Umahi vied from the South, Dr. Edward Nkwegu from the North against him. In all of this, the founding fathers did not and has never endorsed any candidate in the past.

"Therefore, the founding fathers cannot at this stage where candidates of various political parties have already emerged, delve into discussing the issue of zoning of the Governorship position to a particular zone. That is like shifting the goal post in mid way into a football match", the counter Communique reads.

The 'faction' of the founding fathers opposed to Governor Umahi rather advised that the best convenient time to discuss the matter should be in 2024 when there would be no serious political interests, and not now.

Another source said it is expected that should the founding fathers loyal to the governor proceed with their planned meeting today, the other faction comprising the Chairman and about five others may likely distance themselves from the outcome.

"We would also make our position known to Ebonyians in the coming days if they proceed further because we cannot allow some of our members drag all of us into the mud just for a morsel of meat", the elder statesman opined.

The Trumpet gathered that the founding fathers comprises former political office holders, public and private servants, who played prominent roles in the creation of the State. They include some former Governors, Deputy Governors, former National Assembly members, former political appointees, among others.

Pat Utomi unveils Labour Party plans for Nigerians

Urges youths to take back country

Renowned economist, Prof. Pat Utomi, has challenged Nigerian youths to embrace the challenge of taking back the country through the Labour Party in the 2023 general election.

"Entrepreneurship training programmes will be offered free to young people across Nigeria, from Jigawa to Jos and Jakande estates in Lagos, and capital support prepared in the associations that we have, with your 'soro soke' third force.

"In addition, we will talk about the listening clinics that we plan during the course of this month and going further from this month, these listening clinics will be opportunities for people across the country in different economic sectors and communities to express themselves about what their real problems are and tell us where the pain is, and suggest to us how they think the healing can come", he said.

He encouraged youths to rise up to environmental challenges, adding that the month of August is significant because Africa is observing its climate month and the world is celebrating youths.

"In this year that Africa is hosting COP27 in Sharm el Sheikh in Egypt, we want to urge the youths of our country, through a systematic programme that the #Obidient movement is developing, to begin to take over their country by taking over the environmental challenge.

Senator faults state pardon granted Dariye, Nyame, others

- Charges youth to give FG 3 months ultimatum to end corruption
- Says flagrant display of ill-gotten wealth worsening situation

The Senator representing Osun East senatorial district, Francis Fadahunsi has faulted the All Progressives Congress (APC)-led Federal Government over recent state pardon granted some Nigerians including two former Governors, Jolly Nyame of Taraba State and Joshua Dariye of Plateau.

The People's Democratic Party (PDP) Senator said the government is further entrenching corruption by granting such state pardon to politicians and public office holders convicted of corrupt charges.

He said such gesture might have negative consequences as the government might be encouraging the youth to engage in corrupt practices.

Senator Fadahunsi questioned the rationale in granting such pardon to corrupt political office holders after tax payers money had been spent to prosecute their cases to logical conclusion even at the Supreme Court.

He said, "leaders like former governors Joshua Dariye and Jolly Nyame who were convicted for financial crimes against their states are now being granted state pardon and the society are celebrating them.

"How would the frustrated youths be happy with the government, which had no effective sanction against corruption?

"I hereby challenge the youths to issue a three-month ultimatum to the Federal Government of Nigeria to get things right or face the consequences.

"it is unfortunate that the level of misap-

propriation and fraud is much and this could lead to a total collapse of the country.

" I am not encouraging the youths to take laws into their hands but embrace a civil means like dialogue and electoral process to change the system. The God of justice had landed in Nigeria to avenge the wicked."he said.

Speaking with journalists in Abuja on Saturday as part of his message to Nigerian youths in commemoration of the year 2022 International Youth Day, the lawmaker lamented the high rate of unemployment among the youths which he said is aggravating spate of criminal activities including banditry and kidnapping.

The retired Deputy Comptroller of the Nigeria Customs Service, who is the Deputy Chairman, Senate Committee on Customs and Excise said investigations had revealed that the young Nigerians having failed to make government improve the situation after the end-SARS protests in 2020, were now taking laws in their hands.

The Senator further alleged that educated young Nigerians are forming kidnapping gangs targeting the elite, the rich and those in government at all levels.

He said the youth were protesting against elite flagrant display of affluence, corruption and rot in the education, healthcare sector.

He said, "education is no longer within the reach of the poor any longer. The sons and daughters of the poor who were going to public schools are no longer getting quality education because government had refused to fund public education.

"Regrettably, the children of the elite are going abroad to study while those who could not afford foreign education enrolled their children in high fee paying private schools from primary to tertiary.

"Meanwhile, there are many idle youths who are prone to criminality because they are into drugs and are taking up arms against the elite and their children in form of kidnapping.

"There is a case of unemployment galore because children of the poor who are graduates of higher institutions could not get a white collar job in public establishments which had been flooded with sons and daughters of the rich and the elite.

"Employment slots in federal agencies had been reserved exclusively for the children of the elite.

"Automatically university graduates from poor homes are engaging in menial jobs and criminality while the talented ones embraced the entertainment industry where they had to use drugs to suppress complex.

"The Head of Service had also compounded the crisis by placing embargo on employments.

"The sons and daughters of the poor are therefore, highly frustrated while those of the rich are returning from overseas after their education to take appointment in the best health institutions and other federal establishments."

The lawmaker therefore urged the government to take necessary steps to address the time bomb by funding education and provide jobs with realistic empowerment programmes that could meaningfully engage the idle youths.

Speaking during inauguration of the Udu Ward 4 Executive of IPF in Udu Local Government area of the state, the commissioner commended the group on


its grassroots mobilization inclination.

442 parcels of Crystal Math uncovered in smoked fishes

No fewer than 442 parcels of Crystal Methamphetamine which were concealed in heads of fishes have been uncovered.

Operatives of the National Drug Law Enforcement Agency (NDLEA) made the discovery while carrying out due diligence on cartons of fishes for export to Dubai, the United Arab Emirates through the SAHCO shed of the Murtala Muhammed International Airport, Ikeja

Director of Media and Advocacy, Demi Babafemi, who made the disclosure on Sunday in a press statement, said the consignment arrived the airport on Friday 5th August.

The 11.90kg consignment was brought to the SAHCO export shed of the airport on Friday 5th August by a freight agent, Adekunle Oluwapelumi Paul, 32, from Yagba West LGA, Kogi State, who was promptly arrested upon the discovery that the seven cartons he presented for export contained parcels of the dangerous drug wrapped with foil paper and concealed in the heads of hundreds of smoked catfish.

following The. day. Saturday 6th August, another consignment containing 1.45kg cannabis concealed inside granulated melon and crayfish and packed among food condiments going to Dubai, UAE was

also intercepted by NDLEA operatives who arrested the freight agent, Ajisefini Lateef that presented the cargo for export at the SAHCO shed. The 39-year-old agent is from Abeokuta West LGA, Ogun State," Babafemi said.

Meanwhile, anti-narcotic officers at the Akanu Ibiam International Airport, Enugu have arrested a 50-year-Mgbeobuna Victor Eberechukwu for ingesting 77 pellets of cocaine. "He was arrested on

Saturday 6th Aug following his arrival from Addis Ababa, Ethiopia onboard an Ethiopian airline flight.

"The suspect who hails

from Idemili South LGA, Anambra state passed out the 77 wraps of the illicit drug in eight excretions spanning four days," he said.

He further stated that three suspects, Saifullahi Salisu Nafi'u and Abdulrazaq Mamman, were arrested in Zaria, Kaduna State on Thursday, 11th August with 1,112,350 tablets of Tramadol (225mg and 100mg) weighing 38.3kg.

"In Kano, a female drug dealer, Saratu Abdullahi, 28. from Wurno council area of the state was nabbed at Hotoro with 541 blocks of cannabis weighing 245kg," he added.

In another development, NDLEA operatives recovered a total of 1,773.25kg cannabis sativa at Ebutte-Meta and Akala in Mushin areas of Lagos State in separate raid operations between 9th and 10th August.

"At the Tincan seaport in Lagos, 86 parcels of cannabis indica (Colorado) weighing 43kg were recovered from a 40ft container during a joint examination with Customs and other security agencies.

"The illegal consignment seized on Friday 12th August came from Toronto via Montreal, Canada and concealed in two drums inside a Mercedes Benz SUV

in the container.

How \$1.9b monthly loss to oil theft puts Nigeria on edge

Nigeria is one of the major crude oil producing countries in the world. The country is among the top 15 crude oil exporting nations. Over the years, the country has been contending with oil theft, pipeline vandalism and oil bunkering, which have posed serious economic challenges and negative health implications for the entire country. Recently, the Federal Government declared that it loses over \$1.9 billion monthly to the menace, while the creeks and environment of the oil bearing states continue to be polluted. Last week, the Minister of State for Petroleum Resources, Chief Timipre Sylva, led a Federal Government delegation to the oil producing states to solicit support of governments of the nine Niger Delta states in a bid to end the menace. But in spite of the efforts, the oil and gas sector will require a long time to mend, **JOHNMARK UKOKO** writes.

igeria, richly endowed with huge deposits of crude oil and natural gas in several states of the country, is presently on edge. The country has earned trillions of dollars from crude oil and gas since the natural resources were first discovered in commercial quantity in 1959 at Oloibiri in present day Bayelsa State.

Sadly, most of the proceeds of crude oil sold in the last six decades ended up in private pockets of top politicians, military top brass and senior civil servants, while the country is left with little resources for economic growth and development of infrastructure.

Besides the diversion of crude oil earnings to private pockets, the country now grapples with massive and unprecedented crude oil theft and in spite of measures purportedly put in place by successive administrations to tackle the menace, no desirable results have been achieved.

Over the years, the United Nations (UN) and Organisation of Petroleum Exporting Countries (OPEC) had raised concerns about the impact of crude oil theft not only on Nigeria, but also on the global oil industry.

Evidences have shown that some powerful countries around the world collaborate with unpatriotic Nigerians to fleece the country of huge volumes of crude oil, hence the inability of Nigeria authorities to end the menace.

Unfortunately, most security apparatuses deployed to the Niger Delta region to protect oil installations and facilities turn around to aid and abet crude oil theft with unpatriotic Nigerians and their foreign collaborators.

Curiously, the menace that Nigeria has grappled with for years, seem to have worsened in the last few years of the President Muhammdu Buhari administration to the extent that top government officials, players in the oil sector and even International Oil Companies (IOCs) have raised the alarm that over 100,000 barrels of crude oil were being stolen daily.

While most Nigerians find it difficult to believe the revelations and disclosure of the IOC chiefs at a conference in Abuja last year, the Federal Government declared last week that the country was actually losing about 400,000 barrels of crude oil daily, amounting to about \$1.9 billion monthly

The development, which has

made it difficult for the country to generate enough revenue to meet its daily expenses, led to acute foreign exchange shortage in the economy and massive economic challenges in the country in the last few months.

The financial strains the country is passing through due to the massive crude oil theft, which has been adjudged the worst in the country's history, made the Federal Government to send a delegation led by Minister of State for Petroleum Resources, Chief Timipre Sylva to the nine oil producing states of the Niger Delta to solicit the support of the governors to end

Prominent among the states the delegation visited were Imo, Rivers, Delta, Akwa Ibom and Bayelsa, which is referred to as the state that had witnessed the worst cases of pipeline attacks and crude oil theft over

The delegation also had the Chief of Defence Staff (CDS), General Lucky Irabor and Group Managing Director (GMD) of the Nigeria National Petroleum Company (NNPC) Limited, Mele

Kyari, among others.
Speaking at the Bayelsa State Government House in Yenagoa, Sylva said the Federal Government delegation visited the state to seek collaboration against oil theft in the Niger Delta, adding that the stealing of crude oil was being perpetrated at an alarming rate and should no longer be tolerated, given its negative effects on the nation's economy.

Sylva, who lamented that oil production has been severely affected and also having negative impact on foreign investments in the country, commended Governor Douye Diri for his willingness to partner with the government to end oil theft and assured that the Federal Government was determined and desirous of ending the menace, adding that a lasting solution

was long overdue.

On his part, Irabor said the military has heightened operational engagement to stop criminal activities in the region, noting that the activities of oil thieves was a serious cause of concern, as the economy was bleeding and urged those involved in the act to have a rethink, failing which military action will be taken.

Also speaking, Kyari said the country was facing a dire

situation that is not just affecting the economy but also the environment.

Maintaining that the importance of collaboration with states in the region could not be over-emphasised, as only one tier of government could not do it alone, he said Nigeria was losing huge amounts of money daily to the menace, which was

seriously limiting the country.
Responding, Diri pledged
to collaborate with the Federal Government in its bid to tackle the menace, which he said, posed a serious threat to the Niger Delta region and canvassed urgent action to end the ugly trend in the interest of the state, Niger Delta region and entire country, adding that oil theft was also affecting government

at all levels.

He said: "Oil theft is affecting government at all levels. It has also denied the locals their means of livelihood. If the oil theft menace is not stopped or reduced drastically, the implications would be grave."

Recalling how the CDS discussed with governors on the issue, Diri welcomed synergy between the states and the Federal Government to tackle the menace and assured the delegation that his administration would play a vital role in ensuring that oil theft was effectively nipped in the bud.

His words: "The federal and state governments depend on

oil. So, oil theft does not affect only the Federal Government. It also affects the state and the local governments. We have spoken about this over and over again and we will continue to talk about it.

"We are talking about our environment that has been brazenly polluted through oil bunkering activities. If you go to our communities, you will see oil floating on our rivers and that has led to the destruction of our people's means of livelihood.

În Asaba, the Delta State capital, the message was the same, as Governor Ifeanyi Okowa also highlighted the economic losses the menace has imposed on the state and the negative impact on its economy.

He expressed concern over the impact of oil theft on the state's revenue and health implications on the people and the environment, adding that the state government was ready to support and collaborate with the Federal Government to tackle the challenge.

Okowa, who commended the delegation for the visit, pledged his administration's support at all times, maintaining that oil theft must be stopped so that the country's economy could thrive.

The delegation, which visited the nine oil producing states of the Niger Delta region to preach the gospel,

commended the Rivers State

Governor, Nyesom Wike and his Imo State counterpart, Hope Uzodimma, for their fight against oil bunkering and oil theft in their states even before the Federal Government woke up to the reality of the challenge.

On several occasions, Wike and Uzodimma visited locations where crude oil was being refined by local refiners, which posed serious health hazards to their communities and economic losses to the entire country.

It would be recalled that Wike on many occasions visited sites where criminals, in collaboration with some security forces, were reportedly engaging in oil bunkering, thereby exposing the people to danger.

Following his strides, it could be said that no politician at the state or federal level has fought oil theft and oil bunkering the way Wike had done.

While oil theft, bunkering and petroleum pipelines are being massively damaged, thereby making it difficult for the country to meet its OPEC production quota, the Nigerian Navy, the Nigerian Maritime Administration and Safety Agency (NIMASA) and other government agencies set up to protect crude oil production and pipelines, appear to be helpless or have been compromised.

And whereas OPEC offered Nigeria between 1.7 million and 2 million barrels per day production quota, the country has only been able to export between 1.1 million and 1.2 million barrels per day (mbpd) for several months running.

Although it is coming late, the Federal Government seemed to have woken up to its responsibility in setting up a committee to fight the menace and with the revelation of the Minister of Finance, Budget and National Planning, Zaniab Usman Ahmed, that the country was losing \$1.9 billion monthly to oil theft, it must not be condoned or allowed to continue going forward.

But whatever happens now or in the future, with the massive oil theft, dysfunctional refineries and continued importation of petroleum products, which had deteriorated to the extent of signing a Memorandum of Understanding (MoU) with Niger Republic for importation of fuel, the country's oil and gas industry and the economy will require a long time to mend.

Renewed port concession pacts ready soon, minister pledges

Inister of Transportation, Muazu Jaji Sambo, has assured that the details of the renewal of concession agreements with some terminal operators are now ready and will be perfected within the next 45 days.

He gave the assurance during a visit to the Nigerian Ports Authority (NPA) in Lagos at the weekend where Managing Director of NPA, Muhammed Bello-Koko, suggested that the five terminal operators will be given six months to renew their concession when their agreements expire soon to which the minister refused.

While addressing journalists during his visit to the Tin Can port, the minister said: "I do not have six months. I will ensure that the concessions are renewed in the next 45 days" and assured that he would prioritise the reconstruction of the dilapidated quay aprons of the Tin Can Port.

According to him, the quay aprons of the port are getting destroyed due to lack of maintenance, adding: "I have advised the management of NPA, in the past, there is what we call programmed preventive maintenance, this is why at every port, we have an engineering outfit headed by the Chief Port Engineer.

Part of his responsibility is to draw out preventive maintenance programmes for the ports under his jurisdiction every year, he takes it to the headquarters for consideration and approval and that forms part of the forthcoming budget.

"If you carry out preventive maintenance, you would avoid a lot of the deterioration that is taking place. This is the truth, the sooner we accept it, the better.

"As you would recall, I was posted to the Federal Ministry of Transportation on June 6, 2022. This is actually my second official assignment outside Abuja. I was in Kano for the Dala Inland Dry port to declare it as a port of


origin and destination.

"Today I am in Lagos, the maritime headquarters of Nigeria. The purpose of my coming to Lagos is to look at the ports and the related infrastructures which are supposed to support maritime activities. As you all, the ports are the gateway to the nation's economy.

"If we get our acts right, the maritime industry can replace the revenue from the oil industry, this is why we have come to see how we can support the port authorities in order to improve on their deteriorating structures," he said.

Speaking earlier at the Port and cargo terminal by SIFAX Group, Sambo said the NPA had approached him with a devastating problem that the Tican Port is facing.

"I personally attach great importance to the maritime industry, there are billions of dollars that can be earned from the maritime industry, if we get our acts right," Sambo stressed.

Outrage as Nigeria signs MoU to import fuel from Niger Republic

Public outcry has trailed the Nigerian government's Memorandum of Understanding (MoU) with its Niger Republic counterpart for the importation of petroleum products from the Sahel country.

A statement issued Nigeria's the Ministry, of Petroleum Resources, Soraz Refinery, Zinder, revealed that Niger Republic has an installed refining capacity of 20,000 barrels per day (bpd) domestic requirement, which leaves a surplus of 15,000 barrels per day.

Group Managing Director

Group Managing Director (GMD) of the Nigerian National Petroleum Company (NNPC) Limited, Mele Kyari, signed the MoU on behalf of Nigeria, while Director General of Niger Republic's National Oil Company, Societe Nigerienne De Petrole (SONIDED), Alio Toune, signed on behalf of Niger Republic.

The signing ceremony was witnessed by the ministers of state for petroleum of both countries- Chief Timipre Sylva of Nigeria and Foumakoye Gado of Niger Republic.

"This is a major step forward, Niger Republic has some excess

products, which need to be evacuated and Nigeria has the market for the products, therefore, this will be a win-win relationship for both countries.

My hope is that this is going to be the beginning of deepening trade relations between Niger Republic and Nigeria," the minister said.

Commenting on the development, Kyari said the two countries have had long engagements in the last four to five months with a view to restoring the importation of petroleum products from Niger Republic into Nigeria.

"With this development, we hope to have a long-lasting and sustainable commercial framework to have a pipeline from Soraz Refinery in Zinder, Niger Republic to the nearest Nigerian city, so that we can develop a depot.

"We are happy that we have reached that conclusion and our two ministers have endured this framework. We are also working on a detailed MoU between the two companies, so that we can continue the execution process immediately," he said.

Nigeria currently imports refined petroleum products despite having four refineries in the country, which have largely remained comatose for several years. As a result, huge foreign exchange is spent to ensure that there is no scarcity of petroleum products in the country.

Government officials have expressed hope that the 350,000 capacity Dangote refinery, which is near completion, will end the importation of petroleum products into the country.

Clearing agents suspend payment of customs duty at ports

Association of Nigerian Licensed Customs Agents (ANLCA) has directed its members to suspend further capturing of cargoes and payment of duties due to constant network malfunctioning and serial failure of the Nigerian Customs Service (NCS) server.

Acting President of ANLCA, Dr. Kayode Farinto, in a correspondence to members of the association, at the weekend, noted that the server failure was causing astronomical increases in duty payment on imported vehicles.

"We noticed on Friday, August 12, 2022 that there is a systems error on Customs' portal to the extent that when you make declarations, it was giving outrageous and astronomical duty payable. I have contacted the Nigeria Customs headquarters in Abuja and they confirmed that they were having challenges with their system, hence I advise

our members that if they have not made declarations on their jobs, they should kindly wait till Monday (today).

Hosaid the NCS has assured those who have already made assessment of their cargoes, at all area commands would be given access to cancel such declarations, adding: "Please let us kindly bear with them till the challenge is sorted out on or before Monday (today).

Customs generates N1.293tr revenue in first half of 2022

Nigeria Customs Service (NCS) has generated N1.293 trillion in the first six months of 2022 into the Federation Account.
Public Relations Officer (PRO) of

the NCS, Timi Bomodi, a Deputy Comptroller, disclosed this at a media briefing in Abuja at the weekend, saying the amount was an increase compared to N1.004 trillion generated in the corresponding period of 2021.

He said the amount surpassed its achievements for 2021 by N48 billion, accounting for 28.8 per cent, adding the revenue generation was remarkable, given the fact that only 116, 691 Pre-Arrival Assessment Reports (PAARs) were issued against the 129, 667 processed within the

same period of last year.
"Our half year scorecard comprehensively captures our activities from January to June 2022. The revenue target given to the Nigeria Customs Service for the year 2022 is N3.019 trillion, exceeding the target for 2021 by 80.78 per cent. As it has become customary, the service remains focused and steadfast in its commitment to meeting the challenges of the moment. It is fully confident in its ability to innovate and adapt to a dynamic socio-economic environment," he

Bomodi said N156 billion was also generated into the non-federation account as collections on behalf of other government agencies.

While giving a breakdown of the amount generated within the period under review, he said the figures was generated from excise, industrial incentives from free trade zones and anti-smuggling activities, among others.

On excise, free trade zones and industrial incentives, Bomodi said excise duty was tax levied on the manufacture, sale and consumption of goods under excise control.

Bomodi, who said the amount was collected through the 22 commands of the service, noted that N68 billion was collected from manufacturers of alcoholic beverages, as well as cigarettes and tobacco, among other

products.

"In the month of June, the service began collections from extant traders producing carbonated and sugary drinks newly added under schedule five of the CET. So far, the service has collected more than one billion Naira from carbonated and sugary drinks in the month of June.
"Other revenues from telecom-

munication, like call and data and digital network services are yet to be collected. The service is expected to start collecting revenue on these products and services as soon as the modalities for collection are put in place. Duties from these revenue sources are expected to boost our collections in the current year," he said.

Bomodi also said of the 42 free trade zones in the country, only 25 were active with 15 of them operating in Zone A, four in Zone B, five in

Zone C and one in Zone D.

He pointed out that in addition to providing employment opportunities for Nigerians, the special economic zones were expected to engender transfer of technology and building of local capacity, among benefits.

On enforcement and antismuggling, Bomodi said in the period under review, various goods with total Duty Paid Value (DPV) of N39 billion were seized due to policy infringements, adding that narcotics and other illicit drugs with DPV of N8.8 billion were among the top seven items seized, followed by foreign parboiled rice with DPV of N8.3 billion, among other collections.

OPEC pegs Nigeria's crude oil losses at N101billion

rganisation of Petroleum Exporting Countries (OPEC) has declared that Nigeria's crude oil production dipped by 2.3 million barrels in July 2022 compared to the production level in June 2022.

In its latest Monthly Oil Market Report for August 2022, OPEC stated that crude oil production figures based on direct communication indicated that Nigeria's output dropped by an average of 74,000 barrels per day in July.

This implies that for the 31 days in July, the country lost about 2.3 million barrels of crude oil. The organisation further stated that the average cost of Brent crude, the global benchmark for oil, during the month under review was \$105.12/

By losing 2.3 million barrels in July this year, it means Nigeria's

oil earnings fell by about \$241.1 million or N101.13 billion (at the official exchange rate of N419.37 to the dollar) in the month under review.

Data from OPEC further showed that Nigeria's oil production in June 2022 amounted to 1.158 million barrels per day, but dropped to 1.084 million barrels per day in July.

The country had produced 1.024 million barrels per day in May this year, according to figures released by OPEC at the weekend.

The Federal Government, operators and industry experts have consistently blamed Nigeria's poor output and its continued failure to meet the monthly oil production quota approved by OPEC on massive crude oil theft in the Niger Delta.

Chief Executive Officer of the Centre for the Promotion of Private Enterprise, Muda Yusuf, blamed the challenges in the oil sector on the high



level of insecurity across the country, adding that this had continued to discourage investors in the sector, leading to lower production of crude oil and lower earnings for Nigeria despite the increased price of crude, which witnessed marginal decrease in recent times.

He said: "Investors in the oil and gas sector continue to lament the challenges posed by insecurity, oil theft, unstable policies and inappropriate fiscal regimes. The downstream sector has continued to be weighed down by the pricing regimes and the regulatory environments which have continued to dim the growth prospects in the sector.'

Meanwhile OPEC stated that crude oil prices dipped in July, as against their costs in June, adding that crude in OPEC Reference Basket fell by \$9.17 or 7.8 per cent month-on-month in July to an average \$108.55 per barrel.

"Oil futures prices remained highly volatile in July, amid a sharp drop in liquidity. The ICE Brent front month declined \$12.38 or 10.5 per cent in July to an average \$105.12 per barrel, while NYMEX WTI declined by \$14.96 or 13.1 per cent to average \$99.38 per barrel," it stated.

They requested the Disco to provide more distribution transformers to their growing communities and replace the deteriorating electrical poles and wires affecting the power supply. Other complaints included high estimated billing and request for prepaid meters.

Sanda assured the customers of prompt resolutions to their complaints and announced that EKEDC is about to commence a 72-hour metering exercise (mobile MAP) for Agbara District in September to step up the metering of customers without prepaid meters and put the issue of estimated billing to an end.

She explained that the MAP scheme was reintroduced by the Nigerian Electricity Regulation Commission (NERC) to close the metering gap before the commencement of Phase 1 of the Federal Government's National Mass Metering Programme (NMMP)

CAPPA backs youths on calls to make Big Tobacco pay for harms

Global youth organisations have condemned the tobacco industry's resolve to create a new generation of smokers and users of their product through addiction and urged the government at all levels to make the tobacco companies pay for their past, present and future health hazards and harms their products were causing.

The youths, who spoke on behalf of themselves and future generations on the sidelines of the International Youth Day, which holds on August 12 every year are seeking justice, as well as get compensations and ensure that the tobacco industry does not get a seat wherever and whenever issues affecting the welfare of youths are being discussed at global forums.

In a statement issued in Lagos, Director of Programmes, Corporate Accountability and Public Participation Africa (CAPPA), Philip Jakpor, highlighted the tobacco industry's involvement in the vaping epidemic, digital marketing, sports sponsorship. child labour, environmental harms, including accumulated toxic single use plastics in the oceans, which are covered up by fake philanthropic programmes and dubious grants.

(CAPPA) joined the call of

the global youths.
"When governments allow the tobacco industry to influence tobacco control or vaping policy, they are serving the heads of our children to the tobacco industry on a platter and we should not allow this.

"Vaping policies should consider primarily the risks of youths' addiction and recreational use. The youths also want governments to exact tobacco industry accountability and liability, which can come in the form of revocation of licences. compensation for harms, financial guarantees for future harms and could involve court cases, tobacco surcharges, penalties, fees and taxes, among others, the statement reads.

The group also explained that smoking and consumption of other tobacco products cause eight million deaths yearly in addition to causing addiction and environmental hazards associated with deforestation in communities where tobacco plants are cultivated and discarded

It further pointed out that single use plastics in cigarette packs and butts alone cause at least \$20 billion yearly in losses of marine resources, which it insisted outweighed any economic gains of the tobacco industry, costing \$1.4 trillion in economic losses every year.

CAPPA, a Pan-African non-for profit organisation, is passionately devoted to working with African communities in building partnerships with them and taking collective social action towards the promotion and defence of the rights of peoples.

It challenges the abuse of Nigeria and Africa's natural resources, the environment and peoples through corporate state policies and practices.





Kane's late goal denies Chelsea victory in fierce London derby

ngland striker Harry Kane snapped a late equaliser for Tottenham to deny Chelsea a win at Stamford Bridge on Sunday.

This resulted in Conte going ecstatic to celebrate the goal outside his technical boundaries which angered Chelsea boss



Thomas Tuchel to respond likewise when Reece James scored the Blues' second goal in the 77th minute.

Following what looked like a finished job for Chelsea in front of their home fans soon turned sour as Kane in the additional time headed a late equaliser before stoppage time to spark an open confrontation between both clubs' managers.

Meanwhile, Conte in a post-match interview, refrained from commenting on the incident involving Tuchel, adding that he prefers to talk about the game

"My opinion is it's better to talk about the game. It was a difficult game for both teams and we try in every game to be competitive," he said.

The Italian manager, who was linked with a move to Paris Saint-Germain at the close of last season, as a replacement for Mauricio Pochettino, insisted that Chelsea proved to be a better team compared to last season

"Chelsea showed they are a really good team. Compared to last season we did better, but if we want to create problems for Chelsea [in the table] we have to be better," he continued.

"I don't want to comment on the [Tuchel] situation, this is not the most important thing. If there's a problem, it's between me and him. It's normal to come here and to suffer but at the same time we created chances to stay in the game," Conte added.

Chelsea in their next Premier League fixture will travel to Elland Road to face Leeds United who beat Wolves in their opening match before playing a 2-2 draw with Southampton on Saturday.

Prior to the US Open event, the duo will meet for the first time in Cincinnati on Monday, with the winner of the first-round clash taking on either Victoria Azarenka or Kaia Kanepi in the next

The American, who clinched her first of her six titles at Flushing Meadows in 1999, was tearful following her second-round exit to Belinda Bencic at the National Bank Open in Toronto on August 10, 2022.

Taiwo Awoniyi fires Forest to first Premier League victory in 23 years

Nottingham Forest striker Taiwo Awoniyi scored his first Premier League goal against West Ham United on Sunday to hand Forest their first Premier League victory in 23 years and 90 days.

West Ham scored the first goal through Said Benrahma which was disallowed by VAR in the 42nd minute before Awoniyi broke the deadlock in what resulted in the only goal of the game to hand Steve Cooper his first Premier League win since Nottingham gained promotion to the English top-tier last season.

Feelers have continued to overwhelm the entire space at City Ground that contains about 27,000 fans whose chants, "Forest

are back" rented the air spine-tingling.

According to postmatch Opta stats by The Telegraph, Taiwo Awoniyi netted Nottingham Forest's first Premier League goal in 23 years and 90 days (Chris Bart-Williams vs Leicester City in May 1999) – the longest gap between a team scoring consecutive goals in the competition's history.

Victor Osimhen made a switch to Napoli last three seasons ago from LOSC

Lille having had a spell in German Bundesliga with Wolfsburg and RŠC Charleroi in Belgium First Division A.

Penultimate the season he switched allegiance to Diego Armando Maradona Stadium, the 23-year-old scored 18 goals in 38 appearances for LOSC Lille coupled with 6 assists to propel Les Dogues to a fourth-place finish.

This goal-poaching attracted quality interest of Partenopei to spend a club-record fee of €70 million potentially rising to €80 million with add-ons, making him the most expensive African transfer to date.

Among the clubs that presumably boycotted the tournament were Kano Pillars, Wikki Tourists, Nasarawa United, Katsina United, and Lobi Stars.

However, due to their withdrawals, Kogi United got two walkovers to the final awaiting to play the winner between Niger Tornadoes and the Heartland of Owerri.

But in a twist of event, on Friday, the NFF, LMC and representatives of the clubs that are through to the Aiteo Cup quarter-finals, went for an emergency meeting where they reached a compromise in the spirit of fair play.

According to the resolutions reached, the NFF maintained that all the quarter-final matches will be played on August 20 in the earlier selected venue except Ilorin centre Heartland tackled where Katsina United.

Furthermore, the NFF said that 8 of the quarter-final teams will receive the sum of

Infantino said he was happy to have witnessed the historic event development on the foundation of the existing footballing framework.

FIFA President, speaking on Thursday at the groundbreaking ceremony of the African Super League by CAF at Arusha in Tanzania, explained that since the Africa Super League is built within the pyramidal structure of international football, it will definitely transcend success of club football in Africa beyond the continent.

"As FIFA President, I am happy to witness such a historic moment of this exciting football project to boost and improve club football in Africa," Infantino expressed during the groundbreaking ceremony.

"African club football needs to be brought to the next level and to do that, it is important to be innovative and to have new ideas, while fully respecting existing institutional framework.

"The Africa Super League, built within the international football pyramid structure, is a project which will make African club football shine in Africa and beyond," the FIFA President assured.

Earlier in his remark, the President of CAF, Dr Patrice Motsepe, during the launch of an innovation projected to change the face of African football, stated that the African Super League is one of the most historical feats achieved to grow football in all dimensions in the continent.

Motsepe noted that one of the benefits of the Africa Super League is that it would ensure African football is on the same pedestrian with UEFA, CONMEBOL, CONCACAF and other Confederations' tourneys.

"This is one of the most exciting projects in the history of African football and will significantly contribute to the development and growth of the quality and competitiveness of football in Africa," CAF President said.

"The Africa Super League would contribute to ensuring that football on the African managed Continent is and operated at the same professional, ethical and governance level as UEFA, CONMEBOL, CONCACAF and other Confederations," Motsepe clarified.

Moreover, CAF President added that the prize money in the tourney is \$100m with the winner receiving \$11.5m. He also said that \$1m will be sent to each of the 54 Confederations to help develop football in their countries which amounted to

Timo Werner rediscovers self in Bundesliga

striker Timo Werner has rediscovered his scoring form after returning to German Bundesliga for RB Leipzig. Werner completed the

move from Chelsea in the summer transfer window having failed to secure a starting place in Thomas Tuchel's squad.

Three seasons ago, Chelsea snapped the Germany international to Stamford Bridge in 2020 following his exploits for RB Leipzig where he finished the Bundesliga 2019-2020 season as the second highest goalscorer, behind Robert Lewandowski.

However, the player on getting to Stamford Bridge, could not perform as he did in the German topflight division under Thomas Tuchel who had to deploy him from the central striking position to the wings.

Despite the switch of role, the 26-year-old who scored 91 goals in 157 appearances Leipzig to become the club's all-time record scorer, could not replicate the same feat for two seasons in the English Premier League for Chelsea.

Consequently, sold Werner whom they bought for €53m back to Leipzig for €20m in a fouryear deal and the player who played five Premier League matches before he scored his debut goal for the Blues, opened the goal chart with a 30 yards powerful strike for Leipzig against Cologne in his first Bundesliga appearance on return to Die Roten Bullen.

Leipzig in their next Bundesliga fixture will travel to Alte Forsterei Stadium to face Union Berlin and the pair of Timo Werner and Christopher Nkunku, who both scored against Cologne, will lead Die Roten Bullen's







Ex-militants warn ministry officials, mull citizens arrest

ormer militant leaders from the nine states of the Niger Delta have warned officials of the Federal Ministry of Justice led by the Solicitor-General of the Federation Permanent Secretary, Mrs. Beatrice Jedy-Agba, to stop allegedly sabotaging the Presidential Amnesty Office. They specifically mentioned the probe of the allegedly looted N60 billion Amnesty Training Centre located in Bayelsa State.

The angry former warlords also warned that the alleged sabotage of the Presidential Amnesty Programme (PAP) from filling proper defence against a @3.8billion suit, plus damages filed by the accused fifteen companies involved in the 2019 looting centre is provocative and raising tensions across the region against the ministry and its officials.

Under the aegis of the eintegrated Ex-Militants Reintegrated Forum (REF), they, however, declared that failure by Jedy-Agba and others to allow proper judicial process as well as to immediately provide the Amnesty office with competent legal representatives to defend the alleged fraudulent cases as required by law, will lead to

them being declared "Persona Non Grata across the nine (9) states in the Niger Delta region and order citizen's arrest."

The REF, in a statement by issued its National Coordinator, former General Tony Ebikalaide (aka Black Spider), said, "at the strategic moment, alerts will be issued to all ex-militant camps to be on the lookout across the entire Niger Delta region to ensure citizen's arrest of the Solicitor-General of the Federation and Permanent Secretary, Federal Ministry of Justice Mrs. Beatrice Jedy-Agba, and other officials in the Judiciary fingered in the alleged plot to sabotage the PAP cases for their personal benefits."

Another group, Niger Delta Amnesty Beneficiary Forum, had accused Jedy-Agba and other officials in the judiciary corruption and being compromised.

The group said: "instead of the officials of the Federal Ministry of Justice and the of Solicitor-General the Federation and Permanent Secretary to support the legal representation made by the Amnesty Office's legal team against the suits filed by the accused 15 companies in the tune of N3.8billion, plus 21 per cent post - judgment fees, and special damages which can go as high as N5billion to N8billion,

Jedy-Agba and other officials in the judiciary are busy sabotaging the Amnesty office's efforts in court by removing the Amnesty Programme's legal adviser and other experienced legal officers from the Amnesty office to deprive the Amnesty office from putting in proper representation in court.'

The Niger Delta Amnesty Beneficiary Forum in their previous publication also stated that the "15 companies' suits had different directors, and were filed separately on the same day, but all 15 cases were assigned to only two (2) judges of the FCT High court.

It added: "Whereas there are over 140 courts within the FCT jurisdiction. What are the odds that one judge was assigned nine (9) cases, and the second judge assigned six (6) cases? We had our observers in these courts proceedings; therefore, it will interest you to know that the suits were diligently defended by the Amnesty office lawyers, but in a bid to ensure that there is no clog on their way, the Solicitor General hastily posted out the lawyers that were diligently defending Presidential Amnesty Programme against these fraudulent suits."

The REF called President Muhammadu Buhari and other officials in the Presidency, including the

National Security Adviser. Major General Babagana Mohammed Monguno (rtd.), to note the alleged schemes by some officials within the Federal Ministry of Justice and the Judiciary in collusion with plaintiffs suing the federal government; these officials may sabotage cases in court worth billions of naira in favour of plaintiffs for their personal

monetary gains.

It added: "These frequent acts of treachery and or treason, if not nipped at the bud, might cause grave economic and national security implications for the federal government.

"Mrs. Beatrice Jedy-Agba and her colleagues have taken our silence for weakness. Since the appointment of Col. Miland

Dixon Dikio (rtd.) as the Interim Administrator of PAP, the Niger Delta region has been the most peaceful region in the country. Col. Dikio vigorously worked with stakeholders to gain the trust and respect of the diverse ex-militants and ex-warlords camps. Col. Dikio has successfully repositioned the PAP towards achieving its core mandates as envisioned by our founding-father and hero, Late President Umaru Musa Yar' Adua GCFR, and Col. Dikio is on track with the PAP to achieve major milestones prior to 29th May 2023.

"We are all witnesses to the lawlessness and anarchy goingon in the country, where many parts of northern Nigeria are not motorable, including corruption

allegations and government officials for fraud by the Economic and Financial Ćrimes Commission. Col. Dikio (rtd.) is the only appointee by the President Buhari administration from the Niger Delta region that is directly working with exmilitant leaders and ex-warlords to stem the tide against violence, kidnapping of expatriates, pipeline vandalism and total anarchy that would have been caused by angry ex-militants across the oil and gas- rich Niger Delta region which could devastate the national economy.

"Can Mrs. Beatrice Jedy-Agba and her colleagues try this nonsense at the North-East Development Commission (NEDC) or any northern intervention agency?

"We are aware in the past that the sons and daughters of the Niger Delta region are the ones being used to truncate efforts of our region's intervention agencies such as the NDDC and the PAP, and against the development of our region, including the empowerment of people in the Niger Delta, but this timearound, we want to warn Beatrice Jedy-Agba, who hails from Edo State to thread carefully as she and her colleagues are no longer welcome in Edo state or any other state across the Niger Delta region.

Civil society groups from Nigeria and across Africa and ancestral peoples of the Federal Capital Territory, (FCT) who met in Abuja to mark the United Nations World Day of Indigenous peoples have expressed deep concern over what they consider as the continued socio-economic exclusion of indigenous peoples in Abuja. The groups said the situation is a time bomb that should be addressed without

Hundreds of stakeholders celebrated the August 09 event in the FCT with a regional conference, a workshop and a day dedicated to the promotion of indigenous heritage when thousands of indigenous peoples gathered at the Abuja Old park to showcase the culture and of their people. They insist that their land taken away represent the most significanť historical injustice they suffer.

conference organized

by Resource Centre for Human and Civil Education, (CHRICED) and the MacArthur Foundation was attended by hundreds of people, traditional rulers from the various kingdoms, Government Officials, Civil Society Organisations, (CSOs), Executive Director, CHRICED, Mr Ibrahim Zikirullahi, the (CSOs), media, labour, peasants, several representatives of indigenous peoples Environmental Rights Action, (ERA), Prof A B Ahmed of the Faculty of Law, Bayero University, Executive Director, Centre for Transparence and Accountability, (CTA), HRH Alhaji Ismaila Danladi Mohammed, Journalists for Democratic Rights, (JODER), and the members of the FCT Original Inhabitant Association. There are nine indigenous ethnic groups in the FCT namely the Gbwari, Koro, Bassa, Ebira, Ganagana, Gade, Gwandara and

Since 1976 when the Nigerian Capital was moved from Lagos to Abuja, the original owners of the land claim that have been subjected to all forms of sociocultural repression. They said peanuts was paid to them which does not meet up to the worth of their land.

In a communiqué issued at the end of the National stakeholders dialogue on Rights of Original inhabitants of FCT and signed by Dr Ibrahim Zikirullahi and leaders of several civil society groups the stakeholders said the bottled up anger of indigenous peoples in the FCT should be addressed to Justice.

stakeholders The indigenous peoples are distinguished by their ancestral land, their distinct language, culture and time honoured which are treasured values and have been preserved for centuries;
They noted that in Nigeria,

the rights of indigenous peoples in the FCT are a major challenge in the search for sustainable development, peace and stability

The participants said they recognise other ethnic groups like Hausa and Fulani who are in the FCT and have been there for several decades adding that they are not asking them to leave but to work with the other indigenous ethnic groups for peace and stability in the FCT.

The stakeholders in the communiqué said 'we are aware that the Original Peoples of the Federal Capital Territory, (FCT) are indigenous to their territories, their ancestral land which they have lived for centuries. That they own the land; the land is their livelihood, their dignity and pride; they have cultivated the land which is their greatest

material and spiritual assets.'
That the indigenous peoples in the FCT are about nine with their own culture and civilisations that continue to face existential threats from various dimensions;

Participants noted that in 1976, the history of Original People of FCT was deconstructed with the movement of the Federal Capital from Lagos to Abuja by the military government. The movement led to dramatic changes in the sociology, the land ownership, control and management effected through the military Decree 6, all of which affect the past, present and future of FCT indigenous peoples;

'That indigenous peoples in FCT are recognised by their own history and values backed by international instruments including but not limited to International Convention in Indigenous Peoples, the ILO Convention 168 all of which emphasise the protection of indigenous peoples including their intellectual and cultural

property" On December 23, 1994,

the UN General resolution 49/214 adopted the International Day of Indigenous Peoples to address the fears over ancestral land and associated lost resources.

The communiqué said that the FCT 1976 Decree 06 has affected the history, spirituality, indigenous knowledge, environment, culture, civilisations and heritage indigenous peoples of the FCT;

That indigenous peoples in the FCT have been consistently denied their right to land and capacity to own property in a territory that historically belongs to them. Other forms of discrimination and exclusion manifest through denial of access to ancestral land, lack of economic, political, cultural opportunities and identities, denial of statehood, denial of opportunities access to utilities like health, quality education and job opportunities' they said.
