

Progressives Congress (APC) presidential candidate Bola Ahmed Tinubu is intensifying his parleys with the camp aggrieved Peoples Democratic Party (PDP) henchmen led by Rivers State Governor Nyesom Ezenwo Wike.

The APC torchbearer is said to have met in London with Wike and two other PDP governors, Samuel Ortom(Benue State) and Sevi Makinde (Ovo) to boost his chances in next year's general election.

Tinubu left Nigeria on Monday for Europe on a week's break and did not attend the NBA conference to which he and other presidential candidates were invited.

Yes, we left Nigeria to meet with Tinubu on We initially Monday. thought it would hold in France because that was where Tinubu went the last time he left the country. We however got signal close to our time of departure that we should proceed somewhere else.

Governors Ortom and Makinde who have been supporters of Wike from the beginning were also on the trip," the source told a newspaper.

The source confirmed that the meeting was connected with the APC candidate getting Wike's support for Tinubu in next year's election: "Yes, the discussion was centred on the 2023 election. The Tinubu camp know how important votes from Rivers State are and are Wike to work for them.

While it may the hard for Wike to leave the PDP because of some of his followers who are already contesting elections in the party, the Tinubu camp is expecting him to use his influence in the state to work for them and deliver Rivers for the APC.

Since Wike lost the PDP presidential primaries to former Vice President Abubakar, Atiku has allegedly rebuffed moves by party leaders to

Spokesperson for the groups, Victor Duniya, said the implication of the contract was that "a private citizen like Tompolo will be allowed to handle not just light but sophisticated weapons to be able to ward off possible bunkering cartels."

The Federal Government had reportedly renewed the pipeline surveillance contract to Tompolo, who was Commander of the defunct Movement for Emancipation of Niger Delta (MEND).

According to Duniva, the development is coming at a time the North is bleeding profusely due to activities of terrorist elements, while youths are not allowed to get weapons to defend their communities.

He, therefore, called on President Muhammadu Buhari to sack the Minister of State for Petroleum, Timipre Sylva, Chief Executive Officer of NNPC Ltd., Mele

Director, Upstream, Adokiye Tombomelye, over the roles they allegedly played in the

contract procedures.

Duniya added: "We are aware that Tompolo and his boys are major beneficiaries of the Presidential Amnesty Programme (PAP), wherein Federal Government under the leadership of the late Umaru Musa Yar Adua extended same to the restive youths of the Niger Delta.



Chairman, PDP Board Senator Trustees, Walid Jibrin, gave the hint about Ayu's possible resignation on Sunday, when he appeared on Television Channels programme, Sunday Politics.While confirming that it was not right for the PDP presidential contender and the party's national chairman to come from the same Northern region of the country, the BoT chairman revealed that a report on the matter is being awaited by the party's national leadership.

As the party's national caucus, BoT and National Executive Committee (NEC) plan to convene any moment from now. it was also gathered that the recommendation of the various reconciliation committees will guide action on the issue.

It was also learnt that while the Wike camp made Ayu's leave their cardinal demand, some members faithful to Atiku Abubakar emphasized through a that only mini convention after the general elections could Ayu be replaced. to Attempts Arapaja's response to the development failed as the National Vice Chairman did not pick calls or reply to SMS sent to his phone line. However, when contacted, the National Publicity Secretary of the party, Debo Ologunagba, said he was yet to know.

The last meeting of NWC was last Thursday, the next one will be next Thursday and there is nothing like that on the agenda to my knowledge as of now," Ologunagba

Barely four days after the Umaru Fintiri-led PDP peace panel met in Port Harcourt to address the two stalwarts of the party, an atmosphere of unease and anxiety has overtaken the party.

The camp of the Rivers governor has not just emphasized that Ávu

¬ do State Governor **d** Godwin Obaseki has **⊿** urged stakeholders to step up global efforts to end the scourge of human trafficking and all other forms of modern slavery.

He made the call in commemoration of the International Day for the Remembrance of Slave Trade and its Abolition. It is marked on August 23, every year, by the United Nations Educational, Scientific and Cultural Organisation (UNESCO), to remember the transatlantic slave trade and its abolition.

Call for Orton's impeachment won't distract Nigerians from APC's misrule, says aide

• Alleges it's plot to cover up failure of Buhari's govt

alls by the Benue State chapter of the All Progressives Congress (APC) for the impeachment of the state governor, Samuel Ortom has been described as an effort in futility which cannot stand the test of time.

This is as a former governor of the state and serving senator of the APC, George Akume, was asked to address the total failure of his party under the administration of President Muhammadu Buhari in all aspect of governance.

An aide to Governor Ortom, Mr Terver Akase said members of the ruling party, including Akume should have been more concerned about how to revamp the country from the brinks of collapse which an APC government has driven Nigeria, than engaging in petty futile exercise of trying to unseat a performing state governor.

According to him, the current move by ex-governor Akume to unseat Ortom will suffer same defeat and disgrace as in 2018 when he sponsored eight out of thirty members of the Benue State House of Assembly to impeach governor Samuel Ortom for dumping the APC for PDP.

Akase, the Special Adviser on Media and Publicity to the Benue State governor, lamented that the fresh call by the APC

and it's chieftains in the Benue State for Orton's impeachment, is coming at a time when the APC government at the centre failed to tackle insecurity of terrorism and banditry. He said such calls was just "to cover up their failure."

In his reaction to the call for impeachment of his principal, he noted that the APC's press conference which was addressed by its State Publicity Secretary, was a clear attempt to divert attention from the concerns, fears and focus of Benue people and other Nigerians on the disturbing matters of insecurity occasioned by the failure of the Federal Government which Governor Samuel Ortom has constantly been speaking about.

While saying that the lame distraction of APC was long expected, he fingered the APC leader in Benue, Senator George Akume as the mastermind of the statement made by the APC Publicity Secretary in the state.

Akase, in a statement made available to the media said "we are aware that the APC press conference in Makurdi on Friday was a ridiculous response to Governor Ortom's recent call for the impeachment of President Muhammadu Buhari on account of his inability to lead the country.

"Their outing was also an attempt to divert attention from the plethora of problems facing the APC in Benue State arising from their yahoo yahoo primary elections which aftermath is the court cases instituted by aspirants of the party, as well as their deepening crisis over the choice of a deputy governorship candidate.

"APC is in shambles in Benue State and the only way for them to breath is to launch media attacks on Governor Ortom.

"An attack on the Governor earns them instant 'commendation' from the Villa.

"We expected APC to address the confusion within their party and not raise infantile allegations over local government administration. A party that thrives on imposition and marginalization while abhorring justice and equity lacks the moral standing to question anyone on accountability.

"Our response to APC's allegation that Governor Ortom has been mismanaging local government funds is simply that he who accuses should provide proof.

"We challenge APC to publish evidence to back their claim that the Governor has turned local governments to his private use and has been diverting funds meant for the councils.

"They should spare Benue people of the stress in searching for the proof. It is on record that in the last seven years, under the Ortom administration, three different local government elections have been conducted and three sets of council chairmen duly elected.

"The APC should be worried that it was unable to field candidates for the last local government election in Benue. How was Governor Ortom responsible for the party's failure to present candidates for the council polls?

"It can be confirmed that Governor Ortom has ensured that leaders of the Nigeria Union of Local Government Employees, NULGE, the Nigeria Union of Teachers, NUT and several labour unions, as well as the association of local government councilors are members of the Joint Account Allocation Committee in Benue State.

"The unions know precisely how local government funds are administered. APC in Benue State has every reason to be desperate owing to the mass defection of its members into the Peoples Democratic Party, PDP as the 2023 elections draw closer.

"A party which suffered a devastating defeat in 2019 and is now facing another defeat in 2023 has justification for distress.

"The pain of the impending defeat of APC is inevitably similar to circumcision. The cry of a baby does not stop it. Governor Samuel Ortom remains committed to serving his people and standing with them.

"He will neither be discouraged nor distracted by the sponsored media assault."

Breach of power rotation will affect Atiku's 2023 Presidency, VON's DG claims

As the 2023 general elections draw closer, a Chieftain of the All Progressives Congress (APC), Mr. Osita Okechukwu has disclosed that the breach of the power rotation principle is affecting the chances of the Presidential candidate of People's Democratic party (PDP), Alhaji Atiku Abubakar. The Chieftain said according to the APC Northern Governors' letter to President Muhammadu Buhari dated June 4, 2022, there was an evidence that the rotation of the presidency between the North and South is intended to unite the country.

I was part of the meeting when the agreement was made between Northern and Southern Leaders. I am even surprised PDP gave her ticket to another North candidate.

"It will be an injustice to the South if the North retains Power after 8 years of rule."

Consequently, Okechukwu, who is also the Director-General (DG) of Voice of Nigeria (VON), remarked that it would be a herculean task for Atiku in his mission to divide North and South to defeat the APC Northern Governors' Forum, President Muhammadu Buhari, former President, Olusegun Obasanjo and a host of other unifier patriots like Afenifere Leader, Pa Ayo Adebanjo, Governor Wike, Chief Edwin

Clark and uncountable unifier patriots who support power shift from North to South.

The Enugu State APC chieftain, who spoke to journalists on Sunday, added: "My take is that Atiku is not a unifier and cannot defeat the Northern Governors' Forum, Buhari, Obasanjo, Adebanjo, Clark and sophisticated northern electorate by his mission to win by dividing the north and the south.

Six die in Ondo auto crash



Troops kill many terrorists in Sambisa forest bombardment

Many terrorists have been reportedly killed by a Nigerian Air Force (NAF) jet under Operation Hadin Kai (KAI). It followed the bombardment of terrorists' hideouts in Sambisa forest and the Tumbuns in Borno

Troops while acting on credible intelligence were said to have directed NAF aircraft to a location in Sambisa forest believed to be the enclave of a notorious terrorist, Fiya Ba Yuram, the current Islamic State West Africa Province (ISWAP) who succeeded leader, Abubakar Shekau.

According to a source, the title 'Fiya' connotes the most senior position in the terrorists' militant hierarchy.

The source noted that Yuram was an ally of and switched allegiance to ISWAP after his death.

The source disclosed that on arrival at the location, the soldiers observed activities, hence, air bombardments were carried out on the location on Monday.

It added that successful strikes on the location, many terrorists were reportedly though it remained unclear if Yuram was among the casualties.

In a similar development, air strikes were undertaken in the Tunbuns near Lake Chad after suspicious activities were observed believed to be terrorists' training camp. The targets reportedly went up flames.

After the airstrike, there pandemonium the location, as surviving terrorists took cover under nearby trees, which were later struck by the aircraft, a source said.

The source further said the ability of the Armed Forces of Nigeria (AFN) and other security agencies, alongside their foot soldiers, to pick out key terrorists' targets for elimination is also indicative of the credibility of the intelligence provided.

When contacted, NAF Director of Public Relations and Information, Air Commodore Edward Gabkwet, confirmed the strikes adding: "Yes, strikes, adding: strikes were carried out on some specific targets in the Tunbuns and Sambisa with varying degrees of successes recorded.

"This followed IGP's directives to all Commands Formations immediately commence a special visibility policing operation across country. In compliance with this directive, Sokoto police command began crime mapping, identification of vulnerable points, massive and deployment of personnel on motorized and foot patrols in addition to the utilization of intelligence on targeted locations where several raids on criminal hideouts were undertaken.

"In the same vein. this police command is determined to secure critical government installations and most importantly the Nigerian Correctional Service facility in the state and it is on this note that had already jointly conducted a review of the existing security architecture, and identified the gaps and vulnerabilities at the Custodial facilities and currently complementing the Service strength in its determination for upscaling security in and around such facilities and never to allow any avoidable security breaches.

Call 'Obidients' inconsequential at your own peril, Fani-Kayode warns APC, PDP

• They're far more dangerous to our collective cause as a ruling class, he says

Tigeria's political elites as well as their supporters in the larger parties have been warned to be weary of the cult-like growing followership of the presidential candidate of Labour Party, Mr. Peter Obi.

Flamboyant politicoan and former Aviation minister under the Peoples Democratic Party (PDP) administration, Mr. Femi Fani- Kayode otherwise known as FFK who sounded the warning said the swelling popularity of Obi and the Obidient Movement of his followers is a big threat to the interest of the ruling class ahead of the 2023 election in the country.

Rather than casting aspersions on the movement, he said the loading political revolution at the instance of the Obidients may consume elitist politicians.

Projecting the movement as a generational and paradigm shift in Nigerian politics, Fani-Kayode in an article, titled: "Who Are These Obidients", posted on his verified Facebook page noted that the movement is capable of riding Nigeria of the old order and usher in the new.

He went ahead to instil fear in elitist politicians that they should be ready to vacate the country, if the LP candidate becomes Nigeria's next president, saying: "If they ever get power, many heads will roll and many of today's and yesterday's leaders will run into exile or go into hiding. This is especially so of those who have something to hide or who have skeletons in their cupboards.

"They want a real and fundamental change and not a fake one. They want to pull the whole house and system down with everyone in it and rebuild a new one in their own image, with their own values and on their own terms.

"Most important of all they want to see the back of those of us that are in any way associated with the old order or that have been in Government or the corridors of power at ANY point in time over the last 62 years. That desire and sentiment is the force that is driving and propelling them and that is kindling their fire and swelling their ranks.

"That is what makes them so threatening and I repeat, those of us that are in the larger political parties or that are members of the existing and ancient ruling class underestimate them, ignore them and display disdain for their firm resolve and rising anger at our own peril."

Ignoring the movement and regarding the Obidients as being an inconsequential bunch that only exist on social media, he said, will be dangerous.

FFK said: "most of my political associates, friends and colleagues across party lines tend to dismiss them with contempt. They regard them as being inconsequential and argue that they only exist on social media. I beg to differ. I see them in the streets and I see them in the Churches.

"I see them amongst my staff and amongst those that regard themselves as being amongst the oppressed and downtrodden. I see them amongst the professionals and those that are bankers, lawyers, doctors and artists. I see them in the North, West, East and South. I see them everywhere and not only on social media.

"I see them as being a very powerful and potent rising force which, if properly managed, will develop into a major political power over the next few years with a strong ideological and electoral foundation and massive structures. That is the potential that they have and that is how dangerous they can be.

"The sooner those of us that are in the larger political parties get off our high horses, display a little humility, try and understand their mindset, reach out to them, take them more seriously, appreciate their anger, restore their hope, make the necessary concessions and try and abate their rage and rising angst the better it will be for us all. They may not have today but if we do not play our cards right they may end up having tomorrow."

Saying that the movement is gradually gaining ground in every part of the country, he stressed: "those that are the supporters of Peter Obi, the Labour Party presidential candidate, are known as 'Obidients' and they are EVERYWHERE. Those of us in the larger political parties like the ruling

APC and the opposition PDP, treat them with contempt and ignore them at our own peril.

"The truth is that they are far more dangerous to our collective cause as a ruling class than many of us can possibly conceive or appreciate. Only the discerning can appreciate this and know precisely where this whole thing may be heading.

"They may not have structures or elected representatives in the legislative and executive arms of Government but they have IDEAS and VISION coupled with a clear ideological and philosophical bent which can and will endure for far longer than mere political platforms and structures.

"Unknown to them as well as virtually everyone else, therein lies their power. As they say, an idea whose time has come cannot be stopped. Long after we are all gone they will still be here because structures and political alliances rarely endure but IDEAS and VISION last forever.

"Again they will outlive and outlast us all because they are not a political party in the true sense of the word but rather a growing national movement which scales and spreads across ethnic, religious, political and regional lines and traditional boundaries.

"They also represent a generational and paradigm shift which is increasingly attractive to many and they are bound tightly together by a common purpose, common cause and common objective: namely to rid Nigeria of the old order and usher in the new. That is really what they want to do and that is the primary and strongest source of their inspiration and motivation.

"They are far more dangerous to what

the French describe as the 'Ancien Regime', the old political class and the entire system itself than anything we have ever seen before because most of them, bar their leader and a small handful of political tried and tested veterans and old war horses around him, are NOT politicians and have never ventured anywhere near the political arena or the circles of power.

"In the main they are an innovatively aggressive and frightful array and association of angry and determined young men and women who clearly have the courage of their convictions coupled with the audacity, fury, daring, rage and firm resolve of those that were involved in the Endsars protesters and the fiery footsoldiers that effected the 1917 Russian Bolshevik revolution led by Vladimir Iliyich Lenin.

"There is also something Rawlingesque and intimidating about them. That is to say they are like the late, great and mighty son of Africa and leader of Ghana, President Jerry Rawlings, who also led a successful revolution in his country in 1979 and who, on his second coming in 1981 when he toppled yet another Government said, 'if there is no justice there can be no peace!'

"That is the spirit that is in the Obidients and that is what moves them. Yet though they do not like to hear it their chances of winning the presidential election next year, short of a miracle, are very slim and deep down they all know it even if they refuse to publicly acknowledge it.

"Despite that they are determined to fight to the end, hope for the best, work hard and give it their best shot and, of course, therein lies their victory. In this game courage is the key. As they say, 'he who dares wins'. Again as they say, 'fortune favours the bold' and these young people are both daring and bold.

"That they can challenge the status quo and vie for the sacred and awesome power that has been shared by the two major political parties or their ancestral variants over the last 62 years is commendable in itself. I am not part of them but I certainly commend and applaud their efforts.

"They too have a right to fight for their rights and future and to be heard. They too have a dream and a story to tell and we must never begrudge them that. Of Reptiles, Primates, Insects and Statecraft

By the time the administration of President Muhammadu Buhari winds up on Monday May 29, 2023, it would have taken our country through every conceivable insanity and ridiculousness.

Beyond the time-worn, tripodal possibilities of "the good, the bad and the ugly," Nigerians have gone through what the iconic afrobeat musician, Fela Anikulapo Kuti, described as experiences in "craze world."

Just name it: record-breaking killings in peace time; freestyle abductions even under the daylight nostrils of security forces; unabated insurgency, unceasing terrorism. Festering banditry, bestial butchery of hapless and innocent folks by psychopathic marauders, mindless arson, deliberate violence and vandalism, headline the manner of deathly motions our despairing people have gone through, these past 87 months.

Earlier this year, "SBM Intelligence," a socioeconomic research firm in its "Media Reported Killings in Nigeria" submission for 2021, put the death toll of Nigerians lost to insecurity within the period at 10,366. Nigeria's President, Muhammadu Buhari personally received the report. The death toll was attributed to "violent incidents including attacks from Boko Haram, militia herdsmen, abductions, gang clashes and terrorism."

The same report observed that nearly one thousand security agents were killed within the period under review. This included 322 police officers and 642 soldiers. Tallied together, using the 2021 average, Nigeria might have lost close to 80,000 people to a miscellany of painful deaths and exterminations, under the Buhari regime.

This is the manner of unimaginable waste and ruination of highly prized human capital Nigeria has suffered in recent years, numbers which can successfully drive the socio-economies of some countries elsewhere in the world.

Road travel, hitherto the preferred and most popular means of movement, is spiralling out of the reach of ordinary folks. Increasing commuting costs attributable to fly-away fuel prices, and the potential of highway attacks in various ways, have impacted road travel adventurism in several ways. I have not, for instance, been able to brave a trip to my hometown, Isanlu in Kogi State, hitherto an oasis of sanity and serenity, viciously violated two years ago, by daredevil robbers.

Attacks on segments of the national rail system which is still being developed, has compelled discontinuation of services in parts. Airlines are shutting down because of heightening operational costs. The few airlines keeping afloat, have stuck virtual daggers in the throats of air travellers, one way economy class trips now hovering around the \$200 mark.

Inflation figures pole-vaulted to 19.64%, basically 20%, in the month of July 2022, the highest it has been since 2005. This was when the Peoples' Democratic Party, (PDP), the much maligned opposition party by the ruling All Progressives Congress, (APC), held sway. Foodstuffs, fuels such as diesel and kerosene, have become virtual untouchables.

Nigeria's currency, the *naira,* is one of the weakest and worst in the African continent. According to a survey report, the naira ranks "number 24 among the poorest currencies on the continent." It exchanges for about N710 to the dollar in the parallel market, away from N199 to the USD, in May 2015, when the Buhari government came into office. Critics of the administration have

repeatedly enjoined Buhari, to revert Nigeria to its situation and standing as at 2015.

Amidst this very grim and disheartening scenario, Nigerians have, in staccato sequence, been subjected to the wry humour of zoological dimensions to the nation's travails. The monumental heist, the scandalous looting, the quantum stealing which has been perpetuated at various levels, in ministries, departments and agencies under this government, have been casually explained away as atrocities perpetrated by animals of various kinds! Primates, reptiles, insects and the like, have been listed and accused as complicit and culpable in the novel rape on our commonwealth, by today's trustees of our nation's resources and economy.

Hitherto, mindless and spontaneous incineration of sections, departments or whole organisations where mammoth thievery was committed, was the vogue. It was popular expectation in the past, that every other organisation which came under the spotlight of public scrutiny, crashed in an incendiary heap overnight. Every trace of malfeasance, therefore is safely buried beneath the ash dust and rubble of such edifices, sparing no room for forensic inquisition.

These days, however, rapists of our communal resources have upped the ante of their atrocities. It will become expedient henceforth, for codes of conduct and ancillary regulations of public service, to accommodate minimum competence in zoology, as prerequisite for intending public servants.

No financial losses were disclosed when animals first became major stakeholders in the corporate governance and administration of the Buhari regime, back in 2017. Presidential spokesman, Garba Shehu simply told Nigerians that vicious rodents encroached into the office of the president while he was away for nearly four months on his trademark medicals in the United Kingdom, that year.

According to Shehu, the rodents turned Buhari's office upside down while he was away, puncturing office furniture and eating up the pipe network of the airconditioners serving the office. While rehabilitation efforts proceeded, Buhari squatted in a corner of the "Office of the First Lady." This is just how very important rodents and similar animals must be taken in governmental affairs.

Early 2018, a reptile reportedly swallowed a whopping sum of N36 million from the strong room of the Joint Admissions and Matriculation Board, (JAMB). As I write this, there is a news report to the effect that the Independent Corrupt Practices Commission, (ICPC), is investigating massive fraud to the tune of N11 Billion, perpetrated by the same JAMB.

Hopefully, this was not swallowed by a whale or an elephant, which rank in the bracket of the largest creatures. I'm restrained from further comments for now because Ishaq Oloyede, the professor chief executive of JAMB, has had an impressive public service profile thus far. Let's see how this pans out.

Since the N36 million JAMB snake incident, however, phantom animals have grown more and more emboldened and brazen, ever snacking so indiscriminately at public resources. A week later, the sum of N70 million belonging to the Northern Senators Forum, (NSF), and kept in the custody of the present National Chairman of the APC, Abdullahi Adamu, was reportedly ingested by "monkeys."

Adamu, then a serving senator and chair of the NSF, lost his position as leader of the body to mismanagement of the funds.

Earlier this year, however, he was gleefully rewarded with the apex position in the party's hierarchy. This self same Adamu, had in the past, held very enviable senior executive positions, not the least as two-term governor of Nasarawa State, and Works Minister at some point, under the erstwhile military government.

A quizzical question has been making the rounds on the social media lately. It has the images of three creatures, namely: a rat, a monkey and a termite. And the question is: Which is the strongest of these animals? The last in this list, the termite that is, has joined major stakeholders in our current governance system, owing to a very recent development.

A few days ago, documents containing multibillion naira transactions by the Nigeria Social Insurance Trust Fund, (NSITF), were declared missing. Officials of the agency reportedly told a committee of the Senate, that all the files and records bearing the breakdowns of expenditure worth N17. 1 Billion, had been eaten up by termites.

This vermin infestation, according to the government officials summoned to illuminate this unthinkable discovery, was compounded by the rage of the elements, namely the rain in this instance. It completely destroyed the metal container which housed the files and papers, obliterating every record and document. Curiously, the termite in the three-way quiz earlier alluded to, bested its competitors, the snake and the monkey!

This is how ridiculous our country has sunken in the eyes of the world. We are a tragic laughing stock, a caricature for popular, global amusement, even as we continually humour ourselves as "the giants of Africa."

We have in place a government which rode on the horseback of popular sentiments and support. It pledged to do things differently from the preceding government, including the reversal of every misdeed and affliction, hitherto foisted on the country. The high point of its manifesto was its advertised determination to fight corruption and instill accountability in governance.

Yet, back home, our people and troops are forever at the mercy of mean-spirited insurgents, Fulani militias, terrorists, kidnappers, gunmen, each geopolitical zone contending with its own peculiar security issues.

Buhari cannot feign ignorance of the crass kleptocracy which has defined his

administrations in various ways. The dubious "school feeding programme," for which several billions of naira was voted, yielded *kwashiokored* children and robust contractors. What became of the whimsical *tradermoni* scheme for which billions of naira was voted under some ill-thought empowerment scheme, which was just a violation of our national treasury? How about the multibillion naira *COVID-19 palliative programme* which only delivered severe dis-empowerment for our people?

Didn't I just read about a scheme into which N5.9 Billion was committed in training 177 youths in *smartphone repairs?* The programme was reportedly powered by the Ministry of Disaster Management and Humanitarian Affairs, headed by Sadiya Umar Farouq as minister. Didn't we receive the news recently that the Federal Ministry of Agriculture expended the sum of N18. 9 Billion on "bush clearing and land preparation?" The former Accountant General of the Federation, (AGF), Ahmed Idris, was recently docked for fraud in the sum of N109 Billion? The fiscal budget of Ekiti State for year 2022, is just N100 Billion.

Mammoth scams and scandals such as we have detailed above, flourish in high places with very little reprimand for defaulters. At the very best, sanctions are all but a slap on the wrist, in what the inimitable Fela described as "paddy paddy" governance in his hit song, *Army Arrangement.* And since no one is appropriately and decisively punished, the trend simply blooms and blossoms, prevalent across the broad spectrum in the executive, legislative and judicial arms of government. Entrenched, systemic corruption was the major highlight of the "charge sheet" against the immediate past Chief Justice of the Federation, (CJN), who bowed out voluntarily and has not been questioned ever since.

Other people therefore simply adopt this archetype of slime and sleaze, lock, stock and barrel, confident they can most probably go unnoticed and unpunished. At the very best, they subscribe to a plea bargain which still entitles them to substantial onshore and offshore aggregates, from their monumental hauls. More ingenious rogues enlist their contacts in the judiciary, where they obtain "perpetual injunctions forbidding their arrest and arraignment," even for visibly established crimes and complicity, deserving of heavy forfeitures and longterm incarceration. This is the way the system progressively decays and degenerates.

Contemporary governance, probity and accountability in Nigeria, have become so very susceptible to the whims and wiles of all types of insects, reptiles and different mammals. Shouldn't we formally integrate them into the scheme of modern day corporate administration in recognition of their serial exploits as thieves, robbers and marauders in our body politic? Let's invest them with National Identification Numbers, (NIN), our digitised international passports, plus permanent voters cards, (PVCs), to further legitimise their citizenship.

To do otherwise will be a disservice to these critical stakeholders. On this score, let's, once again, show the whole wide world the way. Despite our globally acknowledged multivariate ingenuity, genius, capacities and positives, we, sadly, so often, also excel in the weird and bizarre.

EFCC rejects establishment of electoral offences commission

igeria's main anti-corruption agency has opposed the establishment of a separate commission to investigate and prosecute electoral offenders in the country.

An Assistant Commander of the Economic and Financial Crimes Commission (EFCC), Deborah Ademu-Eteh, made the position of the anti-graft agency known. It was at a public hearing on a bill to establish an Electoral Offences Commission. The hearing was organised by the House of Representatives Committee on Electoral Matters.

Ademu-Eteh said the offences provided for in the electoral offenses bill have already been covered by various laws of the land, including the 2022 Electoral Act.

"Most of the speakers here have come out to support the establishment of the Commission. But we have a different

"The bill for an Act to establish the National Electoral Offences Commission and For Related matters, 2022 seeks to provide for the establishment of a National Electoral Offences Commission which wilt coordinate the investigation and prosecution of electoral offences.

"A holistic review of the contents of the proposed bill shows that the offences contained therein in Part IV (Sections 13-32) largely constitute offences that have already been criminalized by extant laws such as the Electoral Act, 2022 (See Sections 114-129), The Penal and Criminal Codes, the Independent Corrupt Practices and other related offences Act, 2000; The Economic and Financial Crimes (Establishment)Act,

"It is apposite to state that these offences are offences that the Nigerian Police, the Federal Ministry of Justice, the Economic and Financial Crimes

(EFCC), the Independent Corrupt Practices and other related offences Commission (ICPC), and even the Independent National Electoral Commission (in Section 145 of the Electoral Act, 2022) are empowered under our extant laws to investigate and prosecute.

"There is, therefore, no need to create an agency solely for the purpose of investigating and prosecuting electoral offences most especially when our electoral process is seasonal in nature being that elections are held once in 4 years in the Country.

"Furthermore, it is our suggestion that the existing law enforcement agencies should be strengthened to achieve maximum output Instead of creating a new agency of investigation and prosecution of electoral offences in the light of the ongoing plan to implement the Oronsanye Committee's proposal by the Federal Government of Nigeria," she stated.

Nigerians require political integrity as a quality for the election of leaders capable of confronting the menace of political corruption," Salihu stressed.

Impeachment notice to President Buhari

ately, there has been increasing calls for the resignation or outright impeachment of President Muhammadu Buhari. The grounds for the calls are his alleged non-performance in office and the scary state of security in Nigeria. The recent call, which was first mooted by the Senate, is prompted by security breaches which the Federal Capital Territory suffered. Islamic terrorists successfully "rescued" their colleagues from the Kuje Correctional Facilities without suffering any loss. Their actions forced the federal government to close down a number of schools in the FCT, they attacked the Presidential Guards Brigade at Bwari-Kubwa Road, killing seven members of the guard. The fact that terrorists and members of ISWAP could threaten to kidnap a sitting President and Governor, was the last straw that jolted members of the National Assembly from their slumber. It suddenly dawned on them that Abuja was "surrounded" by terrorists!

Al Jazeera reported that "Nigerian opposition senators are pushing for President Muhammadu Buhari to face impeachment, less than a year before the end of his second term in office, over the country's spreading security problems." The earlier move by the Senate was scuttled by the Senate President when he closed the Senate Chamber for a recess. It however resurfaced in the House of Representatives where many members of the opposition party with a few members of the ruling APC threatened on July 27, 2022 that the President will be removed from office if the security situation in Nigeria did not improve within six weeks.



Governors have set up various forms of local internal security units and some have gone on to advocate that citizens should bear arms to defend themselves.

Those supporting Nigeria's latest political sensation and former governor of Anambra State, Peter Obi of the Labour Party, call themselves Obidients. Those supporting septuagenarian APC leader and former Lagos State governor Bola Ahmed Tinubu call themselves Batists. Those supporting Nigeria's serial presidential aspirant and former Vice-President Atiku Abubakar of the PDP prefer to be known as Atikulated. Of course, the neutrals have keenly and critically looked into the future and, given Nigeria's current exertions, are circumspect about the reality of 2023. Surely, it can only take the most optimistic person in Nigeria to believe that the 2023 elections will hold. The signs are ominous. It does not portend well that the seat of power Abuja, which ordinarily should be the most fortified and protected, is currently under siege by terrorists. Yet, millions of Nigerians are hopeful that 2023 will witness the installation of a new government elected by the people. Their hopes are valid because there is a huge possibility of the emergence of a New Nigeria under Mr Peter Obi of the Labour Party. Of a truth, never in the history of this country has there been a groundswell of support for a new beginning led by one man. This underscores the value of the Obi Phenomenon.

But will election hold next year? If the activities of terrorists

for interpreting the Absurdist and bandits continue unchecked across the country, then Nigerians should prepare to kiss 2023 goodbye. Terrorists are daring, bold, and unrelenting. While the APC government watches with paralyzed interest, these goons gradually take over the length and breadth of Nigeria. Gradually, terrorists and bandits are taking over the country, just gradually.

If these conditions continue unabated as they are likely to do, will elections take place in Nigeria next year? I flinched after watching a video of some army officers admitting that their superiors instructed them not to go after the terrorists. The all-important question is - will

If the legislature succeeds in impeaching him, it will be good riddance to bad rubbish.

While the Obidients, Batists, and Atikulated square up in media warfare, let them pause and ask will elections hold next year? In a previous essay titled "2023: To be or not to be" I argued that 2023 is not yet certain. I remember vividly that Pastor E.A Adeboye declared to a bewildered congregation that God has not told him if the election will hold next year. If terrorists eventually take over the reins of power in Nigeria, what options do we have? That Mr Buhari donated \$1,000,000 (One Million US Dollars) in a show of solidarity to the terrorist government in Afghanistan immediately after they sacked a democratically elected government is a testimony of how his mind is working. Let those who know better than us kindly interpret the Nigerian scenario for us because it appears that Nigerians, like Estragon and Vladimir, will wait for 2023 in vain. God forbid.

After seven years on a long, winding road to civilian rule, the Transition hit a dead end. The election winners sat down in conference halls and hotel suites to negotiate away their electoral victory with the same people who voided their victory.

On August 2, Lt-General Ibrahim briefed senior officers at the Senior officers were asked to submit recommendations on the lNG's composition. The officers considered three structures for the ING: (i) a full civilian government with equal representation from the SDP and NRC (ii) a hybrid military and civilian government, or (iii) a full military government.
Shehu Yar'Adua demanded that

a civilian should head the ING, and that Babangida, Aikhomu and all the service chiefs should resign. The demand was accepted with one exception. General Abacha was the only military officer named to serve in the ING. Obasanjo was asked

to head the ING but declined. He contacted Yar'Adua and urged him to stand firm and resist Abachas retention in the ING. Yar' Adua reluctantly agreed to Abachas retention as he did not want to give Babangida a pretext to remain in power.

The Tripartite Committee recommended an ING to be led by civilians, but with military representatives. The head of the ING was to be the head of state and chairman of the ING. Nebulously, the ING chairman's powers as Commander-in-Chief of the armed forces were to reside in the National Defence Council and the National Security Council. The ING was to commence on or before August 27, 1993, and would stay in office until December 31,1994.

However, its duration was shortened, with its terminal date being brought forward to March 1994. The NDSC accepted the Tripartite Committee's recommendations with a few amendments.

A small band of hardliners urged Babangida to stay on. Some planned

to use the Senate to pass a motion calling for an extension of Babangidas tenure. The Senate president, Iyorchia Ayu, was

impeached by the Senate for opposing moves to extend Babangidas tenure beyond August 27.9 This was the first time that a Senate president had been impeached in Nigeria's history. Politician

Mohammed Arzika said that "it is a sad commentary on the political environment of the country ... that being principled and honest is considered something unbecoming that should be gotten rid of'

Finally out of options, Babangida announced on August 17,1993 that he would "step aside" as "a personal sacrifice': The following Tripartite Committee members and stakeholders signed a document agreeing to create the ING.

A remarkable aspect of the I G's emergence is that many of those behind its formation were unelected, while the majority of those who had been elected (Abiola, the National Assembly and state governors) played little or no part in its creation. The ING was superimposed on the polity and nation without the consent of the overwhelming majority of both constituencies.

The ING was unique. It was the only government in Nigeria's history that was not the product of a coup or election. On August 26, 1993, Babangida "stepped aside". He stood down after eight

years in power and retired with his service chiefs (Lt-General Ibrahim, Air Vice-Marshal Akin Dada, Vice-Admiral Dan Preston Omatsola and Alivu Attah). He left the crisis-racked country to an uncertain future in the hands of an ING headed by the chairman of the Transitional Council, Ernest Shonekan.

Shonekan was the former chief executive of the multi-national United Africa Company. His selection was strategic. Like Abiola he was an Egba Yoruba from Abeokuta. The military knew that Shonekan would be regarded as a traitor by other Yorubas for agreeing to lead the ING after the voiding of an election won by a fellow Yoruba. Even though Babangida had officially retired, Shonekan was perceived as a puppet being controlled by Babangida from behind the scenes.

In a last-ditch attempt at continuity, Babangida left his loyalists in charge of key military units. Lt-Generals Joshua Dogonyaro (Chief of Defence Staff), Aliyu Mohammed (Chief of Army Staff) and Brigadier John Shagaya (GOĆ, 1'1 Division) were left behind to watch Shonekan. The Defence Secretary and Chairman of the Joint Chiefs of Staff, General Sani Abacha, also retained his position and was the only military member of the ING.

Babangida stood down with the military's reputation at an all time low. When he came to power he was seen as a visionary benevolent leader with foresight, a reform agenda, finesse and a

forward thinking economic blueprint. Yet he left office eight years later with his reputation mutilated and became (at that time) the most unpopular military leader in Nigeria's history

How KO Mbadiwe varsity is surmounting challenges

Professor Ikechukwu N.S. Dozie, the Vice-Chancellor, of Imo State Government-owned Kingsley Ozumba Mbadiwe University, Ogboko in Ideato South LGA spoke to **ATHAN AGBAKWURU** on the situation of the institution.

The admission program of the K.O. Mbadiwe University -How did it go? How many students have you admitted under your tenure?

A: The 2021/22 admission process is going on very well as stipulated by the Joint Admissions and Matriculation Board (JAMB). All admissions are being processed on the JAMB Central Admissions Platform (CAPS). We have so far admitted about 120 students. We hope to admit more candidates who have shown interest in the university before the Matriculation ceremony scheduled to take place on May 27, 2022.

The university successfully garnered accreditation for her programs from the NUC. What does it portend and imply for both the University and students.

Successful accreditation of programmes by the National Universities Commission (NUC) implies that those programmes are being run according to the stipulations of NUC Benchmark Minimum Academic Standards (BMAS). The overriding implication for the university is that those programmes satisfy the provisions of BMAS for teaching and learning aimed at producing quality graduates for self-actualization and for the task of nation building. The overriding implication for students is that the products (i.e. graduates) of those programmes will qualify on graduation to embark on the mandatory one year National Youths Service Corps (NYSC) programme.

Do you have quality and innovative manpower and academia ready to meet up to new global standards?

Yes.We have quality manpower who are ready to conduct teaching and learning and overall university business in line with global best practices. We have a policy of constant engagement with our staff through training and retraining programmes to keep them abreastwith modern trends in curriculum design and development and overall teaching and mentorship.

A major challenge of Nigerian Universities is the

epidemic of cult groups whose activities frequently end in social mishaps and crisis that threaten academic work? How do you plan to checkmate such occurrences?

As a preventive measure, we have a policy of engaging our students on a regular basis through orientations, workshops and seminars on the dangers of involvement in

anti-social activities and behaviors including cultism. We also have regulations contained in the Student Handbook that deal with misconducts by students and their associated sanctions/penalties/punishments. As Management, we enforce those sanctions on students who flout the rules and regulations of the university including membership

of secret cults. The sanctions are pronounced after the affected students would have been given an opportunity to defend themselves before a disciplinary committee of Senate. This implies that the students will always have the right of fair hearing before being punished.

Tertiary institutions are bedeviled with very unethical practices such as exchange of money or sex for grades. How do you plan to tackle this?

We prevent such unethical practices through frequent engagement with staff and students. We also punish such acts of gross misconduct by invoking relevant sanctions on erring staff or student, after they have been given the right of fair hearing.

Trust deficit, hazards and Nigeria's Ponzi schemes

Ponzi schemes are some of the ways through which certain persons use to make quick fortunes, while most Nigerians who fell for such schemes have burnt their fingers. But despite repeated warnings to Nigerians against patronising such outfits in their quest to make quick money, most Nigerians still easily fall for ponzi schemes, JOHNMARK UKOKO writes.

onzi schemes are increasingly becoming the ways and means through which some financial institutions and business outfits advertise their investment opportunities to gullible and high risk takers to get quick returns on their investments.

In most cases, those who embrace such schemes actually get 'rewarded' by their promoters, as the customers who subscribe to the schemes are promptly paid as promised.

The realisation that the early patronisers, who embrace the schemes had their investments doubled or tripled in a matter of days or weeks, normally attract thousands and sometime millions of other people to such schemes with a view to benefiting from the mouthwatering promises the promoters offer, at which point most of the scheme normally

It should be noted, however, that the promoters of such schemes are usually not registered with any government regulatory agencies and as such, after defrauding as many people as they could, they disappear.

In most cases, when Ponzi schemes begin to advertise their services, government regulatory agencies will quickly used the media to warned the members of the public to shun such groups who are always promising too good to be true returns on investments.

More often than not, the promoters always target youths and teenagers who are always in a hurry to get rich through the dubious schemes, because in most cases the early customers get paid, while others are defrauded.

Curiously, when such schemes debut in the country, security forces including the police and even the Economic and Financial Crimes Commission (EFCC) hardly arrest and prosecute promoters of fraudulent activities, which constitute financial crime in the mode of obtaining by trick

In the late 1980s, Ponzi schemes that operated in the country were Arise and Shine and Plan Well in Benin City, Edo State, which helped a few persons to get money to buy cars and travel abroad, while majority were defrauded

In Lagos, Forum Investment defrauded thousands of youths, while a banker, Umana Úmana, promised high returns on investments in his company within a

Umana's office, which was located in Allen Avenue, Ikeja, was usually a beehive of activities, as youth and unemployed Nigerians thronged the outfit with some even borrowing from their family members and friends to invest in the scheme they thought

was high-yielding investment.
Arise and Shine, Umana
Umana, Plan Well and several other Ponzi schemes that invaded Nigeria since late 1980s to date successfully operated in the country, paid a few people their investments and amounts they were promised and defrauded millions of others.

A few years ago, a Ponzi firm traced to Russian promoters defrauded Nigerians and citizens of other countries when the four brothers, who established the Ponzi scheme, invaded most countries of the world.

Commenting on the menace of Ponzi schemes in Nigeria and the danger it portends for the Nigerian youths, Director-General of Securities and Exchange Commission (SEC), Lamido Yuguda, described Ponzi scheme as a "cancer hindering effective operations of the capital market."

Yuguda, who spoke at the post-Capital Market Committee (CMC) media briefing in Abuja recently, said the SEC had been fighting a serious war against Ponzi schemes in the country.

He said: "Ponzi scheme is like a cancer bedeviling effective operations of capital market in the country. The commission had been fighting a serious war against Ponzi schemes, where people without licences extort money

from unsuspecting victims."
Yuguda disclosed that the commission had been working with other agencies to reduce access of Ponzi schemes to advertising platforms, adding: "We have been saying that people should only deal with registered operators with the commission. People must confirm that operators are licensed with the commission before they patronise them.

We have done a lot of sensitisation to discourage people from patronising schemes that offer return on investments that are too good to be true. We have done a lot of sensitisation to discourage people from patronising Ponzi schemes, but unfortunately, a lot of people still patronise them."

He explained why the promoters of Ponzi schemes are not usually arrested before they defraud the people and why it has been difficult for the commission to stop Nigerians from falling prey to the promoters of such schemes.

"We have several reported cases and our enforcement agencies and the police have been working on most of the cases trying to resolve issues of investments that have been lost. It is not really difficult to recognise a Ponzi scheme. When a return looks too good to be true, desist from it," Yuguda warned.

He further disclosed that the commission was already collaborating with the EFCC to fight Ponzi schemes and money laundering, adding that the SEC would continue to enlighten members of the public on the need to desist from patronising Ponzi schemes.

Apart from the SEC, the Nigeria Deposit Insurance Corporation (NDIC) expressed serious concerns about the menace of Ponzi schemes in the country's economy and had cautioned against outfits that collect deposits from Nigerians and were not licensed by the Central Bank of Nigeria (CBN).

In statement issued recently, the corporation warned Nigerians that in the event that the illegal outfits collecting deposits from Nigerians not licensed by the CBN depositors of such firms do not stand a chance of insuring their deposits, adding: "Those who patronise unlicenlised outfits, like they say in local parlance, are "on their own."

The corporation lamented

that despite its consistent enlightenment and sensitisation programmes against the menace, most Nigerians still patronise such firms.

Also, an economist, Felix Amechi, who spoke in an interview with The Trumpet, said greed and ignorance were the main reasons why despite the several warnings to Nigerians against patronising Ponzi scheme, many still do so.

Amechi argued that some of the few people who patronise Ponzi schemes were rich, hence Nigerians still take the risk with their hard-earned money, stressing that the youths do not trust the government and its institutions,

which is why they do not heed their warnings.
"There is trust deficit in the

country. Many youths and even adults don't trust the government and its agencies, hence they don't listen to them when the government or its agencies caution them about Ponzi schemes," he added.

Amechi also pointed out that the country does not have opportunities for the youths, hence the youths embrace any or every opportunity available, lamenting that some youths were also embracing ritual and other forms of criminality.

"Many Ponzi schemes have reared their ugly heads in the country. No doubt, some few lucky Nigerians realised their expectations from what those outfits promised them. However, thousands youths if not millions have burnt their fingers. They have lost their hard-earned money to Ponzi schemes.

"No doubt, government agencies regularly issue warning to Nigerians not to get involved in Ponzi schemes. There is trust deficit in Nigeria. Most youths and teenagers know that the promoters of most of the Ponzi schemes do not trust our government or its agencies," he stressed.

It would be recalled that about five years ago, four brothers from Russia promoted a Ponzi scheme in some countries, including

When they arrived Nigeria, they targeted youths in higher institutions and as expected, most students fell for it. While the first few ones who participated in the scheme were paid for their investments, most of those, who later joined were defrauded.

Most of the youths even used their school fees to invest in the scheme, with the hope that they would get their funds doubled up to five times the amounts they invested within 30 days.

Sadly, some of the students, who came from poor homes, could no longer continue their studies, as their parents or uncles could not give them more money to pay their school fees.

Before the Russian brothers promoted Ponzi scheme crashed in December 2016, millions of Nigerians lost their investments, while the youths that invested their money, could not roll over their investment, which they hoped to sign after earning huge amounts.

Before they could realise their aspirations, the scheme crashed

and the promoters and their workers disappeared.
Respondents, who spoke to The Trumpet on the menace, appealed to the Federal Government, its institution and regulatory agencies to initiate quick-win actions that would activate the economy to provide opportunities for the

While appealing to the SEC, NDIC, CBN and the police initiate steps aimed at reducing the number of Nigerians who fall for the Ponzi schemes, they said youths who are properly engaged and have viable means of livelihood would not easily fall prey to such schemes.

They charged the police and EFCC to arrest promoters of illegal activities to prevent fraudsters from having a field day in the

Respondents also appealed to the youths to heed warnings of SEC, NDIC, EFCC and government against Ponzi schemes, lamenting that Nigerians have lost billions of naira to fraudsters who played on the ignorance or desperation of the youths and unemployed Nigerians.

They argued the fraudsters easily manipulate their victims because they capitalise on the harsh economic situation in the country and charged government at all levels to create enabling environment to enable the younger generation of Nigerians opportunities to create a legitimate means of earning a living instead of easily falling prey to promoters of Ponzi schemes.

Taking a cue from Yuguda, who described Ponzi schemes as 'cancer bedeviling effective operations of the capital market,' the SEC should be commended for collaborating with the EFCC and other security agencies to tackle

the ravaging 'cancer.'

By and large, the future will determine if the SEC and the government will win the war against promoters of Ponzi schemes in the country.

In addition to the already existing PEBEC-NEC sub-national intervention, the SABER programme seeks to provide additional incentives, such as improving the business environment and facilitating crowding in private sector investments at scale.

The eligibility criteria for the programme include developing an annual action plan with private sector collaborators to be approved by the states executive councils and published online.

Recommendations from the second sub-national EoDB report, due for release in October 2022 are expected to be considered.

Vice President Yemi Osinbajo has declared that the inauguration of the board of the Nigeria Electricity Liability Management Company (NELMCO) will enhance efforts at resolving liabilities relating to tariff shortfalls for distribution companies (DisCos) among other challenges in the power sector.

He stated this in his remarks he delivered virtually on Friday, August 19, 2022 at the unveiling of the new board of NELMCO.

Osinbajo revealed the company has been running without a duly constituted board since the first one was inaugurated in 2013 and dissolved shortly after.

The Vice President said the inauguration marked an important milestone in the bid to resolve the liabilities relating to tariff shortfalls in the power sector, especially for DisCos and to provide a veritable mechanism for managing the dynamic nature of the liquidity challenges of the power sector.

"This ceremony formally brings on board the invaluable skills and derivable skills and experience of notable and highly respected personalities as members of the board of NELMCO," he said.

On the expectations of the board, Osinbajo charged the members that as a board, "you are expected to make conscious and deliberate efforts to develop appropriate strategies to facilitate the successful conclusion of the outstanding pre-privatisation issues of the defunct Power Holding Company of Nigeria (PHCN) and ensure effective implementation of NELMCO's additional mandate to resolve the tariff shortfall problems in the DisCos."

He added: "In view of the challenges ahead, you are expected to draw extensively on our experience over the years, to continue to give credence to the federal government of Nigeria's economic development programmes in a transparent, sustainable, credible and acceptable manner."

"The board is required to take appropriate steps to also ensure that the interest of the various segments of society and particularly ordinary Nigerians are protected in the implementation of NELMCO's mandate"

On the board's mandate, he

charged the members to diligently carry out the responsibilities assigned to the board in accordance with the provision of the Memorandum and Article of Association (MEMART) of the company.

Some of the provisions of MEMART include to assume and administer the stranded debts of the defunct PHCN Plc pursuant to the provisions of Electric Power Sector Reform Act 2005 and to manage post-privatisation liabilities in the power sector as may be directed by the National Council on Privitisation (NCP) or any authorised agency of the Federal Government from time to time in line with the power sector reform Act 2005.

Responding, Minister of Finance, Budget and National Planning, Mrs. Zainab Ahmed, assured the vice president of the board's preparedness to ensure quick resolution of tariff shortfalls and related issues in the power sector in the most efficient manner.

Other members of the board are the Minister of Power, Abubakar Aliyu; Director- General, Bureau of Public Enterprises (BPE), Alex Okoh; Director-General, Debt Management Office (DMO), Ms. Patience Oniha; Managing Director of NELMCO, Bayo Fagbeni; Muhad Aliyu; Jumma Olufunso; Olutola Olukoga, Chinedum Orisakwere, Modojinouwa Dekalu-Thomas and Nurain Hassan Ibrahim.

Meanwhile, Okoh said the takeover of the Kaduna, Kano, Ibadan and Port Harcourt DisCos has been successfully completed.

Okoh, who disclosed this in a presentation at virtual meeting of the NCP held recently, added that the challenge in the takeover of the Benin Electricity Distribution Company (BEDC) was being addressed.

Osinbajo was represented at the meeting by the Minister of Finance, Budget and National Planning, who is the Vice Chairman of the council.

Measuring due diligence of oil areas' rights, privileges

Following the severe pollution of oil producing communities in the Niger Delta region and the recent euphoria of International Oil Companies (IOCs) divestments from the receive it has been supported in the receiver in the statements from the receiver it has been supported in the receiver in the statements from the receiver in the statements from the receiver in the statement of the statement the region, it has become expedient for lawyers, community leaders, oil companies and civil society organisations (CSOs) to determine due diligence in measuring the rights and privileges of impacted host communities.

It is in this regard that the Stakeholders Alliance for Corporate Accountability (SACA), a non-governmental organisation in collaboration with the Nigeria Agip Oil Company (NAOC) assembled a team of lawyers from the core oil producing states of the Niger Delta to review guideline that would be required to carry out human rights impact assessment in impacted communities.

The project, sponsored by Misean Cara of Ireland, Saint Patrick Mis-sionary Society (SPMS), entailed a two-day due diligence review in Yenagoa, Bayelsa State in which 21 lawyers and other stakeholders from the host communities and civil society organisations from the four major oil producing states of the Niger Delta brainstormed on national and regional frameworks that would be used as benchmark for assessment of the impacts of oil exploration

and pollution of the environment.
The lawyers, according to
SACA were specifically selected to review all regional and national laws as they pertain to issues of environmental degradation, land acquisition and use, social impact on indigenous people, communities, engagements and consultations, as well as mechanism for addressing violations and grievances.

In his opening remarks, Executive Secretary of SACA, Kingsley Ozegbe, noted that the Human Rights Due Diligence Committee (HDDC) in the communities was in line with the United Nations Guiding Principles on Business and Human Rights (UNGP).

He stated that the programme tallies with the premise of protection, respect and remedy of human rights breaches in the host communities of oil companies for harmonious relationship without necessarily

breeding conflicts.

Ozegbe explained that currently the risks associated with oil and gas activities in the Niger Delta Region were heightening, just as the investment climate was shrinking.

"Oil spillages into the environment are becoming alarming and 76.24 per cent of spillages are caused by human interference with oil facilities. This prompted stronger team work to safeguard humanity and improve the environment to attract investors to create opportunities to absorb working population that is

surging daily. "On May 26, 2022, we constituted three strategic committees to address the threat. Since then, the Environmental Management Committee (EMC) has been raising awareness in communities and the media to educate members of the public on risks associated with high exposure to crude oil and other petroleum

"The Agricultural Management Committee (AMC) has been supporting communities to engage in sustainable agricultural practices, while HDDC has been creating awareness on human rights and privileges to appropriate guide Community actions in seeking the protection, preservation and remedy of their breached rights," he stated.

He added that the human rights component of the project has had two major events including inauguration of the HDDC held on May 26, 2022 and the triggers of human rights on June 30, 2022. The last even gave us the opportunity to hear and integrate the views of 60 participants drawn from community leadership, NGOs and academics.

Speaking further, he said: "On August 18, 2022, we gathered to review and reinforce a draft Human Rights Due Diligence Tool with national and regional legal frameworks that will enable the HDDC to gather data on the project and appropriately advice the management of NAOC to minimise potential on human rights breaches.

Eni/NAOC has shown commitment to the project and so, we are hopeful that they will be integrating and acting on findings of the HDDC to prevent and mitigate adverse human rights impact as enshrined in principles 19 of the UNGP"

He disclosed that the HDDC

shall be tracking effectiveness of response to verify if the risks are being addressed to properly account and share lessons on how businesses can address their impacts on human rights as indicated in principles 21 of the UNGP and Urged the lawyers to work within the ambit.

Also speaking, the Head , Legal Services and Enforcement, Bayelsa State office of the National Human Rights Commission (NHRC), Goselle Vinings, applauded SACA and NAOC for the collaboration, describing it as "a healthy initiative."

He noted that the amount of seriousness and good intentions which the NGO and oil companies were pursuing to ensure human rights due diligence in the oil and gas sector, with particular reference to Niger Delta region and the entire country would ensure that the right things are done and work better going forward.

On his part, Project Manager of SACA, Augustine Anyio, restated the importance of human rights diligence tool in the operations of

oil companies in the country. He pointed out that HDDC tool review became imperative because the multi-national oil corporations will leave the country some day, adding that if human rights diligence tools were not adequately put in place, the indigenous oil companies, which would soon be leading in the exploration and exploitation of mineral resources in the Niger Delta region and other parts of the country would capitalise on the absence of human rights due diligence tool to undo their host communities.

Participants also commented and applauded SACA on the programme, as Legal Adviser to the Bayelsa State civil society organisation, Bar. Alagoa David, expressed shock over NAOC's sponsorship of such programme in spite of environmental degradation, pollution and community conflict in their areas of operation.

He said: "I commend the workshop being organised by SACA, a civil society group involved in corporate accountability that has put in place a review of human rights diligence tool that will be administered on oil companies to ensure compliance in the oil companies operating communities.

"The the essence is to engage the rural communities, oil companies and

regulators with respect to human rights. It is amazing that NAOC is funding the programme and I thank SACA for taking the bull by horn. It is a welcome development."

Earlier, SACA explained that it discovered that most oil pollutions were caused by indigenes of oil producing communities indigenes over grievances of neglect and lack of development

It said oil companies feed governments as internally generated revenue of Bayelsa State could not do much, but the state relies on what comes from oil companies as budgets are based on oil facilities and hence the programme aimed at advising against pollutions.

"Budgets are based on oil revenues and without oil government cannot operate, as states will be obliterated without oil and that will lead to dog eating dog, infant mortality and unprecedented poverty, except a win-win situation we will suffer and cannot go anywhere, we need oil for sustenance," it added.

Another participant and Senior

Human Rights Officer with the Imo state office of NHRC, Bar. Okoroji Ihunanya Chukwu, also commended SACA for assembling the legal team to brainstorm on institutions that available and delegations that would hold oil companies accountable for human

This is expedient because lives are being threatened, environmental degradation caused by oil producing companies and the result of the human rights diligence committee tool will go a long way for the oil companies to know what do with their host communities, as applicable in other climes globally by domesticating best practices, existing legislations and implementation as obtainable in other countries to secure the life of people in the host communities.

The SACA process proves that there is an Isaac Adaka Boro of our time. Many have died, while others suffered dire consequences over the fight for restoration of human rights of indigenous people and giving voice to the voiceless and what SACA has done is to avoid crisis. The instrument is a framework that seeks to protect, respect and remedy human rights breaches," he stated.

3. Line your lip with a lip liner

Lip liners have waxy formulas that sort of binds with your lipstick colors, making them last longer. So, line the outer corner of your lips preferably with the shade of lip liner nearest to the colour of the lips or the lipstick.

4. Apply the lipstick properly

It's best to use a brush when applying your lipstick (brushing from the corners of your mouth to the center) so that the lipstick is evenly applied

5. Blot

Blotting helps you take away the excess oil from the lipstick to keep it from smudging.

6. Apply a translucent powder

Gently dust any translucent powder over the lipstick. You can place a tissue over your lip before applying the powder or do it directly.

7. Apply the lipstick again

Finally apply the lipstick again. There you are good to go

Celebrating ever vibrant Argungu Fishing Festival



rgungu Fishing Festival is an annual four-day fiesta in ▲Kebbi State, in the Northwestern part of Nigeria. The festival usually takes place in the capital city of Argungu Emirate Council. The region is made up of fertile river areas (matanfada, mala, gamji), with much irrigation and orchards (lambu in Hausa). The majority of fishermen are the followers of Islam and also predominantly farmers. Kanta museum is the main historical centre in Argungu for visitors across the globe. People from around the world travel to Argungu just to witness the occasion.

Call it the Fishing-Frenzy Festival. It's one of the most famous cultural festivals in Nigeria, and is celebrated to mark the beginning of the fishing season in Argungu, a river-side town in Kebbi state. Celebrated between February and March every year, AFF sees most local men and boys entering the Argungun river, armed with large fishnet scoops. They are joined by canoes filled with drummers, plus men rattling huge seed-filled gourds to drive the fish to shallow waters. Vast nets are cast and a wealth of fish is harvested. This is followed by Canoe racing, wild duck hunting, bare-handed fishing, diving competitions and swimming. There is drinking, singing and dancing into the night afterwards. A fun time indeed you would say!

History

The festival began in the year 1934, as a mark of the end of the centuries-old hostility between the Sokoto Caliphate and the Kebbi Kingdom.


In 2005, the winning fish weighed 75 kg, and needed four men to hoist it onto the scales. In 2006 the festival banned fishing due to safety concerns relating to the low water levels. The importance of the

festival to the economy has led the government to conserve fish stock by prohibiting use of gill nets and cast nets. The Zauro polder project, an irrigation scheme in the Rima River floodplain to the south of Argungu, has been criticized because the reservoir threatens to flood the traditional site of the festival.

Competition

On the final day of the festival, a competition is held in which

thousands of men and women line up along the river and at the sound of a gunshot, all of them jump into the river and have an hour to catch the largest fish. The winner can take home as much as 7,500 US dollars. Competitors are only allowed to use traditional fishing tools and many prefer to catch fish entirely by hand (a practice also popular elsewhere and known as "noodling" in the United States) to demonstrate their prowess.

Yam Pottage/ Porridge (Asaro) recipe

asaro is also known as Yam pottage or porridge. It is a very delicious Yam recipe. Although it's eaten by most tribes in Nigeria, it is more common in the Yoruba-speaking parts of the country. It's also easy to make. If you love yam, it's a must-try recipe!

Asaro recipe

This yam porridge recipe tastes just like my mom's. The only difference is that it uses basil which is not typical in my mom's recipe. However, you can choose to add any herb or any leafy green of your choice like spinach, kale, or ugwu.

How is Asaro made?

Asaro is made from Puna Yam which is boiled till it's tender and it's cooked in a blend of Peppers, Tomatoes, onions, palm oil, and seasoning. While the dish is more common in the Yoruba-speaking region of Nigeria, it is still a meal enjoyed by the majority alike each with their own regional variation.

It is nicknamed "Asaro elepo rede rede" meaning yam porridge boldly colored with fresh palm oil and garnished to perfection.

What is porridge made of?

· African yam: Yam comes in different species, but the best one for this recipe is African yam.

Red Bell Pepper, tomato, and



habanero pepper: the blend of these three will make a perfect pepper mix for the porridge.

· Fresh Palm Oil: There is no yam porridge without oil. Fresh palm oil gives it the color and makes it fluffy.

· Onion: Onions bring the flavor out of the porridge. You need onions for the pepper mix and the porridge itself

· Salt and Chicken bouillon powder: This will bring out the taste of the porridge. Ensure that you add in moderate quantity.

· Fish and crayfish: add this to spice up the meal. You can add mackerel, crab meat, stockfish, or dried fish. · Vegetables/Herbs: perfect the meal with herbs like basil, parsley, scent leaves, and any other leafy vegetables like spinach, kale, or fluted pumpkin leaf (Ugwu).

How to make Yam Porridge

· Peel and cut and rinse the yam. Ensure that you rinse the yam more than once until the water is clear and no longer cloudy. The yam should be in medium-sized chunks about 2 inches thick.

· Blend your pepper mix. Blend the bell pepper, habanero, tomato, and half onion.

· Cook the yam and the pepper mix together. Put the first yams inside a pot, and add the pepper mix, salt, bouillon powder, and water. Cover and let it cook for 10 minutes on medium to high heat.

· Stir in the Palm oil, sliced onions, and crayfish. Cover again and let it cook extra 10 minutes.

· Mash the yams. You can use a potato masher or a wooden spoon. I love to mash some yams and keep some chunks. It gives more texture!

· Add the fish. You can smoke fish, dried, boiled, canned, or stockfish. You can also add smoked turkey or any other meat you prefer.

· Simmer for an additional 3 to 5 minutes.



Nigeria, USA sign agreement for return of fresh \$23.4m Abacha loot

agreement signed has been Nigeria and the UUnite Sates of America (USA) for repatriation of additional \$23,439,724 allegedly looted by the late military Head of State, General Sani Abacha.

While the Attorney-General the Federation and Minister of Justice, Abubakar Malami [1], represented the Federal Government in the signing of asset return agreement at the Headquarters of Ministry of Abuja, Justice in United States

its ambassador to Nigeria, Mary Beth Leonard.

Various sums of allegedly money stolen from the national treasury when Abacha was head of state, commonly referred to as 'Abacha Loot' had been repatriated from most countries in Europe and the United States of America since the former maximum leader died in 1998 and return democratic governance in 1999.

Malami said the decision to return the Abacha loot, which

was represented by he tagged Abacha-5, was a product of series of negotiations and meetings between Nigeria, the U.S. Department of Justice and the United Kingdom National Crime Agency (UK-NCA).

"It is worthy to note that in line with the terms of the agreement, President Muhammadu Buhari had already approved the funds to be used for the ongoing Presidential Development Infrastructure Funds (PIDF) projects namely: Abuja-Kano Road, Lagos-Ibadan Expressway and the Second Niger Bridge linking Asaba, Delta State with Onitsha Anambra State and

the South under the supervision of Nigerian Sovereign **Investment Authority** (NSIA).

"The President's mandate to office is to ensure that all recoveries of the nation's stolen resources from foreign countries are invested in a transparent and accountable manner and monitored by civil society organisations (CSOs) to complete the projects within the agreed timeline," Malami said.
