IGP deploys more manpower, assets over rising security threats, tensions in FCT

'n a bid to reassure residents of its determination to ensure security of lives and properties, the Nigeria Police Force (NPF) has additional manpower and assets to provide security for the Federal Capital Territory (FCT).

Recall that have been heightened tension and fears over frequent terrorist attacks in the nation's capital city.

Security reports indicated that bandits terrorists have concluded plans to launch terror attacks in the FCT and other of the federation.

"In the same vein, the Inspector-General of Police has assured Nigerians in general, and residents of the in particular, FCT of their safety and security, while urging them to go about their lawful duties without fear of attacks.

"He equally reiterated the firm determination of the Police leadership to continue to explore avenues to enhance the security architecture the country. through intelligence gathering, operational deployments application of cuttingedge technology decimate the activities of criminal elements across the country.

NNPP raises alarm over APC's plan to ambush **INEC for fresh nomination in Akwa Ibom**

Udoedehe spoke in the media briefing through the state Publicity Secretary of NNPP Mr Solomon Johnny recalled that the process to quit PDP in Akwa Ibom started in 2007 when he was with the Action Congress of Nigeria (ACN) party.

He maintained that NNPP remains strong in her determination to sack PDP from Akwa

Ibom State Government House and warned APC not to thwart the effort to realize the said plan.

Security: Obaseki finalises documentation, audit of Edo forests, to begin recruitment of forest police By **ISAAC OLAMIKAN**

Plans by the Edo State Government to secure the lives and properties of residents are in full gear as Governor Godwin Obaseki, has said the government has finalized the documentation and audit of the state's forests and is embarking on the recruitment of new forest police as part of a renewed effort to enhance security across the state.

Obaseki disclosed this at a Special Security Council Meeting with relevant stakeholders in Edo South Senatorial District, held at the Government House, Benin

The governor held similar meetings with stakeholders in Edo North and Edo Central Senatorial District to review security strategies mechanisms to tackle insecurity

Obaseki said the government in partnership with relevant stakeholders is strengthening the security architecture and adopting various measures to sustain security in the state, including bush combing, registration of motorbikes and marketplaces, signing of anti-grazing laws, and residents'

registration, among others.

He said, "The responsibility of any government in any society is to guarantee the security and safety of the people. No government can call itself a government if it cannot protect and secure the lives of the people that it oversees.

That is why for us in Edo, given what is going on in the country today, we have decided that security is now our number one priority. In the area of our forests, we have completed documentation and audit of all our forests in Edo State, particularly in Edo South.

"We have done a flyover of all our forests and as we speak, we have set up a new forestry commission. Our forestry laws that have not been updated in more than 50 years now have been updated. And part of the provisions of the law is that we will now reenergize the institution of forest guards."

The governor added, "We are currently in discussion with the Federal Ministry of Environment and some other stakeholders to begin the recruitment of the first set of the new forest police as we will call them to support the activities of all the other security agencies."

On strengthening local ernments to support governments to support the government's efforts at sustaining security across the state, Obaseki noted, "In terms of squatters in markets, we are going to enforce the local government laws which stipulate that it is only the local government that is entitled to register markets and shut down illegal markets.

"Any place where trading is currently taking place today and such a place has not been registered will be immediately shut down," the governor

Impeach Buhari, Osinbajo now, Ohanaeze tells National Assembly

The leadership of apex Igbo socio-cultural organization Ohanaeze Worldwide Ndigbo has asked the National Assembly to urgently kick start the impeach proceedings of Vice President, Prof. Yemi Osinbajo and President Muhammadu Buhari.

The Body said both Buhari and Osinbajo have failed woefully primary their responsibility protecting Nigerians.

In a statement signed by its Secretary-General, Okechukwu Isiguzoro, Buhari

Osinbajo's inability to protect Nigerians shows their failure of leadership in governance.

Isiguzoro, Recall that Senators had threatened to serve an impeachment notice on Buhari over his inability to tackle insecurity in the country.

According to him, the Senate minority caucus gave Buhari a six-week ultimatum to tackle insecurity in the country.

On Bola Tinubu, Ohanaeze said the All Progressives Congress (APC), presidential flagbearer, stands the chance to benefit if Osinbajo is exempted from the impeachment process.

The apex body National Assembly that "if the impeachment threats President served to Buhari should be taken seriously, Vice President Yemi Osibanjo must be part of the impeachment process, as both of them have failed Nigerians.

"The exemption of Vice President, from the impeachment threats, shows that APC Presidential candidate, Bola Ahmed Tinubu stands to be a major beneficiary."

Ohanaeze said Osinbajo may create loopholes that would favour Tinubu in the 2023 election if becomes president.

"Ndigbo reminds the National Assembly that attempts to initiate the impeachment process President against Buhari without Vice President Osibanjo are an incomplete process and will create windows and loopholes for the Vice President to play an ethnic card for the West.

"Irrespective running against Tinubu in the APC primaries, he will use the power incumbency favour of Bola Tinubu's victory which is a contradiction with the body language of the Mr President, who is likely reluctant to influence the 2023 elections for anyone but whoever Nigerians want at the polls.

"If Buhari should be impeached, then Osibanjo must go with him, both of them should be blamed for the rising insecurity challenges in the country.

"Ndigbo is in support of any Impeachment threats by the National Assembly, but it must serve as a wake-up call for the President and Vice President to be active with their duties, but if they continue to be onlookers and things goes awry, the National Assembly should not the Vice exonerate President for the notice impeachment, Tinubu stands benefit if only Buhari is impeached."

Four burnt to death as

Four persons were, in the wee ĥours of Monday, burnt to death in an auto crash that occurred at the popular Ekiugbo Junction along the East-West road, Ughelli North Local Government Area of Delta State.

Sources confirmed to The Trumpet Newspaper that a Toyota Sienna conveying space bus suspected illegallyrefined diesel lost control and rammed a parked

Dangote truck.

The minivan was said to be escaping from security operatives who had mounted a roadblock when it lost control and rammed the parked truck, causing an explosion.

Video footage from the scene obtained from witnesses revealed some of the victims were burnt beyond recognition and others lav on the ground and covered with leaves.

Meanwhile,

portion of the road where the accident occurred, it was gathered, has been barricaded from road users.

Unit Commander of the Federal Road Safety (FRSC), Ikechukwu, confirmed the tragedy, saying it occurred at 6:15 a.m.

Narrating journalists, said: There was this Toyota car coming from Warri end towards Ughelli and the Toyota was carrying

"On the way because of the speed violation, the driver went and hit a parked truck and got in flames.

"As a matter of fact, four eople were consumed, burnt beyond recognition at that point," he noted.

He reiterated that besides the impact, the vehicle carrying was illegally-refined diesel which caused the inferno.

He added that the four persons who died included

the Toyota Sienna driver and the occupants of the truck who were inside the truck as of when the accident occurred.

Ikechukwu disclosed that the Hausa community in the area came and took possession of their corpses.

The FRSC officer has, however, advised drivers and commuters to abstain from carrying inflammatory liquid inside their vehicles and eschew speeding.

NDLEA arrests two drug barons, one chemist in Lagos, Anambra labs raids

The National Drug Law Enforcement Agency (NDLEA) has busted and dismantled two major clandestine laboratories in Lagos and Anambra States where dangerous illicit drugs, crystal methamphetamine, called Mkpuru Mmiri in local parlance, were produced for distribution across Nigeria and beyond.

This was disclosed on Tuesday by the Chairman/Chief Executive Officer of NDLEA, Brig Gen Mohamed Buba Marwa (Rtd) while addressing the media at the agency's headquarters in Abuja.

Marwa noted that the outbreak of the abuse of crystal methamphetamine was in the last quarter of 2021, predominantly in the South East.

He said following the cry for help from many communities in the region because of the devastating effects of the distribution and abuse of the dangerous stimulant drug were having on their youths and others, the Agency deployed all available assets to find the primary source of manufacturing of the drug in Nigeria and arrest the barons behind it.

Marwa said efforts in the past seven months against the cartel behind the Methamphetamine scourge, have led to the arrest of four kingpins and a cook.

"Now, we have added two barons and another cook. This no doubt is a

loud statement to those involved in the criminal illicit drug trade that

it's time for them to quit or risk losing it all; that is losing their freedom, investment and assets acquired through proceeds from the illegal business," he added. According to him, "I am

According to him, "I am pleased to inform the public today that, after months of painstaking intelligence gathering, diligent tracking and coordinated offensive action, we recorded a breakthrough on Saturday, July 30, 2022, when officers and men of the Agency successfully busted two methamphetamine manu-

facturing facilities, called Meth Laboratories.

"The first one, located in Victoria Garden City (VGC) Estate of Lekki, Lagos is owned by a baron, Chris Emeka Nzewi, while the second, in Nise Community of Awka South Local Government Area of Anambra State was owned by Paul Ozoemenam. The owners of these two illicit meth laboratories were successfully arrested alongside Sunday Ukah from Aba, Abia State, the cook or chemist that produced the drugs for them.

"The laboratory in Lagos was set up inside the Boys' Quarter building of a four-bedroom duplex. From there, we recovered a total of 258.74 kilograms of crystal methamphetamine and various precursor chemicals used for the production of the toxic drug. The complete paraphernalia of laboratory equipment such as gas cylinders, giant gas burners, industrial face masks, industrial gloves, tubes and flat-bottomed conical flasks, among others, were also found."

Marwa said he's addressing the public about the weekend busts to raise people's awareness of the danger that meth production constitutes to public health and the modus operandi of the barons involved in the unwholesome activity.

"The owner of the labora-

tory in VGC, for instance, was producing this highly unstable and toxic drug in a house where he lived with his

family. This speaks volumes about his insensitivity to the consequences

of exposing his family, which includes a three-month old baby, to the danger of hazardous chemicals. If that is the case, that is an indication that public health was of no concern to him.

"In this particular case, aside from the laboratory being close to the

kitchen of the main house, the waste from the laboratory was channelled into the septic tank and soak-away in the compound, with a high risk of contamination of the water table of the entire neighbourhood.

"On average, the lab produced 50 kilos of methamphetamine every week with plans underway to increase the capacity of production to at least 100kg per week. Where do these drugs end? From our preliminary interrogation, we now know the drugs from this lab were both for export and local consumption. We also know there is a supply chain of distributors and buyers for export and the domestic market.

"When you consider the fact that the price of this dangerous drug was going for as high as US500,000 per kilo in the international market in recent time, you will understand why Nzewi cared less to put the lives of his own family at risk by producing this in the same house where they live. Hence, taking these two labs out of operation is a major feat in our continuing effort to curb the meth problem," he stated.

The NDLEA boss said the busting of the labs has exposed the interconnectivity among syndicates involved in meth production, adding that the cook was hired by both producers to produce for the VGC lab, as well as the lab in Anambra.

Marwa urged members of the public to be sensitive to their environment.

"As we step up the offensive against drug traffickers, we want the public to be more vigilant and be aware of the fact that producers of methamphetamine always chooses unsuspecting environments with tight security, like the VGC estate, in this case. And the reason is not far-fetched: They choose secured estates to prevent law enforcement agents from monitoring their activities. They also locate meth labs in remote unsuspecting communities where residents would not be aware of their activities.

"It is very important to note that the waste from methamphetamine production is dangerous to the ecosystem. The chemicals are toxic and once they seep into the soil, they contaminate the water table from which surrounding wells and boreholes draw their water. And citizens who unwittingly consume the water from such sources are exposed to heart and kidney ailments and other organ diseases.

"Neighbours, too, who inhale gases from the lab, are also susceptible to the same risk. What makes it worse is that the production usually takes place in the middle of the night, between 11 pm and 4 am, and therefore, unsuspecting neighbours could have been exposed to the hazards for months or even years," he added.

Marwa commended the professionalism of the intelligence-led special

units forensic experts and the 200-man strike assigned the task.

Akeredolu Extends Enforcement of Compulsory Installation of CCTV in Public Places

Ondo State Governor, Oluwarotimi Akeredolu, has extended the enforcement of compulsory installation of Close Circuit Television (CCTV) devices in all public places in the state to September 1, 2022.

According to a statement signed by his Chief Press Secretary, Richard Olatunde, the extension was sequel to appeals from churches, mosques and other public centres to enable them put in place necessary measures as contained in the State Executive Order.

Recall that Akeredolu had earlier directed the compulsory installation and use of the close circuit television (CCTV) device in all public and private institutions in the state.

The Governor signed the Executive Order on June 22, 2022, to mandate owners, occupiers, managers and operators of public/private institutions within Ondo State to install, use and maintain CCTV devices and other secret cameras to monitor and keep surveillance on the daily activities in their premises.

According to him, all security agencies in the state shall enforce the Executive Order as from September 1, 2022, immediately after the one-month extension ends.

The Senior Advocate of Nigeria added that the violators of the order shall be prosecuted in accordance with Section 203 of the Criminal Code (Cap. 37) Laws of Ondo State of Nigeria.

Governor Akeredolu further reiterated his administration's commitment to the security of lives and property of the people, describing it as top priority.

Kogi gov orders brothels' shutdown, bans facemask use

The Kogi State Governor, Yahaya Bello, has ordered the closure of all brothels harbouring prostitutes in the state.

He also banned the wearing of facemasks in public places to ensure the proper identification of persons in the state.

This is sequel to a series of security breaches being experienced in the state in recent times.

He gave the order on Tuesday in Lokoja during a meeting with all first and second-class traditional rulers, including local government council chairmen in the state.

Bello also ordered the removal and demolition of shanties in Lokoja, Osara, Zango, Itobe, Obajana, and all other areas in the state.

He urged the State Commissioner for Local Government and Chieftaincy Affairs, Local Government Chairmen, union leaders, and security agencies to meet with tricycle and motorcycle riders for proper documentation.

Governor Bello also urged all traditional rulers to guard their domain and ensured all the nooks and crannies of their areas were cleansed.

"Ensuring peaceful coexistence in your domain is your exclusive responsibility. You have the exclusive responsibility to ensure that all nooks and crannies of your areas are free from the criminality of all sorts," the governor said.

He also sympathized with the family of the killed security agents in Ajaojuta Local Government Area last Saturday.

While admonishing all local government council chairmen and security agencies to continue to do their jobs without fear or favour, Bello sent a strong warning to politicians not to be involved in anything that could disrupt the peace of the people and the security they presently enjoy.

"Let me sound a note of warning to all politicians irrespective of political persuasions to desist from anything that could disrupt the peace we are currently enjoying in the state," he added.

Ondo Amotekun nab 30-year-old for killing girlfriend, parade 44 others

A 30-year-old man, Seun Ojo, has been arrested by the Ondo State Security Network Agency codenamed Amotekun for killing his girlfriend for not giving him attention. The suspect said he killed his girlfriend, Enny when she started ignoring him and giving attention to other men.

The incident happened in Owo, Headquarters of Owo Local Government Area of Ondo State. Ojo, who was paraded with 44 other suspected criminals at the Amotekun headquarters in Akure, the state capital, accused the late Enny of engaging in prostitution. He said that he had been having issues with Enny for some time before the incident happened.

"My girlfriend's name is Enny,

she is a prostitute who always comes to Ikare Junction in Owo. I shot her after I noticed that she gives other men more attention

"We have been having issues for a while now. That particular day she repeated what I warned her against and I became furious and I shot her. But she did not die. I learnt that she is in hospital.

"I'm not a cultist, and I have never shot anyone in my life. The gun that I used on her belongs to my father who is a hunter. My father uses the gun to hunt and kill animals.'

The Operatives also paraded forty-four criminals for different offences who were arrested for different offences ranging from kidnapping, armed robbery, illegal possession of fire arms, attempted murder and rape among others. Among the forty-four were six members of a gang who specialise in kidnapping in Ore area of the state.

The Amotekun Commander, Akogun Adetunji Adeleye, revealed that in the course of cleansing the Sunshine State of crimes, the corps arrested suspected armed robbers, kidnappers, and rapists among others. Adetunji said the six suspects who specialise in kidnapping normally hypnotize their victims before kidnapping them. He added that two suspects who attempted to kidnap a businesswoman in the Akoko area of the state were also paraded, adding that some suspects were also paraded for allegedly snatching of motorbikes and attempted murder in Oba-Akoko area.

According to the Corps Commander, the suspects usually killed their victims after snatching their motorbikes and subsequently dismantle the same for onward transfer to Ogun State and other neighbouring states as spare parts. He reiterated that Governor Oluwarotimi Akeredolu ledadministration would not relent in its determination to rid the state of undesirable criminals.

He further implored the people of the state to join hands with all security agencies in the state to rid the state of criminals, announcing that the current slogan is "See something, say something." He emphasized that the suspects will be charged to court as soon as investigations on them have been concluded.

judiciary workers had not salary in the state and this delay in salary payment has been like this since December 2021," the spokesman said.

"We call on the state government to put us on the priority list as the third arm of the government.

"If the executive and legislative arms are given priority, the judiciary should also be given the same. The sit-at-home will continue until we receive our July salary," Okulaja added.

The strike action embarked on by the union led to the

closure of the gates of Iyaganku magistrates' court and the state high court.

Ălso, a worker who pleaded anonymity appealed to the government to salvage the precarious incident because the workers were undergoing hard times.

Nigeria pharmacists flee country, seek opportunities abroad, laments AHAPN

The Association of Hospital and Administrative Pharmacists of Nigeria (AHAPN), has revealed that some of its members have left the country to seek better career opportunities because of several issues including the heightened level of insecurity.

AHAPN said that most of the members have exploited the option of going to Canada and other developed countries.

In a statement by the President of AHAPN, Olabode Ógunjemiyo, during its 23rd Annual National Scientific Conference with the theme 'COVID-19 Experience: Expanding the Role of Health System Pharmacists' in Lafia, he recounted how a friend of his was kidnapped en route to Benin, Edo State.

Ogunjemiyo said, "I remember a colleague of mine who was travelling from Owo, in Ondo state where we practice to Benin in Edo state. He was kidnapped along the way. As soon as he was released, he immediately left the country with his family. So those are the major reasons.

"Within the last one year, we have lost about 200 pharmacists to brain drain. Most of them have gone to Canada and other developed countries," he lamented.

The President of AHAPN stressed that the outflow of Nigerian pharmacists has created an imbalance in the system with top-level pharmacists outnumbering the pharmacists in the lower cadre because the latter have resorted to exploring opportunities in the developed countries.

Ogunjemiyo, said, "The association expected over 1,000 pharmacists across the country from the rank and file within the hospital and administrative positions, and those from other areas of pharmacy practice to attend the conference which kicked off today.

"It is worthy of note that Nasarawa state is hosting the conference of any professional group of this magnitude for the very first time since its creation.


"It is indeed a great honour for the government and the people of Nasarawa state as the name of the state will be included in the pharmaceutical lexicon," he commended.

UN, Nigeria, others, form alliance to end AIDS in children by 2030

Nigeria has joined other countries to partner with agencies of the United Nations (UN) to end HIV infections among children by 2030.

The new Global Alliance for Ending AIDS in Children by 2030 was announced by leading figures at the International AIDS Conference taking place in Montreal, Canada.

In a report by the World Health Organisation, (WHO), on Monday, August 1, 52% of the children living with HIV globally have access to antiretrovirals which is far below that of the adult's 76% according to data by UNAIDS Global AIDS Update 2022.

With this wide difference existing between children and adults, UN agencies thought it imperative to form an alliance to provide the avenue for more children to get access to these antiretrovirals.

Aside from Nigeria and the UN agencies, the alliance includes civil society movements, such as the Global Network of People living with HIV, national governments in the most affected countries, and international partners, including PEPFAR and the Global Fund.

Twelve countries that have also joined Nigeria in the first phase include Angola, Cameroon, Côte d'Ivoire, the Democratic Republic of the Congo (DRC), Kenya, Mozambique, South Africa, Uganda, the United Republic of Tanzania, Zambia, and Zimbabwe.

Meanwhile, the Nigeria Minister of Health, Dr Osagie Ehanire has promised to create a system in the health sector that will provide an avenue for children living with HIV to get the proper care.

The Health Minister, who was at the event in Canada to reiterate Nigeria's commitment to combating the infections, announced that the country will host the alliance's political launch in Africa at a Ministerial meeting in October 2022.

Globally, only half (52%) of children living with HIV are on life-saving treatment, far behind adults where three quarters (76%) are receiving antiretrovirals, according to the data that has just been released in the UNAIDS Global AIDS Update 2022. Concerned by the stalling of progress for children, and the widening gap between children and adults, UNAIDS, UNICEF, WHO and partners have brought together a global alliance to ensure that no child living with HIV is denied treatment by the end of the decade and to prevent new infant HIV infections.

The new Global Alliance for Ending AIDS in Children by 2030 was announced by leading figures at the International AIDS Conference taking place in Montreal, Canada.

In addition to the United Nations agencies, the alliance includes civil society movements, including the Global Network of People living with HIV, national governments in the most affected countries, and international partners, including PEPFAR and the Global Fund. NCDC confirms monkeypox in 15 states

The Nigeria Centre for Disease Control (NCDC), yesterday, confirmed 15 new confirmed positive cases of monkeypox in Epi Week 29 from 10 states – Ondo (three); Taraba (two); Lagos (two); Bayelsa (two); Rivers (one); Kogi (one); Imo (one); Delta (one); Anambra (one) and Abia (one).

The latest Update on Monkeypox in Nigeria published by the centre showed that there were 19 new suspected cases reported in the week under review, spanning July 18 to 24, from 12 states, namely Ondo (four); Bayelsa (three); Taraba (two); Lagos (two); Rivers (one); Kogi (one); Kano (one); Imo (one); Delta (one); Anambra (one); Akwa Ibom (one) and Abia (one).

It noted: "From January 1 to July 24, 2022, there have (89 males, 44 females) from 26 states – Lagos, 17; Adamawa, 11; Delta, 11; Rivers, 10; Bayelsa, 10; Ondo, nine and Edo, eight.

"Others are Nasarawa (seven); Plateau (six); Federal Capital Territory (five); Anambra (five); Taraba (five); Imo (four); Cross River (three); Kwara (three); Borno

(three); Oyo (three) and Kano (two), Katsina (two), Gombe (two), Kogi (two), Niger (one).

"The rest consists of Ogun (one); Bauchi (one); Akwa Ibom (one) and Abia (one).

"Three deaths were recorded from three states – Delta (one); Lagos (one) and Ondo (one). Overall, since the re-emergence of

monkeypox in September 2017 and up to July 24, 2022, a total of 869 suspected cases have been reported from 35 states."

The centre continued: "Of these 869 suspected cases, there have been 359 (41.3 per cent) confirmed (237 males, 122 females) from 30 states – Rivers (62); Bayelsa (53); Lagos (47); Delta (40); Edo

(18); Cross River (17); Imo (12); FCT (11); Adamawa (11); Ondo (nine); Nasarawa (nine); Oyo (nine); Plateau (nine); Akwa Ibom (eight); Anambra (seven); Taraba (five); Enugu (four); Abia (four); Kwara (three); Borno (three); Benue (two); Ekiti (two); Kano (two); Niger (two); Ogun (two); Katsina (two); Gombe (two); Kogi (two); Ebonyi (one) and Bauchi (one).

"In addition, from September 2017 to July 24, 2022, a total of eleven (11) deaths have been recorded (CFR= 3.0 per cent) in eight states – Lagos (three); Edo (two); Imo (one); Cross River (one); FCT (one); Rivers (one), Undo (one) and Delta (one).

"The ongoing efforts to strengthen surveillance at national and sub-national levels increased awareness from global news headlines and our investments in risk communication and community engagement (RCCE) have contributed in part or whole to this observed increase in cases, which we have seen this year. The NCDC will continue to monitor the situation even as we sustain ongoing response efforts."





Political Dynasties: How Nigerian leaders plant children as successors

olitical dynasties exist around the world. In the United States in 2001, George W. Bush became the first modern president whose father (President George H.W. Bush) had also been elected president. (The sixth president, John Quincy Adams, served from 1825-1829 and was the son of the second president, John Adams.) Bush also became the first U.S. president to hold the position for longer than his father. In East and South Asia, there have been many daughters of heads of state who have been elected to the same position, such as South Korean President Pak Geun-hye, former Philippines President Corazon Aquino, and former Indian Prime Minister Indira Gandhi. In Pakistan, in a rare occurrence, a husband took over from his wife, Benazir Bhutto.

Africa has a more mixed experience. Seven countries on the continent have had both father and son (and one brother) lead the country: Botswana, Kenya, the Democratic Republic of the Congo (DRC), Gabon, Togo, Mauritius, and Malawi. These are different from Morocco and Swaziland which are kingdoms.

In each of these cases, the succession process has been different, as has the interim between father and son.

However, to guard against the creation of birthright dynasties as opposed to meritbased family political dynasties, recent events suggest that countries should and must have clear constitutional processes for succession as well as open transparent freely contested elections.

In Nigeria, political leaders are fast planting their children in political offices using their influences, resources and political party platforms.

First Republic federal lawmaker, Chief Saburi Bankole saw his son Dimeji elected member of the House of Representatives and emerged Speaker apparently due to his brotherhood fraternities with the then President, Chief Olusegun Obasanjo.

Even Obasanjo's daughter, Iyabo after serving as a Commissioner in Ogun State went ahead to represent the state as a Senator.

Second Republic Senate Leader, late Dr Olusola Saraki handed over his political dynasty to his children, Dr Bukola Saraki who became Senate President in the 8th Senate. Also his daughter, Gbemisola Saraki went as far as contesting the Kwara State governorship election on the platform of the Allied Congress Party of Nigeria (ACPN) but lost to the People's Democratic Party (PDP).

His father, a military President of Nigeria, Muhammed, son of late General Sani Abacha recently emerged as the governorship candidate of PDP in Kano. He had previously contested the governorship election in Kano on the platform of CPC and lost.

Apart from Abacha, whose son is being propped up to become a state governor due to his father's influence, a former governor of Jigawa State and PDP chieftain, Alhaji Sule Lamido succeeded in making his son the governorship candidate of the PDP in the state ahead of 2023.

Like an anointed candidate, Mustapha polled 829 votes to defeat former Minister of Power, Hon. Saleh Shehu Hadejia, who scored 0 votes out of a total of 832 votes

Strongman of Ibadan Politics, late Lamidi Adedibu after successfully mentored many politicians, fielded his son, Kamorudeen in senatorial elections and he represented Oyo South in the 7th Senate.

Educationist and activist, late Chief Lam Adesina was Oyo State governor from 1999 to 2003. After his demise, his political groups within the APC compensated the family by giving his son Dapo a House of Representatives ticket to represent Ibadan South East/ North East federal constituency.

One-time Senator and former Nigerian Ambassador to Ghana, Senator Musiliu Obanikoro had his son elected lawmaker to represent Eti Osa State Constituency in Lagos State.

Former governor of Oyo State, late Otunba Christopher Adebola Alao- Akala's son, Olamijuwonlo recently won the APC ticket for Ogbomoso North, South and Oriire Federal Constituency in the House of Representatives.

As a preferred candidate, Olamijuwonlo, a former chairman of Ogbomoso North local government area, polled all the 150 votes to clinch the ticket of the APC.

Daughter of the Delta State governor, Ifeanyi Okowa, Marilyn Okowa-Daramola, won the Ika North East ticket for the Delta House of Assembly.

Also the daughter of former governor James Ibori, Ms Erhiatake Ibori-Suenu clinched the PDP House of Representatives ticket for Ethiope West federal constituency by defeating the incumbent in a rerun election.

Umar Ganduje, son of sitting Kano State governor, Abdullahi Ganduje, emerged as the flag bearer of the APC for Dawakin Tofa/Tofa/Rimingado Federal Constituency in the House of Representatives.

Umar Ganduje was the only contestant as the stakeholders from the constituency chose him as a consensus candidate following the withdrawal of his opponent, Junaidu Yakubu, after a reconciliation meeting arranged by the senator representing Kano North, Barau Jibrin, and the House of Reps member representing Bichi Federal Constituency, Abubakar Bichi, before the primary election.

Governor Ganduje paid the price by rescinding his senatorial ambition for the incumbent Senator Jibrin in a reconciliatory effort to prevent the lawmaker from dumping the APC.

Idris Abiola-Ajimobi, son of late former governor of Oyo State, late Abiola Ajimobi, emerged the APC candidate for Ibadan South-West II State Constituency of Oyo State House of Assembly. He emerged as the consensus candidate in honour of his late father's position in the party.

Another sitting governor, Nasir El-Rufai of Kaduna State had his son, Bello El-Rufai, emerge winner of the APC ticket for the House of Representatives in Kaduna North Federal Constituency.

Former Ekiti State governor Ayodele Fayose's son, Joju emerged the winner of the PDP House of Representatives ticket for the Ekiti Central Federal Constituency I comprising Ado and Irepodun/Ifelodun.

Another former governor of Ogun State, Chief Olusegun Osoba got his son, Olumide the APC third term ticket for the House of Representatives seat for Abeokuta North /Odeda/Obafemi-Owode federal constituency.

PDP crisis festers as Ayu's camp insists National Chairman will not resign

• Damagum tip to act pending 2023 polls

• Party will not break, said BoT chair as body, NWC meets today

Party members loyal to the national chairman of the Peoples Democratic Party (PDP) are insisting that Dr Iyorchia Ayu will not resign his position.

They argued that there is no justification for the call for Ayu's resignation in the face of the ongoing crisis rocking the opposition party following the outcome of its presidential primary and selection of vice presidential candidate.

Ayu's loyalists believed that efforts to save the polarization along Atiku and Wike factions would yield results.

The national chairman was said not to be folding his arms while the crisis lingers but striving behind the screen to galvanise leaders across regions and zones to both actors, Atiku and Wike together.

A member of the party's National Working Committee (NWC) said the reported clamour by the Wike's camp that Ayu must step down is not feasible.

He told The Trumpet that the situation in the party has not warranted such call for Ayu's resignation.

Speaking anonymously, he said "there is no justification for such call as such call will further trouble the party. I wonder what such demand is set to achieve in this pre-election year.

"I heard someone saying they want the chairman to resign on the grounds that both the national chairman and the presidential candidate cannot come from the same region. But they forgot that such can come into play after our candidate Atiku emerged the winner. Then it will be mandatory for the chairman to step down.

He was reminded of an agreement that Ayu needed to resign if Atiku picked the presidential ticket but said he was not aware of such agreement.

Buttressing his position that Ayu has not been so docile about the crisis, he said "was it not the national chairman that worked on the Saraki's reconciliation committee that has been going round lieutenants of the two major actors.

"The national chairman will sit over the reconciliatory efforts and two will be reconciled. All aggrieved members will be brought together and we will have a united house ahead of the election. Let me shock you, this issue will top discussions at our meeting on Wednesday and our elders, the BoT is also meeting the same day to discuss the same issue.

"Results of the underground efforts by Ayu and other leaders will be manifested in the list of the national campaign council that will be composed soon.

He acknowledged that a meeting of the majority of NWC members was held at Ayu's private residence in Abuja on Monday, he said it was not a face saving meeting but a meeting to put certain things in order before today's meeting.

The tension in the party is being fuelled by strong words across the fence and the national chairman, Dr Iyorchia Ayu caught in between, prompting the call for his resignation.

Also, a former chieftain of PDP, Senator Abdul Ningi who is a staunch supporter of Atiku was critical of alleged foot dragging by the NWC in resolving the crisis.

He spoke on Channels Television on Monday.

He accused the national chairman Iyorchia Ayu of improper handling of the issue

because of his personal interest.

According to him, s proactive leadership should have mend fences between Atiku and Wike but lamented that Ayu left the task to the presidential candidate and his men to sort out.

He said it shouldn't be Atiku's men that will be looking for a way to broker truce between the two over lingering issues but the leadership of the party should have taken the initiative.

Ningi also expressed optimism that all issues will be resolved amicably.

Members of PDP who are aggrieved that the governor of Rivers State was shortchanged in the race for vice presidential race accused the national chairman of sabotaging the process leading to the primary and influencing the choice of Delta governor, Ifeanyi Okowa as Atiku's running mate.

Wike personally accused Atiku of not speaking the truth about circumstances surrounding recent events in the party after having kept mute for a while.

In an attempt to defend Atiku, reactions from his support rather stretch the fight.

Wike's loyalists accused Atiku's supporters of aggravating the crisis through uncomplimentary comments.

Former Governor Sule Lamido was quoted to have uttered statements that can further pitch the two actors against one another.

Comrade (Engr) Igbini Odafe Emmanuel, National President, Vanguard for Transparent Leadership and Democracy (VATLAD) said the totality of what Lamido said about Governor Wike is even more unfair and lies than the unfair and unjust treatment Atiku Abubakar meted on Governor Wike.

He faulted Lamido for saying that on the claim that what transpired at the PDP National Convention and that the outcome of the Process (Primary) was the Decision of PDP and should not be seen as personal?

"as Sule Lamido told the Truth about the process that led to the choice of Governor Okowa as the Vice Presidential Candidate of Atiku instead of Governor Wike?

"Has Sule Lamido told the Truth that the Presidential and Vice Presidential Ambitions of former Governor Peter Odili were stopped or truncated by the Party (PDP) which went on to nominate late Governor Musa Yar Adua of Katsina State as its Presidential Candidate and then Acting Governor Goodluck Jonathan of Bayelsa State as its Vice Presidential Candidate? The obvious answers to these questions are, NO, NO, NO. Sule Lamido has deliberately misrepresented Truth and told Untrue.

"How then does anyone who deliberately distorts the truth and tells lies, want to be described in the English Language? A "Liar" is an English Word which by its dictionary meaning is: "a person who tells lies". Governor Wike only spoke in English and used the appropriate English word. How then does this amount to insulting Atiku or anyone for that matter who told lies?

"If Atiku Abubakar or Sule Lamido did not want this English Word, "a Liar", to be used on them by Governor Wike or any lover of the Truth, they should not have embarked on telling what is not true about what happened or deliberately misrepresenting Truth and proven Facts of what Ttranspiredat the recent National Convention of PDP where Atiku narrowly garnered more Delegate Votes than Governor Wike to be declared the Party's Presidential Candidate.

"Was it the decision of the PDP of which Wike is a leading Chieftain and Presidential Aspirant, that Alhaji Atiku Abubakar is adopted as its Presidential Candidate? Is this what Sule Lamido is trying to tell Nigerians and the whole world as the Truth?

"Is Sule Lamido pretending not to know that what transpired at the venue of the PDP Presidential Primary which saw Governor Aminu Tambuwal allowed to go back to the podium to renege on his earlier decision to contest in the Primary and his call on his Supporters (Delegates) to cast their votes for him and instead, went to step down for Atiku and asked his Delegates to cast their votes for Atiku? Did this not run against the agreed procedure adopted by the PDP for the conduct of a Free, Fair and Transparent Presidential Primary?

"Did this not amount to Electoral Fraud and a valid legal ground for Wike to seek Judicial Intervention to nullify the entire outcome and the nomination of Atiku as Presidential Candidate?

"Yet, the same Governor Wike who is now vilified by Atiku, Sule Lamido and some other few PDP Chieftains, deliberately chose not to nullify the fraudulent process of the Primary for the greater good of the Party ahead of 2023 General Elections. Shouldn't he be commended?

"Is Sule Lamido pretending not to know that well-meaning Chieftains and members of the PDP were the ones who went to appeal to Governor Wike to accept to be Vice Presidential Candidate to Atiku in order to heal the wound caused by the Injustice done to him at the National Convention?"

Meanwhile, there is agitation that the Deputy National Chairman (North), Ambassador Ilya Damagum should be allowed to take charge as acting chairman should the plot to impeach Ayu scale through.

However, the chairman, Board of Trustees of the Peoples Democratic Party (PDP), Sen. Walid Jubrin on Monday said efforts are on the way to resolve the lingering crisis in the party, as a special reconciliation body and members of the BoT are set to reconcile Alhaji Atiku Abubakar, Governor Nyesom Wike and other aspirants in the last presidential primary of the party.

This is as he said that a reconciliatory agenda will be set at today's meeting of the BoT in Abuja.

According to the BoT chairman, the crisis which was consequent upon the outcome of the presidential primary and the selection of the PDP vice presidential candidate.

Jibrin said "I notice with great concern that the PDP primary elections of Atiku Abubakar and the appointment of Chief Okowa as president and vice president is unnecessary causing confusion among some PDP members.

"May I point out very strongly that there is no problem as envisaged by some people in our great party the PDP. I want to assure everyone that all plans are on ground to bring all members together as one and united.

"As what is happening in PDP can never be compared with the situation in APC especially their plans in trying to bring religious issues of Muslim-Muslim president and vice president.

Speaking on efforts on ground at finding a solution, the BoT chairman said "I have also noted that some groups are coming up trying to solve the issues of Okowa as vice-president. The latest group include some former governors of the party and the current governors, some BoT members and elders including Prof Jerry Gana, the chief spokesman of the Wike group, that is Dankwambo, governors of Enugu and Abia states, and former governor Ibrahim Idris of Kogi State.

"The aim of the group is to reconcile the aggrieved, especially Wike.

"Interestingly the BoT, the highest advisory body and the conscience of the party is meeting on Wednesday 3rd August to discuss the issues accordingly and we will be coming up with strong recommendations for the special committee set up for reconciliation of aggrieved members, especially Governor Wike.

"After the BoT meeting, we will meet with Atiku and Wike and all aggrieved members and all past presidential aspirants.

"It is my prayer as Chairman of BoT that the PDP will remain strong and win all elections in 2023.

Both camps anxiously await the outcome of today's meeting of the two organs of the party, the NWC and BoT.



EFCC arraigns father, son over illegal banking activities in Lagos

• As Surety bags five years for impersonation in Kaduna

The Economic and Financial Crimes Commission (EFCC) in Lagos State has arraigned one Emmanuel Jayeoba and his son, Ademola Jayeoba Wales, before Justice I. Nicholas Oweibo of the Federal High Court sitting in Ikoyi, Lagos on a two-count charge bordering on illegal banking activities.

A statement by the EFCC spokesperson, Wilson Uwujaren, said the suspects were arraigned on Monday, 1st August 2022.

According to the statement, one of the counts reads, "that you, Wales Kingdom Capital Limited sometime between October 2019 to December 2020 in Lagos within the jurisdiction of this Honourable Court did carry on banking business without a valid license and thereby committed an offence contrary to Section 2/2) of the Banks and Other Financial Institutions Act, Cap B3, Vol.2, Laws of the Federation of Nigeria, 2004."

The second count reads, "that you, Adewale Daniel Jayeoba, Emmanuel Jayeoba And Wales Kingdom Capital Limited whilst being Directors of Wales Kingdom Capital Limited sometime between October 2019 to December 2020 in Lagos within the jurisdiction of this Honourable Court knowingly consented to the carrying on of banking business without a valid license by the Company and thereby committed an offence contrary to section 2/2) and 49(1) of the Banks and Other Financial Institutions Act, Cap B3, Vol.2, Laws of the Federation of Nigeria, 2004."

The suspects were said to have pleaded not guilty to the offence when the counts were read before them.

Following their pleas, the prosecution counsel, Chinenye Okezie asked the court for a trial date and their remand in a correctional facility.

However, counsel to the defendants, Olaniyi George informed the court of a bail application and prayed that his clients be remanded in the custody of the EFCC pending the hearing of the application.

Justice Oweibo adjourned the case to Wednesday, August 3, 2022, for a hearing of the bail application and ordered the remand

of the defendants in EFCC custody.

Meanwhile, the Kaduna Zonal Command of the EFCC on Monday, August 1, 2022, secured the conviction and sentencing of one Ali Sani Yaro before Justice Daruis Khobo of the State High Court Kaduna, on a one-count charge.

Sani allegedly posed as a Grade Level 12 staff of Soba Local Government Area to secure the bail of a suspect under investigation by the EFCC. But the documents he presented were found to be forged in the course of verification by the Commission.

The charge against him read, "That you, Ali Sani Yaro sometime in February 2022 in Kaduna within the jurisdiction of this Honourable Court, pretended to be a staff of Soba Local Government Council on Grade Level 12 before Economic and Financial Crimes Commission, when you stood surety to one Charles Fred and in such assumed character and you thereby committed impersonation, an offence contrary to and punishable under Section 142 (1) of the Penal Code Law, 2017 of Kaduna State."

He pleaded guilty to the charge. Consequently, the Prosecuting Counsel, Y.J Matiyak, urged the court to convict the defendant accordingly.

In his ruling, Justice Khobo convicted and sentenced the defendant to five years of Imprisonment.

Court admits evidence against defendant for impersonating EFCC

The trial of one Ladeji Babatunde before Justice Oluwatoyin Taiwo of the Special Offences Court sitting in Ikeja, Lagos for offence bordering on obtaining money by false pretence to the tune of N2.9 million continued on Monday, August 1, 2022 with the trial judge delivering ruling on his trial-within-trial as the court admit in evidence the statement of the defendant.

Babatunde who was first arraigned in December 2021, is being prosecuted by the Economic and Financial Crimes Commission (EFCC) on a four-count charge.

According to the EFCC, one of the counts reads, "Ladeji Kelvin Babatunde on or about 19th - 22nd February 2021 at Lagos within the Ikeja Judicial Division of this Honourable

Court with intent to defraud obtained the sum of N1,500,000 (One Million Five Hundred Thousand Naira) only from one Chijioke Mmadubue and his syndicate of internet fraudsters based at Chevron axis of Lekki, Lagos under the false pretence that you will protect them from arrest by the operatives of the Economic and Financial Crimes Commission (EFCC) which representation you knew to be false."

Another count reads, "Ladeji Kelvin Babatunde on or about 18th March 2021 at Lagos within the Ikeja Judicial Division of this Honourable Court with intent to defraud obtained the sum of N800,000 (Eight Hundred Thousand Naira) only from one Jacob, an internet fraudster under the false pretence that you will help with his case at office of the Economic and Financial Crimes

Commission (EFCC) which representation you knew to be false."

The defendant, however, pleaded "not guilty" to the charges when read to him.

In the course of the trial, when the prosecuting counsel, Nnaemeka Omewa, sought to tender in evidence the statement of the defendant through the prosecution's witness, Bot Dachung Toma, the defence raised objection arguing that the statement was made involuntarily.

The objection necessitated the need for a trial within trial.

Delivering ruling on the trial-within-trial, Justice Taiwo held that "no act of torture was established".

The court thereafter admitted the statement as Exhibit C1 to C13 as the EFCC closed its case against the defendant.

Continuing with his testimony, Toma, told the court that the EFCC received a petition against the defendant alleging that he was going about posing as an official of the EFCC and using the guise to extort money from suspected internet fraudsters.

"We investigated the petition and found out that he was actually impersonating EFCC officials and going around the city collecting money that he will help them not to get arrested," he said.

He further testified that money was traced to his bank account and that it is believed that the extorted funds formed part of the money he used to build a house in Ogun State.

The prosecution thereafter closed its case. The matter has been adjourned till August 16, 2022 for the defence to open its case.

Court sends fake America actor, five others to jail for internet fraud

Justice Efe Ikponmwonba of the Edo State High Court sitting in Benin City on Monday, August 1, 2022, convicted and sentenced six internet fraudsters to jail for fraud.

A statement on Tuesday by the Economic and Financial Crimes Commission (EFCC) identified the convicts as Emejom Jude Chinomso, Okolie Collins, Hezekiah Oghenekume, Musa Dauda, Akinselure Adebayo and Obafemi Olywatosin

They were arraigned by the Benin Zonal Command of the EFCC on a separate one-count charge bordering on impersonation, intent to defraud and making false statements to the EFCC.

The charge against Akinselure Adebayo reads, "that you, Akinselure Adebayo on or about the 8th day of June 2022 at No 1 Court Road, GRA Benin City, Edo State within the jurisdiction of this Honourable Court did make a false statement in writing to an officer of the Economic and Financial Crimes Commission in the course of his duties as an officer of the Commission as to the ownership of a 2008 Toyota Camry with registration number: ABU 219 GF which you knew to be false and thereby committed an offence contrary to section 39(2)(a) of the Economic and Financial Crimes Commission (Establishment) Act,

2004 and punishable under section 39 (2)(b) of the same Act."

The charge against Okolie Collins reads, "that you, Okolie Collins between 2020 and 2021 in Abudu, Edo State within the jurisdiction of this Honourable Court did with intent to defraud represent yourself to be Alex Lougwin, an actor and American citizen on the Facebook platform and thereby committed an offence contrary to and punishable under section 484 of the Criminal Code Law Cap 48 Laws of Bendel State of Nigeria (as applicable in Edo State) 1976."

The defendants pleaded guilty to the charges

preferred against them by the EFCC prompting the prosecution, Francis Jirbo, I. N. Elodi and K. U. Udus to pray the court to convict and sentence them accordingly.

However, counsel to the defendants, Emmanuel Okorie, pleaded with the court to temper justice with mercy as the defendants have been remorseful for their actions.

In his ruling, Justice Ikponwonoba convicted and sentenced Collins and Chinomso to two years imprisonment with an option of N200,000 and N300,000 fine respectively.

The Judge sentenced the duo of Adebayo and Dauda to one-year imprisonment with

an option of N150,000 fine each.

Meanwhile, Oghenekume was sentenced to two years imprisonment with an option of N150,000 while Emmanuel got one-year imprisonment or a fine of N100,000.

Justice Ikponwonoba also ordered that a 2008 Toyota Camry car recovered from Adebayo be forfeited to the Federal Government of Nigeria.

Other items forfeited include mobile phones and Laptop computers recovered from the defendants. The defendants are also to undertake in writing to be of good behaviour henceforth.

Uniform cut-off marks for all Unity Schools

The recent ruling by Justice John Tsoho on Olisa Agbakoba vs the Attorney General of the Federation and Minister of Education which put an end to discriminatory cut-off marks for admission into Unity Schools is a welcome development. The learned Senior Advocate of Nigeria Chief Olisa Agbakoba (SAN) had filed a suit before a Federal High Court, Lagos asking the Court to stop the federal government from further using discriminatory cut-off marks for admission into Unity Schools across the nation. With this ruling, the nation could be on the way to proper unity and integration of our dear country, Nigeria.

It is an open fact that the principle behind applying different cut off marks for the 104 Federal Government Colleges, known as Unity schools across the nation based on gender, ethnicity and states of origin is discriminatory at the stage of our progress and development as a Nation.

In retrospect, the reason for all these can be rooted in the North then seen as educationally disadvantaged. It was then appropriate to use the disparity to encourage the affected states to catch up with the others. The ruling will remove all forms of discriminations prevalent in our unity schools to the shame of the vision and mission of the schools as enunciated by the nation's founding fathers | have been practised, such states are expected and past heroes. | to grow their educational institutions and

Unity can never be built on discrimination, marginalization, and segregation! We can no longer bring our children to the boxing arena of healthy education foundation with some of them blindfolded and ask them to compete with others. To prevent some states from being comfortable in an untenable situation, we must make our Federal Government Colleges, not only centres of excellence for healthy, non-discriminatory competitions, but make them places of our first elevens. This is because it has been indicated that many years after different provisions for the educationally backward states to meet up with their contemporaries

to grow their educational institutions and personnel through prioritized budgeting for education in their different states. We cannot remain rooted in one spot in the name of educationally disadvantaged.

We cannot continue to degrade our children by making it impossible for them to compete with their compatriots from other states. It is this healthy competition that made

States that are beneficiaries of these skewed provisions must be encouraged to present their first elevens to these unity schools, instead of the present practice of flooding such schools with ill-performing sons and daughters of the rich and mighty. They should do more of mobilization, coaching and injecting of more teaching personnel into their different ill-funded Institutions for the brightest and best to be fed into these Federal Government colleges. These colleges have now acquired a bad name because of disparities in cut-off marks for Unity Schools. How do we justify a cut-off mark of 160 points for candidates from Anambra or Delta States while fixing 2 points for candidates from Jigawa or Borno?

Federal Government Colleges or Unity Schools must be made centres of excellence as originally conceived. In a global village which the world has become, mediocrity should not be promoted over academic excellence. It is repugnant to equity, justice, and fair play.

2023: Will Nigerians wait in vain?

The waiting game is on. With measured apprehension and nervous presage, Nigerians are waiting for 2023 to arrive quickly. Those supporting septuagenarian APC leader and former Lagos State governor Bola Ahmed Tinubu call themselves Batists. Those supporting Nigeria's serial presidential aspirant and former Vice-President Atiku Abubakar of the PDP prefer to be known as Atikulated. Of course, the neutrals have keenly and critically looked into the future and, given Nigeria's current exertions, are circumspect about the reality of 2023.

Surely, it can only take the most optimistic person in Nigeria to believe that the 2023 elections will hold. The signs are ominous. It does not portend well that the seat of power Abuja, which ordinarily should be the most fortified and protected, is currently under siege by terrorists. If the activities of terrorists and bandits continue unchecked across



Still, they brazenly attacked the National Guard, one of Nigeria's most sophisticated security arms, killing two soldiers and wounding about six others. Nothing happened. Nobody was queried or sacked. Emboldened by the lack of resistance from any quarters, they threatened to kidnap Mr President and the governor of Kaduna State Mallam Nasri El-Rufai. They also threatened to invade and attack major cities in the country including Lagos, Port-Harcourt, and Enugu. At the moment, the government has shut down all schools, both primary and tertiary in Abuja indefinitely, an open admission by the APC Buhari administration that they cannot guarantee the lives of Nigerians. Gradually, terrorists and bandits are taking over the country, just gradually.

If these conditions continue unabated as they are likely to do, will elections take place in Nigeria next year? I flinched after watching a video of some army officers admitting that their superiors instructed them not to go after the terrorists. The all-important question is - will there be an election in Nigeria next year? Is the Buhari APC government committed to hand-

7ith the selection of the Presidential flag bearers by the various political parties for next year's election, the era of lame duck, especially in the Central Government is here. The lame duck definition refers to when a person in power has entered the final stages of their control, and the chosen successor has been elected or soon will be. Lame-duck became the term used to describe politicians, especially the president, who either lost an election or decided to forgo reelection.

For some time, we have been witnessing a weak Presidency, but it is likely oing to get worse now. What is about to happen is the deconstruction of the imperial Presidency. Nothing humbles a man or a woman who has been in power to realize suddenly that he or she has to lose the power. Exit date humbles any government official and that is why they say power is transient. I have witnessed the era of lame duck twice. The first time was the last six months of General Abdusalam Abubakar (80), GCFR, between 1998 and 1999. The second time was the last six months of President Olusegun Obasanjo (85), GCFR, during which President Umaru Musa Yar'adua was elected at the PDP Presidential election in December 2006. At those two occasions, I saw power fading from those in authority.

Suddenly those who wielded enormous power before became human to the extent that they were answering telephone calls and receiving telephone calls by themselves instead of through secretaries. Suddenly they were contacting old friends knowing fully well that they will soon be out of power.

During the lame duck era of General Abdusalam Abubakar, GCFR, he only concentrated on the construction of the Eagle Square, the National Assembly building and devoted much of his time to the transition programme. He dispatched his then Secretary to the Government of the Federation, Alhaji Gidado Idris, GCON, (15 March 1935 – 15 December 2017) to South Africa and East Africa to sell his transition programme to the leaders of that region. I accompanied Alhaji Gidado Idris on the trips. We met the then South African President, Nelson Mandela (July 18, 1918, Mvezo, South Africa—died December 5, 2013, Johannesburg) in Pretoria and Johannesburg. Present at the meetings with President Mandela was the then Nigeria ambassador to South Africa Alhaji Shehu Othman Malami(88), Sarkin Worno in Sokoto state and former Chairman of Union Bank, who was not only a friend to President Mandela and also part of his household. He constantly referred to him as Shehu while Malami referred to President Mandela as Madiba. No doubt President Mandela was very much fond of Alhaji Malami. The affinity between the two men was very strong.

In the various meetings, President Mandela always referred to General Obasanjo as my "friend". He was consoled when Alhaji Gidado told him that General Obasanjo was among those vying for the Présidency and his chances of becoming President were bright.

From South Africa, we moved to Kampala, Uganda where we met President Yoweri Kaguta Museveni (77). We also met President Daniel Àrap Moi (1924-2020) in Kenya as well as the Namibia President, Samuel Shafiishuna Daniel Nujoma(93). During the two weeks tour, we met President Benjamin Mkpa(1938-2020) of Tanzania.

That was when Nigeria was like a colossus in Africa.

Lame duck era is when ministers rush memos to the CABINET secretariat for approval by the Federal Executive Council. During the Lame auck era of General Abausalam, The CABINET secretariat was the centre of activities. Day and night members of the cabinet secretariat were receiving memos on contracts from different ministers. Their Permanent Secretary then, Dr. P.K. Kaigama, along with Alhaji Auwab Abdullahi, Mr. A. Fasan, Mr. O.S. Ogedengbe, Mr. Ibrahim Mahe, Mr Chike N. Agina, Mr. Wuese AI, Mr. T.A. Ajayi, Mr. M.U. Nnaji, Mr Joshua E. Okpo, Mr. K.W. Jibril, Mr. F.F. Ogunshakin, Mr. E.I. Onuoha, Mr. S.K. Ikata, Mr. O.I. Adisa, Miss Charity C. Utok and others were

working day and night. The gossip among the workers in cabinet secretariat was that the memos were "partying gifts". At that time the media was reporting how our foreign reserve was depreciating daily.

The only thing remarkable about the lame duck era of General Abdusalam was that it was successful, in that he handed over to General Olusegun Obasanjo on May 29, 1999.

In January 2005, Chief Audu Innocent Ogbeh(74), an Idoma from Otukpo in Benue state, was forced to resign as Chairman of PDP. It was assumed that Chief Ogbeh fell out with President Obasanjo on certain principles. Chief Ogbeh had earlier taken over the Chairmanship of the party from Chief Bernabas Andar İyoryer Gemade (73) also from Benue state. Chief Ogbeh's resignation took effect from February 28, 2006. Chief Audu Ogbeh returned to his Efugo Farms in Makurdi.

He was replaced by Colonel (rtd) Ahmadu Adah Ali(86) from Idah in Kogi state. Colonel Alí has served as Minister of Education between 1976 and 1979 during the era of General Olusegun Obasanjo. Esprit de Corp between Colonel Ali and President Obasanjo is so deep. After Chief Audu Ógbeh's removal, the PDP headquarters was being run as a epartment under President Olusegun Obasanjo. Rumours were circulating that President Obasanjo wanted a third term which was unconstitutional.

On May 16, 2006, the deputy Senate President Alhaji Ibrahim Mantu(February 16, 1947- August 17, 2021) from Gindirin in Manga Local Government Area of Plateau state representing Plateau Central presented a bill to the Senate. The bill was to enable anyone including President Obasanjo to contest election without a limit to his term. The bill was termed THIRD TERM by the

Insecurity: Don't wait for govt, defend yourselves, Masari tells Nigerians

"The security challenges we are facing in terms of killings and kidnappings are not only limited to Katsina or Nigeria, but they happen everywhere, even in America and China. But their citizens don't fold their arms and

"Don't lock yourselves inside and say it is the responsibility of the government or police to defend you: how many people will the police defend? But if you defend yourself, it will reduce the work of policemen and soldiers," he added.

Masari's statement came weeks after Governor Bello Matawalle of Zamfara encouraged citizens in his state to buy guns and defend themselves against bandits and terrorists.

FCTA demolishes illegal structures in Kuje over insecurity

Territory Administration (FCTA) Monday commenced a week-long massive demolition of illegal structures at Kuje to rid the satellite town of crime and mitigate the proliferation of illegal structures, purportedly obstructing human vehicular movements in the

few days after the terrorists' attack on the Kuje Medium Security Prison, the demolition followed after months of sensitisation and the expiration of authorities' notices to illegal occupants to vacate the area.

During the clean-up exercise, which lasted for about seven hours, hundreds structures ranging kiosks, containers, attachments to stores and worship centres, shanties and signposts encroaching on the road corridors were pulled down by the authorities.

FCTA officials rolled in the bulldozers and dismantled roadside encroachments from the notorious Tipper Garage to the Kuje main market while some illegal squatters frantically salvaged some of their belongings before the demolition team arrived.

The Senior Special Assistant on Monitoring, Inspection and Enforcement to FCT Minister, Ikharo Attah, said the exercise was approved by the FCT Minister, Mohammed Musa Bello and was under the guidance of FCT Police Commissioner, Sunday Babaji and other security heads in the territory.

According to him, the inister was displeased minister with the extreme violations at Kuje, noting that the multiple contraventions like illegal settlements, extreme road encroachment, roadside trading, and encroachment of rail corridors made Kuje a very unsafe area.

He said the clean-up would be a week-long exercise, as Kuie had been very worrisome in some areas of insecurity.

"Today, we have been able to address the issue of roadside encroachment from Tipper Garage to the main market. We also touched the fruit market. Tomorrow, we will be claiming the rail corridor, the entire rail corridor and keep it safe, and children can use it for recreation," Attah said.

He added, "We marked Kuje about four months ago. And we have been waiting for a long, so the word of caution is what they have seen today."

Air fares soar as Lagos-Abuja-Kano route, others hit N135,000

ir travellers continued to lament the incessant ▲hikes in ticket prices on the domestic routes, especially from Lagos to Abuja, Abuja-Kano and Port Harcourt-Lagos-Abuja, as airlines now charge as much as N125,000 and N135,000 for one-way domestic flights.

Subsequently, most intending air travellers have had to cancel their planned trips to parts of the country due to the sharp increase the air fares and are opting for road transport.

Airlines have blamed the development on the incessant increase in the price of aviation fuel, otherwise called Jet A1 and other operational costs, which

kept rising. The Trumpet recalled that aviation fuel, which was sold for less than N200 per litre last year now goes for over N800 and there are fears that it could hit N1000 amid the falling value of the naira and the Russia-Ukraine war, which had disrupted supply chain in the oil industry.

This was exacerbated by the Nigerian Civil Aviation Authority's (NCAA) suspension of flight operations of Aero Contractors and Dana Air by

Following the development, some stakeholders have advised airlines to sell tickets to reflect the current price of Jet A1, even as some sources also revealed that the airlines had to do so to remain in business.

Reports indicated that most airlines have reviewed their prices upwards with the lowest ticket selling for N80,000, as against N50,000, which the airlines introduced recently in light of unfolding events in the aviation industry.

A passenger of one of the local airlines told The Trumpet he wanted to travel to Lagos from Abuja for a programme on Thursday last week and the only available flight he got was N125,000 and he had to suspend the trip.

"I found that quite exorbitant, which means I would be spending over N200,000 for a return trip. Where will I get that kind of money? It is quite absurd and unsustainab, especially for businesses," he said.

Checks on Ibom Air on Monday showed that Lagos-Abuja flight for Wednesday indicated that most seats have been fully booked but the ticket costs N78,000, Air Peace flight from Lagos to Kano now cost over N80,000, while Abuja-Kano flight costs N135,000 on Max Air.

However, booking 48 hours ahead of the flight costs N78,000 per passenger, just as Azman Air's flight from Lagos to Kaduna cost N100,000 in the last few weeks. Also, its Lagos-Kano flight costs between N95,000 and N105,000 depending on the travel date and time.

It was also learnt that flight from Lagos to Abuja on Green Africa Airlines, which used to cost between N27, 000 and N35,000 with the tag of low-cost carriers at a time other operators were charging N50,000, has virtually dumped low cost fares in their inventory and selling Lagos-Abuja flights for N80,000.

It also selling its Lagos-Abuja and Abuja-Ilorin flight tickets for N54,000 to N70,000, as against the usual N25,000.

Responding to the development, an aviation analyst and Chief Executive Officer (CEO) of TopBrass Airline, Captain Roland Iyayi, said while the current fare hike was unsustainable, airline operators have no option but to

review their prices upward to recover costs.

He said as part of the solution to the current challenges facing the airlines, the NCAA should review the five per cent Tickets Sale Charge (TSC), adding: "The immediate solution is for the Federal Government to import and subsidise Jet A1 before the refineries become functional

CBN assures Nigerians on foreign exchange crisis

Following rising demands for foreign exchange by individuals and businesses in Nigeria and the unprecedented crash of the naira, the Central Bank of Nigeria (CBN) has asked stakeholders to resist the urge of accepting speculators' gimmicks and manipulations in the foreign exchange market.

Director, Corporate Communications of CBN, Osita Nwansobi, who made the call in Abuja, recently said the apex bank remained committed to resolving the foreign exchange crisis confronting the nation, as it has been working to manage the demand and supply sides of the market.

The CBN spokesman, however, admitted that there was actually huge demand pressure for foreign exchange to meet the needs of manufacturers as well as payment of tuition, medical fees and other invisible items.

He said the bank was con-

cerned about the international value of the naira, adding that the monetary authority was strategising to help Nigeria earn more stable and sustainable inflow of foreign exchange in the face of dwindling revenue from the

Nwansobi noted the RT200FX programme and the Naira4Dollar rebate scheme, as well as other initiatives undertaken by the bank have helped to increase foreign exchange inflows into the country.

He said the bank's records showed that foreign exchange inflow through the RT200FX programme in the first and second quarters of 2022 increased significantly to about \$600 million as of June 2022, adding: "The Naira4Dollar incentive also increased the volume of Diaspora remittances during the first half

According to him, interventions such as the 100-for-100 policy on production and productivity,

Anchor Borrower Programme (ABP) and the Non-oil Export Stimulation Facility (NESF), among others, were also geared toward diversifying the economy, enhancing inflow of foreign exchange, stimulating production and reducing the pressure of foreign exchange demands.

The bank will continue to make deliberate efforts in the foreign exchange sector to avert further downward slide in the value of the naira fuelled by speculative tendencies," he said.

He stressed CBN Governor, Godwin Emefiele's advice to Nigerians to adjust their consumption patterns by looking inwards and finding innovative solutions to the country's economic challenges.

Nwanisobi added that monetary policy alone would not solve all the changes surrounding foreign exchange demand and supply in the country, adding: "It is our collective duty as Nigerians to shore up the value of the naira."

Meanwhile, stakeholders of the aviation industry have expressed concern that more airlines could follow suit if the CBN, which restricts access to foreign currency to tackle the severe dollar shortage, failed to adequately address the challenges facing airlines in the

It would be recalled that aviation fuel, also known as Jet A1 currently sold for about N1,000 per litre, while the naira is currently exchanging for about N710 to \$1 in the parallel market.

Nigeria, which gets roughly 90 per cent of its foreign exchange from crude oil sales, is struggling to produce due to pipeline vandalism and crude oil theft, in addition to years of underinvestment and official mismanagement of proceeds from crude oil sales.

It would also be recalled that amid similar foreign exchange restrictions in 2016, several airlines reduced their flights and carriers, while Iberia and United Airlines stopped flights to Nigerian.

The International Air Transport Association (IATA) said in June this year that Nigeria was withholding hundreds of millions in revenue that international carriers operating in the country had earned.

Port users vow to resist planned increase in wharf landing fees

learing agents and freight forwarders have flayed plans by the Lagos State Wharf Landing Fee Collecting Authority to increase fees on imported goods through the seaports in the state, insisting they will resist the move.

It would be recalled that the agency had last week, disclosed that it had approached the state House of Assembly to review the 13-year-old law, which empowered the state to collect N300 on vehicles, N500 on buses and N1,000 on trucks coming into the country through the Lagos ports.

But reacting to the development, the Public Relations Officer (PRO) of the Association of Registered Freight Forwarders of Nigeria (AREFFN), Taiwo Fatomilola, accused the state government of crippling businesses

at the ports through the imposition of multiple taxes, levies and fees. Fatomilola challenged the state government to publish details of the money it has been receiving in the last 13 years, which it claimed had been domiciled with the local government areas and local council development areas (LCDAs) in the

"They are not sharing any money with the councils. They should provide details of the money being given. The roads under the local governments are in terrible conditions and have not been repaired, so if their claim of giving the landing fees generated from the wharf to the councils in the past 13 years is true, why are the roads not in good shape?

"We will resist and fight the state government with all our strength. Importers do not give freight forwarders money for wharf landing fees. Rather, the freight forwarders that pay from their pockets. Of the whole states in the country, only Lagos State has been collecting the fee. Why do they want to increase it now that the 2023 general election is close? He asked.

Also, Deputy President of the National Association of Government Approved Freight Forwarders (NAGAFF), Dr Segun Musa, who said the wharf landing fees was the most unfortunate thing that has ever happened to the maritime industry, accused leaders in the freight forwarding and customs brokers for being responsible for the development.

"Unfortunately, the silence of the leaders in the freight forwarding and customs brokerage in the face of oppression is a direct indication that they are only interested in themselves without considering the impacts of the hardships on innocent and upcoming practitioners and the industry at large.

The maritime sector is dominated by self-interest leaders that are careless about the future of our industry, but only express concerns when it affects their interest," he

Also speaking, the Chairman of the International Freight Forwarders Association (IFFA), Port and Terminal Multi-Services Limited (PTML) Chapter, Sunny Nnebe, queried what the money the state government has been collecting over the years was used for.

He described the wharf landing fee as illegality and wickedness on importers making use of the Lagos ports because stating that such fees are not collected in other ports. Nnebe queried the rationale

behind the Lagos State Government's review and the increment of the fees based on the rising exchange rate, asking: "Does the state government use the money to repair port roads? Do they use dollars to do that? Why is the Chairman talking about the exchange rate and if there are no ports in Lagos can they come up with this wicked demand?

"Before former Governor Babatunde Fashola implemented the forcible collection, had the local government not been funded? A demand for an increase in this regard amounts to wickedness and mockery of other states whose residents do the importation, but don't have ports

in their states," he said.
On his part, a Youth Leader of the Association of Nigeria Licensed

Customs Agents (ANLCA) at Tin Can Island Port, Remilekun Sikiru, said an increase in the fee at this time the economy is not stable, would not be tolerated by the agents.

He debunked insinuations by the Wharf Landing Fee Collecting Authority Chairman that some clearing agents collect as high as N50, 000 from their importers under the guise of paying the fee maintaining that the agency stationing its officials on port access roads to chase after cleared vehicles to collect the fee is tantamount to robbery and touting.

Their activities are causing a lot of traffic on port access roads, especially at Liverpool under a bridge and along Trinity bus stop, they have gone as far as recruiting area boys with a lot of weapons damaging vehicles as a result of

the collection of the fee.
"What the chairman of the agency, Adegboyega Salvador, said about agents collecting as much as N50, 000 from importers for the agency fee is laughable. How can importers, who are hardly able to pay total

charges to the agents now give such?
"As clearing agents, we pay
the fee from our pockets and
the Chairman has failed to let members of the public know that his men attached with policemen and soldiers, especially under the Liverpool Bridge seize vehicles from us to their premises anytime our members beg them that they have no money. They even towed our vehicles with a towing vehicle, which will be added to your charges as a penalty, which is nothing less than 100, 000 for settlement.

He, however, suggested that the Wharf Landing Authority could digitise collection of the fees and remove touts from the port access roads, adding that doing so would be a welcome development.

How Inland dry ports will boost Nigeria's agric exports, generate revenue


Minister of Transportation, Mu'azu Sambo, has declared that the operation of Inland Dry Ports (IDPs) across the country will be a catalyst for improved trade inflows and revenue generation for the Federal Government besides its importance in facilitating international trade and transit cargoes to landlocked

Sambo said the dry ports would also bring shipping activities closer to shippers in the hinterland, increase cargo throughput, boost inland trade and promote export of agricultural products, thereby leading multiproducts oriented economy.

He stated this, yesterday, during the Nigerian Shippers' Council (NSC) and Federal Ministry of Transportation (FMoT) one-day stakeholders sensitisation programme and launching of operational manual for Inland Dry Ports in the country Lagos.

Sambo, who was represented by the Deputy Director Inland Container Depot of the ministry, Ewache Victor, stated that the dry ports project would also create employment opportunities that would ultimately stem increasing rural-urban migration, act as source of internally Generated Revenue (IGR) to the host communities and states, as well as boost revenue sources of

the Federal Government. According to him, the inland dry

port project was conceived as part of the government's ports reform programme designed in 2006 to decongest the seaports, while also taking shipping and port services closer to importers and exporters in the hinterland, among other objectives.

He said the project is being developed through Public Private Partnerships (PPPs) using the Build, Own, Operate and Transfer (BOOT) Model in Isiala- Ngwa, Abia State; Erunmu Ibadan, Oyo State; Heipang in Jos, Plateau State; Funtua, Katsina State; Maiduguri, Borno State and Dala in Kano State, which would soon be commissioned.

Sambo noted that other inland dry ports are currently being processed in Kebbi, Osun, Anambra, Oyo, Edo, Bauchi and Abia states, adding that the operational manual, which is being launched, would cover activities in the dry ports, which would accommodate container import and export by rail, container import and export by truck, customs controls and empty container storage.

He urged operators and regulators to abide by the operational processes as contained in the manual, which specifically describes the functions, activities and operations of the dry ports as it relates to export and import according to international best practices for standard quality control

Speaking earlier, Executive Secretary and Chief Executive Officer of the Nigerian Shippers' Council (NSC), Emmanuel Jime, said the inland dry ports project was conceived as part reform programme transport sector to promote efficient transportation, enhance efficiency at the ports and engender trade facilitation in the country.

He explained that the strategic importance of producing the manual articulates the step-by-step procedures for receiving, storing, handling and delivery of cargoes as well as highlighting the operations and responsibilities of agencies and timelines for discharging such tasks.

He said the operational manual, which was launched in Kano on July 21, 2022, will be launched in Port-Harcourt, Rivers State on Tuesday, August 9, 2022, as it provides detailed processes and procedures for the main activities of the Inland dry ports.

The manual is based on best international practices adapted to suit the Nigerian context. Indeed, each dry port will have its own specialities, organisational implementation, layout constraints and services offered and would therefore amend aspects of the manual on a case-by-case basis.

Jime stressed that the NSC will work to ensure that the upcoming inland dry ports, particularly those in Dala, Funtua and Jos will avoid the pitfalls that the seaports are currently experiencing by ensuring they are fully compliant with the operational manual and ISPS compliant, as well as operate for every day for seven days a week. He said: "They are transit facili-

ties fully digitised and served with intermodal transport among others."

On his part, the Managing Director, Nigerian Ports Authority (NPA), Mohammed Bello-Koko, said the Lagos seaports were operating beyond their capacity, hence, the need to optimize the inland dry ports.

Bello-Koko who was represented by the Assistant General Manager, Operations, Ayodele Durowaiye, said NPA had been working to ensure that the Kaduna Inland Dry Port (KIDP) was linked to the borders of neighbouring countries in the northern part of the country to ensure passage of goods in and out of the country.

He said the effective operations of the IDPs would provide viable options for shippers and consignees outside the possibility of export cargoes.

Bello-Koko, however, pledged the NPA's support for other government agencies under the ministry of transportation to aid the movement of import and export cargoes as well as boxes in the country.

President of the Shippers Association of Lagos (SAL), Leonard Ogamba, commended the operational manual as a working tool that will enable cargo owners, importers, exporters and shippers to hold the government agencies at the ports accountable for performing their duties efficiently, as well as when they deviate from their core responsibilities.

Uncertainty dogs release of \$3.1b AFC fund for e-customs project

If feelers from stakeholders are anything to go by, there is uncertainty over the status of the \$3.1 billion African Finance Corporation (AFC) funding of the Nigeria Customs Service (NCS) modernisation project.

This followed as a Federal High Court vacated an earlier order stopping the commencement of the project.

As of press time, the status of the fund could not be confirmed, as the AFC failed to respond to an electronic mail sent to it, but when contacted, Public Relations Officer of the NCS, Timi Bomodi, expressed the hope that the AFC was committed to participation in the project, but was not specific if it had released any funds.

In a telephone interview, Bomodi, a Deputy Comptroller of Customs said: "At this stage, they will release whatever needs to be released to get the project going. And of course, they are working and nothing has stopped.

'There was never a time they stopped from releasing the funds. They have signed an agreement. The \$3.1 billion is not the kind of money you just give to someone, because it is big money. It will be done in phases and they are proceeding with all the phases. We have said from the beginning that the whole process will be done in phases.

"Every phase will have its component and AFC is working. For them to work, they will have funds. They are proceeding with the project whichever way they want to do it."

Prior to vacating the order, the court had restrained the Federal Government from enforcing or giving effect to the Customs Modernisation Project otherwise known as e-Customs initiative allegedly executed by its agents on May 30, 2022.

The agents, who allegedly executed the disputed concession project, are the Nigerian Customs Service, Trade Modernisation Project

Limited, Huawei Technologies Company Nigeria Limited and the AFC.

The court also issued an order of interim injunction against the Federal Government or its agents acting through the Federal Executive Council (FEC) from retrospectively ratifying the decisions to concession the e-Custos project to Trade Modernisation Project Limited, Huawei Technologies Company Limited and AFC.

The restraining order issued by Justice Inyang Ekwo shall last till the hearing and determination of a suit brought against the Federal Government by the e-Customs HC Project Limited and Bionica Technologies (West Africa) Limited, which challenged the alleged what they described as the "unlawful and fraudulent concession of the e-Customs project to the AFC.

In a related development, another firm that sought a rejoinder to the suit, Adani Mega Systems Limited, alleged that the Federal Government contravened the law by awarding the project as according to it, as there are several pending suits on the matter before other courts.

In a motion on notice brought before the court by counsel to Adani Mega Systems Limited, Taiwo Abe, the company while seeking to be joined in the matter, listed the cases and described the government's action as subjudice.

The firm averred that it would be affected by the outcome of the ongoing matter while listing some of the pending cases it claimed were on and related, which are concerned with the automation of the NCS.

Adani Mega Systems Limited, through its lawyer, wrote: "The purported Federal Executive Council approval of September 2, 2020, and the signing of the contract award to the Defendants for automation of the activities of the Nigeria Customs Service E-customs when an action is pending is subjudice, pre-emptive of the court's decision, illegal, unlawful and planned to steal a match against the applicant."

Adamu commends UNICEF, TRCN for moving to end corporal punishment in schools

Inister of Education, Adamu Adamu, has commended the United Nations Children's Fund (UNICEF) and the Teachers Registration Council of Nigeria (TRCN) for collaborating to end corporal punishment in schools.

UNICEF, an agency of the United Nations that is responsible for providing humanitarian and developmental aid to children worldwide has collaborated with TRCN to develop a draft national action plan targeted at ending corporal punishment.

While commenting on the

While commenting on the initiative, Adamu said the action plan would improve enrolment, retention, transition and completion in education.

The Minister, who was represented by Hajia Binta Abdulkadir, the Director, Senior Secondary Education Department, stated this at the National Awareness Creation Meeting on Ending Corporal Punishment in Schools.

Adamu said the country is beginning to see a global change of how corporal punishment is considered, noting that now it is easier to see that such punishment is not effective and that there are alternatives.

He said, "the Federal Ministry of Education, therefore, endorses this plan to serve as a roadmap for ending corporal punishment in schools in line with the Child's Right Act passed into law in 2003.

"It will help to protect children's right to a life of violence."

Meanwhile, the Registrar, TRCN, Prof Josiah Ajiboye, said that learning and safety could no longer be thought of as separate entities, hence the need to build a safe education to build better and safer children.

Ajiboye harped on the need for a more effort to educate parents and teachers on the implication of corporal punishment as well as the alternatives that were available to them.

He said good school discipline depends on skilled and properly trained teachers, not students' bad behaviour.

According to him, "Globally, there is a paradigm shift from corporal punishment in schools because of its effect on pupils.

"It has been proven to be ineffective, dangerous and an unacceptable method of controlling and maintaining behaviour and discipline.

"This is because it brings negative rather than positive consequences in the whole process of teaching and learning."

Ajiboye, therefore, said the

campaign was committed to seeing a school culture that ensured a safe and respectful environment for everyone.

On his part, representative of the Technical Working Group of the action plan, Noah Ashibi, said over 62 per cent boys and 59 per cent girls were reported to have experienced some form of physical abuse.

Ashibi, who is also an Assistant Director, TRCN, Cross River Coordinator, further stated that pupils had such abuses as corporal punishment in schools and at home.

He stressed that the findings have huge implications for children's right to education in Nigeria and the achievement of the Sustainable Development Goals (SDGs) 4.

He said, "Nigeria is presently struggling with a large number of out-of-school children, a phenomenon largely attributable to the various forms of violence affecting children.

"In a recent survey of learners, teachers, parents and traditional leaders in northern Nigeria, 62 per cent of learners reported experiencing various forms of corporal punishment such as flogging, slapping, kicking, frog jump and other physical violence.

"Over half of the respondents identified teachers as the main perpetrators of corporal punishment.

"These violent disciplinary practices persist with the large body of research that acknowledged the physical, emotional, developmental and psychological harm that they inflict on children."

However, he called for serious action from all stakeholders to eradicate the practice from schools.

Also, Mrs Ödinakachi Ahanonu, the Policy Advisor, Civil Society Action Coalition on Education for All (CSACEFA), called for a strong synergy in ensuring that the plan contributed to ending corporal punishment in schools.

A call to action was placed on federal, state, local governments, and school levels to create awareness on the dangers of corporal punishment, coordinated at all levels.

Stakeholders were also charged to develop and implement a policy framework focusing on ending corporal punishment in schools and homes

1,261 computers distributed to primary school in Kebbi

The Kebbi State government on Tuesday said it has distributed not less than 1,261 computer tablets to 1,261 primary schools, saying the number represents 65 per cent of public schools in the state.

Executive Chairman, Universal Basis Education Board (SUBEB) in Kebbi State, Prof Suleiman Khalid, disclosed this at the Public Schools Verification Programme held in Birnin Kebbi, the state capital.

The verification four, it was gathered, was organised by the National Bureau of Statistics (NBS) to ascertain areas of needs in public primary schools.

in public primary schools.

Speaking during the exercise,
Khalid said, the deployment of
technology in the State would
help to monitor and track pupils
in the State.

"I invite you to note the deployment of technology in our dear state. DLI 7 deals with the deployment of digital attendance and record keeping in schools.

"Under this programme, our pupils in the state will be daily monitored and this will no doubt assist in tracking and monitoring the attendance, check-in and check-out of pupils and teachers in schools."

"Today, classroom attendance

stood at 374,855 pupils representing roughly 67 per cent of the pupils in the primary is monitored digitally across the state," he said.

He further said that the deploy-

ment of digital attendance record keeping would assist the School Based Management Committees, Education Administrators, Local Government Education Authorities and SUBEB to act swiftly on the issue of attendance of pupils in schools and ensuring high level of retention of pupils.

According to the chairman, some major achievements of the board include the establishment of 5,400 non-formal learning centres made up of 3,943 Interested Qur'anic Schools, 1,751 Girl Child Centres and 156 Nobody Child Centres with a total enrolment of 790,500 learners.

or 790,500 learners.

"We have engaged the services of 15,810 facilitators, we provided shades, two sets of toilets and open dug well and other sources of water to 1,008 Integrated Primary Schools (IQS), we are also providing a monthly stipend of N5,000 to each of the 3,943 IQS proprietors and we have provided centre improvement grant to each centre management committee the sum of N50,000 to 3943 IQS centres," he said.

The Kebbi State Commissioner

for Education, Alhaji Muhammad Magawata-Aliero, in his speech said that in the year 2000, African member nations met in Dakar, Senegal and proposed "Education For All" by 2015 "meaning that by 2015 no member nation will have out-of-school children."

However, he said, Nigeria recorded about 11.4 million out-of-school children by 2015 according to reports, while in many countries there were zero or less number.

Magawata-Aliero said according to reports, in Kebbi State, they have conflicting figures of 501,000 and 914,945 out-of-school.

He, therefore, appealed to NBS to do justice in the course of their verification and assessment everyise

On his part, the NBS State Officer, Kebbi, Malam Sa'idu Sale, said the exercise was expected to cover 17 states, assuring that of the affected states, "Kebbi has the highest number of schools totaling 7,217 to cover, more than any other states to be covered.

"I want to assure you that all schools will be visited, we are going to conduct a five-day training for our staff, I am assuring you that we have our staff in all the 21 Local Government Areas of the state and we are going to do justice to the exercise."

9 home remedies for curing heartburn

eartburn is something that most adults will experience during their lifetime. It is characterized by an uncomfortable burning sensation right behind the breastbone that oftentimes creeps up the throat, and is a symptom more so than a disease. It is caused by acid reflux, which occurs when the ring of muscle that allows food into your stomach relaxes when it shouldn't. The result is acid from your stomach goes back up your oesophagus, which then causes the sensation of heartburn. Think about it... it's acid burning your throat...ouch! It's actually possible to have reflux without heartburn, but it is not possible to have heartburn without reflux. While over-thecounter and prescription medications are available, if you suffer only from occasional heartburn, lifestyle changes and heartburn home remedies may be the route you want

1. A spoonful of baking soda... A spoonful of sodium bicarbonate, or teaspoon-full to be exact, can help put an end to the burning, sensation of heartburn caused by acid reflux. Baking soda, as sodium bicarbonate is more commonly known, can help your reflux and in turn help your heartburn because it is a base substance. It has a pH higher than 7.0, and therefore neutralizes stomach acid. Neutralizing the stomach acid means that if/when your LES decides to be lazy and acid comes up your throat, you don't get "burned."

You will need...

-1/2 teaspoon or 1 teaspoon of baking soda

-a glass of fresh water

Directions

Mix either a ½ teaspoon or 1 single teaspoon of baking soda into a glass of water that is no more than 8 ounces. Give it a good stir and drink all of the mixtures. You can repeat this as needed but should not exceed seven ½ teaspoon doses in 24 hours. Also, avoid using this as a remedy for more than a week straight, as it is high in salt and can have side effects such as swelling or nausea.

2. Soothe your stomach with aloe juice... Aloe is a plant used to soothe burns, and people often think of using it to help something like sunburn, but it can do more than that. It may be able to help with heartburn too because it reduces inflammation. This means when your tummy starts getting irritated and inflamed, or your oesophagus is getting eaten away at, a nice glass of aloe Vera juice may be just the thing to help calm it down.

You will need...

-1/2 cup aloe Vera juice

Directions

drink a ½ cup of aloe juice, cool or room temperature, before meals. Keep in mind that aloe can act as a laxative, so unless you're looking to fit in a few extra bathroom Sudoku puzzles, look for a brand that has the laxative component removed.

3. Chew gum... The Journal of Dental Research conducted a study that showed people with symptoms of gastroesophageal reflux disease (GERD), or chronic heartburn,





experienced relief when they chewed a piece of sugar-free gum for 30 minutes after a meal. This is because chewing gum stimulates the salivary glands, and increases the flow of saliva. Any acid that has built up in the gut is diluted and washed away or cleared out more quickly. The clearance of acid then improves the symptoms of GERD. It is possible that the same school of thought could be applied to occasional heartburn as well. It's our regular saliva that we swallow that actually makes normal bouts of reflux here and there completely painless.

You will need...

-1 piece of sugar-free gum

Directions...

After a meal, pop in a piece of sugar-free gum and chew for 30 minutes to help ward off heartburn.

4. Chin up (and don't lie down) Heartburn tends to get worse at night, thanks to the fact that you're lying down when you sleep. Gravity works against you, and it's easier for the digested contents of your stomach to back up into your oesophagus, along with acid. Try elevating your head about 6 inches when you sleep by placing bricks, books, or blocks under the legs at the head of your bed. You could also try a wedge-shaped pillow under your mattress, but don't simply piles up extra pillows as it's easy to slip off of them at night. Don't lie down within 3-4 hours after eating, because lying down with a full stomach makes stomach contents press harder against your lower oesophagal sphincter.

5. How, what, and when...

Watch how you eat: Don't inhale giant mouthfuls of food. Take smaller bites and

eat slowly, allowing your stomach time to digest and without giving it an excuse to pump out excess acid.

Watch what you eat: You're probably aware that specific foods trigger heartburn, usually foods high in acid (tomatoes or citrus fruits, for example,) or spicy foods. Avoid these as best you can to ward off

Watch when you eat: Don't eat within 3-4 hours before bed. Lying down puts more pressure on your LES and increases the likelihood of acid sneaking through.

6. Get more acid... When you have acid-burning your oesophagus, it seems quite counterintuitive to ingest even more acid. In many cases though, acid reflux is caused by having not enough acid in your stomach, rather than having too much, as over-the-counter or prescription "acid blockers" imply (although that can also be the case, among other factors.) It is the acid itself that tells the lower oesophagal sphincter to tighten and close off. If you don't produce enough acid, your LES is going to think it's no big deal to loosen up for a little bit. Then, of course, you get a reflux of acid into your oesophagus. If you think this may be your case, try drinking some pure, raw, unfiltered apple cider vinegar to see if this prevents your reflux, or cuts it off.

You will need...

-3 teaspoons or 1 tablespoon of raw unfiltered apple cider vinegar

-6 to 8 ounces of fresh water

Directions

Mix 3 teaspoons, or up to 1 tablespoon, of apple cider vinegar into 6-8 ounces of fresh water, and drink. You can do this before each meal (probably the most effective,)

before bedtime, or 2-3 times during the day. If you feel it worsens your reflux, do not continue to ingest it. Too much may also contribute to the problem.

7. Eat a banana or an apple... Bananas contain natural antacids that can act as a buffer against acid reflux. If you want to try out the simplest home remedies for heartburn first, try letting a few bananas ripen up nicely and eating one every day. Another option is to try an apple a day. Slice one up and eat it a couple of hours before bedtime to relieve or prevent discomfort.

8. Make gingerroot tea... Gingerroot can help ease up several stomach woes, from nausea to acid reflux. Sipping a cup of fresh tea about 20 minutes before a meal can help calm down your tummy and act as an acid buffer.

You will need...

-3 quarter sized slices of gingerroot

-2 cups of water

Slice up 3 quarter sized pieces of gingerroot and simmer gently in 2 cups of water, covered, for 30 minutes. Remove the ginger pieces, or leave them in, pour them into a glass, and drink all of it about 20 minutes before a meal.

9. Avoid tight-fitting clothes... Things cinched tightly about your waist or middle can worsen heartburn. If you have super tight jeans on, when you sit down, the waistband is going to sink into your abdomen region. The same goes for tight belts-and even shirts can be a problem for some. This is because all of the above puts extra pressure on your lower oesophageal sphincter, which makes it more likely that stomach contents, will push through and you'll experience reflux.

He claimed that Osimhen had been respectful while

"I honestly don't have any problem with Victor (Osimhen). I've seen him before when he has not gone to Napoli, he used to be a decent young chap," Ikpeba

The soccer pundit started his career in the 80s with African Continental Bant FC before switching to Europe to play for RFC Liege in Belgium where he won the Belgian Cup.

He added, "Football can be so unforgiving sometimes, look at the likes of Mario Ballotelli. A lot of Nigerian Footballers have had this same opportunity and lost it. Osimhen is at the right place at the right time so my advice is for him to calm down.'

"People have to manage stardom. The Victor Osimhen I saw when he played at Charleroi, Wolfsburg, Lille carried himself decently. Going to Napoli might have changed his mentality and that is why I am saying he has to calm down, he has not achieved anything yet and should emulate players like Mane and Salah," Ikpeba advised.

Osimhen joined Napoli two seasons ago in a bigmoney move from Ligue 1 side Lille.

Since he made the switch to Napoli, the 23-year-old has found the back of the net 24 times in 51 Serie A matches coupled with 5

Last season in a match against Venezia at the Partenopei stadium, Osimhen was red carded in the 23rd minute by referee Gianluca Aureliano for violent conduct.

"I know what it's like when you lose a key player and someone else has to step up into that position and fill their boots. It's really tough for that person to assimilate themselves quickly. So that's going to be a challenge for Rangers," he added.

A' Ibom Human Right group moots conciliatory approach to free jailed lawyer

The Akwa Ibom Human Rights Community (AKHRC), has called for a conciliatory approach over Barr. Inibehe Effiong (Esq), jailed for one month by the Chief Judge of Akwa Ibom State, Hon. Justice Ekaette Obot.

The imprisonment of Inibehe Effiong by Akwa Ibom state Chief Judge Justice Obot has generated controversy among lawyers on the appropriateness of the sentence with regard to what transpired in court on that fateful day.

However, the human rights group has advocated for restraint on the matter, saying the case was a sensitive one that needs to be approached with caution so as not to set a bad precedent.

In a statement signed by the National Coordinator of AKHRC, Clifford Thomas, Esq., the group noted that the action of the Chief Judge could threaten the advocacy duty of lawyers.

"We call on all who intend to intervene in this matter, to exercise restraint. This matter is very sensitive, and the best approach we suggest now would be a conciliatory approach.

"There would appear to be rights on all sides, but caution is necessary. Sadly, we feel strongly that advocacy by Lawyers in courts in Akwa Ibom State would be greatly impacted.

"Lawyers may no longer feel very free to do their advocacy freely. A precedent has been set, and human rights advocates may end up becoming victims of the process. May God help the legal profession," he stated.

Meanwhile, members of the Akwa Ibom Civic Space, made up of Civil Society Organisations (CSO), Organized Labour, and Students' Communities have frowned at the imprisonment of Barr. Inibehe Effiong (Esq).

They described the procedure adopted by the Chief Judge, Justice Ekaette Obot in the matter as "vexatious and obnoxious", saying it runs against the practice of judicial precedents on the matter.

In a joint press statement signed by Harry Udoh, Chairman, Akwa Ibom CSOs Forum; Comrade Iboro Ibara, Curator, Akwa Ibom Roundtable; and Mr Peace Edem, Akwa Ibom Youth Advocacy Cluster, the group said the action portrayed the intolerance nature of those in positions of authority.

They called for the intervention of the National Judicial Council (NJC), the human rights community and the public saying if the situation when unchecked, the powers of the court may be used for personal glory.

Space, "The Civic consulted with having sound legal minds, wishes to state with due respect to His the Chief Lordship, Judge of Akwa Ibom State that the procedure adopted in committing the learned counsel

to jail for contempt is vexatious and obnoxious to all tenets of justice and liberty.

"This development is

indeed sad feedback on the worsening national scenario of intolerance of State actors to dissenting opinions of citizens. That the Chief Curator in the hallowed temple of justice would for whatsoever reason, fail to keep the arms of justice on equal balance for all citizens, is most unacceptable in a democratic society.

"Our people may become prisoners wherever they may be, by the mere word or touch of an agent of State, if our jurisprudence becomes such where the powers of the court are deployed for personal glory," they stated
