Why Okowa, Ibori feud lingers

he battle for the soul of Delta between incumbent Governor Ifeanyi Okowa and his political benefactor and former governor of the state, James Ibori has all the trappings and ingredients of self-deceit and betrayal. Both men have their battle axe in Rt. Hon. Sheriff Oborevwori Olorogun David Edevbie for Okowa and Ibori respectively and have vowed not to back down even if it means tearing the Peoples' Democratic Party (PDP) in the state to shreds and allowing the major opposition party, the All Progressives Congress(APC) take the day.

The Trumpet previously reported that the crisis began when Okowa moved against the preferred candidate of his supposed political leader, Ibori in the run-up to the party's 2022 primary in the State. Ibori anointed seasoned financial administrator, Edevbie, who was his commissioner of finance in his first term as potential successor of Okowa. However, Okowa, who was bent on building a political structure of his own, vehemently resisted the much-taunted fearsome political force of Ibori by throwing his weight behind Oborevwori.

The choices of the once political allies, who are now wrestling dirty to claim the soul of the party in the State, have caused a sharp division between members of the PDP with the loyalty of many being tested.

But there seems to be more at stake for the incumbent Governor Okowa, who is yet to settle the dust created by his controversial emergence the Vice Presidential candidate of the party, than Ibori, who many believe still enjoys the lovalty of the Deputy President of the Nigerian Senate, Senator Ovie Omo-Agege, who is the governorship candidate of the APC. Already, there is growing anxiety amongst party faithful of both divides over who flies the PDP flag in the coming days as the battle has moved from political to legal. The matter, which is currently before the Appeal Court, after the Abuja Federal High Court disqualified the nomination Sheriff Oborevwori and ordered the PDP and Independent National Commission Electoral (INEC) to replace him with David Edevbie, has left many in limbo.

Many legal experts have questioned INEC's complexity over the matter, following its decision to partially, rather than totally comply with the High Court ruling. Particulars of PDP and its governorship candidate were missing from the INEC's register of governorship candidates in the state, published on the 22nd of July, 2022. Although INEC has come out to clarify that it was only obeying court orders by omitting the name.

state's Resident Electoral Commissioner (REC Mr Monday Udoh-Tom, said that the PDP in Delta was yet to have a valid candidate for next year's governorship election, adding that there were no details of any candidate for the party. He stated, "We have no particulars of any candidate for the PDP as far as the governorship election concerned because they members) are in court. When the matter is determined, we will have the particulars of one of them.

"You will recall that there was a court judgement that disqualified one of them, and he filed for a stay of execution and also appealed the judgement. As a result, we cannot act on the case of the PDP for now until the Appeal Court delivers judgment."

However, to Barrister Erastus Ukrakpor (Esq), a rights activist, INEC's total removal of the party from the list was a complete misapplication of what was set out in the judgement. He argued that, since the judgement was not elusive by giving a direct order, what INEC ought to have done was to replace the name of Sheriff Oborevwori with that of David Edevbie or simply ignore and allow Sheriff's name to remain, and then wait for the Appeal Court's decision, rather than engage in partial obedience.

It would be recalled that at the instance of the Abuja Court ruling, there was wide speculation amongst party stakeholders many opinion leaders in and that Okowa the state, sacrificed Sheriff Oborevwori to get Ibori to support his emergence as Vice Presidential candidate of the party. This position was further heightened when it was alleged that the national body had directed Oborevwori and the State Executive of the party not to institute an appeal against the judgement but rather accept and work for Edevbie.

that National Organizing Secretary of the PDP, Umar Bature, made the position of the National Working Committee(NWC) of the party known during a meeting with party leaders and stakeholders in the state, held at Asaba just a few days after the High Court ruling. But with the last week's re-endorsement of Sheriff Oborevwori by the Delta Political Vanguard (DPV), a body believed to only execute the directives of Okowa and the declaration of the state chairman of the party, Barrister Kingsley Esiso, during a recent mega rally of the party held in Ozoro, that the party will defend its gubernatorial primary that elected Sheriff Oborevwori till the end, the position of Okowa has been made very clear, "he is not going down without a fight."

Speaking exclusively to The Trumpet, a notable chieftain of the PDP in the state, who craves anonymity, absolved Okowa of any wrongdoing by pushing ahead with Sheriff Oborevwori. to him, contrary to what many have said, that Okowa betrayed Ibori or Okowa is trying to go against any agreement with Ibori, it was lbori who is actually trying to betray Okowa by still pushing for Edevbie. He said, "personally I feel bad about the way Okowa is being treated. The Edevbie in question, is it not somebody that is pushing him? If Ibori had to ask Edevbie to withdraw that case would it have gone on? The answer is no because Edevbie is counting on the support and structure of Ibori.

"I was a strong supporter of Amori during the primaries, but I know what happened, Amori would not have won that election if not for Okowa's

intervention. I know all that transpired, especially during the primaries. When Ibori's daughter could not win the House of Reps ticket, and the elections was rescheduled, the same day, Amori's election was to take place, Ibori called Okowa and bargained with him, that he should allow his daughter and Amori to go, then he can have the governorship, provided it's an Urhobo.

"That was the deal, and that was why you saw Sheriff Oborevwori won overwhelmingly in that primary election. Okowa kept his own part of the bargain by delivering Amori and his (Ibori's) daughter. Now you are fighting the man through the back, and you expect him to just give up. Let me tell you, am a strong member of DC-23 that clamoured for the governorship to come to Urhobo, so whoever becomes governor between Edevbie and Oborevwori. it is DC-23 that wins. We will still be recognized as people that worked for the governorship to come to Ŭrhobo. Okowa has not done anything for me, but I am pained for him. Okowa is a very good person, but the way the Urhobos are trying to treat him, if he had known that he would be treated this way, he would have supported the Ijaws to have it. I know he will be regretting it now."

Another anonymous source, who is a Special Adviser to the Governor of the state, said that Okowa deceived Ibori when the issue of producing a successor came up. According to the source, he said that "a meeting was called by the National Chairman of the party, Sen Iyorchia Ayu with Atiku, Ibori and Okowa in attendance. Okowa was asked to choose either

producing his successor or taking the Vice presidential ticket. Okowa went for producing his successor because he knew that based on the volume of money he had spent on Atiku's campaign and Primaries and his agreement with him, the VP slot was sealed.

"He then deceived Ibori that he was not interested in the VP slot and should be allowed to produce his successor. Immediately after the emergence of Atiku as the standard bearer of the party, Ibori intensified efforts to ensure that he nominates a VP for Atiku, that was when the name of the former governor Emmanuel Uduaghan was on the lips of everyone. Because of this act of deception, Ibori is bent on ensuring that Sheriff does not see the light of the day. I can assure you that if the upper court decides the case in favour of Sheriff, Ibori will pull his weight behind Omo-Agege." He added.

He noted that Okowa, not too sure Atiku will win the presidency, has been advised by his close political alliance not to make the mistake to trade Sheriff away for a VP slot. The source stressed that this has made the Governor vow that he will do everything within his power to ensure that Sheriff succeeds.

In a related development, Barr. Leberos Osogun while commending the judgement of Justice Taiwo Taiwo which sacked Sheriff, described it as watertight. He stressed that he wondered why PDP will decide to go for a candidate with questionable certificates especially now that it is the turn of the Urhobos.

He noted that in an attempt to correct the issues of multiple names, Sheriff committed a greater blunder with his affidavit, He said "on one face of the documents, which was dated seventh of July. 2011 but was signed by a commissioner for oat in 1979, the same year he claimed he was born. That's not enough, the certificate of FIRS showing payment for stamp duty on the document was issued on the 29th of April 2002. How this is CONTINUED ON PAGE 4



Suspected mast vandals, Yobe police command trades word over accusations

No fewer than seven suspects were on Friday paraded by the Yobe state police command for alleged illegal decommissioning of a telecommunication mast.

The State Police Public Relations Officer (PPRO), ASP Dungus Abdulkarim, said the mast in question belongs to the state television.

Briefing media practitioners, at headquarters of the State CID, the suspect, as stated by him, "were arrested by police detectives of the

Dapchi police Division."
"On the 28 July 2022, at about 11.30 hour, detectives from Dapchi divisional

police station, according to him "arrested and brought to CID seven persons who claimed to be hired by a particular company which is named AGN Garun Malam Investment Limited to decommissioned an antenna mast which belongs to Yobe State Television authority.'

Giving the names of the suspects as Bello Wanti 52, Abdulminini Jibril, 39, Alhaji Sabiu 40, Saidu Mohammed Bulunkutu 54, Jibril Yakubu 40, Musa Abubakar 20, Habibu Mohammed 30 years, the command, said: 'they have commenced an investigation on the seven persons"

According to him, the suspects alleged that the mast was sold to them by the NSCDC and therefore

the police have to investigate to get to the bottom of the matter.

Stressing that suspects have said that they bought the masts from Civil Defense" the command said, 'they have written to them as part of our investigation to identify their personnel that are involved.'

But in a swift reaction, one of the suspects, Bello Wanti, said he is a legitimate businessman who is just a victim of circumstance.

Claiming that he bought four masts in Yobe State located at Dapachi Gashua, he noted and that his men were not aware until after they dismantled the mast when they got information that the mast was initially bought by the Yobe State Government from former NITEL.

We did not know that the Yobe State Government has bought the mast until after we had dismantled it. But when we got that information, we came ourselves and reported it to the police.

Nobody arrested us. We came ourselves. If this thing were not legally bought, we would have run away from Yobe State but we came and

reported ourselves to the police. We are just victims of circumstance. Í don't think when everything is clear but they are making us look like we are thieves.," Bello said.

The commandant NSCDC Yobe State Saidu Yakubu Aliyu said he was not aware of what happened at Dapchi nor has he received any correspondence concerning the matter.

Concerning the officer mentioned in the matter, Aliyu said he cannot speak on the officer because he has not reported to the command but stressed that the NSCDC is a disciplined corps that is professional and diligent in

doing their job.

Barrister Aliyu Shehu,
the counsel to the accused persons, accused the police of disobeying a court order which he obtained frowm the magistrate courts for his clients to be released on bail or be prosecuted immediately.

Barrister Shehu added that the continued detention of his clients by the police is a breach of the constitution, adding that, "we have filed a motion of notice at the High Court to ensure the compliance of the police to the court order".

I was born in June 1963 and your secondary certificate is showing 1979. If you say you were born in 1963. So that means in 1979

vou were about 36 years old. We all know that a 36 years old is not allowed to write the May/June examination because it is meant for secondary schools. It is the November /December exam which is called GCE that he can write. It is therefore very clear that in trying to cover up his initial error, he committed even greater errors. "I also called on the national secretariat of the party to, without delay, intervene to save the party in the state because the situation is getting out of hand with every faction claiming that all is well and no shaking.

"There's is indeed a big shaking in the party and I urge the national secretariat to see Delta State as the party's stronghold in Niger Delta because if it fails in the Big Heart, then the danger is glare in the region.

"I appeal to Okowa and Chief James Ibori to set aside their differences and interests and settle for a qualified, credible, competent and capable contestant in the governorship primaries for the interest of the party, yes, PDP must act fast before it's too late"

While leaders of the party are making efforts to bring both political blocs together, Okowa has sacked the Delta State Commissioner for Higher Education, Professor Patrick Muoboghare, and replaced him with a new commissioner, Dr Kingsley Ashibogwu.

Muoboghare who is a strong supporter of Edevbie

was recently accused of not supporting Okowas' choice candidate Sheriff. While commending Okowa for the opportunity to serve Muoboghare said: "I have worked with this government for seven years and I cannot complain that I have not been part of this government because I have been part of it for a whole 7

"In the first tenure of Okowa, I was a Consultant **Educational Matters** where I was placed actually above commissioner; that's the truth of the matter and for the second tenure I was a commissioner for more than

"I cannot say that the man has not done well and I cannot hold a grudge against the governor for that. He kept me for good 7 years; very few persons can survive that. I cannot be angry with the government of Delta State too. I have served 4vears as a commissioner in Uduaghan's tenure and in Okowa's first tenure I was a consultant for educational matters and in his second I served as a commissioner for more than 3years."

It is yet to be seen how the crises rocking the Delta PDP will come to an end. It is even more difficult to understand how the interests of both political blocs will be harnessed to resolve the unending power scuffle.

Terrorists kill three, injure many, abduct dozens in Katsina

uspected terrorists have killed three persons at Dantsauni village in Batagrawa Local Government Area of Katsina state.

Also, terrorists have abducted at least 13 people including women and children, at Natsinata village, in Katsina local government area.

The Dantsauni incident occurred at about 11 am Wednesday morning, with dozens of people said to have been abducted by the ravaging terrorists.

One of the victims, Abdulrahman Abba farm located in the affected community.

The attack also saw several people sustain injuries, including many that had fled their homes and farmlands when the attack occurred.

When contacted, the spokesperson for the police command in the state, SP Gambo Isah confirmed the incident.

Isah, however, said that the terrorists killed one person and injured two others during the attack.

Also, terrorists at about 9:30 pm on Wednesday abducted 13 people including was killed after he left four married women,

Gunmen abduct 3 children, demand N100m ramson in Ajaokuta

Gunmen have kidnapped three children of an electronic dealer in Ajaokuta local government area of Kogi State.

It was gathered that the incident happened at about 8 PM in Kaduna Estate, Ajaokuta Steel township complex.

According to eyewitness, the fully armed men shot sporadically into the air to scare security agencies and neighbours before kidnapping the three children aged 5, 7 and 10 years.

The incident is coming few days when three policemen and five vigilantes were killed by unidentified gunmen in Jida Bassa, Ajaokuta local government.

A family source who craved anonymity identified the parent of the kidnapped children as of Edo State.

The source said the gunmen on Thursday morning contacted the family of their victims demanding for N100 Million before they will release the abducted children.

"They shot countless times to scare people from coming close. When they could not see their target victim (Kadiri) they decided to pick the three children from the house. Local government is foundation for policy formulation, implementation - Osifo

Dr Isaiah Osifo was a two-time chairman of Uhunwode local government in Edo State, Chief of Staff to former Edo State governor, Prof. Osariemen Osunbor, a public policy consultant and a farmer. In this interview, he lamented how lack of continuity of government policies stunts development in the country, the choice of PDP presidential and vice presidential candidate's party politics and efforts at solving PDP crisis in Edo State. Politics Editor, TUNDE JOSHUA brings excerpts.

Some politicians are into farming, so what about being a politician and a farmer?

Everyone should be a farmer because it will be good for the society. Farming can be taken as a career or an occupation, but I don't think being a politician is an occupation. My farming origin is like a heritage because my parents were teachers and farmers and after retirement, they went into farming full time, my grandparents were farmers too. They were into public policy affairs too so it was more like a family career. My father told me if I want to be an independent man, I should be farming and I have seen the results.

We heard that Malaysia came to Nigeria to take samples of palm fruits and are doing good with what they took from here as a leading palm oil producer globally and we are still where we are.

You were a two-time chairman in Edo State which is government at the grassroots level and with your background what are the investments you made in the agricultural sector while you were in office?

Local government area is the foundation for policy, formulation and implementation. I made sure I did something different from others and I was the first local government chairman to create an agricultural department in the local government area. We are rural councils so I made sure we had a specialized department that addresses agricultural issues, to assist the state government ADP to operationalize agriculture in our field. The local government under my administration had a farm, we had maize farm on a large commercial scale.

Is the farm still functioning?

How will it function, that's the system we have in this country, when the leadership is faulty, there's no continuity and policy. I have listened to the presidential candidates and I have asked them to tell me where they served and made a difference and if they give me an example and what difference they made I'll take them seriously. We had a large maize farm supervised by the agricultural supervisor, new graduates of agric that were employed. It is only the council I worked with that has a full government-owned farm with 100 meters oil plantation farm and the commercial value of this plantation is over 400 million investment worth. I left the council in 2002 and this is 2022, 20 years after and no one has planted one tree in addition to the 15,000 trees I planted. What do they do? The council chairman goes to the office and releases it to those exploring it and they are making money. They don't grow more trees, if I left it at 100 meters, and they are now doing 20, 30 meters then imagine a council that's heading 400-500 hectares of oil production in productive age. They don't need to wait for agricultural revenue. What is the government doing, these things are going into extinction because nobody is

encouraging agricultural development? We didn't stop there; we are the first Council in Edo State to raise 25,000 oil palm seedlings. I brought it and shared it to the farmers in Edo State free of charge to go and plant in three to four years. They will be making income from it and today they are grateful to me. With this so much knowledge about agriculture, I have been writing papers to the state and federal government that since they have someone that has done something there, they should utilize it but it is a shame that I left the council 20 years ago and we don't have one additional hectare plantation anywhere in the local government.

You're one politician who seems to be very vocal and outspoken but some will argue that it is always against the opposition party. Is it true?

If you're in a political party and that party is in government you have access to the government so you don't need to go to the newspaper to speak against the government because you have access to the government, so what you do is to present your ideas, your criticism, your memo. Right now I belong to the PDP party, I have access to the government so I speak to them and do my documentation for reference purposes so it would be known. I capitalize on the access I have to the government so I express myself to them instead of coming to the TV or media.

You have moved from one party to another, as a member of a party, why not stay with your party and seek ways to resolve issues instead of jumping ships?

We are deceiving ourselves in Nigeria about democracy. We have not started practising democracy. If I am serving a boss and he is not doing well, I don't have the right to leave him? I can't belong to a party where people just believe that the party is now owned by one man who piles names of delegates, puts them on the line and asks them to vote against the right person. Is that democracy? If you violate rules and regulations, people are not bound to stay with you. There is nothing wrong with leaving a party that doesn't follow rules and regulations, a party that doesn't allow one to air his views and when one has left, there's still nothing wrong with coming back when the party has learnt and taken your opinion into consideration. By the time you violate your own party's constitution and ask them to stay with you, it is barbarism. When a party keeps their rules and regulations, they will be a mild movement because nobody has offended you, the system is good and you have not been undermined. I was elected to the council in PDP in 1999 but they started misbehaving and I left, other people left to other parties. When you have been undermined please go to where you can ventilate, it's not a crime.

Still on PDP, the crisis rocking the party, the factional candidates in Edo State, don't you think this will affect the chances of the party in the forthcoming poll?

Of course, it will, it is natural. When you have division in a political party, it will affect their fortunes in the general elections. What is causing the faction is wrong, two cannot be wrong.

What is the leadership of the party doing to settle this issue?

When the leadership is struggling with members or associations that have the tendency to break rules and regulations the leader will have problems. Political party relationships are meant to be leaders relating with the members and members relating with the leaders. The two factions cannot be right, one is wrong and one is right but how do you now know the one that is wrong and right? I believe every party should keep to their rules and regulations. With what the governor has said in the last meeting I hope it will bring a reconciliation committee and it should be able to bring these interests together and reconcile them for the general election so the party can win. Democracy is evolving, you're not bound to one party doing nothing. If one political party can't put their hand together to achieve something, there are other parties. We have 17 political parties. If INEC can do their job to conduct a free and fair election, this noise about the different political parties will be irrelevant. We should forget about parties and look at the credibility of each candidate.

I think we need a reorientation not just for INEC but also the populac?

Yes, Nigerians should rise up without guns or fear and say enough is enough that they want a free and fair election, they should look at the candidates they are voting for and not the party and they should not vote based on party.

Do you think your party PDP has picked the right candidate?

I believe in zoning for fairness and equity. They are credible candidates from the south east but you have to put the demographic into consideration, you have to put the political culture, voting pattern into consideration and that is how PDP got their candidate from the north.

So, this was done all because of winning the election?

It's all about winning the election and doing the right thing. The southeast will be happy to have a northern man who will do the right thing and give them hope that it will be their turn. It will definitely evolve and go to the right person irrespective of where they come from but we are not yet there, and that is why we need a good president to give a structural layout and Atiku is good with restructuring.

What do you have to say about the accusation against Alhaji Atiku Abubakar that he is a wrong choice?

You can't make a wrong choice in two elections in two terms for 8 years. If he was bad he wouldn't have been there to serve for 8 years and after a year you would have seen his character but he wasn't bad. Since 1999 Obasanjo's achievement has not been beaten by anybody, and we are in a democratic government, and in democracy only one man cannot take the credit because it is a collective responsibility. Atiku's government was good, so we want him to build on that foundation and save Nigeria.

Still on the running mate, there were grievances that Wike was to be the running mate to Atiku but he picked governor Ifeanyi Okowa of Delta State.

I didn't speak with the presidential candidate, but what I think is Wike is a fantastic guy, he is a local government man, and Okowa is also good but the difference is that Okowa has an affiliation with the South East. Atiku is a very reasonable man, he felt if he can't pick someone from the South East, he should be able to pick someone who is close to the south-east and Okowa has his right leg in Sout-South and his left leg in South East which is an advantage for election and representation.

Ahead of the 2023 election, what is your advice for Nigerians and your party?

Nigerians should go out there and tell INEC that they have no choice but to conduct a free and fair election. To my party, I commend them for choosing a candidate who is from the grassroots and has evidence of what he has done, and his certificate.

I want to eradicate poverty as assembly member – Sapere-Obi

Tuebi Sapere-Obi, the chief executive officer of TEOET Global Enterprises, in this interview with AHERHOKE AMOS OKIOMA, bears his mind on why he wants to contest for the Sagbama Constituency 3 of Bayelsa State House of Assembly, why he chooses YPP, his manifesto amongst other issues. Excerpt:

May I meet you, by way of introduction

My name is Tuebi Sapere - Obi. I'm from Elemebiri community in Sagbama LGA of Bayelsa state and my village is under constituency 3 in Sagbama LGA and it is made up of 17 communities.

I'm an entrepreneur, in construction, entertainment, tourism and hospitality. I reside in Yenagoa and also do business here. I'm married to a beautiful wife from Isampo community in Kolokuma/ Opokuma LGA and we have three children, two boys and a girl. I'm the candidate for YPP in the 2023

the candidate for YPP in the 2023 general elections.

What informed you of the choice of a political party (YPP) that is relatively unknown?

I believe that the political awareness right now is that the party does matter, it is the personality of the candidate that matters and that is my boliof. That is what is going on presentations. candidate that matters and that is my belief. That is what is going on presently. That's why I said the political climate is getting wider every day, it's not about jumping into one of those big parties or popular parties as the case may be. By the way, there will be no space there. Especially for an upcoming politician picking up the tickets in those parties are not certain except you're called by a Godfather and for me, I wasn't called. I just think it's time to look into the I just think it's time to look into the business of leadership because of how it affects my regular business here, so I made the decision of contesting. I'm very certain about contesting. It's not about losing at the primary level and commending yourself. We have 18 political parties registered, why stress yourself into a place you will not pick a ticket? I was so confident in myself and the way I started it and how far I have gone. I started over 3 years ago, I've been going from community to community telling them of my ambition of contesting and some would ask me "why come this early?" The election is still far away and I'll simply reply that I can't come 4 - 5 months or even one year to the time and then bring posters, caps, t-shirts and start sharing and expect to win when I'm not well known to them. So because of that, I needed to start very early, I've gone to all 17 communities over a year ago to 17 communities over a year ago to tell them that I'm contesting. And also, while I was talking to them I hadn't even joined any political party then, but I felt like it wasn't a problem. I told them that when the time comes, I'd get a political party. Why I started early is because I wanted them to look at me and analyse me, if I'm fit to be given such responsibility to go and represent the constituency, and if they find me worthy I don't have to worry about the political party because it's the people that vote, not the political party. If they accept me then they'd definitely accept the political party

that I present to them. What do your constituents expect

from you?

The first thing that should be considered is what you are going to do, not how much you have in your wallet. I'm doing it with the little resources available and maybe the people who believe in the project would support me. So I'm not interested in those big political parties. I cannot beat my chest and say I'm willing to spend millions to secure a party ticket when some parties give me for as low as 200 - 400,000 thousand thereabout, that's what I told them and they were comfortable with it. I also went further to present the kind of blueprint of empowerment l intend to deliver if I find my way into the assembly.

One thing that spurred me to say I want to contest is the high rate of poverty and unemployment, there is hunger everywhere and I think is hunger everywhere and I think it's a deliberate act of the political class to keep the masses at that level where they will always be begging for food. So when the election comes they just give a little change and get the people to vote for them. It hurts a lot, I've noticed over the years I've seen these things happen.

If elected, I will keep to my word and eradicate poverty in our communities. I kept focusing on the communities that I'd create employment and all that.

employment and all that.

What added value do you intend to bring to change the narratives as a lawmaker?

Right now the world is facing e-commerce, while this is happening people are predicting that very soon agriculture will take the lead.

Looking at agriculture, the ordinary Ijaw man is born a farmer. Growing up, you already know how to farm. And then you find out that that's the major source of survival. They'll use that money to train you, though subsistence, but they'll use that money to put food on the table for themselves and the children. We've been surviving like this for years and now it's time to look into commercial farming. I told them that

should I find my way there, we'd go into mechanised agriculture.
What I mean is that the 17 communities would choose whatever kind of farming they wish to have in their community, I've found out that different communities are good at different types of farming systems. I want to use my community, Elemebiri, as an example, from when I was a child I knew that in my community we have a lot of pepper and Okra. Until today, this is still the major type of farming in my community. Though it's a quarterly thing, it has helped so many people build houses and send their children to school.

While going around then, we picked voluntary coordinators that believed in the project we were about

believed in the project we were about to embark on and decided to come to join us on that level and I was able to register a foundation.

So we had two coordinators each from the 17 communities. So whatever type of farming the community chooses, the community will provide us with the land, a land big enough to give us what we're looking for. Then going further, the constituency, in collaboration with me will see how we can clear the land, prepare the land and prepare a nursery bed for the pepper before the time for planting. And the foundation will be on ground to support them at every level until harvest season. have money on ground to buy the things we're lacking. People come from Onitsha to my village to buy pepper and okra and they determine and fix the prices of these commodities, but what we intend to do is to build a farmhouse. Pepper is a perishable commodity, so for instance, if we end up not selling all the baskets of pepper we could take them back to the farmhouse, dry them, grind them and seal them. So those peppers can now go to the markets outside my community. This will now create jobs because from people that will farm in the village to those who would grind, package and sell the commodities all

of them would be put under salaries. So we'll get the account details of these so we'll get the account details or these persons working in the farm, they'd be in the village and get the usual or regular alerts at the end of every month. We will set up the accounting/management teams that would run a particular farm and these are people from that community and we will only oversee as a foundation. At the end of the day money realized from the farm would be used to develop that community. The money may be put into other sectors, maybe health, ICT and infrastructures as the case may be because there is money. So we choose to get computers in the schools, so the children in those communities would see and know how to use computers. We can also decide to put the money into education, you know, buy textbooks from the money

Why we're doing this is because I believe the money in the assembly is not big enough to start sharing or to say you want to take care of everything and that is why I'm coming up with ways these communities can develop ways of making their own money. When the so-called constituency money comes, we would now know what to use it for, allow me to say capital project or thereabout. But we will not just fold our hands and wait for them to pay for the constituency projects and then use the money to pay and that is all. So it's the same thing for communities that want to farm cassava. We fix the lands, buy the cassava stems and watch them do the farm. We will build a farmhouse close to the cassava where they will harvest, get a grinding machine to grind these cassavas and fry them, and so Garri bags would just be coming out from the community which they will take to the market to also sell and generate money for the community. So we're looking towards self-reliance and sustenance of these communities before thinking of some other kind of projects.

The basic thing about the assembly is that it's law making, it's to go and make laws. And oversight functions.

But it won't be easy for a single member out of the 24 to make laws that will stand, so we would also know how to lobby our colleagues to make sure that good laws are passed. Because I intend to widen this whole idea, for it to be passed this whole idea, for it to be passed as a law at the assembly level. It will get to the point where the government would vote for a particular figure for this purpose. We know what food is, if you can survive and sustain yourself, you will now look upwards and say okay let me now sell. We're looking forward to even selling food to a neighbouring state and even exporting pepper because we have large amounts of pepper, a nice aroma that we are ready to export, you know, in pepper farming. Likewise, every other product in the seventeen communities. Seventeen different products from seventeen different communities, you know what it is. There would be enough food to eat and you wouldn't just sell everything and besides, it is in your community. as a law at the assembly level. It will

sell everything and besides, it is in your community.

Another thing I'm looking into is paying WAEC fees for very brilliant students or those that don't have the privilege to go to school. We're looking into different aspects with the little resources like I said, I'm a business man and I've been I'm a business man and I've been surviving in business for some time now, over six years and I started from nowhere but I have over 30 staff now, you know from the little resources coming in I've been able to manage this whole system and gone into other projects so I feel that if we find our way to the assembly to represent these people bringing like minds together, people who are willing and genuine enough and have the people at heart to work together as young people, yes we can work together deliver something different from what we have been seeing in the assembly level.

You also asked about why I chose YPP, this is because YPP is a small party, it's not about the size of the vehicle that matters, it's the capacity of the vehicle. What I'm trying to say is that YPP is a small party but it's like a family thing where everybody understands the projects in front of us and everybody is working towards them. Nobody dictates and expects others to bend, but you have the right to make suggestions, bring your opinions to the table and people will understand. The meaning of YPP is Young Progressive Party, I see us as young people that want to make a change, young people that party, it's not about the size of the make a change, young people that are tired of the usual. We want to are tired of the usual. We want to make a genuine change. That's why I chose YPP, I'm sure I'd get the ticket to make this change and not end up in the primary.

The leadership of YPP in the state and national level have also made it

easy for everybody to see this as a project we should all do together to succeed. YPP also slashed the price of the form for youths below 40 years, they gave me the form for half the price.

As you go about your consulta-tions, what has been the reception from these 17 communities so far?

Consultation is still ongoing because we haven't started campaigning yet, for me it doesn't end like I said we started three years ago and we're still doing consultation. The constituency is big, we have to meet with the high and low to share ideas.

So far, the consultations have been going very well. I see myself as what I'll call "the ordinary man". What I thought before going into

consultation was that it was going to be very difficult and tedious because there was no money to throw about. We go as ordinary people to these communities, though we don't have money they welcome us and listen to us attentively. The people in the grassroots are not fools, they understand when people are lying or telling the truth. When we talk to them we tell them very practical things that they can do but haven't been given the opportunity. We make them understand that leadership is not for any set of people called politicians. Leadership is for anybody who understands how to do things properly. A leader is a person who there was no money to throw about. properly. A leader is a person who understands that once he's given a task, it's to get it done immediately. So they too can be leaders. I told them that I'm looking at how I could come down home so that I'll be involved in this process because aside from being an assembly member and getting good salaries, we need to be at the grassroots. It's not always about sending people over there and ask them for results, they could tell you that everything is fine while it isn't. I have a business where I have up to 30 staff, but when it's time to clear grass you'll see me holding the cutlass, you wouldn't even know that I'm the owner of the business. Whenever the leader gets involved in the job everybody will be doing the job like a personal thing because they find the leader doing it with them. These are a few things I tell them that make them happy. And then, for the elite class they would tall you that the the life had they would tell you that that's how politics should be, most of them know the proper thing to do but it's just that they haven't seen a person who they would trust down there and deliver to their taste. So we've been able to talk with them and make them put us in a position where we are at an advantage because we're not the governor's candidate or Abuja candidate, but I tell them that they sitting down there are my godfathers. My party is YPP, what is YPP without the people? If they believe in the project and also believe in me, they should vote for me when the time comes. So far the consultation has been going

quite well, the people are happy to meet us especially because it's the first time that they're being involved in a thing like this.

I'm very confident coupled with INEC's new development about the newly introduced machines, I would say that is one of the happiest things happening to me since I started this project, I didn't even know that it'll come. This machine has made me believe that all the done PVCs are waste now. As there would be no room for ballot snatching and rigging. All the real voters would not just want to play with their votes. I've been encouraging people to go and register and obtain their PVCs and get ready to vote and protect their votes.

Finally, what is your advice to your constituencu?

My advice to the people in my constituency is that they should register and get their PVCs and they should vote and make sure their votes count. Make sure everything goes smoothly, free and fair. They should try to capture any irregularities such as people coming to the pooling units with money to buy votes. They should take down all that information.

Gunmen abduct traditional ruler, three others in Ondo, as police vow to rescue victims

gunmen nknown suspected to be kidnappers have abducted the traditional head of Iku Quarter, the Oniku of Iku Quarters in Ikare Akoko, headquarters of Akoko North-East Local Government Area of Ondo State, High Chief Mukaila Bello, a chieftain of the All Progressives Congress(APC), Hon. Adeniran Adeyemo and two other indigenes of the town.

The other two kidnapped were the former House of Assembly candidate for Akoko North-East Constituency, Yèyé Gbafinro and a community leader, Bashiru Adekile.

The Trumpet gathered that the victims were kidnapped on Thursday night along the Ago Panu axis on the Owo-Ikare Highway while on their way

to Ikare-Akoko from Akure, the state capital.

The victim's driver who is currently receiving treatment at an undisclosed medical centre in Owo was also matcheted by the gunmen. As of the time of filing this report, the kidnappers had not contacted the victim's families for any ransom.

Meanwhile, the Ondo State Police Command has assured that the kidnapped traditional head and three others who were abducted on Thursday around Ago Yeye, Along Owo/Ikare road in a Toyota Corolla Car, Reg. No. KAK 818 AE would be rescued uninjured.

In a statement by the Ondo State Police Public Relations Officer, Funmi Odunlami in Akure said police, local hunters and vigilantes in the area are combing the forest to rescue the victims and arrest

the perpetrators.

The statement reads: "The Police on 4/8/2022 received a distress call that at about 6:30 pm around AGO YEYE, ALONG OWO/IKARE Road, gunmen shot at one TOYOTA COROLLA CAR, REG. NO. KAK 818 AE, while in motion, the bullet hit the driver on the head and the vehicle came to a halt.

"The other occupants numbering about 4 (identities unknown) were whisked into the bush while the driver was abandoned.

"The police have recovered

the vehicle while the driver was taken to the hospital.

"The driver is currently in a stable condition while the police, local hunters and vigilantes in the area are combing the bush for the rescue of the victims and arrest of the assailants."

Chides FG for neglect of traditional institutions

A traditional ruler in Ondo State, Oba Pius Akande has promised his people that he will revive all the forgotten traditional activities in the community.

Oba Akande, who is the monarch of Oka-Odo Akoko in Akoko South-West Local Government Area of Ondo State, said that since the throne was ceded in 1904, most of the activities have been abandoned.

The monarch in his statement, during his second coronation anniversary, said his reign on the throne will ensure all religions are given the room to operate freely in the community.

"If we have somebody like Governor Akeredolu in the Federal Government, it would be better. The government at the central level is not doing well. Money is there but the Federal Government has refused to release the money.


"We have been neglected for a long time. Most of the (traditional) things we have been doing have been neglected.

"We just had the throne that as taken from us since 1904 Most of the things we were doing before have been abandoned. We are trying to resurrect them and bring them back.

"I have nothing against masquerade, I have nothing against Christianity, I have nothing against Muslims. All religions will be allowed in my community," Oba Akande stated.

Speaking on the spate of insecurity in the country, the monarch said he was in support of the creation of state policing to curb the insecurity excesses and also provide effective security.

The community, which also celebrated the new yam festival with the coronation anniversary, resulted in Oba Akande and the people walking to the Okunre shrine to offer thanks for the bumper harvest.

MURIC counters US Senators' claim on Christian persecution in Nigeria

■ Says 32,000 Muslims killed in 3 years By PAUL MICHAEL,

The Muslim Rights Concern claim of five US Senators over alleged Christian persecution in Nigeria, saying about 32,000 Muslims were killed within three years (2015 - 2018) in the

country.

The US Senators include Josh Hawley, Marco Rubio, Mike Braun, James Inhofe, and Tom

The Senators, while citing the attack on St Francis Catholic Church in Owo, Ondo State, and the lynching of Deborah Samuel, a female student of Shehu Shagari College of Education in Sokoto State, said in a letter written to Antony Blinken, US Secretary of State, to re-designate Nigeria as a Country of Particular Concern (CPC), noting that there is no "demonstrable improvement in the country's religious freedom conditions'

In December 2020, the US listed Nigeria among the countries blacklisted for "violating religious freedom" under the CPC designation.

In November 2021, however, Nigeria was removed from the list, thus the request of the

Responding to the US Senators, Ishaq Akintola, Director of MURIC, said on Thursday at a media briefing in Lagos that no fewer than 32,000 Muslims have been killed in the country within three years.

Akintola accused the Christian Association of Nigeria (CAN) of claiming that only Christians are being killed in Nigeria and of lobbying US politicians until the five senators

wrote to Blinken. He said the claim that the Federal Government of Nigeria is failing to protect the religious freedom of Christian citizens is a "shameless attempt to overturn the facts of history", stating that millions of Muslims have faced harassment in southern Nigeria.

"Boko Haram, in particular, has killed, maimed, and displaced more Muslims than Christians, more Muslim clerics and more Muslim traditional rulers have been killed or kidnapped than Christians.

"Most importantly, more Muslim majority states are under siege by these terrorists than Christian majority states while more Nigerian Muslims have been impoverished by insecurity than Christians. Insecurity in Nigeria has had a greater impact on Muslime than Christians but our Christian neighbours are standing history on its head.

"The US should encourage Nigerian Christians who are entangled in a cobweb of entitlement syndrome. Christian leaders are taking advantage of the precarious security situation in Nigeria which has been compounded by the Libya factor," he said.

Akintola challenged the US Senators to provide the source of their claim that 4,000 Christians were killed in Nigeria as of 2021, adding that Christian leaders are simply capitalising on the enormity of the security challenges facing Nigeria.

Army confirms policeman beaten to death by its personnel in Lagos

The Nigerian Army has confirmed that some of its personnel on Wednesday beat a police officer to death in Ojo area of Lagos State.

It was gathered that the soldiers numbering about thirty, were reported to have whisked two policemen who were working as traffic wardens to their barracks while a third officer managed to escape from being forcefully

A source who narrated the ordeal claimed that the three police officers stopped the lane through which the soldiers were driving in a Coaster bus that was still behind unknowingly to the police officers while controlling the flow of traffic to allow other road users on the other lane.

He said the soldiers got infuriated and insisted on taking one way when an

argument ensued.
The source said the soldiers pounced on the policemen and beat them to a pulp, noting that afterwards, they forcefully took two of the policemen to their barracks

where the beating continued.

The source further said when the soldiers noticed that the abducted policemen had become unconscious, they decided to take them to their decided to take uncir to hospital at the cantonment.



Settling in locations outside God's will

Then the Lord appeared to him and said, "Do not go down to Egypt; live in the land which I shall tell you" (Genesis 26:2). In many ways, the writings and words of the Holy Bible are cast in poetic language. The instruction of the Lord to Isaac is one of such. Isaac was commanded not to go down but to live in the land where God will show him. We go down if we do things out of the purview of God. We live if we put ourselves in the sight range of God.
Our prayer is that we shall be where

God has marked for us as our location Between Isaac and his father Abraham, there were two famines. Consequently, there is nothing we are undergoing today in terms of hardship and lack or scarcity that the people of God did not undergo in the Bible. However, in all this, our relationship with God matters a lot.

The experiences of human lack and deprivation may lead to desperation. The account of Esau (Genesis 25:29-34) is instructive. Hunger made Esau so weary that his reply to his brother, Jacob's request was "Look I am about to die; so what is this birth right to me?'

Hunger can be 'weaponized.' Why do you think unscrupulous politicians keep their people poor in a state of destitution? In the face of death, shame, failure, and poverty, we naturally become eager and desperate. This state makes us devise human ways that we may figure as the way out. There is nothing wrong with using human reason to solve daily problems that we face. But we must seek the divine face in every situation. Isaac needed to look up to God.

Our human ways should not be outside the divine will of God. Our today's experience can be

likened to the famine faced by Isaac. In spite of the resources and structures we see everywhere, both human and non-human, we are enmeshed in poverty, unemployment,

dying industries and firms, decaying health and education systems, and even in areas with huge budgetary votes, we are still shamefully in dire need of help. Look at our oil sector, look at our security, etc. People manning these areas cannot complain about the lack of resources and finance. "Unless the Lord builds the house, they labour in vain who builds it; unless the Lord guards the city, the watchman stays awake in vain" (Psalm 127:1). It is not late in the day for us to seek the face of the divine Builder and Watchman in our human affairs.

There are many impediments we encounter in our life's journey. They come in our workplace, family, spouses, children, and businesses. We should strive to be victorious over these challenges and obstacles. Only those who stand up to confront and put these obstacles down are called overcomers and conquerors (Romans 8:37). In our text today and based on the experience of Isaac (Genesis 26:1-33), as a victim of a natural evil famine - Isaac needed to look up to God. His situation can only be turned around when he could find water. But not water in just any location! The natural place to seek water was Egypt. The Nile was there. But God told him otherwise. In the Bible, Egypt is a metaphor for bondage, slavery, and punishment. Are you living in plenty but in punishment, bondage,

Many are in such situations here and

outside Nigeria.

God has since delivered His people from Egypt and would not want them to return to this experience again. Isaac became his own barrier. He failed or chose not to follow God's leading. He did not go down to Egypt, but he did not go the way of God either. Isaac went to the land of Gerar. He met Abimelech, the King of the Philistines. But the men of the place 'asked' about his wife (Genesis 26:6). Isaac had to resort to falsehood for the fear of death.

He ran away from one death to another death. The king rescued Isaac from this

The story says further that Isaac sowed in this land and reaped in the same year a hundredfold "and the Lord blessed him. The man began to prosper, and continued prospering until he became very prosperous" (Genesis 26:12-13).

Nevertheless, Isaac became an object of envy due to this prosperity and wealth. The same King Abimelech issued Isaac a quit notice. "So the Philistines envied him" (verse 14) "and Abimelech said to Isaac, "Go away from us, for you are much mightier than we" (verse 16).

Isaac only got material blessings in a location that was outside the will of God. He had no rest! He opened blocked wells. He had good harvests. His flocks increased. But so were the quantum of envy, hatred, and enemies that surrounded him. At the Valley of Gerer, Isaac opened all the closed wells of Abraham, giving them the same names his father gave them thus: Esek (contention, v. 20); Sitnah (hatred, v. 21), and Rehoboth (there is room, v. 22).

God did not appear to Isaac in any of these places.

We must go to locations where God would appear to us. This will be a place of worship, prayer, and where God gives his people rest. It is in such a place we can chant, "O come, let us worship the Lord! Let us shout joyfully to the Rock of our salvation. Let us come before His presence with thanksgiving; let us shout joyfully to Him with psalms" (Psalm 95:1-2). God

desires our worship. We cannot be truly blessed where we cannot worship God truly.

It is therefore important to become born again as well as move on to become converted in order to be established in the Kingdom

If you say you are now born again into the Kingdom of God and still take pleasure in sin and the works of the devil, you are not born again. CAN urged to pray for Nigeria unity

The Vice-Presidential Candidate of Peoples Democratic Party (PDP) Governor Ifeanyi Okowa has urged Christians to pray for "recovery" and unity of the country, and not allow political intrigues to pollute the Church and divide it.

Okowa made the call on Friday when he received leaders of the South-South Zone of the Christian Association of Nigeria (CAN) led by Archbishop Israel Ege at Government House, Asaba.

He said that the time had come for Christians to go on their knees and seek divine direction in the choice of the nation's leaders that would emerge in 2023 rather than succumb to distraction by politicians.

According to him, it is my prayer that the church will continue to lead us in prayers and we need to be a little cautious as a church.

Okowa said "I am saying this because from the conversations I am beginning to see, I want to be sure that the church will not because of politics divide itself.

"The church in itself must be very prayerful that the will of God be done in 2023. We may have our individual preferences but we must be cautious about the unity of the church.

"Although we are traumatised as Christians we must be careful not to, because of that trauma, take decisions that may not actually be the will of

While attributing the successes of his

administration to the grace of God, the governor pledged to continue to synergize with the church in piloting the affairs of Delta and in his future

He advocated for constitutional review to pave the way for devolution of powers, especially giving more powers to states to establish their own police outfit as a way to tackle insecurity, pointing out that the nation was in

The governor also stated that it was time for the rebuilding of the nation by giving all segments of the society a sense of belonging in the scheme of things.

He frowned at the continuous stay of tertiary institutions' students at home due to industrial action by teachers and other workers, emphasizing that drastic steps should be taken to pull the nation out of economic quagmire, worsening insecurity and other heinous crimes taking place in all geopolitical zones of the country.

"There is no doubt that we are very challenged as a nation and it appears that all hope is lost, particularly to the younger ones. But I am one person that believes that all hope is not lost.

"Whatever thing that we have seen in the last seven years, I believe that God has allowed it for a purpose. I believe that there are lessons to be learnt.

"As of today, there is so much insecurity; the economy is going really down beyond what you think and know. Most Nigerians don't even know how

huge these challenges are.

"With the things going on now in the Education sector, it's not what anyone would wish for our country. We need to be very prayerful.

"The church must stay very prayerful and it's a time for us as a nation to unite and find peace," he stressed.

Okowa further said that "looking at

the constitution of the security agencies, I think that there is a need to expand it. My principal, the Presidential Candidate of the PDP, Alhaji Atiku Abubakar, has always said that it's not possible to police this nation with the Federal Government police only.

"It is not because of the situation of today but because of the peculiarities of this nation. We need to devolve power and resources to the states to ensure that they can run their own police force.

"If it were so, a lot of things going on at the moment would have been tackled, and so I believe that we need men who have the experience to bring about the change that we need in our nation today.'

Earlier, the leader of the team, Archbishop Israel Ege, had said that they were in Asaba to thank the Governor for his support for Christians in Delta and the South-South and assured him of their support at all times.

He congratulated him on his emergence as the vice presidential candidate of the PDP and for his transformation agenda in Delta and charged him to remain a good ambassador of the church in his political career.

The cleric said that Satan was at war with the church through the use of Boko Haram to kidnap and kill Christians and persecution of believers, and called on Christians to redouble prayers for the nation.

The high point of the event was a special prayer for the Governor, his family, the state and the nation.

Deltans have been charged to be cautious about accommodating persons in their homes that might turn out to work in order o actualize the Islamic agenda of a section of the country.



Rising cost of fish and Nigerians' dilemma

Fish used to be readily available and affordable in time past, as it was considered a necessity for the poor, despite its very nutritious value. While the rich and the middle class prefer cow goat, pig, chicken and turkey meat, the less privileged simply go for fish due to its affordability, but the story has changed, as the price of fish now competes with that of meat in the market. Curiously, while the masses are lamenting that fish has increased beyond their reach, former president Olusegun Obasanjo has canvassed further increase in its price, **JOHNMARK UKOKO** writes.

s the United Nations (UN), the Food and Agriculture Organisation (FAO) and their partners are working hard to ensure the availability of fish and investing billions of dollars yearly to ensure availability of fish for the people, the World Trade Organisation (WTO) constantly has met ministers of agriculture to brainstorm on how fish can be made available and more affordable to people globally.

The move stems from their realisation of the importance of fish in the nutritional value and the health of the people, which is why the organisations vote billions of dollars and provide expertise yearly in the fishing industry to increase fish production.

To that effect, they have organised conferences in various cities to further enhance the production of healthy fish for the people and have commissioned several research programmes to boost fish production.

Only last week, the WTO and FAO and their partners converged on Maputo, Mozambique to brainstorm on how best to increase production of fish globally.

In Nigeria, the Federal Government earmarked huge amounts of money to the Ministry of Agriculture and awarded robust funds for fisheries as a major component aimed at further boosting the sector.

But in spite of the huge amounts allocated to fisheries department and government's promises to Nigerians to ensure that the people get affordable fish, it seems achieving the objective is far from reality as the price of fish has more than doubled in the last two years to the extent that most Nigerians are no longer able to afford fish, due to constant increase in its price.

Despite the lamentable increase in the price of fish, a development most Nigerians see as way too expensive, former President Olusegun Obasanjo does not seem to connect with the dilemma of fish consumers.

Recently, the farmers in the South West gathered at the Olusegun Obasanjo Presidential Library (OOPL) in Abeokuta, Ogun State to address the issues confronting fish farmers in the geopolitical zone.

Speaking at the event, Obasanjo, who was guest of honour and a big farmer himself, bemoaned the difficult times businesses were going through in the country due to the itive cost of diesel

Obasanjo, who said the price hikes had made enterprises impossible to run, adding that his fish farm was also being negatively impacted, attributed the problem to the cluelessness of President Muhammadu Buhari's administration and cautioned that the rising cost of diesel, as well the steadily rising cost of fish and other food items could eventually force fish farmers out of business.

He argued that the only way fish farmers could remain in business was to synergise to assure sustainable price of fish, adding: "Farmers can no longer depend on customers who offer whatever amount that suits them without taking into account the effect of the current economic situation in the country on the production of fish.'

He stressed that a kilogram of fish now cost N1,400 to produce due to the present price of diesel, which is above N800 per litre and that the farmers could not afford to sell for less than N1,500 to avoid total loss and generate even a small profit.

Lamenting the hard times facing the industry, he further said: "The price of diesel has increased because of the mismanagement of the country and it is as simple as that. What will happen is that particularly those of us who have to use diesel in producing fish, will completely go bankrupt and when that happens, Nigerians will still have to eat fish.

'Fish production will be out of reach and then people will be produc-ing fish outside Nigeria and dump it in the country and people will go jobless, poor and indigent so, what do we have to do? We must come together to sustain fish production and take care of fish farmers."

Obasanjo, who asked the farmers how many of them were using diesel for producing fish, said: ' am perspiring already. This is the essence of this gathering. We find out that we have come to take our destiny into our hands. We can't continue to produce and be at the mercy of buyers.

"We felt we needed to come around and do something for ourselves. We are starting with the South West and in a matter of time, will be all over the country."

In his presentation, President of the South West Fish Farmers Association, Amo Tunbosun, who said price sustainability remained crucial to the industry, disclosed that Nigeria now imports about 2.6 million metric tons of fish yearly to make up the 3.6 million metric tons needed in the country every year.

Amo alluded to the difficult circumstances Obasanjo highlighted when he said one of the biggest problems facing fish farmers was the constant increase in the price of fish feeds and other inputs used in the production of fish, as well as the insistence of consumers to pay amounts not commensurate with the cost of production.

A cat fish farmer, Mrs Chinyere wacukwu told The Trumpet that feeds and other items needed for fish production continue to increase, maintaining that cat fish production does not need diesel and as such, it was not her major concern.

She disclosed that she produces her fish from the dung, blocks and cement to build her fish farms, but that the price of fingerlings and small cat fish have increased, adding: "Cat fish production is very expensive. The price of feeds and cost of labour have increased. To produce big cat fish, one must be ready to feed them well and take good care of the workers.

"Transporting the fish from the farm to the market is also expensive, just as the cost of transporting workers and the fish to the market has consistently increased in recent

Speaking in an interview with The Trumpet, another cat fish farmer, Tony Odey said the price of catfish and other items have more than doubled and that as a catfish farmer, he lived by the proceeds of his farming, adding that since the prices of all products have increased, the price of cat fish cannot be left out.

He disclosed that an average sized cat fish that was sold for between N300 and N500 last year ago now goes for between N600 and N1,000 depending on the size and that although he does not use diesel, he uses the money he makes from the cat fish farming to pay his other bills.

'I agree that the price of cat fish has increased, but is there any product, whose price has remained the same in the last one or two years? The price is further higher because the middle men and women own the market and so, it is difficult for the farmers to take their fish directly to the market.

"I laugh when people say the price of cat fish has risen. Such people think the price they buy the fish at the market is the same price the farmers sell to them. The middlemen do less and make higher profits than us.

"Fish farmers don't have direct access to the consumers. We know how much cat fish is sold in the farms and what it is being sold in the market to the final consumers. Those who do 'point and kill' make more profit with less stress than the farmers who produce the cat fish," he stated.

He said cat fish farmers do not get the needed support from the government, adding that the current inflation rate has impacted the cat fish farming sector and that Obasanjo was right in blaming the Federal Government for failure to refine diesel and other petroleum products in the country.

"Seven years is long enough to have built new refineries to refine diesel and other petroleum products in a major crude oil endowed country. Why has the Federal Government not been able to establish at least one functioning refinery, when it promised to establish one every year?

If the country has been able to maintain the four old refineries in Warri, Port Harcourt and Kaduna, the story would have been different. If President Buhari has established one refinery every year of his tenure, by now seven new refineries would have been producing diesel not only for Nigeria, but also for other countries and by so doing, Nigeria would have been better and would have generated huge revenue from the Russia-Ukraine war.

Despite Buhari's failings in delivering on his promises, Obasanjo should also share part of the blame as he had the privilege of leading the country between 1999 and 2007 when crude oil sold for \$100 per barrel, yet he failed to turn around the four refineries in Kaduna, Warri and Port Harcourt.

Nigerians believe that if Obasanjo had built a new refinery during his time as president, things would not have been this bad, while others are of the view that it was wrong for the former president to canvass increase in the price of fish due the hike in diesel price.

They argued that the way things are done in Nigeria, Obasanjo farm in Otta, Ogun State should have a huge depot where petroleum products must have been stored that would last him for decades, insisting that it was not fair for successive administrations to impoverish the Nigerian masses and be denied fish consumption, when they could hardly afford meat and other healthy sources of protein.

"Obasanjo should not be the one to call for hike in the price of fish when the masses have already been over burdened by increases in all items while their salaries have not been increased for years, many are being owed for months, while millions remain unemployed.

"How can Obasanjo says he was already perspiring? If the likes of Obasanjo can say he was perspiring, what should the Nigerian masses who have been made extremely

"Nigeria is the poverty capital of the world, as thousands of our people keep migrating to poverty level and many are losing their jobs, yet they are still pushing on with their lives, so Obasanjo should not rob salt in their injuries, a respondent

In all, the months ahead will determine if Nigerians will be priced out of fish as they have suffered from so many injustices in the past. The question now is whether they will be able to afford fish again or simply embrace vegetables.

Naira appreciates after EFCC's raid of parallel market in Lagos

Operatives of the Economic and Financial Crimes Commission (EFCC) raided Bureau De Change (BDCs) operators at various locations in Lagos State over the continued lepreciation of the naira, especially in the last two weeks.

The development has partly led to an appreciable increase in the value of the naira to about N630, as against the N710 it reduced to

This prompted most Nigerians to speculate that the naira might exchange for as much as N1,000 to the dollar before the year ends.

Following the development, the Senate summoned Governor of Central Bank of Nigeria (CBN), Godwin Emefiele, to explain the continued free fall of the naira to as much as N710 to \$1.

In one of the raids at Tinubu

Square in Marina, Lagos, the EFCC operators arrested some parallel market operators.

Also, investigation by The Trumpet at Allen Roundabout in Ikeja showed that the value of the naira was gradually stabilising against the dollar, which led to massive losses by the parallel market operators, as they were forced to sell at lower rates, having bought at higher rates.

It was also learnt that most black market operators and BDCs operators were careful to tell foreign exchange buyers the correct rate, as they were unsure if such customers were security operatives.

It would be recalled that following the Senate's threat to summon the CBN governor to explain the free fall of the naira, the apex bank vowed to arrest and prosecute Nigerians, who are

using naira to buy dollars.

Emefiele, who said at the last Monetary Policy Committee (MPC) meeting in Lagos recently that it was illegal to take money from the banks to buy dollars, cautioned operators that if security agencies arrest anyone doing so, the implication would be grave.

The CBN governor, therefore, urged those illegally exchanging the naira for dollars to stop the practice, adding that the apex bank would conduct investigations and bar those found guilty from doing transactions in Nigeria banks.

'We will investigate the matter to have proof and the operators will not be able to conduct transactions in any Nigerian bank. We will place post no debit (PND) on the accounts of defaulting customers to stop conducting illegal flow of domestic or foreign currencies,' Emefiele said.

NDIC cautions against investments with illegal fund managers

The Nigerian Deposit Insurance Corporation (NDIC) has announced that its insurance does not cover investments with illegal fund managers in the country.

It stated this statement issued by the Director Communication and Public Affairs Department, Bashir Nuhu, noting that with the recent increase in investment channels arising from innovative products had created several illegal fund managers.

The NDIC warned that fund managers have been using different platforms in persuading members of the public to invest their funds with them, promising excessive returns on such investments.

To protect unsuspecting depositors, it has become necessary for the NDIC to continue to sensitise members of the public on the high risks associated with investing funds with illegal funds managers.

"Accordingly, as the deposit insurer, the NDIC would like to inform members of the public that contrary to claims by some of the fund managers, the corporation does not insure investments with them. The NDIC insures only deposits of financial institutions licensed by the Central Bank of Nigeria (CBN) to accept deposits from members

"All enquiries regarding invest-ment of funds should be addressed to the Director of Communication and Public Affairs Department of the NDIC. Members of the public are also advised to report any entity suspected to be involved in illegal deposit mobilisation to law enforcement agencies," the statement reads.

Nigeria targets 80% reliance on technology by 2025, bans importation of SIMs

Minister of Communication Technology and Digital Economy, Prof. Ali Pantami, has said that it is not proper for Nigeria to be importing items that could be produced locally in the country.

Speaking in a conference recently in Lagos, he noted that Subscriber Identity Module (SIM) cards-chips that contain information and enable mobile phone users to connect to their telecommunication operators-are produced in Nigeria and therefore, their importation has been banned in the country.

He said: "From now on, all SIM cards sold in Nigeria will have to be produced in the country. The government has banned the importation of SIM cards used in mobile phones.

"The ban was part of the Federal

Government's efforts to promote local manufacturing following the launch of a SIM cards factory in

Lagos in June this year."
Stressing that SIM cards are now being manufactured in Nigeria, he stated that the development was a product of the national policy on local content signed by President Muhammadu Buhari.

He added that before the Buhari administration, SIM cards were being imported into the country but today, Nigeria has the capacity to produce SIM cards for the African continent.

It would be recalled that the first SIM card was developed in 1991 by Munich Smart -Card Maker, Giedecke & Devrient, which said the first 300 SIM cards were deployed to the finished wireless network operator radio, but today, SIM cards are ubiquitous, allowing over seven billion devices to connect to cellular networks globally.

Former Minister of Industry, Trade and Investments, Okechukwu Enelamah announced funding support for a local card production firm in Lagos.

OPEC raises Nigeria's production quota as oil price declines

The Organisation of Petroleum Exporting Countries (OPEC) raised Nigeria's crude oil production quota for September 2022 to 1.83 million barrels per day (mbpd), as the price of Brent, the global benchmark for crude oil, dropped on Wednesday, August

Data obtained from OPEC showed that the 13-member organisation increased Nigeria's oil production quota marginally from 1.826mbpd in August to 1.83mbpd in September. This followed as industry figures

sighted in Abuja indicated a drop in the cost of crude oil, as Brent fell by 2.36 per cent, shedding \$2.37 to close at \$98.17 per barrel as of 5:10 p.m.

It was also observed that the price of crude oil grades in the OPEC basket dropped e, losing \$1.94 or 1.82 per cent to close at \$104.86 per barrel at 5:13 p.m., just as oil prices have stayed above \$100 per barrel for months due to several industry concerns such as the Russia-Ukraine war.

However, Nigeria has not benefited much from the price increase because of its persistent inability to meet its monthly oil production quota approved by OPEC.

For instance, figures obtained from OPEC showed that while the OPEC quota for Nigeria in June 2022 was 1.772mbpd, the country could only produce 1.158mbpd, but the country's production in June was, however, higher than its production in May 2022 by

134mbpd.

The Trumpet learnt that Nigeria's oil production in May 2022 amounted to 1.024mbpd, but increased to 1.158mbpd in June, although far lower than the 1.772mbpd production quota by OPEC.

Meanwhile, the organisation stated that the decision on the latest crude oil production quota for September 2022 was made during the 31st OPEC and non-OPEC Ministerial Meeting.

"The meeting noted the dynamic and rapidly evolving oil market fundamentals, necessitating continuous assessment of market conditions. It pointed out that the limited availability of excess capacity necessitates using it with caution in response to severe supply disruptions," OPEC stated in its report.

It added that the meeting noted that chronic underinvestment in

the oil sector has reduced excess capacities along the value chain in the upstream, midstream and

downstream segments.
"It highlighted with particular concern that insufficient investment into the upstream sector will impact the availability of adequate supply in a timely manner to meet growing demand beyond 2023 from non-participating non-OPEC oil producing countries, some OPEC member countries and participating non-OPEC oil producing nations.

The organisation further said the Declaration of Cooperation on conformity had averaged 130 per cent since May 2020, supported by voluntary contributions of some participating countries.

Stressing the value and importance of maintaining consensus as essential to OPEC's cohesion and participating in non-OPEC oil producing countries and in view of the latest oil market fundamentals, the participating countries reached some decisions.

They decided to reaffirm the decision of the 10th OPEC and non-OPEC Ministerial Meeting held on April 12, 2020, and further endorsed it in subsequent meetings, including the 19th OPEC and non-OPEC Ministerial Meeting of July 18, 2021.

Seplat advocates just energy transition for Africa

Seplat Energy Plc has said its greatest business opportunities ahead will remain the supply of the right mix of energy to support Nigeria's growth and development in all sectors of the economy.

In doing so, the company said it remained committed to making positive social impacts and will contribute to Nigeria's achievement of the United Nations' Sustainable Development Goals (SDGs).

Director of New Energy at Seplat, Effiong Okon, said this while delivering an address at the 45th edition of the Society of Petroleum Engineers (SPE), Nigeria Annual International Conference and Exhibition (NAICE) with the theme: Operationalising a Clean Energy Transition for Sustainable Development in Africa.

Okon, who represented the Chief Executive Officer (CEO) of Seplat Energy, Roger Brown, said for successful energy transition in Africa: "We must support the goals of the Paris Agreement and the Paris Agreement of the Paris Agreement and align with society's objective to get the world to net zero carbon emissions by 2050, if not before; as loweremission hydrocarbons, particularly gas has a crucial role to play in energy transition by replacing diesel generators and biomass.

"Though hydrocarbon export will continue to be a mainstay of the Nigerian economy and will fund Nigeria's growth as well as its energy transition, the Oil and Gas Industry has a role to play as a responsible steward of Nigeria's oil and gas assets, including those that might be divested."

He stressed that in the longterm, the reality and threat of climate change would require the decarbonisation of energy systems in Nigeria, but sustainability and transparency must be at the heart of business operations and decision-

Speaking on 'just transition,' Okon noted that there was the need to balance decarbonisation with development, adding: "Global warming and climate volatility are existential threats to humanity and nature. The world needs to accelerate efforts to achieve net zero and mitigate warming effects. Africa's climate, agriculture and people will suffer most in the coming decades. The problem has been caused by emissions from developed-world countries that have enjoyed their 'carbon privilege' and built strong economies on fossil fuels.

"However, we need to consider the reality on the continent. Poverty, hunger, unemployment, population growth abound here. Africa contributes just 3.3 per cent of global emissions. About 600 million African lack access to reliable energy, which hampers development. Use of inefficient, costly diesel and petrol generators drains finances, foreign exchange and creates pollution.

"Biomass use for cooking causes deforestation, health problems and

nearly 0.5 million premature deaths in Sub-Saharan Africa yearly. The developed world's drive to impose de-carbonisation on Africa will constrain development."

Brown, who made a strong case for gas, said pressures by the developed world to abandon fossil fuels are being pushed back by recognition of the need to drive development with reliable energy.

He explained that COP27 will focus on how best to achieve balance for the future benefit of 2.5 billion Africans of whom 500 million will be Nigerians, adding that given current low emission levels, Africa can achieve a disproportionate improvement in living standards through a global small increase in emissions from cleaner gas for power and cooking.

He urged players in the continent to leverage oil and gas revenues to cash flow transition, but also tap international transition funding were available, hence the need for good corporate governance.

He, therefore, urged industry operators to focus on quick wins first, including decarbonising the upstream and focus on producing 'advantaged' low-carbon barrels with low Scope 1/2; end routine flaring and redeploy gas to power operations and local communities: deploy renewable energy to power operations where possible, and share with local communities.

"We need to develop gas as a transition fuel from gas-to-power to replace diesel, move along the value chain into power in business parks, large buildings, hybrid gasto-power, solar offerings and bottled gas products for domestic use.

"În addition, we can expand into renewable energy sources including hydro, wind, geothermal, blue and green hydrogen, as well as develop and monetise carbon capture and storage" he added.

2023 elections: Apathy in real estate sector

head of the 2023 general elections in Nigeria, experts in the real estate sector have predicted that things would get worse in the real estate industry due to unfavourable government policies and the high level of inflation in the economy.

The level of inflation has risen to 17.7 per cent in the past six months, with the naira going down against the dollar at N615 in the parallel market and N415 at the international market. The building and construction industry that is heavily reliant on the importation of some important building materials has been exposed to price fluctuations.

The astronomically high costs of building materials forced many developers and independent builders to abandon projects as political actors are putting more funds to electioneering campaigns than investing in critical sectors like housing, while many infrastructural projects initiated by the government are technically stalled, starved of critical funds.

Looking at government at the state level, only a few state governments are still in the pursuit of delivering housing units while others have shifted focus to winning the 2023 elections in order to remain in office.

Since this year began, many developers and institutional investors have slowed down on investment in housing due to political instability and fear of the unknown. The confidence of investors is currently very weak as they await the outcomes of the 2023 general elections.

Buying capacity has drastically reduced as interest rates rise, eroding interest in long-term funds for property development etc. Taking a critical look at the real estate value chain, access to land has been difficult and finance for affordable housing is a big issue as the sector is encumbered by high mortgage rates.

The odds notwithstanding, the real estate sector shows resilience in the first half of the year according to the National Bureau of Statistics (NBS) report. The sector contributed 5.34 per cent to real Gross Domestic Product (GDP) in Q1 2022, higher than the 5.28 per cent it recorded in

the corresponding quarter of 2021.
The Gross Domestic Product (GDP) reveals sustained positive growth and an improvement in economic performance for the sixth consecutive quarter since the recession witnessed in 2020 when negative growth rates were recorded in quarters two and three of 2020 respectively.

Nevertheless, housing supply remains in a state of constant undersupply as population and demand continue to outpace supply with a deficit as high as over 17 million in the affordable segment of the market.

Speaking on the situation, Prof. Austin Otegbulu, council member of the Nigerian Institution of Estate Surveyors and Valuers (NIESV), said the housing sector is highly influenced by property market dynamics, which oscillate in response to economic or business cycles.

He said the nation's political

system is unpredictable; hence there is always the notion that the general election could trigger violence and an unfavourable investment climate.

He observed that many people will want to sell their property and relocate, adding that politicians vying for electoral positions and those sponsoring candidates may be received the required fund. need to raise the required fund by selling houses with the hope of buying new ones if they win the elections.

"The cumulative effect of this is that it changes the market by creating an imbalance due to oversupply. The effect of supply and demand imbalance coupled with a decline in economic activities leads to decline in property

"They prefer to keep their money in the bank. Some school of thought is of the opinion that the property market will bubble under this scenario. I believe that such views run against logic as most foreign and local investors will avoid investing under conditions of uncertainty and political instability. We must realise that we are part of the global property market,"

Gbenga Ismail, former chairman, Royal Institution of Chartered Surveyors (RICS), Nigeria Chapter, said: "I have not seen any one of them yet unveil plans for housing but we hope when the campaigns start in full, we will see that. I want to see how they will tackle the affordability issues and easy access to property and mortgage finance and development. It is important for them to identify how they would make people have access to housing because it is a big problem that needs necessary action. The same way that we say power is a problem, housing is also a problem."

Similarly, a former chairman of

NIESV's Faculty of Estate Agency and Marketing, Mr. Sam Eboigbe, said the electioneering period has obviously affected the real estate sector in some notable way as campaigns attract a huge flow of

This dimension of injection of funds in local and foreign currencies, Eboigbe said: "Real estate sector contributes a huge flow of funds to campaigns since most of the participants and their sponsors are investors in the real estate sector. For ease of liquidity, prices respond to the market and adjust downwards as the volume of listings in terms of the gamut of the supply chain are far in excess of demand."

"It is an economic principle that prices will realistically adjust themselves in relation to demand over time. Also, lack of confidence as no one could predict the direction as people expect a major shift in governance and policies. At the moment, the fluctuating nature of the naira against the dollar is also making the sector lose confidence."

"When there is a lull in business activities and the trend is consistent over time, this will generate a lack of motivation for developers or investors in the market space. There is this issue of capital flight as stakeholders create room for the inevitable. They throw their properties into the market space. Upon consummation of transactions, the proceeds are deployed to purchase

until such a time they feel it is safe to acquire properties. It is usually not unlikely to find investors halt activities on site leading to the abandonment of projects.

"Some investors use the electioneering period to acquire properties, and take advantage of the opportunities, especially those offerings and listings below the market value." the market value.'

"They understand the market dynamics and have analysed the market over time to know the specific and choice locations and type of listings to increase their portfolios. These categories of investors are usually not many,"

"When we exit the inflationary

trend and the naira is strong, then issues of housing and interest rate will similarly and ultimately adjust accordingly. I think no serious political candidate can afford not to have a realistic policy on the recovery of the housing market."
Mr Lookman Oshodi, Project

Director, Arctic Infrastructure, said: "Electioneering period impacts housing as governors who are seeking re-election will want to increase the production of new housing units to convince the electorate on their sincerity to do more after re-election. Not many low-income earners will become new homeowners but the impact will be more among the medium-to-high-income earners since the mortgage system is not yet a mass appeal.

"Real estate investors who want

to hold assets on a long-term basis are generally conscious of political risk and often take back seats in this period. Instalment payments approach for assets and lending with real estate collateral are usual at this period."

"Investors want to be sure that the number is backed up by adequate purchasing capacity, which the next government needs to address. Regeneration of brownfields in our large cities must be a priority, as this will create viable markets for investors and a sustainable housing system for the people. 'Win-win' situation for the stakeholders."

Widows rendered homeless as brother in-law demolished family house

Two widows, Helen Agbi and Ogeri Agbi with their children have been rendered homeless following the alleged demolition of their family house by their brother in-laws.

The unfortunate incident occurred on the 18th and 26 July 2022 respectively, in Ezi Agbi, Úkpa Community in Afikpo North Local Government Area of Ebonyi State over ownership of a family building.

A visit by The Trumpet to the scene of the incident at Ezi Agbi, Ukpa Community, it was gathered that part of the family house including the fence and the properties inside were all destroyed.

Speaking with the affected widows, the duo Helen and Ogeri Agbi lamented that she had never seen that kind of thing before and never believed that her brother-in-law could do such a thing to them.

They alleged that the boys that demolished the building and destroyed their properties were hired by Azubuike Agbi, one of their brother in-laws, who conspired with the other whose name was not ascertained.

They further lamented that they have no place to lay their head, calling on the government to come to their rescue.

You have seen how the world is, we don't have anybody to come for our rescue nor to speak for us. I have never seen this kind of thing in my life. I never knew that my husband's brother could demolish our house for no just cause.

`They destroyed the building including the properties inside the house. All our cushion chairs, bed, fan, Television, lamp, kitchen utensils, wrappers and other things were all destroyed.

"I want the government to come to our rescue. You can see how we are struggling to earn a living. We are only surviving by God's Grace", Helen and Ogeri Agbi lamented. "As you can see, our husband died some years ago. It is my brother-in-law that came and destroyed the only house where we are living. They gave us notice to pack out.

"We have been living peacefully in this compound until when they came and told us that they wanted to rebuild their own side of the building and later migrated to our own side and did the same thing.

`This thing happened on the 18th and 26th July, 2022. Our husband, Egwu Agbi owns this building. Our late husband and his brother inherited this building from their mother and were divided for both of them to live.

The issues we had with them were in the past and have been settled by Ukpa Community who divided the compound into two. one side was given to our husband while his elder brother has the other side. And We have had no issue recently that could warrant this type of wickedness.

One of the widow's children, Mr Agbi Anelechi while reacting to the matter, stated that the building

is a family compound which his father Egwu Elechi and Okwa Agbi inherited from their grandmother and have lived there for years, but unfortunately, their cousin's brother, Azubuike Agbi came and claimed ownership of the compound and served them quit notice to pack out saying that the compound belongs to them.

He further explained that his cousin hired some group of boys on the 18th of July 2022 led by Mr Heart Okwa and demolished the building, but following the alarm raised by an Okada rida they ran

Also, on 26th July 2022, those boys came again with all manner of weapons such as machetes, axes, guns among others and succeeded in demolishing part of the build-ing including the fence and the properties inside it.

He, therefore, called on the overnment and Non-Governmental Organizations to come to their rescue and ensure that the perpetrators are arrested and prosecuted.

When contacted for his reaction to the allegation, Mr Heart Okwa said he won't react to the issue until he knows the people that reported him.

Meanwhile, Mr Azubuike Agbi, one of the brother-in-laws who instructed that the building should be demolished, is based far away in the United States of America

All effects made to get his contact proved abortive.

EFCC warns real estate operators, landlords to obey KYC policy

The Economic and Financial Crimes Commission (EFCC) has warned Real Estate operators, landlords, and property managers in the country to desist from renting out, leasing, or selling properties to individuals that do not comply with the "Know Your Customer" (KYC) policy.

This was disclosed by the Commission in a statement on its official website on Thursday, noting that the Ibadan Zonal Commander of the EFCC, Assistant Commander of the EFCC, ACE Kanu Idagu gave the warning while addressing members of the Kolapo Ishola Government Reservation Area (GRA) Residents Association in a Town Hall meeting at Rolat Event Centre, Akobo, Ibadan, Oyo State.

Idagu said the KYC is a regulatory mandate for both the private and public sectors with the primary aim of mitigating fraud.

According to him, KYC was set up by the government to uphold and maintain the standard of conducting business and sanitize the economy.

"One major regulatory concept that was set up by the government to uphold and maintain the standard of conducting business and sanitizing the economy is the concept of KYC and it simply means Know Your Customer.

"This has become a regulatory mandate, which requirement is not only limited to the private sector but to all sectors of the Nigerian economy with the primary objective of mitigating fraud," he said.

Idagu, who was represented by the Head, Extractive Industry Fraud Section (EIFS), Chief Superintendent of the EFCC, CSE Oluwasegun Oloruntuyi stressed the need for real estate operators to verify, monitor, and report any suspicious activities on their premises to the Commission.

He said such intelligence information will help curb and combat all fraud schemes, money laundering, and terrorism financing, which are major setbacks for the Nigerian economy.

He further reiterated the stance of the Executive Chairman of the EFCC, Abdulrasheed Bawa, regarding the use of premises for fraudulent activities, stressing that the law shall take its course whenever individuals fail to comply with Section 3 of the Advance Fee Fraud and Other Related Offences Act, 2006, which states that, "a person who, being the occupier or is concerned in the management of any premises, causes or knowingly permits the premises to be used for any purp ose which constitutes an offence under this Act commits an offence and is liable on conviction to imprisonment for a term of not more than 15 years and not less than 5 years without the option of a fine."

Idagu commended the Association for its deliberate efforts and role played in sensitizing and enlightening the public in the fight against corruption.

According to him, the EFCC is aware "of the role played by the real estate operators and property managers as major stakeholders in the fight against crimes and corruption. Hence, it is crucial to further collaborate in creating more awareness and enlightenment campaigns on the positive roles expected from every Nigerian.'

In his response, the Chairman of the Association, Barr Olalekan Thanni thanked the EFCC for gracing the event, while emphasizing the commitment of his members to ensure that the government has adequate information on every citizen who resides in Nigeria.

"The synergy between the Association and the EFCC will help reduce crime rate and make the Commission a pacesetter," Thanni said.

EFCC probes S/Court Registrar over alleged N10bn loot, racketeering

Economic and Financial Crimes Commission (EFCC) is probing an allegation of racketeering against Supreme Court Chief Registrar, Ahmed Gambo Saleh.

It was alleged that Saleh has received over N10 billion in bribes from court contractors and other persons with criminal cases with the judiciary.

A whistleblower petitioned EFCC to look into the activities of the Chief Registrar, accused of feeding fat on the court's funds while leaving vital projects to suffer neglect.

It was alleged that Saleh had connived with Surajo Muhammad, son of the immediate past Chief Justice of Nigeria, Muhammad Tanko, to embezzle public funds.

It was further gathered that Muhammad (Jnr) despite lacking in qualifications and competence to handle judicial matters, was in charge and managed affairs of the apex court and wielded his father's position as a tool to carry out backroom deals.

"Today (June 1), Surajo could be said to

be a de facto head of the SCN as his father seems to have relinquished the administration of the court to him, even when he is not a staff," the petition sighted by The Gazette

Citing instances of their brazen underhand dealings, the petition said the duo sold off the residence of a Supreme Court justice without the knowledge of Tanko, who was CIN at the time.

"It will interest you to know that a residence of a justice of the Supreme Court located in the villa, Abuja was sold by Gambo and Surajo recently. The underhand dealings between Gambo, Surajo, and the agency so pissed the CJN that he ordered the reversal of the transaction," added the petition with no. EFCC/PET/HQR/1817/2022 and dated June 1.

Meanwhile, the building was said to have been demolished before the situation was remedied, a situation that rendered the justice who should have been assigned the residents homeless.

The petition further noted that Saleh connived with Muhammad to allegedly withheld the funds meant for purchasing exotic vehicles usually assigned to newly sworn-in justices.

"Under Gambo and Surajo's shenanigans, they, JSC were given only a Land Cruiser, albeit refurbished. A Hilux was added after one year, and to date, the Mercedes Benz is still being awaited by the justices," the petition added.

It was revealed that eight justices sworn in since November 2020 are yet to be properly accommodated and receive the Benz even though the projects were captured in the capital budget for the 2020 fiscal year.

In 2017, Saleh was charged having been accused of diverting N2.2 billion, a matter later withdrawn by the Attorney General of the Federation over a purported plea bargain.

Before the withdrawal of the case by AGF, Saleh was charged with diverting Supreme Court's N2.2 billion to his personal bank account at the United Bank for Africa PLC, account number: 2027642863.

Saleh, despite fraud charges and allegations, was appointed as the Secretary of the National Judicial Council (NJC), a body responsible for the appointment, promotion, and discipline of judicial officers.

A spokesman for the NJC declined comments

Although Saleh then confessed the money belonged to him as it was a collection of cash gifted to him by friends, further investigations revealed that the money was "bribes collected from various court contractors who ended up executing shoddy jobs or outright abandonment," the petition stressed.

He was also charged with obtaining N21 million gratification from MBA Computes Ltd, N16 million from Dean Musa Nigeria Ltd, N10 million from Willysdave Limited, and N2.4 million gratifications from Welcon Nigeria Ltd, all contractors of the Supreme

The petition also claimed that the Chief Registrar, a public servant, was worth over N10 billion.

ICPC won't disclose information on investigative activities – ICPC Chairman

The Chairman, Independent Corrupt Practices and Other Related Offences Commission (ICPC), Professor Bolaji Owasanoye, SAN has said that the Commission was not at liberty to disclose information related to the identity of a petitioner and suspects, or the status of any investigative activities until investigation was completed.

This was made known by the ICPC Chairman on Thursday during an advocacy visit to the Commission's headquarters by the Service Compact with All Nigerians (SERVICOM) Office led by its National Coordinator and Chief Executive Officer, Mrs Nnenna Akajimeli.

Owasanoye revealed that when cases are received, they are investigated to ascertain which ones are to be handled by the Commission, saying not all reported cases fall under the purview of ICPC.

However, he said, despite the Commission's efforts to be responsive to requests for information, ICPC was constrained by law not to disclose to anyone any piece of information regarding any case that is still under investigation.

"Section 64 of the Corrupt Practices and Other Related Offences Act, 2000 clearly forbids the Commission to reveal any information, the identity of informers and all other circumstances relating to a matter except to a trial Judge or the defence lawyer in any civil, criminal or other proceedings," he said.

Speaking at the meeting, the SERVICOM National Coordinator, Mrs Nnenna Akajimeli praised the Commission for the creation of the SERVICOM unit and said she was happy at the progress the unit has made so far.

The Coordinator stated the advocacy visit was to improve the Commission's public service delivery by building the capacity of the management through training and to demonstrate how services can be improved in practice. According to her, law enforcement agencies in Nigeria can offer quality service to the public despite the delicate nature of their mandate and advocated a proactive disclosure of what customers should expect when coming to the Commission.

"The quality of governance is determined by the quality of services delivered to citizens and the extent to which these services meet their expectations, and therefore SERVICOM's mandate focuses on improving the quality of service delivery to the public by working with MDAs to ensure effective service delivery,"

She urged the Commission to continue its engagement and support to the SERVICOM team in the Commission as that would help to achieve more effective service delivery.

The ICPC Chairman was named as a SERVICOM Ambassador during the visit.


headquarters in Abuja.

Kunle Afolayan is a leading filmmaker who has produced timeless movies and positioned the movie industry globally; Afolayan doubles as the CEO of Kunle Afolayan Production (KAP), cinema, film and television academy, Afefeyeye restaurant and bar amongst others. In this interview with OMONIYI ALLI, he spoke about why he is a different filmmaker from others.

Nigerian film industry?

A: My understanding and experience of the Nigerian film industry didn't start 10 or 20 years ago. It started about 40 years ago because my father was a filmmaker and I was opportune to watch and witness how films were made in those days, coupled with the fact that we all grew up on Indian films and Chinese films. When television started, we had very few channels and started broadcasting at about four pm and everyone was always looking forward to watching Indian and Chinese films. But when it came to motion pictures, we used to have a lot of cinemas around. And Nigerians would go all out to watch indigenous films at the

Q: Why does your film seem different from other filmmakers?

A: I decided to adopt what was obtainable then and now to create a kind of balance.

Q: How would you describe what makes your films different?

A: To start with, I tell stories that people can relate to. I tell stories that an average movie lover regardless of where they are from would understand. Primarily, I always consider Nigerians and Africans as my first audience. Secondly, production value is what I will never compromise because that's what gets your films to the big screens and not just beyond the shores of Nigeria but the Nigerians and Africans in the diaspora. If the production value is there and the quality is good, then it would be open to exploration of different parts of the world.

Q: When and how did your career in acting and directing begin?

A: I started as an actor in 1998 when I featured in Tunde Kelani's film titled Saworo Ide. After that, I did a few films here and there but because I was working in a bank at that time, I couldn't really get to feature

Q: What's your understanding of the in a lot of films. In 2004, I resigned my appointment at the bank, I went to New York Film Academy where I did a diploma, came back to Nigeria and set up this company in 2005. I did my first feature film in 2006 titled Irapada meaning redemption. The film enjoyed a bit of exposure here and there. It premiered at the Pan African film festival in Los Angeles, United States of America. It screened at women of colour in Atlanta, US and went to a few other places.

> Q: You said you make movies others can be able to relate to, but can you say that

about other movies emanating from Nigeria?

A: Well, some yes, some no. But there are quite a number of stories that are primarily targeted at Nigerians specifically in different genres. Some of them are comedies, and these are comedies that only Nigerians would find funny. Even in my own films, there are some scenes in which people here laugh when they see it but outside the shores of Nigeria, they have different perceptions about those same scenes. So, it is important to know your core audiences.

Q: How in your opinion has the movie

industry contributed to the promotion of tourism in Lagos for instance?

A: Generally, I believe, movie production contributes to the development of tourism and revenue generation in any society. This is because when a movie is done, it engages a lot of hands; there is a lot of financial and cultural exchange. Specifically, Lagos is peculiar in that aspect. The Nigerian film industry pretty much started here. If you ask me, I'd say just as Los Angeles contributes immensely to the GDP of the United States as a whole, Lagos serves that purpose for Nigeria.

Q: Nigerian films recycle the same characters that are often known for just particular kinds of roles. Why the stereotype?

A: It's the same in Hollywood. Bruce Willis is always playing the bad guy, Denzel Washington is always playing the cool guy, and these guys have been there for more than two decades doing the same thing. But maybe in their own case, they do one or two films in a year, while in Nigeria, those actors do maybe 50 films (giggling) in one year. A talent is a talent. We can't change that. If the talent still has the relevance to still be in the industry, they would be there. There are so many aspiring actors with less training but who believe that they have all the talents in the world. But for me, in doing my findings, I realized that most of them lack discipline and discipline is key in the profession. I think it's the same trend everywhere. Even in India's film industry.

Q: What do you watch out for in scripts?

A: It must have cultural and entertainment value as well as a universal theme.

Q: How long did it take you to conceptualize the Kunle Afolayan Production hub?

A: I really can't put time into it, but we have been on these premises and we put up another building beside it, which we started using in 2019. It took us another year to complete the others and here we are.

FIFA U20 W'Cup: Falconets jet to Costa Rica

Danjuma unveils final list of 21

Twenty-one Falconets of Nigeria departed the country on Thursday to kickstart the FIFA U20 Women's World Cup campaign with an opening group C match against France on August 12 in Costa Rica.

Coach Chris Danjuma picked team captain Oluwatosin Demehin and captain 20 others - an overwhelming majority of whom were involved in the lengthy qualifying series - to wear Nigeria's colours at the 19day championship.

The Falconets had to scale the hurdles presented by the Central African Republic, Republic of Congo, Cameroon and Senegal, winning six of seven matches (they only drew with Cameroon in Douala) to be eligible to fly Africa's flag once more at the finals in Central America.

Aside from Nigeria play Canada and Korea Republic in Group C of the 16-nation tournament starting on 10th August, while 2018 runners-up Spain will tango with hosts Costa Rica, Australia and Brazil in Group A. Africa's other flagbearers Ghana are up against Cup holders Japan, the Netherlands and threetime champions United States of America in Group D.

Germany, who have also won the competition three times, including 2010 and 2014 when they beat Nigeria in the final, will play Colombia, New Zealand and Mexico in Group B.

All group phase and quarter-final matches will be played at the Alejandro Morera Soto, which is a hybrid of natural and synthetic stitched grass. The semi-final, final and third place matches will take place at the Estadio Nacional.

Nigeria's first match of the competition will be against France, which hosted the 2018 edition. At the 2014 championship in Canada, Nigeria topped a group involving Korea Republic, beating the Koreans 2-1 in a group phase match. France finished in third place in the same competition as Nigeria finished as runners-up.


"We hereby announce the departure of our Head Coach,

NNL actions resume on Saturday — Organisers

The Nigeria National League (NNL), the second-tier division of the federation's football leagues, will commence actions on Saturday, August 6, 2022, to conclude the remaining fixtures of the season.

These actions are scheduled in a four-week time frame for clubs in group B2 while other groups have a two weeks time frame.

In a 'circular 212', dated August 3, 2022, and signed by the Chief Operating Officer, Emmanuel Adesanya, the NNL clubs by the notice are expected to kickstart preparations.

While the NNL organisers want fairness and a hitch-free event, they admonish the State Football Associations to ensure they uphold the integrity of the league.

The circular read: "We convey to you the warm regards of the Chairman, Management and Staff of the Nigeria National League.

"We write to humbly inform you that Nigeria National League matches for the remaining 4 weeks in Group B2 and 2 weeks in other groups have been scheduled to commence on Saturday 6° August, 2022 at the various designated centers.

"All Nigeria National League Clubs are by this circular requested to commence preparations to honour their league fixtures accordingly.

"The hosts State Football Associations concerned are also requested to ensure that the integrity of NNI. League matches are not compromised.

"We regret the inconveniences our delay in resuming our league matches may have caused all clubs and stakeholders alike.

"While thanking you for your understanding, please accept our warmest sporting regards," the circular concluded.

Meanwhile, El Kanemi in group A1 presently top the table with 31 points, a point above Sokoto FC and City FC Abuja in second and third positions with 30 points.

In group A2, Doma United head the log with 36 points, 8 points above Jigawa Golden Stars, DMD FC and Malumfashi on 28 points to sit at the second, third and fourth places.

Also, Bendel Insurance have been in top form to dominate group B1 with 46 points edging out Gateway United from the top spot with a 10-point lead while in group B2, Bayelsa United though have the same 36 points as Crown FC, top the log with Warri Wolves trailing on 34 points.
