Tinubu, others push back against attacks on Muslim-Muslim ticket

s the July 15 window f o r

replacement of running mates lapsed at the weekend, the pr2esidential candidate of the All Progressives Congress (APC), Asiwaju Bola Tinubu stood by his choice of Kashim Shettima and said he refused to bow to any pressure to rescind his decision as a result of public outcry that greeted the choice.

The presidential candidate said he did not allow himself to be pressured or blackmailed into dropping Senator Kashim Shettima as his running mate.

Earlier, the spokesman of the Bola Tinubu Campaign Organisation, Bayo Onanuga said that the former Lagos State governor is an astute politician who takes responsibility for decisions taken.

"That not possible. There is nothing like that going on in our camp. We have seen this move before, all these campaigns to pitch us against fellow Nigerians. It happened in 1993, and the result was There was pressure from several quarters for (MKO) Ābiola to drop (Babagana) Kingibe because of his Muslim background.

"I pray people will come back to their senses to discover that what they should be looking at is not religion but competence of the candidate to deliver and take the country to a greater height" he added.

Also, the reaction that greeted the Muslim/ Muslim presidential ticket of APC is yet to abate as Christian bodies in the country have been castigated for rejecting the choice of Shettima.

Segun Awosanya, convener October 2020 #EndSARS nationwide protest criticized Nigerian Christians for raising dust over APC's choice of a Muslim presidential Muslim vice presidential candidate.

Awosanya was categorical in saying Nigerian Christians in particular and others who condemned APC's choice as being hypocritical.

Presenting the same faith ticket by APC should not be condemned "as long as they are capable of improving the security of the country, creating jobs and others.

"Our hypocrisy reached troubling heights but that to me is not a critical discussion as much as how we are going improve national security, create jobs, unite our people, improve our economy, devolve more powers to the states and eradicate poverty."

Awosanya posited that Nigerians should see the religious difference of the country beyond Christianity and Islam. He said those who belong to other beliefs are not oftentimes

considered in national matters.

"We have had Muslim-Christian ticket forever yet our issues persist. The sensitivities of popular belief are there but do that better the conversation equity in a country other religious beliefs are marginalized and deemed nonexistent?

"Sango, Osun, Ogun, Ifa, Obatala, Amadioha and other worshippers are out there within our secular state & yet we pretend our religious belief is binary? Again, in a country with women having almost an population, we don't see the need to Female inclusion in Government?"

M e a n w h i l e , following the selection of Shettima as Vice Presidential candidate, the APC has picked a former state Attorney General, Kaka Shehu Lawan as the party's candidate for the Borno Central Senatorial district.

The Former

Commissioner Justice scored votes out of 480 valid votes in the senatorial primaries. Declaring Lawan as the party"s choice, the returning officer and former Deputy Governor of Taraba State, Alhaji Uba Magari said, "having satisfied the provisions of the electoral law, by the authority vested on me by the National Chairman of our declared great, I that Bar Kaka Shehu Lawan, former Attornev General, has been validly elected as the APC candidate for Borno Central Senatorial seat," Accepting the party's offer, Lawan appreciated the state delegates for choosing him while urging them to mobilize eligible voters for the ongoing permanent voter registration exercise. He assured of quality representation the Senate even as he asked the people to always pray for their leaders. State Governor, Babagana Zulum also hailed Lawan's emergence adding that it was a 'divine' occurrence.



Ghana announces 15% wages rise to cushion inflation

Public workers in Ghana have a 15 per cent raise starting from July 2022 to reflect the current economic situation in the country, especially to cushion the effect of skyrocketing inflation that has beset it in recent years, which has greatly affected the general quality of living.

Ghanaian government signed the Cost of Living Allowance (COLA) agreement with the workers, in exchange for a stable workforce in the economically-troubled country, where cost of living has become a major problem.

Ghana Minister of Information, Kojo Oppong Nkrumah, said the decision was reached after consultations with the country's organised labour and other stakeholders, in a tweet on Friday, adding that the allowance took effect on July 1, the same day Ghana sought the support of the International Monetary Fund (IMF) for its economic crisis.

"Government and organised Labour have concluded negotiations for Cost of Living

Allowance. A 15 percent allowance has been agreed effective July 1. Government is keen on mitigating the impact of global challenges on the people of Ghana," he said in a tweet.

The government agreed that COLA would be paid at a rate of 15 percent of the base pay of public workers after negotiations between the government and organised labour concluded on Thursday 14 July.

Ghana is one of the low-income nations currently being crumbled by the effects of Covid-19 and the war between Russia and Ukraine.

Ghanaians crowded the streets of Accra last month in protest against rapid increase in energy costs and the newly imposed e-levy, which mandates them to pay a 1.5 percent tax for every electronic transaction they carry out.

In the 1980s, the Trumps were the ultimate power couple in New York before their equally public, and messy, divorce after Donald Trump met his next wife, Marla Maples. But in recent years, Ivana Trump had been on good terms with her former husband.

Delta CP orders DPO to produce man who allegedly defiled infant within 24 hours

Delta State Commissioner of Police (CP), Ali Mohammed Ari, has ordered the Divisional Police Officer (DPO) in charge of Oleh Police División in Isoko South Local Government Area. Supol Paul Oboware to produce a suspect, Mr Lawrence Emeriovo Edigheji, who allegedly defiled a six year old baby within 24 hours.

CP Ari confirmed that he has directed the DPO to transfer all those involved in the matter to the Deputy Commissioner of Police (DCP) in charge of State Criminal Investigation Department (SCID) at the Police Headquarters, Asaba.

"I also directed him to produce the suspect within 24 hours. I will not take such cases lightly. What is bad in the sight of men is also bad in the sight of God.

How can somebody with clear conscious defile such a little girl," he lamented

The victim (name withheld), was said to have been lured into the house of Lawrence, on Tuesday, July 5th 2022.

It was gathered that the little girl was bleeding, arousing the curiosity of a grown up girl who later learnt that it was Lawrence who defiled her.

The grown up girl was said to have alerted the father of the girl when he returned from the farm.

The little girl's mother is said to have died in 2019, making Lawrence who is said to be married with three kids to take advantage of the baby's motherless condition to defile her.

There is suspicion that Lawrence might have used the blood of the baby for rituals.

Meanwhile, the Oleh DPO on getting the information, put several calls across to the community chairman, Mr Moses Oruerighe Ogbogo to brief him on

the alleged defilement.

Mr Ogbogo was said to have ignored the DPO's phone calls.

It was gathered that the DPO was said to have learned that the DPO was said to have learned that the community chairman and others were allegedly making concerted efforts to resolve the matter at community level without

informing the police.

The DPO was said to have been irked by the chairman's blunt refusal to pick up his calls and sent him an invitation letter to report to his station on Wednesday, July 13, 2022, with the Vigilante members of the community and any other person involved on the issue, to defend themselves on an allegation of covering up the case.

Meanwhile, Lawrence the suspect is said to be on the run.
The vigilante members were

said to have failed to show up at the police station on Wednesday.

"The DPO had to order the

community chairman to bring all those involved - including the vigilante chairman, Mr Gideon Isara and his members to the station on Thursday," a reliable source at Araya disclosed.

It was further gathered that the DPO ordered detention of Isara and his men, while the community chairman was said to have escaped from the police

The DPO was also said to have disbanded the vigilantes of Araya with a view to inaugurating fresh members.

'Okowa owing both living and dead Delta retirees'

Retirees from primary schools in Delta State have accused Governor Ifeanyi Okowa of owing both the living and the dead of accrued retirement benefits.

The retirees yesterday staged a protest at the State's Government House, Asaba, demanding the payment of their gratuities. They stated that after 35 years of meritorious service to the state they were yet to be paid their gratuities seven years on the

Addressing the press on behalf of the retirees, their leader, Chief Mrs Eiieh C.E., said in spite of repeated promises during made meetings with a delegation the state government, Governor Okowa bluntly refused to honour his words and have left the retirees in the cold, choosing to pursue a Vice President of Nigeria ambition.

She lamented that in the face of public outcry to the governor to demonstrate a humane sense of leadership

on the matter, nothing tangible had been done even when it was clear that the resources to reduce the burden of debt owed retirees were available to the State Government. She pleaded with the state government to declare a state of emergency in the public primary schools retiree's gratuities payment matter and also ensure that the over N5.9 billion owed by some local councils in the state are duly remitted to the Bureau of Local Government that is in charge of the payment.

The protest which lasted for hours led to gridlock of vehicular movement along Anwai Road, Asaba where the Government House is situated. The road was completely blocked by the retirees who sat on the road demanding to see the governor face to face to explain why he derelicted on his statutory obligation to pay their gratuities.

The Chief of Staff to the Governor, Mr Festus Ovie Agas, who addressed the protesters on behalf of the state governor, pleaded with

the retirees for time assuring that the payment would be made.

Security operatives including the police and a detachment of soldiers failed in attempts to disperse the protesters as the senior citizens remained adamant on the road.

After a while, the retirees decided to return home but with a message delivered to Governor Okowa that they will be back next month to ask for the money if nothing tangible was done before then.

There is rising tension in Koluama Community in Southern Ijaw Local Government Area of Bayelsa State following the invasion and shut down of oil facilities being operated by Conoil Producing Limited by angry youths over alleged non-implementation of Memorandum of Understanding (MoU) with host communities.

The Trumpet gathered that the breached oil facility known as Ango 2 Field, operated by Conoil since 2013, has a crude oil production

capacity of over 30,000 barrels per day.

It was gathered that the aggrieved indigenes, including women, youths, and elders, caught security personnel stationed on the facilities unawares and invaded with placards with inscriptions some of which read "No MoU, No crude oil exploration", "Conoil pack, and go, we are tired of suffering" and "Koluama people are suffering", demanded the shutdown of operations at the facility.

The decision of the aggrieved community indigenes was also backed by the members of the Koluama Oil and Gas Committee., insisting that the oil multinational have failed in the implementation of the Memorandum of Understanding(MoU) by Conoil, which spelt out social obligations of the oil firm to its host communities. The Chairman of Koluama

Clan Oil and Gas Committee, Chief Jonathan Amabebe, who spoke with The Trumpet on the breached oil facilities, said some of the community's demands include, clean-up of oil spill sites in the various communities and carrying out medical outreach to communities affected by oil spill.

According to Amabebe, others are the issuance of employment letter to one of the community's qualified indigenes, who was successful in Conoil's last employment exercise in 2015 and the award of contracts across the five host communities, in Koluama Clan, namely, Tamazo, Koluama 1, Koluama 2, Olobia and Kalaweiama, embedded in the MoU amongst others.

speaking development, the Technical Assistant to Special Adviser to the Governor on Oil and Gas, Prince Tare Ekubo, said that despite several warnings from the community, intervention by government, meetings and letters sent to Conoil, to ensure that the relationship by both parties does not degenerate, the oil company has refused to implement decisions reached and as such the action from the community.

He, however, said the Bayelsa State Government will engage both parties to resolve the lingering issues once and for all.

NIMASA boost basic education in Taraba with teaching, learning equipment

"If we succeed in helping to ensure that some students improve academically, we would have made a difference.

"We appeal that the materials donated today be used judiciously to give the children the best,' Jamoh said.

Umahi said: "EXCO reviewed the unfortunate increase in the rate of rape in Ebonyi State and commended the office of Her Excellency, the Wife of the Governor and the Ministry of

Women Affairs and Social Development for a very beautiful job they are doing in the fight against rape in the state.

"EXCO directed that there should be no sacred cow in the enforcement of the Laws on Rape. EXCO directed that there should be urgent State campaigns against rape in public institutions including churches, schools, markets and other public places.

Journalists admonished to use Cybernetics, Robotics for news gathering

Journalists have been admonished to inculcate the use of cybernetics, artificial intelligence, and robotics in journalism practice. The admonition was given in a one-day seminar organized by the Department of Mass Communication, Bingham University, Karu, Nasarrawa State. The seminar brought together experts in cybersecurity, media practice and academia, who deliberated on the need to leverage on technology in the effective practice of journalism in Nigeria.

Mr Azubike Ishiekwene of the Leadership Newspapers reiterated the urgent need for media practitioners to leverage cybernetics and robotics in journalistic practice. He said connecting the dots has become imperative given artificial intelligence and robots are set to take over human jobs. He tasked media practitioners to brace up to the challenge and play active roles in this era and connect the twos in the service and craft of journalism.

A keynote address given by The NUJ Chairman, Mr Chris Isiguzo, on the role of the Media in deepening democracy described the media as the oxygen of democracy; since it helps shape the mindset, perception, and opinion of the people. In addition to monitoring governance and holding governments

accountable, the media avails the masses of the information required to make appropriate and meaningful choices. He decried the absence of regulations for the provision of a conducive environment and lack of protection for journalists.

A cybersecurity expert, Mr Aviele Timothy described journalism as both an art and science and admonished all to innovate. He said "Given the forthcoming 2023 elections, a clarion call has been made to all stakeholders in the Nigerian project to connect the dots of cybernetics, robotics, and journalism in ensuring a hitch-free and credible election in Nigeria. More still is the urgent need for improved security and economic recovery for the Nigerian nation"

Dr Desmond Okocha, Head of department, Mass communication of Bingham University reiterated the need for the Nigerian state to fine-tune who a journalist should be.

Goodwill messages and felicitations were sent to the mass communication department for taking the lead in organizing departmental lecture series and seminars where national and international scholars and media gurus bare their minds on the ever-dynamic trends and innovations in the media and communication world.

Ondo Police begin enforcement on spy number plates ban

Ondo State Commissioner of Police, CP Oyeyemi Adesoye Oyediran, has ordered the immediate enforcement of the ban and confiscation of any spy plate number in use within the state including the ones used for escort purposes.

This order was in compliance with the directives of the Inspector-General of Police, IGP Usman Alkali Baba on the total ban of the usage of spy plate numbers to curb the excesses of using the plate number to disregard and violate traffic rules and regulations and other extant laws.

In a statement by the Police Public Relations

Officer(PPRO) in the state, SP Odunlami Funmilayo, the Police and other security agencies in the Command also authorized the immediate seizure of spy plate numbers in use within the state.

The command directed vehicle owners to revert to their original registered number plates as well as cooperate with the police in the enforcement of the order. Oyediran further warned that the enforcement must be carried out with the utmost sense of diligence and professionalism.

In the same vein, policemen and personnel of other security agencies attached to VIPS are enjoined to ensure compliance to avoid being arrested for flouting the order.

crack team of anti-robbery police squad from the Abia State Police Command foiled an alleged attempt to rob an old-generation bank in Umuahia during the weekend.

Eyewitness accounts said that the operation was carried out by a four-member gang.

It was learned that the

armed men, on sighting the policemen, began to shoot sporadically as they made an attempt to escape.

They were said to have abandoned their red-colour Corolla car, with Reg. No: LND 126 HL, and escaped in another car reportedly snatched from an unsuspecting motorist.

The incident caused a serious stampede among residents and traders in the area, including passersby, who "ran helter-skelter"

for their lives. At the end of the gun duel between the police and robbery suspects, three persons, including a policeman at the bank, sustained bullet wounds.

The victims were immediately rushed to a nearby Federal Medical Centre for medical attention.

Meanwhile, residents of the capital city, who were jolted by the incident, have appealed to the Governor of the state. Okezie Ikpeazu

Five top UK PM contenders to face off in TV Debate

five remaining candidates in the UK Conservative leadership race are preparing to go head-to-head in the first of three live TV debates on Friday.

Arms proliferation's major cause of insecurity in Nigeria — NSA • Tasks CSOs to collaborate with govt to tackle menace

The National Security Adviser (NSA), Maj-Gen Babagana Monguno (Rtd) has said the proliferation of small arms and light weapons is a major cause of the alarming upsurge in insecurity and criminal activities in the country.

The NSA stated this Thursday while presenting a keynote address at a one-day interactive session with relevant Civil Society Organizations (CSOs) at the Nigerian Army Resource Centre in Abuja.

The event with the theme 'Harnessing the Capacities of the Civil Society Towards Promoting an Illicit Armsfree Society in Nigeria', was organized by the National Centre for Control of Small Arms and Light Weapons (NCCSALW) to fashion a roadmap towards the eradication of illicit firearms in the hands of unauthorized persons.

Gen Monguno, who was represented by his Special Assistant on Special Duties, Amb Ahmed Muhammed, said the event was part of many multilateral engagements that the government

intended to carry out with CSOs, NGOs, Religious Organizations, Community Leaders, and youth groups.

He said the effort is geared towards the security of the country against illicit Small Arms and Light Weapons as well as its devastating effects, which according to him, have been issues of serious concern to West African countries and the global community.

"Rather, it is the easy access to them and the simplicity of their use that make violence more lethal and conflicts more

"Therefore, SALW have become weapons of choice for criminals, terrorists and bandits in Nigeria and beyond, posing a significant challenge to the country, especially in the wake of insecurity that has recently engulfed the Sahel Region.

"Hence the need to stop the proliferation of these deadly weapons," the NSA stated.

He further stated no emphasis is required to know that the uncontrolled availability of small arms and light weapons, especially the illicit ones, have continued to undermine global peace and significantly hinder development.

Monguno attributed the suffering in the society to the threat and the use of illicit firearms in circulation in the country. He, however, stated that it is important to emphasise that these weapons themselves do not cause conflict.

He said it was against the backdrop of the proliferation of weapons and its attendant consequences that President Muhammadu Buhari authorised the establishment of the Centre to tackle the menace following global standards.

According to him, President Muhammadu Buhari has further demonstrated Nigeria's commitment to the provisions of Article 24 of the ECOWAS Convention on Small Arms and Light Weapons.

"Which requires each member state to establish national institutions to promote a multilateral approach to stamping out illicit arms trade in the Sub-region.

"The effort towards eradicating illicit arms globally is one that has involved all

stakeholders including the international and regional community, nations, states and most importantly, the civil society.

'In spite of our best efforts, it has become apparent that West Africa and indeed the global community are losing the war to transnational organised criminal networks, terrorist groups, domestic criminal elements and weapons manufacturers," Monguno said.

He further disclosed that numerous studies conducted by Small Arms Survey, OXFAM and SBM Intelligence suggested that Nigeria currently accounts for about 60 to 70 per cent of the 10 million illicit weapons believed to be in West Africa.


According to him, this has already manifested as evidenced in the level of armed violence witnessed across Nigeria.

Monguno, therefore, called for the support of CSOs for the government's avowed commitment to rid the society of illicit weapons.

He commended the Centre for its efforts in ridding the nation of illicit small arms and light weapons.



Wike, PDP and 2023

or former Vice President and presidential candidate of the Peoples Democratic Party, (PDP) in the 2023 general election, Alhaji Atiku Abubakar, if there were to be reincarnation, he would not wish to contend with even a shadow that has a resemblance with that of Nyesom Wike, governor of Rivers State.

The former vice president and many PDP faithful obviously believed that having emerged victorious from the hotly contested presidential primaries; the only hurdle left for the party and their flag bearer is the presidential election proper.

Little did they know that the party would be thrown into a quagmire that has the potential of polarizing the opposition party and rob it of the much needed cohesion and virility to confront the ruling APC at the polls next February.

Top echelons in the PDP in their wisdom considered and nominated the Rivers governor, Wike to pair Atiku as running mate for the battle of the presidential election. But Atiku for whatever strange reasons rather saw Wike as a liability other than the asset he was meant to be for the success of the party at the polls next year.

The Turakin Adamawa (Atiku) unilaterally (even against the principles of the opposition party) snubbed Wike and went for Governor Ifeanyi Okowa of Delta State as his running mate whom he perhaps perceived would be more pliable.

Atiku must have underestimated the rising political profile and influence of Governor Wike, even when he had no reasons to do so. And since that faux pas by the former Vice president, the

umbrella of the PDP has been riddled with embarrassing holes.

Some analysts say Atiku ought to have known better than Wike is not that small fry that could be squeezed easily by the ball of the thumb taking into cognizance the governor's antecedents in the PDP and national politics.

Wike almost single handedly put together the immediate past national leadership of PDP led by Prince Uche Secondus who invariably was Wike's Man Friday then.

In 2018 when PDP was planning its national convention and sought to move the venue of the convention from Port Harcourt to Abuja, Wike had roared like a lion and threatened dire consequences against the party should the venue be moved out of Port Harcourt. The party quickly rescinded the plan and stuck to Port Harcourt venue as earlier agreed.

It is on record how Wike fought at the convention to ensure that his friend and governor of Sokoto State, Alhaji Aminu Tambuwal emerge as the flag bearer, but Atiku eventually carried the day after much dollar rain.

In this year's PDP convention held in May, Wike also caused much stir in the polity as he traversed the length and breadth of the country ahead of the convention seeking the support of delegates. But for the last minute withdrawal of Tambuwal from the race on the convention ground and the joker of asking his supporters to support Atiku, Wike would have shocked even Atiku with all the vaunted connections and influence of the former Vice president.

Is Atiku piqued by the tough challenge Wike had given him over time that he felt the governor does not deserve such

position and recognition alongside him? Some analysts say Atiku by turning down the recommendation of Wike as running mate has lost the services of a "bulldozer and swamp bogie" that would have cleared every stump and obstacle on the way to Aso Rock in 2023 for the PDP.

Interestingly, since Atiku sought to stifle the glowing light of Wike politically, the reverberations have been deafening within the polity and in PDP in particular. And as it appears, the PDP is now in a quandary on how to handle the reverberations, while Wike the supposed victim is gleefully enjoying the unfolding drama.

Today, Wike has become unarguably the most sought after politician in the country, even more attractive than the presidential candidates that emerged in the recently conducted primaries, Atiku inclusive.

Thus it is confounding according to some analysts why Atiku would not see the sterling qualities Wike possesses that other politicians are falling over themselves to court such that politicians from all walks of life in Nigeria are streaming down to Port Harcourt to consult the Rivers governor.

Wike is now being addressed in different colourful appellations - the beautiful bride, political colossus, avant-garde, political juggernaut, just name them and fuelled mainly on account of the blunder by Atiku who many before now thought is a political strategist.

Although many politicians have been visiting Rivers State since the end of the PDP primaries, mostly PDP henchmen, the frequency became intense since Atiku turned down the choice of Wike as running mate. However, what caused strong ripples was the last Friday visit of three serving governors on the platform of the ruling All Progressive Congress, (APC), namely, Sanwo Olu of Lagos State, Kayode Fayemi of Ekiti State and Rotimi Akeredolu of Ondo State.

Even as the content of their discussion in their closed door meeting were not made public, it is obvious that the meeting was aimed at coaxing Wike to swing his support towards the APC, in particular to the Presidential project of Asiwaju Bola Tinubu in line with the demands of the Southern governors that the presidency should return to southern Nigeria in 2023.

Wike's continued silence after each meeting with different political interests is not helping matters for the PDP as it has always left the party more confused on how to approach the governor, some

So the one million dollar question is, will Wike leave the PDP or stay and fight within? Does the governor who has professed so much love for the PDP have such tendency? Or has he been so provoked or maltreated that his anger is now tipping over such that anything is possible now?

What is Wike just up to that the leadership of PDP are all holed up at Wadatta Plaza headquarters of the party in Abuja looking forlorn towards Port Harcourt like a child whose mother went to the market without keeping lunch for him and the day wearing down to evening?

Is Wike really the oxygen of PDP? If the governor refuses all entreaties to be appeased, would it be nunc dimitis for Atiku and his 2023 ambition?

Political pundits are eagerly waiting to see how the PDP will handle this seeming delicate situation and come out unscathed.

The statement reads in part: "Our attention has been drawn to some conflicting stories propagated in some quarters which bothered on the followings: The paternity of our revered king, His Imperial Majesty, Rich Arisco Osemwengie JP, OOS, the current 24th Ogiamien of Benin, (Utantan) Kingdom, Benin City, Edo South, Igodomigodo land of Edo State. The Whereabouts of Ogiamien Osarobo Okuonghae and The Mode of Succession of Ogiamien Royal Stool."

Wehere said the press conference was called to put the records straight;

"The Great Ogiamien Royal Stool and the Great Ogiamien Royal Palace predated the colonial administration that gazetted the Great Ogiamien Royal Stool and the Great Ogiamien Royal Palace as National Monuments

"It will interest you to know that this is the only Royal Palace gazetted by the Colonial Masters, which they handed over to the Federal Government during independence in 1960. The OGIAMIEN stool/Ogiamien Palace was also recognized by UNESCO contrary to the beliefs that the Oba of Benin Palace was also a national monument, which is not true due to the Armageddon that befalls the palace in the 1897 invasion.

"In addition, the Great Ogiamien Royal Stool is recognized in the Midwestern State of Nigeria Gazette No 59 Vol. 5 and M. S. L. N. No 37 dated 7th day of November 1968 tied to the Constitution of the Federal Republic of Nigeria, Constitution (Suspension and Modification) Decree, 1966 Chiefs Law (CAP 19), which is also protected by Part V Sections 38 and 39 of the Bendel State Traditional Rulers and Chief Edict of 1979. The Appeal Court judgment by Justice Jimi Olukayode Baba of Appeal Court in the Appeal Case No: CA/B/99/2016 also confirmed that the Great Ogiamien Royal stool is a

recognized instrument. Hear Justice Jimi Olukayode Baba of Appeal Court sitting in Benin City, Edo State.

"It is my humble view that the Ogiamien of Benin Chieftaincy is one of the recognized instruments (M.S.L.N 37 of 1968) (See page 37 of the Judgment delivered by Jimi Olukayode Bada, JCA) dated Wednesday, 16th day of November 2016 in Benin City, Edo State.

"The issue of paternity, His Imperial Majesty, Rich Arisco Osemwengie JP, OOS, the current 24th Ogiamien of Benin (Utantan), Kingdom, Benin City, Edo South, Igodomigodo land of Edo State is a direct scion of the Great Ogiamien Royal Dynasty. His biological father, late Prince Daniel Osemwengie Orumwense, is the direct male child of late Prince Orumwense Ogienor; late Prince Orumwense Ogienor is the direct male child of Prince Ogienor Ekunwe; while late Prince Ogienor Ekunwe is the direct male child of Ogiamien Okhuanhenzuwa.

"The aspect of maternity, Ogiamien Rich Ariscos, mother late Mrs Victoria Aimwenyeke Iroegbetin Osemwengie (Nee Ediagbonya Osawe) of Ilobi Village in Uhunmwonde LGA of Edo State hails from the family of Iyase of Udo in Ovia South West LGA of Edo State.

"It is on record that the Oba of Benin known as Oba Eweka, the First and the area known as the Benin Kingdom was leased to them by Ogiso/Ogiamien Erebo via the

Memorable Ekiokpagha Treaty in 12:00AD."

On the whereabouts of Ogiamien Osarobo Okounghae, Wehere said, when it became evident that Okuonghae was missing, we wrote to the then Commissioner of Police, Edo State to alert them of the missing Ogiamien.

"On Tuesday, 6th August 2015, the then PPRO of the Edo State Police Command, DSP Stephen Onwecheo, published a Police Press Release about the missing Ogiamien Osarobo Okuonghae.

"But in a swift reaction, the Benin Traditional Council published a rejoinder on Saturday, 8th August 2015, signed by the secretary, Mr Frank Irabor, querying the use of HRM for Ogiamien Osarobo Okuonghae instead of condoling with the bereaved families.

The Benin Traditional Council did not send a formal condolence message till this very moment, but they kept saying that Ogiamien Osarobo Okounghae is alive even when the Police appealed to any person with useful information about his whereabouts to come forward and contact the nearest Police station or the family, then the question now is this, since the BTC know the whereabouts of Ogiamien Osarobo Okuonghae, they should please go to the police and give them the information and stop raising unnecessary dust about the whereabouts of Ogiamien Osarobo Okuonghae. After all the preliminary investigations we have done so far and based on the recent press conference of Iyase of Benin thus indicates that they are behind the disappearance of Ogiamien Osarobo Okuonghae, all these dramas are to circumvent the Ekiokpagha Treaty to further reenact their dominance in the state."

Wehere noted that since there is no vacuum in nature, after following the traditional due process, we installed Prince Rich Arisco Osemwengie JP, OOS, as the 24th Ogiamien of Benin (Utantan) in accordance with our native laws and custom.

"On the mode of selecting a new Ogiamien whenever there is a vacuum, note, the Ogiamien Royal Stool is not only hereditary by Primogeniture but through ruling houses.

"What is today known as Ogiamien Royal Stool came into existence in the 9th Century AD. At inception, it was known as Ogiso Royal Stool. The first occupant was Pa Idu Ogiso the progenitor of Igodomigodo. He was known as Ogiso Igodo.

"From the Era of Ogiso Igodo to the present era, the Ogiso Royal Stool has passed through 4 different traditional transitions namely:

"The Era of Primogeniture; The Era of Gerontocracy; The Era of Second Son and The Era of Grand Son.

"Historically speaking, the Ogiamien Royal Stool traditionally has been moving from one Ruling House to the other. The way the ancestors designed the transition, it is therefore difficult for anyone Ruling House to lay absolute claim to the Stool.

"It is therefore misleading to say that the Ogiamien Royal Stool is ONLY hereditary by primogeniture.

"For record purposes, the Ogiamien Stool can be inherited by any direct male child from any of the Ruling Houses.

"We know the Ruling Houses." At the appropriate time, we shall publish the list of the Ruling Houses indicating details of the Family Tree. The Ruling Houses are in the Family Tree. Any time there is a vacuum or vacancy, we use our internal traditional mechanism to fill the vacuum.

"Every transition is unique. The prevailing circumstances always determine who should be installed as Ogiamien hence the various modes of transition: Primogeniture, Gerontocracy, Second Son, and Grandson. But the truth however is that only direct Male Children are qualified to sit on the throne of Ogiamien of Benin (Utantan) stool.

Wehere added that, recently, the Chief and Enigies under the Benin Traditional Council requested that the OGIAMIEN should tender an apology in three national newspapers for an offence we don't know anything about. We find such requests appalling and outlandish. He concluded.

Details of my private meeting with President Buhari-Oluwo of Iwo

The charismatic Oluwo of Iwo Land, Oba Abdul-Rasheed Adewale Akanbi, Telu -1, is one controversial traditional ruler that means so many things to so many people in Yoruba land. He is one of the first class Traditional Rulers in the state, he is known to take on any first-class traditional ruler, who dares mess around with him.

Whatever people's opinion about him, good or bad, the Oluwo of the Iwo Kingdom is never perturbed. He believes strongly in himself and is pushed by his personal beliefs and conviction.

Trumpet Palace Watch recently encountered him, and a range of issues were discussed. It is our pleasure to lead our readers into the heart of these exclusive discussions.

Trumpet: Sometimes ago, you were accused of taking sides with the Fulanis, who most people accused of invading the bushes and forest in the South West. Why the accusation?

Oluwo: I'm not surprised that people will just sit in their comfort zones and begin to insinuate and make so many unfounded accusations. But as a firstclass traditional ruler, I'm used to such accusations by now.

Anyhow, what transpired is that, at the height of the raging controversies about Fulani's invasion of our farms, and our immediate environment as a traditional ruler, I decided to carefully study the situation. From my careful study of things, I discovered, yes, some Fulani herders, who are long known for cattle trading and rearing for centuries in this part of the country, were indeed in some of our bushes. But they were just minding their businesses. In the same breath, my findings also showed that a large number of armed mercenaries from Libya, Guinea, Cameroon and Niger, were also all over our forest. These mercenaries were indeed and are still causing a lot of trouble in and around the South West Region as we speak.

I, therefore, seek a private audience with Mr Mrsident Muhammadu Buhari and brief him in detail on what I discovered and what is happening around us in the South West. I also seized the opportunity to advise the President on what I think should be done, to separate our local Fulani herders, who have lived with us for several centuries from these dangerous elements, who are trying to cause trouble in our lands and country.

From my findings, we discovered that these foreign marauders were in the habit of killing and rustling the cows of our indigenous Fulanis. Oftentimes, they use these cows they stole as a decor to commit more heinous crimes in the

I made no pretence in telling the President that pasturing is part of the daily life of our indigenous Fulanis. And for them to embrace modern ranching techniques, they need to be trained and taught what to do with regard to modern ranching. And as such, special national economic provisions should be made to accommodate the kind of training that will benefit them. As this is the only way, our indigenous Fulanis who are used to pasturing can gradually transit from the present crude methods of rearing cows to embrace modern day ranching. I, therefore, suggested that some

of them should be taken outside the country to places like South Africa and the Netherlands for training on ranching.

Trumpet: Kabiyesi, traditional rulers are supposed to be apolitical. What informed your open endorsement of Governor Adegboyega Oyetola for a second term as the Governor of Osun

Oluwo: Endorsing Governor Oyetola for a second term as the Governor of our State Osun, doesn't make me partisan in any way. I'm a traditional ruler, who must at all times look out for the interest of my people.

Moreover, it is not just and proper, to just wake up one day, and change a man who has been performing and doing an excellent job as a governor, just because some people want him out of office. Why most people are after Governor Oyetola's chair, is because unlike other governors in other states of the federation, he is not a noisemaker. He does his things quietly without making noise about them and moves on to other projects. For example, Governor Oyetola had done several roads quietly without any fanfare, as some State Governors are known for. The Iwo-Oshogbo Road, Alliece Osun - Oyo Road and within the four years of his first tenure constructed one of the fly-over bridges in Oshogbo, all these projects he initiated and completed without making

For example, Osun state is largely a civil servant state, since he assumed office, he has consistently made sure that all the civil servants in the state are paid their salaries as at when due. Pensioners also are not own a dime within this period in question.

Moreover, I am looking out for the Osun West Senatorial zone interest as it concerns our present and future interest. This I make no pretence about and also have no apology about. If you

must know, Senator Adeleke, the P.D.P candidate in the July 16th Governorship election is from Ede. He is also from this Senatorial zone just like Iwo, my domain. If he wins the Osun State Governorship election, that means my desire for an Iwo indigene to emerge as the next Governor of Osun State, will evaporate into the thin air. As expected from a traditional ruler, who loves his people and wants the very best for his people, I am expected to go where my heart is. If people like it, let them call it selfishness. I don't see what is wrong with what I am doing.

Trumpet: What could be the possible reason(s) for the sharp disagreement between the immediate past Governor Rauf Aregbeshola, who is now the Minister of Interior and Governor Oyetola?

Oluwo: I don't know what caused their disagreement. You know politicians, they can never be predicted they always go where their bread is buttered.

FG moves to mop up small arms, light weapons, engages CSOs

he Federal Government through the National Centre for Control of Small Arms and Light Weapons (NCCSALW) has vowed to mop up illicit weapons in the hands of unauthorised persons across the country as part of its efforts to address growing insecurity.

National Coordinator of NCCSALW, Maj-Gen AM Dikko (Rtd), stated this in a one-day interactive session with the theme 'Harnessing the Capacities of the Civil Society Towards Promoting an Illicit Arms-free Society in Nigeria', which was held at the Nigerian Army Resource Centre in Abuja on Thursday.

Dikko, Gen while Society welcoming Civil (CSOs), Organizations which were carefully drawn from the six geo-political zones of the country said, the government is determined partner with critical stakeholders to mop up and destroy all illicit small arms and light weapons currently in circulation as well as stop the proliferation and local manufacturing of such weapons.

He further stated that the proliferation of small and illicit firearms has negatively impacted the peace, security, and economic development of Nigeria while noting that the Centre has established Zonal Offices in each region in a bid to decentralize its operations by directly engaging stakeholders at the grassroots.

"The NCCSALW was established in May 2021 as part of a wider national response to the escalating menace of illicit arms and light weapons in the country and the sub-region. There is no gainsaying the fact that the proliferation of small arms and light weapons has negatively impacted the peace, security, and socioeconomic well-being of our dear nation.

"In the last two decades, it has remained a key driver for terrorism, ethnoreligious crisis, violence, and sundry organized criminal activities within and across our borders," he said.

According to him, Nigeria has borne the brunt of insecurity in the Sahel Region as a result of arms trafficking and proliferation. He, however, added that the government is tackling the challenges.

"Consequently, Nigeria has closed ranks with our neighbours, the ECOWAS, and other International Stakeholders over the years to eradicate illicit small arms and light weapons in the hands of unauthorized

"Even though the progress made in this area has been the subject of debate, Nigeria has continued to tackle the challenge head-on.

"I am delighted to say that since its establishment, the Centre has made giant strides within the short time frame to achieve full operationalization. Of note is the establishment of regional offices in the six geopolitical zones of Nigeria.

"The operationalization of the Centre has focused on discharging its core functions of providing a strategic platform for arms control in Nigeria through close partnership with stakeholders, especially Civil Society both local and internationally.

"The mopping up of these weapons will remain a continuous exercise until our security space is free of the menace of illicit small arms and light weapons," he added.

The CSOs, which were grouped into six focused groups in accordance with the region of operations, interfaced with the Zonal Coordinators and proffered actionable solutions to arms proliferation based on the peculiarities in each of the zones.

Insecurity has in the last two decades constituted a major challenge to the advancement of the country with far-reaching implications on the safety of lives and properties, socio-economic wellbeing of citizens, development, and growth as well as peaceful coexistence among various interest groups.

While Boko Haram and Islamic State West Africa Province (ISWAP) terrorize the Northeast, banditry, and kidnapping for ransom dominate the Northwest. In North Central, religious extremism and herders/ farmers clashes have been the order of the day.

Meanwhile, the rise separatist ritual groups, killings, herders/farmers clashes, and kidnapping among others unsettle the Southwest Southeast and while militancy, kidnapping, cultism, armed robbery as well as crude oil theft reign over the South-South region.

These security challenges and more are fuelled and sustained by the small arms and light weapons in the hands of outlawed groups, disgruntled elements, organised criminals, political thugs, and other unauthorised persons. Hence, the urgent need for mopping up small arms and light weapons to restore peace to the country.

Six terrorist leaders, 3,858 terrorists, families surrender to troops

The Defence Headquarters has stated that six top terrorist commanders have surrendered to the troops of Hadin Kai operating in the Northeast.

This was disclosed by the Director of Defence Media Operations, Maj-Gen Benard Onyeuko, on Thursday in a press briefing held at the Defence Headquarters, Abuja.

According to Gen Onyeuko, the terrorists surrendered on Wednesday at Gwoza. He gave their names as Mallam Mala Hassan (WALI), Ali Madagali (MUNZUR), Musa Bashir (CHIEF ANUR), Buba Dahiru (MUNZUR), Jafar Hamma (KAID) and Abbali NAKIB Polisawa while noting that this was the first time that such high calibre of Commanders were surrendering

surrendering.

He further stated that about 3,858 Boko Haram terrorists and their families also surrendered to troops between 1 – 14 July 2022.

"Ålso, about 3,858 Boko Haram Terrorists and their families surrendered between 1 - 14 July 2022, comprising 505 males, 1,042 Females and 2,311 children.

"Furthermore, in the theatre, troops neutralized several Boko Haram/Islamic State of West African Province terrorists within the period under review at different encounters at Gamage village in Dikwa Local Government Area, Dikwa - Gambora Ngala road, Pulka – Gwale road in Borno State among others.

"Several terrorists logistics suppliers/collaborators arrested with various items at various logistics towns within the theatre. Among them were two women namely; Hauwa Gambo and Khadija Dirsa," the General said.

Also, the Air Component of Operation Hadin Kai was said to have conducted air interdiction operations at Tumbum Jaki and Tumbum Murhu near Lake Chad in Borno State on the receipt of intelligence report on the activities of the insurgents in the general

Onyeuko said the operation led to the death of about 21 terrorists.

Meanwhile, troops of Hadarin Daji neutralized two terrorists and recovered weapons at Sambo village in Dandume Local Government Area Katsina State. More so, one Mallam Sani Umar Wara, who was serving at Zuru Correctional Centre but was kidnapped at Kofar Gabas town in Shinkafi LGA on 2 July 2022 was rescued by troops at Maberiya Village in Shinkafi LGA of Zamfara

In the South-South region, troops discovered and destroyed 109 illegal refining sites, 34 wooden boats, 150 storage tanks, 119 ovens,

and 104 dugout pits.

"Cumulatively, within the period under review troops recovered 27 pumping machines, 1 weapon, 1-speed boat, 13 vehicles, 7 outboard engines, Four Million Three Hundred Thirty-Nine Thousand (4,339,000) litres of crude oil, Two Million Fifty-One Thousand (2,051,000) litres of AGO and Thirty Thousand (30,000) litres of DPK," Onyeuko said.

He added that 24 economic saboteurs were also arrested by the troops within the same period.

was gathered that Τt after the Administrative Secretary in Enugu State, Jude Okwuonu Mr reported the incident to Headquarters, Commission decided suspend the Continuous Voter Registration (CVR) exercise in the affected area.

The gunmen fired

sporadically into the air to disperse registrants and registration officials. In the ensuing stampede, one of our staff sustained injuries and is receiving treatment in a hospital," the statement read.

"Two voter registration machines and personal items of the staff such as mobile phones were lost. Consequently, Ward level registration of voters in Igboeze North is hereby suspended," it added.

According to Okoye, the Commission has reported the incident to the police authorities in Enugu State to commence an investigation.

Osun Election: NSCDC deploys 11,226 personnel to enhance security

The Nigeria Security and Civil Defence Corps (NSCDC) has deployed no fewer than 11,226 personnel to provide security during the conduct of the Osun State gubernatorial elections scheduled to hold on Saturday.

Commandant General of the Corps, Dr Ahmed Audi, while approving the deployment of the officers said they shall man the 3,763 polling units in the state, collation centres, flashpoints and critical infrastructures in all 31 Local Government Area.

NSCDC's Director of Public Relations, DCC Olusola Odumosu, disclosed this in a statement on Monday while noting that the officers were drawn from the National Headquarters and nine State Commands of Osun, Ondo, Ekiti, Oyo, Ogun, Lagos, Kwara, Kogi and Edo.

Odumosu further disclosed that the operatives have been exposed to the Rules of Engagement as provided for in the Electoral Act.

According to him, Deputy Commandant General (DCG) in charge of Operations, Dauda Mungadi is to oversee the election exercise while Assistant Commandant General (ACG) Operations, Philip Ayuba, Zonal Commander (Zone J), Fasiu Adeyinka and Commandant

Special Duties, Oliver Ugwuja are deployed as field Commanders monitoring each senatorial district of the state.

He said, "The CG stated that the objectives of the Corps in the forthcoming election is to create a secured environment for its successful conduct and enhance the general security in the State before, during and after the election.

"He explained that personnel had attended various workshops on best practices during elections.

practices during elections.

"They have also been acquainted with the provisions of the Electoral Act as regards Rules of Engagement, hence, must comply with the Corps' Operational Code, Standard

Operating Procedure and above all, display of professionalism and high sense of discipline throughout the election.

"This robust operational order has been activated to ensure a hitch-free exercise and guide against molestation and intimidation of the electorates by hoodlums or party thugs.

"Dr Audi hinted that in readiness for the election, the Corps' undercover personnel from the National Headquarters have joined their counterparts in Osun State for covert operations to nip any security compromise in the

He stressed that the Antvandalism Squad, Critical National Asset protection unit and other special forces were specifically deployed to all key points in the State to protect critical assets of government against the activities of vandals and other criminal elements before, during and after the election

More so, a pool of officers drawn from Special Forces, such as the Arms Squad Unit, Counter Terrorism Unit (CTU), Chemical Biological Radiological Nuclear and Explosives Unit (CBRNE), the Special Female Squad, Rapid Response Squad, K9 and SWAT Unit, which are different from the regular conventional personnel, were part of those deployed.

Decay in federal government teaching hospitals

he decay in federal government Teaching Hospitals has reached an embarrassing crescendo, yet government officials are more concerned with lining their pockets with stolen funds and politicking against 2023. Recently at the University of Port Harcourt Teaching Hospital, 42 babies died because of lack of incubators at the medical facility. This is tragic, criminal, actionable, and unacceptable.

Across the world, responsible governments take their healthcare sector seriously because it safeguards people's lives against unforeseen, inevitable health challenges. No country in the world can do without a functional healthcare system. Some countries like India, Switzerland, and UK, depend on their sophisticated healthcare system to attract foreign exchange and boost their economy. Obviously, it is not the case in Nigeria given that over the years, the Nigerian healthcare system has gradually decayed and continues to slide into an empty shell of what it used to be. It is either because successive governments in Nigeria are not interested in developing the health sector or there is an inherent negative mechanism that does not allow the health sector to develop.

In Nigeria, federal government teaching hospitals share structural and administrative proximity with federal government owned universities' Colleges of Medicine. In such an arrangement, medical lecturers function as consultants to the teaching hospitals. Given the foregoing scenario, one would expect that the teaching hospitals will be the best in the country in terms of manpower, professionalism, availability of modern medical equipment, research, and output. Unfortunately, the opposite has been the case. Our teaching hospitals, like most infrastructure in the country, are in complete disrepair. They are an eyesore: not fit to be called a clinic by any standard. It is inconceivable that a university teaching hospital in the 21st century will lack basic equipment like incubators.

There are many reasons for the decay in | class and politicians troop to for health issues. the teaching hospitals. One is their obvious neglect by government officials because they all travel abroad for Medicare with their families. In the early seventies in Nigeria, the University College Hospital (UCH) Ibadan was adjudged the best in the whole Commonwealth region. Also, it is on record that former military Head of State General Yakubu Gowon used to visit Lagos University Teaching Hospital for treatment with members of his family. His wife had her first child at LUTH. But today, due to the decay in the teaching hospitals, government officials do not visit them, preferring to visit medical facilities abroad. Thomas Hospital is a public hospital in London where the Nigerian ruling


Last year, the hospital spent about \$2.4bn on patient care, an amount more than twice the federal government's budget for healthcare.

Incessant strikes by doctors in the country to protest poor working conditions and low salaries is part of the decay in federal government teaching hospitals. Doctors and other health workers should be handsomely remunerated to give their best and remain in the country. It is no longer news that many Nigerian doctors migrate to different parts of the world where they excel. In New York alone, it is reported that there are over 4,000 Nigerian medical doctors. Ironically, when the ruling class travels abroad for Medicare, they are treated by their fellow citizens who left the country due to poor conditions of service and remuneration.

Also, the federal government should as a matter of urgency commit more funds to all the teaching hospitals to upgrade facilities, provide electricity and other necessary materials needed for effective delivery of medical services. A situation where patients in a teaching hospital are required to pay 1,000 naira every day as reported at UCH for the provision of diesel to power generating sets for electricity is condemnable.

Henceforth, public servants should not be allowed to travel abroad for Medicare. If such a law is put in place, perhaps, the federal government will be forced to fund and upgrade existing teaching hospitals. Perhaps this is the solution that can reverse the decay in the health sector. If the president, senate president, senators, members of the House of Representatives, governors, senior civil servants and many other public officials are forced to patronize our teaching hospitals, it will force the government to upgrade the institutions to acceptable, international levels. A country with a sick healthcare system is a sick country. Nigeria cannot continue to be sick on all fronts.

Restful Prosperity in God's Promised Location

ne of the assurances and promises of God to his chosen is prosperity, but one that is accompanied with rest. There are many wealthy people who do not have rest, rightly called 'peace of mind,' in our common parlance. Their wealth is accompanied with battles, anxiety and fears. They battle with their neighbour and community, with their health and immediate families. They cannot live without human security around them. They feel hate all around their environment. And so they find it difficult to truly appraise themselves as wealthy and happy. God desires rest for us both here and in eternity. This is explicit in both the OT and the NT.

In Genesis 49:15, Jacob spoke, "Issachar is a strong donkey, lying down between two burdens; he saw that rest was good, and that the land was pleasant, he bowed his shoulder to bear a burden and became a band of slave." For whatever it was worth, a good rest and land made Issachar to commit his life to slavery. Sadly, many are in this situation. Sabbath Day is not only a day of worship, it is also a day God separated for rest (Exodus 34:21). It is in fact called 'solemn rest' (Leviticus 23:3). Rest is a promise given by God as part of His covenant obligation to His people. "My presence will go with you and I will give you rest" (Exodus 33:14).

Rest signifies the presence of God. Wherever He allows His altar to be built enjoys divine rest. In Numbers 10:33-36, the account of the departure of the Israelites from Sanai was given, and it reads: "So they set out from the mount of the Lord three days' journey. And the ark of the covenant of the Lord went before them three days journey to seek out a resting place for them. And the cloud of the Lord was over them by day, whenever they set out from the camp." Many are so quick to run to locations where they can find prosperity without bothering about their 'solemn rest.' God desires a promised land of rest as well as a land of milk and honey for His people. The case of Isaac is instructive.

It is only in the location God has assigned that anyone can be very restfully prosperous. His promise is always supported by His rest. God's rest is also His peace which passes all understanding. "Ând He said to me, My grace is sufficient for you, for My strength is made perfect in weakness. Therefore most gladly, I will rather boast in my infirmities, that the power of Christ may rest upon me. Therefore, I take pleasure in infirmities, in reproaches, in needs, in persecution, in distress, for Christ sake. For when I am weak I am strong" (2 Corinthians 12:9-10). The concluding part of the foregoing verses is to assert that our rest and peace in this world lie in God through Christ once we are where He has assigned us to be.

It is only unbelievers that do not enjoy the rest of God (Psalm 95:11; Heb 3:11). And in Hebrew 4:1-3ff, 9), "Therefore since a promise remains of entering His rest, let us fear lest any of you seem to have come short of it. For indeed the gospel was preached to us as to them; but the word which they heard did not profit them, not

being mixed with faith in those who heard it. For we who have believed do enter that rest, as He has said, 'so I swore in My wrath they shall not enter My rest."

The true prosperity of Isaac was found in God's place of rest. In all the other locations where Isaac dug wells, he did not see the face or presence of God. But God appeared to Isaac in Beersheba! "And the Lord appeared to him the same night and said, "I am the God of your father Abraham; do not fear, for I am with you. I will bless you and multiply your descendants for My servant Abraham's sake." The Bible goes go to list four things Isaac did immediately. They are: "So (i) he built an altar there and (ii) call the name of the Lord, and (iii) he pitched his tent there, and (iv) there Isaac's servants dug a well" (Genesis 26:23-25).

The four things Isaac did at Beersheba

signified that he had found rest both with himself and his God. He did not go down to Egypt, he was no longer living with the Philistines, and he was no longer at Gerar. He had established a relationship with God; and only at a location approved by God Himself. Our prayer, as you read this is that you will not be short of God's promised rest. "Weaknesses, infirmities, reproaches, may come our way, but we pray that we shall be overcomers because of the assurances God has given us in Christ Jesus;" wherein our rest lie. Like Isaac, we all shall erect altars of appreciation of the goodness of God upon us. We shall be where our calling God's name will be answered. Let us therefore pitch out tents in the right and divine locations.

Isaac was not only blessed; he had an appreciative communion with God. So, those envious of you, contending with you; your haters and troublers, shall seek your peace and covenant as Abimelech did with Isaac (Genesis 26: 26-28). Let us make peace and live right. "Therefore humble yourselves under the mighty hand of God, that He may exalt you in due time, casting your care upon Him, for He cares for you" (1 Peter 5:6-7). And as Apostle desired, "From now on let no one trouble me, for I bear in my body the marks of the Lord Jesus" (Galatians 6:17).

Religion uproar over Muslim-Muslim ticket

igeria is a multi-ethnic and multi-religious society. The two major religions in the country are Islam and Christianity. Adherents of these two major religions take divergent positions on the questions of the secularity of the

The constitution protects religious freedom, "The government shall not

adopt any religion as State Religion."
As enshrined in the country's constitution. Secularism means separation of religion from political, economic, social and cultural aspects of life, as religion is to be treated as a purely personal matter. It emphasized dissociation of the state from religion and full freedom to all religions and tolerance of all religions.

Section 38 sub-section 1 of the 1999 constitution states, "Every person shall be entitled to freedom of thought, conscience and religion, and freedom to manifest and rengion, and needom to manifest and propagate his religion or belief in worship, teaching, practice and observance." Non-Muslims have, however, argued that the imposition of Shari'a in some states in the country violates these rights. Despite this open opposition in the past, nothing was done about the imposition of Sharia in some states of the Federation.

A secular state does not have any official religion. It neither encourages nor discourages the practice of any religion. All citizens are free to propagate, profess or practice their own religion. No discrimination is made among citizens based on religion.

The three main objectives of a secular State are; Religious community does not dominate another. Some members do not dominate other members of the same religious community and The State does not enforce any particular religion nor does it take away the religious freedom of individuals.

With all these provisions in the country's constitution, most religious watchers were surprised at the uproar that greeted the All Progressive Congress, APC, Presidential Flag bearer, Asiwaju Bola Ahmed Tinubu, a Yoruba Muslim, unveiling another Northern Muslim, Alhaji Kashim Shettima, as his running mate in the forthcoming Presidential election in Nigeria, come next year, 2023.

Trumpet Religion Desk, after a study of the situation in the country, decided to carefully examine all the views expressed so far across board, to find out whether or not, there is justification for the fear over the Muslim-Muslim ticket of the APC.

Human Rights Lawyers, Ebun-Olu Adegboruwa, SAN, in a statement dated, Tuesday, July 12, 2022, described as dangerous, APC Muslim-Muslim ticket and asked Nigerians to vote the party

Adegboruwa outlined in a statement, ave implications of APC Muslin Muslim ticket;

1 - Others don't matter, saying it shows absence of consideration for the unity and plurality of the country.

2 - Desperation and over-ambition on the part of the APC ticket holder and the party, whose attitude to the game was, "We just want power at all cost and we don't care what others think or do."

3 -"We can win the election without you, especially by other means other than by open ballot."

4 -"It is a cruel affirmation of the supposed superiority complex. That only one region determines electoral victory. That

the presidential candidate of the APC is not acceptable to northern Muslims."

5 -"It is an indication of a hidden agenda. The spirit of Hope 93 died with MKO Abiola and those who betrayed him and his mandate. May Boko Haram, terrorists and insurgents, their sponsors and sympathizers not win the 2023 general election"

6 -"That Nigeria is not a secular state but rather being ruled to satisfy certain religious tendencies."

7 -"That the APC has absolute control of the electoral system and thus electoral victory may not be determined through free, fair and credible elections.'

8 -"That certain political tendencies and interests do not trust others to accommodate them if they are entrusted with power whereas they have been in power and accommodated by others."

9 -"That the APC Presidential candidate has no mind of his own and he will be unable to defend the unity of Nigeria in crucial moments of decision making.'

10 -"That the APC is incompetent to manage a complex nation like Nigeria with diverse interests, different tongues and tribes and consisting of different

The Catholic Bishop of Sokoto Diocese, Most Reverend Mathew Hassan Kukah, was one of the very first prominent Christians in Nigeria, to react to the Muslim-Muslim APC Presidential Ticket in a press statement in this manner, "Tinubu is free to pick whoever he wanted just as a coach is free to select the players

"It is up to Nigerians to decide if they ant a Muslim-Muslim President and Vice-President or not. This is what we call team selection and everybody will choose depending on what they think will give them a fair chance. So people will take responsibility for the choices they have made. For me, it is not something to lose sleep over."

The Bishop stressed, "If people feel unhappy with the kind of choices that have been made that is why we are democrats, you can't force it. We outsiders cannot force a choice on any candidate. It is now left for you to look at the choices that have been made. And there is no guarantee that all Christians will

vote for Christians and all Muslims will vote for Muslim."

Speaking in the same vein, the Catholic Archbishop of Abuja Diocese, Most Rev. Ignatius Kaigama, in a press statement entitled "Catholic Bishops Condemn APC, Tinubu's Choice of 'Muslim-Muslim' Ticket: Nigeria Not Ripe to Have President, VP Of the Same Faith, he described the choice of APC Muslim-Muslim ticket as

Archbishop Kaigama maintained that Nigeria as a country was not ripe for a same faith Presidential ticket. He stressed, "When you decide that only one religion will produce the major actors, excluding others, who will become like strangers, it would not be fair and just. For the sake of religious sensitivity in a place like Nigeria, it is good that we have a balance so that we become like one big family."

The Muslim Rights Concern (MURIC) led by Professor Ishaq Akintola in its reaction said the group has satirical facts to support its claims that there has been an imbalance against Muslims in Nigeria, in the country's political system. Saying that the APC Muslim-Muslim ticket amounts to nothing anyone should bother about.

The Islamic Human Rights advocacy group said it is unfortunate that the Christian Association of Nigeria (CAN) has decided to heat up the polity with its comment on Tinubu's choice of a running mate. Thus asking CAN to address the APC presidential candidates not their

"The Christian Association of Nigeria (CAN) has come again. As usual, Muslim candidates for the 2023 presidential election are targets. This time around, it is Senator Bola Ahmed Tinubu and his running mate. Tinubu is under CAN's hammer for picking a Muslim, Senator Kashim Shettima, as his vice presidential candidate and Rev. John Hayabl of Kaduna State Chapter of the organization is the axe man for CAN.

"We are not surprised by CAN's verbal halitosis over Tinubu's choice. The Christian umbrella body is just staying in character. It is always out to oppose any Muslim in power or any Muslim seeking office. That is because CAN will never be satisfied with a Muslim

as President of Nigeria. It will not suit its agenda of Nigeria for Christ.

"CAN is simply hungry for power. We know CAN. The group has been canvassing for a Christian running mate not for the benefit of Nigerians but for parochial ends. The idea is to milk the Christian vice presidential candidate if his party wins in the end by claiming that the Christian umbrella body fought for him. It is for political influence, for contracts and for power. We advise CAN to form its own political party.

"Democracy is a game of numbers and every candidate should be allowed to make a free choice. It is not written in the constitution that a candidate must not pick a running mate from his own religious group. Every candidate's choice is at his own peril. So what's the big deal? What is CAN afraid of? Its own shadow, of course.

"Nigerians should not allow themselves to be deceived by CAN's spiritual banditry. We should be looking at a candidate's pedigree, his integrity and competence. By the same token, a presidential candidate should look for a running mate, who has electoral value as well as relevant experience. CAN's insistence on Muslim-Christian ticket is motivated by articulated religiosity and tramadolised spirituality. Candidates should not be assessed by their religion.

'CAN talks about fairness and balancing at the national level but ignores the gross lopsidedness in the Christian-Christian regimes of the whole South. Is CAN unaware that all but one of the 17 states in Southern Nigeria have Christian governors? That is 94 per cent for Christians and just 6 per cent for Muslims.

"There are only three Muslim deputy overnors in the whole Southern Nigeria (Lagos, Ogun and Oyo) as against fourteen Christian Deputy governors. That is 82 per cent for Christians and 18 percent for Muslims. Ekiti and Ondo states with substantive Muslim populations have Christian governors and Christian deputies. This is give and take. The world goes round by giving and sharing. But why does CAN want to share by force

when it is not prepared to give?
"Nigeria has 36 states. Of these,
Christian Governors are 20 while Muslim governors are just 16. That is 56 per cent for Christians and a paltry 44 per cent for Muslims. Yet, CAN is not satisfied and the organization will always cry marginalization when in actual fact, it is taking all the milk and honey in the land. We are waiting for CAN to deny this 20 to 16 computation. But CAN cannot. It dares not because the facts are there, and facts are sacred. Are the United States' Senators listening? Is Kukah still there? "There are 22 Christian Deputy Gov-

ernors in Nigeria as against 14 Muslim Deputy Governors. Mathematicians should put that together and work out the percentage. This is 61 per cent for Christians and just 39 per cent for Muslims. So what is CAN talking about?

"Can charity not begin at home. That is why it is making so much noise about Muslim-Muslim ticket at the centre? CAN is not ready to share in the States but it wants to force sharing down our throats at the centre. Is that not a double standard? Must CAN take everything?

CAN is simply hungry for power and it is always seeking ways to railroad everyone to have its own way. Bulldozing, blackmailing, harassment and intimidation are CAN's stock in trade. But the same intimidating CAN is now the one accusing Tinubu of intimidating the Christian group and threatening to escalate the situation.

Nigeria businesses embrace solar energy as price of diesel soars

ompanies investing in and promoting solar energy products in the country are witnessing a surge in demand for mini-grids and equipment, as businesses in the country grapple with the high cost of diesel and erratic public power

As Africa's largest economy and major crude oil producer, Nigeria's inability to refine its petroleum products, even with the country's four refineries, had led businesses to seek alternative power sources following soaring cost of diesel globally due to rising global oil prices.

Solar supply constraints could, however, hamper their ability to capitalise on the trend with some sources saying they have begun to turn away customers because they have largely been unable to meet rising huge demands.

Nigeria, with a population of over 200 million people, reportedly have installed electricity capacity of 12,500 megawatts, but the national grid only provides 4,000 megawatts or even lower at its peak, leaving businesses and citizens to heavily rely on diesel, which has not been subsidised like petrol.

Findings in Lagos and other parts of the country showed that diesel is currently sold at between N800 and N900 per litre, as investigation showed that most of the increase resulted due to the Russia- Ukraine war.

Chief Commercial Officer of Daystar Power Limited, Victor Ezenwoko, told The Trumpet there has been increasing demand

for solar energy products and inverters, saying: "I think it is really driven by the constant hike in the price of diesel this year.'

Also speaking on the development, Onareme Geoffrey, who supplies solar energy products and inverters in Warri, Asaba in Delta State, Benin City, Edo State and Port Harcourt in Rivers State, as well as their environs, confirmed the surge in solar energy products, adding that the situation could only be so, considering the epileptic power supply and diesel crisis in the country.

Besides, the Energy Commission of Nigeria (ECN) affirmed that businesses and individuals spend \$22 billion yearly to fuel generators in the country, as solar power adoption has been estimated at below two per cent, while some businesses perceive it as unsuitable for large-scale use.

A study conducted earlier this year by Boston Consulting Group and All-On firm also revealed that Nigeria's installed photographic voltaic solar panel per capital amounted to one megawatt compared to an average of eight megawatts in other emerging markets like South Africa.

Managing Director of Resource Energy, Prince Ojeabulu, lamented that the situation was getting worse in the country, as energy costs eat deep into companies' margins, forcing most businesses to actively consider solar as a cleaner and cheaper source of energy.

"In 2021, Resource installed under one megawatt of solar panels, but it is now constructing six-megawatt plants. By the end of the year, going by the trend so far, we should have 12 megawatts of solar installations operational across the country or even more," he said.
An official of the Ministry

of Power said there was an increase this year of approved solar mini-grids serving industrial users, but declined to give details.

But global supply chain dis-ruptions caused by the COVID-19 pandemic lockdown in China this year and the Russia-Ukraine war were altering and frustrating the hope for growth.

Ezewonko and co-founder of Daystar, Jasper Graf von Hardenberg, said: "We could install 60 megawatts this year if we had the equipment. We have started turning down customers, we have become choosier with who we work with."

Managing Director of Guinness Nigeria Plc and Chairman of the group, Baker Magunda, who stated this at a media briefing in Abuja recently, said the BSG comprised leading beer manufacturers in Nigeria, including the Nigeria Breweries Plc, Guinness Nigeria Plc and International Breweries Plc, among others.

Banks move to enforce N1.4tr debt on loan defaulters

Deposit Money Banks (DMBs) have started monitoring accounts of loan defaulters with a view to enforcing a debt of N1.4 trillion on borrowers that signed the Global Standing Instructions (GSIs) clause.

The Trumpet learnt that the GSIs policy authorised banks to debit accounts of chronic loan defaulters in any bank in Nigeria to recover debts or settle defaults, just as the Central Bank of Nigeria (CBN) data showed that 5.31 per cent of the N26.1 trillion credit to the economy representing N1.4 trillion are Non-Performing Loans (NPLs) being monitored for the GSI sanctions.

A top banker, who is a Regional Director in a mid-level bank told The Trumpet that the country's banks are reviewing credits in their balance sheets to ascertain delinquent loan defaulters with a view to enforce the GSIs Policy on defaulting accounts.

The banks are already preparing lists of short and long terms loans which expired in June 2022 ending. The debit on the defaulting accounts that signed the GSIs clause will start by next week in many of the banks," he said. According to him, the GSIs

implementation gained momentum among banks after the CBN follow-up circular in January 2022, which stipulated that the frequency of recovery attempts via the platform will be continuous and unrestricted.

He said the GSI automated loan recovery feature applicable to all loans in the industry is now perpetually in place throughout the tenor of the loan or until the loan is fully repaid.

Speaking on this issue recently, CBN Deputy Governor of CBN, Kingsley Obiora, said total flow of credit to the economy increased to N26.10 trillion in April 2022 from N21.45 trillion in April 2021, representing an increase of 21.66 percent.

Obiora explained that some sectors with increased credits include, manufacturing, consumer credit and general consumer, Information and Communications Technology (ICT), agriculture and others.

He added that the Non-Performing Loans (NPLs) ratio stood at 5.31 per cent at the end of April 2022, slightly above the prudential threshold of 5.00 per

"It was however an improvement from 5.89 per cent at the end of April 2021, reflecting recoveries, restructuring of facilities and sound management practices by Other Depository Organisations (ODOs), he said recently in his notes to members of the Monetary Policy Committee (MPC)

Governor of CBN, Godwin Emefiele, who backed the GSIs policy, said debtors must repay their loans, stressed that the CBN would not allow people to borrow money and refuse to pay, adding: "That era has gone. If you borrow money and refuse to pay, we will take your money wherever you

He added that the initiative was conceived to address the recurring instances of wilful loan defaults in the banking industry to identify and watch-list recalcitrant loan defaulters, enhance recovery from eligible and funded accounts in the industry and improve credit repayment culture.

The GSIs mandate authorises recovery of amounts specified by the bank from accounts maintained by the borrower in all financial institutions. It also empowers banks and other financial institutions to debit accounts of chronic loan defaulters in any bank within the country to ease the growth of NPLs in the country," he said.

MAN laments continued increase in price of diesel, FX scarcity, others

The Manufacturers Association of Nigeria (MAN) has decried the constant increase in the price of Automated Gas Oil (AGO), popularly known as diesel.

It stated this in a statement issued by the Director-General of MAN, Segun Ajayi-Kadir and made available to *The Trumpet* in Lagos, maintaining that the Russia-Ukraine crisis had impacted negatively on the country's real sector.

He stressed that if not curtailed, the current price of the product and constant hike could collapse the country's business sector due to the lack of stable power supply.

"Global events have shown that the world is like a village. The emergence of challenges in one country can become a major constraint with spiral effects for the world. Oftentimes when disruptions occur in any part of the global economy, only countries with functional institutions and strong internal economic mechanisms will be able to respond appropriately to such external shocks.

"The current increase in prices of crude oil and other refined petroleum products such as diesel is one of such disruptions occasion by external shocks that confirm the interconnectedness of global economies. No doubt,

the recent short supply and over 200 per cent increase in the price of diesel are part of the backlash of Russia's invasion of Ukraine," the statement reads.

It said MAN was greatly concerned about the implications of the over 200 per cent increase in the price of diesel on the Nigerian economy and especially the manufacturing sector, adding that more worrisome was the deafening silence from the public sector regarding the plight of manufacturers.

"Should manufacturing companies that are already battered by multiple taxations, poor access to foreign exchange and over 200 per cent increase in the price of diesel be advised to shut down operations? It asked.

In the short-term, the disruptions occasioned by Russia's invasion of Ukraine would continue to impact the global energy space and upset the supply of petroleum products, thereby causing persistent increases in the price of refined petroleum products including AGO.

The MAN lamented that in the long run, the development would further result in enormous increase in the prices of other manufacturing inputs like wheat, maize, fertiliser and other raw materials.

It maintained that the implementation of the sharp increase in the price of diesel on the manufacturing sector include exertion of untold hardship on the manufacturing sector leading to the closure of several business outfits and reduction in capacity utilisation, further decline in Gross Domestic Product (GDP), unemployment in the 76 sub-sectors of the association and increasing crime rate.

"There will be further decrease in foreign exchange from the manufacturing sector, as high cost of production impact export commodity prices. It will also lead to a sharp reduction in government tax revenues occasioned by the drop in sales, lower profitability, as lesser quantum of disposable income will be available to purchase manufactured goods," the statement added.

NIMASA deploys special mission aircraft to fight oil theft in Nigeria

The Nigerian Maritime Administration and Safety Agency (NIMASA) has assured that two special mission aircraft in the agency's deep blue project fleet will be deployed to fight oil theft and protect the country's economy.

Director-General of NIMASA, Dr. Bashir Jamoh, who spoke at the 16th edition of the Maritime Seminar for Judges organised by the Nigerian Shippers Council (NSC), described oil theft, pipeline vandalism and illegal refining, as unlawful activities capable of threatening the country's economic and environmental safety.

He said the aircraft from the mobile assets of the deep blue project would support existing platforms being deployed by other security agencies with which NIMASA has subsisting Memorandums of Understanding (MoUs).

Jamoh explained that the aircraft would assist in patrolling oil facilities, installations and other assets to effectively monitor suspicious human and vessel movements in and around

the facilities.

While restating the agency's commitment to a crime-free and secure maritime domain, he reminded participants at the seminar of President Muhammadu Buhari's interest in rebuilding stakeholders and investors' confidence in the country's maritime sector.

He said the President's approval for procurement of the assets, their commissioning in Lagos and their deployment for security duties, have contributed immensely to the fight against maritime crimes.

He said: "We shall be deploying our two special mission aircraft for aerial surveillance to prevent and fight oil theft in the country. With this, we aim at using the aircraft to patrol sensitive areas, record suspicious human and vessel movements to process intelligence for timely action by our security agencies.

"The oil industry is critical to our national economy and no space of the sector should be left for criminals to occupy or operate. We have recorded gains in our maritime security efforts and more needs to be done to sustain and consolidate

"Among other reasons, our collaborations with security agencies with which we have MoUs are to ensure effective partnership and work ahead of criminal elements and I am happy to state that our synergies have been beneficial to the country in several ways."

Bloom Tower: a bold statement worth over N20bn — Blessing Obomovo

Standout Property Limited has entrenched itself deeply into the Nigerian Real Estate market. With the launch of its 21-floor Bloom Towers in Victoria Inland, they are making a deeper reach in the industry. In an interview with our Weekend Editor, OBAH SYLVA, the CEO/MD, Blessing Obomovo, gave insights on the journey, successes and challenges of the emerging giant – Standout Property.

Who is Blessing Obomovo and what are some of the factors that shaped you to become the

man that you are today?

Blessing Obomovo is a very quiet and humane personality. I am from Otor-Owhe paternally and Ozoro maternally, both from Isoko North Local Government Area of Delta State. I live in Lagos, studied Building Technology, and proceeded for my Master's in Housing Development and Management at the University of Ibadan. I am married and blessed with kids. The truth is that we didn't get here by accident, we got here through hard work, perseverance, and complete faith in God because we believe that God can do all things. I am a construction expert and we share a vision and have worked hard to achieve it. But we still believe that we are at the genesis compared to the vision that we have.

A few days ago, you launched the Bloom Towers in Victoria Island, Lagos. Can you give us the details of the project?

Bloom Tower is one very audacious project that we are embarking on. It is audacious because of the size and because of the cost value of the area. Housing a twin tower of 19 and 21 floors is not a joke; you know what that means. It is a project that is worth over 20 Billion Naria. It is a huge one and it is a bold statement that we want to make. We do not want to limit ourselves, that is why when we started MIJL Residence and Villa it was as if it is not possible, but today you can see MIJL is here, we are wired to do things unusually and we are putting everything in place to achieve our plans. In Bloom Towers, we have offices and luxury shops, we also have residential apartments.

We have the basement for parking, the ground and first

floor for both luxury offices and shops, while on the second floor we have Apartments for flats and Maisonette. Because of the nature of our luxury shops, we are not selling less than 20 square meters and a square meter is going for N2 million for the office spaces. For the apartment, we have the one-bedroom flat for N80 million and the one-bedroom Maisonette for N90 million. The two-bedroom flat is N120 million while the two-bedroom Maisonette is N130 million. The three-bedroom apartment is N150 million and the Maisonette with BQ is N180 million and a unit of three-bedroom penthouse for N205 million

Apart from the office and shops, in all the residential apartments, you pay a minimum of 30 percent deposit and spread your payment up to 30 months. For the luxury shops and office space, you pay a minimum of 50 percent and spread the balance within 30 months. Bloom Towers is providing high-grade finishing and top-notch kind of development with a gym, lounge, and laundry in the heart of the city of Lagos

Standout Property has been around for some time now. Can you tell us about when it was birthed and the journey so far?

Standout Property was registered in 2010, our mind was built on our goals obviously, and we started like every other small building contractor, like I said I am a Builder. Far back in 2009, we said enough of the small contracts, then we were actually working with developers. That was how we got into our own development and that was how MIJL came to be. MIJL is a 155 units housing estate, people are already staying in MIJL. We will be done with MIJL in the next two months. From MIJL to Bloom Haven. Bloom Haven is almost 40% now, so much

work is currently going on there, it's a two years project. Then the Warri project, a lot of materials are already coming in, we currently have one block of three bedrooms ready, then 2 units of two-bedroom have already taken off; we are done with the foundation. We also have the stand-alone 4-bedroom duplex and we are already at the woodwork for the slab. In fact, so much is happening here. We also have the Cynergy Gardens in Lagos which was launched sometime in February, in a month or two we will start construction work there too. Then the big one, Bloom Towers. We are on the verge of concluding with the contractor we want to use. Hopefully in

the next few weeks, we will be done and by August we will commence construction. It is a 4 years project but we want to be done before 4 years.

We noticed that most of your projects and investment are concentrated in Lagos, do you have any plan of expanding to other regions of the country?

Obviously Abuja and Port Harcourt are in the pipeline. Some investors are also talking to us in yenagoa. We have the intention of expanding. Standout Property is a growing company and whatever success we have achieved so far is just the starting point. We want to concentrate and consolidate on them. We want to be the leading company when it comes to housing

When it comes to housing
What are some of your biggest challenges so far running
Standard Property and how have
you managed them?
Well for anybody who is in an
industry like this, funding will

always be one major issue, but like I said God has been faithful. MIJL is over N4 billion currently and we didn't borrow one kobo from the bank, we were able to sort for funding through the market, and because we actually do off-plan investment and that is why we do installment payment, which has worked for us so far. But funding is a major challenge, in fact, it's a Nigerian thing. We hope to do bigger projects than MIJL and we know that as we go on investors will come. We have a bit of investors already but we know that as we continue to push ourselves in the market more investors will come in. However, I must admit that funding is an issue, just imagine taking a loan that you pay 20 to 30% interest. Then you should ask yourself how much am I making? At the end of the day, if you factor in all these costs you won't be selling at the prices we give our offers.

This is one reason why our prices are lower when you compare with the prevailing market, not because we lower our quality but because we have decided to provide better services and products by using these processes.

So far what will you consider to be your greatest achievement?

Delivering MIJL is our biggest one. When we went into that project, there were doubting Thomases everywhere. We used to hear things like it is not possible, you can't deliver that project and all of that, but as of today, the present cost of that project is over N4 billion, and not 1 kobo was borrowed from the bank. This is our greatest achievement and that is why we can boldly talk about Standout Property because we were able to deliver MIJL.

What is your vision for Standout Property in the next

MIJL is 155 housing units. Bloom Haven is 63unit housing, Warri is about 210 though we are still expanding, Cynergy is 190, and Bloom Towers is about 243 units. So, in a few years, if you add all of these with more that are still coming, we will be well above one thousand. So in the next 10 years, we must have done over 10 estates in Lagos, we must have finished Warri and we must have done something in Asaba and Ughelli and a minimum of five estates in Delta.

Also, we must have established ourselves in the Abuja and Port Harcourt Markets and in a majority of our state capitals. For us, it's about providing affordable luxury. So, in the worst-case scenario, we must have established ourselves in a minimum of 50% of our State capitals in the next 10 years.

As an expert in the real estate business in Nigeria, what is the future of the industry in the country?

We have not scratched the surface. If we are talking about having over 70 million housing deficit with an expanding population and you know we cannot do more than 3 or 4 million per year, so there is still a huge gap. We have not started, most of our people are still living in the slum and in shantytowns. The real estate business is a goldmine for this country as far as job creation is concerned.

Courageous petrol tanker driver saves lives

🕇 omrade Ejiro Otarigho, who averted a monu-→ mental tragedy that would have caused many their lives and properties in Agbarho, Ughelli North Local Government Area of Delta state, granted an interview to the Trumpet newspaper, where he recounted how he successfully drove a petroleum tanker that had caught fire from a residential area to a safe space to avoid the destruction of lives and properties.

Comrade Otarigho who has undoubtedly become a hero in his community and the country at large told The Trumpet how the incident occurred in the evening of June 10, 2022, and all of the appreciation and applause that he has received because of his courageous action:

What exactly can you say caused the fire outburst?

Honestly speaking, up till now, I still do not know what exactly triggered the fire. I still haven't figured it out. It was my boy who works with me that alerted me that fire was coming from the tanker. Immediately I saw the fire, I told my boy to jump down to safety, while I tried to drive the furiously burning tanker as far away from people as possible.

In what part of Agbarho did the fire start?

Anyone that is familiar with Agbarho would know the water board junction. It was around that area we noticed the fire on the tanker.

How long did it take you to drive the tanker to a safe space?

It took about 15 to 20 minutes at most to have successfully driven the tanker to where there were no people. When we noticed the fire at the water board junction, I had to drive through a place called Five Junction, from there down to Okpokpo and from there to the express road that leads to the Agbarho River where I considered safe. That was how long I drove, through the fairly heavy evening traffic. The more I drove the more the fire raged more dangerously. But I was resolute.

What prompted such swift and heroic decisions as most people in that situation may be paralyzed by fear?

Well, I had to put away

would have made me lose my concentration. Then again, I am from Agbarho and quite popular in the community even before this incident. I didn't want to be the one responsible for the death of anybody in my own home town. How would I walk the streets? What would people say about me? That I had caused the death of many? The thought of these alone prompted me to swing into that action, to avoid all of those blames and name callings. With God helping me, I succeeded without any injury. If I hadn't succeeded, my boy who I told to jump down earlier when we noticed the fire, would have told the story of how it all happened, but God was faithful.

What was the reaction of your family, particularly your wife when she heard about the situation?

Honestly, my wife is a very calm person by nature. The only thing she told me was that I took a deadly risk endangering my life, leaving them out of my thoughts or didn't I think about them? I subsequently told her that I had to take the risk, to save the lives and properties of many people and also protect her from the stigma of: "the wife of the tanker driver that killed people". I didn't want that for her or my family either. If that had happened, I am sure on hearing about the situation she would have become destabilized. Although, I did apologize to her because, in all honesty, the action I took was really a risky and scary one. It didn't

every atom of fear as that would have made me lose my concentration. Then again, I am from Agbarho and quite cause any quarrel at home, rather she hailed me by the nick name she usually calls me.

What is your reaction to the outpouring of applause from the general public, especially the people of Abgarho?

Well, after the incident, I have received numerous songs of praise from various people from across the country, particularly in Agbarho, my community, including the king and all the chiefs of his cabinet, even down to the ordinary man in the street. I was also recognized by the Agbarho Urhobo Improvement Union (AUIU) which gave me a heroic award for my bravery. Honestly, I have been treated with so much love and respect, I mean if the people controlling the affairs of Agbarho can appreciate and honour me, that speaks volumes. It means that I have a place in their hearts and in the community. I am

extremely grateful for the love that has been showered on me in this period. It means a lot to me.

It is no news that you were invited over to the Senate, what can you say about this?

Yes, I was invited to the senate, where our Distinguished Senator, Chief Ovie Omo Agege, the deputy senate president moved a motion for the President to give me a national award for my heroic act. The motion was overwhelmingly approved, for onward transition to the presidency. You know that the process may take a little while, but I am sure that before the year ends, something will be done about it. I also met with the Senate President, Ahmed Lawan who congratulated and appreciated me, for the lives and properties that were saved, because of my courageous

Has the tanker that burnt to ashes been replaced?

No, there hasn't been any replacement for the tanker just yet, but I believe in a short while, it will be replaced. However, I am overwhelmed by the appreciation of well-meaning Nigerians who have reached out to me and rewarded me both in cash and in kind. I am grateful to them.

How long have you been into petrol tanker driving, and has this ever happened before?

I have been driving fuel tankers since 2010 and I have gained a lot of experience. This kind of incident has never happened before. This was just an unfortunate situation, but I am grateful to have been saved by God.

What are some of the challenges you face as a tanker driver?

Well, in this profession, there are a lot of challenges just like every other job. For instance, scarcity of petrol which leads to low earning, and bad roads that damage our vehicles. One would have to repair the vehicles to keep them in good shape at all times. As you know that is very expensive and it affects our daily bread.

What are some of your hopes for a better Nigeria?

For me, I would say if you are in a position to do that which is good, you ought to do it, for the overall interest of the country, whether you are being paid for it or not. If you are in such a position, your responsibility is to add value to the lives of the people you are governing, for them to live a better life. What I did, I didn't do it for any rewards. I did it because I was placed in the position to do so because I know saving lives is a priority. If I hadn't taken the risk of saving those lives, I wouldn't be a free and happy man today. I would have probably moved quickly to another state with my family to save us from shame and ignominy. So if you are in any position to help the country, you should put in your best for the greater good of our nation.

Comrade Ejiro Otarigho who is now popularly called the 'superhero' in his community, said that he is entirely grateful to God who gave him the courage to take the risk that averted a situation that would have left many dead, and properties destroyed.

Professionals' lack of integrity fuels corruption, Owasanoye says

hairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC), Professor Bolaji Owasanoye (SAN) has stated that lack of integrity by professional bodies was responsible for the spate of corruption in Nigeria.

Prof Owasanoye stated this at the 11th Summit of Professionals, which was organised by the Association of Professional Bodies of Nigeria (APBN) in Abuja on Wednesday.

The ICPC boss, who was the Special Guest of Honour at the event, noted that the country's ailing economy was currently suffering from maladies bordering on a lack of integrity and good ethical conduct.

According to him, "If we must achieve our dream of sustainable economic growth as a nation, integrity should be the cornerstone of every professional practice, and professional bodies must be seen to enforce their code of ethics to the letter."

He noted that financial fraud cannot be committed without the complicity of a 'professional', hence, the decision of ICPC to introduce a Forum of Professional Bodies and Business Management Associations, which brings professionals together to brainstorm on how to reduce corruption to the barest minimum and to conduct their businesses with uttermost integrity and strict adherence to code of professional ethics.

"The overall objective of the Forum is to sensitize professionals on the content of anti-corruption laws, especially the Corrupt Practices and Other Related Offences Act, 2000, and discuss the possibility of infusing relevant aspects of the law into the professional

code of ethics of various professions so that violating the codes of ethics would invariably amount to violating ICPC Act and therefore punishable

"The motivation to do wrong is very high because professional codes of ethics are not implemented by those saddled with the responsibility whether they be the officers of the professional body or regulators partly because the rules allow for discretion or because they are implicated. The result is that erring professionals easily rationalise their actions.

"Experience however shows that a person, professional, or business that chooses the path of integrity will always appear short-changed but only in the short term. Such is vindicated in the long term if they stay the course,"

The ICPC Chairman added that the Commission has made further efforts to help reduce corruption in the country by liaising with various professional bodies through the forum.

"Between 2013 when the Forum was introduced and 2018, ICPC had conducted five sessions whereby it sensitized and interacted with 627 professionals from 28 professional bodies. ICPC had signed a Memorandum of Understanding with some professional bodies such as the Council for the Regulation of Engineering in Nigeria (COREN) with the view of ridding the engineering profession of unwholesome behaviours such as quackery,"

While urging APBN to team up with ICPC in the implementation of anti-corruption policy, he said the private sector, consisting largely of professionals, was important to the implementation of the National Ethics and Integrity Policy (NEIP).

Earlier in his remark, the President of APBN, Surveyor Akinloye Olufemi, noted that the Association, being the umbrella body for all professions in the country, has the undisputable responsibility to continue to intensify its effort on advocacy against corruption.

"It is common knowledge that the world is going through trying times. Just as the slow Socio-economic recovery after the Covid-19 pandemic was gathering momentum came the Russian invasion of Ukraine which has preoccupied the developed countries. As lives are being lost daily, the attention of the

developed countries has been shifted to trying to contain the invasion and its far-reaching implications.

"It is as if our nation's share of this was not enough, we have a high level of inflation and insecurity to contend with on a daily basis.

"APBN as the umbrella Association for all professions in the country has the undisputable responsibility to continue to intensify its effort on advocacy and enlightenment. This is borne from the conviction that it is the professionals of any country that would develop it," Olufemi said.

The ceremony was attended by key stakeholders from thirty (30) different professional bodies that make up the APBN.

Court to rule on Jonah Jang's N6.3bn fraud case

Justice C.L Dabup of the Plateau State High Court sitting in Jos is set to rule on the ongoing N6.3 billion fraud trial of former Governor of Plateau State, Senator Jonah David Jang, and a former cashier in the Office of the Secretary to the State Government (OSSG), Yusuf Pam in a date that would be announced.

Justice Dabup on Thursday, July 14, 2022, adjourned the case for judgment after the adoption of final written addresses by both the prosecution and defence counsels.

Jang and Pam are facing trial for alleged criminal breach of trust and misappropriation of Plateau State funds to the tune of N6.3 billion.

At the resumed hearing of the case on Thursday, counsel to the first defendant (Jonah Jang), Mike Ozekhome SAN adopted his final written address and urged the court to discharge and acquit his client.

Ozekhome, who also informed the court that the first defendant pleaded not guilty to the charges preferred against him, said the case lacked merit and that the prosecution did not prove its case beyond a reasonable doubt.

Speaking in the same vein, counsel to the second defendant (Yusuf Pam), S.G. Odey, while adopting his final written address, urged the court to discharge and acquit his client on all charges levelled against him.

However, prosecution counsel, Rotimi Jacobs SAN, urged the court to consider the evidence of all fourteen (14) witnesses before it, especially the evidence of Prosecution Witness 5, PW5, which supported the confessional statement of the second defendant.

Jacobs submitted that the required proof is not "proof beyond all shadow of doubt".

He informed the court of two pending motions seeking leave to appeal the two rulings on trial within the trial and urged the court to allow the adoption of the two pending motions.

Ozekhome did not object to the two applications but Odey indicated his intention to oppose the applications. The court thereafter directed that the final addresses be adopted.

The prosecution adopted the written address and urged the court to convict the first and second defendants. Ozekhome adopted his written address and prayed the court to discharge and acquit his client while Odey also adopted his written address and urged the court to discharge and acquit Pam.

Whistleblowing policy used for vendetta, not working - AGF

The Attorney-General of the Federation (AGF) and Minister of Justice, Abubakar Malami (SAN), has said that the much-celebrated anti-corruption whistleblowing policy is not working because it is being abused by some to settle personal scores.

The AGF stated this in Abuja at the formal launch of the Corruption Anonymous (CORA) whistleblowing platform organised by the African Centre for Media and Information Literacy (AFRICMIL) and other partners on Thursday.

Malami, who was represented by the Special Assistant to the President on financial crimes, Abiodun Aikomo, commended AFRICMIL for the initiative to support the government's anti-corruption fight while noting that the process for having robust legislation for the protection of whistleblowers is ongoing and that the government was not relenting in its fight against corruption.

"Governments cannot do it alone. So, we need everybody, I want you to know that the government is committed to bringing everybody on board," he said.

Earlier in his address, the Coordinator, AFRICMIL, Dr Chido Onumah, said that the CORA whistleblowing platform was organised to increase citizens' participation in the anti-corruption fight in Nigeria.

Dr Onumah recalled that the federal government on December 22, 2016, introduced the whistleblowing policy that offered, among other things, financial incentives for citizens who blow the whistle that leads to the recovery of looted public funds.

He said that AFRICMIL launched CORA

in its quest to help the government get the desired impact of the policy.

Meanwhile, the Chairman of the Independent Corrupt Practices and Other Related Offences Commission (ICPC), Prof Bolaji Owasanoye SAN, who was represented by a board member of the commission, Mrs Anne Odey, commended AFRICMIL and the Yar' Adua Foundation for their

On his part, Director General, National Orientation Agency (NOA), Dr Garba Abari, represented by the Director of Press, Mr Paul Odenyi, urged AFRICMIL, MacArthur Foundation, Yar'Adua Foundation, and other partners to extend the whistleblowing platform to elections in the country.

According to him, vote buying and selling in the electoral process was becoming worrisome, hence the need to nip it in the bud.

ICPC to probe MDAs on abuse of COVID-19 intervention funds

The Independent Corrupt Practices and Other Related Offences Commission (ICPC) has vowed to investigate Ministries, Departments, and Agencies (MDAs) for infractions on COVID-19 intervention funds and other procurement abuses.

Chairman of ICPC, Prof Bolaji Owasanoye (SAN) said this while speaking at the 2022 African Union Anti-Corruption Day, saying that the commission had observed discrepancies and infractions in the procurement and payments made by some Ministries and Agencies after the disbursement of the COVID-19 fund.

"The Commission had observed discrepancies and infractions in the procurement and payments made by some Ministries and Agencies after the released and appropriate disbursement of COVID-19 funds.

"The Commission observed that in some instances, the distribution of relief materials or palliatives was chaotic, disorderly, and uncoordinated.

"Some implicated MDAs denied the monitoring team access to their records thereby impeding the successful inquiry into their activities. These MDAs are flagged and will be investigated for breaches and

infractions of the law and COVID-19 intervention funds guidelines and other procurement abuses.

"Hoarding and diversion of materials were also common warranting the raids by people in some situations, facilities or locations warehousing palliatives. Some of such also created widespread violence," the ICPC boss said.

While citing media reports, Owasanoye lamented selective distribution, favouritism, nepotism, and other biases in the allocation and distribution of palliatives as well as the 'high-jacking' of palliatives by political actors, their proxies, cronies, and affiliates.

Q: So talking about script, what factor would make you reject a script?



Q: What of financial wise?




Q: As a leading brand, what do you stand for in the industry?

How Super Falcons qualified for 2023 FIFA World Cup

■ Book semi-final clash against host Morocco ■ Pinnick praises 'resilient' Falcons Nigeria, 15th team to qualify for 2023 FIFA WC

igeria qualified for the 2023 FIFA Women's World Cup finals after a lone goal by Rasheedat Ajibade steered the Super Falcons to the semi-finals of the ongoing Women Africa Cup of Nations in Morocco at the expense of Cameroon's Indomitable Lionesses.

Ngozi Okobi-Okeoghene made a bold run at the Cameroonian defence supported by twists and turns and the ball somehow landed at the feet of gangling Ifeoma Onumonu, who heaved the ball into the box for Ajibade to nod past Ange Bawu for the only goal of the match in the 57th minute.

The nine-time champions dominated a physical game right from the onset and could have led by at least two goals in the first period only to be undone by near misses.

In the 7th minute, Onumonu, who scored the first goal in the 2-0 defeat of Botswana in Group C that rejuvenated Nigeria's campaign following the opening game defeat by South Africa, headed Okobi-Okeoghene's well-weighted

free-kick over the sticks. In the 24th minute, Onumonu and Ucheibe were involved as a melee ensued in the Lionesses' vital area, but Bawu was up to the task.

The two teams abbreviated each other's opportunities with very close marking in a turgid second half. However, after Nigeria scored, Gabrielle Onguene lashed at the Nigeria goal but it went far away.

Ajibade's headed goal, her third of the tournament, took Nigeria to eight goals in the championship with only two conceded – both against South Africa – and their reward is a potentially-explosive semifinal duel against the slick host nation, Morocco.

Meanwhile, President of the Nigeria Football Federation and FIFA Council Member, Mr Amaju Melvin Pinnick has showered praises on the Super Falcons, saying their resilience against the fit-fighting Indomitable Lions reflected the fabled Nigerian spirit.

He said, "I congratulate the

He said, "I congratulate the girls for a strong performance against another strong team. They showed that truly, Nigeria is the powerhouse of African women's football. They held firm to victory even in the face of pressure towards the end.



"Their strength and perseverance were highly commendable. They have done very well to qualify for the FIFA World Cup. Now, we can aim for retention of the trophy," he added.

The Super Falcons have set up a mouth-watering semifinal duel against host nation Morocco, with vintage football expected from both teams who have already qualified for the FIFA Women's World Cup.

Nigeria's Super Falcons on Thursday night became the 15th team to qualify for the 9th FIFA Women's World Cup finals, to be staged in Australia and New Zealand from 20th July – 20th August next year.

Hosts Australia (with five venues) and New Zealand (four venues), as well as China, Korea Republic, Philippines, Vietnam, Japan, France, Spain, Sweden, Denmark, United States of America, Morocco and Zambia are the other teams.

The 5th and 6th –placed teams at the ongoing tournament in Morocco will have another shot at qualifying for the World Cup, as they join eight other teams for a Playoff Tournament early next year.

Nigeria is one of only six teams, among them the USA, Germany, Brazil and Japan, to have played in every edition of the FIFA Women's World Cup finals since the championship was launched in China in 1991.

The Atletico Madrid of Spain forward, Ajibade was named the Woman of the Match.

WAFU B change draw date, venue for WCL

The West Africa Football Union B (WAFU B) have shifted the date previously slated to hold on Tuesday 12 to Wednesday 20 July for the draw of the zonal qualifiers of the Confederations of Africa (CAF) Women's Champions League.

WAFU B had earlier slated the draw for the zonal qualifiers of the CAF Women's Champions League at Ivotel Plateau in Abidjan but rescheduled it to take place in Morocco.

According to the information by the zonal football governing body, a notification will be communicated in due course to keep football associations in the zone

abreast with further development.

WAFU's statement read: "We hereby bring to your attention that the draw for the WCL 2022 initially scheduled for July 12th, 2022 in Abidjan, is postponed to July 20th, 2022 in Morocco. The re-transmission links will be communicated in due course."

Barcelona, De Jong dilly-dallying over United move

Barcelona have accepted Manchester United's offer for Dutch midfielder Frenkie de Jong and expect the player to honour the move to Old Trafford likewise The Trumpet gathered.

Reportedly, the 25-yearold prime target for Red Devils' coach, Erik ten Hag in the summer, who once was under the tutelage of the Dutch gaffer in Ajax, is adamantly against the move to the English Premier League.

According to several reports from Europe, Manchester United have promised to build the team around De Jong in a way to convince him of the club's plans for him.

While United think big for the player, he does not fashion a move to a club he would be denied the Champions League football in the new season; a related incident Cristiano Ronaldo is presently engulfed with.

However, Catalans were initially against the move with President Joan Laporta, during the tribute to club legend Johan Cruyff, reiterating that De Jong is not for sale at any price.

Every decision has a price and Barcelona which are highly engrossed in financial difficulties in a dramatic turn, have accepted the United's offer reportedly about €70m with add-ons that would see it rise to circa €80m.

With this agreement reached between both clubs, the final decision lies on the Dutch who still has a contract at the Camp Nou to heed the Blaugrana's wish of honouring the move to Manchester United.

Reportedly, Barcelona need the money from De Jong's deal to assuage other players' agreements, those whose contracts have expired and to wrap up some new deals.

Head coach of Barcelona, Xavi Hernandez is not happy over the move as reported by Mundo Deportivo because he needs the player in his squad for the new season's campaign but with the financial mess bedevilling the club, he has no option but to allow De Jong leave.

Despite the rigmarole, Blaugrana will have to look for a capable replacement for the Dutch midfielder of lesser monetary value with Manchester City Bernando Silva already on the Catalans' glimpses.

Mundo Deportivo added that De Jong's 'departure would also help players like the recently signed Kessie, Gavi and Nico González gain prominence'.

How Zambia secured first FIFA Women's World Cup ticket Reach first WAFCON semi-finals

Zambia women's national team secured the FIFA Women's World Cup ticket to Australia and New Zealand after they edged out West African side Senegal in the quarter-final through penalty shootouts at the Complexe Sportif Mohamed V in Casablanca.

The Copper Queens also from the 4-2 penalty victory against Senegal after both teams played a one-all stalemate at extra time, booked their first WAFCON semi-final place in history.

Senegal opened the scoresheet through Nguenar Ndiaye after both teams played a goalless first-half draw but the South African side responded 20 minutes to the ninety through Avell Chitundu's close-range strike to level the scoreline.

However, the inability of both sides to find the back of the net in the course of processing the extra time, forced the game into a first WAFCON quarterfinal penalty shootouts where Teranga Lionesses lost 4-2 to book a ticket back to Dakar.

"Zambia demonstrated their desire to win the match as coach Bruce Mwape made no changes to the impressive starting team that beat Togo in the last group game four days ago," CAF reported in a statement.

"Senegal gaffer Mame Moussa Cissé made a couple of changes to the team that lost narrowly to host country Morocco in their last group game.

"Mareme Babou, Anta Dembele, Ndeye Awa Diakhate and Nguenar Ndiaye were brought into the starting list for the Teranga Lionesses," CAF statement noted.

Consequent to the shootout, Siomala Mapepa, Misozi Zulu, Ireen Lungu and goalkeeper Hazel Natasha Nali scored for Zambia while Teranga Lionesses' Mama Diop, Haby Baldé were the only players that scored for Senegal.

Ajax eye Calvin Bassey as Martinez's replacement

Rangers and Super Eagles versatile defender, Calvin Bassey, has emerged as a target for Ajax who are eager to replace Manchester Unitedbound Lisandro Martinez.

Bassey has been on the radar of European clubs with Aston Villa's Steven Gerrard reported being in need of the 22-year-old that broke into the spotlight in the second half of the season for the Gers.

The Nigerian defender, who grew from the ranks of Leicester City youth team and is valued at £25m by the Gers, has two years left to run on his

contract at Ibrox.

According to Daily Mail, 'Ajax have identified the Nigerian international as a replacement for Manchester United-bound Lisandro Martinez. The Dutch champions are set to rake in a £46m windfall for the defender and it's said Bassey is on their wishlist'.

Bassey's impressive development as one of the promising world-studded defenders, started when he was snubbed by Nigeria's senior men's national team for the TotalEnergies Africa

Nations Cup (AFCON) in Cameroon.

The Super Eagles defender is versatile and can play in the left-back and centre-defensive positions making him a suitable replacement for Martinez who played both positions for Godenzonen.



Why Bassey will be interested to embrace a new challenge in Eredivisie, Gers manager Giovanni Bronckhorst would be opposed to the deal in a bid to keep the player by an extra season at Ibrox for Champions League group stages' qualification.

Rangers recently sold Calvin's fellow compatriot and Super Eagles midfielder, Joe Aribo to Southampton but are reportedly 'sweating over the futures of Ryan Kent and Alfredo Morelos as the duo enter the final 12 months of their contracts.

Friendlies: Super Falcons, USA clash in September

ine-time African c h a m p i o n s Nigeria will fly to the United States of America for a two-match tour against the United States Women's National Team (USWNT) in September.

Both teams, presently competing in their respective continental tournaments, will clash at the Children's Mercy Park in Kansas City, Kansas on 3rd September and then have a go at each other's jugular once more at the Audi Field in Washington, D. C. on 6th September.

The USWNT is the most successful team in the FIFA Women's World Cup, having won half (4) of all eight championships competed for so far. The Stars & Stripes were champions of the very first edition in China in 1991 and then won on home soil in 1999, in Canada in 2015 and France three years ago. The team has also won four Olympic women's football gold medals and eight CONCACAF titles.

The Super Falcons billed to

face Cameroon in the quarterfinals of the ongoing Women's Africa Cup of Nations on Thursday evening, have won the African championship nine times, played in every edition of the FIFA Women's World Cup and also played in 2000, 2004 and 2008 Olympic women's football tournament. They remain the most successful women's team on the African continent.

The Children's Mercy Park is home to Kansas City in the US National Women's Soccer League and Sporting Kansas City in the Major League Soccer, while Audi Field is utilized by National Women's Soccer League side Washington Spirit and Major League Soccer team, D. C. United.

The match in Kansas City will see Vlatko Andonovski, appointed Coach of USWNT at the end of 2019, return to his home area for the second time. It is the sixth time that the USWNT will be playing at the Children's Mercy Park but it is their first time at the Audi Field, though they have played 10 times previously in Washington – all at the RFK Stadium



Andonovski says he's excited to send out his girls against the Super Falcons: "First, I'm just excited to play two matches against Nigeria. They have some very talented players who will present a lot of different problems for us to solve on both sides of the ball.

"Secondly, of course, we're looking forward to bringing the team back to one of the best soccer stadiums in the United States in Kansas City, as well as getting to play our first game at Audi Field, which I've visited several times for NWSL games and is

also a fantastic venue for our team to play in front of our home fans," USWNT coach added.

The USWNT has already qualified for the 2023 FIFA Women's World Cup, becoming the 12th team to reach the finals and the first team from the CONCACAF region.

Nigeria's Falcons are also coached by an American, long-time college coach Randy Waldrum – who is aiming for a FIFA Women's World Cup ticket and first African title with Nigeria in Morocco.

Maduka Okoye relishing his time with Watford

Super Eagles goalkeeper, Maduka Okoye is having a good time in his club and English Championship side, Watford, in their pre-season tour as they work to kickstart a return to the England top-tier division in August.

Okoye signed for Watford from Sparta Rotterdam during last season's winter transfer window but returned on loan to Het Kasteel to complete the remaining part of the 2021-2022 season in Eredivisie, the Dutch topflight league.

The 22-year-old goalie, who was handed his first international cap by the former Super Eagles' German gaffer, Gernot Rohr on October 9, 2019, in a friendly match against Ukraine that ended 2-2, has earned a total of 16 caps for the national side

In an interview with Watford TV during a training session, Okoye said the game was tough in the first half but noted that the Hornets found a way out in the second half.

"I think it was quite difficult in the beginning and is understandable because we just came together and that's a new thing for us. But yeah, I think we will find our way and you could see in the second half we did way better and that is progress," Okoye told Watford TV.

The Super Eagle added that he is relishing his time with the Hornets, stressing that his teammates are fantastic.

He said, "Yeah, fantastic. Having a great time with my already funny guys, funny teammates, good vibe in here. And I think that's important. Feeling connected to the players and the staff.

"Ihad a good time there [Austria]. We worked very hard. But we had fun with a smile on our faces and I think we made good steps in the right direction in Austria. And now we're just out here continuing the with the work," Okoye added.

The Hornets open their 2022-23 English Championship campaign with Sheffield United on August 1 at Vicarage Road with coach Roy Hodgson eyeing a quick return to the English top-tier division.



AFN, ministry's negligence affected my participation in Oregon, Birmingham Games, laments Ezinne

United States-based Nigerian Athlete, Ezinne Abba has lambasted the Ministry of Youth and Sports Development and Athletics Federation of Nigeria (AFN) for negligence that has resulted in her ineligibility to compete in the 2022 World Athletics Championship in Oregon and the Commonwealth Games in Birmingham.

Ezinne recently switch her allegiance from the USA to fulfil her dreams of competing for Nigeria on the world stage but met a shocker in her life when a week for Nigeria contingents to journey to the USA for the World Athletics event, she was told her name was not on the list.

According to 100 & 200m sprinter who came second in 100m race at Pac-12 Track and Field Championship, Hayward Field, Eugene, Oregon, on May 15, 2022, she has prepared herself mentally and physically for the contest after her first hamstring injury

"It has always been my dream to compete for Nigeria on the world stage. But, despite

reaching the world standard, flying to Nigeria alone, s witching my allegiance from the US, and

mentally/physically preparing myself after my first-ever hamstring strain, the athletics federation of Nigeria has failed me," Ezinne lamented.

"The negligence and egocentric actions of the Minister and other [administrators] have once again overcome the federation which negatively affects the athletes," the Nigerian athlete complained.

Ezinne three months ago, ran her personal best in the 100m sprint of 11.12s at Mt. SAC Relays, Hilmer

Lodge Stadium, Walnut, California.

The disheartened 21-year-old claimed that she was informed about 40 minutes before her flight to Oregon adding that the federation are being coarse by irrational fear.

She added that of the three required drug tests for competing athletes, she has successfully completed two (2/3) while being denied the third for fear of failure on the part of the federation.

Ezinne continued: "Why am I being told 40 minutes before my flight to Oregon, the week of competition, that I'm no longer competing because of their wrongdoings and irrational fear? I have already passed 2/3 drug tests, but for some reason, I am not allowed to do my third test because of fear of failure."

She opined that despite the changes the federation is undergoing by hiring new staff to rejig the system, the national athletics governing body is still submerged in corrupt practices.

"They speak repeatedly about trying to fix the broken system that is Nigerian athletics by firing and hiring all new staff but the corruption still lives. I, unfortunately, will not be competing at worlds or the commonwealth games," Ezinne said.

Recall that in Tokyo Olympics 2020, Nigeria selected 23 athletes of which 10 were denied to compete including Annette Echikunwoleke who switched allegiance for not having an Out of Competition Test (OCT).

Preceding Blessing Okagbare's doping case, Nigeria have been kept under strict surveillance by the Athletics Integrity Unit (AIU) in charge of doping issues since reportedly, the country has not been testing their athletes as it ought to be on doping.
