# PDP unperturbed as court reserves verdict on suit against Osun victory

ational Publicity Secretary Peoples Democratic Party (PDP), Hon. Debo Ologunagba, has dismissed anxiety over the fate of its victorious candidate in the recent Osun State governorship election.

It follows an update on a suit against Governor-Elect, Senator Ademola Nurudeen Jackson Adeleke by aggrieved PDP gubernatorial aspirant.

He said: "the people of Osun have spoken and they gave spoken well. Nobody should

himself seeking victory through the back doors.

"We are aware of the Zamfara example but ours is a different case. When you go to court, vou state vour case and prayers but leave the technicality of the case to the presiding judge.

We are not disturbed at all and at the end of the day, we shall come out of court victorious.'

There is apprehension Osun over the possibility alleged Adeleke of losing given mandate him at last Saturdays governorship election.

This follows reservation the judgement by Appeal Court sitting in Akure, Ondo State

in a case instituted by Prince Dotun Babayemi on the eligibility of Adeleke as the party's torchbearer in the July 16, 2022 election.

He sued Adeleke and the party, alleging that he emerged from an illegal primary election.

Babayemi and his faction of the PDP held a parallel primary with the one that produced Adeleke.

Although INEC officials monitored the exercise conducted by the Osun Governorship Primary Committee appointed by the national secretariat of the party, but Babayemi is at but at the Court of

It is feared that this pre-election case of who is the authentic candidate of the PDP, if not amicably settled out of court, may spell doom for the party and Adeleke.

Groups opposing bill include Southern and Middle Belt Leaders Forum, Nigerian Bar Association, Afenifere, Ohaneze Ndigbo, Pan Niger Delta Forum (PANDEF), Urhobo Progress Union (UPU) Ijaw National Congress, among others. notable voice against the bill is Nobel Laureate and playwright, Professor Wole Soyinka.

On September 15, 2020, Corporate Accountability Participation Public Africa (CAPPA) and Amalgamated Union of Public Corporation Civil Service, Technical Recreational Employees (AUPCTRE) had led a delegation of civil society and labour allies to a meeting with the Minister of Water Resources, Engineer Hussein Suleiman Adamu to whom a harmonised and well highlights laid-out clause-by-clause analysis of the bill was

submitted with specific recommendations encapsulating voices and concerns of the public.

Contentious sections of the earlier version included Section 98 which stated that, "the use of water shall be subject to licensing provisions," Section which made compulsory for Nigerians to obtain a driller's permit before sinking borehole in their homes, and Section 107 which says, a licence might be cancelled if the licensee fails to make "beneficial" use of the water.

CAPPA questioned determines beneficial use of water. Some of the identified problematic provisions in the previous bill are still recycled in the "revised" version.

If it becomes law, it will empower the Federal Government to control all water resources such rivers, streams, lakes, underground water in all parts of the country. It also makes a strong case for the much-discredited Public Private Partnership (PPP) water privatisation model.

In a statement issued

Lagos, however, described the so-called revised version as exactly the same bill that was roundly rejected by Nigerians and interest groups.

According the group,  $reint roduction \, of \, the \, bill \,$ is an insult to Nigerians from all the geopolitical divide, including sociopolitical groups that have kicked against it from the beginning because of its many anti-people provisions and the ulterior motive of its promoters.

**CAPPA** Executive Akinbode Director, Oluwafemi said:

"It is distasteful that the promoters of the Bill did not consider of the objections Nigerians about the draft Bill but only moved them to other sections with the intent to deceive Nigerians."


Oluwafemi explained that a clause-byclause analysis the re-presented bill conducted by CAPPA showed that regardless of the "re-packaging" re-arrangement of its sections and a few expungements, it still fails woefully to meet the obligation of integrating the tenets of Human Right to water and sanitation.

The group warned that the bill, if allowed to scale through, would result in dispossessing a section of Nigeria of inherited and cultural rights to water and this is by no means an equitable venture.

Further, it noted that a dysfunctional consequence of the bill is the establishment a new Federal Government Commission, Institute and Boards to take over responsibilities of the states on water within

tjeirvterritorial jurisdiction which runs contrary to the spirit of true federalism.

CAPPA reiterated its call that a pro-people bill should prioritize the normative elements accessibility, affordability, availability of water as mutually exclusive components of human ordinary rights by Nigerians' citizens. water remains a natural resource which should not be commodified, it warned.



# Terrorists kill another Catholic priest in Kaduna

decomposing body of the Kaduna priest was discovered on Tuesday, July 19, while his colleague was released after a ransom was paid

Reverend Father John Cheitnum, one of the two Catholic priests abducted in Lere Local Government Area (LGA) of Kaduna State, has been killed by his abductors.

Until his abduction and killing, the victim was the Director of Communications the Catholic Diocese of Kafanchan, as well as the Chairman of the Christian Association of Nigeria (CAN) In Jema'a LGA of the state.

Father Reverend Cheitnum and his colleague, Reverend Father Donatus Cleopas, were kidnapped bandits on July 16 while they were on pastoral work at the rectory of Christ the King Catholic Church, Yadin Garu in Lere LGA.

According to by statement

Chancellor of Kafanchan Catholic Diocese, Reverend Emmanuel Okolo, the decomposing body of the priest was discovered on Tuesday.

Reverend Father Cleopas, on his part, was said to have been released by the bandits after an undisclosed amount of money was paid to them as ransom.

This was contained in a statement by the Chancellor of the Catholic Diocese Kafanchan, Rev. Fr. Emmanuel Okolo.

statement read, "Sequel to the announcement of the two kidnapped priests from our diocese, we announce wish to that Rev. Fr. Donatus Cleophas escaped from his abductors and has reunited with us.

"However, it is with a deep sense of sorrow and pains that the Bishop, Clergy, Religious and Laity of the Diocese of Kafanchan announce the gruesome murder of Very Rev. Fr. John Mark Cheitnum.

"Fr. John Mark, who was abducted from the rectory of Christ the King Parish YadinGaru, Lere L.G.A of Kaduna State, was brutally killed by his abductors on the same day of his abduction; Friday 15th July, 2022.

"Until his demise, he was the CAN Chairman, Jama'a LGA, as well as the Coordinating Chairman of CAN, Kaduna. Southern Cheitnum was Dean of Kwoi Deanery, Director of Communications in the Diocese of Kafanchan and the Pastor of St. James Parish Fori, Jama'a LGA, Kaduna State."

Channelstv.com reported that in recent times, Kaduna State has witnessed several kidnapping incidents, most of which were targeted at religious leaders.

In the last one year, the Catholic Church


Kaduna alone has lost three of its priests to banditry, while four others were kidnapped and only regained their freedom after ransoms were paid to their abductors.

Elsewhere, authorities in the state said security operatives have killed a notorious bandit who was part of the groups terrorising residents of Chikun LGA

The Commissioner for Internal Security and Home Affairs in the state, Samuel Aruwan, said the security forces intercepted some criminals at Kidunu general area around By-Pass in Ĕastern Chikun LGA, during an exchange of fire, one of the bandits was neutralised, while the rest escaped with gunshot injuries.

He said two AK-47 rifles, charms, and amulets, as well as two motorcycles and a mobile phone, were recovered from the bandits during the operation.

# Why I had surgery in Nigeria — VP Osinbajo

Ithough his doctors advised him to consider doing the surgical operation to correct a fracture on his right femur (thigh bone) abroad, the Vice President, Prof. Yemi Osinbajo insisted on using a Nigerian hospital and medical experts for the procedure.

According to sources close to Duchess International Hospital where the operation took place on Saturday, some of the government and private practice doctors of the Vice President made the suggestion because the going abroad option is often usually considered by

such class of patients and at times the option could also seem more seamless.

But one of the doctors who coordinated the whole operation, Dr. Yemi Onabowale, who is the founder of the Reddington Hospital, was quoted to have said "the VP was clear that he had confidence in Nigerian doctors both at home and abroad and would prefer they handle the operation."

His preference to have the surgery done in Nigeria is also being regarded as a major boost for the government's often stated objective of a reversed medical tourism as some voices in the healthcare sector have expressed excitement at Prof Osinbajo's choice.

He was also said to have argued that doing the operation in Nigeria would not only encourage Nigerian doctors who are among the best anywhere in the world, but it would also help develop the capacity here in Nigeria warmly including groups of doctors like some NMA chapters and other public intellectuals

Meanwhile, the Federal Executive Council, FEC, has wished Prof Osinbajo a quick recovery, after the successful operation.

FEC conveyed its

goodwill message in a statement yesterday in Abuja by the Secretary to the Government of the Federation (SGF), Mr Boss Mustapha.

Mustapha said the surgical operation, possibly related to a long-standing injury associated with the game of squash, was performed by a team of specialist doctors in Lagos.

"As Prof. Osinbajo recuperates from the surgical operation, FEC wishes him quick recovery so as to continue to give the needed support for the overall growth and stability of the country, " Mustapha said.

# Indigenous firm moves to rescue Nigeria's shipping industry from foreign dominance

An indigenous firm, White Dove Shipping Limited, has set out to rescue the industry from foreign dominance by effectively catering for the evacuation and export needs of local producers as well as providing employment to Nigerian seafarers.

Chief Executive Officer of the firm, Chiemezie Ejinima, in a virtual media roundtable said there are few indigenous shipping companies operating in the country due to the capital intensive nature of the shipping business, thereby giving opportunities to foreigners to dominate the industry.

He said while the marine industry remained quite lucrative with different segment of shipping, lack of funds to acquire equipment and vessels for indigenous players to operate in the market, especially in the evacuation of crude oil, had led to the dominance of International Oil Companies (IOCs).

Ejinima said the gaps led to the incorporation of the shipping firm in 2017 to help provide robust marine equipment spread for crude oil evacuation, storage, offloading, terminal services and general marine operations, especially for local manufacturers.

He said: "We saw a lot of indigenous players having problem with their crude oil evacuation and so we came up with this strategy to evacuate their products by using vessels and tankers. We set up a one-stop shop for full evacuation of crude oil from the point of production to export.

"We have a retinue of vessels from the storage vessel where the oil company produces into to a host of shuttle vessels, which are basically medium range tankers that move those crude from the storage vessel to offshore and then to the terminal."

He added that while transportation of crude oil through pipeline poses several risks to communities and loses to the producers, the firm is helping the indigenous producers to ensure that they adequately account for the exact amount of crude oil they produce after shipment.

"Currently we are able to take capacity of 60, 000 barrels of crude oil per day, but we hope to have sufficient capacity to cater for more than 150, 000 barrels of crude oil per day. Our marine fleet has to increase extensively. Now we have one terminal, four floating storage and offloading (FSO) vessel and one Very large crude carrier (VLČC), our plan will be to increase to three VLCC to be able to take care of the terminal and export needs of Nigerian

oil and gas companies.

He said with this, the firm is helping to eliminating opportunities for incidence of crude theft and that the impact will ensure the indigenous oil companies get value for their investment, while the government adequately gets returns that are due to them through royalties and taxations.

Ejinima also noted that the firm, with its capacity is providing sea time and jobs to cadet and seafarers to bridge the knowledge gap between Nigerians and foreigners as well as eliminate unemployment of seamen.

According to him, the firm engage 90 per cent local workforce, adding that most of their vessels are manned by Nigerians with the aim of achieving close to a 100 per cent indigenisation.

Most of the foreign vessels and foreign owned companies prefer to bring in their own expatriate staff, but our philosophy is to develop Nigerians and that is what we are doing," he stated.

Speaking on challenges affecting the industry, Ejinima said the 100 per cent rise in energy cost, especially marine gas oil has increased operational expenses, noting that this will not deter the firm from providing adequate services to its clients in the upstream oil and gas industry.

#### Aviation unions to shut airports in support of ASUU

Two unions, Association of Nigeria Aviation Professionals (ANAP) and the National Association of Aircraft Pilots and Engineers (NAAPE), have urged governments to end the lingering industrial action embarked upon by Academic Staff Union of Universities (ASUU) in the interest of the nation.

The unions have also threatened to embark on a nationwide protest on July 26, 2022 and July 27, 2022

In separate statements issued by Deputy General Secretary of NAAPE, Umoh Ofonime and the General Secretary of ANAP, Abdulrasaq Saidu, the unions stated that they would be shutting down the country's airspace in solidarity unless urgent steps are taken to address

this misnomer.

ANAP explained that not only the students are suffering but parents and the society, adding that the poor economy has also affected every home in the country, noting that education remained the bedrock of any nation aspiring for greatness saying that ASUU strike will eventually lead to a regrettable situation in future if not well handled

"Our children are using eight years to read courses of four years with resources being wasted. We cannot continue this way," it stated.

way," it stated.

ANAP further warned that their members will align with the Nigeria Labour Congress' (NLC) position on protest against the unfortunate situation in the tertiary education

stating that all members have been put on alert in solidarity actions on the directive of Nigeria Labour Congress at very short notice," the statement added.

In a statement titled: Our Children In Tertiary Institutions Cannot Remain At Home Perpetually, NAAPE said it observed with regrets how the Federal Government is treating the crises in the educational sector, resulting to strikes, as the teaming students have remained at home for over four months.

It said: "The refusal of the Federal Government to honour the agreement signed with the union since 2009 is very disturbing considering the negative impact the prolonged strike will create in the life of these children.

"NAAPE, therefore, completely support the position of the National Executive Council of the Nigeria Labour Congress (NLC) to embark on a nationwide protest on July 26 and 27, 2022 in solidarity with the trade unions in the Nigeria Public Universities and others.

"By this, the National Administrative Council (NAC) has directed that all branch chairmen and secretaries are requested to disseminate this information to all the members in their various branches to participate in the solidarity protest in their various states."

Lagos State Commissioner of Police, CP Sylvester Abiodun Alabi, can fittingly go for a man of peace. Describe him as a diligent Police officer and you're not far from the truth. Say he is an unrivalled manager of human and material resources, you're definitely on point. As the new Commissioner of Police in the state, Alabi has not only emplaced a unique policing stratagem, he has also distinctively galvanized officers and men of the command on intelligence-led community policing model. This has engendered peace and serenity for thriving socio-economic activities in the state. The workaholic Alabi who says he sleeps for only two hours daily, speaks on his policing model that has earned him commendations from Governor Babajide Sanwo-Olu and Inspector-General of Police, IGP Alkali Usman Baba. He says policing Lagos State requires no rocket science: "just know the evolving crime trend and pattern and put in place the necessary modalities." As Commissioner of Police in the past five months plus has been very interesting as well as challenging, he said in an encounter with **The Trumpet** during which he spoke on critical issues in policing Lagos State. Excerpts:

You have been in Lagos State for over five months plus now as Commissioner of Police; how has it been like

fighting crime in the state? A: Like you rightly said, I took over on 24th of January this year and in the next couple of days I would have been six months old in Lagos State. My experience; it has been very interesting and challenging. Like I said in my maiden briefing, I said I was going to study the patterns and trends of crime and that will guide me to put in place some strategic plans on how to police Lagos and that is exactly what I did. I went to the records through our statics and realized that the prevalent crimes in Lagos were cultism, traffic robbery and occasionally, murder cases arising from landing disputes. After studying that, I quickly put in place some certain plans towards reducing traffic robbery to the barest minimum and also to reduce the wave of cultism. And I think by the grace of God, we have been able to do that in these past five months. Although, we still have some pockets of cultist rivalry clashes but not as prevalent as it was when we came on board. Then the issue of traffic robbery has been reduced drastically, it is almost at zero level now because in the first two months, we used to see on social media about people that we attacked, trying to tell the whole world that we were attacked on traffic but you can bear me witness now that, that doesn't exist again. So we have been able to reduce that and we shall continue to do our best to ensure that it doesn't resurface again. Principally, we have really put in place certain strategies to ensure that traffic robbery is a thing of the past in the state.

Lagos State is a peculiar one when it comes to crimes and criminality. What has been your greatest challenge so far?

A: Yes, like you rightly said, Lagos is a peculiar state, it is a unique state that allows a unique way of policing, it is an industrial form of commercial nerve center, it is a kind of mini-Nigeria. The best way to police Lagos is to get everybody involved and practically gets the various people, the communities involved as a follow up to our policy trust of which of this is community policing; to engage various stakeholders, to partner with us, the Police cannot do the job alone without having collaboration and co-operation with other security agencies. These are critical stakeholders, so I charged my Area Commanders and DPOs to always be at stakeholders' meetings every week or fortnightly, so that they can reappraise their work, so that they can listen to information of intelligence from the people. Let me particularly mention the relevance and importance of the Lagos Neighbourhood Watch, they have been wonderful, they really set plans in policing Lagos State very well by sharing intelligence and relevant information with

Let me also mention the importance and efforts of the DSS in the state for their information and intelligence sharing. The Director has been very wonderful. he is really cooperating with us and we are working together and that has helped us to bring down the crime rate in the state to the barest minimum because of intelligence sharing. Beyond that, I have been able to galvanize the Rapid Response Squad, to response to distress calls swiftly and our response has now remarkably improved and the DPOs, the officers and men to be sincere, I want to be frank with you, I want to salute their resilience, their commitment and dedication to duty. They have been very wonderful with special reference to responses to distress calls because I monitor the command every second through our communication system and that enables me to get abreast of what is going in the state to know if there is any area I need to change my strategy or if there is any area I need to galvanize my men the more so that we can respond adequately to distress calls. However, we do have problems with logistics but again, it is not peculiar to Lagos State Command alone; it is all over the country. Logic has always been the problem of the Police. The Police is poorly equipped and I am sure you are aware of that and that is why kudos should be given to us because even with the tools, the limited tools that the police is given, we have been able to achieve this, you can image if we are well equipped and have the wherewithal and equipment to work with adequately, you would agree with me that we would have done even much better than what you're seeing. Talking about logistics, I still have some Divisions with only one patrol vehicle but I still want to appreciate the government of Lagos in that regard because they have been very helpful in terms of provision of vehicles, fuel and motivation for the men occasionally to do their best and that has contributed to the successes we have recorded so far. But like you said, we have a logistic problem but the leadership of the force have tried their best because recently we

received five trucks and vehicles from the IGP to do our job very well. And recently too, the men have been motivated in terms of welfare by the leadership of the Force in such a way that it will bring succor to us.

How has the ban on motorcycle riders affected the rate of crimes and criminality in the state?

Honestly, the ban has greatly reduced the rate of crimes in the state. In fact there is a positive correlation between the ban on motorcycle riders and crime in the state; yes, I can attest to that because I have the statistics. If you recall the interview I had with the Channels TV, I made it clear that some of these criminals masquerading as motorcycle riders are armed robbers, yes, most of them always dispossess their victims of their belongings where they carried them to, some even after their commercial activities with their

to crime. I can authoritatively tell you that so many of them were arrested with locally made pistols and they have been charged to court accordingly. Honestly, like I said, there is a positive correlation between the ban on motorcycle riders and crime in the state, the ban has really brought down the crime rate in the state. So I want to also implore the government to extend the ban to some other local governments particularly, Festac area, Ejigbo and Agege, Kosofe local government- Ketu and Alapere areas, because we are still having some pockets of issue with motorcycle riders in these areas. It has even been confirmed by the Controller of Immigration when we had our last security meeting with the governor that most of these riders are non-Nigerians, majority of them are from outside the county and that was why we said he too should assist the state by profiling them to know those who here illegally so that they should be deported back to where they are coming from.

So, what is your advice to criminals and would-be criminals in the state?

I have said over and over again even when I took over the mantle of leadership of the Police in the state that Lagos is not a hiding place for criminal activities and we have been carrying the war to their dens as a proactive measure, we been doing constant raiding of criminal hideouts and we have been having results to that effect. So my advice to them is to relocate from the state or the long arm of the

law will catch up with them.

Is there anything you want to tell us that we didn't ask?

Well, what I want to say is that members of the public through our community policing partnership program have been able to build the confidence and trust in us, but we want to solicit their support the more because there is no other Police than the Nigeria Police Force and they should understand that we are serving them and working for them and we shall continue to do that so that they can have the enabling environment to go about their lawful businesses. That can only happen if they continue to share information with us, share intelligence with us and that will be treated with utmost confidentiality without betraying any of them and at the end of the day by the grace of God, Lagos will be very peaceful for all of us to live in.

# Ondo farmers protest against attempt to seize their land

Farmers in Idanre Local Government Area of Ondo have stormed the streets to protest against the plan by the state government to seize their land for private

The protesters alleged that the state government had given about 50,000 hectares of their land to private business owners for 99 years. The farmers lamented that over 20,000 of their farmlands had been destroyed.

Also, Hon. Festus Akingbaso, Ondo State House of Assembly representative for Idanre Constituency, kicked against the state government's plan to sell land owned by his people to private companies. Akungba in a statement revealed that the state government had arrogantly granted private business owners 99 years of access to about 50,000 hectares of land in the Idanre Forest Reserve.

He said: "There have been rumours and unrest around a supposedly planned action by the Ondo State Government to hand over the land of my people in Idanre to private businesses for a while.

"The fact is that the area known as Idanre Forest Reserve (A05) was submitted to the colonial power under British indirect rule by an agreement dated 22nd day of September, 1918, between Idanre Community and the colonial power represented by the Governor – General. "The terms of the agree-

ment are explicit. Among which is that the area was constituted as a Forest Reserve for the joint use and benefit of the government and the native communities owning the land. Above ciear and e and to Idanre people it is a running covenant in respect of the area.

To the dismay of Idanre people the government of Ondo state without regard or deference to the Owa of Idanre and the people has arrogantly given about 50,000 hectares of land in the area to private business owners for 99 years.

"The following companies are known to be behind the moves to grab Idanre Land. These are Blue Sky Ltd (4000

hectares), Sao Agro services Ltd (10,000 hectares) and Rex (30000 hectares).

"On Sunday, the 17th day of July 2022, SAO Agro services Ltd aided by eight vehicles loaded with person-nel of Amotekun Security Corps and officers of the Nigerian Army invaded Ofosu area with a Bulldozer to begin the destruction of farm lands of over 20,000 farmers who are presently farming on the land.

"It is our believe that to alienate about over 50,000 hectares of land to private people to the defriment of over 20,000 citizens is immoral and illegal

ople will not watch while the government is giving away the legacies from our forefathers and what should serve the future generation of Idanre away to few business men.

The reality on ground is that the government will not be able to manage the economic and social consequences of this move. Government exists to protect the interest of the people, not the few opportunists in our midst.

"I'm appealing to the

# Ghana confirms first cases of Marburg Virus

hana has confirmed its first two cases of the deadly Marburg virus, a highly infectious disease in the same family as the one that causes Ebola.

It says both patients died recently in hospital in the southern Ashanti region.

Their samples came back positive earlier this month and have now been verified by a laboratory in Senegal.

Health officials in the West African nation say 98 people are now under quarantine as suspected contact cases.

These include relatives, medics and mortuary workers who came into contact with the two patients.

This is the second time that Marburg has been identified in West Africa. There

was one confirmed case in Guinea last year, but that outbreak was declared over in September, five weeks after the case was discovered.

The World Health Organization (WHO), which is supporting Ghana's health authorities, has praised the country's swift response.

"This is good because without immediate and decisive action, Marburg can easily get out of hand," said Dr Matshidiso Moeti, the WHO's Africa

"There's a whole multi-disciplinary team in the field trying to ensure that we are able to unearth the real source of this," Dr Patrick Kumah-Aboagye, the head of Ghana's health service told BBC Focus on Africa radio.

Contact tracing and strict infection control measures have been introduced to prevent more fatalities.

Teams are also going into communities to make them aware of the symptoms and to ensure they alert health authorities if any suspected cases emerge.

No treatment yet exists for Marburg - but doctors say drinking plenty of water and treating specific symptoms improves a patient's chances of survival.

The virus is transmitted to people from fruit bats and spreads between humans through the transmission of bodily fluids.

Those at highest risk of getting infected include family members and hospital staff caring for someone who is sick.

It is a severe, often fatal illness with

symptoms including headache, fever, muscle pains, vomiting blood and bleeding.

Ghanaian officials are warning people to keep away from caves and to thoroughly cook all meat products before eating

Beyond West Africa, previous out coming breaks and sporadic cases have been reported in Angola, the Democratic Republic of the Congo, Kenya, South Africa and Uganda, the WHO says.

The virus killed more than 200 people in Angola in 2005, the deadliest outbreak on record according to the global health

The first ever Marburg outbreak was in Germany in 1967 where seven people

# Don decries policy inconsistency on environmental issues

A university teacher, Christian Madu, has expressed worry over policy inconsistency on environmental issues affecting the country.

Madu, a Professor of Environment Management and Control with University of Nigeria, Nsukka (UNN), stated this in an interview with the News Agency of Nigeria in Enugu.

He spoke on the sidelines of the ongoing massive felling of trees and deforestation across the country, as more Nigerians take to firewood and charcoal for energy for domestic use.

NAN reports that the recent development is a direct fall out of the rise in the price of kerosene to between N750 and N800, while a kilogramme of cooking gas has gone up to between N850 and N900 nationwide.

According to Madu, there are many reasons for the policy inconsistency in the environment sector in the country, stating, however, that the major problem is that government policies are not

synchronised.

"We offer contradictory policies and practices at the various sub-national and departmental levels which are different from the central or national policy.

"It will take good leadership to look into how the different units of government can work to achieve a common goal on environmental issues.

"Right now, all the units operate as independent islands to achieve their respective agenda, to the detriment of the central unit or," he said.

The don noted that it was rather unfortunate that most locals were already resorting to heavy use of firewood and charcoal for cooking and other domestic energy needs.

He said that this latest development was depleting the nation's forest resources and eco-system as well as endangering its trees.

"This is setting us back from all the campaign and sensitisation that many of us have concluded to encourage transition to the use of cooking gas as a cleaner energy alternative for the betterment of our environment," he added.

# Why APC lost Osun and the danger ahead

Saturday July 16, 2022, loss of the Osun governorship election by the All Progressives Congress to the Peoples Democratic Party was long in coming. It will take naivety or dishonesty or both not to acknowledge this.

It was an election the APC could have won hands down for many reasons. The first is the national weakening of the PDP. The party, having been alienated from power since 2015 and having no coherent leadership, is grossly and hopelessly adrift. It is no longer in a position to rally its members and command resources; many of its havens already crossed to the APC or Peter Obi's Labour Party.

Secondly, the party in Osun is divided into three factions, with three governorship candidates emerging from its fold; the main candidate (who eventually won), Senator Ademola Adeleke, Dr Akin Ogunbiyi, who flew the flag of the Accord Party, and Dotun Babayemi, who stepped down and supported Adeleke. At a point, Babayemi briefly enjoyed the ownership of the party's flag, following an interlocutory grant from a court and it looked then like Adeleke was out of the race.

The third factor was the quality of the PDP candidate. Adeleke is a scion of the Adeleke dynasty in Ede. Their father, Ayoola Adeleke, was Chief Obafemi Awolowo's ally and a Second Republic senator. Isiaka Adeleke, Demola's brother, was the Third Republic and Osun's first democratically elected governor and serving senator before his death on April 23, 2017. Demola brought nothing, other than his gawdy dance steps and unending controversy on his educational qualification.

The last is the fillip that the emergence of Asiwaju Bola Tinubu ought to have given to the candidate of the APC. It is well known that Osun is the ancestral home of the APC presidential candidate and Governor Gboyega Oyetola is his uterine relation. This should have rubbed off very well on the Osun election. Indeed, Asiwaju was in Osun a whole week before the election, coordinating the campaign and mobilising resources.

On a good day, it would have been impossible for the PDP to have won against the APC, given these factors.

It is curious then how the PDP won against all rational considerations and the APC managed to snatch defeat from the jaws of victory.

The first is the crisis that began shortly after the inauguration of Governor Oyetola in 2018. He probably felt he was his own man and wanted to assert his bona fide on the state and its politics. But he forgot that he became governor ex nihilo and his emergence as the candidate of APC was a result of the influence of Asiwaju, which almost cost the party the election. He saw the immediate past governor, Ogbeni Rauf Aregbesola, his benefactor, under whom he served as Chief of Staff for eight years, as a competitor. He, therefore, failed Green's first law of power which says, 'Never outshine the master.' The party never got over the crisis, going into the election, which eventually did

them in

The power of incumbency tends to give the occupier a false sense of superiority. Oyetola and his men were never short of this. His own is compounded by his blood relationship with Asiwaju. He had false confidence that Asiwaju alone would win the election for him. When the crisis in the party began, his supporters were wont to tell anyone that urged caution that just one word from Asiwaju to Aregbesola to go and work for Oyetola's re-election was enough.

Going into the election, he had divided the party into his loyalists versus Aregbesola loyalists; as if the election was between him and the former governor. He never made any attempt to reconcile the two sides, being fully persuaded that the other side was inconsequential to his re-election. Aregbesola was not a member of the APC election council nor was he personally invited by the governor to help him.

Rather, Oyetola surrounded himself with political minions, especially those who left the party in 2018 to contest against him. He added to the mix the traditional and ideological enemies of the party and enlisted just anyone who would join him in the fight against Aregbesola. They did not disappoint him. His term was noticeable for the fight with his former principal and everyone associated with him. He practically undid Aregbesola's programmes one after the other and stopped the ones he could not undo.

He was implacable and totally uninterested in any other thing. Anti-Aregbesola became the principal directive and guiding principle of governance. In that instance, sycophancy was not in short supply, as government officials openly

attacked Aregbesola and competed to outdo each other in this macabre dance.

Things began to deteriorate as the governor unofficially banned Aregbesola from coming to the state. Anytime the minister was billed to come to Osun for one assignment or the other, the governor's men will plant in the media, allegations that he was coming to foment trouble. It took a turn for the worse, out of power drunkenness, I guess, as Aregbesola's men were being arrested by the police and arraigned in court for no particular offence. Oyetola destroyed the coalition that made him governor.

Going into the election, the APC had become the old PDP, everything the people loathed, their nightmare long forgotten—in brigandage, thuggery, wickedness, selfish, patently anti-people, careless, rudderless, chaotic, vote-buying and worse, lacking ideological focus.

In contrast, Aregbesola as governor, after his inauguration in November 2010, hit the ground running. He had panache and engaged the people politically and governmentally. He was accessible, as his office and homes were accessible to the people 24 hours. His human intervention programmes touched every segment of society. Through it, he was able to transfer resources directly to the people. Even vagrants and lunatics were touched by his administration. He was able to expand microeconomics and unleashed prosperity never before experienced in Osun, which made him win elections, even after he demolished houses and owed workers salaries.

He raised the bar of governance and never ceased to excite the people until he completed his record two terms and left. He endeared himself to the people and they were hoping that his successor would maintain the tempo.

But Oyetola was elitist, with his government lacking any ideological focus. He was paying salaries and concentrated on programmes that reached not more than 25 per cent of the people, without much backwash effect. He was inaccessible, as the gates of his office and residence were shut against party members and the people. This amounts to disengagement from the people, and it came with serious deleterious consequences as the same people now look at the Aregbesola administration that Oyetola is fighting with nostalgia. It is not difficult for them, therefore, to decide on whom to support in the fight.

Going into an election, Aregbesola would leverage his performance. The party would have been organised in a top to bottom way, as members would be well mobilised on election day to the polling booths. But the party had been destroyed by Oyetola so he relied on vote-buying, even as his henchmen were boasting that they would simply write the result. While this policy got him a lot of votes, it could not get him enough to win. Many voters got his money and voted for the opposition, others simply refused to collect money and would rather vote their conscience.

The PDP winning, therefore, is rather a protest vote against Oyetola and not as much the love for Adeleke or his PDP.

Going into the general elections next year, there is still room to make amends and approach it with a united house, failing which the consequences would be disastrous for the party. This is because the PDP would be enlivened by this victory and would have more resources by then.

### El-rufai under attack for denying LP supporters usage of Arewa House

#### • 'It shows APC's jittery over Obi's rising profile'

overnor Nasir El-rufai has come under heavy criticism for the denial by Kaduna government of the usage of Arewa House in the state capital for a planned summit of the Peter Obi Support Network (PSON).

The frontline support group had unveiled plans to hold a summit specifically designed to interact with supporters of the frontline presidential candidate across the 19 Northern states of the country.

POSN berated the governor for his act of political intolerance while noting that the Arewa House is a public property and not El-rufai's personal building.

The state government had on Monday prevented the planned Northern Summit of the POSN in Kaduna. The summit was to further build support base for Obi ahead of the 2023 election.

The Governor was said to have ordered the denial through his spokesperson who allegedly called the Manager of Arewa House to notify POSN spokesman that "we cannot have Peter/Datti Northern Summit in Arewa House", less than 24 hours to the event.

The state government, however, failed failed to give further reason for turning down the group's widely advertised use of the venue.

Comrade Sani Saeed Altukry, Spokesman, Peter Obi Support Network (POSN) told newsmen that the summit is not a political campaign of any sorts, but a converge of volunteers and would-be volunteers and supporters of the Obi-Datti project, for necessary interaction and cross-fertilization of ideas.

"The event was initially billed to hold on the 19th of July 2022 at the popular Arewa House, Raba Road, Kaduna, Kaduna State, but the governor issued a directive cancelling the use of the venue after the group had paid for its use," he said.

POSN further stated that Governor El-rufai is too small to stop the "Peoples Movement" which Peter Obi represents vowing not to succumb to intimidation aimed at suppressing the liberation of northern Nigeria from under-development and poverty.

The statement reads, "we condemn the decision of the Governor of Kaduna state, Mallam Nasir El-rufai to block the hosting of the Northern Summit for Peter Obi and Senator Yusuf Datti Baba-Ahmed, the Presidential candidate of Labour Party (LP) and his running mate at the Arewa House in the state.

"The decision of the Governor is disheartening at the critical point in time when Northern Nigerians are desperate for development and liberation from poverty due to maladministration.

"The Governor of Kaduna state is intimidated by the rising profile of Peter Obi, the Labour Party's presidential candidate, across the length and breadth of the country.

"The Governor should know that this is a "Peoples Movement" which can never be stopped.

"The Movement represents all oppressed Nigerians and everyone that desires good governance, and Governor El-rufai is too small to suppress it."


PDP expressed optimism that Nigerians would continue to reject the APC and its candidates for foisting and presiding over unimaginable hunger and frustration in the country.

# Money laundering Act invalidates SCUML certificates

issuance of new ones begins soon

oney Laundering Act 2022 has invalidated the old Special Control **▲**Unit Against Money Laundering (SCUML) Certificates issued by the Economic and Financial Crimes Commission (EFCC).

EFCC Spokesperson, Wilson Uwujaren, in a statement said the fresh law altered existing regulatory framework, and renders all certificates not reflecting SCUML's new status as an agency domiciled in the EFCC invalid.

Uwujaren said the issuance of SCUML Certificate to businesses was suspended for administrative reasons to bring the Agency to fill compliance with its statutory responsibility. He assured that issuance shall soon commence.

"The Special Control Unit Against Money Laundering, SCUML is aware of the difficulties currently being experienced by successful applicants for the SCUML Certificate. This development was caused by the suspension of the issuance of certificates to successful applicants by the SCUML.

"The move is an administrative measure designed to bring the agency to full compliance with its statutory responsibilities and obligations under the new Money laundering Act, 2022.

"The law fundamentally altered the existing regulatory framework and substantially invalidates the certificates issued by SCUML, which did not reflect its new status as an agency fully domiciled in the Economic and Financial Crimes

"It therefore became imperative to suspend the issuance of the old certificates until a new one that takes into account the new regulatory environment is printed. Being a security document, there are processes involved in printing the new document.

"However, SCUML is delighted to announce that the procurement process for the production of the new certificates have been concluded and, a very soon, successful applicants will begin to receive notification to collect their certificates as machinery have been set in motion to ensure that the backlog is cleared with dispatch," he said.

SCUML empathised with applicants for the difficulties of the past few days to secure the certificate while assuring that all arrangements have been made to ensure that the process is returned to the established order of prompt and excellent service delivery.

### Senator admits receiving vehicles from Omokore in money laundering case

Fresh facts have emerged in the ongoing trial of Senator Albert Bassey before Justice Agatha Okeke of the Federal High Court sitting in Uyo, as he admitted on Thursday that he received vehicles from a contractor, Olajide Omokore while he was a commissioner in Akwa Ibom State.

The Economic and Financial Crimes Commission (EFCC) is prosecuting Bassey for alleged money laundering and being in possession of six vehicles worth N204 million, at the instance of Omokore, whose companies allegedly executed contracts for the Akwa Ibom State government.

According to the EFCC, the cars include Infinity QX 56 BP, valued at the sum of N45million; Toyota Land Cruiser V8 B, valued at the sum of N40million; Range Rover, valued at the sum of N40million; Toyota Hiace high-roof, valued at the sum of N27million, another Toyota Hiace high-roof valued at the sum of N16million and Toyota Hilux 4X4 valued at the sum of N36million.

"That you Albert Bassey (whilst being the Commissioner for Finance, Akwa Ibom State and Chairman of Akwa Ibom State Inter-Ministerial Direct Labour Coordinating Committee (IMDLCC) sometime in December, 2012 within the jurisdiction of this Honourable Court, indirectly took possession of a vehicle (Infinity QX 56 BP) valued at N45,000, 000.00 at the instance of one Olajide Jones Omokore (whose companies had contracts with Akwa Ibom State Government at that material time), when you reasonably ought to have known that the said vehicle formed part of proceed of unlawful activity (to wit: corruption) and you thereby committed an offence contrary to Section 15 (2) (d) of the Money Laundering (Prohibition) Act, 2011 (as amended) and punishable under Section 15 (3) of the same Act," one of the charges against the Senator read.

At the resumed trial of the matter on Thursday, July 14, 2022, Bassey, while being led in evidence by the lead defence counsel,

Kanu Agabi SAN, admitted receiving cars from Omokore.

According to him, he had been friends with Omokore for nine years before he joined politics. He, however, denied knowing Omokore's companies, and also denied being involved in the award of contracts to any of his companies in November 2013 before he left office as the Commissioner for Finance in April 2014.

In a cross-examination by the EFCC's counsel, E. E. Iheanacho, Bassey admitted that he was aware that contracts were awarded to companies while he was the Commissioner for Finance and the Chairman of the Inter-Ministerial Direct Labour Coordinating Committee-IMDLCC, but did not know if the said Committee he chaired received over N30billion as alleged.

The prosecutor further asked the Senator if he knew that the cars mentioned in the charge were luxury cars, Bassey affirmed that they were bullet-proof cars, but denied knowing if they were luxury cars.

Bassey was also asked if he would be

surprised to know that the said Committee he chaired, made payments to Omokore's companies during the period in question, and he responded that he would not be

Justice Okeke adjourned the matte to September 26, 2022 for adoption of written addresses.

### Court adjourns till Sept 26 in Naira Marley trial as EFCC presents more evidence

Trial of Azeez Fashola also known as Naira Marley continued on Friday, July 15, 2022, before Justice I. Nicholas Oweibo of the Federal High Court sitting in Ikoyi, Lagos with a prosecuting witness, Dein Whyte, an operative of the Economic and Financial Crimes Commission (EFCC) continuing his evidence even as the court dismissed the defendant's objection to the forensic evidence earlier presented by the witness.

Fashola is standing trial on an 11-count charge bordering on credit card fraud brought against him by the EFCC.

At the last sitting on June 9, 2022, the defence counsel, Olalekan Ojo SAN had objected to the witness's opinion on the forensic evidence linking the defendant to credit card fraud. He had argued that only the court could make pronouncements on the defendant's culpability, not an investigator.

However, at the resumed trial on Friday, Justice Oweibo delivered a short ruling in which he dismissed the defence's objection.

"It is the duty of the law enforcement agency or Police, charging a person to court to investigate if the defendant committed the crime or not. The investigator must be able to link the defendant to the commission of the crime. The prosecutor must have made up his mind as to the involvement of the defendant before bringing the case

to court. I do not agree that the prosecution has declared the defendant guilty," the

Continuing his evidence, PW3, Whyte, who was led by the EFCC Counsel, Rotimi Oyedepo, told the court that findings from his investigation, "clearly established that the defendant through his phone had in his possession credit card details that did not belong to him.

"That he shared this credit card information with another person and it was also discovered that a fraud report had been generated for the same credit card stating that it had been used fraudulently."

He said, investigation also revealed that the defendant had on his laptop "electronic tools that are specifically used for accessing compromised credit card information as well as other electronic tools that are used to disguise both the identity and location of anybody accessing compromised credit cards in real time on the internet.".

Explaining the role of his team before Exhibit E (forensic analysis) was produced, the witness said it was procedural in investigation for investigators to make a request to the Digital Forensic and Crime Laboratory Services Department to carry out forensic analysis of the content of recovered digital device of evidential value to a case.

In doing so, the investigator or investigating team will include specifics to guide the Forensic as to what is of importance to the investigation. These specifics guide the Forensic examiner in narrowing down the analysis and search", Whyte said.

While analyzing the forensics report, the PW3 revealed that the defendant had running on his computer, a VPN called IP Varnish (a tool used to disguise identity and location of the user).

According to him, "In relation to the contents found on the NOTES (a software application) on the devices of the defendant, wherein counterfeit card number was found alongside the details of the cardholder and an IP address, It would suggest that the only reason the possessor of this information will need an IP address attached to it, would be to satisfy the location specifics for consumption of transaction for merchants who require cards to be used only within countries and locations recognized by them.

"If these cards were to be used on the internet from Nigeria, the browser that is stated here will attribute in real time the location of the user to the IP address. And, If Nigeria is not the compliant location of the card issuer, the transaction will be blocked. But if this card when being used passes through a VPN and assigned with the IP address to conform with the compliant location of the card issuer, the Nigerian Location will be disguised and substituted to be Cardiff, thereby giving the merchant the impression that the card is being used from Cardiff or otherwise the compliant location."

Counsel to the defendant, Olalekan Ojo SAN objected to the evidence of PW3, on the grounds that he was not competent to give evidence on what went on in the mind of the user of the laptop.

"I wish to rely on the Provisions of S11(2) of Evidence Act in support of my objection. An investigating officer is not competent to ascribe a state of mind to any defendant. Whether the state of mind exists or not is a matter for judicial determination. PW3, though an investigator is not a psychologist but a forensic officer who cannot give evidence on the state of mind of a defendant", he submitted.

Responding to the objection, the defence counsel, Oyedepo said the learned silk missed the point. According to him, the "the question being answered by the witness is to connect if there is any relationship between Pages 8 & 27 of Exhibit E (The forensic analysis).

"The witness is not only competent to give that evidence, but rather in the circumstance of this case, is in the best position to bring life in the best way by explaining the relevance of the report of the forensic analysis that he sought for

# The blunder in not having state police (1)

The non inclusion of State Police in the Constitution was an error. It was a grave omission. The lapse occurred in 1976, forty-six years ago.

No one could have imagined forty-six years ago that our security challenges would become so grave to this level, that we now live in perpetual fear at the mercy of terrorists, kidnappers, Boko Haram, ISWAP, political thugs, armed robbers and the rest.

Who could have imagined that our country will be so mismanaged like this, to the extent that we are experiencing depression and bewilderment of crippling fear like a nagging hound of hell pursuing our every footstep, certainly no one.

Instead of emotional lamentation, bewailing or grieving, if we really wanted State Police, we could have had it. No need crying over spilled milk. There is no use stressing out over things that have already happened.

But if we have really wanted State Police, that blunder should have been corrected by now. And perhaps our security apparatus would have improved. For some of us who grew up in this country before independence and even during the first Republic, we experienced the services of regional police and local government native police called AKODA.

If you look at Section 106(4) of the 1963 Constitution, the establishment of regional police was recognized. The Section states that "Subject to the provisions of subsection (3) of this section, the Commissioner of Police of a Region shall comply with the directions of the Premier of the Region or such other Minister of the Government of the Region as may be authorized in that behalf by the Premier with respect to the maintaining and securing of public safety and public order within the Region or cause them to be complied with:"

When we have issues like the creation of State Police, we have no choice than to trace how the Presidential Constitution was made with particular reference to the founding fathers no matter how often we make that reference. They are the framers of our constitution. Moreso, when our Presidential Constitution did not pass through a referendum, plebiscite, initiative or mandate.

General Johnson Thomas Umunnakwe Aguiyi-Ironsi MVO, MBE (3 March 1924 – 29 July 1966), the first Military Head of State of Nigeria, on assuming power on January 1, 1966, suspended the 1963 Constitution and with it, the Regional Police. General Ironsi promulgated the Constitution Suspension and Modification Decree 1966), Decree 1 dated January 17, 1966 but not published

in the official gazette until March 4, 1966. The decree pronounced the death of Regional Police.

Even in his speech at the Lugard Hall in Kaduna on April 19, 1967, at a meeting with Emirs and Chiefs, the then Military Governor of the Northern Region, Lt-Colonel Hassan Usman Katsina (31 March 1933 – 24 July 1995) emphasized that Regional Police and native authority had become a thing of the past. He said on that day that "one of the main features of the Panel's recommendations was a closer control of the native courts of the Government. The taking over of the native courts by the Government was in fact accepted in principle by the civilian Government and judging from some of the legislation it had passed since 1958 there is no doubt that it was working towards the goal" he declared. Throughout the tenure of General Yakubu Gowon (87) GCFR from 1966-1975, there was no mention on the need to create State Police.

It was against this background that the Constitutional Drafting Committee was announced by the then Head of State in 1975, General Ramat Murtala Mohammed (8 November 1938 – 13 February 1976) on October 1, 1975 in his broadcast. The committee was headed by Chief Frederick Rotimi Alade Williams, QC, SAN (16 December 1920 – 26 March 2005). The committee

then established seven sub committees. The subcommittee on Public Services including the Armed forces and the Police was headed by Dr. Obi Wali (February 27, 1932-26 April, 1993). Other members of the subcommittee were Alhaji Ahmed Talib, Colonel M. Pedro Martins, Dr. O. Idris, Mr. A. Makele, Alhaji Mamman Daura and Chief Ekanem Ita.

Alhaji Ahmed Talib was the Chairman of New Nigerian Development Bank and the former deputy governor of Central Bank of Nigeria.

Chief Ekanem Ita, who died on Thursday, 03 September, 2009, was a former Registrar and Secretary to Council of the University of Ibadan (1982 – 1994). High Chief Ekanem-Ita attended the University College, Ibadan, from (1960 – 1963); Columbia University, New York, U.S.A.(1972-1973) and University of London Institute of Education, (1989). High Chief Ekanem-Ita was a Government, a Rockefeller Foundation and a British Council Scholar. He joined the services of the University of Ibadan as a Graduate Assistant/Administrative Officer in 1963, was promoted Assistant/Senior Assistant Registrar (1968 -1975), became a Deputy/

Senior Deputy Registrar (1975-1982) and was the Registrar and Secretary to Council, Senate, Congregation and Convocation from 1982 to 1994. The late High Chief Ekanem-Ita was a member of the American Association for Higher Education, Washington; Association of Commonwealth Universities; International Association of World Universities and the International Committee of University Administrators. He was a member of the FG/NUC Panels on University Administration Review; a Pro-Chancellor and Chairman of Governing Councils of Nnamdi Azikiwe University, Awka (1997-2000) and Cross River State University of Technology (2000 - 2003). Some other national assignments included membership of the Constitution Drafting Committee (1975-76); and membership of the Visitation Panel to Rivers State University of Science and Technology (1995-1996 and 2005-2006). A tràditional title holder, late High Chief Ekanem-Ita was the Ada-idaha-ke-Eburutu; Etonwed Efik Eburutu; Mkpisong Ukara Ekondo Efik; Ikpamfum Calabar and Ntufam of Qua Nation, Calabar. High Chief Ekanem-Ita who was nick-named 'Registrar Emeritus', held the record of being the longest serving Registrar in any Nigerian University, a position he held for twelve years!

### Failure of govt promotes proliferation of small arms, light weapons, says Ochoche

Txecutive Chairman and Chief Executive Officer Foundation for the Support of Victims of Terrorism, Professor Sunday Ochoche, has said that government is not innocent in the problem of proliferation of small arms and light weapons in the country.

He stated this at the Nigerian Army Resource Centre in Abuja during a one day interactive session organised by the National Centre for the Control of Small Arms and Light Weapons (NCCSALW) to interface with relevant Civil Society Organizations (CSOs) on how to eradicate the proliferation of illicit weapons.

While presenting a paper on the theme, 'Harnessing the Capacities of the Civil Society Towards Promoting an Illicit Arms-free Society in Nigeria', Prof Ochoche said the failure or limitation of government has in several ways contributed to the problem of illicit weapons. According to the professor, who

is also a Senior Policy Advisor with the United Nations, insurgency is driven and nursed by bad governance.

"In several ways, it is the failure or the limitations of the State that brings the problem of illicit small arms and light weapons to the fore.

"Insurgency for example, which creates a larger demand for light weapons, is largely politically driven and nursed by bad governance.

"General insecurity leads to citizens seeking to protect themselves by acquiring their own weapons.

"Of significance concern is the leakages of national arsenals to mainly groups, that now use them to form different insurgency and militia groups. So, the State is implicated in a number of challenges we face in small arms and light weapons," he said.

Ochoche faulted the call by Zamfara State government and Minister of Defence on citizens to take up arms and defend themselves.

"In Nigeria, the insecurity has reached a point that the Zamfara State government is calling on the citizens to acquire weapons to defend themselves.

"The Minister of Defence has made similar calls and I dare say that there is no better promotion for the proliferation of small arms and light weapons than seeing high level government officials urging citizens to go acquire weapons to defend themselves.

"There is no better acknowledgement of the failure of the State to deliver its primary responsibility to the people than those responsible for the provision of security now to begin to call on people to go and acquire weapons to protect themselves," he added.

Ochoche said it is paramount for government to partner with CSOs in tackling the menace of illicit weapons in the hands of unauthorised persons.

"Civil society organizations have important roles to play especially in societies emerging from arms conflicts in supporting the collection of arms and supervision of the public destruction of collected shucks at local level and help to reassure communities that weapons

According to him, CSOs also have significant roles to play in educating the media and by extension the public on the challenges posed by illicit weapons, train security agents, monitor who buys what, where it goes, who moves it to where, and Why is it going there. Earlier in his opening remark,

Chief of Staff (COS), Armed Forces of Liberia (AFL), Major General Prince Charles Johnson III has commended the Armed Forces of Nigeria (AFN) for playing a vital role in the restoration of peace and stability in Liberia.

Major General Johnson gave the commendation on Friday 15 July 2022 when he visited the Chief of Defence Staff (CDS), General Lucky Irabor at the Defence Headquarters,

He also paid tributes to late Lieutenant General LN Yusuf and Major General SA Abdurrahman, who served as the first and second COS of the new AFL before handing over to an indigenous COS.

According to him, Nigeria and Liberia have had long standing

defence and bilateral relations, saying that "today Liberia has witnessed seventeen years of relative peace and stability because of the sacrifices of men and women of the AFN, for which Liberia is ever grateful and indebted to Nigeria."

As an expression of Liberia's depth of gratitude, he said, a befitting memorial was being planned to honour and immortalize the AFN in the annals of Liberia's history especially, those who paid the supreme price with their lives to bring peace to Liberia.

Responding, General Irabor said the AFN remains proud to have actively participated in the restoration of peace, law and order to Liberia during the period of the country's security challenges.

Meanwhile, the Chief of the Air

Staff (CAS), Air Marshal Oladayo Amao has expressed the willingness of the Nigerian Air Force (NAF) to assist the AFL in developing its airpower capability.

The Liberia COS with his team had paid similar visits to the Chief of Army Staff, Lieutenant General Farouk Yahaya, Chief of Navy Staff, Vice Admiral Awwal Gambo and the Chief of the Air Staff, Air Marshal Oladayo Amao in their offices at the Armed Forces Complex in Abuja after visiting General Irabor.

The CAS while receiving Major General Johnson, who sought for assistance of NAF in developing Liberian Air Wing, said "Whenever you have pilots for further training, be rest assured that our training schools are open for them to become full-fledged pilots under the Nigerian Air Force pilots training programme."

Amao further advised the AFL to take advantage of NAF's technical and engineering schools for non-pilot courses such as the Air Traffic Control and ground support crew.

The CAS also noted that the NAF would support the AFL in providing airlift capability for AFL contingent to the United Nations Multidimensional Integrated Stabilization Mission (MINUSMA) in Mali once the request is made.

The visiting COS was accompanied by Colonel JS Willie (Commander Liberia Coast Guard), Colonel ON Ejiga (a Nigeria, who is a Senior Adviser ECOWAS Advisory Training Team to Liberia) and Captain JJ Dwanah (Liberia Military Pilot).

### How vigilantes killed, burnt 90-year-old man in Sokoto

#### Suspects to be arraigned in court

A 90-year-old man, Muhammad Riskuwa, has been killed and burnt beyond recognition, robbed of N430,000 and his house set ablaze by members of an outlawed vigilance group, who were armed with guns, cutlasses and sticks at Zangon Atti village in Gwadabawa LGA of Sokoto State.

Shehu Mamman, a son of the victim while narrating the ordeal to the police, said he was molding blocks with his father on 21st June, 2022, around 08:00 am when the criminal gang attacked them. Mamman said one of the hoodlums shot his father dead, while others ransacked the house, made away with the sum of N430,000, set their house ablaze and also burnt the corpse of his father beyond recognition.

DSP Sanusi Abubakar, Police Public Relations Officer of Sokoto Command, said on Friday that a full scale investigation was launched by the police following the report of Mamman, which led to the arrest of six suspects.

"A full scale police investigation was promptly commenced by state CID. Shehu Mamman who recognized identity of some of the assailants led the investigation team to the arrest of Aliyu Abdulrazak and Rabi'u Abdullahi, both members of the outlawed vigilante that lunched the attacks.

"Their arrest further drawn some vital confessions which led to the arrest of other key suspects that physically took part in the commission of the crimes. They are all male residents of the same address as follows: Mustapha Yakubu, Abdul'aziz Suleiman, Abdulbasiru Alhaji Idi, and Isah Musa," Abubakar said.

He said all the suspects have confessed to committing the crimes, so shall be arraigned in court soon by the police.

In another development, police in the State on Wednesday foiled the kidnap and robbery attempt of hoodlums armed with dangerous weapons after they invaded Tungan liman village, Wurno LGA in two teams and began shooting sporadically.

The hoodlums, who were already breaking and ransacking shops and houses in the village took to their heels following a quick response from the police. Police from Wurno Divisional Police Headquarters gave them a hot chase leading to the recovering

of one tecno cell phone, two live ammunitions 62 X 39 mm and a pair of sandals.

Meanwhile, three suspects were arrested by men of the Wamakko Police Station for robbing and attacking one Mamuda Mande on 7th July, 2022. The victim was said to have been dispossessed of N100,000 cash and injured on

Abubakar gave the names of the arrested suspects as Hussaini Harande, Shehu Aliyu, and Aliyu Abubakar. He said the suspects will be arraigned in court immediately police investigation is completed.

# NNPC will continue to fix fuel price on FG's behalf

•Fixed it at N179 per litre for petrol •'N1.89tr realised in five months, but money to share among tiers of govt'

espite its transformation into a commercial entity, Nigerian National Petroleum Company (NNPC) Limited, the government-controlled firm will continue to determine the prices of oil products

This was disclosed by the Group Managing Director of NNPC, Mele Kyari, who said the company would henceforth carry out the exercise for a fee on behalf of the Federal Government. He explained that whereas before its transformation, which took place yesterday in Abuja, the company functioned as the sole importer, it could not have done so as a commercial entity, but by the unveiling of the company in Abuja by President Muhammadu Buhari, the company would now charge a fee for such function.

"In the case of the price of petroleum, this is a policy matter. NNPC is going to be a supplier to the federation for a fee, so the price at which sell the product is sold will be the decision of the state.

The state has continued to maintain that we must continue to pay subsidy on petroleum products. We are happy to do this, but as a commercial venture, we will have a service level agreement between us to render that service" he said.

With the unveiling of the NNPC yesterday by President Buhari, the company has been incorporated into a limited liability company, as a result of the provision of the Petroleum Industry Act (PIA).

It would be recalled that the President recently delayed the full deregulation of the sector, which would have ensured the removal of the controversial and opaque petrol subsidy for which the Federal Government budgeted N4 trillion in the 2022 fiscal policy document.

Kyari restated that it would no longer be business as usual, insisting that as a commercial venture, NNPC would now be a service provider to the Federal Government, rather than shouldering the responsibility of importation and allowing it to be hurt company's bottom line.

be hurt company's bottom line.

He said: "We will procure the products and we will sell to the state and will be step-on-step with the country and literally I have seen no indication at this point in time that the state was ready to phase out any price of petroleum products, it has nothing to do with our operations.

"The new NNPC will not withdraw from the international organisation, but will rather continue to ensure more openness in its operations to attract more investments and foreign partnership. There is now more demand to be more transparent in our operations. NNPC is a partner company for the global initiative that voluntarily chose to become partner companies to Industries Transparency Initiative (EITI).

"The meaning of this is that we are going to make certain disclosure to your shareholders and to the world community that companies ordinarily are not required to do and we will keep to that because we are not going to withdraw as a partner

company to the EITI."

Meanwhile, motorists across the country will now pay between N179 and N180 per litre of petrol from N165 per litre, a development expected to raise the cost of transportation across the country.

The NNPC authorised the increase in the pump price of Premium Motor Spirit (PMS) from N165 to N179 per litre on Monday, which took effect from July 19, 2022 as the NNPC had already directed d oil marketers to change the petrol price on pumps to the new price. NNPC also increased the ex-depot price from N148.17 to N167 per litre following scarcity of

petrol, which resurfaced across the country as fuel marketers seek to force a new price which they have finally achieved.

Filling stations have already adjusted their pump price, as most filling stations in Lagos have embraced various pricing patterns. The Trumpet learnt that the price has not stabilised yet, as some filling stations in Lagos State are selling fuel for N170, N175, N180, N190 and N200 respectively, depending on the area and marketer supplying them.

While some filling stations have adjusted the pricing on their meters to reflect the actual price, others have left theirs to reflect the approved retail price at N165 per litre, but were selling over the displayed price.

For instance, the Mobil Filling Station on Agidingbi sold a litre of petrol for N170, as indicated on it meters, Enyo Filling Station at Chisco Bus Stop in Lekki, sold for N170 per litre, Eterna Filling Station at Jankade Bus Stop in Lekki sold for N180 per litre, while Mobil Filling Station at Osapa London in Lekki sold at N180 per litre.

Also, the NNPC has announced that there was no money to share among federal, states and local governments. Providing a breakdown of its finance, NNPC revealed that it realised N1.89 trillion in five months between January and May this year, but that most of the money has been spent, a situation which made the World Bank to earlier express concern that Nigeria could be heading for serious fiscal crisis due to continued payment for subsidy.

### Why Aero Contractors suspended passenger operations

Aero Contractors has announced that it has temporarily suspended scheduled passenger service operations with effect from today, July 20, 2022.

A statement issued by the company revealed that the decision was taken due to the impact of daily operations, which has led to high cost of operations, aircraft maintenance, aviation fuel, also known as Jet A1 oil, high inflation and scarcity of foreign exchange.

# IMB confirms decline of piracy in Gulf of Guinea

BIMCO seeks full deployment of Deep Blue assets
 Collaboration key to success, says Jamoh

International Maritime Bureau (IMB) has lauded the reduction in piracy in the globe and expressed optimism that it is a new dawn for the shipping community globally.

In its 2022 half-year report 2022, the bureau disclosed that

received the lowest number of reported incidents for the first half of the year since 1994, which is evident in its efforts at raising awareness to make the waters safe globally.

The Gulf of Guinea Declaration on Suppression of Piracy has confirmed that there has not been any case of kidnapping of seafarers kidnap one year after the May 2021 declaration. This is considered commendable progress in comparison to the 2020 statistics when 130 seafarers were kidnapped. The status report from the GoG declaration also confirmed that there has not been any case of kidnap for ransom in 2022, as against 20 cases in 2020 and 12 in 2021.

Director-General of the Nigerian Maritime Administration and Safety Agency, NIMASA, Dr. Bashir Jamoh, said Nigeria is committed to sustaining the momentum of the success recorded in recent times in the fight against piracy in the region.

"It is heart-warming that the international maritime community is acknowledging the progress made so far. It is a direct result of collaboration amongst national, regional and non-regional stakeholders. It is our hope that this trend will be sustained and very soon, we will start reaping the benefits such as a change of status concerning the Insurance premium paid on Nigerian bound cargoes; the War Riskpremium being paid at the moment. We hope this status will change very soon," he said.

While commending the progress, Baltic and International Maritime Council, BIMCO the world's largest direct-membership organization for ship-owners, charterers, shipbrokers and agents called for the effective and full deployment of Deep Blue Assets on Anti-piracy tasking. Efforts of the Nigerian Navy in clamping down on pirates camps, the Deep Blue project C4i coastal surveillance and collaboration with international Navies for law enforcement off Nigerian waters and the series of meetings under the umbrella of the Gulf of Guinea maritime coordination Forum, Shared Awareness and De-confliction, GoG/SHADE were identified as key to the success in the war against Piracy in the

On its part, the International Maritime Bureau IMB has also confirmed that no case of vessel hijack took place in Nigerian waters in the first half of 2022. The ICC and International Maritime Bureau (IMB) have confirmed that the first half of 2022 witnessed the least cases of piracy globally in 28 years with only 58 reported cases as compared to 68 within same period in 2021. Of the 58 incidents, 2 were classified as Piracy attacks in the Gulf of Guinea, with NONE of them occuring in Nigerian waters. While the reduction in reported incidents is indeed encouraging the IMB PRC continues to caution against complacency.

IMB Director, Michael Howlett said, "Not only is this good news for the seafarers and the shipping industry, it is positive news for trade which promotes economic growth. But the areas of risk shift and the shipping community must remain vigilant. We encourage governments and responding authorities to continue their patrols which create a deterrent effect."

### **AMCON** receives N126b from commercial banks in Q1 2022

Assets Management Corporation of Nigeria (AMCON) has received N125.9 billion from commercial banks listed on the Nigerian Exchange Limited (NGX), as part of the financial sector resolution funds in the first quarter of 2022.

Data obtained from the financial reports of the listed banks indicate that AMCON's bank charges increased by 29.5 per cent from N97.18 billion paid in the corresponding period of 2021 to N125.9 billion during the same period under review.

The banks are Access Bank, First City Monument Bank (FCMB), Fidelity Bank, First Bank of Nigeria, Guaranty Trust Bank, Stanbic IBTC Sterling Bank, United Bank for Africa (UBA), Union Bank, WEMA Bank and Zenith Bank Plc.

The Trumpet learnt the increase in AMCON's charges were attributed to the impressive rise in the total assets of the banks, just as the aggregate total assets of the banks stood at N61.23 trillion in the first quarter of 2022, representing a 5.29 per cent increase compared to the beginning of the year.

In the previous year, the total assets of the 12 banks had increased by N8.75 trillion largely due to increased customer loans.

The funds is part of the requirement of the AMCON (Amended) Act 2915, which mandated banks to make contributions to a fund established by the AMCON Acteffective from January 1, 2013.

Banks are required to contribute an equivalent of 0.5 per cent of their total assets plus 0.5 per cent of all contingent assets as of the preceding year- end to AMCON sinking fund in line with existing guidelines.

This contribution is for a period of 10 years from 2013, it non-refundable and does not represent any ownership interest.

A cursory look at the data shows that the 12 banks have paid in excess of N1 trillion to AMCON between January 2017 and March 2022. It is worth nothing that the charge is sometimes expressed as sector resolution fund, AMCON Resolution Fund AMCON sinking fund or part of regulatory costs.

# NAGAFF heads to Appeal Court to challenge CRFFN status

Government Approved Freight Forwarders (NAGAFF) has decided to head to the Appeal Court to ascertain if the Council for the Regulation of Freight Forwarding in Nigeria (CRFFN) is an agency of the Federal Government.

Founder of NAGAFF and the New Nigerian Peoples Party (NNPP), Dr. Boniface Aniebonam, who gave the hint in Lagos at a roundtable organised by the Maritime Journalists Association of Nigeria (MAJAN), expressed disappointment that a body his group founded as a private sector initiative was being hijacked by a cabal as an agency of government over pecuniary interests.

He, therefore, vowed that NAGAFF would pursue the case to the Supreme Court, adding that there was no justification for such going by the letters of the Act establishing the council.

He expressed displeasure, while reacting to the issue of setting an agenda for the new Minister of Transportation, Mu'azu Jaji Sambo, who he said, should strive write his name in gold by correcting the errors of his predecessors concerning the CRFFN.

"For the new minister, I advise him to write his name in gold by correcting the mistakes of his predecessors like Chibuike Rotimi Amaechi by implementing provisions of the CRFFN Act.

"If the CRFFN is an agency

ational Association of government, why should the Chairman of the Governing Board be chosen through election from the Register of Freight Forwarders? Which other government agency has the Managing Director or Director-General appointed through election?

"Are the heads of NIMASA, NPA, the Nigerian Shippers' Council (NSC), National Inland Waterways Authority (NIWA) and others appointed through elections like the CRFFN? Just because a set of people want to be collecting money from government, they said it is a government agency. Our lawyers are heading to the Appeal Court to continue the case. We went to the Federal High Court to challenge the hijack of the council We are ready to pursue the case up to the Supreme Court," he said.

It would be recalled that some years back NAGAFF had challenged the conversion of the council to an agency of government at the Federal High Court in Lagos and lost. Thereafter, the association raised an alarm sometime ago as moves were allegedly made by ministry officials to the National Assembly to amend the CRFFN Act in line with NAGAFF argument in court on why the council should not be an agency of government.

Meanwhile, Aniebonam reminded Sambo that by the Act establishing the council, the freight forwarding body was supposed to be akin to

the Institute of Chartered Accountants of Nigeria (ICAN), adding that the body should be independently funded as spelt out in the Act instead of through appropriation as presently being done and clarified that all freight forwarders, including former board chairmen, agreed that the council was a private initiative and should be managed as such.

"I urge the minister to thoroughly investigate the real status of the council and look at the Act, ask relevant questions and he will find out the truth and do the needful. Government needs money for a lot of things calling for attention, yet some people are taking money from the government to run an organisation which the law says should be funded independently.

"Îmagine Amaechi, who hurriedly inaugurated the Council Board on the eve of his exit saying some people were saying the CRFFN should not belong to government, but to the private sector," he said.

The council was established by the CRFFN Act 16 of 2007, with a mandate to, among other things, regulate and better control freight forwarding business, promote the highest standard of competence, practice and conduct among members of the profession.

# Naira falls to N430 per dollar at official window

The Exchange rate between the Naira and the United States of America dollar closed at N430.33 to the dollar at the official Investors and Exporters (I&E) window.

Naira depreciated massively against the dollar at the official market on Friday, July 15, 2022 with a 1.34 per cent decline to close at N430.33 to \$1 compared to N424.62 to \$1 recorded as at the close of trading session, the lowest rate on record apart from the rate as of December 31, 2021.

The depreciation of the local currency followed sustained low foreign exchange (forex) turnover in the market with a total of \$63.19 million on Friday, July 15, 2022, representing a decrease of 28.15 per cent compared to \$87.95 million that exchange on Thursday.

Also, the peer-to-peer exchange rate deprecated by 0.14 per cent on Saturday morning to trade at a minimum of N622.25 to \$1 as earlier recorded on Friday, being the highest rate recorded at the official market.

The Trumpet learnt from a Bureau De Change (BDC) operator in Lagos that the exchange rate at the parallel market remained at N618.20 to \$1 as of Friday morning as the Nigeria External Reserve had been on the downward trend due to the Central Bank of Nigeria's (CBN) interventions in the forex market with a view to ensuring stability of the local currency Naira.

However, rising crude oil prices have seen the reserve level improve marginally in the recent weeks, but the exchange rate at the official market depreciated on Friday, July 15, 2022, dropping by 1.34 per cent to close at N430.33 to \$1, as against the N424.02 to \$1 recorded on Thursday, July 14, 2022 at the official Investors and Exporters (I&E) window.

The opening indicative rate closed at N424.03 to \$1 on Thursday July 14th, 2022 from N424.04 to \$1 in the previous trading day.

Furthermore an exchange rate of N444 to \$1 was the highest rate recorded during intra - day trading before it settled at N414 to one dollar during day trading.

A total of \$87.95 million in Foreign Exchange value exchanged hands on Thursday, which is 44.56 per cent higher than the \$66.84 million traded in the previous session.

# Air fares may rise as aviation fuel hits N822 per litre


Travelers may pay more for air fares as the price of Aviation Fuel Jet A1 fuel now sells at over N800 per litre across the country. Also, airline operators are set to increase fares through a proposed 25 per cent surcharge. The Trumpet learnt that jet

### Expert seeks recognition of Federal High Court on admiralty claims

Akabogu, has urged Judges to appreciate the Admiralty Jurisdiction Act that confers jurisdiction on the Federal High Court to determine admiralty claims. He said such claims arise from the carriage of goods by sea and all other aspects maritime

The expert, Dr. Emeka Akabogu lamented that more often than not when claims arise and are filed at the Federal High Court, they are truncated due to wrong application or appreciation of Admiralty jurisdiction

He said the claim issues were usually successful at the Federal High Court and then when the claim is appealed at the Court of Appeal or the Supreme Court, the court will come up with the position that the Federal High Court did not have jurisdiction in the first place.

Akabogu said the appellate court had often suggested that the jurisdiction of the Federal High Court should end when the cargo is discharged from

Maritime expert, Dr. Emeka the vessels but unfortunately such decision does not favor the consignees as many losses/ damages occur after the cargo was discharged from the vessel and before being delivered to the consignee.

Speaking to journalists said: "I will like to advise and encourage all judges at the high court level and appellate level to better appreciate the significance of foundational maritime laws, particularly the Admiralty Jurisdiction Act which confers jurisdiction on the Federal High Court to determine such matters.

"It will enable them make better decisions that will impact on free flow of goods, quick vessel turn around, trade facilitation and better business enablement at the ports as lots of port congestion and associated constraints arises from people who have rights which have been breached, but cannot be fully ventilated at that point."

He further lamented that people have their cargoes stuck at the ports due to breaches of their economic rights, but are constrained in dealing with it due to technical issues in the law and courts bordering on jurisdiction and often, the value of the cargo will dissipate over time and they will not even have any encouragement or any desire to go and clear it from the ports anymore, leading to congestion.

He stated that these are some of the type claims that Nigerians need to have adjudicated upon to enhance business at the ports.

Akabogu said if the court says the Federal High Court does not have jurisdiction because the cargo has been discharged, it meant that many people who lose their cargoes or suffer damages at the ports after their cargoes have been discharged from the vessel would have their rights extinguished.

He pointed out that the same thing has happened to those who have losses occurring in the course of carriage to deliver to the consignee or in their ware houses or similar other things. Continuous enlightenment is necessary to resolve this chaloperational cost of airlines by over 130 per cent, even as the airlines are unable to increase fares; and also suffer from the challenge of sourcing foreign exchange to conduct operations due to biting scarcity.

"To forestall a backlash and total shutdown of the system, airlines are hoping to resort to an introduction of a fuel surcharge of between 25 per cent and 40 per cent of NÚC as a way of offsetting the additional burden brought about by increased fuel cost bearing in mind that jet fuel accounts for about 40 per cent of total operational expenses," it stated.

To this end, the airline operators, therefore, requested a review of some policies by the NCAA which include: a review of the decision that airlines are required to obtain approval for an initial three months before implementation of a fuel surcharge; waiver of demand that airlines pay an additional 5 per cent on the fuel surcharge entirely separate from the 5 per cent Ticket Sales

Charge (TSC)."
They also requested that taxes should be based on the proportion of the fare due to airlines, meaning that the fuel surcharge should be exempted from the TSC and called for an urgent meeting of chief executive officers of airlines to urgently address the issues.

Meanwhile, the AON blamed the Federal Airports Authority of Nigeria (FÁAN) for closure of the 18L runway on a short notice for causing additional costs to the airlines operations.

The operators questioned why FAAN did not ensure the contractor do the work at night as the current move is disrupting airlines operations.

În a letter written by President of AON, Abdulmunaf Yunusa, the group flayed the 90-day period stipulated for the installation of the Air Field Lighting, stressing that the closure of the main domestic runway of MMA automatically adds an additional 10-15 per cent more fuel costs per sector into and out of MMA, based on the additional flight and taxi time incurred.

The group urged he Managing Director of the FAAN, Captain Rabiu Yadudu, to convene a stakeholders consultation meeting to urgently review the closure of Runway 18L and discuss the procedure for the project in such a way that it would limit the cost implications on airlines and disruption of normal flight operations.

# JAMB decides admission cut-off marks, NATAP-M Awards

oint Admissions and Matriculation Board (JAMB) and stakeholders are to meet to decide the minimum admission cut-off mark for the 2022/2023 academic session.

This was disclosed in the board's weekly bulletin, which was made available in Abuja.

The meeting between the board and other agencies which is scheduled for Thursday July 21, 2022 would be presided over by the Minister of Education, Malam Adamu Adamu.

The examination body noted that Thursday is scheduled for two events which will be held at the same place. The Policy Meeting and the third edition of the NATAP-M Awards, the Minister of Education would chair the policy meeting as well as serve as the chief host of the NATAP-M Awards Ceremony.

According to JAMB, "The two events, which are scheduled to be held on the same day and place, will have in attendance heads of tertiary institutions, heads of regulatory agencies in the education sector, and other critical stakeholders such as Chairmen of the Committee on Education at the lower and upper chambers of the National Assembly."

According to the management of the board, the policy meeting, which is to kick-start the 2022 admission process into the nation's tertiary institutions, will be held before the National Tertiary Admissions Performance-Merit Awards (NATAP-M).

The board added that the policy meeting will discuss critical issues emanating from the presentation to be given by the Registrar, Joint Admissions and Matriculation Board, on the just-concluded 2022 Unified Tertiary Matriculation Examination, Direct Entry Applications, in addition to setting the tone for the 2022/2023 admission exercise.

"The policy meeting is expected to chart policy directions for the nation's tertiary institutions, set admission guidelines and present application statistics, candidates' performance, as well as evaluate the 2021 admission exercise. The meeting, among other things, will take a stand on acceptable minimum admission standards to be applied in all admissions to be undertaken by all tertiary institutions."

The second event of the day, which is the 3rd Edition of the NATAP-M Awards, is an initiative of the Board to promote excellence in tertiary institutions.

The year 2022 NATAP-M Awards is the third edition and is meant for the 2020 Admission Session, which could not be in 2021 as most institutions the Most Compliant in Keeping were unable to conduct their admissions within the specified time frame due to COVID-19 restrictions.

The Awards are in five categories: the Most Subscribed Institutions by Candidates, the Most National Institution in terms of Admission Spread, and

the Rules and Regulations on Admissions.


Other categories are: the Institution with the Highest Number of Admission of International Students and the Most Improved Institution in Gender Balance over Previous Year.

For this 3rd Edition, the Board

disclosed that it had obtained relevant approvals to increase by 150% the value of its previous Awards for maximum impact.

position). Nigerian-born tech execs convicted in US for laundering \$167 million

Three businessmen of Nigerian descent – Anslem Oshionebo, Opeyemi Odeyale and Aleoghena Okhumale – have been convicted for money laundering in the United States.

Their fate was sealed after Ping Express U.S. LLC pleaded guilty to failure to maintain an effective anti-money laundering program.

The Texas company, which transferred millions of dollars from America to Africa, admitted that it failed to play by the rules.

Though the company was licensed to transmit money, it had no approval to conduct currency exchange.

Ping Express charged U.S. customers a fee to remit money to beneficiaries in Nigeria and otner countries in the continent.

The company confessed to allowing over 1,500 customers to violate the laws. One customer remitted \$80,000 in one single month, more than 17 times the

Ping Express transmitted more than \$167million outside America, including \$160million to Nigeria, since 2019,

The company admitted it failed to request sufficient details about the sources or purposes of the funds involved in the transactions, or the customers.

A customer, Collins Orogun acknowledged accepting a fee in exchange for transferring money for "romance scam" fraudsters and other criminals.

Orogun received at least \$1.3million, cashier's checks, wires into U.S. bank accounts and moved more than \$1million to Africa through Ping.

The defendant faces up to 20 years in federal prison; his sentencing is set for January 23,

Ping CEO Oshionebo and Ping COO Odeyale were sentenced to 27 months in prison; IT/Business Development Manager Okhumale got a 42 months jail term.

The company now faces five years of probation and a fine of up to \$500,000; sentencing has been set for December 19, 2022.

Christopher Miller, Acting Special Agent in Charge of Homeland Security Investigations (HSI) Dallas said agents and forensic accountants work to eradicate bulk cash smuggling.

"Our investigative reach provides access to a wide range of financial networks allowing HSI to disrupt any criminal organization attempting to exploit global trade", Miller noted.

HSI Dallas Field Office conducted the probe in collaboration with the Texas Department of Banking. Assistant U.S. Attorney John de la Garza is the prosecutor.

# Nigerian-born Kemi Badenoch knocked out of Tory leadership race

s Kemi B a d en o c h is the l a t e s t leadership contender to be knocked out of the race to become United Kingdom's Prime Minister.

The former equalities finished minister bottom on Tuesday in the fourth round of voting by Conservative MPs and was leaving eliminated. Rishi Sunak, Liz Truss and Penny Mordaunt as the final three in the contest to replace Boris Johnson.

Badenoch exited the race with 59 votes, while former chancellor Rishi Sunak again topped the fourth ballot with 118, adding three to his tally from Monday suggesting he is likely to secure a spot in the final two places.

Mordaunt came second, adding 10 supporters to reach 92, while Foreign Secretary Li Truss had the most cause for optimism with 86 votes, an increase of 15 in a day.

Badenoch took to Twitter to thank her supporters for what her campaign had achieved in two weeks.

A spokesman for Ms Badenoch said, "this is a great achievement and demonstrates the support for her honest politics and vision of change for the country and the Conservative Party."

The three remaining candidates will face a further vote by MPs on Wednesday to decide who will make the final two.

The remaining runners will not face each other in a debate that had been scheduled by Sky News for Tuesday

night. It was planned to give Tory MPs a final chance to assess the contenders before Wednesday's ballot, but it was canceled after Mr. Sunak and Truss said they would not take part.

They tore shreds out of each other during ITV's debate on Friday.

Conservative MPs are said to be concerned about the damage the previous debates have done to the image of the party after exposing disagreements and splits between the leading candidates.

The leadership contest was triggered after Johnson announced he would be leaving Downing Street after a large mass of ministerial resignations over series of scandals.

He will remain as prime minister until his successor has been named.

#### Ukraine's Zelensky fires top security chief, prosecutor over collaboration with Russia

President Volodymyr Zelenskyy has dismissed two top security officials of Ukraine. They are the prosecutor general and the head of the powerful Security Service of Ukraine

Citing many of treason in the two organisations, powerful the president's executive orders announced the sacking of SBU chief Ivan childhood Bakanov. friend of Zelenskyy, and Prosecutor General Iryna Venediktova. They led the effort to prosecute Russian war crimes in Ukraine, were published on the president's official website.

In a separate Telegram post, Zelenskyy said he had fired the top officials because many cases had come to light of members of their agencies collaborating with Russia.

He said 651 treason and collaboration cases had been opened against prosecutorial and law enforcement officials, and that more than 60 officials from Bakanov and Venediktova's agencies were now working against Ukraine in Russian-occupied territories.

"Such an array of crimes against the foundations of the national security of the state pose very serious questions to the relevant leaders," Zelenskyy said.

"Each of these questions will receive a proper answer," he added.

Senior officials in the SBU in southern Ukraine have been blamed for the ease with which Russian forces were able to capture large areas of the south within a week of the invasion.

Zelenskyy replaced Venediktova with her deputy Oleksiy Symonenko as the new prosecutor general in a separate executive order that was also published on the president's site.

The President also said the Prime Minister would be tasked with intensifying the search for a new head of the National Anticorruption Bureau.

# EU to soften sanctions on Russian banks for food trade

Unfreezing of some funds of top Russian banks that may be required to ease blockages in the global trade of food and fertilisers is on the cards, a draft document showed.

The European Union (EU) will amend its sanctions on Moscow amid criticism from African leaders about the negative impact of the penalties on the trade, which may have

worsened shortages caused by Russia's attacks on Ukraine and its blockading of ports in the Black Sea.

Under the changed regulation, which is expected to be adopted EU envoys on Wednesday, EU nations will be able to unfreeze previously blocked economic resources owned by top Russian VTB (VTBR. lenders Sovcombank, MM), Novikombank, Bank, Otkritie FC VEB, Promsvyazbank and Bank Rossiya, the document said.

Separately, under the new sanctions to be approved, Sberbank (SBER.MM), Russia's largest bank, will also become subject to the freezing of its assets, with the exception of resources needed for food trade.

The draft document said money could be released after determining that such funds or economic resources are necessary for the purchase, import or transport of agricultural and food

products, including wheat and fertilizers.

The EU also plans to facilitate exports of food from Russian ports, which traders had stopped using after EU sanctions despite the measures explicitly exempting food exports.

The European Union has so far denied its sanctions affected food trade.

Meanwhile Russian forces continue with their bombardment of cities across Ukraine with intense shelling of Sumy in the north, cluster bombs targeting Mykolaiv, and a missile strike in Odesa in the south.

The EU, along with

States, the United Britain others, imposed sweeping sanctions on Russia after its invasion of Ukraine on Feb. 24. Russia calls its actions "special military operation" to disarm "denazify" and Ukraine. Kyiv and the West say Moscow is waging an unprovoked war of aggression.
