



# Anxiety hits Okowa, Ibori camps as INEC delists Delta PDP gubernatorial candidate

nternal wranglings in the Delta chapter of the People's Democratic Party (PDP) have made its leaders and stalwarts in the state apprehensive and sceptical about what awaits awaits its 2023 gubernatorial bid.

The Trumpet can authoritatively report that anxiety has gripped members of the party over the possibility of not having a governorship candidate on the 2023 ballot following the ruling of a Federal High Court and subsequent Appeal by one of the battling camps.

The Independent National Electoral Commission (INEC) on Friday published the personal particulars of candidates nominated by their political parties for the 2023 Governorship and State Assembly elections in all the constituencies nationwide.

Professor Mahmood Yakubu, chairman of INEC, had on Thursday urged Nigerians to scrutinize the particulars of the various candidates and seek judicial remedy for any observed violation of the law when finally published on Friday.

However, there were neither particulars of Speaker of the State Assembly, Rt. Hon. Sheriff Oborevwori from the Okowa camp nor those of Olorogun David Edevbie of the Ibori faction. The development has further unsettled and thrown members of the PDP into dilemma as the chances of having a candidate in the 2023 elections grow slimmer.

The Governor of the State, Dr Ifeanyi Okowa, has been having an unending power tussle with the state's erstwhile helmsman, Chief James Ibori, who many analysts described as the political godfather of the party in Delta. Ibori was the political leader of Okowa before his emergence as Governor of the State in 2015.

Crisis, however, began when Okowa moved against the preferred candidate of his supposed political leader, Ibori in the run-up to the party's 2022 primary in the State. Ibori had anointed seasoned financial administrator,

David Edevbie, as a potential successor of Okowa. However, Okowa, who was bent on building a political structure of his own, vehemently resisted the much-taunted fearsome political force of Ibori by throwing his weight behind Oborevwori.

The choices of the once political allies, who are now wrestling dirty to claim the soul of the party in the State, have caused a sharp division between members of the PDP with the loyalty of many being tested.

It was gathered that Okowa was allegedly able to take advantage of his office as the incumbent governor with access to the State treasury to influence many of the power brokers across the three senatorial districts and 25 Local Government Areas to his side by appointing a retinue of aides, thereby subjecting the State to a borrowing spree.

Our findings revealed that Okowa relegated all members of the party who are supporters and loyalists of Ibori by starving them of appointments and political patronage; a move that has caused a significant inadequacy in the circulation of resources within the Ibori bloc, thereby forcing many to shift allegiance.

It was, therefore, not surprising that the State's Speaker emerged the winner of the party's primary election that was conducted on 25 May after polling 590 votes to defeat his main rival, Edevbie who polled 107 votes. Senator James Manager came third with 83 votes. But then, that was the beginning of the crisis that is now threatening to kick out the PDP from the seat of power that it has held hostage since the return of Democracy in 1999 – some 23 years ago.

Edevbie wasted no time to file a pre-election case against Oborevwori, challenging his qualification to seek the office of the governor. He prayed the court to disqualify the winner for false information and forged certificates.

In his ruling on Thursday, 7th July 2022, the judge, Justice Taiwo Taiwo of a Federal High Court sitting in Abuja, ordered the PDP

and INEC to replace Oborevwori's name with that of the plaintiff, Edevbie, who scored the second highest votes.

"The 1st Defendant (Mr Oborevwori) should and ought to be prohibited, prevented, or otherwise restrained from holding out, parading, and or advertising himself as the candidate of the 2nd Defendant (PDP) for the forthcoming Gubernatorial elections in Delta State scheduled to hold on 11 March 2023 by the 3rd Defendant (INEC)," Justice Taiwo ruled.

The ruling of the court sent waves into Okowa's camp with supporters deadly silent, confused, and shattered despite Oborevwori appealing the judgment.

INEC guidelines stipulated that political parties should submit their candidates' names through the party's portal on or before Friday, 15th July.

The court judgment was said to have been served to both the PDP and the INEC before the deadline of the electoral umpire. However, it was gathered that the PDP failed to keep to the guidelines by submitting the name of Edevbie as a replacement for Oborevwori, a situation that may lead to the disqualification of the political party.

A top PDP chieftain who spoke to The Trumpet on the condition of anonymity expressed fear that the chances of Oborevwori in the ongoing legal battle are slim. He said the party is facing a very tough time and its members, especially those in the Okowa camp are currently in a state of dilemma.

He further stated that the name and particulars of the PDP governorship candidate missing from the INEC's published list have further increased tension and fear within the ranks of the PDP.

The source accused the

Deputy President of the Senate and governorship candidate of the All Progressives Congress (APC), Sen Ovie-Omo-Agege, of orchestrating the crisis rocking the PDP to ensure that the party has no candidate in the 2023 governorship election

"What is going on in our party has made many of us devastated. There is fear that PDP may not have a gubernatorial candidate in Delta State as a result of this unending battle between our leaders, which has resulted in lingering court cases. I believe that Ovie Omo-Agege is behind this whole crisis. He is the Deputy Senate President and has a close rapport with the Judiciary," the source alleged.

Meanwhile, there are speculations that Governor Okowa, who is the Vice Presidential Candidate of the PDP, is currently considering opting for Accord Party by supporting former Secretary of State Government (SSG), Festus Agas.

## CAPPA backs national protest over ASUU strike

Corporate Accountability and Public Participation Africa (CAPPA) has commended the Nigeria Labour Congress (NLC) for its decision to organise a two-day national protest in solidarity with the Academic Staff Union of Universities (ASUU) to get Nigerian students back to school and support unions in the nation's public universities clamouring for uninterrupted quality education.

A circular sent by NLC National Executive Council (NEC) to its affiliates and state councils after its meeting on June 30, 2022, indicated that the protests will take place on Tuesday, July 26, 2022, and Wednesday, July 27, 2022, in all the state capitals across the federation and the Federal Capital Territory (FCT), Abuia.

In a statement signed and issued in Lagos by Policy and Research Officer of CAPPA, Zikora Ibeh, the group said the decision of organised labour to embark on solidarity protest with ASUU was the best course of action given the Federal Government's insensitivity in the past five months despite attempts by the NLC and other stakeholders to intervene in the impasse.

"CAPPA welcomes the NLC's decision and urges all civil-society organisations, student unions, including the National Association of Nigerian Students (NANS) and all groups committed to the defence of social, economic, and human rights to join organised labour and education unions to defend the public university system.

"We at CAPPA support every legitimate action to ensure a speedy resolution of the strike and resumption of classes by students, who have been idling away at home for over five months," the statement reads.

The group expressed concern that the ASUU strike, which started on February 14, 2022, had now entered its fifth month, adding that this, coupled with the several months lost during the COVID-19 pandemic lockdown in 2020, meant that Nigerian

students have cumulatively lost over a year of academic work within two years.

"The long-term consequences of this loss for students and society can only be imagined. Unfortunately, the Federal Government does not seem bothered. Therefore, the national protest of July 26 and 27, 2022 must become a crucial point of engagement to demand accountability from political office holders and to insist on the right of the Nigeria child to improved funding of education, as enshrined in the 1999 Constitution (as amended) and other international agreements to which Nigeria is a

signatory.

"CAPPA believes that Nigeria's public universities are severely underfunded and bedevilled by a poor governance system that promotes mismanagement and misappropriation of the paltry funding available. No doubt, this is one of the reasons why, according to the World University Ranking 2022 report, no public university in Nigeria is in the first 100 in Africa or

the first 1000 in the world," it said.

The group expressed concern that Nigerian academics were some of the least paid in the world despite having highly rated knowledge and qualifications comparable to any of their peers globally.

It stressed that any government that places value on education would do everything possible to ensure that the welfare of its academics and funding of its schools and tertiary institutions were prioritised in its budgeting and resource-mobilisation processes.

"We, hereby, urge the Nigerian people to continue to support academics and non-academic staff in public universities to demand improved funding for the university system and appropriate wages and allowances commensurate with their skills and services. This is the only way to block the curse of brain drain that plagues Nigeria and restore the integrity of the country's university system," the statement added.

# Atiku tackles Tinubu, Obi, decries debt burden, others

the dust raised by the hiring alleged clergymen endorse unveiling of Senator Kashim Shettima as the vice presidential candidate of the All Progressives Congress (APC) is yet to settle, torchbearer of the Peoples Democratic Party (PDP). Alhaji Atiku Abubakar, has spoken on various issues, carpeting his main rivals, Asiwaju Bola Tinubu, and Mr. Peter Obi.

He specifically revealed he parted with Tinubu, politically the APC 2023 presidential candidate, in 2007 over single religion ticket.

He deplored the foisting of a single religion leadership ticket on Nigerians. He stressed that the Muslim-Muslim ticket was an unfair treatment for a secular nation like Nigeria.

The former vice president spoke spoke Friday morning while featuring on Arise TV, Morning Show programme.

As a Nigerian believer of the Islamic faith, he said he has been very careful about the sensitive issue of religion and has always been avoiding playing politics with religion.

This, he said, informed his decision in 2007 to oppose Tinubu on the issue of the same faith ticket when the latter was contesting for the presidency then.

"The diversity in the nation was from the APC-led government. My fundamental disagreement and departure from Asiwaju politically was in 2007 on the issue of Muslim-Muslim ticket.

"Remember I came out of PDP on the issue of zoning and together with him we formed AČN and I was given a ticket my running mate and I said no, I am not going to have a Muslim-Muslim ticket. So, he switched his support to the late Umaru Yar'Adua. That was the departing point."

Also, the PDP presidential candidate has expressed worries over the slipping trend in the Nigerian economy.


He lamented the rising profile of the nation's debt which he said is slipping from medium to high risk of distress.

Atiku said this Friday while responding to a statement credited to Nigeria's finance minister. Hajia Zainab Ahmed that the nation's debt servicing exceeds revenue.

Thursday's said revelation by Nigeria's Finance Minister that the cost of servicing Nigeria's debt has surpassed the Federal Government's retained revenue by N310 billion in the first quarter of the year is very worrisome.

"First, this action must be in breach of all known reasonable debt-sustainability thresholds. Second, it puts a big question mark on the capacity of the government to manage its rising debt profile without endangering macroeconomic stability Indeed, I am concerned that this action is already exposing Nigeria to financial stability issues as we slip from a medium risk of debt distress to a high risk of debt distress.

"I had on several occasions warned that not only is the fiscal cost of government's borrowing indiscriminate so enormous but has even greater opportunity costs as we sacrifice investments in critical areas, including education, health, and other basic services. This is certainly detrimental to Nigeria's long-



term growth.

"I urge the government to as a matter of urgency take immediate steps to slow down the rate of debt accumulation by promoting more Public Private Partnerships in critical infrastructure funding and identifying more innovative funding options.

the 'Review current utilization of all borrowed funds and ensure that they are deployed more judiciously. Specifically, the government must ensure that all borrowed funds are for priority infrastructure projects that would generate income, boost output, and put the economy on the path of sustainable growth.
"Review the country's

debt strategy by focusing on concessional and semiconcessional sources with lower interest rates and relatively long-term maturity. The government must reduce the issuance of short-dated debt instruments".

Atiku also charged the Federal Government to take steps to improve its spending efficiency and drastically cut unnecessary and wasteful expenditures.

In the same interview with Arise Television, Atiku addressed a wide range of issues including the economy, insecurity, his chances at the poll, and those affecting Tinubu and Obi.

On President Muhammadu Buhari's appointments, "First and lopsided Atiku said: foremost, you have to give every part of this country a sense of belonging...we have 17 security outfits in this country and all of them being headed by one section of the country, that's a very serious imbalance."

He spoke about Tinubu, his long-time friend and former political associate whose presidential interest now clashes with his. He said: "My fundamental disagreement with Asiwaju since 2007 was on the issue of a Muslim-Muslim ticket, which led to my political departure from

Recall that Atiku contested the 2007 presidential election on the platform of the Action Congress of Nigeria (ACN) formed by Tinubu after he

(Tinubu) fell out with the leadership of the Alliance for Democracy (AD).

When asked about the threat posed by Peter Obi with his Obidient movement, he said: "It will take a miracle for the Labour Party with no structure in the grassroots to win the presidency. In the north 90% of our people are not in tune to Social media." He advised Nigerians not to expect a miracle to happen on the basis that Peter Obi joined the Labour Party to contest the presidency in 2023.

On his choice of Governor of Delta State, Ifeanyi Okowa as his running mate, and his rejection of Rivers State Governor, Nyesom Wike, Atiku said: "I didn't reject Wike. I picked who can deliver. Wike is brilliant and tenacious. Going by history, I had picked an Igbo as running mate in 2007, in 2019. I still picked an Igbo for 2023.

"The committee that presented the three nominees was chaired by the Governor of Benue State, Samuel Ortom. They recommended three people, so I picked one. People should be fair to me and state the facts."

Admitting that members were not happy with his vice presidential candidate pick, particularly Wike, Atiku said, "We are reaching out to Wike and talking to him, very soon, we will resolve our internal

#### To avert global food crisis, Ukraine, Russia sign deal for resumption of grain exports

Accord unprecedented between warring countries, says UN

Ukraine and Russia have signed a United Nations-backed deal to allow export of millions of tonnes of grains from blocked Black Sea ports to avert threat of a catastrophic global food crisis.

A signing ceremony at Dolmabahçe Palace in Istanbul was attended by the UN Secretary-General, António Guterres and Turkey's President, Recep Tayyip Erdoğan, who had played a crucial role during months of tense negotiations.

Guterres said at the ceremony that the deal would open the way to significant volumes of food exports from Ukraine and alleviate a parallel food and economic crisis in the developing world, saying: "The beacon of hope was shining bright in the Black Sea" and called on Russia and Ukraine to fully implement the accord."

It is hoped the agreement will secure the passage of grains and essential goods such as sunflower oil from three Ukrainian ports including the Odesa Port, even as the war continues to rage elsewhere in the country. The UN had warned that the war risked mass malnutrition, hunger and

International media reported that the deal is also aimed at ensuring the safe passage Russian-made fertiliser products, essential for ensuring future high crop yields amid efforts to ease a global food crisis provoked by Russia's invasion

UN officials said they hoped preliminary shipments could begin today, with the hope of reaching prewar levels of exports

coalition of Turkish, Ukrainian and UN staff would monitor the loading of grains into vessels in Ukrainian ports before navigating a pre-planned route through the Black Sea, which had been heavily mined by Ukrainian and Russian forces.

Ukrainian pilot vessels would guide commercial vessels transporting the grains to navigate the mined areas around the coastline using a map of safe channels provided by Ukraine.

The vessels will then cross the Black Sea towards Turkey's Bosphorus strait, while being closely monitored by a joint coordination centre in Istanbul. containing representatives from the UN, Ukraine, Russia and Turkey.

Ships entering Ukraine will also be inspected under the supervision of the same joint coordination centre to ensure they are not carrying weapons or items that could be used to attack the Ukrainian side.

The Russian and Ukrainian sides have agreed to withhold attacks on any of the commercial vessels or ports engaged in the initiative to transport vital grains, while UN and Turkish monitors would be present in Ukrainian ports to demarcate areas protected by the accord.

Guterres said such a deal between the two warring countries was 'unprecedented' and that it would "bring relief for developing countries on the edge of bankruptcy and the most vulnerable people on the edge of famine. And it will help stabilise global food prices, which were already at record levels even before the war- a true nightmare for developing countries.

"Specifically, the initiative we just signed opens a path for significant volumes of commercial food exports from three key Ukrainian ports in the Black Sea-Odesa, Chernomorsk and Yuzhny. The shipment of grain and food stocks into world markets will help bridge the global food supply gap and reduce pressure on high prices."

### Thirteen Nigerian tertiary institutions win N500m

Nigerian Thirteen tertiary institutions were awarded the sum of N500m by the Joint Admissions and Matriculation Board

The beneficiaries include federal, state, and privatelyowned institutions. They were ranked best for the 2020 JAMB National Tertiary Admissions' Performance-Merit Award (NATAP-M Award).

The award is in five categories, the winners shared N100 million among the best three institutions in each category.

The categories are the most preferred institution candidates, institution with the highest national diversity, the most

improved institution gender balance, and the institution with the highest number of international students.

The award ceremony and presentation of prizes was held at the International Conference Centre, Abuja,

According to the JAMB registrar, Is-haq Oloyede said this year's ceremony is the third in the series since it was initiated in 2018.

University of Ilorin (UNILORIN) emerged as the most sought-after tertiary institution in Nigeria, with 81,659 applicants in the 2020 Unified Tertiary Matriculation Examinations (UTME), while Ahmadu Bello University (ABU) ranked second with 75,446. Bayero University, Kano

(BUK), ranked third with

UNILORIN was awarded with N75 million, ABU, BUK received N15 million and N10 million.

national The most admission spread award was given to Kaduna State Polytechnic, which has candidates from across 33 states of the Federation.

Ahmadu Bello University, with candidates across 32 states, and Afe Babalola University, with candidates across 29 states, emerged first and second runners-up.

Mr Oloyede said this category considers institutions with the highest number of diverse students from across the country.

Federal University, Lafia, took home the prize for the most improved in gender balance for the year 2020. The FCT College of Education, Zuba, emerged as the first runner-up and Abia State University, Uturu was the second runner-up in the category.

For the institution with the highest number of foreign students, Ahmadu Bello University, emerged first with 61 candidates, the University of Maiduguri came second with 20 and Nile University, Abuia, ranked third with 11.

#### Woman arrested for stealing a day-old baby

A 35-year-old woman, Funmi Mogbojuri, has been arrested by the Ondo State Police for allegedly stealing a day-old baby. According to the Police, Funmi stole the baby at Sabo, an area in Okitipupa, the headquarters of the Okitipupa Local Government Area of the state and took the baby to Sagamu in Ogun State.

The Police public image maker in the state, Mrs Funmilayo Odunlami, said the suspect was arrested while about to name the stolen baby.

"One Abass Issah of Arikawe Street, Okitipupa, came to the station and reported that his newborn baby was stolen by unknown persons. A discreet investigation by the Okitipupa Divisional Policemen led to the arrest of Funmi Mogbojuri, who absconded with the baby to Makun, Sagamu in Ogun State.

"During interrogation, she confessed to having absconded with the baby to her husband's house. It was also discovered that she had earlier stolen another baby on the 16th of January, 2021, in Okitipupa, took the child to Igbokoda and gave him to one Lucky and said the child died a few days later."

The Police Public Relations Officer said the suspect would be charged to court after the investigation had been concluded on the matter.

While confessing, the suspect said she doesn't know the spirit that entered her to commit such an act and

pleaded for forgiveness. She further said she had given birth to two children for her first husband before her husband's family prevented her from having access to the kids

the child and I did that to
take good care of the child.
I have given birth before,
but I never had a child for
the husband I'm presently
with. I just like the child,
that's why I abducted the

She revealed that her current husband knew nothing about the situation, adding that she lied to the husband that she was pregnant. She said this was her second time abducting a child.

Speaking to newsmen, the mother of the stolen baby, Binta Alhassan, disclosed that Mogbojuri came to their house the day she put to bed and requested to spend the night which she obliged because the suspect said she was stranded in Okitipupa and had no place to sleep. Binta said they knew the suspect through a friend she always visited in their house, adding that the man was no longer living in their house.

"We allowed her to spend the night in one of the vacant rooms. We even gave her food to eat that night, not knowing that she had a mission. To my surprise, the following morning, while on my way from the bathroom, the woman had disappeared with the baby which I had not even been breastfed by then, it was after five days that the police found and arrested her."

The Queen grandson's challenge concerns the February 2020 decision of the Executive Committee for the Protection of Royalty and Public Figures (Ravec), which falls under the Home Office's management.

Ravec told the prince he and his family would no longer be given the level of personal protection he received as a full-time working royal.

Harry and his wife stepped back from royal duties in January 2020.

On Friday, a British High Court judge granted permission for Prince Harry to challenge the lack of transparency around Ravec's decision-making and its policies.

He was granted approval for part of his claim for a judicial review of the decision. A judicial review involves a judge examining the legitimacy of a public body's decision.

The permission for Harry to apply for judicial review was granted on several different grounds although not all of those the prince's legal team had sought, the judgment, published on the court's website, showed.

Earlier this month lawyers for Prince Harry, argued in court that the royal household should not have been involved in the UK's decision to deny him police protection in Britain.

Prince Harry and the Home Office will submit further information to the court ahead of any application for judicial review.

# 2023: Dizzying echoes from Rivers APC

Politics by its very nature encompasses some measure of uncertainties and palpitations without which it loses most of its attributes.

Ahead of the 2023 general election, some of those attributes are beginning to manifest in different shapes and colours.

In recent years, Rivers State has been attracting more than a passing attention in every election season due to the style and modus being adopted by the dramatis personae in the murky game.

The state is rich in hydrocarbon resources which is the nucleus of the national economy, and this may also define the mindset of the political actors in their cut throat struggle to clinch power and preside over the resources.

Since 2015, the PDP and APC have remained the dominant political force in the state and have been locked in a supremacy battle to out-do each other and call the shots.

However, the APC which is a party put together in 2014 after the merger of different political groups has not been able to find its rhythm in the state. The party has largely remained a replica of the legendary soap opera, 'Fuji House of Commotion', always bickering and tearing itself apart.

Even after what befell the party in 2019 general election where it was wiped out of the ballot and could not field any candidate in the election, almost four years after, the party is still pointing fingers at imaginary directions for its problems even as its leadership continues to display stubborn disinclination to enthrone due process amongst its ranks.

According to some observers, the Amaechi-Abe seeming intractable feud which is the genesis of the crisis in the party has remained so largely because of the apparent refusal by Amaechi, leader of the party in the state to allow due process to reign in the party.

The party had plunged into its governorship primaries in May with the baggage of grievances some of its critical stakeholders were carrying, pretending that all was well

Before then, the announcement of Arch. Tonye Cole, the oil mogul as the consensus governorship candidate of the party by some elders after their meeting in Abuja at the instance of the former Minister of Transportation, Rotimi Amaechi had raised tension in the party.

The primary eventually did not produce any dramatic result as it was mere ratification of the choice of Cole. And so to most Amaechi apologists it was eureka as everything seemed to be working according to plan.

But according to some observers, the growing list of disenchanted members of the party were only holding out for the conduct of the presidential primaries of the APC where Amaechi was a major contender before making a decision on what to do next.

"Now with Amaechi losing out in the presidential primaries and also out of office where he could dispense some favours and create opportunities for his followers and Cole who doesn't command the respect and followership of critical stakeholders of the party as governorship candidate, many felt it was to your tents oh Israel", said an analyst who craved anonymity while reacting to the wave of defections and resignation sweeping across the Rivers APC.

Indeed, the Rivers APC is a troubled entity with the recent events in the party. Interestingly many of those who had one of their legs in and the other out of the party without openly speaking out are now justifying their resignation and defection on the ground of the Muslim-Muslim ticket adopted by the party for its presidential and vice presidential

candidates.

However, of all the heavyweights who have resigned from the party in recent times including former Acting Managing Director of the Niger Delta Development Commission, (NDDC) and former commissioner for Information, Mrs Ibim Semenitari, Prince Tonye Princewill, former Commissioner for Energy and Natural Resources, Dr Dawari George, Hon. Golden Chioma, etc, the one that rang the bell the most was that of Hon. George Tolofari, former Commissioner for Transport.

Tolofari headed the committee formed by all the governorship aspirants from the riverine extraction of the state before the governorship primaries. The committee had produced and assented to an accord to support any one of them who emerged victorious in the governorship primaries since the choice of a candidate was narrowed to the riverine axis by the party.

And so when eventually the committee that met in Abuja nominated Tonye Cole as the consensus governorship candidate, Tolofari came out boldly to defend the decision of the committee.

In an epistle to the party faithful, Tolofari argued forcefully why the choice should stand, making references to the accord by the riverine aspirants.

Hear him, "...I write with a deep sense of commitment and loyalty to our great party and to all of you who have stood to defend this party, her leadership and her ideals over the years.

"The event that took place on Friday, 22nd April 2022, has brought about mixed feelings and reactions from across many quarters because some expectations were not met. Many of you were disgruntled, sad, shocked and even surprised to say the least. Some of you as a result have reached out to me and other party leaders privately and openly to vent your spleen. Sincerely, we feel your frustration and understand how it feels when the lot does not fall on you because we've all been there before at one time or the other."

On what transpired in Abuja, Tolofari

revealed thus: "What many of us may not know is that all the aspirants from the Riverine Ijaw extraction came together and surrendered their rights to the party to choose for them since they could not reach a consensus amongst themselves. Hence, the decision taken by the committee was in the best interest of the aspirants, the party and all of us after a thorough scrutiny of all concerned.

"Some of you have erroneously accused and cast aspersions and insults at our leader for imposing Tonye Cole on the party, but unknown to you, our leader, The Minister of Transportation recused himself from the process and asked us to freely exercise our rights in the best interest of the party which we did. I appeal to us all to stop the unwarranted attacks on our leader because he has done nothing wrong, rather he set the stage for free deliberations and consultations. If he had wanted to impose a candidate on us, he would not need to set up a committee. He would have just announced his preferred candidate and asked us to support him, but this he didn't do. It may even surprise some of you that our leader's preference may not have emerged but he allowed the majority decision of the party elders to fly.

"I was part of that process and all decisions taken by the larger majority of the committee members are binding on me. I will say that again for emphasis. Although expectations of all party faithful may not have been met as some of us had wished our 'principal' emerged. I do not believe in that system where when it favours me, I applaud the leadership and its process and castigate leadership and its process when it does not favour me. As painful as it is, we must exercise restraint. We must not destroy APC because we didn't get the endorsement of the leadership this time around.

"Many of us have been beneficiaries of the same consensus decisions at some point in time and when it favoured us, others were probably displeased and when it favours others we may be displeased also. That is a common human factor. I, George Tolofari benefitted from consensus in the past. Dakuku Peterside, Sokonte Davis, Emeka Beke, Victor Giadom, Dawari George, Ojukaye Flag Amachree and a host of us are all beneficiaries of this same system however, it was arrived at. So we must learn the principles of give and take at times like this and also understand what party loyalty means. Loyalty is a very costly commodity and difficult to find and it's no loyalty until it is tested. Indeed, we are in for a loyalty test once again."

This was in April/May and now in July, Tolofari is singing a different song: "The above subject matter refers. Joining the APC was based on personal conviction, but having reviewed the general state of affairs of the APC-led government in the country, I'm no longer convinced of my continued stay in the party.

"The APC came on the mantra of anticorruption, justice, equity and insecurity. But today that hope is dashed as insecurity; corruption and injustice stare us squarely in the face and threaten the very existence of our beloved country.

"To my dear leaders and die-hard party faithful in Bonny who see me as a role model and a loyal party man, I'm sorry to disappoint you by my decision. I guess I'm human after all, forgive me.

"My gratitude goes to my leader, His Excellency, Rt. Hon. Rotimi Amaechi and the party for the opportunity to serve the state and the party in the recent past.

"Although this is a very difficult and painful decision to make i believe it's time to move on. Let me also take this opportunity to wish the APC all the best in the forthcoming elections in 2023", Tolofari had written in his resignation letter to the chairman of his ward in Bonny Local Government.

Earlier, in his own epistle to communicate his resignation, Tonye Princewill had written, "I cannot defend the decision of my party, in fielding a Muslim Muslim ticket, especially at a time like this, against all protestations from well-meaning Nigerians across religious and political divides, it sets a very wrong precedent; it is totally insensitive and even if you win, will prove bad for good governance

"Under these dire circumstances, I find no justification to still remain in good conscience a member of a political party that subordinates electoral victory over the safety of lives and peace of mind of its citizens..."

In the same breath; Senator Magnus Abe who has been leading a faction of APC in the state announced his resignation, saying the party would not provide him with a platform to actualize his governorship ambition.

But reacting to all these disturbing developments in the party, the APC in the state accused Governor Wike and Magnus Abe of being the mastermind of the misfortunes the party has suffered over the years.

"The culmination of their evil machinations was the exclusion of Rivers APC from the ballot in 2019.

"Evidence exists how Senator Abe and his lieutenants broke into celebration the day the Party was excluded by the court", the party said in a press conference in Port Harcourt.

Chris Finebone, Publicity Secretary of the party in the state who addressed the press conference said "Rivers APC considers the formal exit of Abe and his associates from the APC as good riddance. We liken it to a successful excision of a debilitating cancer from the body."

He said the party can now heave a sigh of relief "from the sustained destabilizing onslaught by Senator Abe" and wished him well "as he joins the SDP".

# PDP asks Tinubu to quit presidential race over 'fake' bishops saga

Says Osun election result signposts collapse of APC

eoples Democratic Party (PDP) asked the presidential candidate of All Progressives Congress (APC), Asiwaju Bola Tinubu, to toe the path of honour by withdrawing from the 2023 race and apologize for allegedly misleading Nigerians by dressing hired persons in bishops vestments to orchestrate an endorsement for his single religion ticket campaign.

"It is in its strongest term, we condemned what is described as a profane and highly provocative act of desperation by Tinubu, in the face of "APC's collapsing leadership, membership and followership structure across the country."

The party said it was appalled by the 'nauseating, blasphemous and unpardonable' act by the APC and demanded from Tinubu, a public apology to Nigerians.

The PDP said from the foregoing, it is obvious that the image of APC and Tinubu has been battered beyond repair and that it is only responsible for the former Lagos State governor, to honourably bow out of the race to avoid further embarrassment.

National Publicity Secretary of PDP, Hon. Debo Ologunagba said these at a briefing in Abuja on Friday.

He said "Nigerians were sickened by videos and pictorial evidence of known mechanics, bus conductors and fraudsters sacrilegiously being dressed in fake bishop vestments and paid to endorse the unveiling of Asiwaju Tinubu's widely rejected running mate, Sen. Kashim Shettima.

"Such action is unacceptable and unbecoming of any individual aspiring to a leadership position at any level let alone, the office of the President. This is an embarrassment to leadership."

He added that with this scandalous act, Asiwaju Tinubu, who is still battling with issues of "alleged perjury, non-existent certificate and allegations of extortions" has become more ethically challenged and lost all moral standing to seek election as the President of the Federal Republic

"More sickening is the outcry by the hirelings that they were defrauded by agents of the APC Presidential candidate, who paid them sums ranging from N30,000 to N40,000 as against the N100,000 they were earlier promised.


"It is therefore ludicrous that instead of being remorseful and asking for forgiveness, the APC Presidential Campaign is shamelessly posting lame denials and excuses in the face of hard and verified evidence of its involvement in the shameless venture.

His Royal Majesty, Pere of Akugbene-Mein Kingdom in Bomadi Local Government Area of Delta State, is the first Vice Chairman of the Delta State Council of Traditional Rulers.

The 56 years old Monarch, who ascended the throne of his ancestors at a youthful age of 21 years, has been on the throne of Akugbene-mein for 25 years. He is known to be very reserved and rarely intervenes in national issues.

Some days after the euphoria of his 56th birthday celebrations, *Trumpet Palace Watch* decided once again to try its luck and asked him for an interview after several attempts in the past were quietly declined.

He spoke about the efforts he had been making to attract developments to his hitherto rustic fishing village which is now one of the bustling modern cities in the Niger Delta Region of Nigeria. We then dovetail into present-day politics, banditry and other national issues.

Commenting on recent political developments in the country, the Akugbene-Mein expressed disgust at some political developments: "The absurdity and political recklessness, which is almost becoming a norm in Nigeria, is most unacceptable and not good for the health of the nation, from here in the Niger Delta Region, to Imo State in the South East, to Kastina, North Western and Borno in the North-East, we are all Nigerians. We all have a common stake and common interest in the survival of the country. We, therefore, need each other to survive. It is our collective responsibility therefore as a people to ensure that Nigeria as a country, no matter its present challenges survives."

Speaking on the most recent political developments in the country, he said, "It is with utmost restraint that I am making these comments. As a traditional ruler, I am not supposed to play politics and I will never actively or covertly support any political group or party no matter the pressure. But this does not prevent me from making informed comments on issues that are giving the country great concern. Sadly, we were all wrong in our assumption then. Surprisingly, this bill has again been reintroduced, because the Federal Executive Council led by President Muhammadu Buhari, knew it has a willing tool in the current 9th National Assembly headed by Senate President, Ahmed Lawal. Most disappointingly, Senator Lawal and Speaker Femi Gbajabiamila had unashamedly told the Nigerian public when they assumed office, that whatever Executive bills were ever forwarded to them, they will pass without asking questions. ### Why there is relative peace in Niger Delta under Buhari - HRH Suanu

I, therefore, call on the leadership and people in these areas to cooperate with the State and federal government in the rehabilitation programmes, which will be streamlined and made more effective. As ever, I am ready to listen to grievances of my fellow Nigerians. I extend my hand of fellowship to them so that we can bring peace and build prosperity for our people."

In the same vein, Vice President Yemi Osinbajo, while in Yenagoa, Bayelsa State, on February 10, 2017, said, "We must focus on how to ensure that the people of the Niger Delta see the benefits of the land's wealth. This new vision will define the future of this region."

Since then, there has been an increase in the budgetary allocation to the region. In the year 2018 for instance, N71.20 billion Naira was allocated to the Niger Delta Development Commission (NNDC). A total sum of N53.89 billion Naira was again allocated in the 2018 Budget for the Ministry of Niger Delta, up from the N34.20 billion Naira provided in the 2017 budgetary allocation.

The Minister further elaborated, that the Ogoni cleanup project was cut into phases, out of which ten formerly polluted sites have been cleaned up, adding that there had been concerns about some aspects of the project. The concern the Minister raised during his briefing is yet to be addressed. The Minister again went further to say that the Federal Government had made moves at rallying all stakeholders so that the work

could move faster. Thus, stressing that President Muhammadu Buhari had instructed his Ministry to ensure that adequate attention is paid to delivering on the Ogoni project. As a traditional ruler, I am however speaking the minds of so many people in Ogoni land. We doubt very much whether this project will be delivered before the expiration of President Buhari's administration.

"I had the opportunity to present to Mr President, in accordance with the key priorities of my Ministry, certain key projects that are undergoing some sort of review and seeking direction from Mr President. Firstly, you are all aware of the hydrocarbon pollution remediation project, which is called the Ogoni cleanup. It's a major priority of this government and particularly, based on the undertaking and the promises made by Mr President, to deliver a very clear ecosystem for the Ogoni people." If you must know the truth, our ecosystem is still messed up."

The summary is that there are still a lot of polluted places in Ogoni land that have not been cleaned up. As far as we are concerned, seven years is enough time for these jobs to have been completed. Considering the fact that the livelihood of the majority of Ogoni people which is farming and fishing is dependent on the cleanup exercise.

In some areas of Ogoni land, some youths who are supposed to be in their farms and engaged in their daily fishing activities can't do so because of the pollution, that's why we are pushing for this project to be completed before President Buhari completes his tenure.

Suanu continued, "There have been many attempts and many plans made in the past to improve the lives of the people of the Niger Delta Region of Nigeria. Sadly, each ended with very little to show for the time and resources spent. Therefore, it is understandable that the people of the Niger Delta Region are quite disillusioned with plans at this time. The disenchantment

of the people notwithstanding, it must be stated that the Niger Delta Master Plan is different in its goals, focus, and approach, and will not suffer, the fate of the others before it. This Master Plan is basically conceived as a tool that the millions of people of the region can use to actualize their common vision and build their future to the standard they desire."

Another area, I must quickly comment on, is that the entire Ogoni land as we speak is not connected to the national electricity grid. We are asking that this be done, so that we can also have a regular electricity supply that will enhance the capability of our youths, to venture into little enterprises that will boost our local economy. Finally, let me seize this opportunity to appeal to all Nigerians to go out and register and vote, in the forthcoming elections, as this is the only way we can effectively take control of our country and make sure things work well as expected."

As part of its strategies to curb terrorism and tackle insecurity in the country, the National Security Council has said that it is considering a nationwide ban on motorcycles and mining

disclosed on This was Thursday the Attorney Thursday by the Attorney General of the Federation and Minister of Justice, Abubakar Malami, who addressed State House correspondents after the President, Muhammadu Buhari, met with Security Chiefs in Abuja.

Aregbesola revealed that President Buhari had received a report on the preliminary investigation of the Kuje attack and officers who have been found to renege on their responsibilities would face dire consequences.

Terrorist groups, particularly in Nigeria, are increasingly interested in controlling areas of production of gold. This may have contributed to the increased terrorist attacks in the nation's northeast.

After being the major organizing, tool used for promoting, publicising, and sustaining the #EndSARS campaign that crippled the country for several months in 2020, the Buhari government banned the use of Twitter, one of the leading social media platforms from 5th June 2021 to 13th January 2022.

The ban followed the deletion of tweets warning Biafra agitators of the implications of a repeat of the 1967 Civil War and the suspension of President Buhari Twitter account.

#### Terrorists kill five policemen, three civilians in Katsina

Terrorists have killed five police officers and three civilians in Kankara Local Government Area of Katsina State.

incident, which occurred at Gatikawa village at about 6:30 pm Wednesday, was said to have been carried out by more than 300 terrorists.

The terrorists were said to have stormed the riding community on motorcycles, and armed with AK-47 rifles, among other weapons.

They were said to have operated for more than an

hour, moving from house to house to loot food items, money and other valuables.

Several people in the community were said to have sustained injuries when the terrorists attacked, with some of them said to have been hospitalized and receiving treatment.

A source from the area

had initially told reporters that a mobile policeman and five civilians were those killed by the terrorists during the attack.

However, spokesman for the Police Command in the State, SP Gambo Isah, who confirmed the incident on Thursday afternoon, said eight persons were killed

during the attack.

Isah said the victims include five policemen and three civilians, and that the policemen killed were on special duty to the area from Kano State.

Isah said the attack was carried out by more than 300 terrorists who were armed with sophisticated

"The terrorists were over 300 and were fully armed. The five policemen are from Kano on special duty to Gatikawa.

"The terrorists attacked them at 6:45 pm. The terrorists also killed three civilians. Investigation is ongoing," he added.

# Implications of a Muslim-Muslim Ticket

ecently, APC Presidential Flagbearer, Senator Bola Ahmed Tinubu a Muslim, announced another Muslim, Borno Central Senator, Kashim Shettima, as his running mate for the 2023 presidential election. This decision has stirred the hornet's nest of deep religious sentiments across the country, virtually pitching the predominantly Muslim north against the Christian south. Stakeholders have daubed it a 'Muslim-Muslim Ticket' and have reacted to it in in several ways. The general feeling is that it is inimical to the survival of the country. Indeed, the Legal adviser of APC has resigned from the party to protest the presidential ticket. Foremost Tinubu supporter Babachir Lawal from the north and Christian Association of Nigeria have raised a loud voice against the Muslim-Muslim ticket. The Department of State Security has written a memo to the President advising that the Muslim-Muslim ticket has grave implications on the nation's security.

Since 1960, only two political parties have adopted same religion presidential tickets: the Unity Party of Nigeria in 1979, and the Social Democratic Party in 1983. The three political parties that led Nigeria into independence were formed along ethnic lines. They were implicitly formed along religious lines since each of the dominant ethnic group is known to be strong in either of the two religions in the country. Religion ran through the general elections of 1954, 1959, as well as 1964/65. By 1979 when the military organized the first elections, the choice of presidential as well as gubernatorial flagbearers was dictated by religious sentiments. Popular opinion has it that the 1979 adoption of Muslim-Christian ticket of NPN ensured both political and legal victories over the UPN which ran a Christian-Christian ticket.

In the elections of 1983, 2003, 2004, 2007, 2011 and 2015 the parties were also sensitive to religion. Currently, the president of Nigeria is a Muslim, the Vice President is a | in politics. But certain ideal and desirable Christian, the Senate president is a Muslim, while his Deputy is a Christian. In the House of Representatives, the Speaker is Christian, his Deputy is Muslim. Of the 36 states in Nigeria, there are 20 Christian governors and 16 governors who are Muslims. In the South where Christianity appears strong, 16 out of the 17 governors are Christians, with only one Muslim; there are 14 Christian deputy governors, 3 Muslims. In the North where Islam appears dominant, Muslims occupy 15 of the 19 gubernatorial seats, while the rest four are Christians. Muslim deputy governors are 11 with Christians, 8. These are signs of balancing in the country's political space.

Ideally, one's religious faith should not count

practices may provoke devastating unintended consequences in others if not properly handled. The latter may be the case of any same religion presidential ticket at this time. Certainly, being sensitive to religion in pairing is how the many peoples of Nigeria have managed religion as a factor in national politics.

We are aware, however, that the tendency to overrate religion remains very high even when it has not pragmatically assisted the country in addressing her unending crises of insecurity, nationalism, and the economy. For this reason, we advise the nation's electorate to focus on electing empirically capable candidates, irrespective of their religion or ethnic affiliation. Because of the tendency of each religion to see its adherents as superior to others, many voters are more likely to vote for candidates who share their religion. The belief is that because they have similar orientation and think in similar ways, candidates with of their religious outlooks are more likely to protect their interests. It is important to state that none of the two political parties

It is up to the Nigerian people to decide who will become their leaders in 2023. Beyond the elections, all forms of balancing needed to manage our diversity must be considered for the purpose of post- election legitimacy, peace, and tranquility. The route chosen by APC's Bola Ahmed Tinubu to the 2023 Presidential election is fraught with danger, insensitive to the sensibilities of the Nigerian State and could be a source of future instability in a country already tottering from a savage attack on its national institutions. It is not too late to make a reversal. The overall interest of the country is more important than individual ego and rabid desire to win the Presidency!

# De-sacralization of priestly habits and vestments

hristian priests, as in most religions, are often identified by their attires. This is often called 'habits' and 'vestments' if are to include the altar and other elements of worship.' The most common is the cassock or sultanas. The cassock is actually not a sacred vestment. It may be identified as a common daily attire of a priest.

Nevertheless, most Christian priests are identified with white collars, cassocks and clerical shirts that they put on. Again, only those who can discern would be able to distinguish the differences among priests of the different churches' denominations. There are the traditional Anglican cas-

socks – the simple, double-breasted and 39 articles cassocks - that come in three colours. Most Priests of the Anglican faith may be seen in three colours of clerical shirts of which one, like the cassock, is reserved for Bishops. Only one who is acquainted with what is referred to as orthodox or so-called liturgical churches, may be acquainted with these details. Therefore, a theologically trained priest should be able to know a Catholic, Methodist, Presbyterian or Anglican/ Episcopal priest by mere appearance.

The English poet, Chaucer says the hood does not make the Monk. But the monk must always wear a hood. In the course of their daily offices, and they are diverse in types and forms, priests appear in various vestments. Now, Priestly vestments are termed "holy and sacred" since they are biblically regulated along the order of Leviticus. "And of the blue and purple and scarlet stuff they are made finely wrought garments, for ministering in the holy place; they made the holy garment for Aaron; as the Lord had commanded Moses" (Exodus 39:1). Again, in Leviticus 8:5, 30, the sacred nature of the vestments of a Priest is put thus: "And Moses said to the congregation, 'this is the thing which the Lord has commanded to be

done. 'And Moses brought Aaron and his sons and washed them with water. And he put on them the coat, and girded them with the girdle, and clothed him with the robe, and put the ephod upon him, and girded him with the skilfully woven hand of the ephod, binding him therewith .... Then Moses took some of the anointing oil and the blood which was on the altar, and sprinkled it upon Aaron and his garments, and also upon his sons and his son's garments; so he consecrated Aaron and his garments, and his sons and his sons' garments with him.""

The vestments with which a Christian priest adorns himself are never for profanity.

They may be classified as those used strictly within the confinement of the Church's sanctuary and those worn outside which are simply meant to identify him as a man of God. Now, there has been the common practice among Nigerian politicians who believe that Christian Pastors and Priests can be engaged, hired and fired depending on if their 'price' can be afforded. Everyman, Thomas Bolt wrote, has his price! Given this, one can easily understand why the Roman Catholic, Anglican, Methodist, and a host of other orthodox liturgical denominations in Christianity can be easily relegated to the background, and handle with disdain by some contemporary Nigerian politicians.
The height of this disdain was demon-

strated by the Muslim-Muslim unveiling of the Vice Presidential Candidature of Senator Shetima. Without any regards for the sacredness of priestly vestments; with speechless disregard of their sacerdotal use – liturgical/seasonal colours, stoles and preacher's scares, chasubles, pastoral staffs and rings name it - some persons, God forgive us in Christ Jesus' name, were lined up and marched to the 'unveiling arena' as epitome representatives of Christianity in

# Pentecostal leaders risk revolt over APC Muslim-Muslim ticket

The Presidential candidate of the All Progressives Congress (APC), Asiwaju Bola Ahmed Tinubu, allegedly met with the General Overseer of the Redeemed Christian Church of God (RCCG), Pastor Enoch Adeboye at the Redemption Camp on Sunday, July 17, 2022.

Tinubu, a Yoruba Muslim and Adeboye were alleged to have met in connection with the APC's decision to pick the former Governor of Borno State, Senator Kashim Shettima, a Northern Muslim as his running mate in the 2023 presidential election in Nigeria.

It was gathered that the APC presidential candidate has already set up a team of prominent persons with whom he was scheduled to meet the Christian leaders within the party and faith-based organizations like the Christian Association of Nigeria (CAN), Pentecostal Fellowship of Nigeria (PFN) and the Catholic Church to appeal to them and secure their support ahead of the 2023 polls.

RCCG on Tuesday, July 19, 2022, clarified the purported meeting. They said in a press statement, that contrary to the reports that Pastor Adeboye met with Asiwaju Tinubu over the APC Muslim-Muslim presidential ticket, the meeting between the duo never took place.

"It has come to our notice that some news outlets are reporting that a meeting between Pastor E.A. Adeboye, the General Overseer of the Redeemed Christian Church of God Worldwide and former Governor of Lagos State, Bola Tinubu, was held a few days back at the Redemption Camp where our esteemed father in the Lord was said to have supported the preferred candidature of the party of the former Governor.

"Pastor E.A. Adeboye and RCCG have not and will not endorse any candidate for the 2023 general election in Nigeria."

At the official unavailing of Shettima in Abuja, the alleged hiring of miscreants who posed as Christians Bishops and clergymen further complicated matters.

Trumpet Religious Desk Editor decided to dig into this matter to find out whether or not a meeting did take place between Tinubu's group and Pastor Adeboye. In an effort to further confirm the veracity of these claims and counterclaims, we reached out to Tinubu's Media Adviser, Alhaji Tunde Rahman. But he did not pick his calls.

Meanwhile, Prophet Gabriel Onaolapo, who is the Founder of one of the fast-growing Pentecostal Church in Nigeria, known as the Christ The Kings Rescue Global Ministry based in Ogun State, has warned that some of the General Overseers of the big Pentecostal Churches in Nigeria, need to exercise a lot of caution and restraints over the way and manner they handle this Muslim-Muslim presidential ticket of the APC.

He said, "As an active member of most of the Christian bodies in the country, I know that most younger pastors of churches across board, call it the new generation or orthodox Churches in Nigeria, are very angry over what the APC Flag bearer did when he decided to pick a fellow Northern Muslim as his running mate."

He stressed that Tinubu, attempted to trivialize this matter, claiming that he considered competence above religion in picking his running mate is unacceptable to most Christians as it is a deliberate attempt to hoodwink the Christian Communities. He added that because of this insult younger Pastors from all the dominations have decided to ignore the older Pastor and form a movement. He asked, "is Bola Tinubu saying there are not competent Christians in the whole of the Northern region to be his V.P?" Onaolapo explained that "Justice"

Aniagolu's Deputy in the 1988 Constituent Assembly meeting who was then the Chief Judge of former Gongola State, died suddenly in 1991, two years after that Assembly completed its work. While Justice Aniagolu was a Christian, Ardo his Deputy was a Muslim. While the Secretary to that Constituent Assembly was then Alhaji Babagana Kingibe, whom the country has since then gotten to know a lot more eloquently, he is a Muslim from Borno State. Kingibe's assistant at the Assembly was a Christian lady from Rivers State, Ms Amal Inyingiala

Pepple, who retired from the Federal Civil Service as a Permanent Secretary. This was the time Nigeria only had 21 states."

Onaolapo added that "it was this same Assembly that negotiated the terms of a constitution which we now operate on the basis of which the Babangida regime claimed it would hand over power to an elected government at the end of its transition programme. This is the same Constituent Assembly that got into a very animated debate in October 1998 over this very irrelevant issue of religion as the All Progressive Congress (APC) would want Nigerians to believe. Centred in this heated debate are religion in Nigeria and the role it plays in the civic and constitutional life of the country. In that quarrel that lasted for months, the Muslim and Christian members of that Assembly then, neither gave nor took a quarter from each side of the divide. Yet the APC and Tinubu in the year 2022, want Nigerians to believe that religion should not be of any importance to them."

He warned Christian leaders, who might want to compromise and sell the Christian faith out for a pot of portage, over this matter that a huge surprise awaits them.

Onaolapo said the recent revelations he got indicate that, except there is divine intervention, the way things are currently going in Nigeria today, there might not be elections. He added that, although he is not in a position to say what will happen and the shape things will take in the days ahead, that will prevent the 2023 general elections from holding, he said he foresees an interim government that will eventually midwife a fresh election that will lead to a democratic transition in the country.

# Replicate rice production feat in other sectors, Dangote charges CBN

•As experts canvass robust non-oil export trade, technology to boost Nigeria's economy

President of Dangote Group, Alhaji Aliko Dangote, has urged the Central Bank of Nigeria (CBN) to replicate its feat in encouraging the production of rice, wheat, dairy and other economic crops to boost non-oil exports in the country.

Dangote, who gave the charge at the seventh edition of Zenith Bank International's yearly trade seminar with the theme: Unlocking Opportunities in Nigeria's Non-Oil Export Business, which was held virtually on July 20, 2022, in Lagos, said Nigeria currently imports \$2.8 billion worth of wheat and \$1.4 billion worth of dairy into the country. He said: "Cash crops have

He said: "Cash crops have been major components of nonoil exports and there is room for improvement. Nigeria has abundant varieties of solid minerals, but the sector constitutes only 0.2 per cent of the country's Gross Domestic Product (GDP).

"We can generate \$20 billion from solid minerals, we need a more robust steel industry and so, we should establish an equivalent of the Nigerian National Petroleum Company (NNPC) to hold stake on behalf of the Federal Government."

He also pointed out that Nigeria's non-oil exports remained quite low compared to other African top oil producers, adding: "This exposes the economy to oil price and production risks. There is much room for growth and the CBN is helping to drive this through the RT200 programme."

He maintained that the aim of CBN's RT200 FX programme to achieve \$200 billion in foreign exchange earnings from non-oil proceeds in the next three to five years was laudable, stressing that it included enhancing foreign exchange inflows, diversifying the source of FX inflow, increasing the level of contributions from non-oil export, as well as ensuring stability and sustainability of FX flows.

Besides, stakeholders also canvassed support for Nigeria's non-oil exports sector through collaboration in diversifying Nigeria's export base through the promotion of non-oil exports and technological innovations.

In his goodwill message and presentation, Founder and Chairman of Zenith Bank Plc, Jim Ovia, highlighted the importance of non-oil export to the nation's economy, pointing out that Nigeria largely exported cocoa and several other non-oil products for decades before oil was discovered in commercial quantities.

He cited the 25-storey Cocoa House in Ibadan, Oyo State, which was built with proceeds from cocoa exports, pointing out that some countries like Japan and China had been successful because they were doing a lot of innovations, production and manufacturing of goods and services.

"We should also look at promoting the nation's non-oil export sector through technology to create technological giants like Apple, Tesla and Google. And we already have technology companies in Nigeria, such as Flutterwave, which has a valuation of \$3 billion, making it more valuable than some banks in the country.

Speaking further on the enormous potential in Nigeria's non-oil sector, Ovia highlighted the phenomenal growth of Nigeria's emerging financial technology (Fintech) companies such as Flutherwave, OPay, Interswitch, Kuda and Paystack, with market valuations of \$3 billion, \$2billion, \$1 billion, \$500 million, \$200 million respectively, insisting that this underscored the enormous opportunities in the Fintech space.

He also noted that the most capitalised companies in the world, such as Apple, Microsoft, Alphabet (Google), Amazon, Tesla and Visa, among others, were not oil companies, but were operating in the technological innovation space.

Group Managing Director and Chief Executive Officer (MD/CEO) of Zenith Bank, Ebenezer Onyeagwu, said the yearly seminar had served as a veritable platform to deepen the conversation on promoting non-oil export in Nigeria, bringing together non-oil export practitioners and relevant government agencies to interact and explore the opportunities and proffer solutions to the challenges of non-oil export in the country.

On the origin of the seminar, Onyeagwu said the commodity price

slump of 2014-2016 was a watershed moment, adding: "When crude oil prices plunged from \$114.55 per barrel in June 2014 to \$28.76 in January 2016 with an attendant effect on the availability of foreign exchange, the time was ripe to look towards the non-oil export sector for a more sustainable source of foreign exchange not susceptible to external shocks and price volatility.

Highlighting some of the salient outcomes of the past six editions, Onyeagwu noted that the outcomes of previous editions have found expression and influenced policy initiatives, adding: "For instance, the extension of the repatriation period of non-oil export proceeds from 90 days to 180 days and the policy mandating shippers not to carry exports without a Nigeria Export Proceeds (NXP) Form Number, were recommendations from previous seminars."

Also, the need to incentivize exporters to repatriate their export proceeds through the official channels and the recommendation to create export terminals across various export hubs in the country were from past seminars. Also, previous editions recommended having Export Desks in commercial banks, which has now been instituted.

He also stated that Zenith Bank has trained over 100 exporters through

its Zero to Hero programmes, which provide a platform for grooming and exposing beginners to become strong exporters by providing training on documentation, product sourcing, access to market and financing. He noted that Zenith Bank will continue the advocacy of promoting non-oil export.

Delivering his goodwill message, Governor of the Central Bank of Nigeria, Godwin Emefiele, commended Zenith Bank and its leadership led by Ovia for the initiative in organising an annual export seminar to explore opportunities in Nigeria's non-oil export with the view to increasing the nation's non-oil export base and ultimately increasing its share as a percentage of total exports.

"This is why the theme of this year's seminar is timely and appropriate. This is because the global economy and structure are changing rapidly. The previous world economic order underscored by globalisation and seamless trade possibilities seems to be suffering major disruptions lately. We believe Nigeria has a lot of potential and we can harness this for the good of our people and country," he said.

He pointed out that the CBN had undertaken several initiatives to promote the non-oil export sector, because of its firm belief that the non-oil export sector holds enormous potential to contribute to employment generation, wealth creation and economic growth of the country.

Also, Secretary-General of the African Continental Free Trade Area (AfCFTA) Secretariat, Wamkele Mene, enumerated the progress and achievements of the AfCFTA and efforts to improve intra-Africa trade.

On his part, President Chairman of African Export-Import Bank (Afreximbank), Prof. Benedict Oramah, highlighted the efforts of Afreximbank to enhance intra-Africa trade through implementation of the Pan-African Payment and Settlement System (PAPSS).

He said the PAPSS would make it easy and seamless for Africans to trade and receive payments for goods and services in their local currencies, as well as eliminate the challenges of currency conversion.

# NCAA suspends Dana Air's operations indefinitely on financial, safety grounds

•As Airline appeals to passengers, express confidence of return

The Nigerian Civil Aviation Authority (NCAA) has suspended the Air Transport Licence (ATL) and Air Operator Certificate (AOC) of Dana Airlines indefinitely with effect from Wednesday, July 20, 2022.

NCAA explained that the suspension was made pursuant to Section 35(2), 3(b) and (4) of the Civil Aviation Act, 2006 and Part 1.3.3.3(a)(1) of the Nigeria Civil Aviation Regulations (Nig. CARs) 2015.

The suspension order, which was delivered on the orders of the Director General of the NCAA, Captain Musa Nuhu, has since been communicated to the management of Dana Airlines.

Recall that Dana Air, on June 29, 2022, had announced the introduction of additional flights on its Lagos and Abuja route network, in what could be described as a good development at the time.

The airline revealed that the move was based on popular demand, the desire to meet the growing demand, and the need to follow through with its strategic route expansion.

Latest events have, however, proved otherwise, following the suspension of the airline by the NCAA on financial and safety grounds.

"The decision is the outcome of a financial and economic health audit carried out on the Airline by the Authority, and the findings of an investigation conducted on the Airline's flight operations recently, which revealed that Dana Airlines is no longer in a position to meet its financial obligations and to conduct safe flight operations.

safe flight operations.

"The NCAA acknowledges the negative effect this preemptive decision will have on the Airline's passengers and members of the travelling public and seeks their understanding, as the safety of flight operations takes priority over other considerations," the suspension order reads.

When contacted, Communications Manager of Dana Air, Kingsley Ezenwa, said on telephone that the stoppage of catering services would not be for long, and was not due to any financial difficulty.

On the airline's financial situation, Ezenwa stressed that Dana remains one of the strongest in the country, adding that the recent increase in frequency, sponsorships and partnerships are pointers to the fact that it is doing well financially

fact that it is doing well financially. Confirming the development, management of Dana said the decision was reached to undergo full operational audit and blamed the situation on increasing cost of Jet A1, which now sells at 830 per litre in some airports, unavailability of forex and inflation as contributory factors.

"Our operations have been suspended as advised by the Nigerian Civil Aviation Authority (NCAA) to enable us to undergo full operational audit with effect from July 20, 2022," it added.

#### Shippers Council intervenes in dockworkers, APM Terminals labour crisis

Regulators of terminal operators and shipping firms in the maritime industry, the Nigerian Shippers Council (NSC), has intervened in the ongoing crisis between the AP Moller Terminals (APMT) and protesting dockworkers under the aegis of the Maritime Workers Union of Nigeria (MWUN) over unresolved dispute.

As of the time of filing this report, it was learnt that the officials of the NSC were still in a meeting with the leadership of MWUN with a view to dousing the tension.

It would be recalled that aggrieved dockworkers under the aegis of the Maritime Workers Union of Nigeria (MWUN) have shut down the APM Terminals in Apapa, thereby crippling port operations over poor remuneration of workers at the facilities.

Top executives of the union led by the President-General of MWUN, Adewale Adeyanju, and other members of the dockworker's branch converged on the entry points of the terminals during the protest, insisting that management of the terminal was taking Nigerian labour workers for granted, hence the need for the demonstration.

This followed 24 hours after the expiration of the three-day extension of the strike notice, which the leadership of MWUN gave issued to the terminal operator earlier in the week.

Consequently, managements of the Nigerian Ports Authority (NPA) and NSC started mounting pressure on the terminal operators to find a lasting solution to the current impasse.

Adeyanju said if the management of the APM Terminal refuses to meet with the workers and accede to their demands, the closure of the terminals would continue.

"Our members have closed APM Terminals in Apapa. All the examination offices in the container terminal that are being used by officials of the Nigeria Customs Service (NCS) are currently shut. The agitation is connected with the refusal of the APM Terminal, Apapa management to review the Collective Bargaining Agreement (CBA) of the workers, which ought to be reviewed every year.

"It is an internal agreement between the workers and the terminal operator, but the terminal operator has refused to review the condition of service of the workers this year and that is why everywhere inside APM Terminals is currently under lock and key.

"Management of the APM Terminals has decided to act funny by not reviewing the workers' condition of service, but I will address the workers soon. If APM Terminals refuses to meet with us, the shutdown of port operations at APM Terminals, Apapa will continue," he stated.

Confirming the situation at the APM Terminals, the Spokesman of Apapa Command of the NCS, Abubakar Usman, explained that officers were currently in the ports, but could not access their examination offices, as the workers had shut the entrance gates against them.

"Our officials are in the ports. They have not been locked out of the ports. However, their offices have been locked up by the protesting workers. If the officers cannot access their offices, there is no way they can carry out any cargo clearance duty. Our men are there, but are not working currently, because of the protesting workers, who have locked up all the cargo examination offices in APM Terminals," he said.

#### Senate passes Electricity Bill to boost power distribution, seeks increased investments, reforms

Following the incessant collapse of the national grid and persistent power outages across the country, as well as consideration of a report of the Senate Committee on Power, the upper legislative chamber has passed the Electricity Bill 2022.

Chairman of the Committee, Gabriel Suswam (PDP-Benue North East), in his presentation, said the bill seeks to, among other things, provide an ideal legal and institutional framework to leverage the modest gains of the privatisation phase of the country's electric power sector.

He said when signed finally into law, the bill will improve utilisation of generated power through increased investments in new technologies to enhance transmission and distribution of generated power to minimise aggregate value chain losses.

Suswam, who maintained that the legislation would revive the institutional framework for the reform of the Nigerian Electricity Supply Industry (NESI), as initiated and implemented by the Federal Government, disclosed that the provisions of the bill seek to promote policies and regulatory measures that would ensure the expansion of power transmission networks to address any imbalance in the existing transmission infrastructure.

He further noted that the bill would stimulate policy and regulatory measures to scale up efficient power generation, transmission and distribution capability of the sector, as well as address technological limitations and outdated infrastructure that had been responsible for the huge losses in the electricity value chain.

President of the Senate, Ahmad Lawan, who interjected midway through consideration of the bill, sought to know the role and operational capacity of banks that had taken over distribution companies (DisCos) indebted to them.

But responding, Suswam explained that the banks' intervention in the DisCos was done in collaboration with the Nigerian

Electricity Regulatory Commission (NERC) and the Bureau of Public Enterprise (BPE).

According to him, there was a transitional process put in place during the take-over of the Abuja Electricity Distribution Company (AEDC) by the United Bank for Africa (UBA) to ensure efficiency in its service delivery.

He noted that such transitional process usually involves the invitation of new investors to scale up generation and distribution capacities, adding that the Federal Government had disbursed about \$100 million to Siemens to facilitate transmission in the distribution end of the power sector.

On his part, Senator Ahmad Babba-Kaita (PDP-Katsina North), who said the faulty way in which the DisCos were created was largely responsible for their inability to live up to expectations, urged the Federal Government to ensure a transparent process in the selection of the companies to take-over power generation and distribution across the country.

Deputy Chief Whip, Senator Aliyu Sabi Abdullahi (APC-Niger North), noted that the aspect of renewable energy in the bill was given prominence amidst the energy mix.

After a clause-by-clause consideration of the Committee's report on the Electricity Bill 2022 by the Committee of the Whole, it was passed in the upper chamber.

Speaking shortly after the passage of the bill, Lawan, said: "Because of its importance and sensitivity, we would like to see a quick concurrence by the House of Representatives, because time is of essence, as far as issues of electricity and energy supplies are concerned in Nigeria.

"So, we would like to see that this bill is fully processed in the National Assembly and sent to the Executive arm of government for the consideration for assent by President Muhammadu Buhari. We believe that this piece of legislation could change the fortunes of the country's electricity industry for the better."

# Debt servicing surpasses revenue by N310b as FG releases fiscal report

Govt to spend N6.72tr on fuel subsidy in 2023

The cost of servicing debt surpassed the federal government's retained revenue by N310 billion in the first four months of 2022.

The federal government said this in its 2022 fiscal performance report for four months released on Thursday.

According to the report, the Federal Government's total revenue for the period was N1.63 trillion, while debt servicing gulped N1.94 trillion.

While providing update on the budget performance in Abuja, Minister of Finance, Budget and National Planning, Mrs Zainab Ahmed, said urgent action was urgently required to address under-performance of revenue and expenditure efficiency at the national and sub-national levels.

The aggregate expenditure for 2022 is estimated at N17.32 trillion, with a pro rata spending target of N5.77 at the end of April," the report reads, adding that the actual spending as of April 31 amounted to N4.72 trillion, of which N1.94 trillion was for debt servicing and N1.26 trillion was for personnel costs and pensions.

'As of April 2022, N773.63 billion has been spent on capital expenditure, while the Federal Government's retained revenue was only N1.63 trillion, which is 49 per cent of the pro rata target of N3.32 trillion," she said.

The document added that the Federal Government's share of oil revenues came to N285.38 billion, representing 39 per cent performance, while non-oil tax revenues amounted to N632.56 billion, which translated to 84 per cent performance and that based on the figures, the Federal Government generated N401.8 billion from Company Income Tax (CIT) and Value Added Tax

amounted to N298.83 billion and N102.97 billion, representing 99 per cent and 98 per cent of their respective targets. Customs collections, comprising import duties, excise and fees and the federation account special levies, trailed target by N76.77 billion, amounting to 25.42 per cent. Other revenues came to N664.64 billion, of which independent revenue accounted for N394.09 billion," the report added.

Meanwhile, the Federal Government has said it would make provision for N6.72 trillion for fuel subsidy in 2023.

Ahmed disclosed this in Abuja on Thursday during the 2023-2025 Medium Term Expenditure Framework and Fiscal Strategic Paper (MTEF and FSP) Public Consultation, maintaining that the amount would remain and be fully provided for by the Nigerian National Petroleum Company (NNPC) Limited on behalf of the Federal Government.

The minister, however, said the NNPC, which had funded the fuel subsidy until last month, would henceforth leave that responsibility to the federation, adding that this would even create a greater strain on the fiscal position of the federal government, describing fuel subsidy as unsustainable.

"It will remain and be fully provided for by the NNPC on behalf of the federation if government allow this to continue," she added, explaining that another scenario would be that petrol subsidy would remain till mid-2023 based on the 18-month extension announced in early 2021, in which case, only N3.36 trillion would be provided for.

"Both scenarios have implications for net accretion to the Federation Account and projected deficit levels. There will be tighter enforcement of the performance management framework for Government Owned Enterprises (GOEs) that will significantly increase operating surplus and dividend remittances in 2023," she said.

The minister added that the Federal Government recorded a N3.09 trillion deficit in its 2022 budget implementation between January and April this year, adding that the deficit underscored the fiscal challenges confronting the Federal Government.

Mr Muhammed Abdulahi, The Minister of Environment, made the commitment at a two-day National Stakeholders' Technical Committee Meeting on WACA programme held in Abuja, Nigeria.

Mr Abbas Suileman, Director, Environmental Impact Assessment in the ministry, who represented the minister, said the effort would reduce the vulnerability of coastal areas in the country.

He said that the programme will also promote climateresilient integrated coastal management, within the framework of sustainable environmental management.

"The benefits of the WACA are quite immense; the WACA will help Nigeria obtain financing and exper-

tise to sustainably manage her coastal areas, enhance industrial competitiveness, market access, innovation and investment promotion.

"It is also a representation of your various state governments, Ministries, Departments and Agencies (MDAs) and the minimum expected from you is a service of honesty, integrity and foresightedness," he said.

Mr Francesso Mentovani, Engagement Leader and Lead Water Specialist, Sustainable Development, World Bank said that all countries in West Africa, including Nigeria, were committed to the implementation of the programme.

Mentovani said that the stakeholders' meeting was convened to get the buy-in of all stakeholders on the way forward for WACA in Nigeria.

He said that the objective of the programme was to preserve, protect and tackle environmental issues such as desertification, climate change and other environmental challenges in the region.

The Permanent Secretary of the ministry, Mr Hassan Musa, said WACA was established in 2015 by the World Bank to manage growing coastal erosion and flooding problems in West Africa region.

"WACA established a committee in 2016 to ensure that the programme covered a range of sectoral issues" he said.

The Permanent Secretary was represented by Mr Dilichukwu Etigbue, Director, Erosion, Flood and Coastal Zone Management in the ministry.

The Lagos State Commissioner for Environment and Water Resources, Mr Tunji Bello, represented by Mr Adegbite Mohammed, disclosed that the state had invested much funds in the programme.

He said the state had over 100km of coastal land, adding that it was committed to creating seawall, thereby protecting promenades, roads and houses in the area.

He urged the stakeholders to increase efforts for effective implementation of the programme.

"I will suggest that all the coastal states management should create a strong team to share their problems to make the implementation of the programme easier" he stated.

## IHRC partners FG, set to tackle 28m housing deficit in Nigeria

with a deficit of 28 million houses, Nigeria needs urgent measures to provide affordable housing for her teeming population of around 200 million people. With this in mind, the International Human Rights Commission (IHRC) has revealed that it is in partnership with the federal government to reduce the deficit.

The Director of the Africa Region Headquarters of the commission, Dr Tivlumun Ahure, made this known this month in Abuja during a news briefing at an event that featured the unveiling of the new director of the IHRC Pro-Poor Housing Programme, Dr Edward Olutoke.

The director disclosed that the aim of the project was to contribute to the efforts of the Nigerian government to achieve the affordable housing goal listed under the United Nations Sustainable Development Goals (SDGs) before 2030.

He explained that, for the country to achieve an increase and improved housing opportunities for low and medium income households, special needs populations, among others, concerted efforts at reducing it are required.

He stated that: "Indeed, Nigeria faces a severe housing deficit as estimated by the Federal Mortgage Bank indicating a deficit of at least 28 million housing units.

"While the deficit cannot be addressed within the lifetime of an administration, a concerted effort at reducing it is however clearly required.

"This will entail creating linkages between provision of land to property developers, increased availability of housing finance, reduction in property transaction costs and job creation across sectors ancillary to the provision of additional housing stock," he said.

He added that in January 2021, the Commission communicated with the federal government its intention to assist millions of people that live in slums and substandard houses to have adequate housing.

"The IHRC's proposed Pro-Poor housing scheme in Nigeria is, therefore, going to be on a joint venture basis with the government.

"It will be to us a dream come true to facilitate an increase in housing stock via Public Private Partnerships (PPP) as well as through housing finance reforms,".

While speaking after his unveiling, Dr Olutoke said that housing was key and important to every Nigerian as "it is fundamental to have a shelter over one's head.

"For me, this is an assignment which I am committed to achieving.

"Housing is key, shelter is too key and fundamental and these are the things we toil within our decision making process.

"For instance, if we move 5,000 families from Asokoro or within the city centre to a new land, the house rents will definitely reduce and so the issue of high house rents will be a thing of the past," he observed.

### Experts mull solutions to building collapse

There has been a big question about the engineering practices in the construction of buildings because of the increased rate of building collapses in the past few years. This is blotting on

the professional reputation and integrity of the engineering sector.

Recently experts drawn across different sessions of the building industry called for concerted efforts toward bringing an end to the menace

The experts spoke at the T.M Olatunji Distinguished Annual Lecture organised by the Nigerian Institution of Civil Engineers held in Lagos on Wednesday.

In his keynote address, a former President of the Nigerian Institute of Builders, Builder Kunle Awobodu, decried the alarming rate of building collapses in the state.

According to him, even as he was about to deliver his paper, a breaking but bad news of another building collapse had surfaced in the media.

Awobodu added that lack of capacity had long been identified as the clog in the wheel of appropriate building control.

He said, "The alarming rate at which the BCPG record of collapsed buildings in Nigeria is being reviewed makes me appreciate the herculean task facing the updating team of the organisation searching around for news of collapsed buildings. Owners of 2 collapsed buildings usually try to conceal the information in order to circumvent the confiscation of their land by the government. For this reason, the BCPG records of

collapsed buildings consist only of the 'exposed' or reported collapsed buildings.

"Experience has taught us that each time a building collapses in Nigeria, built environment professionals in other parts of the world tend to doubt the competence of professionals in the Nigerian Building Industry. Building collapse is a global phenomenon, but the frequency at which buildings collapse in Nigeria has attracted a worldwide concern on the need to assist this country to improve on its safety performance."

An engineer and the Special Adviser for Works and Infrastructure to Lagos State Governor, Babajide SanwoOlu, Mrs Aramide Adeyoye, said it was instructive that infrastructure must be sustained if it was to benefit coming generations and its provision must be seen as an investment that would pay off many times over in the future.

She added that the prevention of infrastructure collapse as prevalent in Nigeria and other developing nations was a matter to be looked at critically.

She said, "The construction industry responsible for these infrastructures also accounts for

a major proportion of the GDP of Nigeria. Therefore, seeking to improve the efficiency of the industry is very essential in promoting the growth of the Nigerian economy.

"It is important for professionalism to be exhibited in all stages of the infrastructure project cycle right from concept to planning to design to construction and maintenance stages. Professionalism is key to ensuring the sustainability of infrastructure and professionals are therefore expected to exhibit a high level of professionalism by adhering to their professional ethics when discharging their duties."

She further stated that the public had seen the collapse of new and existing infrastructure across the country because of poor design and periodic assessment/maintenance.

She added, "To curb incessant infrastructure collapse using road infrastructure as a reference, we in Lagos State Government from the planning stage of our road projects have adopted measures to curb their early deterioration. Such measures include giving quality control and quality assurance high priority in our execution of road projects."

### Alleged N109bn Fraud: Court remands ex-Accountant General in Kuje prison

• As EFCC says ex-AGF got N15bn bribe to fast-track 13% Oil derivation payment

ustice Adeyemi Ajayi of the Federal Capital Territory High Court, Abuja, on Friday remanded embattled former Accountant General of the Federation, Ahmed Idris and two others in the Kuje Medium Correctional Centre.

The Economic and Financial Crimes Commission (EFCC) arraigned Idris and his co-defendants including Gezawa Commodity Market and Exchange Limited on a 14-count charge bordering on stealing and criminal breach of trust to the tune of N109.4 billion.

In an earlier statement announcing the scheduled arraignment, EFCC spokesman, Wilson Uwujaren disclosed two counts (one and eight) of the 14 counts the defendants will face while accusing Idris that he received a total of N15 billion bribe to fast-track 13% derivation funds to oil-producing states of the Niger Delta region.

The 13% derivation fund is a benefit-sharing system that helps crude oil producing communities get funds meant for development.

The fund comes from the federation revenue through the state governments as enshrined in section 162, sub-section 2 of the Nigerian

In 2021, the nine oil-producing states of Delta, Akwa Ibom, Bayelsa, Rivers, Edo, Ondo, Imo, Lagos, and Abia shared N450.60 billion from the federation account through the 13 percent derivation formula.

The EFCC claimed that the suspended AGF accepted the sum of N15,136,221,921.46 from

Olusegun Akindele, his Technical Assistant for accelerating the payment of 13% derivation to the states.

According to the anti-graft agency, count one of the charges reads, "That you, Ahmed Idris between February and December 2021 at Abuja in the Abuja Judicial Division of the High Court of the Federal Capital Territory, being a public servant by virtue of your position as the Accountant General of the Federation accepted from Olusegun Akindele, a gratification in the aggregate sum of N15,136,221,921.46 which sum was converted to the United States Dollars by the said Olusegun Akindele and which sum did not form part of your lawful remuneration but as a motive for accelerating the payment of 13% derivation to the nine (9) oil producing States in the Federation, through the office of the Accountant General of the Federation, and you thereby committed an offence contrary to Section 155 of the Penal Code Act Cap 532 Laws of the Federation of Nigeria 1990 and punishable under the same section."

Count eight reads, "That you, Ahmed Idris while being the Accountant General of the Federation and Godfrey Olusegun Akindele while being the Technical Assistant to the Accountant General of the Federation between February and November 2021, at Abuja in the Abuja Judicial Division of the High Court of the Federal Capital Territory, in such capacity, entrusted with a certain property, to wit: N84,390,000,000 committed criminal breach of trust in respect of the said property when you dishonestly received the said sum from the Federal Government of Nigeria through Godfrey Olusegun Akindele trading under the name and style of Olusegun Akindele & Co., and you thereby committed an offence punishable under Section 315 of the Penal Code Act Cap 532 Laws of the Federation of Nigeria 1990."

Recall that the EFCC on May 16 announced the arrest of Idris who was the Accountant General of the federation at the time, a move that sent shockwaves across the nation in the current administration's efforts in fighting corruption.

In a statement, the anti-graft agency had explained that Idris was arrested for an alleged diversion and laundering of N80 billion.

The development forced the Minister of Finance, Ahmed Zainab, to suspend him pending the conclusion of the corruption investigations.

About two weeks later, the EFCC uncovered another N90 billion alleged fraud involving the suspended Accountant-General.

When arraigned on Friday, all the defendants pleaded not guilty. Idris and other defendants. Therefore, asked the court for bail pending trial.

Counsel to Idris, Chris Uche, SAN, in his submissions, assured the court that his client would be available to face the charge against him.

Uche specifically noted that the EFCC had earlier granted administrative bail to the Defendant who he said flew into Abuja from Kano state immediately after he was notified about the arraignment.

"In a matter of this nature that the Defendants have been on bail, and since there is no complaint that they violated the administrative bail conditions, I pray that they be allowed to continue to enjoy the same," Uche submitted.

However, the court ordered that Idris and other defendants should remain in the custody of the Nigerian Correctional Service till Wednesday when their bail applications will be heard.

#### EFCC arrests ex-convict, 32 others for cybercrime

An ex-convict, Okhiria Alex Chibueze, has again been arrested alongside 32 others by the Economic and Financial Crimes Commission (EFCC) for alleged cybercrime.

Chibueze and others were arrested Thursday by operatives of the Ibadan Zonal Command of the Commission.

gathered that the suspects nabbed at the Soka axis of Ibadan, Oyo State, in a sting operation by the EFCC following a credible intelligence report on their alleged cyber-crime activities.

It will be recalled that Chibueze was arrested by the operatives of the Ibadan Zonal Command of the EFCC sometime in 2021 for fraudulently obtaining \$3,800 USD (Three Thousand, Eight Hundred United States Dollars) through a fake lottery scheme.

He was successfully prosecuted and sentenced to six months of community service by the Court on June 16, 2022. However, barely a month after his conviction, Chibueze has again landed in the net of the anti-graft commission. Spokesperson for the EFCC, Wilson Uwujaren, confirmed the arrest on Friday in a statement.

Uwujaren gave the names of all the suspects as "Okhiria Alex Chibueze, Olootu Damilola Ayomikun, Akiwale Isreal Bunmi, Oladele Olatunde Oladimeji, Okeniyi Samuel Akinnivi, Sanya Oyekole Olakunle, Okon Gideon Henry, Stephen Samuel Shekwuduza, Adeshina Opeyemi Akanni, Hezekiah Ajadi Oluwatobi, Omoke Ogbonnaya Okike, Alex Samuel Aiku, Micheal Olakunle Oyinwola, Salami Oluwafemi Salami, Udeh Moses Emeka and Monday Samuel Nnaemeka.'

#### Court declares employment termination of 19 persons' wrongful, awards N11.4m against firm

Justice Faustina Kola-Olalere, pressing judge of the Portharcourt Judicial Division of the National Industrial Court, has declared the employment termination of Emmanuel Ogbonnia and 18 others by Baker Hughes Company via redundancy as wrongful.

The Court, which held that the termination was done in violation of the Labour Act and the International Labour Organization Convention Protocols, awarded the sum of N7.6m (Seven Million, Six Hundred Thousand Naira) only as compensation for the wrongful employment termination and N3.8m (Three Million, Eight Hundred Thousand Naira) costs of action against the firm.


The Court, however, held that Emmanuel Ogbonnia and 18 others are not entitled to the sum of N144m redundancy benefits, USD49,400.00 one-year medical contribution as End of Service Benefits under the Voluntary Release Program (VRP) and was dismissed accordingly.

Facts by the claimants - Emmanuel Ogbonnia, and 18 others - had stated that by policies of the defendants including the Voluntary Release Program (VRP), which did not at any time provided for redundancy, the defendants embarked on redundancy exercise without following the procedure provided for in the Labour Act as well as failed, refused and/ neglected to pay their redundancy package.

In a further submission, the claimants posited that Martin Craighead and Baker Hughes Incorporated were co-employers with the Baker Hughes Company because the firm acted on their behalf.

In defence, the defendants averred that Martin Craighead and Baker Hughes Incorporated are not in any way responsible for the act of Baker Hughes Company and that the so-called Voluntary Release Programme (VRP) heavily relied upon by Amadi, was never introduced, developed, or applied in Nigeria, neither was it provided for in the Claimants' Contract of Employment nor incorporated by reference into the said Contract of Employment.

If you have a brand, it's high time you stop doing jobs that pay peanuts and start doing what will make you the next sponsor of Nigerian Idol or big brother.

*Q: Does that mean music is not profitable?* A: I'm not saying that, I'm just saying it goes beyond music to be able to live that luxury lifestyle.

Q: As a businessman with so much merchandise, how profitable are all these businesses?

A: I can confidently say all businesses that I have ventured into are profitable because if you go to popular malls and stores; you will find my Koko Garri there. The most important is that we need more management in our industry because everyone that comes into the industry now just wants to be popular overnight It is important to have people in the back who will say ok, you have a song that is trending but you can also have merchandise.

Q: How affordable is your DB perfume?
A: The perfume is selling for a token of 250 dollars. It's global now; very soon it will be everywhere in Nigeria but at the moment you can get it online. My partners are from

the UAE and I will also be partnering with Dubai tourism to be able to take people to go and see the factory and try the other scents that we have, just to have that impact.

Q: Don't you think 200 dollars is on the high side?

A: I know you think that 250 dollars is high but we pay more for those foreign brands. The earlier we encourage our people to start investing, the better; from food to clothes, hair and even cars. Even drinks, I'm looking forward to a time when I will have an endorsement with an alcoholic drink that is Nigerian.

Q: Six years of marriage, don't you miss those old days when you could gallivant around?

A: Sure I do miss those days but for how long will you do that; I am happy I took the best decision to not just get married but stay married. I am also glad that there is a huge difference between Daniel Dapo Oyebanjo and Dbanj the koko master. I get on stage anywhere, and it's still the koko master. The amount of kokolet that flows on the stage has not been reduced. You know that you still have it but now you are committed to someone. When you've done it too much, you get tired.

Q: What has sustained your marriage because a lot of people don't believe you could still be married till now?

A: It is very important for me when I say that I'm happy that I got married when I got married and for the reason, I got married. I thought I had reached the best part of my life and I wanted to start building an empire for me to do this, I have to be stable, have a best friend as a partner and then you have to be true to yourself. I pray to God a lot and the Bible says He who finds a wife, finds a good thing, so I got myself a best friend, my best partner who understands me and knows everything about me and because of that, we can grow together. In May, the 'Ukwu' crooner had called on men to be financially buoyant before embracing polygamy.


"If you want to be a polygamist, do it like Ned Okonkwo. You can't be managing and have two wives," he had said.

## Oshoala wins historic fifth CAF player of the year

Barcelona Femini forward Asisat Oshoala has won the 2022 CAF Women Player of the Year award for the fifth time surpassing her fellow compatriot, Perpetua Nkwocha's record, to become the all-time highest record holder in the continent in both male and female categories.

The CAF award ceremony held in Mohamed VI Technical Centre in Sale, Rabat, saw Bayern Munich's new signing and Senegalese forward, Sadio Mane scooping home the CAF Men's Player of the Year award.

Oshoala, who recently returned to Barcelona after sustaining an injury in the Women's Africa Cup of Nations (WAFCON) in Morocco, won the Pichichi award in Spain last season to become the first African and the second Barcelona Femini player to win the award.

The 27-year-old Super Falcon has been fantastic in her footballing career prior to her fifth CAF accolade having

played in top English clubs, Liverpool and Arsenal where she won the Women's FA Cup with the latter in the 2015-2016

She was instrumental to her club's success last season with a record of 20 league goals despite being ruled out by injury for a couple of months from action.

While in the men's regard, Sadio Mane guided his country to win their first African Cup Nations (AFCON) title by slotting in the decisive penalty kick against Egypt in Cameroon's final.

Mane made his debut for the Senegalese national team in 2012 and has established himself as a rallying point where he has been capped 91 times to finish off 33 chances advantageously.

The former Liverpool player recently joined Bayern Munich this summer after winning the Carabao Cup and Fa Cup last season for Liverpool and featured in the UEFA Champions League final in Stade de France against Real Madrid.

Remarkably, the 30-yearold Teranga Lions' captain who won the 2019 CAF Men's Player of the Year award is



the only Senegalese player that has won the diadem two

Other recipients of CAF awards are Ghana's Evelyn Badu, who won both the Interclub Player of the Year (Women) and Young Player of the Year (Women) awards, Egypt's Mohamed El Shenawy for Interclub Player of the Year (Men), Senegal's Pape Matar Sarr for Young Player of the Year (Men).

More so, Banyana Banyana coach, Desiree Ellis and Teranga Lions coach, Aliou Cisse, scooped home the CAF Coach of the Year awards for women and men respectively while the Club of the Year award (Women) went to Mamelodi Sundowns of South Africa and that for the men was given to Wydad Athletic Club of Morocco.

CAF concluded the event with the Teranga Lions of Senegal winning the CAF National Team of the Year award while that of the women, will be awarded at the close of the WAFCON tournament in Morocco.

#### Pinnick flew private jet amid Falcons' unpaid bonuses

The Super Falcons camp at the Women's Africa Cup of Nations in Morocco, is allegedly a bit unsettled following the inability of the Nigeria Football Federation (NFF) to upset the bonuses of the players The Trumpet gathered.

According to a British Broadcasting Corporation (BBC) reporter, Osasu Obayiuwana, the bonuses owed the Falcons is a minimum of \$10,000 with the NFF only paying \$1000.

Obayiuwana, who was a member of the NFF Reform Committee and former Anti Racism Taskforce of the International Association Football Federation (FIFA), stated that Nigeria's senior women's football team boycotted a training session following the NFF's inability to upset their bonuses.

"The Super Falcons boycotted training this morning, ahead of their WAFCON2022 third-place match against Zambia," the BBC correspondent tweeted on Wednesday.

"The Super Falcons" players have reportedly received \$1k of the minimum \$10k they're entitled to. Coach Randy Waldrum got \$2k and assistant coaches \$1.5k. Backroom staff got \$1k each. When will they be paid the remaining cash?," Obaviuwana asked?

Obayiuwana in his vituperation against the Federal Ministry of Youth and Sports Development Nigeria Football Federation, under the stead of Hon Sunday Dare and Amaju Melvin Pinnick respectively, lampooned both institutions that towing a path

degrades the country's reputation.

He said, "How come that nearly 25 years after, Super Falcons are going through the same indignities? The same humiliations? How insensate and wicked can NFF and the Federal Ministry of Youth and Sports be doing this for a quarter of a century, to these patriotic, gallant women?"

"Do people in Nigeria realise that the failure to pay Super Falcons' allowances & bonuses started right from 1998, when they won their first WAFCON? Marvellous Mercy Florence Omagbemi tell you their tales of woe, from that time. You will weep, the former NFF committee member added.

Super The Falcons against Morocco, lost 5-4 on penalties at the Prince Moulay Abdellah Stadium Monday having valiantly tamed the attack of the host team despite conceding two secondhalf red cards.

However, Obayiuwana in a recent update, added that the Falcons have been paid \$2800 per player and expect all the accrued allowances cleared, adding that South Africa pay Banyana Banyana at due time.

# Britain's Jake Wightman emerges 1500m world champion in Oregon

ritain's Jake Wightman has emerged as the new world champion of 1500m race after he edged Olympic champion and Norwegian Jakob Ingebrigtsen to clinch the gold medal.

Wightman in 2018, won the Commonwealth and European bronze and broke the 'Scottish record at a Diamond League meet' in 2020.

The 28-year-old in a record of 3:29.23, ran past Ingebrigtsen who got 3:29.47 to beat the 2020 Tokyo Olympics champion while Mohamed Katir from Spain came third.

Unbelievable, the astonished British runner after he made history to defeat stronger contenders that included defending champion Timothy Cheruiyot and Abel Kipsang of Kenya, said he had to shrug off the disappointing result in Tokyo last year before he ran the world record.

"It probably won't [sink in] until I've retired. It's mad," Wightman said after winning gold in the 1500m in Eugene.

"I had such a disappointing year in Tokyo last year. I don't think people realise how crushing it was to go in with such high expectations and come away hoping for a medal but ending up with tenth.

"I just knew, here, take the pressure off, the only thing that can happen is that it is a better run than last year," he admitted.

From the start of the race, Ingebrigtsen took the race and led the frontline with the tactical Wightman saving his best charge for the last lap.

Firm to his tactics, after realising that the race was left with about 200m to decide on the winner, Wightman surged forward and overtook the Olympic champion to lead a new 3:29.23 record time.

He said, "I just got a whiff of it on the last lap - I knew if I was there with 200 [metres] to go, I was going to do everything



I could to put myself in a position to win it. I was just running for my life down the home straight."

Geoff Wightman, the father of the world champion who was also a runner and an announcer in the stadium at Eugene, applauded his son's feat echoing that it is the world champion.

"Running is coming home.

Wow. That is my son and he is the world champion," the world champion's father said in Hayward Field.

The Trumpets reports that this feat achieved by Wightman is the first of Britain's gold medals in the men's 1500m race since Steve Cram ran 3 minutes 30 seconds at the 1983 World Championships at the Olympic Stadium in Helsinki.

## Joel Obi joins Reggina on two-year deal

Nigeria midfielder Joel Obi has signed for Serie B club Reggina on a free transfer after his contract with Salernitana ended last season.

Obi, who has plied his career in Italy, with Castello Calcio as his foundation, joined Salernitana from Chievo Verona and helped coach Fabrizio Castori's campaign to retain the Garnets Italy's topflight division status.

The former Inter Milan midfielder made his debut for the Super Eagles in 2011 during an international friendly match against Sierra Leone that Nigeria won 2-1.

won 2-1.
The 31-year-old, who earned his debut under coach Samson Siasia, a former Super Eagles coach, went on to feature in 11 friendly matches and 5 times in the Africa Cup of Nations (AFCON) for the national side.

Last season, Obi featured 23 times for Filippo Inzaghi's side in all season and provided the assist for Simy's opener against Spezia in a Serie A clash at Alberto Picco stadium.

According to Reggina, the midfielder who has played 295 matches in his club career, netting 23 times, brings a wealth of Serie A experience to the Italian second-tier division club.

Reportedly, Obi signed a two-year contract with the Amaranth that will keep him at Stadio Oreste Granillo until 2024.



# 'Kano Pillars seek backdoor return to NPFL'

#### We'll play in elite league - Doma United

Relegated Nigeria Professional Football League club, Kano Pillars, are allegedly on the verge to bypass the Nigeria National League (NNL) campaign through Doma United to return to the Nigeria topflight division.

The Kano State-based club before the matchday 38 fixture against Shooting Stars FC of Ibadan, were sanctioned for breaching the League Management Company (LMC) rules against Dakkada FC and Katsina FC which resulted in the Disciplinary Committee of the Nigeria Football Federation (NFF) ratifying the deduction of league points from their accrued points.

Consequent to the actions of the NFF, Kano Pillars who were contending with other clubs like Shooting Stars of Ibadan, Lobi Stars, Dakkada FC, Abia Warriors, Niger Tornadoes, Katsina United and Heartland of Owerri for NPFL survival, irredeemably wallowed in the red zone notwithstanding the 2-1 win against Shooting Stars in Sani Abacha Stadium on Sunday, July 17, 2022.

Sai Masu Gida having been relegated will have to begin their 2022-23 campaign in Nigeria's second-tier division but an unconfirmed report reveals that they are on the move to return to the top tier by leveraging on Doma United NPFL qualification ticket.

According to the report, Kano Pillars are planning to buy the qualification spot of the Gombe Statebased club for N40,000,000 to quickly return to the NPFL which Doma United have refuted by reaffirming their commitment to kickstarting their campaign in the NPFL next season.

In a statement by Doma United CEO, Alhaji Suleiman Umar, he

stated that contrary to reports making the rounds on various media outlets, the club is ready to play in the NPFL, reiterating that they worked assiduously to get to where they are presently.

"Let me clear the thought about this and assure the good supporters of Doma United Football Club that Doma United is not going to sell its NPFL ticket and we're ready to play in the elite league," he assured.

"We didn't come this far to stop, we will play in the elite league. People should debunk any other report that is saying a different thing because we don't know where they're emanating from

"We're a professional club and I believe in my players' performance so we'll play in the league," Umar reiterated.

The Doma United stand regarding the melee which was reported by the club's media officer, Abubakar Saleh, further reaffirmed the NPFL newbie's position not to concede their NPFL spot to anyone at any price.
