



Questions raised after scanning through documents submitted to INEC by Atiku. He submitted Secondary School Certificate Examination (SSCE) result with name Sodique Abubakar. Space meant for the primary school he attended was left unfilled as well.

He, in an attached sworn affidavit, declared to be addressed as Atiku Abubakar in his position as Deputy Preventive Superintendent attached to Customs Preventive Station, Apapa Wharf, Lagos.

The PDP presidential candidate, who was resident at No 3, Ayanboye Street, Anthony Estate, Ikorodu, declared in the sworn affidavit: "That I was known, addressed and called Atiku Abubakar. That in the year 1965, I changed my name to Siddiq Abubakar."

Also of concern Atiku's certificate is that he claimed to have a Master's degree mentioning without University from where he had his first degree or its equivalent. mentioned just Diploma certificate



Ahmadu Bello University (ABU), Zaria.

Dr. Okowa, the Vice Presidential candidate of PDP, also claimed that he lost his educational certificates. He attached affidavit of loss of original certificate.

The affidavit obtained from the High Court of Justice, Delta State, in the Asaba Judicial Division on October 3, 2006 reads in part: "I, Ifeanyichukwu Arthur Okowa, adult, male, Christian, medical doctor and Nigerian citizen of House No. Commissioners' Quarters, Asaba, Delta State, do hereby make oath and state as follows:

"That I personally enrolled and sat for West African Examinations Council (WAEC) West African School Certificate (WASC) examinations in the year 1974 at Edo College, Benin City, in now Edo State.

"That I passed the said examinations and was subsequently issued the said certificate therefore. "That the original of the said certificate issued to me is now missing, lost and cannot be found."

The presidential candidate of the Young People's Party (YPP), Prince Abdul Malik Ado Ibrahim also claimed to have lost all his

Cited documents he submitted to INEC was an affidavit sworn to at the Federal High Court of Justice, Maitama, Abuja, on June 3, 2022, in which he disclosed that on July 17, 2021, while in transit from Kaduna to Abuja, he lost certain documents which included "original BSc certificate issued by American College of Los Angeles, dated 1988; High Šchool Diploma issued to me by Langley High, Norwich, UK Norwich, dated 1979 and official degree transcript.

"Also lost was expired international passport issued by Nigeria Immigration Service. 'That all efforts made to trace the said documents have proved abortive."

Ado Ibrahim also attached a Police Entry signed by Assistant Superintendent Moĥammed Protection Unit, FCT, High Court, Maitama, Abuja, on the lost documents dated June 6, 2022.

aforementioned, As the certificate issue started with Chief Tinubu who left blank columns meant for his primary and secondary schools education.

to have bagged a degree from Chicago State University. This raised eyebrows as to how someone can have university learning without preliminary primary and secondary school formal education.

The issue complicated references were made to INEC which forms he filled pre-1999 election when contesting Lagos State governorship poll in which he claimed to have attended a primary school in Arolaya area of Lagos and Government College, Ibadan for his secondary education.

Tinubu. in recent forms however submitted an affidavit in which he claimed that he lost all his certificates to an invasion on his Lagos residence while away on exile during the Abacha military era.

Likewise, his 'holding' running mate, Kabir Masari declared to have lost his certificates.

Masari in a sworn affidavit for the loss some original documents submitted to INEC claimed to have misplaced vital including documents C of O of one plot KT 17522 in Katsina state, his Grade II certificate from Katsina Teachers College and his primary school certificate.

"That sometimes in January 2021, while on transit within Wuse Area, FCT-Abuja, discovered that my original Certificate of Occupancy (C of O) of Plot, No KT 17522, GRA Katsina, Katsina State; Certificate of Kaduna Development Centre from 1994 - 1995; Grade II Certificate from Katsina Teachers' College (KTC) from 1978 1983 and First Leaving School Certificate issued by Masari Primary, Katsina State, from 1972 – 1978, got lost," partly stated the affidavit sworn by Mr Masari at the Supreme Court in July 2021 and submitted to INEC on June 17, "That all efforts made

pollution, emission of toxic, noxious gas, and hydrocarbon which is injurious to human health.

In statement, Goli reiterated the for Conoil to need responsibility and move in without further delay to stop the noxious gas which is life- threatening from spreading further.

The statement says: "Regrettably while the previous oil leak is yet to be cleaned properly, another incident has emitting occurred, volumes of noxious gas at the Adriatic 1 offshore oil rig, Otuo field, OML 59, operated by Conoil Nigeria Producing Ltd, in Akassa, Brass Local Government Area of Bayelsa State, leaving inhabitants of the impacted communities, as well as marine life in

grave danger.

"This is the second time we are witnessing ugly situation. particularly on this facility, operated by Conoil Producing Nigeria Ltd, as a similar noxious gas leak was experienced on it, some time ago in October, 2021, and nothing was done to mitigate the impact on the affected communities.

He noted that the impacted communities are Fishtown, Sangana, Okumbiri-Beleu, Opu-Okumbiri and Ogonibiri, while the leak has continued unabated with the spread going viral. Goli submitted that as debilitating life threatening the incidents pose to inhabitants of the communities, the management of Conoil has shown absolute

sanctity of human lives, as well as the impacted environment.

The federal lawmaker reasoned that with a clear knowledge of the danger associated with inhaling noxious gas and hydrocarbon, the management of Conoil would speedily evacuate all its staffers working on the Adriatic 1 offshore oil rig, while measures are never in place for the safety of children, the youths and aged persons residing in the impacted communities. Peeved by the double standard in dealing with their host communities, Goli reiterated: "leaving the inhabitants of the impacted communities to their fate, without any recourse to putting in place concrete measures to mitigate the impact of the gas leak on the environment and its inhabitants, or carry out

remediation work on the impacted environment,

the height corporate irresponsibility a corporate entity that should exhibit a good measure of rectitude."

Hon. Goli lamented the untold hardship that inhabitants of the affected communities whose natural occupation are farming, fishing, canoe carving woodwork, grappling are owing to the oil leaks have destroyed environment economic life. Accordingly, he stressed that the oil leak has polluted the source of water of the impacted communities, as well economic farmlands and aquatic life, as lifeless fishes are seen floating on the surface of the river.

He warned:

affected communities must not be left to wallow in pain bearing in mind that they feed from their God-given marine environment, nor the misery of losing their sources of economic sustenance.'

He warned that such corporate nonchalance and high-handedness, as being exhibited by Conoil to neglect the impacted communities is unacceptable, and cannot be tolerated.

Goli called on the National Oil Spill Detection and Response (NOSDRA), Nigerian Upstream Regulatory (NURC) Commission other relevant agencies of government urgently swing into action and ensure the that company responsible for environmental disaster is held to account.

INEC tasks journalists on factual reporting ahead of Osun governorship poll

head the July 16 governorship election scheduled to hold in Osun State, the Independent National Commission (INEC) has tasked iournalists to be factual in their reportage of activities of the body and indeed the process.

National Commissioner and Chairman of the Information and Voter Education Committee Festus Okoye Esq, made the call during Building Capacity Workshop for Journalists on new innovations in the conduct of elections, organised with support from the International Foundation for Electoral Systems (IFES), held in Osogbo, the Osun state capital at the weekend.

The IVEC Chairman who spoke on a wide range of issues including legal matters with regards to the new Electoral Act. innovative approaches in election management said; "We plead with the media to be factual, objective and professional in reporting the election".

added journalists covering the election must on no account interfere with the processes and procedures of voting or in any way distract Presiding Officers in the performance of their

"The media must on no account attempt to know or report on the way someone has voted. The secrecy of the ballot is at the heart of the democratic process. The media must also not make any declaration or return of any election as it is the exclusive preserve of the Commission", he

National Commissioner disclosed that as part of the Commissions efforts to ensure all loose ends were tied and Osun Governorship election is organised in a free, fair, credible and inclusive manner, the Chairman of the Commission and some National Commissioners will be in Osun state from Sunday for a readiness assessment visit, and will use the opportunity to stakeholders engage solicit their support.

He said; "the Chairman the Commission National Commissioners will be in Osun State from tomorrow on readiness assessment. The Chairman will observe accreditation processes. He will visit and interact with traditional

"He will hold top level meetings with traditional rulers. He will visit some of our Local Government Offices. He will hold meetings with Staff of the Commission and members of the National Union of Road Transport Workers".

In his welcome remarks, Resident Electoral (REC) Commissioner Osun state, Prof. Abdulganiy Raji, spoke on the preparedness of the Commission to conduct the election come July 16.

He said Voter Education and Sensitization through the Media, House House campaigns with the Support of the NYSC INEC Ambassadors, Jingles and social media enlightenments have been ongoing in the state.

The REC noted that the state had witnessed a surge in the interest to get registered and collect their Permanent Voter Cards (PVCs), a development which he attributed to massive enlightenment campaigns, especially in the Media.

He assured that the ongoing PVC distribution will continue until every registered citizen collects

his/her PVC before the election, and announced that the state will take delivery of additional 3.000 PVCs tomorrow.

The REC also disclosed that election will be held in all polling units in the state, as no polling unit had zero registered voters in the state. He said the expansion of voter access polling units earlier embarked on by the Commission has led to an increase from 3,010 to 3,763 in the state.

Prof. Raji, used the medium to appeal to the Media to give INEC consideration and fair hearing. He urged them to ignore faceless peddlers of fake news, and merchants of campaign of calumny, especially on social media, while urging them to explore the open door policy of the Commission verify information before feeding the public.

"Balanced news is what we want. don't destroy us while attempting to sell your medium", he urged.

his presentation on INEC Social Media the Platforms. Chief Press Secretary to the INEC Chairman, Rotimi Oyekanmi, explained that the Commission was



one of the most active on social media with huge followership.

He said there was a lot of information being churned out on the INEC social media every minute, and challenged participants to take advantage of the social media to enhance their work.

Mr. Oyekanmi noted that every serious organisation, and journalist must have social media presence at this age and time.

In his remarks, the Chief Technical Adviser (CTA) to the Hon. Chairman, Prof. Bolade Eyinla, called on all journalists to ensure they get accredited for the election. He warned that their Identity cards may not give them free access to

cover the elections.

The CTA also challenged the participants to create a profile on the INEC Result . Viewing Portal and follow the real time update of election results from the Polling Units.

He said "Make sure you keep your eyes on our processes and procedures. Ensure you create a profile on our result viewing portal as results from all 3,763 polling units in Osun will be uploaded in real time. You can even know the outcome of the election before it is officially announced".

In his good will remark, the Deputy Country Director for IFES, Mr. Obaje Ukeh, observed that the way journalists do their job

He said the workshop was important and a bridge builder between the Commission and the Media, as it provided an avenue for journalists to ask questions about the electoral process and

He expressed optimism that the Osun election will be better than the Ekiti, which according to him has been rated as one of the best elections conducted in recent times, and stressed that it can only be possible with the contribution and support of members of the 4th estate of the realm.

The Chairman Nigeria Union of Journalists (NUJ) Osun state, Ajadosu Wasiu, appreciated Commission putting together such a commendable workshop.

He said it is the Union's belief that its members will be better equipped and the knowledge acquired from the workshop will go a long way in enhancing their capacities in reporting the electoral process.

Mr. Wasiu assured that whatever they learn from the engagement will be put to practice in the interest of the state and the country.

USA Senate members decry churches' destruction, killing of Christians in Nigeria

Some members United States Senate have condemned continuous violence and killings at Christians targeted and churches in Nigeria. Their outcry came as a result of terror attack on St. Francis Catholic Church, Owa-luwa in Owo Local Government Area of Ondo State. They faulted the removal of Nigeria's designation as a Country of Particular Concern (CPC) as well as demanded its immediate re-designation by USA.

They, in a letter addressed to the USA's Secretary of State. Honorable Antony Secretary, Blinken stated that the Nigerian government has failed to protect the religious freedom and basic safety of its Christian citizens. The letter was signed by Senators Josh Hawley; Braun; Mike Tom Rubio Cotton; Marco and James M. Inhofe. They particularly listed the June 5th Owo terror attack and the killing Deborah Emmanuel Yakubu as evidences of persecution of Christians in Nigeria.

The letter reads: "As ou are well horrific acts of deadly violence have been committed against Nigerian Christians in recent weeks, including massacre churchgoers on Pentecost Sunday and the stoning of a Christian college student.

"Sadly, such violence has become all too familiar for Christians in Africa's most populous country. Last year, however, you inexplicably removed Nigeria's designation as a Country of Particular Concern (CPC) despite demonstrable improvement in religious country's conditions. freedom On the contrary, the Ňigeria situation in has grown worse. We previously urged you to immediately reverse vour misguided decision, and we write today to renew our call. Recent highprofile acts of violence underscore the intense religious persecution that is regularly experienced by Nigerian Christians.

"On Pentecost Sunday, gunmen attacked St. Francis Catholic Church in Nigeria's Ondo State, reportedly killing at least churchgoers. Last month, a violent mob brutally stoned to death Deborah Emmanuel Yakubu, a student at Shehu Shagari College of Education in northwest Nigeria. According to reports, Islamist some students were enraged 'blasphemous' a message Deborah posted in a WhatsApp in which she group, said that 'Jesus Christ is the greatest. He helped pass my exams.' expressing Merely one's Christian faith has apparently become tantamount to a death sentence in many parts of Nigeria.

Religious and intolerance directed toward Nigerian Christians has worsened in recent years. One report documented more than 4,650 cases of Nigerian who Christians were killed for their faith in 2021. Accordingly, Nigeria earns the dubious honor for the second consecutive being deadliest country on earth for Christians. We wrote last year that not only has the government of Nigeria failed to take meaningful steps to mitigate such violence, but Nigerian authorities restrict and

crack down on religious

minorities and individuals indefinitely blasphemy-related

charges.
"We remain concerned that the Nigerian government is failing to protect the religious freedom and basic safety of its Christian citizens. Furthermore, as annual reports vear's bipartisan Commission International Religious Freedom (USCIRF) and from vour own Department make clear, Nigerian government authorities directly participate in the persecution of Christians, Muslims, and even nontheists, most notoriously through arrests under convictions blasphemy laws.

"Make no mistake: continued enforcement state-sanctioned blasphemy laws enables the type of deadly violence killed Deborah Emmanuel Yakubu and so many others. When previously wrote to you, we were met with a response which failed to answer our questions about why the State Department views Nigeria as not having engaged in or tolerated 'systematic, ongoing,

and egregious violations of religious freedom' or even 'severe violations of religious freedom.' This is unacceptable, especially because you are required by federal law to consider the recommendation of USCIRF—which, 2009, has been to designate Nigeria as a CPC. In fact, USCIRF reiterated in its 2022 Annual Report that it was 'appalled' at the removal of Nigeria's CPC designation.

"Despite statements from you and other State Department condemning officials the recent bloodshed in Nigeria, the fact remains that the Department still does not officially regard Nigeria as a violator religious freedom. The Department released Report on 2021 International Religious Freedom on June 2, which starts the 90-day timeline Department make its religious freedom designations.

"Given the abysmal state of religious freedom in Nigeria, it is incumbent upon you to reverse last year's decision and redesignate the country as a CPC. The moment demands that you do so without delay.

Police rescue 77 church members, arrest pastors in Ondo

ndo State Police Command has rescued 77 persons who were found locked in the cell of 'Whole Bible Deliverance Church' in Ondo Town. The police disclosed that the victims were twenty six children, eight teenagers and forty three adult members who were deceived by the Assistant Pastor of the church, Pastor Josiah Peter, that Jesus will come in September, this year.

The Trumpet gathered that the pastors of the church popularly known as 'Ondo Church' told the worshippers to devote themselves, vacating whatever they were executing and camp in the church for a seven-day programme ahead of the coming of Jesus Christ. Report had it that pupils, workers and their spouses left school and their respective offices to devote themselves for the coming of Jesus Christ. for the coming of Jesus Christ. Furthermore, it was reported that some members of the church who did not believe the prophecy and got annoyed reported the development to the state police

The police operatives invaded the church and rescued the worshippers kept in an underground apartment of the church. While parading the victims and the pastors at the command's headquarters in Akure, the state capital, the Police image maker, DSP Funmilayo Odunlami, said the two pastors are in Police custody and preliminary investigation had commenced into the matter.

"Preliminary investigation is ongoing and further information will be communicated to the public. We urge the good people of Ondo State to be calm as the State Criminal Investigation and Intelligence Department have taken over the case."

She further added that the suspects would be charged to court after the completion of the investigation. Meanwhile, the family of the victims who were at the scene when the police operatives arrived said their children and husbands abandoned work and schools because the pastors hypnotized them.

They said the pastor told the congregation that Jesus Christ was coming in September and that members should stay in church, abandon sinful life by staying in God's presence. They said the pastors instructed students to quit schooling, workers should halt working, wives and husbands to leave themselves and come to meet their Lord. They disclosed that their daughter had left home since January 2022 and had been living in the Church.

Another family who was also around during the rescue said their daughter, a Part 3 student, dropped out of school due to the strange teachings of the Pastor and left home in January 2022 to start living in the Church. However, some of the victims who spoke with our correspondent debunked being kidnapped by anybody, saying it was their faith to be a member and attendees of the church without their parent's BernsandtOdoh

The Pastor in charge of the church, Peter Josiah, said he only taught them what the Bible says about the second coming of Jesus Christ.

"The prophecy that is being fulfilled this time is showing that the rapture is close. I never even mentioned years to the church. I never taught them to run away from their parents. I only taught them the gospel. I told them to obey their parents in the Lord."

Another pastor in the church, Pastor David Anifowose, denied the allegation of hypnotising or abducting the victims, saying they only preached undiluted words of God to the members, adding that they didn't teach them to

disobey or abandon their parents.

Public Relations Officer of the State Command, SP Funmilayo Odunlami, told newsmen on Saturday evening that a parent of one of the victims reported at a local police station in Ondo town that her children had left home for days.

Her complaint was said to have prompted the police to accompany her to where she thought the

children were hiding.

"The police followed her to check. When they tried to talk to the pastor, the church members became violent and attacked the police officers. However, people around there assisted the police and police called in

for reinforcement.

"At the end of the day, 77 members were rescued. They were there in the church.

"According to what we heard from some of the parents of those rescued, the assistant pastor was the one piloting the affairs of the

"He claimed rapture was going to take place in April. But he later changed his mind that it would take place in September,' Odunlami said.

According to her, the pastor ordered the victims to always obey whatever he told them.

She said that the pastor, who was not named, told the worshippers that education was not

necessary and that rapture would take place very soon.

police spokesperson The further disclosed that one of the members left home in January and abandoned her admission to a tertiary academic institution without informing her parents.

'Investigation is ongoing. The two pastors are in custody, and 77 members have been rescued," the spokesperson added.
A short video of the church that

went viral on social media showed a Bible kept on a table, flanked by bottles of exotic whiskeys, while some members spoke in hushed tones. Some parents were seen in the video famenting over the development.

A statement on Sunday by the Agency's Director of Media and Advocacy, Femi Babafemi, said the suspect, Muyiwa Babalola Bolujoko, was placed under excretion observation after body scan result confirmed drug ingestion.

Babafemi said the suspect later excreted the 90 pellets of cocaine

while in custody.

"NDLEA officers at the airport had on Monday 27th June arrested a former driver with a public transport company, BRT, Muyiwa Babalola Bolujoko for ingesting

90 pellets of cocaine.
"He was arrested at the screening point before boarding a Qatar Airways flight enroute Doha to Sharjah, with his trip expected to terminate in Dubai, UAE.

"The 39-year-old from Ijebu South LGA, Ogun State, was placed under excretion observation after body scan result confirmed drug ingestion. While in custody, the suspect excreted all the 90

pellets in four excretions.

"He claimed he left his N60,000 per month job as BRT driver in February and decided to work as drug courier to raise funds to buy a shuttle bus popularly called Korope in Lagos to continue his transport business."

Despite epileptic electricity supply, DisCos gross N2.4tr

lectricity Distribution Companies (DisCos) in the country have raked in N2.4 trillion as revenue between 2015 and 2020, the National Bureau of Statistics (NBS) has revealed.

According to the NBS electricity report for June 2022, revenue generated by the DisCos in 2015 stood at N278.89 billion and rose to N303.03 billion in 2016, representing a growth rate of 8.65 per cent.

Also in 2017, revenue generated by the DisCos increased by 22.25 per cent to N\$70.46 billion and further rose by 19.48 per cent in 2018 to N442.63 billion.

The revenues further increased by 9.03 per cent in 2019 to N442.63 billion, rose by 9.03 per cent in 2029 to N482.61

billion and sustained positive growth of 19.15 per cent by generating N526.15 billion in 2020.

The NBS electricity report, which presents statistics on electricity supply and payment from 2015 to 2020, focuses on customer base, metered customers, estimated billing customers and most importantly, electricity supply and revenue collected within the review period.

In the 2020 revenue receipts, the Ibadan Electricity Distribution Company (IEDC) collected the highest revenue at N102.10 billion, closely followed by the Eko Electricity Distribution Company (EKEDC) with N81.39 billion, while the least collection was recorded by the Yola Electricity Distribution Company (YEDC) with N10.64 billion.

Nonetheless, electricity supplied to customers during the

period under review showed an unstable trajectory, adding that in 2015, about 20337.40Gigawatt hours (GEh) were supplied across the country, but the figure fell by 6.36 per cent in 2016 as 19044 30GWh were supplied.

Also, it rose in 2017 by 2.04 per cent with 19,432139GWh and further rose in 2018 by 10.55 per cent, with 21,483.25GWh. Total electricity supplied in 2019 stood at 22.450.67GWh, but declined in 2020 by 1.82 per cent.

The NBS report also revealed that customer numbers in the period under review increased on a year-on-year basis with the highest numbers recorded in IBEDC.

Generally, customer base rose from 6.99 million in 2016 to 10.37 million in 2020, while the customer numbers were highest in IBEDC with 1,282,136 and lowest in EKEDC in 2020 with 269,027.

Commenting on the statistics, Statistician -General of the Federation, Adeyemi Adeniran, said: "With the overwhelming global demand for energy and the emphasis positioned by the Sustainable Development Goal 7 on access to energy for all places, the need for statistics on electricity as a form of energy is important.

"Thus, electricity statistics remain a very useful tool for socio-economic planning and development, particularly for a developing economy like Nigeria. These numbers will provide an insight and shape policy making on improving energy, especially electricity supply in Nigeria."

The report further stated that the trajectory of metered customers had shown yearly positive growth rates consecutively except in 2020, even as metered customers rose to 3.15 million in 2015 and rose slightly by 0.23 per cent in 2016. This increased in 2017 and 2018 with 3.57 million and 3.58 million customers respectively.

Metered customers in 2019 stood at 3.80 million showing a 5.96 per cent growth rate, but lower in 2020, as 3.51 million customers were metered.

Police present body of man, 70 in place of

30-yr-old allegedly tortured to death

The death in custody of 30-year-old Chinonso Omeh has continued to generate furore as family members have accused the Police of using their son for ritual purpose. The accusation is coming on the heels of the Police presenting the corpse of a 70-year-old man to the family in place of their son.

A family sources said Chinonso was arrested by the Anambra Police Special Tactical Squad and and allegedly tortured to death while in custody at the defunct notorious Awkuzu Special Anti-Robbery Squad (SARS) now renamed State CID Annex.

Addressing journalists in Onitsha, during the weekend elder brother of the victim, Onyebuchi Omeh said Chinonso, who had a car wash at Ogbunike former toll gate, was arrested on February 4, 2022, at the instance of one Austin Izunnwanne on trumped-up charges of threat to life.

Omeh said Chinonso was subsequently detained at Ogidi Police Station before his transfer to Awkuzu but there they were refused access to see him in the cell and even initially denied ever having him in their custody.

According to Omeh, after repeated attempts by himself and the family to see Chinonso at Awkuzu State CID Annex failed, they petitioned the AIG in charge of Zone 13, Ukpo, Anambra State through a lawyer and the Investigating Police Officer (IPO) at Ogidi was summoned. Upon interrogation, he gave a graphic account of how, when and to whom he handed Chinonso

over at Awkuzu.

He said when the team from Awkuzu was also summoned to Zone 13 Ukpo, they confessed that Chinonso was in their custody but had died having reportedly slumped in their cell and later pronounced dead by a medical doctor.

Omeh disclosed that when they requested to see his corpse, they were taken to a private mortuary and shown the corpse of a 70-year- old man in place of their brother, Chinonso. He alleged that the police at Awkuzu State CID Annex might have killed his brother and used him for ritual purposes since they cannot produce his body.

"The last time they (the family) had an appointment with the police team investigating the matter at Zone 13, Ukpo, they were totally surprised to hear that the two policemen from Awkuzu, the IPO, Michael Nelson and his team leader known as Big Sam who handled their brother's matter earlier detained over the case had been released and they are now walking freely," he said.

Calling for justice over the matter, the family insisted that the police should come clean and tell them what happened to their brother and show them the corpse if he is truly dead. The family called on human rights bodies to assist in ensuring that those involved in the heinous crime are brought to justice.

The zonal command spokesperson (Zone 13), Ukpo, Nkiruka Nwode, who spoke to journalists said she had not been briefed on the extent of investigation on the matter. She, however, promised to make enquiries and act accordingly.

Congestion looms as importers abandon vehicles at ports


In spite of review of the VIN Valuation policy, importers and freight agents are having tough times as they have been left with no choice than to abandon their vehicles at the port terminals with attendant accumulation of demurrage and other sundry charges

Speaking at a roundtable organised by the Maritime Journalists Association of Nigeria (MAJAN) in Lagos, a member of the Association of Professional Freight Forwarders and Logistics in Nigeria (APFFLON), Clinton Okoro, said the Nigeria Customs Service (NCS), should exercise patience in test-running the VIN Valuation policy and expressed concern that Customs officials seem to be implementing the policy in a hurry.

"Although the NCS gave a three-month window after the protests that greeted its introduction, but the way they made us believe it will work is not the way it is working. So, the policy is not okay with us, because it is causing a lot of delays, which come with congestion and accumulation of demurrage. Worse still, the officials don't explain the challenges to the terminal managers," Okoro lamented.

However, on what he thinks should be done, Okoro said two widows should be created in the VIN Valuation System to incorporate the manual and standard systems before gradual harmonisation of the entire system.

Also responding to the effects and workability of the VIN Valuation policy, another member of APFFLON, Iyke Umelo, said: "It is true that the Federal Ministry of Finance introduced the new system through the NCS to facilitate trade, but it is also true that we applauded the Customs when they introduced the policy because we were seeking a

way of harmonising clearance procedures to save time and eliminate bottlenecks.

"But we have found out that there are several contradictions in the new valuation system to the extent that some vehicles like Toyota Corolla and Mercedes Benz have not been imputed into the system."

He pointed out that the major problem was non-standard value, because of the delay and high duty on non-standard rated vehicles, which he said, was causing a lot of stress for car dealers, freight forwarders and importers.

"Furthermore, everyone is complaining about the high valuation, which is forcing people to abandon their vehicles at the ports. Terminal operators are not also having it easy with congestion in their terminals. Even the Customs officers are not left out of the lamentation, because there is a drop in revenue generation and meeting their target is becoming an Herculean task.

"People are also suspicious

that the Customs is systematically phasing out the importation of over-aged vehicles, which is why the difference between 2016 model of Toyota Corolla and that of 2013 is so wide," he said.

On his part, George Okafor of the National Association of Government Approved Freight Forwarders (NAGAFF), lamented that the high valuation of vehicles was due to the fact that the NCS was trying hard to meet the target given to it by the Federal Government, while also trying to plug the gap left by the 20 per cent drop in duty collection.

"The value of Mercedes and Toyota Corolla are so outrageous, if you are on 846, they use the new template of 2003 to 2013, which cost is about N2.8 million, as against between N390,000 and N400,000. This has made most owners to abandon their vehicles, although consultations and meetings are going on to find a solution to the anomaly," he said

Another stakeholder, Mrs. Jewel Igwe of NCMDLCA, said: "Non-standard value is the cause of the outrage, as there was no circular to that effect. What we had was 15 years, before they said they were going to work with 12 years, but they imputed nine years into the system."

She urged the authorities to adjust the duty and review the age limit of vehicles adding: "The letter of error in valuation is causing serious congestion in most terminals, but at Tin Can, the CAC Code will rescue the situation, because it has been routed to the Controller instead of the registry.

"The Customs has said there is no going back on the VIN Valuation policy and we agree with them, because of our experiences with the Ad-hoc Task Force, which usually extort us on the roads."

After school, you can come to us and there are lots of skill areas to focus on including programmes in Information Technology and other lucrative jobs as long as you put effort into what you do.

'Cybercrime comes with so many negatives on the individual including lack of integrity, untimely death, waste of resources, hardships among others in the society, as well as prosecution or even jail term," she added. The Director urged the

students not to give in to peer pressure to engage in cybercrime but rather engage in meaningful and legitimate means of livelihood.

Delta State Police Command has said about six suspected armed robbers have been killed by its

operatives after a gun duel.
According to a statement by the Police Public Relations Officer(PPRO), DSP Bright Edafe, operatives attached to 'B' Division Warri Surveillance Team while on Aberdeen Patrol along lower Erejuwa Street in Warri, received a distress call, that a suspected armed robbery gang were terrorizing Igbudu Market/Old Welfare.

He disclosed that the team, acting on this distress call moved to the scene, where the hoodlums, on sighting the police took to their heels. The team chased them to Old Welfare Road, where the hoodlums engaged them in a gun battle but were overpowered by the superior firepower of the police.

He explained that, during the gun duel, five of the hoodlums sustained serious gunshot injuries while, two locally made cut-tosize single barrel guns, three rounds of expended cartridges, three rounds of live cartridges and one dagger were recovered from them.

"The injured suspects gave up the ghost while they were being taken to the hospital. Investigation is ongoing," he

added.

Similarly, police personnel belonging to the Rapid Response Squad (RRS) attached to the State Command, Asaba, have also neutralized a gang of four robbers killing one of them in the process.

According to the force spokesperson, on 30/6/2022 at about 0230hrs, operatives of the Command Rapid Response Squad (RRS) while on visibility patrol along Ezenei Street, Asaba, sighted four suspicious looking young men in a parked mini bus without registration number.

He said, "When the team advanced towards them to find out their identity, they zoomed off towards Asaba-Benin Expressway. The operatives gave them a tireless chase till they got to Issele-Asagba in Aniocha South LGA. The team while trying to double cross the vehicle were faced with stiff resistance from the hoodlums, who crashed into the Police van, abandoned the vehicle and fled into adjoining bush while firing at the police-

"This confirmed the suspicion of the operatives, they followed them into the bush while exchanging gunshot. Consequently, one of the suspects sustained gunshot injury while others escaped with bullet wounds. One (1) cut-to-size english double barrel, one (1) locally made pistol, six (6) expended cartridges, two (2) live cartridges and a big iron cutter were re-covered. The injured suspect was taken to Agbor General Hospital, where he died while receiving treatment.

Imo abolishes payment of pensions to ex-govs, others

Imo State Government has abolished the payment of pensions and gratuities to all former governors, deputy governors and speakers of the House of Assembly, IMHA. This followed Governor Hope Uzodinma's assent to a bill passed into law by the state legislature repealing the law on payment of pensions, allowances and gratuities to former governors, deputy governors,

assembly speakers and deputy speakers.

Uzodinma while signing the bill into law at Government House, Owerri at the weekend, noted that the repealed law runs contrary to the 1999 Constitution of the Federal Republic, as amended, which stipulates that a pensioner must have worked for at least 10 years and must be up to 45 years of age.

The governor decried the practice whereby some of the beneficiaries of such payments also get huge amount of money as salaries and allowances in other positions they occupied such as serving as senators or members of the House of Representatives or ministers.

 $\bar{\mbox{He}}$ argued that apart from the inconsistency of such a law to the provisions of the grundnorm which is the nation's Constitution, it has set an unfortunate "precedence that does not encourage diligence and prudence in service delivery."

Uzodinma applauded the State House of Assembly for rising to the occasion and embracing totally the desire of government to strengthen the Internally Generated Revenue (IGR) base of the state by discouraging leakages and wastage of the meagre resources of the state.

Speaking on the occasion, Speaker of the Imo House of Assembly, Hon. Kennedy Ibeh, stated that the House of Assembly presented two bills for the governor's assent namely: the Bill on Imo State University of Agriculture and Environmental Sciences and Bill on the Repeal of Pensions and Gratuity.

Commending the governor for signing the bill into law, Ibeh stated that the bill on pensions and gratuity has long been repealed in many states of the federation when it was discovered to run contrary to the 1999 Constitution of the Federal Republic of Nigeria (as amended).

28-year-old Nigerian, James Junior Aliyu, has been arrested by officers **▲**of International Criminal Police Organization (INTERPOL) for allegedly defrauding dozens of United States citizens of money totaling \$12m.

Aliyu was arrested in Sandton, Johannesburg, South Africa on Wednesday in a 'takedown operation' carried out by INTERPOL with assistance from members of the South African Police Service (SAPS).

According to a statement issued by the South African police, Alivu is "believed to be part of a cybercrime ring involved in phishing, internet scams and money laundering.'

The South African police further stated that authorities in the US, where the investigation originated and where most of his alleged victims are based, have applied for the extradition of the suspect.

The police noted that the suspect was charged to court the day of his arrest, adding that the case would be heard on Tuesday, July 5, 2022.

The statement added, "Just after 10:00 on Wednesday, 29 June 2022, members from the Interpol National Crime Bureau (NCB) in Pretoria with the assistance from members of the SAPS Gauteng Highway Patrol Unit swooped in on the upmarket estate where they effected the arrest.

"His arrest follows a widespread investigation involving law enforcement authorities from South Africa (SA) and the United States of America (USA).

"The cybercrime suspect who has been conducting his criminal activities from South Africa is accused of swindling dozens of US citizens millions in USD through email and text messages."

ICPC, CCB team up against corrupt practices

Oyo State Office of the Independent Corrupt Practices and Other Related Offences Commission (ICPC) has offered to collaborate with the Code of Conduct Bureau (CCB) to confront graft by public officials.

A statement by the Commission at the weekend applauded the CCB on its initiative of sensitizing the public on the Bureau's guidelines on the fight against corruption.

Mr Oluwole David, an Assistant Commissioner, who represented the ICPC Oyo Resident Anti-Corruption Commissioner (RACC) at a sensitization session organized by the two agencies, assured the CCB of the Commission's readiness to collaborate in whatever capacity as the fight against corruption cannot be done in isolation by any anti-corruption agency.

Deputy Chief Superintendent of the Bureau, Mr Amao Bolaji, who delivered a lecture at the sensitisation programme, said that it became necessary to sensitise ICPC staff because most officers of MDAs only knew of the "Asset Declaration" among the 14 guidelines as enlisted in the Fifth schedule of the 1999 Constitution.

According to Bolaji, "there were 14 guidelines listed in the Fifth Schedule of the 1999 Constitution and the essence of these is to ensure a very high level of public morality."

He said it is imperative for ICPC operatives to know all the guidelines to ascertain whether public officers had complied fully with all the provisions.

Also speaking at the event, Superintendent Ologun Adebola, another officer of the Bureau, expounded on how to fill the Assets Declaration form accurately and correctly.

Given a closing remark, Mrs Faustina Adeoluwa of the Legal department of ICPC, acknowledged and praised the efforts of the CCB in taking out time to educate and enlighten ICPC officers in readiness for the fight against corrupt

ICPC restates commitment to corrupt-free healthcare system

Independent Corrupt Practices and Other Related Offences Commission (ICPC) has reiterated its readiness to continue supporting the activities of the Anti-Corruption and Transparency Unit (ACTU) of the Federal Ministry of Health. It is in a quest to promote a corruption-free ministry.

of transparency within the Ministry. Permanent Secretary of the Ministry, Alhaji Mahmuda Mamman, in his remark thanked the ICPC for its support in addressing the issue of corruption in

the administrative procedures, especially

at this time where the use of ethics is abused by public officials.

Also speaking, the Executive Secretary of the Presidential Advisory Committee Against Corruption (PACAC), Professor Sadiq Isah Radda, stressed that Nigeria had achieved a lot in the fight against corruption, "looking at what ICPC, EFCC, JAMB and Nigeria Customs Service have accomplished compared to what they were before this administration."

Meanwhile, Mr Hassan Salihu, an Assistant Commissioner of the ICPC, in his lecture titled, "Effective Communication: A Veritable Tool for Monitoring and Reporting Corruption", stated that effective communication is beneficial to making recoveries, assessing corruption risks, mitigating the risks and preventing of corruption in the Ministry of Health.

Court jails fake America military officer for cybercrime

Justice Muhammed Sani of the Federal High Court, Ilorin has sentenced a 300-Level Student of Federal University, Lokoja, Adesanya Adeolu Tosin, to one-year imprisonment for posing as an America military officer to defraud his unsuspecting victims.

Adesanya was convicted on Friday alongside one Usman Abubakar from Ofu Local Government Area of Kogi State. The Ilorin Zonal Command of the Economic and Financial Crimes Commission (EFCC) arraigned the duo on separate charges bordering on cybercrime and retention of proceeds of unlawful activities.

The defendants pleaded guilty when the charges were read to them.

Following their guilty pleas, Innocent Mbachie and Sesan Ola who prosecuted the cases on behalf of the Commission reviewed the facts of the cases and tendered the extra-judicial statements of the defendants, phones, drafts which they brought as restitution to their victims and fraudulent messages printed from his devices, which were admitted in evidence.

The prosecutors urged the Court to convict the defendants in line with their pleas.

Justice Sani in his judgment said from the totality of evidence brought by the prosecution, the court was convinced that the EFCC has proved its cases beyond reasonable doubt and subsequently convicted the defendants as charged.

The judge sentenced Adesanya to one-year imprisonment with option of N400,000 fine. and ordered that one iPhone 12 Pro Max which he used to perpetrate the crime and a draft of N600,000 which he raised as restitution to his victims, be forfeited to the Federal Government.

Justice Sani slammed a jail term of three years on Usman with option of N479,290.00 fine.

In addition, the court ordered the convict to forfeit his iPhone X 5 and Samsung s8 which he used to perpetrate the crime and also restitute the sum of N279,290.00 to his victim.

UK ex-convict returns to prison for credit card fraud

Lagos Command of the Economic and Financial Crimes Commission (EFCC) has secured the conviction and sentencing of one Ahmed Soetan Adebola, a United Kingdom ex-convict for credit card fraud.

Adebola was sentenced to one vear imprisonment by Justice Mojisola Ďada of the Special Offences Court sitting in Ikeja, Lagos

The EFCC had on June 3, 2022, arraigned the convict on a one-count amended charge bordering on obtaining by false pretence, which is contrary to Section 312 of the Criminal Law of Lagos State 2011.

The charge reads, "Ahmed Soetan Adebola sometime between the 23rd day of October 2020 and 4th November 2020 in Lagos within the Ikeja Judicial Division with intent to defraud, checked

into RADISSON BLU Anchorage Hotel for the sum of N4,449,633.12 with the understanding that your payment will be made using an American Express card with pretence you knew was false."

The convict pleaded "guilty" to the charge when read before him.

The prosecuting counsel, Ahmed Yerima, had led in evidence, his witness, an operative of the EFCC, Godwin Okara, who gave a review of the facts against the defendant, detailing how the EFCC received a petition from RADISSON BLU hotel in Lagos, sometime in December 2020, alleging that the defendant who had lodged in their facility, "off and on", made payments through credit cards, American Express in favour of the hotel and that "the payments were recalled by the unified payment system".

The trial judge had at the last sitting on June 3, 2022 fixed July 1, 2022 for

In his ruling, Justice Dada declared the victim guilty as charged.

According to the ruling of Justice Dada, "The defendant is hereby sentenced to one year in prison.

"All the items recovered from him are hereby ordered forfeited to the Federal Government and he must sign an undertaking with the EFCC never to go back to the same crime again."

He was however, given an option of fine of N2million, and ordered to restitute the money he was alleged to have defrauded the hotel, within four months.

EDITORIAL

The five months shutdown of universities

risis in the nation's educational sector aggravated on the 14th of February, 2022 when the Academic Staff Union of Nigerian Universities commenced yet another industrial action over the refusal of the Federal Government to implement the agreements and memoranda signed with the Union. It started as warning, but soon transformed into full blown strike when the union sensed insincerity on the part of the government. Other universities' workers' unions soon joined by commencing their own strikes over the same scenario of the Federal Governments disrespect for agreements and memoranda. This is the fifth month of complete breakdown of teaching, research and other activities in governments' owned universities across the nation.

The impacts of this sectoral crisis are unimaginably dangerous and devastating to the existence of our nation. WAEC and NECO continue to conduct the Senior School Certificate Examinations for secondary school leavers. But the school leavers are stuck in the strike space and the flow in the entire educational system is broken. Inside the universities research, teaching, learning and even community services are disrupted. Active youngsters that form 50 percent of Nigeria's population are kept idle. More and more of them are taking to drug and fraud. Many others are being recruited as political thugs for the 2023 general elections. Students whose parents can afford overseas education are forced to leave en mass, and to face many new environments where they are vulnerable to being re-socialized into strange ideas that may be antithetical to humanity. Anxiety of future uncertainties grip the youngsters and their parents alike.

Also, as a result of the crisis, the striking university workers are being denied their salaries. Their families starve. Many of them can no longer pay rents nor purchase drugs to manage their health conditions. Brain drain is once again renewed and aggravated as many lecturers now escape to get jobs in other countries. Aside the universities' students and workers,

other families that operate businesses on the universities' campuses are equally in agony as a result of the crisis. Once again, they are returned to the streets to join the army of unemployed Nigerians.

Although the Federal Government claims it has been negotiating with the striking university unions, concrete results are yet to hit the public. The entire scenario appears like implementation of agreements to address industrial crisis is a rocket science, especially when the agreements and memoranda have been severally signed and re-signed over the years. Amidst all these, sadly, Nigerians read daily the disturbing news of how individual government officials continue to steal national wealth, latest of which is that of the Accountant General of the Federation. The quantum of money that exchanged hands

amongst politicians during the primary elections leaves everyone wonder why the university sector has for long been abandoned as agitated by the striking workers. It is even soul depressing that none of the leading presidential aspirants in the political parties is making the crisis an issue in their campaigns. Geopolitical agitation, religion, ethnicity and circulation of elite are the defining characters of their campaigns.

Indeed, a period of five months shutdown of universities is a national emergency, and in managing emergencies, nations must go to the extents of collapsing structures and taking painful policy options to address the emergency and forestall the disasters it may bring. It is on this note that we call on the Federal Government of Nigeria to treat the current strike in the universities as national a emergency, and take all steps necessary to end it. Whatever it takes: budget, policy redress and even radical political reversal must be brought to the table at this time to ensure the fast and immediate end of the five months strike. As part of their agenda setting roles, the civil society organizations should mobilise the entire Nigerian society into making education a front burner issue during political campaigns. Parents association, students, religious leaders and traditional rulers who have joined in pressurizing the federal government should not relent. This is the time all sectors in the Nigerian State should mount pressure on the government to act timeously to save the nation.

Finally, we are not unaware that the Professor Briggs led committee currently negotiating with ASUU is making some progress, but the Committee needs to make the difference this time by using the press, the civil society and other social structures across the country to ensure that its final decisions with the unions are implemented to the letter. This is how the Committee will not end like others before it whose reports were either discarded or disregarded. This is when our students can return to class, and university workers return to work. This when we can re-kindle the hope that our country can work again.



Whatever name we call them, a runs girl is an ashewo! Period. No decent lady wants to be called ashewo, except the ones who reside in brothels. Those ones in cheap redlight districts hotels, or the ones who line up Allen Avenue in Ikeja or around Law School! I was shocked once when one of those ladies greeted me 'Good evening, Sir' near my hotel in Osubi. She thought I was one of their patrons! Holy Moses! Of course, I have said a permanent goodbye to the once decent and affordable hotel!

I first encountered use of the word in St. Augustine's popular highlife tune of the 1970s titled 'Ashewo no be Work! Ironically, that track was very popular in the brothels and hotels that dotted the murky districts of Sapele where I grew up! Iconoclastic and Marxist dramatist Bertolt Brecht also interrogated the ashewo idea in The Good Woman of Setzuan in which when the gods came visiting, the only good person willing to offer them accommodation was a prostitute! Any by the way, do we know the story of Rahab the Harlot in the Old Testament, the woman who housed the spies sent from Isreal, and who received commendation from the erudite Apostle Paul in the Book of Hebrews?

Lest you begin to wonder whether I was a patron of that dark business, Cemetery Road by Ogodo Road Junction was my regular route to my primary and secondary schools in the 1970s. And those familiar with Sapele (Safa City) would understand that reference! Apart from moral revulsion instilled by the narrow path of church and family, I was too young to contemplate such debased behaviour! Cavorting with *Ashewos*? That would be the day!

Ashewo politics and the future of Nigeria! What a title! I am sure my readers don't for one moment believe that I have set out to pour one thousand words on Ladies of the Night. This quaint title came to my mind as I contemplated events which preceded and dominated the last PDP and APC conventions in

Constitutionally, the Ndigbo might not have a unilateral claim to produce the next president but logically, morally and on the principle of equity, the southeastern region is long overdue to produce the next president of the Federal Republic of Nigeria come 2023.

One might be compelled to ask why the Ndigbo are not considered fit enough to produce the country's president after the ugly civil war? Could it be because of their political leanings? The fear that they might cede or disintegrate the country? They have not been forgiven for their roles in the civil war? Or could it be that their business prowess is seen as a threat to other regions?

None of the above reasons nor any other that any person, persons or group can put forward are enough to deny the Ndigbo a sense of belonging in their own country. They have paid their dues. It is an overdue necessity to heal our country of the unjust treatment of a particular region that is not only qualified to lead this country but also has some of the best administrators, technocrats and economic gurus of international class. It will also pacify our illustrious brothers and sisters of the eastern origin and the Biafrans heroes and heroines who lost their lives in the unfortunate

civil war. It will be a spirit lifter for the victims of the war on the Nigerian government side. It will ensure that our First Republican heroes who paid the supreme price rest in peace. It is national duty. A duty that all must collectively partake in to write their names in gold.

Amosun's political camp explodes over alleged financial underhand dealings

Just eight months to the 2023 general election in Nigeria, one of the registered opposition political parties in the country, the Allied Peoples' Movement, is neck-deep in crisis, over alleged financial recklessness, political intrigues and underhand dealings.

Available facts before Trumpet Newspaper showed that the crisis tearing the party apart, is not only protracted, but also irresolvable. In view of the forgoing, Trumpet Newspaper decided to get to the bottom of this crisis. As expected, we reached out to all the principal actors in the conflict.

First to speak with us, is the party's Board of Trustee (BOT) Chairman, Mallam. Mohammed Musa Bagana, who took time to paint a graphic picture of the possible reason(s) why the National Chairman of Allied Peoples' Movement, Alhaji Yusuf Mamman Danttale, is allegedly up in arms against him and some other key national members of the party.

The party's BOT National Chairman said, "When the idea for the formation of this particular party was muted, sometimes in year 2018, since I was not too active in the country's political terrain, I immediately reached out to a longtime friend called Faruk, who has been disturbing me to join one of the political parties in Nigeria. This friend of mine is resident in Lagos. I asked him to help get a suitable person who could assume the position of the party's National Chairman. This was how, Alhaji Danttale was sought after and invariably appointed the party's interim National Chairman alongside other key members of the party, who are presently occupying various position. And since I wasn't too familiar with the political terrain in the country then, I opted to be at the back ground as the APM National Chairman, Board of Trustee.

"Immediately, APM certificate of registration was released by INEC on the 14th of August, 2018 to me, the certificate which is still in my possession up till today, I took up the responsibility of personally funding the party without any assistance from any other member. This was how my private office in Utako, Abuja, became the APM National Headquarters in Abuja for almost three years. It was during this crisis, that Alhaji Danttale and Ayodele moved the party's National Headquarters away from my place. Before the crisis rocking the party began, some members have begun to complain about the excesses of the party's National Chairman. When the murmur and complaints became pronounced, I reached out to the suspended National Chairman and pleaded with him to endeavor to be fair to all members of the party in all that

"He Alhaji Danttale, during our discussions over the complains of other members of the party, promised to carry other members along in all that he does and change for the better. I then after decided not to interfere in all that he was doing as the APM National Chairman.

"We the members of the party's BOT were shocked and surprised, when we heard moths after this discusions, that sometimes in November, 2021, that Alhaji Yusuf Mamman Danttale, the APM National Chairman was arrested and detained by security operatives, over an alleged case of kidnapping, gun-running and other sundry crimes. As expected, members of the BOT could not fold their arms and do nothing over these grievous allegations. It was also dangerous for our party to allow this ugly situation which impacted on our party's image and integrity to continue and fester.

"Hence, we decided to do something urgent, to manage the crisis until Alhaji Danttale is release from detention. We thus, went about doing all within our powers to control the situation. This we did, so as not to adversely affect our party's image nationally. As you might be aware, our party slogan is 'integrity, sacrifice and service'. We therefore had to do, all we could to assist in any way we could for him to be released from detention. When he was finally released, after about three weeks in detention, members of the BOT paid him a sympathy visit.

"It was then after, the BOT members had due deliberation over the matter and it implications, if he continue to remain our party National Chairman. In one of our meetings we then resolved to write him a letter, which was dated 17th January, 2022, entitled "Urgent need to step aside from the position of the National Chairman of our great party pending the final outcome of your trial at the Federal High Court in Lokoja."

"Paragraph 3 of that letter, reads as follows, "We the members of the Board of Trustee of our great party, having considered the precarious condition of our great party which was occasioned by your unavoidable absence, as a result of your pending criminal prosecution at the Federal High Court in Lokoja, and in view of the fact that the general election in which our party has the intention of fielding candidates at various levels, is fast approaching, we have during our extra-ordinary meeting which took place on December 12, 2021 came up with the following resolutions.

1-That the BOT, being the conscience of our party, is our firm view that it will be morally and legally wrong and reprehensible for you to continue to preside over the affairs of our party, while still answering a criminal charge, which is preferred against you at the Federal High Court in Lokoja. Enclosed herewith is a copy of the said charge sheet for your careful perusal.

"The concluding part of that letter after our three point resolutions, we urged him not to take our position in this matter in bad faith, as his stepping aside, will enable us as members of the BOT to help other members of the party to reposition the party for a robust politics thinking in the months ahead.

"We were shocked beyond words over his uncontrolled out bust alongside his ungentlemanly conduct on the day in question.

"Since that particular day, we were no longer surprised over his antics and calculated attempt to destroy every key member of the party whom he perceived as his enemy for selfish reasons."

Countering, the National Chairman of APM, Alhaji Danttale, dismissed the BOT National Chairman's allegations and claims. He said, "It is true, it was the BOT National Chairman, who reached out to me, when the main financial of this party, who is resident abroad, was planning to help set up this party.

"The BOT National Chairman Mallam Bagana being a novice in political matters then took interest in the formation of the party because the main financial had promised then, to make available to us a huge sum of three billion Naira to run the party after its formation. A promise the main financier later did not fulfill. As at this time, I was already a well-known politician in my state, Kogi state. Because I contested the Governorship seat in Kogi State under the Labour Party in the years 2015 and 2019 general elections.

"When they contacted me, it took quite some time and hard work, to convince my party followers to join me in APM. It was after then, I began to work tirelessly to put the party's structures in place nationally.

"While working to put the party structure in place, I noticed a major defect in the APM VP, which was the original name for the party. It took me quite some time to liaise with the people at the INEC National Headquarters to streamline things. It was after this, that I now came up with the name the party now bears today which is the Allied Peoples' Movement APM. Ever since then, I have been working round the clock daily with my other colleagues in the party to strengthen the party's structures, so as to make it more effective, and pro-active.

"Several attempts have been made by a group of people, who wanted the party sold out rightly to buyers, who are ready to pay huge sums of money. But I have been the stumbling block, as I refused to agree to the selling of APM to the highest bidder, this is part of my crime.

"Since the inception of this party, if you must know, I have been the person running the affairs of the party, with my personal resources. If it is true, according to the suspended BOT National Chairman claims, in which he said, that he has been the person financing the party, I challenge him to provide evidence of his expenses over the years. I am ready to show the receipts, vouchers and other bank statements, with which I either bought him rams during Sallah, or sent him money when he requested for some assistance.

"Alhaji Danttale explained further, "On the 5th of February, 2022, at the Allied Peoples' Movement (APM) National Working Committee (NWC) meeting in Abuja, the former Chairman of APM BOT, the BOT Secretary, alongside other BOT members were suspended indefinitely for inefficiency and gross misconducts. Their suspension was done while they were present at the NEC meeting. It was at this same meeting, which was witnessed by two officials from INEC, that 6 National Officers and 3 State Chairmen were also suspended for Anti-Party activities.

He said the suspended officers of the party, allegedly held a kangaroo meeting where they made the former party National Treasurer, Mrs. Rose Gyar, as the APM National Chairman in violation of the APM constitution, which is registered with the Independent National Electoral Commission, INEC.

He stressed, "Article 10(7) of the party constitution provides that, "Two-third majority of the Executive Committee at all levels shall form a quorum' for any meeting at the instance of the National Chairman.

"But unfortunately, in the so called National Working Committee meeting where Mrs. Gyar was purportedly elected as my replacement, only six out of the 20 members of APM NEC members, were in attendance. And as such, whatever decision reached in that meeting was null and void and of no effect whatsoever in the operations of the party."

As tech companies pull back from Russia, China looks on with concern

¬ xtensive efforts by Apple and other **◄** Western tech companies to curtail ■ their business with Russia over its invasion of Ukraine have raised a question for product users in China: Could the same thing happen there?

Much of Chinese consumers' concern has been focused on Apple, which like Google, Microsoft and other tech giants moved quickly to curb its Russia business after President Vladimir Putin invaded Ukraine on Feb. 24. The company has stopped product sales and exports, limited services like Apple Pay and removed the Russian state news outlets RT News and Sputnik News from the Apple Store outside Russia.

Russia's invasion of Ukraine, as well as the global response, have been closely watched in Asia, where there are longstanding tensions between China and the self-ruling island of Taiwan, which Beijing claims as its territory. Chinese leader Xi Jinping has said "reunification" with Taiwan is inevitable and has not ruled out the use of force to achieve it, though the Taiwanese government says there are no signs of imminent attack.

Chinese officials reject any comparison between Taiwan and Ukraine, saying only Ukraine is an independent country. But some online commenters in China, where social media is dominated by nationalist and pro-Russian sentiment, have criticized Apple's actions in Russia and said China should prepare itself for similar tactics.

"If one day China finally decides to liberate Taiwan, who can guarantee that our own iPhones won't get deactivated?" one user asked on Zhihu, a Chinese social media platform similar to Quora.

Experts say it would be difficult for Apple to walk away from China, which is a critical manufacturing center for the company as well as its third-largest market after the United States and

"It is a very different story than what is happening in Russia," said Kendra Schaefer, head of tech research at Trivium, a policy research team based in Beijing.

Schaefer pointed out that Chinese regulations require Apple and other companies to store Chinese customers' information on servers inside the country.

"The question would be, does pulling out of China mean that Apple not only loses its customers, but all of its customer data completely?" she said.

Apple did not respond to emailed requests for comment.

Before the war in Ukraine, China was already pursuing a national strategy of "tech independence," emphasizing indigenous innovation and the recruitment of overseas talent. Xi has stressed its importance in recent years as both the Trump and Biden administrations have tightened U.S. restrictions on Chinese tech giants like Huawei and ZTE that they deem threats to national security.

"The U.S. sanctions on Huawei and ZTE during the Sino-U.S. trade war already abruptly awoke Chinese policymakers about the importance of technological self-sufficiency," Angela Zhang, director of the Center for Chinese Law at the University of Hong Kong, said in an emailed response to questions.

But Zhang said it could take decades for China to catch up with the United States and Taiwan in the manufacturing of semiconductors and other essential components of electronic devices.

"It is also very costly, if not impossible, to achieve complete self-sufficiency of many hardcore technologies, which involve a very long and complicated supply chain," she added.

Russia's growing isolation from companies like Apple has added to calls for China's tech independence from the West, which is also referred to as the "great decoupling."

One commenter on Weibo, China's equivalent of Twitter, noted his reliance on Apple's cloud storage service.

"Now I'm really worried that if anything happened, a company like Apple would deactivate my phone and my data," he said.

"The great decoupling is inevitable," he added.

VC Funding, Nigeria Startup Bill and other Soundbites from 10th Digital Africa Conference

Despite the Covid 19-induced global business disruptions and economic difficulties faced by most countries of the world in the past two years, international venture capitalists continued to hunger for new and existing tech startups.

Collectively they poured \$643 billion in VC funding to these startups globally in 2021, a 92% year-on-year growth compared to \$335 billion in 2020.

Ready access to the largest chunk of global VC funding is the principal factor for the continuing leadership and dominance of the global tech space by US companies today. They received \$329 billion, 51% of the funds available globally in 2021.

Less than \$10 billion of this amount came to the 54 countries of Africa combined. There's a tremendous room therefore for the growth of VC funds in Africa, the world's second largest continent both in area and population; the region that has recorded the fastest growth rate in mobile subscription and internet usage in the past two decades; and a region whose youth population is increasingly comprised of digital natives.

Based on the latest annual report for 2021 by Partech Ventures (a Paris-based VC company), Nigeria received \$1.799 billion in VC funding for its tech startups,

continuing its continental leadership in this critical area.

South Africa came 2nd with \$832 million, with Egypt, Kenya, Senegal and Ghana receiving \$652 million, \$571 million, \$353 million and \$167 million respectively in

Startups in Tanzania, Algeria, Mauritius and Tunisia received \$46 million, \$43 million, \$38 million and \$33 million respectively.

The forthcoming Nigeria Venture Capital Summit, slated for November 10-11, 2022 in Abuja is aimed at helping the country to substantially step up its game in attracting even more VC funds for its growing number of tech and non-tech startups in 2023 and beyond.



Nigeria hints on Blockchain technology regulations

inister of Communications and Digital Economy, Prof. Isa Ali Ibrahim (Pantami), has assured key industry players and indeed Nigerians of the Federal Government's commitment to create and enforce regulations that will Fast-track effective utilisation of Blockchain technology for the development of the country's digital economy.

He said this while delivering a keynote address on the Applications of Blockchain Technology for Intellectual Property (IP) Enforcement at the American Business Council event, in partnership with the United States Patent and Trademark Office.

The Minister, represented by Dr. Salihu Abdulkareem of the National Centre for Artificial Intelligence and Robotics (NCAIR), alluded to the fact that the theme of the event: "Blockchain for IP Enforcement; More than Crypto and NFTs" is apt and timely especially at a time when crypto currency is presently the headlines of financial losses.

The Minister noted that in today's knowledge based economy, an increasing share of business value is derived via intangible assets, which means success often depends upon the ability to manage and exploit IP.

He stressed that for that reason, businesses require managers to effectively acquire, govern and commercialize copyright-and patent-protected content.

"You would all agree that, traditional businesses that rely on IP-protected material are confronting internal and external factors that pose several key challenges. Internally, unsynchronized IT systems do not enable data to flow, creating friction to locate and comply with copyrights under control. Externally, firms are recently operating in more complex, and diverse business networks with the need

to validate multiple IPs within a single transactions model", he said.

Prof. Pantami highlighted the benefits of Blockchain technology which he said represent a paradigm shift in how various companies protect their information exchange, adding that emerging technology provides a secure and fault-tolerant distributed ledger platform for transactions.

"No doubt, Blockchain technology has evolved greatly since the introduction of Bitcoin in 2008, the first decentralized peer-to-peer electronic cash system. Today, innovators in various fields are realizing the benefits behind this great technology. From medicine to agriculture, finance to governance, education to transport and across global supply chain; many sectors are looking for ways to integrate Blockchain into their infrastructures", he added.

While observing that governments and businesses all over the world are realizing the powerful usability of Blockchain, Prof. Pantami affirmed that the Federal Ministry of Communications and Digital Economy as well as its parastatals are not left behind, as they are inclined to employ the statutory responsibility towards innovative technologies, to develop corresponding strategies for a healthy ICT ecosystem that encapsulate emerging technology such as Blockchain.

He said, "It may interest you to know that one of the Agency's under my supervision, the National Information Technology Development Agency (NITDA), has developed a National Blockchain Adoption Strategy that seeks to facilitate effective utilisation of Blockchain technology for the development of the Nigerian digital economy. The strategy outlines the roadmap and schemes for the adoption of the Blockchain technology by government in its digital transformation

agenda in a way that supports efficiency, transparency, and productivity".

Although, it is an established fact that the technology drives new businesses and service models, the Communications and Digital Economy Boss made it known that there is need to equally create and enforce regulations to protect citizens and ensure fair markets while letting innovation and business flourish.

He went on to register the Federal Government's concern on how the technology can be used to foster healthy growth of the nation's digital economy and safety through the right regulatory instruments and implementation strategy that drive the adoption of the technology by both public and private sectors.

"In this regard, we directed NITDA to develop a national infrastructure for the deployment of Blockchain solutions that integrate identity and incentive platforms, promote research and development, in addition, to focus on the skilling of the workforce, and create a procurement process to enable government agencies to adopt Blockchain solutions", he noted.

As a way of exploring ways to develop regulatory actions that would strike the right balance between facilitating innovation and mitigating new risks, the Minister confirmed that the ministry has further directed NITDA to introduce regulatory sandboxes that enable participants to test products and services on a small scale in a controlled environment, reducing innovation costs and barriers to entry.

These sandboxes, Pantami emphasized will also allow regulators to collect important information about innovative products before deciding which regulatory action to take.

"Through sustained engagement with stakeholders like you and many others, implementation of these regulatory guidelines would be enhanced and in turn, would engender a conducive regulatory environment for all players in the digital economy to thrive and fulfill their potential for prosperity and national development," he added.

Meanwhile, Prof Pantami recounted many IT issues that still remain unresolved, such as "the interoperability of different Blockchain platforms, and legal issues such as data ownership, privacy, liability, and jurisdiction".

However, Pantami expressed his belief that with engagements such as the event, all business stakeholders and IP communities would reap the full benefits of Blockchain technology to promote innovations, support anti-counterfeit and anti-piracy operations; grow businesses, create jobs; entrench security, reliability, and transparency in all processes models.

Nigeria to support global efforts against marine plastic pollution

President Muhammadu Buhari has pledged Nigeria's commitment to an international legally binding instrument to reduce the menace of marine plastic pollution from land-based sources and activities.

The President gave the assurance weekend in a speech at the 2022 United Nations Ocean Conference in Lisbon, the capital of Portugal.

Highlighting Nigeria's effort at ensuring the health and sustainability of oceans, seas and marine resources, the President represented by the Minister of State for Environment, Sharon Ikeazor, said a national policy on plastic pollution and the road map on tackling solid and plastic waste management has been formulated and established.

The President, who lauded the United Nations for leading the process of effective ocean governance, said Nigeria had mainstreamed ocean management into the economy, constituting a Presidential Committee on Sustainable Blue Economy.

He also announced that Nigeria has

embarked on the creation of two marine protected areas.

President Buhari reaffirmed Nigeria's commitment to participating constructively in the ongoing negotiations for various multilateral agreements, including on the conservation and sustainable use of marine biological diversity in areas beyond national jurisdiction.

According to him: "The entire Southern border of Nigeria is the Atlantic Ocean with a coastline of about 853km being the longest in the West African region.

"It is endowed with enormous biodiversity resources such as the freshwater and mangrove forest ecosystems with diverse species of fauna and flora.

"We acknowledge the fact that a healthy ocean and coastal environment is key to sustainable development. We must therefore conserve and sustainably use the oceans, seas and marine resources.

"The ocean is key to the global economy,

with an estimated 40 million people projected to be employed by ocean-based industries by 2030.

"Our oceans and seas are repositories of tremendous wealth, in terms of natural capital, ecosystem services, living and non-living resources. We are conscious of the fact that our maritime and aquatic resources are critical for the livelihoods of our people.

"Hence, our commitment to the Africa Union 2063 Agenda and the attainment of United Nations SDG 14".

The President also stressed the need for more scientific partnerships and knowledge sharing to protect humanity's common ocean heritage.

His words: "The science tells us that in order to stop the downward spiral we are witnessing in the ocean, we must fully and highly protect at least 30% of the global ocean by 2030, and dramatically strengthen the management of human activities in the other 70%.

"This must be reflected in the text we negotiate here as well as in upcoming negotiations planned in December 2022 at the upcoming Convention on Biological Diversity (CBD) of the Conference of Parties (COP).

"Nigeria is a member of the High Ambition Coalition for Nature and People and the Blue Leaders Campaign.

"The global community needs to agree to the effective protection of 30% of the global ocean by 2030 at the CBD COP in December, and a robust high seas treaty that doesn't simply endorse the status quo, but the one that ensures all nations manage their activities in the high seas to prevent significant effects on the ocean.

"These two steps will go a long way in restoring the health and resilience of our oceans."

Buhari Pledges Nigeria's Support for Global Efforts to Tackle Marine Plastic Pollution



Tackling menace of substandard materials, products in Nigerian markets

A few years ago, the United Nations (UN) declared that about 70 per cent of products and materials on sale in the Nigerian market were either fake or substandard and have done serious damage to their users or consumers. Curiously, in spite of the efforts of the regulatory agencies charged with the responsibility of monitoring to rid the country of them, the country's markets are still flooded with fake or substandard products or materials on daily basis, which has been causing health challenges to Nigerians and building collapses in the construction industry across the country, **JOHNMARK UKOKO** writes.

In the 1950s and up until the early 1980s, products offered for sale were of high quality. Nationals of many countries from West Africa, Central Africa and even East Africa travel all their ways to Nigeria to buy high quality products.

Most of those products were churned out from the country's many industrial factories then in existence. That runs for 24 hours then.

Some of those factories were located in Ogba Industrial Estate, Oregun Industrial Estate, Ikeja Industrial Estate, Eric Moore Industrial Estate, as well as Surulere, Iganmu, Korodu, Apapa, Amuwo-Odofin and Isolo industrial estates, among others in Lagos State.

There were also other industrial estates located in Kano, Kaduna, Bauchi, Emene in Enugu State, Aba Industrial Estate in Abia State, Warri Industrial Estate in Delta State and the Port Harcourt Industrial Estate in Rivers State, among such other locations across the country.

The products and items manufactured in those industrial hubs then were of top quality that competed favourably with imported products and items from across the globe.

However, since the mid 1980s when Nigeria began an unholy romance with the International Monetary Fund (IMF) during the regime of former military President Ibrahim Badamosi Babaginda (IBB) by taking loans from the IMF and World Bank and the exploitative conditions that crippled the country's industries and ruined the economy.

Most of the companies that dotted the above named industrial estates have long closed shops, just most of the large factories have gone comatose and their premises overgrown with weeds.

Some of the large warehouses and factories in those industrial estates that were once famous for keeping top quality locally produced products have been converted to religious and worship centres, as their owners closed down the factories, while several others simply relocated to neighbouring countries that with friendlier operating environment, such as Ghana and other African countries.

Consequently, Nigerian businessmen and their women counterparts rather opted to either import or smuggle substandard products into the country, as most of the local factories have either closed

down or continued operating at minimal production levels.

To curb the menace of influx of substandard products into the country, the Federal Government established the Standards Organisation of Nigeria (SON) to check importation of substandard goods, set standards for products to be locally produced and imported and ensure that products being sold in the country were of high quality.

However, the Federal Government and Nigerians have not been impressed with the type of products in the markets, as several Nigerians have died or have been harmed by consumption of substandard products, especially fake drugs and medicines.

Minister of Industry, Trade and Investment, Otunba Adeniyi Adebayo, who addressed journalists at a press briefing recently, said the Federal Government was worried about the influx of substandard and fake products into the country and that the government was aware of the many Nigerians who have died from the consumption of such products.

He also stressed that the government was aware that most incidents of collapsed buildings in the country in the recent years arose from the use of substandard materials in the construction of such buildings.

Adebayo, who noted that the government knows that many road crashes would have been avoided, if the owners of such vehicles have not patronise substandard tyres, pledged that the Federal Government would do everything within its power to support the SON in winning the war against substandard products.

He disclosed that one of the ways the government hoped SON would be able to win the war, would be through the establishment of a world-class standard laboratory recently put in place at SON's facility in Ogba, Industrial Estate, Ikeja, Lagos.

The minister added that similar laboratories were being set up in Enugu, Ado-Ekiti, Abuja and elsewhere to ensure that goods and materials produced in Nigeria or imported into the country meet international standards.

But while the country still awaits the realization of such aspiration, the two critical government agencies that are crucial to the realisation of the government's aspiration-the Nigeria Customs Service (NCS)

and SON recently disagreed and traded blames against each other over the influx of fake products into the country's markets.

Director-General of SON, Mallam Farouk Salim, who fielded questions from journalists recently fired the first salvo and blamed the Customs for the influx of substandard products, insisting that the Customs was responsible for the influx of fake products into the country.

When asked how fake and substandard products find their way into the country's markets despite his men participating in joint cargo examination with the customers, he said: "We are not always invited for joint inspection. In fact, our invitation for joint inspection is rare and in-between. But, I can guarantee that if our officers get opportunities to inspect products, the moment they look at the items from their experience, they will detect substandard goods.

"Don't forget that our counterparts in the Customs Service are only trained to charge duty payment, they have no idea what cables look like or what substandard goods look like. But SON's officials have unfettered access as stipulated in the 1999 Constitution as amended.

"The laws setting up the agency provided that we must be allowed to be at the ports. It is not a favour that we should be waiting on someone to call us into the ports. As an agency, we are part of the government by the law unless the National

Assembly changes or amends the law. The laws enacted by the National Assembly and signed by President Muhammadu Buhari stated that the SON must and should be at the ports, not at the discretion of any other organisation."

Salim's comments infuriated

Salim's comments infuriated management of the Nigeria Custom Service (NCS), which responded swiftly and fired back at the SON, stating its side of the story through its Spokesman, Timi Bomodi.

Bomodi said the comment credited to the Director-General of SON was not true, adding that there were open channels of communication between the officials of SON and Customs Area Commands if the need arises for clarification or intervention.

"SON's officials usually partake in examination of cargoes. We want to state that the allegations are not true. The Nigeria Customs Service is fully cognizant that strategic co-operation among security and regulatory agencies lies at the heart of national security and as such we willfully work in tandem with other security and regulatory agencies including the SON to achieve national goals," Bomodi said.

He further clarified that under the Nigeria Integrated Customs Information System (NICIS 11), the SON and other regulatory agencies of government are linked directly and frequently make inputs in reference to their operations. "At no time did the NCS refuse to oblige the SON of any request. Indeed, the Nigeria Custom Service, even without intervention from the SON on its own directs suspicious items bordering on brand and intellectual property rights infringements to them. Therefore, the statement ascribed to the SON boss, creates a totally false narrative, it is questionable, raises serious concerns and calls for scrutiny by discerning members of the public. It is also self-condemning.

self-condemning.

"The SON has access to our systems and it officials are informed and fully participate in examination of goods and even go as far as collecting product samples where necessary during examinations for their investigation. Even the field inspection process chart on the SON's official website shows its involvement at the ports and borders, during examination of goods.

"Therefore, the statement credited to the SON boss is unfortunate. While success is said to breed opposition, the success of the NCS is not achieved by tarnishing the image of other agencies, just to look good or score cheap points," Bomodi stressed.

He, however, blamed the influx of substandard products in the country on the incompetence of SON officials.

While the war of words rages on between the two government agencies funded by taxpayers money, more lives continue to be lost daily in the country. For instance, on June 29, 2022, a three storey building under construction in Port Harcourt, Rivers State collapsed due to suspected use of substandard materials. Several persons, who were believed to be trapped under the rubble of the collapsed building died, while many others sustained varying degrees of injuries.

Hardly a week passes in Lagos State without report of one building collapse or another with various degrees of casualties. A few months ago, a 21-storey twin towers building collapsed in Ikoyi, killing scores of workers on the site, visitors and some owners of the project due the use of substandard materials.

The question most Nigerians are asking is when will the authorities rid the country of killer items? Will there ever be a time when Nigerians will be able to buy products in the market with confidence that they have bought real value for their money? Only time shall tell.

Climate action: Global oil reserves drop by nine per cent

Total recoverable oil worldwide has indicated a dip, dropping by nine per cent from 2021 and threatening global energy security at a time price increases associated with falling supplies trigger inflation across major global economies.

A Rystad Energy's 2022 review, an independent and data-based analysis of global energy landscape, showed that the world has suffered a sizable drop in recoverable oil resources in the last one year, generating fears that underinvestment inflicted action was beginning to deliver negative impacts.

The Rystad Energy analysis also showed that global recoverable oil now stood at estimated 1,572 billion barrels, a drop of almost nine per cent since last year and 152 billion lesser barrels than the total in 2021.

Recoverable oil corresponds to the industry term, remaining technically recoverable crude oil and condensate. The hydrocarbon liquids include expected volumes from field discoveries and risked future discoveries.

Rystad Energy said the drop in reserves resulted from depletion of production, low discoveries to replace produced volumes and lack of access to exploration rights.

According to the firm, which provides critical advisory notes

for investors, the fall in reserves is driven by the 30 billion barrels of oil produced last year and a significant reduction in undiscovered resources amounting to 120 billion barrels.

The United States offshore sector, Rystad said, contributed the largest total to the drop, where 20 billion barrels of oil would remain aground, largely due to leasing bans on federal land.

It added that of the 1,572 billion barrels of technically

recoverable oil, only about 1,200 billion barrels would likely be economically viable before 2,100 at \$50 per barrel counting the carbon footprint expected from the global reserves against templates set by the United Nations, Framework Convention on Climate Change (UNFCCC).

Rystad projected that economically, extractable oil would contribute about 0.1 per cent of additional global warming by the year 2100 due to expected absorption capacity of the earth's

natural carbon on sinks.

The analysts reported that the drop in global hydrocarbon liquid reserves represented the raging battle between climate activists on the one hand, as well economists and petroleum industry players on the other hand

Head of analysis at Rystad Energy, Magnus Nysveen, stressed that the declining reserves figures will improve prospects of meeting climate targets, while hurting the global economy.

FG slams high tariff on tobacco firms, smokers

In a bid to discourage the habit of cigarette smoking, the Federal Government has slammed higher tariffs on tobacco products.

In its verified Twitter handle, the Federal Government said from June 1, 2022, it has commenced a new three-year tobacco tax regime, which will end in 2025.

"With effect from June 1, 2022, the Federal Government has commenced implementation of a new three-year tobacco tax regime which will end in 2025. This new regime increased the ad-valorem tax rate from 20 per cent to 30 per cent.

"In addition to the 30 per cent ad-valorem, a specific excise rate has been increased from N58 to N84 per pack of 20 sticks of cigarette, which will further be increased to N94 per pack in 2023 and N104 per pack in 2024.

Also, the tax on Shisha is now N3,000 per litre and N1,000 per kilogramme and will be raised yearly by N500.

"The pro-health tax is an effective public health control measure against behavioral risk factors as it has the capability to reduce demand and consumption of tobacco products. It will also prompt tobacco users to switch spending their resources on tobacco products to health activities such as education, health and nutrition," the tweet added.

Apapa customs half-year revenue hits N522 billion

Revenue profile of Apapa Command of the Nigeria Customs Service has risen to N522.4 billion in the first half of the year 2022 saying that in the corresponding period of last year, it collected N366.5 billion, representing a 42.5 per cent increase in revenue generation.

Area Controller of the Command, Comptroller Malanta Ibrahim Yusuf, disclosed this during the weekend at a media briefing, saying the feat was made possible because of officers' resilience in ensuring that identified revenue leakages were mitigated, while sustaining importers and stakeholders' compliance level in the clearance value chain.

Yusuf hinted that the command has consistently strived in its core mandate of revenue generation, prevention and suppression of smuggling, trade facilitation and implementation of government policies to ensure ease of doing business at the port.

On non-oil export, the controller declared that the command recorded a boost in the exportation of non-oil commodities in the first half of this year from January to June.

According to him, non-oil export rose to 2.5 million metric tons above the 540 metric tons recorded in the first six months of 2021, adding that that the Free on Board (FOB) valued of the exported items rose from \$1.38 million in 2021 to \$1.6 million in 2022.

He revealed that the exported items include steel bars, agricultural and mineral products among others, noting that the Federal Government policy and export incentive schemes have played vital roles in boosting export trade in the country.

On smuggling, Yusuf said the command's operation was guided by the Federal Government import and export prohibition lists, as

well as other government policies as directed.

He stated that in the period under review, the command curbed the smuggling of dangerous items into the country, resulting in the seizure of 83 containers with Duty Paid Value (DPV) of N8.3 billion.

Paid Value (DPV) of N8.3 billion. Giving details of the seized items, including 32 containers of processed and in-processed wood, 18 containers of used clothing and shoes, 12 containers of foreign parboiled rice, seven containers of vegetable oil and three containers of tomatoes paste, adding that a 20-foot container of Tramadol was currently being investigated.

He disclosed that the command had recently handed over two 20 feet containers marked: "SUDU 777479 and UETU 2798479" laden with 150 cartons of illicit hard drugs to the National Drug Law Enforcement Agency (NDLEA) with a view to further strengthening the relationship between relevant government agencies at the port.

Fielding questions from journalists on the rising revenue profile, Yusuf stated that if the command could generate N522.4 billion in the first six months, it will definitely generate more in the second half of the year when activities would peak towards December.

Russia-Ukraine war: Nigeria set to supply gas to Europe, says Buhari

•500bpd modular refinery begins operations in Edo

As the war between Russia and Ukraine continues, Nigeria has expressed its readiness to fill the gaps in supply of natural gas to Europe and other countries of the world.

President Muhammadu Buhari made the disclosure at the weekend in Lisbon, Portugal, during a state visit to the country, saying that with over 200 million population of mostly young people, Nigeria was ready

to become the major hub of the African Continental Free Trade Area (AfCFTA).

Commenting on collaboration between Nigeria and Portugal, he urged the European country to consider Nigeria as a valued and trusted partner in Africa, just as he identified five key areas of cooperation capable of boosting the economies of both countries.

He explained that the country was ready to collaborate with Portugal to harness the abundant crude oil and natural gas resources, tourism and hospitality industry, air travel, security and joint commission.

Buhari said with the current war between Russia and Ukraine, partnership between Nigeria and Portugal had become necessary to avoid further crisis in the gas demand and supply chain, insisting that the West African country was already to fill the gap as a major supplier of gas to Portugal.

On tourism, the President noted that Nigeria possesses huge potential in the sector and would like to benefit from Portugal's expertise, while stressing the need to sign a Bilateral Air Services Agreement (BASA) on air transportation and establish a

direct link between both countries. This followed as promoters of the 2,500 barrels per day (bpd) capacity modular refinery at Egbokor and Ologbo in Edo State worth over N60 billion being executed

over N60 billion being executed by Duport Midstream and the Nigerian Content Development and Monitoring Board (NCDMB) disclosed that the project has been completed and ready for operations this month.

The project was conceived to include 30 metric standard cubic feet per day, while the modular refinery has capacity to process 30,000bpd. Also in the next 18 months, the modular Liquefied Natural Gas (LNG) refinery will be ready to process 10,000bpd.

The Trumpet learnt that the two modular refineries located at Egbokor and Ologbo in Ikpoba Okha Council of Edo State, from which the state government hopes to collect Internally Generated Revenue (IGR), will begin full commercial production by July 28, 2022 subject to final approvals by the regulatory authorities.

It was also learnt that Waltersmith Modular Refinery in Imo State had already commenced refining of 5000bpd, while the Azikel Modular Refinery in Bayelsa State is near completion and on the verge of starting operations.

Police arrest suspects for child trafficking, fake naira notes

Police operatives in Delta State have arrested three ladies for alleged child trafficking at Omerigboma Village Oko, Oshimili South Local Government Area.

Spokesperson of the Delta Police Command, DSP Bright Edafe, in a statement on Saturday, said the arrest of the suspects, Ado-Obi Oguguo, Chidima Osita and Nkimka Ikechukwu, followed a petition written on behalf of a 13-year-old girl who was trafficked at Ebonyi State and was to be taken to Onicha-Ugbo for prostitution.

"On 24/6/2022, the Command received a complaint via petition to the Area Commander Asaba, written on behalf of a victim of child trafficking (Name withheld) age 13yrs, a native of Izza North LGA of Ebonyi State, who was to be taken to Onicha-Ugbo for prostitution.

"A combined team of Policemen and vigilante embarked on an intelligence led operation, which led to the arrest of three suspects namely; Ado-Obi Oguguo 'f' age 38yrs, Chidima Osita age 36yrs, and Nkirnka Ikechukwu 'f' age 30yrs, all residing at Omerigboma Village Oko, Oshimili South, Delta State.

"Preliminary investigation revealed that, suspects were into prostitution, and on 22/6/2022, they arranged for a girl named Chidima surname unknown age 16yrs to be taken to Mali for prostitution," Edafe stated.

He added that investigation and effort to arrest other members of the syndicate is ongoing.

In another development, a 45 year old native of Ebonyi State was arrested by the police after being rescued from the fierce grips of mobs who were attacking him for attempting to dupe a POS operator with fake Naira notes.

DSP Edafe said the suspect, who was arrest at Oko new international market in Asaba, was in possession of about N80,000 fake currency naira notes.

"On 28/6/2022, at about 1530hours, Operatives of Eagle-Net Special Squad while on routine patrol along Asaba/Onitsha bridge sighted a mob, attacking a man at Oko new international market in Asaba. The team rushed to the scene and rescued the suspect named Michael Ozor age 45yrs of Abakiliki in Ebonyi State.

"The suspect was alleged to have made a POS transaction with fake Naira notes with intent to defraud the POS operator. The suspect was arrested and fake naira notes to the tune of Eighty Thousand was recovered from him. Investigation is ongoing," Edafe said.

"Katsina Utd are further fined N250,000 compensation to Mr Michael Onikute of Remo Stars.

"Katsina Utd are to replace the damaged equipment of Remo Stars at the face value of the certified receipts provided to the LMC by Remo Stars.

"Katsina Utd's ground, Muhammadu Dikko Stadium, will be closed to fans indefinitely. The club's home games will be strictly under closed-door till adequate security measures including written guarantees by the Katsina Police Command to prosecute are put in place.

"In event of any further similar breach of the league rules in the course of this season, Katsina Utd shall forfeit 3 points from the points accruing to the club, in addition to any additional sanctions that may deemed appropriate in the circumstance," LMC added.

However, on Saturday while in action in their Matchday 36 fixture at the Next of Champions with Dakkada FC, Katsina United struggling to beat the relegation zone at season's end, fell to a 2-0 defeat.

Moscow accuses Ukraine of hitting Russia in missile attack

Ukraine has been accused of firing three missiles at the Russian city of Belgorod near the border in strikes that killed at least three people and damaged dozens of residential buildings.

At least 11 apartment buildings and 39 private houses were damaged, including five that were destroved, regional Governor Vyacheslav Gladkov posted on the Telegram messaging

app.
"I emphasise that this missile attack had been intentionally planned and was launched at the civilian population cities," of Russian Defence Russian Ministry spokesman Konashenkov Igor said. He added that Russian anti-aircraft defences shot down three Tochka-U cluster missiles launched by Ukrainian nationalists.

At least four people

were injured and two hospitalized, including 10-year-old Gladkov added.

Belgorod, a city of nearly 400,000 some km (25 miles) north of the border with Ukraine, is the administrative center of the Belgorod region.

Senior Russian lawmaker Andrei Klishas accused Ukraine of shelling Belgorod and called for a severe response.

"The death of civilians and the destruction of civilian infrastructure in Belgorod are a direct act of aggression on the part of Ukraine and require the most severe including a military response, Klishas wrote on Telegram.

Since Russia launched its invasion Ukraine Feb. there have been numerous reports of attacks on Belgorod other regions and bordering Ukraine, with Moscow accusing Kyiv of carrying out the

Ukraine has claimed responsibility for previous attacks but has described the incidents as payback and "karma" for Russia's invasion.

Moscow calls actions in Ukraine "special military operation" to disarm Ükraine and protect it from fascists.

Ukraine and its allies in the West say the fascist allegation is baseless and the war is an unprovoked act of aggression.



Egypt shuts down beaches after shark kills tourist

Egypt's Red Governorate issued an order to shut down several beaches a day after a shark attack killed an Austrian swimming near the resort of Hurghada.

The 68-vear-old woman was killed on a Red Sea beach off the coast of Sahl Hasheesh. She lost a leg and an arm in the attack. She died shortly after being brought to a private Nile Hospital in Hurghada, an Egyptian health official said.

She was barely alive when she was brought in on Friday, the official aďding attempts by medical staff to resuscitate her failed due to circulatory failure, which is
