Uproar greets INEC's new body language on 2023 elections

ational outcry led by the presidential candidate of the Peoples Democratic Party (PDP), AlhajiAtiku Abubakar, is trailing a statement made by a senior official of the Independent National Commission Electoral (INEC) that results of the 2023 election will be collated manually.

A spokesman of the Atiku Åbubakar Campaign Organisation, Daniel Bwala, alleged that with such a statement coming from functionary of the electoral commission. " INFC is commission, laying the foundation for the rigging of the 2023 elections.

The alarm was also raised in some other quarters.

National Commissioner and Chairman of INEC's Information and Voter Education Committee, Festus Okove had Saturday said the collation of results of the 2023 general elections would be manual despite the adoption of electronic transmission.

In a swift reaction. Bwala on his Facebook page on Sunday, said the PDP presidential candidate exception to such Okove declaration bv because it ran foul of the provisions of Section 60 of the Electoral Act 2022.

He said: "Section 60 is clear. At the close of voting at the polling unit, the voting results will be uploaded, meaning that by the time the officer from the unit goes to the ward, he cannot present a result different from the one that was uploaded, which every voter can have access to it.

"And the same thing the to government and the state, because there is evidence you have sent it to a server where it cannot be manipulated.

"By what Okoye said it means they are creating the room and possibility for somebody to manipulate the result without prejudice to the counting and the result as announced at the

"And where there is a conflict, that reliance will be placed on the manual collation. In other words, they are trying to go around the provisions of the Electoral Act to take us back to where we are coming

"Sadly, they are trying to find a solution where there is no problem because this same electronic upload and transmission has been done

"If you go to court all the challenge in court were around certificates of individual and whether that individual is qualified or not. But that procedure has worked.

"So why are you trying to fix something that is not broken? It means something is fishy, we smell a coffee. And that's why we're calling all well meaning Nigerians and lovers of democracy in Nigeria and beyond to raise their voice and speak with one voice.

Okoye said: "there is a marked difference between transfer/transmission of results and the collation of results. Section 50(2) of the Electoral Act, 2022 gives the commission the absolute discretion to determine the mode and procedure of voting in an election and the transmission of election

"Sections 60 and 62 of the Electoral Act govern post-election procedure and collation of election results. Section 60(1) of the Act provides that the presiding officer shall, after counting the votes at a polling unit, enter the votes scored by each candidate in a form to be prescribed by the commission.

Section 60(5) of the Act makes it mandatory the presiding officer shall transfer the results, including total number of accredited voters and the results of the ballot in a manner prescribed by the commission. Thereafter, presiding officer the shall after recording and announcing the results deliver the same along with election materials under security and accompanied by the candidates or their polling agents, where available to such person as may be prescribed by the commission.

"The implication of this is that the collation process of results is still essentially manual, but the collation officer must collate subject to his verification and confirmation that the number of accredited voters stated on the collated result are correct and consistent the number of accredited voters recorded and transmitted directly from polling units."

clarifications, Okove said that while the collation of results would "essentially' be done manually, where was a regarding collated outcome or that from any polling unit, the collation or returning officer would use the original of the disputed collated result, accreditation data from the BVAS device and the results transmitted directly from the polling to determine correctness of the result.

But Atiku's spokesperson said there must be strict compliance with provisions of the Electoral Act with respect to electronic upload and transmission of result, without prejudice to what INEC is thinking about bringing.

"We must never try to change the procedure that has worked in these states mentioned.

"It must be free, it must be transparent.

'We don't want litigation. We want the voice and the will of the people to prevail in Nigeria," he said.

Also, another group, AIF Media alleged that INEC's Director in charge of ICT, Engineer Chidi Nwafor, has been removed.

The group said this is part of grand plan to rig the 2023 polls, while doubting the readiness of the commission to conduct free, fair and credible election next year.

The group entertained fears that INEC may not conduct a free, fair and transparent election in 2023, arguing that the latest redeployment of Nwafor is a sign that all is not well.

"We wish to reassure Nigerians that the electronic transmission of result has come to stay. It adds to the credibility and transparency of the process when citizens follow polling unit level results on the INEC Result Viewing (IReV) portal on real-time on Election Day. There will be no change or deviation in subsequent elections.

"The entire gamut of result management provided for in Sections 60, 62 and 64 of the Electoral Act 2022. In line with the provision of the Commission, in law, the April this year, released a detailed clarification of the procedure for transmission, collation and declaration of result which was shared with all stakeholders and uploaded to our website.

The commission appealed to all Nigerians to avail themselves of the provisions of the Electoral Act and INEC's detailed explanation of the procedure and not reach a conclusion on the basis of media headlines.

Director-General of LCCI, Chinyere Almona, made the assertions in a statement issued in Lagos, reacting to the July 2022 inflation rate.

She said: "There is the need for a good mix of both fiscal and monetary policies to tackle the core drivers of the inflation scourge in Nigeria. There should be targeted financing for critical sectors like agriculture, food processing, aviation fuels, transport and forex availability for manufacturing inputs.

"It is obvious that the government's intervention so far has not impacted the inflationary pressures that keep rising till now. Without concrete and quick steps of intervention, the rising inflation rate may continue

into the end of 2022."

Speaking further, she "A major worry is about the inflation scourge production, constraining losses. causing job and imminent courting an The inflation recession. rate may ease in the near term driven by constrained consumer demand, harvests maturing in quarter three and the resumption of wheat exports from Ukraine to Africa. However, there are fears of falling growth due to constrained production in

the past months.
"In July, Nigerians paid more for goods and services than they did in July 2021 by a relatively high rate of 19.64 per cent. With this, Nigeria has now had six consecutive months of increased inflation and the rate is at an almost

17-year high.
"This is largely attributable to rises in food and energy prices, forex scarcity for of critical imports materials for manufacturing, and constrained production due to insecurity in some agricultural sites across the country.

She stated that core inflation increased to 16.26 per cent from 15.75 per cent because of increases in the prices of gas, liquid fuel, solid fuel, garments and passenger transport by road

Almona said it should also be noted that the high cost of aviation fuel or JetA1 drove the cost of air transportation to very high levels and became a major driver of the July inflation rate.

Looking at the inflation rates of the states, the three lowest rates were recorded in Borno, Jigawa and Kaduna, while the highest rates were witnessed in Akwa Ibom, Ebonyi and Kogi states. These records may reflect the lockdown on food items in the North West and North East since the food items are not brought to the South due to insecurity that is constraining the movement of goods," she added.

According to her, the development should be a warning signal of massive food waste and shortages in some parts of the country and scarcity in others.

"Government offer a targeted intervention for the movement of food items from production areas to high-demand areas cushion inflationary pressures

"Specifically input manufacturers. have increased prices astronomically. The price of diesel, which most firms depend on to power their factories have continued to rise causing an unbearable cost of production, which also translates to higher consumer prices.

"Nigeria's energy crisis is worsened by the poor supply of electricity and a bumpy road to renewable energy deployment,"

58 communities flay FG for allegedly omitting them as oil areas in A' lbom

Indigenes of 58 communities drawn from nine local government areas of Akwa Ibom State have queried the federal government for not capturing them as oil bearing in the Petroleum Industry Act(PIA) signed by President Mohammedu Buhari recently.

They are Etim Ekpo, Ukanafun, Uyo, Uruan, Abak, Oruk Anam, Nsit Ibom, Ibesikpo Asutan, and Etinan local government areas of the state

This followed the non involvement of the nine (9)LGA areas in the meeting the state Ministry of Power and Petroleum Development held recently with oil and gas producing local government areas in the state on the issue of Petroleum Industry Act(PIA).

Speaking with newsmen in Uyo on Sunday ,Coordinator of Gas pipeline communities of the 9 LGAs Comrade Kufre Emmanson described said non inclusion of the areas in the Act was unacceptable, adding that the Paramount Rulers of the affected Local governments have already written to the Ministry of Petroleum Resources on the matter.

Emmanson, however appealed to the affected council areas to remain calm and wait for state government's response to the Paramount Rulers' letter which have notified government of omission of their communities which are hosting the East Horizon Gas Company Limited till date.

His words: "We are demanding for inclusion of the 58 communities in Etim Ekpo, Ukanafun, Uyo, Uruan, Abak, Oruk Anam, Nsit Ibom, Ibesikpo Asutan, and Etinan, local government areas as oil and gas host communities in Akwa Ibom state.

"This is sequel to the meeting held in Uyo last month between the Ministry of Power and Petroleum development Akwa Ibom State, with the oil producing local government areas in Akwa Ibom State, concerning the Petroleum Industry Act without the above nine LGAs

"We are aware that the Petroleum Industry Act 2021 clearly stated that 'Host communities" are those whose oil and gas pipeline passes their communities and also clearly stated the three percent dividends to Host communities which these 9 Local governments should be part of.

"The East Horizon Gas Company Limited constructed a natural Gas pipeline from Ukanafun that passes through all the nine local governments and terminates in Akansoko in Akpabuyo LGA of Cross River State.

He appealed to the people to remain calm, shun violence, vandalism of government property, and maintain peace in their various communities as the Paramount Rulers have assured that necessary action will be taken legally if the nine council areas are not included as oil and gas producing communities in the state

The Coordinator appreciated the Paramount Rulers from the affected council areas for the confidence reposed in his leadership to handle the issues affecting the oil and gas communities.

Oba Oluwagbemiga, who was reacting to a statement issued by the Deji's Palace that market and shops should be closed in observance of the annual Aheregbe Festival, said such directive does not affect traders in Isinkan Kingdom.

The Deji of Akure Kingdom, Oba (Dr.) Aladetoyinbo Ogunlade Aladelusi, Odundun II, had earlier ordered markets and shops in Akure to be closed in commemoration of the annual Aheregbe festival. Deji in a statement by his Chief Press Secretary(CPS), Mr Adeyeye Michael said markets in Akure would close on Monday, August 22, 2022.

The Iralepo of Isinkan Kingdom in a statement he personally signed, said it is a taboo to bring such festival to Isinkan, saying forcing such on the community would have grave consequences. He said Akure and Isinkan share what some may consider blurred boundaries but the indigenes of the two communities know their domains and their boundaries are not blurred.

"For the purpose of emphasis, I

will like to say that Isinkan shares boundary with Akure at Imogun, just before Saint Thomas' Anglican Church, Isinkan, and Ondo at Owena River. In all these areas markets and shops are not closed for Aheregbe festival.

"It is a taboo and has consequence on Isinkan Community as well as the priest of the festival. So, for peace to reign, Akure people should not bring the festival to my community and neither can they enforce market and shop closure here. This statement is necessary in order to remove any iota of doubt."

Oba Olofin-Adimula said security agencies have been informed about the development and enjoined all market women and traders in Isinkan land to go about their lawful businesses. He equally enjoined the youths of the community to remain calm. He further congratulated the Deji of Akure Kingdom and wished him success in the activities lined up for the 2022 edition of the festival

2022 edition of the festival. Similarly, the Elemo Isinkan, High Chief Olasehinde Abidakun, stated that Isinkan Community had never been part of Aheregbe festival celebration of the people of Akure or any other such celebrations. High Chief Olasehinde said all Akure festivals stop at Imogun, stating that further exporting of Akure festivals into Isikan land would amount to courting trouble. He affirmed the support of all the chiefs and people of Isikan for Oba Arulewolasi.

If they take the exercise seriously, he believed it would also help reduce the risk of "attack and rape of our women who enter the bush to cut firewood."


The coordinator was also of the view that the programme is "going to empower our women with capacity for additional source of income." He said the women are the first beneficiaries to be trained on "briquetting in the whole project locations across the country. "

The training which according to him is being implemented across the three local government councils of NFWP, he is optimistic will be scaled down to the entire axis of the state.

He stressed that the training that will be also taken to the rural communities would save women from the various dangers they often encountered while sourcing for fire woods in the bush.

He said "with the skill that will be acquired by the women at the end of this training, waste elimination and healthier cooking methods which translate into healthier lives for our women is envisaged."

Also speaking, the state Commissioner of Women and Child Development, Bridget Twar, said listed businesses which they

cannot support. According to her, they include "firewood and charcoal businesses."

She said the briquetting training "is designed by the project to help alleviate the suffering of our women who are daily involved in the use of firewood and charcoal for home use which has been known to have its attendant health and environmental implications."

Applauding Governor Darius Dickson Ishaku, for throwing his weight solidly behind the project, she is optimistic that the incoming state government will as well sustain the project.

Some of the women beneficiaries who explained to The Trumpet the challenges they often confront while going into the bush to source for firewood, believed that the training will liberate them from such hazards.

Retirement of 243 soldiers not caused by corruption, low morale, says Army

Nigeria Army has frowned at statements making rounds on social media that soldiers are proceeding on mass voluntary retirement due to corruption, poor service conditions and low morale.

Chief of Army Staff, Lt Gen Faruk Yahaya, had granted approval for 91 NA/32/4792 WO Ndagana Ishiaku and 242 other soldiers on voluntarily discharge from the Army.

Several commentators have traced the mass retirement in a time that the military needs more manpower to corruption and low morale.

However, the Army in a statement issued by the Director, Army Public Relations, Brig-Gen Onyema Nwachukwu during the weekend, said the allegation is a 'concoction of the imagination of the unrepentant enemies of the nation and mischief makers and should be outrightly discountenanced by the public'.

Gen Nwachukwu said the allegation was an attempt to weaken the spirit and loyalty of soldiers who are at the war fronts in defence of the

country, he added, however, that the move failed on arrival.

According to him, the way that recruitment into the Nigerian Army is volunteering, so also is room given for volunteering retirement and discharge while saying the practice is age-long.

"The subjective and unethical report is a distraction and another failed attempt at dampening the morale and fighting will of the loyal, dedicated and patriotic fighting force of the NA.

"Perhaps these impenitent mischief makers need to be schooled to understand that the NA is not a conscript Army and that recruitment into the NA is voluntary with extant policy on discharge and retirement of soldiers and officers respectively, like other organizations.

"This provides its personnel the opportunity to apply for voluntary discharge, when they deem fit and meet the terms and conditions as stipulated in the Harmonized Terms and Conditions of Service soldiers/ ratings/airmen (Revised) 2017.

"It is thus, the inalienable right of a personnel to voluntarily or on medical grounds apply for discharge, if they meet the terms. It is therefore not an aberration that the COAS granted approval for 91 NA/32/4792 WO NDAGANA ISHIAKU and 242 others to voluntarily discharge from the NA, as being unprofessionally manipulated by some media," he said.

Nwachukwu further said the Army under Gen Yahaya is well motivated as various interventions, welfare schemes and initiatives targeted at boosting the morale of soldiers and officers are being embarked upon.

According to him, the intervention programmes include car loans, housing loans, extensive construction of new accommodation, massive renovation of old and

dilapidated accommodation.

Others are building of befitting residences and issuing of vehicles to Regimental Sergeant Majors, scholarship awards to children and wards of fallen heroes and other unique interventions in the theatres of operation to sustain the heightening morale of troops.

He said these interventions evidently account for troops' game changing onslaught in the Northeast.

"It must also be mentioned, that the quantum of equipment that have been injected into the theatres and prompt payment of operational allowances, have all turned the tide against the insurgents.

"Also worthy of note is the welfare flight for troops, which has significantly reduced the burden of troops travelling in and out of the theatres, in addition to huge commitment on the medical needs of wounded-in-action soldiers and the barracks communities.

"Equally important, is the fact that troops are now being regularly and consciously rotated from the frontline, hence, issues of overstay and battle fatigue are gradually being overcome. Suffice to say, that some of these recently discharged soldiers are beneficiaries of these giant strides," he added.

Meanwhile, the Chief of Army Staff has congratulated the discharging personnel for their gallantry, patriotism, loyalty and courage while in service and wished them the very best as they successfully exit active service from the Army.

Gen Yahaya also reiterated his avowed determination to continue to have direct impact on the welfare and wellbeing of both serving and retired personnel while assuring the retirees that soon, their various commanders would organise a farewell luncheon in their honour, as it is the practice in the Nigerian Army since he took over.

Police rescue victim, arrests suspected kidnappers, others

Operatives of Delta State Police Command have rescued a 17 year old kidnap victim and arrested the suspected abductors in Warri.

Spokesperson for the Command, DSP Bright Edafe, made this known in a statement sent to **The Trumpet** on Sunday.

Edafe said the two suspects were being lunched by angry mobs when the police on patrol duty rescued and arrested them along Effurun roundabout, Warri.

"On 17/8/2022 at about 1345hours, policemen attached to Eagle-Net patrol team while on visibility and confidence building patrol along Effurun roundabout, Warri, saw a large crowd beating two boys.

"The Police rushed to the scene and rescued the boys from the mob. On the spot inquiry, it was discovered that they were suspected kidnappers.

"A woman also accused the boys of kidnapping her 17 year old son earlier that day.

"The two suspects, Oti Shevire 'm' aged 32years and Amos (surname unknown), upon interrogation, confessed to the crime and led the Policemen to their hideout, where the victim was rescued, and is currently receiving treatment. Suspects are in custody and investigation is ongoing," Edafe stated.

Also, one Aaron Uko was also arrested by operatives on stop and search at along Warri/Sapele road.

The suspect was arrested after the police intercepted a Volkswagen Jetta, a commercial vehicle with reg. no. PTN 242 TA, conveying some

passengers from Sapele to Warri.

"On 19/08/2022 at about 0815hours, Police operatives attached to Dragon 26 and Dragon 29 while on intensive stop and search duty along Warri/Sapele road, intercepted a Volkswagen Jetta commercial vehicle with reg. no. PTN 242 TA, conveying some passengers from Sapele to Warri.

"The team subjected the passengers to a search, during which one locally made cut-to-size gun loaded with two live Cartridges were recovered from one Aaron Uko aged 22yrs of Sapele. Suspect concealed the gun in his body close to his private part.

"Preliminary investigation revealed that he bought the gun in the year 2018 from a man nicknamed "OSE" for twenty-seven thousand naira (N27,000) and buried it in his house before leaving for Ghana. He was arrested and taken into custody, the exhibit recovered, and investigation is ongoing," the spokesperson said.

Edafe said the arrest was in compliance with the directives of the State's Commissioner of Police, CP Ari Muhammed Ali on the need for officers and men of the Command to not only sustain the tempo in curbing crime and criminality but also on the importance of stop and search.

The address at the event was delivered by the Permanent Secretary in the SSG Office, Barrister Deborah Enakhimior.

According to Obaseki, "Land access remains crucial as the bedrock upon which agricultural production rests. Land access has consistently been identified as a key constraint to the expansion of agricultural production and productivity in Edo State in particular and in Niger Delta in general.

"Food security, agricultural self-sufficiency and rural development is a priority for us. To facilitate this, the state has provided the needed support to investors in Edo State with allocation of 65,000-hectares of land to eight oil palm investors. We have also facilitated activities in crop production clusters across the state and have entered into partnerships for development of livestock.

'We have embarked on the restructuring of the Edo State College of Agriculture, Iguoriakhi and also facilitated a collaboration between GIZ SEDIN with the Ministry of Agriculture and Food Security to develop a workable agricultural policy in the state. There is also the CBN 5-Star Cassava Project, which would boost cassava production in

Chairman of the Edo State Arable Land Committee and Managing Director, Edo State Investment Promotion Office, ESIPO, Mr. Kelvin Uwaibi noted that Nigeria has about 34 million hectares of arable land which should be sufficient to make the country food self-sufficient and a major supplier of food in the world.

He lamented low productivity in the agricultural sector, noting that the state is taking deliberate measures to boost cultivation of food and cash crops in the state.

Oborevwori, Edevwie intensify media propaganda over Appeal Court on ruling

The certificate controversy surrounding the winner of the Delta State Peoples' Democratic Party(PDP) gubernatorial primaries, Rt. Hon. Sheriff Oborevwori, has in the past two days created fresh tension in the political space. The Appeal Court has already reserved judgement on a suit by Oborevwori and PDP to upturn the Federal High Court judgement disqualifying his candidature as the gubernatorial candidate of the party

in the 2023 general election.

However, the media space has been awash recently with claims and counter claims by both divides, all in a bid to probably influence the Appellate Court to rule in their favour. The fresh issue of controversy was the report published in Sahara Řeporters online, on the outcome of a forensic investigation on the authenticity of the WAEC result submitted by Sheriff Oborevwori to PDP and INEC by one DSP Udenze (Rtd).

The reports captioned, "Forensic Investigation Exposes How Governor Okowa's Stooge, Oborevwori Forged, Submitted Relation's WAEC Certificate To Electoral Body, INEC" has stirred fresh anxiety on the possible outcome of the case before the Court of Appeal. According to the report, the forensic report was part of police investigation into the allegations obtained by Sahara Reporters during the weekend and showed that there were discrepancies in the Assembly Speaker's certificate. The report claimed that Oborevwori is not the owner of the certificate he claims to be his own. Though genuine, forensic investigation showed that the WAEC certificate belongs to his family member identified as Mr. Francis Oborevwori. Francis was born in 1979 and wrote the WAEC examination in 1999 whereas Sheriff Oborevwori was born in 1963 and was 36 years-old in 1999.

"That the passport photographs marked exhibit A and B are single passport photograph of one person made at a time and lifted from Document marked A, and place on the Document marked B at different

period," part of the report read.
"The passport photograph marked exhibit C-C1 is not the same person in the passport photographs marked exhibit A and B. The passport photographs marked exhibit Å, B and C-C1 are different individual passport photographs."

However, in a rejoinder by supporters of the Speaker, captioned, "Oborevwori vs Edevbie: Rejoinder to the 'Forensic Report' Conducted By Apex Forensic Nigeria Limited," they claimed DSP Udenze (Rtd) was not a trained, certified facial image comparison expert. The rejoinder reads in part, "A forensic report conducted by Apex Forensic Nigeria Limited has been widely circulated on social media. The report is the latest in a series of publicity stunts aimed at discrediting the candidature and good reputation of the Rt. Honourable Speaker of the Delta State House of Assembly, Sheriff Francis Orhowedor Oborevwori.

'Opponents of Oborevwori would like to con his supporters and un-suspecting members of the public into believing unfounded allegations of identity theft. However, a closer examination of the report exposes it as an unreliable document prepared by a "hired gun". It is neither independent nor credible and should be disregarded in its entirety. We draw the attention of independent thinking members of the public to the following. "The examiner, Chief Reginald Udunze, describes himself as a forensic

document examiner/handwriting expert. While he may be accomplished in his field of training, there is a vast difference between a forensic document examiner and a facial image comparison expert.

The examination of documents includes detecting alterations and obliterations, analysis of paper, detection and examination of forgery, origin, determining authenticity, and others. Members of the public should note that the examiner, Chief Udunze, does not say that any documents he examined were forged. However, with the greatest respect, Chief Udunze's qualification as a forensic document examiner does not make him a facial image comparison expert.

Facial image comparison experts compare images of unfamiliar faces (i.e., faces not known to them) and decide whether or not they show the same person. Given the importance of these decisions for national security and criminal investigations, practitioners attend training courses to improve their face identification

"The 'forensic examination' starts on incorrect premise by presuming that the reference imagery was each taken at the same time, at the same angle and distance and of the same image quality. These factors can significantly affect the comparison. The examiner did not use original photographs, but images submitted by Oborevwori's opponents. He did not analyse whether these images were altered in any way.

"Additionally, a significant amount of time elapsed between

the photographs in question. The first was taken in about 1999. The second photograph was taken 15 years later, in about 2014. Finally, the third photograph was taken in about 2018, 4 years after the second photograph and 19 years after the first photograph. As individuals grow and age, facial features can change significantly. The examiner does not account for this factor. The fallout from the Delta State Governorship primary elections has been the subject of intense media scrutiny. For this reason, the examiner should not be exposed to imagery before conducting their comparison to minimize possible sources of bias, such as confirmation bias. This is why independent verification is key and accords with international best practices.

"A second independent examiner should repeat the entire facial image comparison process to verify the result. There should have been a blind verification by the second examiner without knowing the conclusion of the first examiner. This prevents confirmation bias and preserves the integrity of the process. There was absolutely no verification in this case. For the avoidance of doubt, Sheriff Francis Orhowedor Oborevwori has never submitted any false documents as alleged or at all. He has not stolen any person's identity as alleged or at all – indeed, none of Oborevwori has brought forward the person they identify as the genuine holder of the identity. The reason for this failure is simple. All the photographs shown in the examination are of Sheriff Francis Orhowedor Oborevwori.

"It is curious that a document apparently addressed to the Deputy Commissioner of Police, Guzape District, FCT Abuja, has found its way to WhatsApp and Facebook, instead of the intended recipient. Equally curious is how a complaint of events allegedly occurring in Delta State has found its way to Guzape District, FCT Abuja. Opponents of Sheriff Francis Orhowedor Oborevwori should test their popularity at the polling booth, not on social media pages.

Ebonyi women protest against alleged attack by Ebebuagu operatives

Thousands of Ebonyi women at the weekend staged a protest alleging maltreatment against them by Ebubeagu Security outfit personnel.

The attack allegedly took place at the Ebonyi state People's Club Recreational centre along Abakaliki-Enugu Road High way where they were supposed to have their August meeting.

The women were seen crying as they protested round the Abakaliki city expressing their dissatisfaction over the action of Ebebuagu security operatives who allegedly distrupted their already scheduled August meeting.

They alleged that the Ebubeagu Security Outfit invaded the venue of the meeting with their branded vehicles and guns, cordoned the place, arrested some women, destroyed already set canopies, chairs, tables and confiscated some of the materials for the event.

They said their rights had been violated against the Constitution of Nigeria which grants individuals and Citizens the right of Association and peaceful gathering.

They called on Nigeria Government to come to their aid as their rights had been trampled upon.

The women in a statement titled "DESECRATION OF WOMANHOOD IN EBONYI STATE: IGP, FIDA, RIGHTS GROUPS SHOULD COME TO EBONYI WOMEN'S AID" described the incident as the desecration of womanhood.

According to the statement signed by Mrs. Charity Chukwuemeka, President, Umuada Ebonyi Women, Hon.Amaka Chukwu, Coodinator, EB-OWATAN, Mrs. Margaret Nweke Chairperson, Ebonyi Widows Forum, Alobu Seraphina, South-East Women Association, Hon. Nwali Eucharia U (Rep. Female Ministers of God,, Amina Mustapha (House Community Women), and Mrs. Ngozi Nwabueze (President-General, Urban Women Organization), the aggrieved women further called on rights groups to come

"This press briefing is aimed at calling for the aid of the press, IGP, FIDA, and rights groups to the desecration of the rights of women of Ebonyi State using Ebubeagu Security Network. The Nigerian constitution guarantees freedom of women. Articles 15(2) and 42 (1) a & b (2) (3) prohibit discrimination on the basis of sex and ensure that men and women have equal access to the courts in matters of contracts, torts and civil matters.

"The hard-working, Peace fostering women of Ebonyi State under the aegis of Federated Ebonyi Women Organization, were on this day 20th of August 2022, unjustifiably attacked, embarrassed and chased out of the venue of their 2022 Annual August Meeting slated to hold in People's Club Hall, Abakaliki.

"This abominable act was carried out by the Ebubuagu Security outfit of Ebonyi State.

"It is not new or alien to the Igbo Race that the entire women meet every August to discuss and chart the best possible developmental ideas and projects to improve the well-being and welfare of our people.

"Noteably, Annual August Meeting is not a partisan gathering as it cuts across party lines and even involves women who never belonged to any political party.

"It is surprising therefore that the Governor knowing the importance of this annual gathering for the women and the society at large, facilitated this dehumanizing attack on this year's August Meeting that has the approval of all relevant security agencies.

Reacting to the development, the Special Assistant to the Governor of Media and

Strategy, Mr. Chooks Oko stated that the Governor had no idea about what happened at People's Club as he (Umahi) was far away Abuja attending several meetings that concern the development of the State.

"The Governor has been involved in lots of consultative meetings in Abuja as it concerns the development of the State. Moreso, the Governor applies rule of law in whatever he does and there's no way he can be connected with any seeming breach of law and order."

When contacted, the Ebonyi State Security Consultant, Chief Stanley Okoro-Emegha added that Ebubeagu operatives went to the location of the meeting as way of nipping at the board any planned attack by unknown gunmen in the State.

The Trumpet had reported that Agballah was sacked from the party on Friday by his Udi/Agbudu ward in Udi Council Area of the State.

Reacting to Agballah's expulsion, Nwoye stressed the need for unity among members of

the party, especially as the 2023 general election gathers steam.

The former Chairman stated that Agballah's leadership style "led to the exit of some of our notable leaders with their teeming supporters to other parties," describing his sack as a right step in the right direction.

Nwoye also saluted the courage of the executive members of the Udi/Agbudu ward for doing the needful, stressing that they had the right to do so.

He named some of the key leaders of the party in the State that recently defected to other political parties to include a former Nigerian Envoy to the Republic of India, Major General Chris Eze, (Rtd.), Enugu State APC Governorship Candidate in 2015, Barr. Okey Ezea, Zonal Chairman of Enugu East Senatorial district, Chief Emma Okenwa, among others.

Nwoye, a Federal Com-

missioner, advised Agballah to stop parading himself as state Chairman of the party, as his expulsion had the APC constitutional backing.

On the claims that the signatories to Agballah's expulsion were not the authentic ward leadership, Nwoye said "the certified true copy is there both with the INEC and the National Secretariat of our party. Their names are clearly there as the executive members of the party in Udi/Agbudu ward."

He recalled that former national chairmen of both the APC and the PDP, Adams Oshiomhole and Okwy Nwodo, respectively, were similarly sacked by member of their ward executives.

According to him, stakeholders of the party have agreed that there was a need to unite and move the party forward to win the 2023 election in the State.

Paris Club refund: Lead consultants accuse governors of \$100m kickback

The lead consultants working on the London and Paris Club refunds, weekend, accused state governors on the platform of Nigerian Governors Forum (NGF) of collecting \$100 million in kickback.

They also disclosed that contrary to the claim of the NGF, the money being owed the consultants was \$68 million not \$418 million.

Ned Nwoko made this known while addressing newsmen in Abuja at the weekend. He alleged that the NGF demanded and received the sum of \$100 million in the name of prosecuting elections in some states.

Nwoko further alleged that when the consultants submitted a bill of \$350 million as the consultancy fee, the state governors demanded to be paid 50 percent of it before it could be honoured

He alleged that a former chairman of the forum had explained to him that the money was needed to prosecute elections in Bauchi, Ekiti and Ondo

Nwoko revealed that it took the intervention of the Ministry of Justice before the governors eventually received the sum of \$100 million.

While commenting on what is being owed the consultants, Nwoke explained that the consultants had nothing to do with \$418 million, noting that it must be a miscalculation.



Inibehe Effiong: 'Trial court erred for conviction without fair hearing'

Convicted human rights lawyer, Inibehe Effiong is currently at the Court of Appeal, Calabar Division to challenge the decision of the state's high court for convicting him without fair trial.

The notice of appeal was filed on the 19th of August, 2022 with Inibehe Effiong as the Appellant and the Governor of Akwa Ibom State, Udom Emmanuel and Leo Ekpenyong as the Respondents.

This was revealed by Court processes sighted by journalists during the weekend.

The notice of appeal contained 9 grounds of appeal and was filed by his legal team led by Femi Falana SAN, Adeyinka Olumide-Fusika SAN, John Aikpokpo-Martins Esq, Monday Ubani Esq, Olukunle Edun, Funmi Falana Esq,

Femi Adeborisade Esq, Taiwo Olawanle, Nsisak Akai, Augustine Asuquo, E.E. Philip, and Joseph Eleh.

In the Appeal, the Appellant said the lower court in its decision made by Chief Judge of Akwa Ibom State, Justice Ekaette Obot on the 27th of July, 2022 in SUIT. NO:HU/279/2019, erred.

The grounds of appeal range from an alleged violation of Section 36(3) of the Constitution by the Honourable Chief Justice by excluding a Premium Times journalist from covering the Court's proceedings, lack of fair hearing in convicting the Appellant for contempt, infringement of the Appellant's right to personal liberty, among others.

In his relief, the Appellant is praying the Court of Appeal for "An Order" setting aside the conviction and sentence imposed on the him by the Lower Court on July 27, 2022.

Alleged N20.5m fraud: Court grants herbalist N10m bail

An Iyaganku Chief Magistrate Court sitting in Ibadan has granted a 29-yearold herbalist, Ganiyu Rilwan bail of N10 million for alleged fraud of N20.5 million.

The defendant Rilwan, a resident of Muslim area in Ibadan was arraigned on a three-count charge of conspiracy, N20.5 million fraud and conversion.

Ganiyu, however, pleaded not guilty to the charges.

The Prosecution Counsel, Inspector Opeyemi Olagunju told the court that defendant conspired with others to obtain money by false pretence and stealing.

Olagunju said Rilwan between November 2021 and April 2022, with

intent to defraud, allegedly obtained the sum of N20.5 million from one Abeeb Adejumo under the pretence of giving him spiritual assistance knowing same to be false.

He added that the defendant allegedly stole the money from Adejumo and fraudulently converted it to his own use. Olagunju said the offence is contrary to Section 383 and punishable under section 390(9), 419 and 516 of the Criminal Code Laws of Oyo State, 2000.

The Chief Magistrate, Mr S. H. Adebisi granted the defendant bail in the sum of N10 million and ordered him to produce two sureties in like sum.

Thereafter, Adebisi adjourned the matter till October 27, for hearing.

Police release journalist, Jalingo after intervention of Falana, Sowore

The police in Abuja have released the publisher of "Cross River Watch", Agba Jalingo, who was on Friday arrested at his residence in Lagos.

Human rights lawyer and Senior Advocate of Nigeria (SAN), Femi Falana and publisher of Sahara Reporters, Omoyele Sowore, earlier faulted the police for the arrest and detention of a journalist over a civil issue.

It was gathered that the journalist had in his newspaper, Cross River Watch, questioned the rationale behind the arrest and prosecution of a lecturer who wrote examinations for someone in the Nigerian Law School, Abuja while the student is being treated like a sacred cow.

The student was said to have failed Law School Bar examination in her first attempt and then hired a university teacher to write it for her a second time.

The lecturer, however, was caught and has been arraigned in court while the said student is walking freely, thus the publication of Jalingo.

The publication was said to have angered the family of the student,

Mrs Elizabeth Alami Ayade, wife of Franco Ayade, the younger brother of the Cross River State Governor, Prof Ben Ayade.

Consequently, a petition was written to the Inspector-General of Police, IGP Usman Alkali Baba, who then detailed a special police squad led by one SP Danbaba M Alura from Abuja to Lagos to arrest Jalingo who was flown to Abuja.

Reacting to the development, Falana said the journalist has not committed any offence known to the provisions of the Criminal Code, saying it is a civil case.

He demanded the immediate release of the journalist while describing the action of the petitioner and the police as "the height of official impunity in a democratic society."

Falana said, "Based on the information at my disposal, I was compelled to demand for his unconditional release since he has contravened any provision of the Criminal Code. But the police officers informed me that his detention was ordered by the Authorities in Abuja.

"Thus, at about 11 am this morning (Saturday) he was flown out of Lagos and he is currently being detained at the Criminal Investigation

Department, Garki, Abuja.

The ongoing harassment of Agba based on the allegation that he has defamed the wife of the brother of a serving Governor is the height of official impunity in a democratic society

"Since defamation is not a criminal offence, the action of the Police is a flagrant breach of section 8(2) of the Administration of Criminal Justice Act, 2015 and section 32(2) of the Police Establishment Act 2020 which have banned the police from arresting any person in Nigeria for civil wrong or breach of contract.

"Therefore, the police Authorities should release Agba Jalingo unconditionally and advise the petitioner to sue for libel in a civil court."

On his part, Sowore accused the IGP of harassing innocent Nigerians that are merely expressing their opinions on the social media and internet.

He described the action of the police as 'unlawful policing' while demanding for the unconditional release of Jalingo.

"The IG of Police devoted a 'Special Unit' to these VIPs dedicated to harassing, brutalising, torturing and kidnapping Nigerians posting opinions on the internet about the fraudulent and sometimes scandalous lifestyles of these VIPs.

"Today, Agba Jalingo is being detained accused of raising concerns over the prosecution of a lecturer hired by the wife of Franco Ayade, the younger brother of the Calabarbased tyrant, Governor Ben Ayade. According to the sources, his wife, Mrs. Elizabeth Alami Ayade, failed Law School Bar examination and then hired a university lecturer to write it for her a second time. The lecturer was caught and is being prosecuted (as I was told).

"As a journalist, public conscience and social critic, Agba Jalingo questioned why the woman, who procured the lecturer hadn't been apprehended.

"Instead of swinging into action, the police were procured to kidnap Agba Jalingo from Lagos, a team of policemen led by one SP Danbaba M Alura led the team from CID Garki, Abuja and flown into Lagos to kidnap journalist Jalingo. This morning (Saturday) Femi Falana (SAN) visited Agba Jalingo at the 'Area F' holding cell in Ikeja. He was politely told this is 'IG's personal

case'.

"The police officers on duty said they can't even entertain legal intervention until Agba Jalingo is flown to Abuja. Apparently, Ayade and family have paid for a one way ticket to have Agba flown to Abuja with the team of police officers sent to fetch him for what is purely a civil matter. In fact, it is Franko's wife that should be flown to Abuja in handcuffs for examination malpractice.

"Today, Nigeria is beset with a myriad of security challenges because the Nigerian police has abandoned its constitutional duties to other security agencies and non state paramilitary units.

"With a 350,000 men, the police force though inadequate could be doing better in protecting the citizenry but corruption, incompetence, scandalous recruitment, poor feeding as well as poor remuneration has ruined the police force," Sowore said.

Following the intervention and public condemnation, the Police on Saturday night released the journalist.

Sowore, who shared a video of Jalingo's release on his Facebook page, said the FCT police command granted bail to the journalist.

"He'll be back on Monday. We will never allow impunity to thrive in our country," he added.

COAS tasks graduating army cadets on tackling insecurity

Chief of Army Staff (COAS), Lt Gen Faruk Yahaya, has charged graduating cadets to ensure they deploy acquired skills in tackling insecurity, which remains the country's major challenge.

He spoke during the weekend as the Special Guest of Honour at the Battle Inoculation phase of Exercise Camp Highland, which wrapped up final exercises for the Army Cadets of Regular Course 69 of the Nigerian Defence Academy (NDA), before their passing out later in October this year.

by the Cadets while noting that with the recent review of training curriculum in the academy, there has been remarkable improvement in the quality of cadets' combat training, in tune with Army's deliberate capacity development effort towards tackling contemporary security challenges.

He expressed optimism that as junior commanders, they will add value to ongoing operational efforts to restore peace and security in troubled parts of the country, Director, Army Public Relations, Brig-Gen Onyema Nwachukwu said in a statement.

According to Nwachukwu, the COAS re-assured the President of the country, Muhammadu Buhari and all Nigerians that terrorists and

bandits will all be dealt with.

"While pointing out that a lot of resources have been invested in training the cadets, the COAS expressed appreciation to the Commander – in- Chief of the Armed Forces of Nigeria, President Muhammadu Buhari for the confidence reposed in the NA, as well as his support and strategic guidance.

Grandpa who allegedly ships illicit drugs to daughter in Dubai nabbed by NDLEA

• Agency intercepts 2.3m tabs of opioids going to Northern states

Operatives of the National Drug Law Enforcement Agency (NDLEA) has arrested a 63-year-old grandpa, Sola Afis Abibu, who ships illicit drugs to his daughter in Dubai.

Director of Media and Advocacy, Femi Babafemi, on Sunday disclosed this in a statement, saying Abibu is a major importer of Loud variant of cannabis from the United States.

According to him, the suspect was arrested at the Murtala Muhammed International Airport, (MMIA) Ikeja Lagos.

"Abibu was arrested in connection with a 19.30kg Colorado consignment from Los Angeles, USA, which was intercepted on 30th June at the NAHCO cargo import shed of the

Lagos airport.

"While Abibu was still being interviewed in custody, a 37.1kg consignment of Loud intercepted on 7th July was also traced to him," he said.

In another development, Babafemi said over 2.3 million tablets of illicit pharmaceutical opioids and other psychoactive substances meant for distribution in seven Northern states of Borno, Kano, Kaduna, Sokoto, Zamfara, Gombe and Nasarawa were also intercepted in series of interdiction operations in last week.

"In all, a total of Two Million Three Hundred and Twenty Five Thousand Five Hundred and Fifty Three (2,325,553.00) tablets and capsules of Tramadol, Pregabalin, Hypnox, Diazepam and Exol-5 including 7, 353 bottles of a new psychoactive substance locally called Akuskura meant for the seven states were seized from locations across Kaduna, Kogi, Sokoto, and the FCT," he said.

Also, Babafemi said a drug dealer Umar Sanusi, was arrested on Friday 12th August during a follow up operation in Kano and brought back to Kaduna where his consignment of 50 cartons of pregabalin 300mg, containing 750,000 capsules, weighing 375kgs earlier seized along Abuja-Kaduna expressway was counted and weighed in his presence.

"Same day, operatives also intercepted along Abuja-Kaduna express road 7,068 bottles of a new dangerous substance of abuse called Akuskura meant for Kaduna.

Zamfara, Gombe, Kano and Borno.

"The recipients in Kaduna and Zamfara have been arrested during follow up operations. The following day, Saturday 13th August, 285 bottles of the NPS were recovered from a dealer, Abubakar Ahmad, along the same highway.

"In Kogi, no fewer than 696,000 tablets of Tramadol and Exol-5 among others loaded into a truck at Onitsha, Anambra state and heading to Maiduguri, Borno state, were seized along Okene-Abuja expressway on Friday 19th Aug, while NDLEA operatives also recovered 300,000 tablets of Diazepam from a suspect, Faruku Bello, 30, in Sokoto State on Wednesday 17th Aug," he added.

Meanwhile, officers of the anti-

narcotic agency FCT command, at the weekend, intercepted a bus loaded with 323,200 tablets of Tramadol 225mg and others.

The bus was heading to Nasarawa State from Onitsha, Anambra State.

"Driver of the vehicle, Osita Nwobodo, 45, who made fruitless bids to compromise the operatives is now in custody," Babafemi said.

Meanwhile, a freight agent, Miss Njoko Elizabeth, 37, has been arrested for attempting to export 250grams of Tramadol and cannabis to Dubai through the NAHCO export shed.

It was gathered that the drug exhibits were concealed inside some gallons of palm oil and honey, which were packed among food items and hair attachment.

Wrong diagnosis in the practice of medicine in Nigeria

proper diagnosis of a health problem is fundamental to commencement of treatment in medical practice. It is for this reason that laboratories are often established both as an integral part of a hospital or as independent entities in the health care delivery system of a country. A wrong diagnosis could have fatal consequences. There have been too many cases of wrong diagnosis in Nigeria in the last ten

In 2019, a patient in Jimeta, Adamawa state died after a doctor operated on him for a kidney disease which he never had. In the same year, a Kebbi-based doctor was convicted after erroneously diagnosing a dead baby in the womb and proceeded to operate on the mother to evacuate the dead fetus only to discover that the baby was alive. The discovery came too late however, since the doctor had amputated the baby's upper limb as he dissected the mother. The famous human right's activist late Gani Fawehinmi had lung cancer which was misdiagnosed as asthma. In 2006, a journalist, Bayo Onanuga nearly lost his broken foot which the doctor misdiagnosed and put in a cast. He was lucky the pain caused him to insist that the cast should be taken off. Another doctor examined the foot and was shocked it had been placed in a cast. If the cast had stayed a few hours longer, the foot would have developed gangrene and would have had to be amputated. In 2020, a Mrs. Odechukwu spent six months taking medication for acute abdominal pain which the doctors had diagnosed as stomach infection or food poisoning, only to discover after another round of tests that she had kidney disease. Another woman lost her husband to colon cancer which had been diagnosed as ulcer.

The list goes on and on. It is therefore not surprising when many Nigerians who can afford it opt to travel abroad for medical care. Nigeria is facing a serious problem in its health sector due to misdiagnoses and missed diagnosis. Already suffering Nigerians are taking medications for ailments that they do not have; or they are suffering acute pain and being told that there is nothing there. Many find out the truth about their condition too late. The Nigerian health sector needs immediate and serious attention if the current trend is to be stopped. The constant loss of lives, trauma and economic strain caused by the decay in our medical laboratories and among medical laboratory personnel is not something to be

The problems are many. Nigeria has become a leading dumping ground for substandard rapid test and diagnostic kits, reagents and chemicals due to poor monitoring compliance to laid-down standards. Unqualified medical lab personnel conduct tests and generate results for doctors to use in making diagnoses; some of the qualified personnel do not have current

trifled with.



working licenses or work permits; pharmacy shops – which are easy avenues for quacks to infiltrate the system – are allowed to provide medical laboratory test services; the regulatory framework provided by the federal government is routinely ignored; and the entire health sector suffers from poor regulation and non-validation. According to some reports, no teaching hospital or federal medical centre in Nigeria has International Certification (ISO 15189) accreditation for the laboratories that they operate.

The Medical Laboratory Science Council of Nigeria (MLSCN), which the federal government has given the sole responsibility of approving, validating and registering diagnostic kits, reagents and chemicals needs to face up to its responsibilities of sanitizing the practice, and taking disciplinary measures against non-compliance to standards. The Ministry of Health needs to develop a policy of mandatory accreditation for medical laboratories in Nigeria and should take steps to arrest the proliferation of unlicensed medical laboratories across the nation, especially those run by pharmacy shops. There should be regular checks and inspections to ensure that lab scientists and technicians adhere to standards and procedures to avoid causing harm or even death to fellow Nigerians.

The Nigerian government should also impose strict sanctions and punitive measures on any laboratory, lab technician or medical personnel found guilty of operating on a false license, running an unregistered or sub-standard laboratory, or any doctor found guilty of carelessly disregarding procedure and due process in handling patients or in making diagnoses. Indeed, medical personnel should be mindful of their code of ethics in carrying out their task as care givers and health providers who frequently hold the lives of other human beings in their hands. Doctors who run private practices in particular should desist from insisting on laboratory tests where none are required, just to make a profit. Nigerians are suffering enough as it is. When we go to hospital, we go there seeking health, not death.

any disqualified candidates from the SDP and NRC took the same view. Some of them had even canvassed the military to annul the election, and felt no sympathy for Abiola, whose misfortune they regarded as no different from their own in 1992. Some politicians also ditched Abiola after being given very generous financial "settlements" by Babangida. Abiola found himself having to financially match or exceed Babangida's "settlement" of these politicians in order to retain their support.' However, the military had totally exhausted its goodwill and had

little credibility left. Few believed it would or could organise a fresh election, and instead believed that the idea of another election was just a ruse to buy the military more time in office. Even if it could conduct another election in such a condensed time frame, such election would lack credibility and the winner would be haunted by the ghost of the annulled June 12 election. Although they had threatened Babangida and severely weakened his authority, the military

clique behind the annulment were willing to give Babangida breathing room to negotiate his own exit - so long as this did not entail Abiola as president. Abiola's stubborn insistence on his mandate further enraged senior officers and stiffened their opposition to him. Babangida decided to bypass Abiola and SDP party members to negotiate directly with the SDP and NRC leadership. After Babangidas meeting with the national chairmen of the SDP and NRC (Tony Anenih and Hammed Kusameth respectively) in Abuja on July 7, 1993, the SDP and NRC issued a joint statement announcing their decision to "cooperate fully" with the FMG, and their acceptance of the FMG's proposal to form a national government. The parties decided: To cooperate fully with the Federal Military Government to ensure the speedy resolution of the present political impasse. To this end, the two parties accepted in principle the second option of a national government proposed by the Federal Military Government, but would suggest that in view of the implications of the option, a committee comprising representatives of the Federal Government and representatives of the two political parties should be set up to

up of the national government. The NRC thought a national government would allow them to circumvent their defeat on June 12, and provide the opportunity of getting some of its members into the government. It is not clear where the idea of a national

government originated. Although the parties' joint statement of July 7 claimed that the national government was proposed by the FMG, Brigadier Shagaya and the Director-General of the CDS denied that the idea emanated from the military (although they disagreed on whose idea it was)." Both Abiola and Omoruyi believe that former Head of State General Obasanjo proposed to Babangida the idea of handing over to a civilian national government which would conduct fresh elections." However, the biography of Shehu Musa Yar'Adua claimed that it was Lateef Iakande (former Governor of Lagos State) who suggested a national government. According to the biography (based on the recollections of Yar'Aduas colleague A.B. Borisade): Lateef [akande tabled a suggestion for an interim national government at a meeting with secretary of the party Su1e Lamido, Chief Anenih and others. IBB said he shouldn't swear in Abiola if Aso Rock was burning because he did not want him dead. Jakande tore off a piece of paper and wrote, 'Why don't we try an interim government?' He handed the paper to Lamido - he probably still has it.'

There does seem to be a consensus that the idea of forming an Interim National Government (ING) originated from a civilian source. Opportunists and pragmatists decided to back the ING proposal for different reasons. Opportunists thought it was their

best chance for another attempt at the presidency. Pragmatists knew that the military would never reverse the annulment, so started considering other avenues to force Babangida to stand down. Their objective changed from trying to validate Abiola's victory, to one of finding a face-saving way to manoeuvre Babangida out of power. Reversing the annulment would almost certainly have triggered a violent coup. Senior military officers repeatedly vowed that they would leave office only on their own terms and would never be "humiliated out of office" by civilian agitation. With the military unwilling to reverse the annulment, the ING became a way to get the military to give up political power without losing face.

The pragmatists knew that confronting a military government populated by soldiers trained and experienced in combat would end in disaster and bloodshed. They also wanted to avoid playing into the hands of hard core Babangida loyalists who were trying to manipulate the crisis to create enough chaos to justify leaving Babangida in power as the least daunting of frightening alternatives.

Shehu Musa Yar'Adua became

a pivotal figure in the planning to force Babangida to relinquish power by August 27. He joined efforts to construct an ING to succeed Babangida, telling his SDP colleagues that as a former military officer, he knew and understood the mentality of a military

government.
When the ING proposal was first presented to senior officers, they initially opposed it. However, they were eventually won over. Babangida was finally convinced of the need to step down by the insistence of his own generals, who concluded that his name had become so synonymous with the

pain of the annulment that his position was untenable. Even respected retired military officers became exasperated by Babangida. In a rare moment of indiscretion, the normally tacitum General Bali later revealed that he gave his fellow "Langtang Mafia" member Brigadier Shagaya the green light to

Force Babangida out:

I think the biggest blunder he [Babangida] made was to annul that election.

Personally I think it was the freest and most orderly conducted election in this country and it was clear that Abiola was winning ... So when that happened, I told General Shagaya (he is a Langtang man: he was then the General Officer Commanding (GOC) the 15t Division); I said Babangida has lost the credibility to remain as head of state of this country. So, they must remove him. If he doesn't leave, they must remove him because he will never

again stay as head of state."
On July 31, 1993, Babangida inaugurated a Tripartite Committee headed by Vice- President Aikhomu to formulate the ING's composition, duration and operational details. The Tripartite Committee comprised representatives from the FMG and the two political parties.

Wike's many battles, how far can he go?

eno, a renowned philosopher once said that, "Ambition often puts men into doing one of the meanest offices, so that climbing is performed in the same posture as creeping".

Governor Nyesom Wike of Rivers State is no doubt a political strategist; no one can take that credit away from him. He is very steadfast and puts all his energy into any task he sets out to do. He is also a stickler for quality.

When he was chairman of Obio/Akpor Local Government Council in Rivers State, he pioneered the building of state- of- the- art secretariat in local government councils in the state.

When Dr. Peter Odili, then as governor of Rivers State, went to commission the state- of –the- art secretariat at Obio/ Akpor, he had while commending the feat Wike achieved in the building said had it not been that the state government had put up a befitting Government House in Brick House, he would have taken over the secretariat Wike built as new Government House to underscore the finesse associated with edifice.

When Rotimi Amaechi later had issues with Odili following the K-leg saga and the emergence of Celestine Omehia as governorship candidate and later governor, Wike who then was among Amaechi's strong loyalists stood uncompromisingly behind Amaechi throughout the latter's travails.

As Chief of Staff to Amaechi, Wike was like a buffer for the governor, ensuring that the business of the Government House flowed seamlessly. As Director General of Amaechi's campaign for second term as governor, Wike ensured that the campaign was fluid, colourful and with clear message.

When he became the Minister of State for Education, he transferred the same zeal and energy he had deployed in previous assignments and positions he had held to his task in the ministry.

And when it became clear that he could no longer be in the same political boat with Amaechi, Wike turned from the buffer he used to be to become Amaechi's nemesis such that the mention of Wike now makes Amaechi's heart beat to miss a pulse.

In the realm of national politics, Wike has established himself into an enigma, and an oracle of sorts who must be consulted before major decisions are taken.

Is it not intriguing that a political juggernaut like Alhaji Atiku Abubakar whom Chief Olusegun Obasanjo literally knelt down to beg for support when both of them were in the saddle of power is in a quandary now on how to handle Wike and seeing his seeming life ambition of becoming president almost being thwarted by Wike?

It is against this background that some analysts are asking the question: Is Wike a political 'monster'? Where does he derive his power of influence such that even fellow governors kowtow to him? Why does the PDP think that the party and its presidential candidate cannot make headway in the 2023 general election without Wike if the

governor thinks and says so? This is what it seems because everyday Wike comes out with behavioral residues that suggest that the ongoing negotiation between his camp and that of Atiku is a mere waste of time.

Amidst the energy sapping negotiations, Wike has continued to play antiparty, 'dinning and wining' with the opposition while dishing out snide remarks against PDP, Atiku and other PDP chieftains.

And while the 'fire' he set in PDP at the national level is raging, the governor has taken the drumbeat of 'war' down to Port Harcourt, positioning the snout of his 'missiles' at his (former) allies who would rather stick with Atiku in the build up to the 2023 general election.

People like the former governor of the state, Sir Celestine Omehia, former Deputy Speaker, House of Representatives, Sir, Hon. Austine Opara, Senator Lee Maeba among many others who have over the years provided astounding support for the governor have now strangely become political outcasts who must be hunted and hounded for choosing a political path they thought good for themselves by standing with Atiku.

"Governor Wike's stance of 'my enemy must be your enemy' in the state is childish and unreasonable. That is what he is telling us by attacking some PDP stalwarts in the state who would rather stand with Atiku Abubakar in the ongoing efforts to bring sanity in the party", a PDP source said at the weekend in Port Harcourt.

The source said that those who declined from antagonizing Atiku in solidarity with Wike are charting a political path for themselves and looking beyond May 2023 when Wike would have lost the paraphernalia of office that is now "intoxicating" him.

In a recent state wide broadcast, Governor Wike had threatened that the state government would seal hotels and other facilities being used as gathering points for suspected political thugs and cultists in the state, apparently targeting perceived Atiku loyalists.

Last Friday, the Rivers State government made good the threat by clamping down on facilities belonging to some loyalists of Atiku Abubakar in Port Harcourt

Security operatives attached to Government House, Port Harcourt, sealed off a lounge, hotel and a petrol station, belonging to three chieftains of the PDP in the state, including a serving member of the House of Representatives, Hon. Chinyere Igwe.

About 40 staff and customers who were at the facilities during the time of the operation were arrested by the security operatives.

Igwe and two others, a former member of the Rivers State House of Assembly, Hon. Jones Ogbonda and former PDP chairman in Port Harcourt City local government area, Hon. Ikechi Chinda, are all associates of former Deputy Speaker of the House of Representatives, Chief Austin Opara, who is also promoting Atiku presidency in 2023.

Reacting to the development, the APC in a statement issued in Port Harcourt on Friday by its acting Publicity Secretary, Darlington Nwauju, said the opposition party was alarmed at the vendetta and style of harming businesses in the state as an act of regulation.

The statement reads in part: "May we draw the attention of the State Government and its agents to the provisions of Chapter 4 of the 1999 Constitution (as amended) which allows for freedom to live and move freely in Rivers State.

"Not even the President is empowered under our constitution to seal up people's legitimate businesses for whatever reasons"

While the action of the security agents

Nigeria's seeming helplessness and Tompolo's solution to oil theft

Over the years, Nigeria has been losing billions of dollars to illegal bunkering, pipeline vandalism and crude oil theft. In spite of security agencies guiding offshore and onshore oil installations and pipelines in the Niger Delta, the country continues to lose huge amount of crude oil to oil theft. The situation has forced the Federal government and the Nigeria National Petroleum Company (NNPC) Limited to revalidate a multi-billion surveillance contract with former Niger Delta militant leader, Government Ekpemupolo, popularly called Tompolo, to help fight the menace, a development that prompted **JOHNMARK UKOKO** to ask if Nigeria and its various security apparatuses have become helpless and clueless to tackle the challenge.

n August 10, 2022 the government of Equatorial Guinea announced that it arrested a sheep laden with 500,000 barrels of stolen crude oil from the Nigeria's waters.

The report claimed that the Nigeria Navy attempted to arrest the ship on the Nigerian sea, but was unable to do so before Equatorial Guinea arrested the vessel in its territory.

The report has that the ship had 10 Indians, five Sri Lankans, two Nigerians and four others, whose nationalities were not immediately confirmed.

While top officials of the government of Equatorial Guinea were discussing the development with the Nigerian government in Abuja and what should be done to the oil thieves and their 500,000 barrel loots, the Federal Government hinted that it has had enough of crude oil theft and swiftly announced that it has struck a multi- million dollars pipeline surveillance contract to a former militant leader in the Niger Delta, Chief Government Ekpemupolo, popularly known as Tompolo.

The government actually renewed the contract that was initiated by former President Goodluck Jonathan's administration, as crude oil theft, which has been rampant during the immediate past government, but worsened under the President Muhammadu Buhari administration, consistently robbed the country of huge revenues.

On their part, International Oil Companies (IOCs) at a recent conference in Abuja announced that the country was losing as much as 400,000 crude oil daily to theft, and as such, the Federal Government, IOCs, the Nigerian National Petroleum Company (NNPC) Limited and security agencies should strategise and synergise to curb the menace.

As the Federal Government was thinking of the best approach to overcome the challenge, the Organisation of Petroleum Exporting Countries (OPEC) announced that oil theft in Nigeria has been giving the oil cartel serious concern as it was distorting its oil production quota.

The oil cartel revealed that for several months, Nigeria has consistently been unable to meet its daily production quota, which it said, hovered between 1.7 million to 2 million barrels per day (mbpd).

While Nigeria is expected to produce 1.7 to two million barrels per day, it currently produces one million to 1.2 million barrels per day, thereby robbing the country of huge amount in foreign exchange earnings.

Its failure to meet crude oil production quota has led to depletion of the county's external reserves from over \$35 billion early this year to less than \$20 billion as of June 2022.

Also, about two weeks ago, the Minister of Finance, Budget and Economic Planning, Mrs. Zainab Ahmed, announced that the country was losing about \$1.9 billion s monthly to crude oil theft, saying that if the country failed to tackle the menace, a serious economic crisis was imminent.

Before painting the country's gloomy economic outlook, the naira, which exchanged for about N500 to the dollar earlier in the year, crashed to about N700 to \$1 in July, prompting the National Assembly to summon Governor of the Central Bank of Nigeria (CBN), Godwin Emefiele, to appear before it to explain what was going on with the local currency at the official the parallel market.

Despite Emefiele's promises and the fact that the Economic and Financial Crimes Commission (EFCC) arrested some foreign currency speculators last month, the naira still exchanged for over N600 to the dollar at the parallel market.

Although the naira exchanged for N429 to the dollar at the Investors and Exporters (I&E) window on Friday, August 19, 2022, it exchanged for between N630 and N645 to \$1 at the parallel market depending on location

Economists and analysts blamed the development on scarcity of Foreign Exchange (FX) due to the low crude oil production and export, a situation that has been compounded by the Russia-Ukraine war.

While other OPEC member countries continue to reap handsomely from crude oil sales, non-OPEC members Nigeria groan under a depressed economy and lack of funds, just as the Federal Government declared that the massive crude oil theft has robbed it of required revenues to meet its budget projections.

In a rather belated response two weeks ago, President Muhammadu Buhari dispatched a

delegation led by the Minister of State for Petroleum Resources Chief Timpre Sylva and comprising Chief of Defence Staff (CDC), General Lucky Irabor, Group Managing Director of NNPC, Mele Kyari and others to visit the oil producing states to solicit their support in the fight against oil theft.

Irabor and the Director-General of the Nigerian Maritime Administration and Safety Agency (NIMASA), Dr. Bashir Jamoh, assured governors of the nine oil producing states and Nigerians of their determination to fight oil theft headlong.

While Nigerians await fulfillment of Irabor and Jamoh's promises and that of other local security forces, a shipped loaded with 500,000 barrels of Nigeria's stolen crude oil was arrested in Equatorial Guinea last week.

However, the failure of the security forces to stop the massive theft might have forced the Federal Government and NNPC to sign a surveillance contract with Tompolo, a former commander of the defunct Movement for the Emancipation of the Niger Delta (MEND) to end illegal bunkering, illegal refining and all forms of oil theft in the Niger Delta region.

A source close to Tompolo told *The Trumpet* that the contract was

worth over N4 billion monthly, adding that the former MEND leader will be responsible for monitoring and overseeing other surveillance contracts, contractors and their activities in the oil-bearing region.

Although, the actual figure Tompolo will be paid could not be confirmed, the source said Tompolo's role in the deal will be similar to the one he played during former President Jonathan's administration when Mrs. Diezani Alison-Madueke was Minister of Petroleum Resources.

Before the Buhari-led government cancelled Tompolo's contract in 2015, it was learnt that the strategy he adopted effectively tackled illegal bunkering and oil theft and increased Nigeria's crude oil production quota to over 2mbpd.

It would be recalled that at the inception of the Buhari administration, the contract was cancelled, while Tompolo was declared him wanted, though he was later exonerated of all wrong doings.

"But it now appears as if the Federal Government has suddenly realised the need to bring him back, because currently, over 500,000 barrels per day (bpd) are being lost to illegal bunkering," the source said.

The Trumpet learnt that the new deal was brokered by Sylva and some top officials of the NNPC, including the Group Executive Director, Upstream, Adokiye Tombomeiye.

In its new status, NNPC as profit making outfit is determined more than ever before to curb all illegal activities affecting operations and making the company run at a loss.

At the signing of the renewed contract with Tompolo, it was also learnt that over 5,000 stakeholders from the Niger Delta, especially from Bayelsa and Delta states attended the meeting.

meeting.

While it appears that the government has realised that security agencies lack the willpower to end crude oil theft, the presidency and top government officials are now lamenting that the menace had impacted negatively on the country's revenue generation capacity.

Responding to the development, most Nigerians say it was ironical that Tompolo has once again secured the contract, in spite of all the allegations the Buhari administration leveled against him at its inception, adding that it was unbelievable that the former militant leader could secure the same contract from the Federal Government.

They expressed surprise that the Buhari government could re-award the contract to Tompolo to protect the country's crude oil pipelines and crude oil facilities.

Expressing disgust that thousands of navy officers, security agencies and their men could not arrest crude oil thieves, they lamented that the country's security apparatuses seem to be collaborating with some foreign powers to steal Nigeria's crude oil.

They maintained that it was unbelievable that crude oil thieves that stole 500,000 barrels of crude oil and evaded arrest in Nigeria could be arrested in Equatorial Guinea.

But with the renewal of Tompolo's contract to guide monitor and possibly protect crude oil pipelines in the Niger Delta region and end crude oil theft, most Nigerians wonder if the country's security agencies and their officials have become helpless and clueless on strategies to effectively put a final stop to the massive stealing of crude oil in the country.

Customs grants N2.3 trillion duty waivers

It has been established that the Nigerian Customs Service (NCS) gave duty exceptions and waivers to importers amounting to N2.5 trillion in 2021, a 194.65 per cent increase from the N779.4 billion waivers it granted in 2020.


The exemptions included Value Added Tax (VAT) relief granted on imports, waivers and concessions on imports duties, Economic Community of West African States (ECOWAS) Trade Liberalisation Scheme surcharges, comprehensive import supervision scheme, as well as excise and levies.

These data are contained in the 2023-2025 Medium Term Expenditure Framework (MTEF) and Fiscal Strategy Paper, which revealed that the exemptions translated to huge amount of revenue forgone relative to the N1.34 trillion the NCS collected as revenue in 2021. Globally, governments use import duty waivers, exemptions and concessions to protect local businesses and jobs, but they are susceptible to abuse and could be major drains on the national economy.

Also, import duty waivers are vehicles to meet specific economic goals, especially in protecting local industries, creating jobs and promoting exports.

Details of the aggregate customs exceptions showed that waivers on import duties were valued at N33.85 billion surcharge or seven per cent of import duty amounted to N30.38 billion, while Common External Tariff (CET) levy reached N1.42 trillion.

Similarly, Comprehensive Import Supervision Scheme (CISS) was valued at N130.04 billion ECOWAS Trade Liberalisation Scheme, N72.91 billion, iron levy, N15.879, National Automotive Council (NAC) levy of N41.39 million and import VAT of N208.24 billion.

The data revealed that the highest jump in aggregate custom was in the Common External Tariff levy which jumped from N223.19 billion in 2020 to N1.42 trillion in 2021.

In 2021, import duty amounted N305.65 billion, surcharge was N305.65 billion and N21.29 billion, Common External Tariff levy was N223.99 billion, comprehensive import duty generated

N28.87 billion, while ECOWAS Trade Liberalisation Scheme was N1.08 billion.

Also, iron levy was N113.77 billion, while NAC levies amounted to N179.60 billion.

"Exemptions applied to imported goods covered by diplomatic privileges, military hard wares, fuel and lubricants, hospital and surgical equipment, aircraft parts and ancillary equipment, plant and machinery imported by companies in Export Processing Zones (EPZs), health and medical supplies to contain the spread of COVID-19 pandemic.

"Other exemptions include reliefs on the Presidential Initiative on COVID-19 supplies, imports, tax expenditure on customs and VAT relief. Tax expenditure estimated based on Nigeria's tax reference, including N1.419 trillion from waivers of CET levy, which constitutes 72.6 per cent of total customs tax expenditures.

"Import VAT tax expenditures amounted to N111 billion of the N1.49 trillion from waivers of common external tariff Levy import duties exemption certificate amounted to N1.417 trillion," the report added.

It further showed that petroleum products, especially fuels and lubricants accounted for 46 per cent of N216.85 billion import duty waivers granted, adding that in 2021, China, accounted for nearly half of total relief granted waivers, while Singapore, Netherlands, Togo, Benin Republic were also major beneficiaries.

SEC to sanction stakeholders over unclaimed dividends •Cautions Nigerians against Ponzi schemes

In spite of efforts by the Securities and Exchange Commission (SEC) to ensure the effective deployment of the Electronic Dividend Mandate Management System (e-DMMS), investors have continued to lament acute delay in the payment of their e-dividends.

Director-General of the commission, Lamido Yuguda, who stated this recently in Lagos, said unclaimed dividends as of 2021 stood at N177 billion, which was higher than the N168 billion in 2020.

"Capital market operators must also do more to demonstrate an efficient capital market system that prioritises the interest of investors through their activities.

"As part of efforts to stem the tide of activities of unregistered crowd funding platforms, the commission warned the operators of the platforms that they stand the chance of being prosecuted," he said.

He also said the commission had obtained donor securities market surveillance system, adding that the system would improve the commission's regulatory and supervisory capabilities over securities trading activities.

Yuguda stressed that commission would continue to engage the Standards Organisation of Nigeria (SON) to deepen the commodities ecosystem, maintaining that the commission had continued to engage the Ministry of Finance, Budget and National Planning on requests for tax exemption for corporate bonds.

Meanwhile, the SEC has urged Nigerians to be careful in patronising Ponzi schemes, describing them as "cancerous and major hindrance to effective capital market operations."

Yuguda said this at its post-Capital Market Committee (CMC) meeting media briefing in Abuja where he revealed that the commission had been fighting against Ponzi schemes where people without licences extort money from unsuspecting victims.

He said the commission had been working with other agencies to reduce access of Ponzi scheme in the country, adding: "We have been saying that people should only deal with registered operators with the commission. People should confirm that an operator is licensed with the commission before patronising them.

"We have done a lot of sensitisation to discourage people from patronising Ponzi schemes, but unfortunately, a lot of people still patronise them. We have cases reported to us and our enforcement and the Police have been working on several cases trying to resolve issues of investments that have been lost. It is not difficult to recognise a Ponzi scheme. When a return is too good to be true, desist from it."

He disclosed that the commission was collaborating with the Economic and Financial Crimes Commission (EFCC) to fight money laundering and promoters of Ponzi schemes in the country.

Yuguda, who said the commission would continue to enlighten members of the public to desist from patronising Ponzi schemes, added that the 2021-2025 revised Capital Market Plan (CMP) would be launched at the next CMC's meeting in November 2022.

NBS points to rising price of kerosene

National Bureau of Statistics (NBS) has alerted that the average retail price per litre of household Dual Purpose Kerosene (DPK), popularly known as kerosene, roseby 98.76 per cent in July 2022 compared to July 2021.

NBS's National Household Kerosene Price watch for July 2022, which was announced on Friday, August 19, 2022 in Abuja showed that between July 2021 and July 2022, its average retail price increased by 98.76 per cent from N397.34 to N789.5 per litre.

According to the report, the product witnessed a month-onmonth increase of 3.68 per cent in July 2022, rising to N789.75 from N761.69 in June 2022.

Also, state profile analysis showed that Enugu State had the highest increase in the average price per litre of kerosene in July 2022, with N1003.68, followed by Ekiti and Osun state with N989.58 and N949.11 respectively.

Alternatively, Bayelsa State reported the lowest price at N643.06, followed by Benue State at N645.76 and Rivers State at N658.24 respectively.

The study further revealed that on regional basis, the South West had the highest increase in average retail price per litre of kerosene with N900.90, followed by the South East with

N892.40 and the North Central with N761.92, while the South-South recorded the lowest with N727.07.

It also showed that consumers paid an average retail price of N2,886.41 for a gallon of domestic kerosene in July 2022 an increase of 7.98 per cent from N2,673.04 in June 2022, adding that the increase from N1,302.56 in July 2021was up 121.60 per cent, year-on-year.

State profile analysis disclosed that the Federal Capital Territory (FCT) Abuja, had the highest average increased in retail price for a gallon of household kerosene followed by Enugu State and Ekiti states at N3,500.75 and N3,450.00.

According to the survey, Borno and Gombe states came second and third with N2,500 and N2,430.57.

The South West had the highest average retail price per gallon of household kerosene with N3,186.93 according to an analysis by zone, followed by the South East and the North Central with N3,130.76 and N2,924.73, while the lowest average retail price per gallon was N2, 597.04 in the North East.

Similarly, the price watch of Liquefied Petroleum Gas (LPG), popularly known as cooking gas for July 2022 showed an increase of 105.35 per cent for 3.5kg of the commodity year-over-year.

Naira appreciates after two-day lull

After a two-day lull, the Naira appreciated against the dollar at the Investor and Exporter (I&E) window on Friday, August 19, 2022.

It exchanged at N429.05 to the dollar, representing an increase of 0.05 per cent compared with the M429.38 it exchanged for the dollar on Thursday, August 18, 2022.

The open indicative rate closed at N428.53 to the dollar on Friday, while an exchange

rate of N444 to the dollar was the highest rate recorded in the day's trading before it settled at N429.08, just as it sold for as low as N416.06 to the dollar in the day's trading.

A total of \$50.22 million dollar was traded in foreign exchange at the official window, while *The Trumpet* findings showed that it sold for between N630 to N652 to \$1 at the parallel market in some locations in Lagos.



Expert laments plight of airlines, urges CBN to release trapped funds

A former Vice Chairman of the National Association of Nigerian Travel Agencies (NANTA), Segun Adewale, has urged the Federal Government to urgently repatriate the \$600 million ticket revenue to foreign airlines operating in the country.

Adewale, who is the Chief Executive Officer (CEO) of an aviation company, gave the charge in a statement he issued in Lagos at the weekend.

in Lagos at the weekend.

It would be recalled that on Thursday, August 18, 2022, Emirates Airlines announced suspension of its flight operations in Nigeria as from September 1, 2022 over its inability to repatriate its funds from the country.

International carriers operating in the country have constantly complained about their inability to repatriate funds to their home countries.

Blocked funds belonging to the airlines have risen to about \$600 million as the Central Bank of Nigeria (CBN) had not been able to make dollars available for the carriers to repatriate to their countries.

Adewale stated that the CBN blocked revenue from ticket sales, which accumulated since 2021 till July 2022, from being repatriated to airline operators through the International Air Transport Association (IATA).

"Repatriation of revenues of tickets sold to travelers by airline operators to their home offices is CBN's responsibility, but it has refused to release the equivalent in dollars for services rendered.

"We have lost many airlines and jobs are being lost in the aviation sector and at our airports. The development is inimical to our economic wellbeing as a country. From the spiritual point of view, it is wrong to muzzle the ox that threads the corn," Adewale stated.

He decried that the blocked funds had already led to reduction of air connectivity and restriction of flights, lamenting that it was disheartening to know that the same foreign exchange (forex) being denied the airlines was being released to import non-essential products such as champagnes and tooth picks.

"If foreign airlines suspend their flight operations, businesses will be shifted to neighbouring countries like Ghana, Benin Republic and Togo. The issue is so difficult for the operators, who now borrow forex from their home offices to fuel their aircraft.

"With the increase in dollar rate leading to rise in the prices of flight tickets, especially en-route America and Dubai, which is now over N1 million, the environment is becoming too hostile for businesses to thrive," he stated.

Adewale, therefore, appealed to the Minister of Aviation, Hadi Sirika, his Finance, Budget and National Planning counterpart, Zainab Ahmed, as well as the CBN to do the needful and ensure availability and release of the funds.

Guidelines for implementation of Finance Act 2021 ready, says NAICOM

ational Insurance Commission (NAI-COM) has declared that having carefully studied provisions of the Finance Act 2021, especially on capital requirements, it has drafted regulatory guidelines, which will soon be issued during year for implementation.

NAICOM's Deputy Commissioner (Technical), Sabiu Abubakar, who disclosed this at a forum recently in Lagos, also submitted that the commission would commence a pilot Risk-Based Supervision (RBS) examination in eight insurance companies.

He stressed that the commission did a pilot RBS examination in 2021 with

seven companies and that the outcome had been sent to the affected underwriting firms.

Maintaining that NAICOM had started training its staff members, he said the RBS would commence in August ending.

"The RBS team in collaboration with FSD Africa and local insurance operators are expected to ensure that they carry out capacity building of their staff members on RBS, as involvement of the operators in the industry remains crucial," he stated.

He said the RBS framework is very demanding in terms of human, technical capacity and other resources, adding that the commission hoped to commence full implementation of RBS between 2023 and 2024.

Rivers State farmers tackle Wike over purported neglect

Rivers State chapter of the All Farmers Association of Nigeria (ALFAN) has lamented the neglect of the Agricultural sector by the Nyesom Wike-led administration in the state.

State Chairman of ALFAN, Chief Firmobari Igwe, who spoke with The Trumpet in an interview, lamented that despite their importance to the economy, farmers' welfare had been relegated to the background in the state and entire country.

He particularly expressed disappointment over the Rivers State Government's attitude towards farmers, who he said, were going through hard times across the country.

across the country.

According to him, farmers needed urgent help from government to avoid food shortage and to encourage others to join the agricultural sector.

"We are saying that farmers in the state have been totally neglected, as their welfare is not being considered. Government is not doing anything about it and it is disturbing. Without farm-

ers or farming activities in the state, there will be no food. We appeal to the state and Federal governments to look into the welfare of farmers.

"The situation in Rivers State in particular should be reviewed so that we will not depend on other states for our food needs. We have fertile land all over the state and we are blessed.

"We can plant our crops without fertiliser, but surprisingly we are still depending on other states for food supplies, which is pathetic. We have good and fertile lands in Ogoni, Omuma, Etche, Ikwerre and other parts of the state where we can plant and produce food stuffs capable of sustaining the state.

of sustaining the state.

Igwe said although the state government was trying in the aspect of commercialisation, it had not impacted grassroots farmers, adding: "When it has to do with farming or agriculture, the grassroots has to feel the impact. In our neighbouring states, their governments carry the farmers along and they are doing well, but it's not the same here in Rivers.

"I don't know whether they are playing politics with it or have other people they are dealing with, because for me as Chairman of all farmers in Rivers, we have not seen anything from the state government.

"Our main challenge has been our welfare, we have been totally neglected and it is telling on us. We just heard recently that the state government approved the training of 10,000 youths in agriculture. Our position is that if it is being done and they are sincere about it, it will take out some youths from the streets and it will boost the state's agricultural sector."

On the impact of insecurity on farming, Igwe, who said agriculture remained the livelihood of every nation, any country without farmers could not survive, lamented that insecurity has really affected farming, but once the government commits to investments in agriculture, it would go a long way.

He called on farmers in the state to use their Permanent Voter Cards (PVCs) wisely in the 2023 general elections and vote people who would cater for the interest of farmers in the state.

Igwe also admonished youths to take farming seriously, because it remains the most lucrative investment, stressing: "Farming is the best business on earth. Even if you are a lawyer or practicing any profession, it is advisable to engage in farming."

NOA pledges to partner NTCA on tobacco control

Director-General of the National Orientation Agency (NOA), Dr. Garba Abari, has said that the agency is willing and available to work with the tobacco control community to ensure that tobacco products are effectively controlled in the country.

He made the commitment when a delegation of tobacco control advocates from the Nigeria Tobacco Control Alliance (NTCA) visited the agency's headquarters in Abuja.

Chairman of NTĆA Board and leader of the delegation, Akinbode Oluwafemi, commended Abari for dedicating time for the meeting in spite of his busy schedule.

He lamented that about 16,000 people die yearly in Nigeria from the use of tobacco products, but added that the figure remained conservative and that the actual number from an updated survey would most likely be higher.

This, he said, is as a result of the proliferation of Shisha

in the Nigerian market, which tobacco companies market as a safer alternative to conventional cigarettes; an assertion that science has debunked as untrue. Oluwafemi stressed that Shisha has higher concentration of chemicals, most of which are known to cause cancer and are twice as deadly as conventional tobacco products.

He also condemned the placement of tobacco products in movies and other entertainment products as a form of advertisement by tobacco companies thus violating the provisions of the National Tobacco Control Act 2015, which bans tobacco advertising, promotion and sponsorship (TAPS).

"This presents a challenge because young people are negatively influenced to take up smoking, which often becomes a gateway to the use of hard drugs. The smoking and public health menace has direct link to the insecurity challenges facing the country," he said.

He also restated that as a

party to the WHO Framework Convention on Tobacco Control (WHO-FCTC), Nigeria had gone a step further towards implementing the recommendations of the convention through the enactment of the National Tobacco Control Act in 2015 and approval of its Implementing Regulations in 2019.

"The NOA with its strategic mandate and national reach has a clear duty of public education and awareness in the fight to ensure that Nigeria is tobacco-free," he added.

The delegation, therefore, requested to partner with NOA to take the tobacco-free message to local communities and all Nigerians.

Responding, Abari said the issue of tobacco control was important because of its devastating impact on society, adding that tobacco control required critical attention, because Nigeria's youth population was high and that most youths are impressionable and easily influenced by who and what they see in movies.

He agreed that smoking and

consequent drug use is a vice that permeates all levels of society, causing rifts, sickness and hardship and, therefore, pledged to open the doors of the agency for collaboration on effective tobacco control.

He made the pledge in company of his management team including the Director, Planning, Research and Strategy, Samuel Soughul, Director, Reform Coordination and Service Improvement, Samuel Attah, Director of Orientation and Behaviour Modification, Theresa Nnalue, Director, Public Enlightenment and Mass Mobilisation, Mrs. Theresa Maduekwe and Director, Documentation, Translation and Publication, Mrs. Victoria Kansa.

The NTCA delegation had Director of Programmes, Corporate Accountability and Public Participation Africa (CAPPA), Philip Jakpor; Project Officer of NTCA, Chibuike Nwokorie; Communication Officer of NTCA, Paul Ashibel and Digital Media Manager of CAPPA, Abayomi Sarumi.

Football matters not for civil courts, Pinnick warns

resident of the Nigeria Football Federation (NFF), Amaju Melvin Pinnick, has warned stakeholders that the world soccer governing body abhors taking related matters to civil courts.

A Member of the Confederation of African Football (CAF) executive committee said the country risks FIFA ban should forces continue to insist on dragging the national federation to court over the amendment of statutes.

His caution is a response to the spate of agitations and appeals by concerned stakeholders, ex-internationals and the Ministry of Youth and Sports Development to the federation to amend the NFF Statutes to include all relevant stakeholders for the development of Nigerian football.

"I want to say that enough is enough. We have tolerated these individuals for much longer than necessary," Pinnick roared.


"I am leaving the position of NFF Presidency in a few weeks but I am still a Member of the FIFA Council and I can talk about Nigeria Football anywhere.

"It is time to call the bluff of these persons. Their actions not only malign and defame the NFF; these also de-market the NFF to a certain degree," the NFF President continued.

"If the NFF holds a General Assembly, they go to court. If the NFF does not hold, they go to court. Every single day, they want to go to court. It is their right, but it is also the right of the NFF to curtail such excesses.

"FIFA clearly stipulates that football matters are not meant for civil courts, and

further infractions by anyone would be met with the stiffest of sanctions, including but not limited to outright ban from the game," he added.

Recall that on June 17, President Muhammadu Buhari directed the NFF to commence processes to amend the NFF Statutes in a bid to include more relevant stakeholders that were hitherto disenfranchised from previous elective congresses.

On Thursday, the NFF held the 77th Annual General Assembly in Lagos State where all the modalities to hold the September Elective Congress that will usher new football administrators into the Glass House were set.

Although there happens to be a headway to the September elective congress after several hitches, including an ex parte order by the Federal High Court in Yenagoa, Bayelsa State that barred the NFF from holding the 77th Annual General Assembly, stakeholders are calling on the nation's football governing body to amend the NFF Statutes.

Furthermore, Pinnick cited the NFF Statutes to assert his position regarding litigations against the nation's football Article 69 (1) of the NFF Statutes 2010 stipulates: "NFF, its members, players, officials and match and player's agents will not take any dispute to ordinary courts unless specifically provided for in these Statutes and FIFA regulations. Any disagreement shall be submitted to the jurisdiction of FIFA, CAF, WAFU or NFF.

(2) NFF shall have jurisdiction on internal national disputes i.e, disputes between parties belonging to NFF. FIFA shall have jurisdiction on international disputes, i.e, disputes between parties belonging to different Associations and/or Confederations."

Meanwhile, the Professional Footballers Association of Nigeria (PFAN), on Saturday, accused the NFF of tactically denying the representatives of the association from participating in the 77th Annual General Assembly.

Harrison Jalla, who heads the task force constituted by PFAN, with other representatives to forge its position regarding the election to usher in new executives, were denied access to present their position.

He noted that the association is paying keen interest as development unfolds, adding that Nigeria football is bound for doom should the local government and state football associations fail to conduct their elections that would produce a new breed of electorates for the NFF election.

"They can return to the trenches if the issue of not holding new Local Government Football Council and State Football Association elections before the general elections is not dealt with first, to produce a brand-new electorate that will elect a brand-new leadership," he said.

Jalla, adding that players are an indispensable entity in the current five constituent members of the congress, reiterated that they are waiting and watching patiently as the event unfolds.

Recently, the FIFA banned the All Indian Football Association (AIFF) over "undue influence from third parties" into issues surrounding the football association "which constitutes a serious violation of the FIFA Statutes."

According to FIFA, who divulged that they are constantly in touch with India's Ministry of Youth Affairs and Sports to fashion out a remedy, stated that the Asian country can no longer host the FIFA U17 Women's World Cup in October until the ban is lifted.

Consequently, should NFF and shareholders not manage the issues surrounding the elective congress and amendment of NFF Statutes properly, which has close similarity with India's, the nation risk FIFA's venomous wrath.

Nigerian Kamaru Usman, after his defeat to Leon Edwards in Sunday's rematch at UFC 278, has vowed to return better than envisaged.

Usman, in the contest against Edwards for the welterweight title, was knocked out with a powerful head-kick to lay out cold.

"And as soon as they were saying it, he literally lands the head-kick.



"I was going to jail, I got bail and I started training my arse off, I wanted to be able to

"This guy to beat me tonight, maybe I could have done better, but it shows the level of hard work I put in so please give him a round of applause as our heavyweight champion of the world," Joshua conceded.

Meanwhile, Usyk has dedicated his victory to the people of Ukraine fighting to defend it from the military

invasion of the Russians.

"I did this victory for my country, for all people, militaries who are defending the country. Thank you very, very much," the heavyweight champion said after the victory.

He added that the outcome of the rematch will transcend generations where they understand how he was able to turn around from being defensive into an offensive approach.

This is already historic. Many generations are going to watch this fight, especially the round when someone tried to beat me hard, but I withstood it and turned it in a

The Ukrainian remains undefeated, holding three out of the four heavyweight title belts with Tyson Fury fondly adored as the Gypsy King and ostensibly retired with the fourth WBC title.

Usyk eyes a bout with the undefeated Fury believing the latter will come out of retirement to challenge him to a contest or he fights no one.

"I'm sure that Tyson Fury is not retired yet," the Ukrainian claimed.

"I'm sure, I'm convinced he wants to fight me.

"I want to fight him and if I'm not fighting Tyson Fury, I'm not fighting at all," Usyk stated.

Comparatively, greatly improved in the rematch against Usyk at Jeddah having included extra trainer, Robert Garcia, in his coaching crew to prep him tenaciously for a victory whilst correcting earlier mistakes made in September

NLC ex-chairman accuses Delta govt of nepotism in civil service recruitment

former the Nigerian Labour Congress (NLC) in Delta, Comrade Mike Okeme, has accused the state government of conducting backyard recruitment for cronies. He specifically accused the Chairman of the State Civil Service Commission, Dame Patience Nkem Okuofu, of being the mastermind of the allege illegality.

Okeme who is also a former Special Adviser both Governor Emmanuel Uduaghan and his successor, Dr. Ifeanyi Okowa on Labour described development worrisome and called for immediate investigation.

According to former the Labour leader, who spoke to journalists in Asaba, the state capital, the purported

service contravenes the guidelines of the civil commission service rules. He revealed that a lot of persons have been recruited into the civil service from the "backyard" which he said has never happened in the history of civil service in Nigeria neither in the

He explained that there are rules and regulations guide the Civil ice Commission, adding that these rules are being jettisoned for people they regarded as first class citizens. He said, "This morning I invited vou here because of what is happening in the state. There have been backyard entry into the civil service in the state, which has never happened in the history of Nigeria neither in Delta State.

"There are rules and regulations that guides the civil service commission. The chairman of the Civil Commission, Service

'Mama Government' is the one ravaging the civil service, a nurse heading technocrats, which is not done anywhere in the country. They are passing through backyard.

"Uduaghan, a to go, employed 1000 civil servants into the service, then they were given letters, they have worked for three months when this government ascended office and this government said they should be suspended. They were not even paid a dime. We made a case and they started reviewing them after two years and decided to absorb about 400 of them, 600 of them are still outside, some of them are in court today, and behind them you are recruiting from nowhere.

"The civil service regulations says that before you conduct recruitment, you must do advert. Some of us came in through adverts. we saw the advert then

and when you apply they shortlist you, you go for interview and maybe taken. Nowadays there is no interview, you are selected on the prerogative of somebody.

"I have never seen a Civil Commissioner Service moving from one ministry to another and they will be supporting k0ola, it is not done. The Civil Service Commission is the builder of ethics. It builds people's

intelligence and moral, but you tell them you are coming to their office tomorrow, that they must wage kola, this is a new dimension to it.

"Government investigate how people are coming through backyard into the civil service whereas there are still 600 people employed by Uduaghan a year to his exit and were stopped because there was no money, they

didn't absorb them, and later when Labour made noise they took some of them. They are recruiting people now and people were recruited eight years ago could not get their appointments ratified.

"The Okuofu of a woman is telling us that some of us are second class citizens. This government has only done public recruitment once since it came into office. So far they have recruited over 70 persons, and they have resumed work. If you go to the ministries you will see some new staff, ask them how they came into the service. I'm calling on you, journalists, to investigate it. The facts are there.'

Tompolo seeks stakeholders' support against oil theft Northern group kicks against his pipeline surveillance contract

will revoke the contract or be forced to either protest or take legal action. The group also called President on Muhammadu Buhari to sack the Minister of State for Petroleum, Timipre Sylva; and Director, Upstream of the NNPC Ltd, Adokiye Tombomelye, "promoting ethnic and regional interest as well as the Group Managing Director of the NNPC, Mele Kyari, for using his office to allegedly reward criminality.

According to them, it is unfortunate that the NNPC succumbed to the "blackmail" of the former Niger Delta warlord to award him such a mouth-watering contract despite being declared wanted by the Economic and Financial Crimes Commission(EFCC) the current under government of Buhari.
